FIG. 9 is a sectional plan view taken along line 9—9 of FIG. 3, the bottom support being eliminated for clarity of illustration;
FIG. 10 is a fragmentary enlarged scale sectional view taken along line 10—10 of FIG. 7;
FIG. 11 is a fragmentary enlarged scale sectional view taken along line 11—11 of FIG. 7;
FIG. 12 is a fragmentary enlarged scale sectional view taken along line 12—12 of FIG. 6;
FIG. 13 is a fragmentary enlarged scale sectional view taken along line 13—13 of FIG. 6;
FIG. 14 is a fragmentary enlarged scale sectional view taken along line 14—14 of FIG. 1; and,
FIG. 15 is a fragmentary enlarged scale sectional view taken along line 15—15 of FIG. 1.

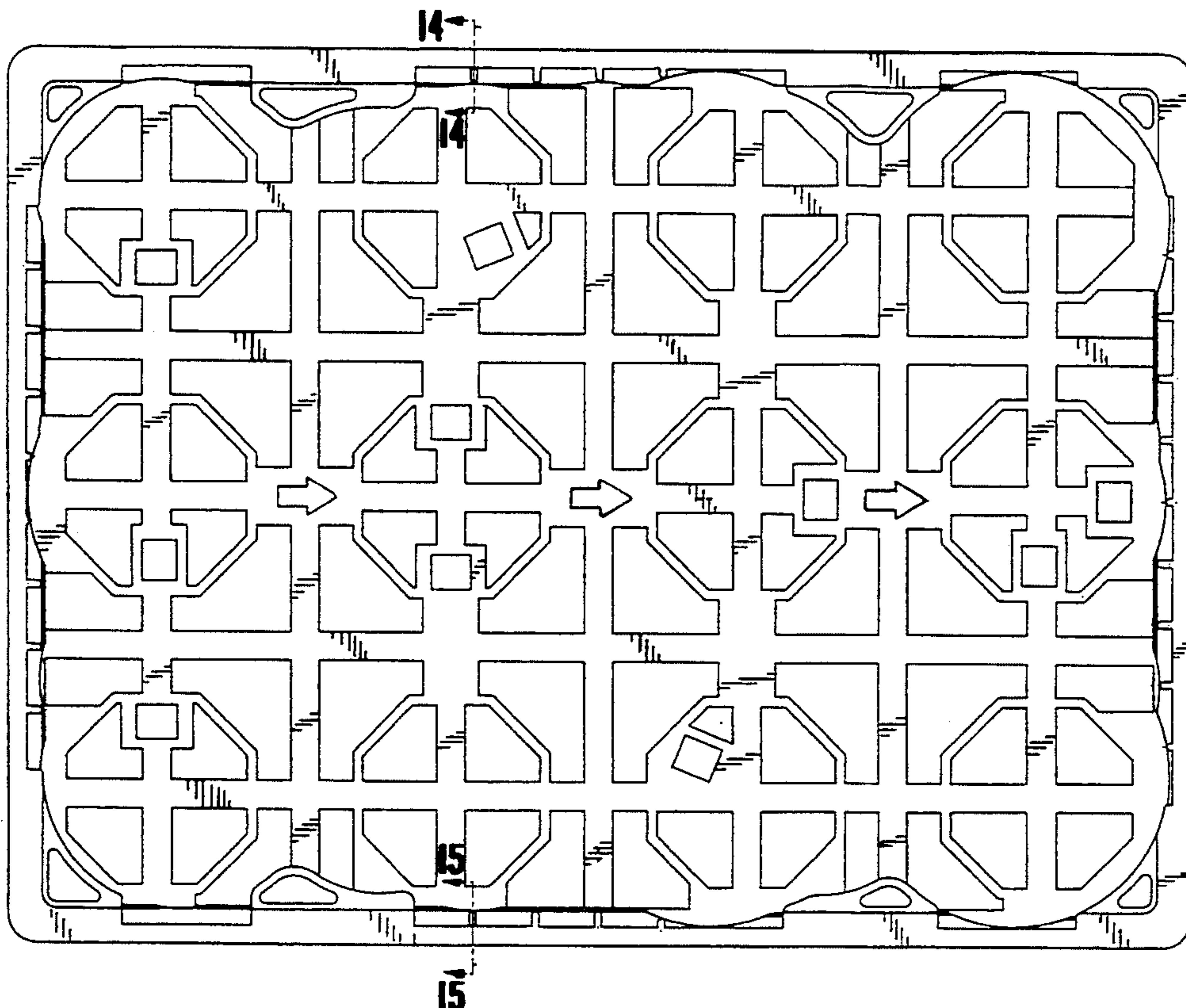

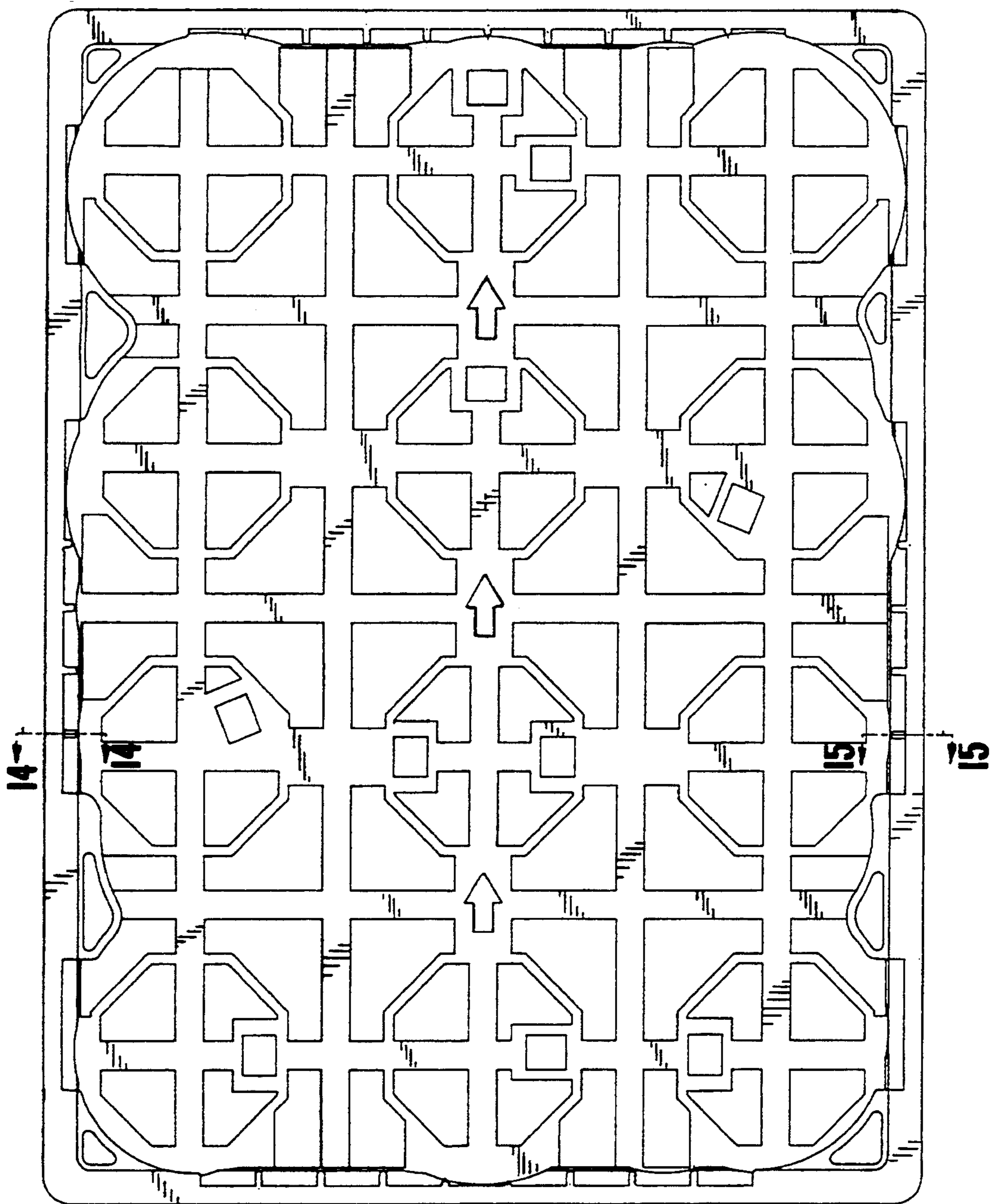

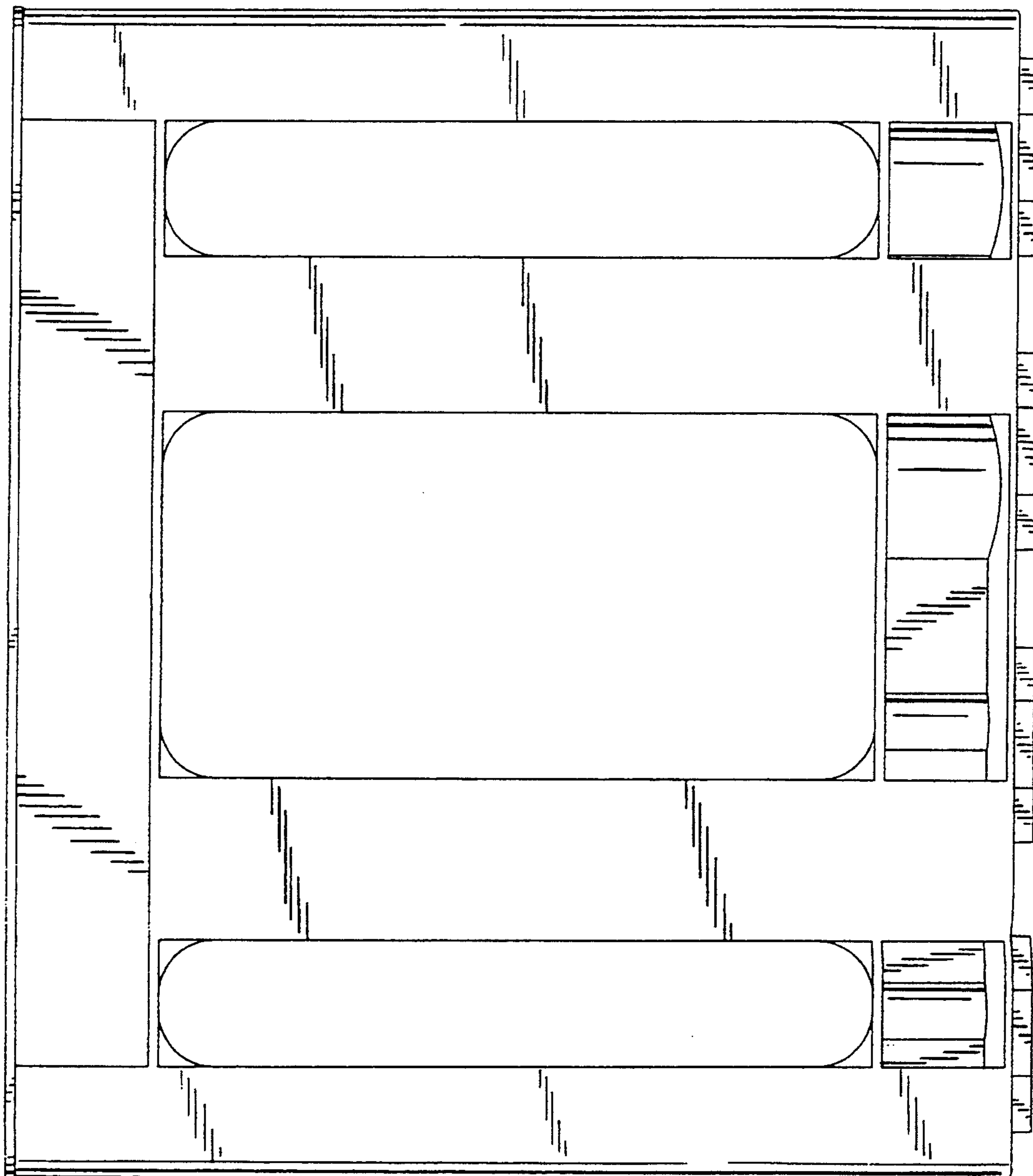

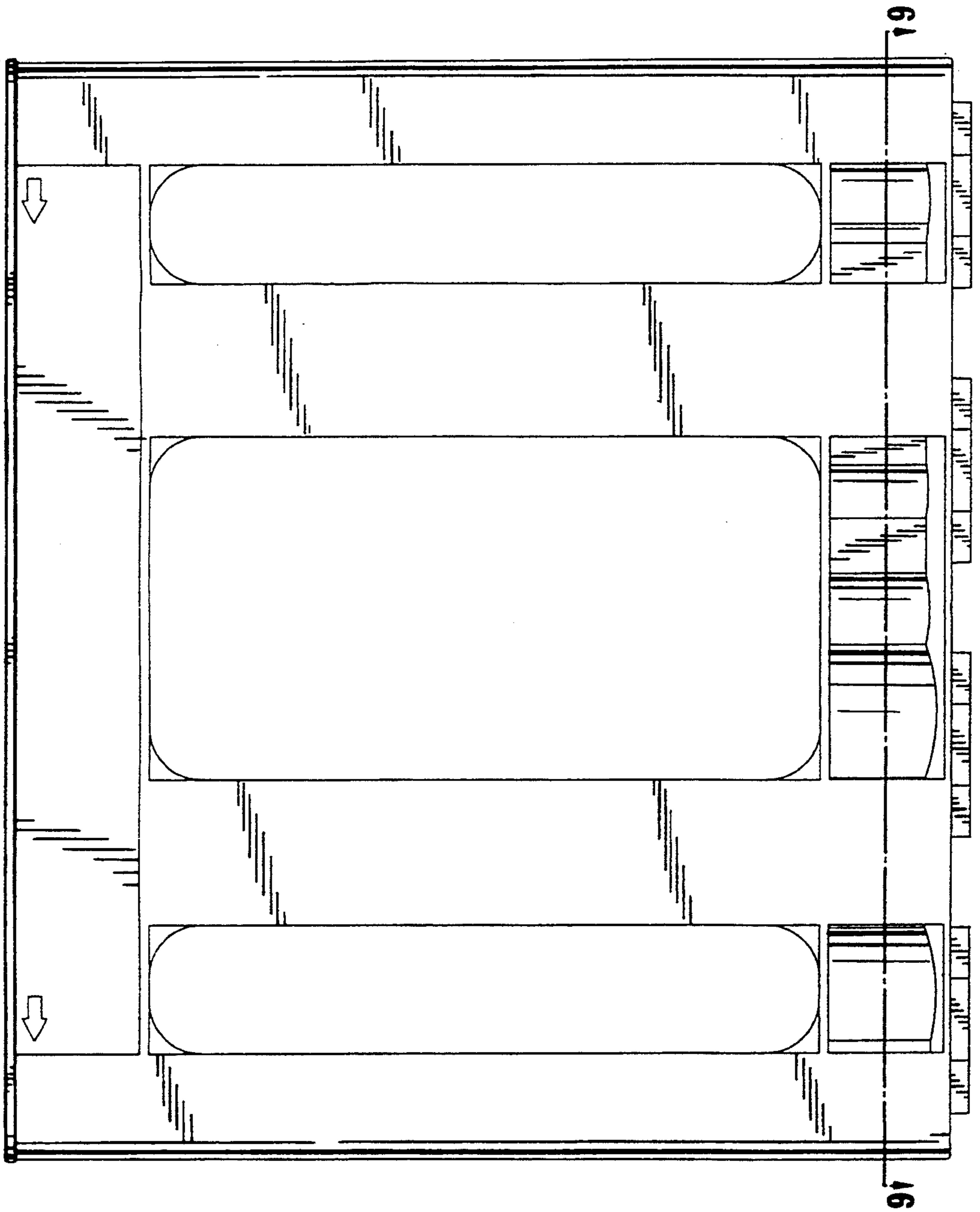

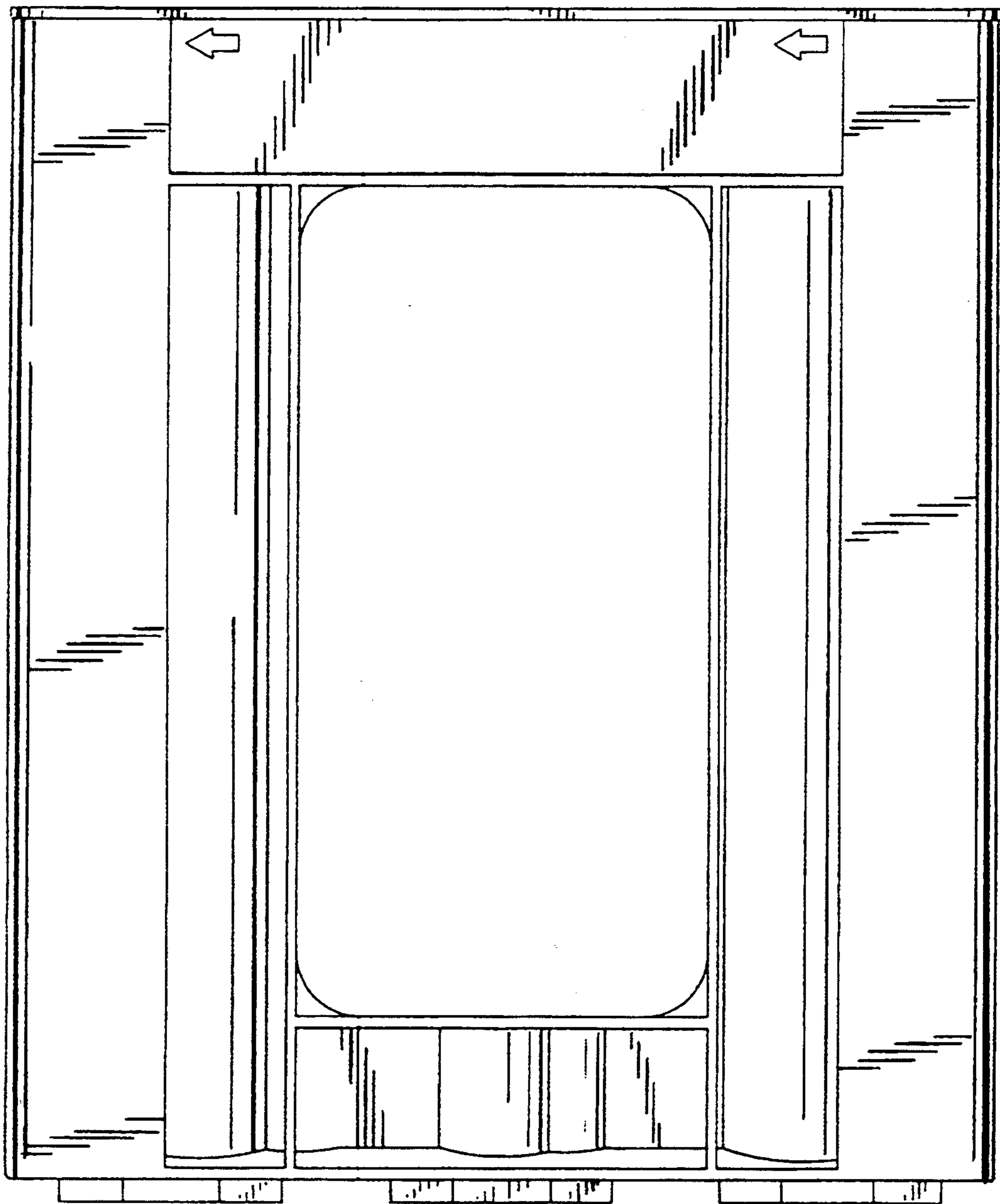

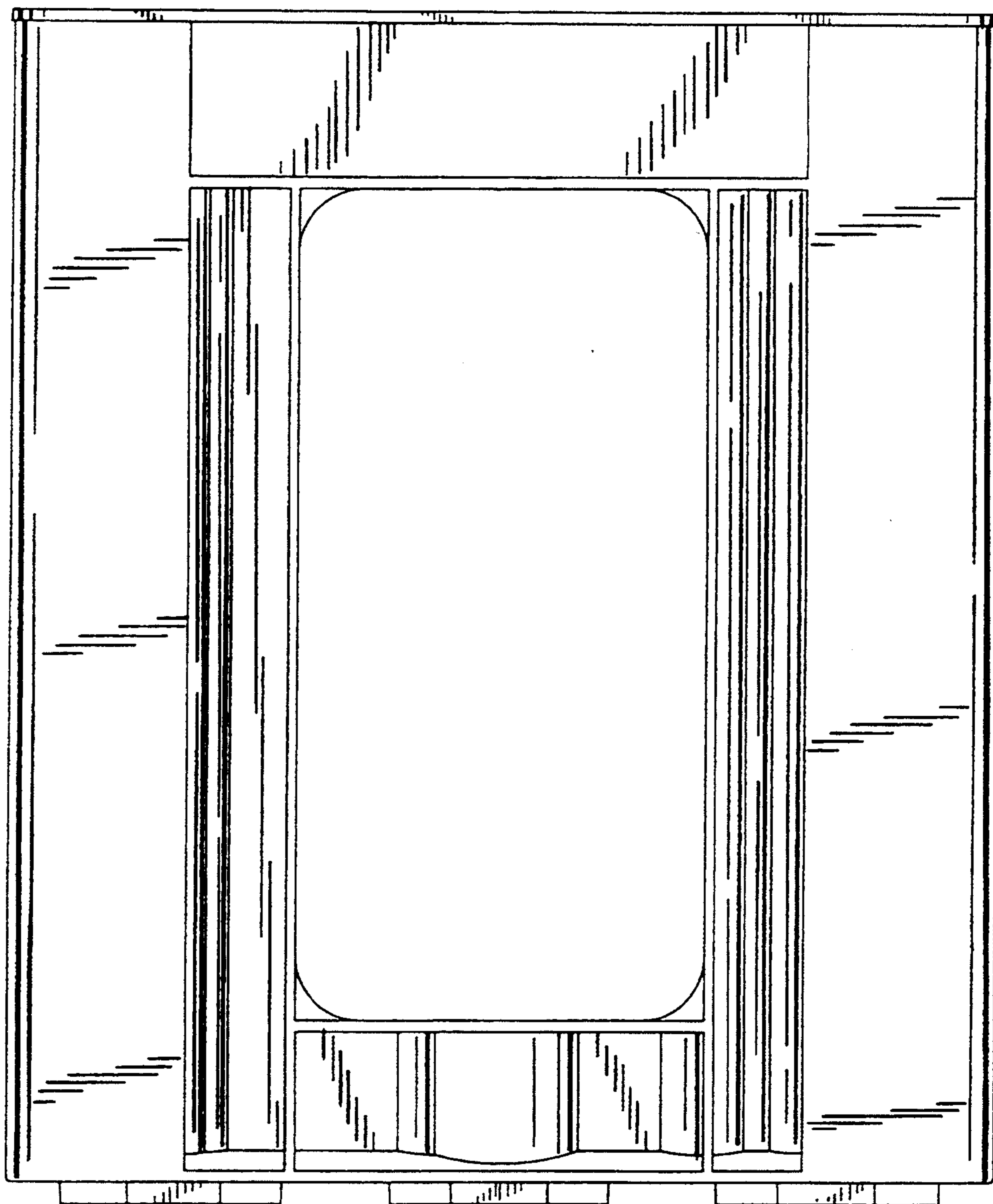

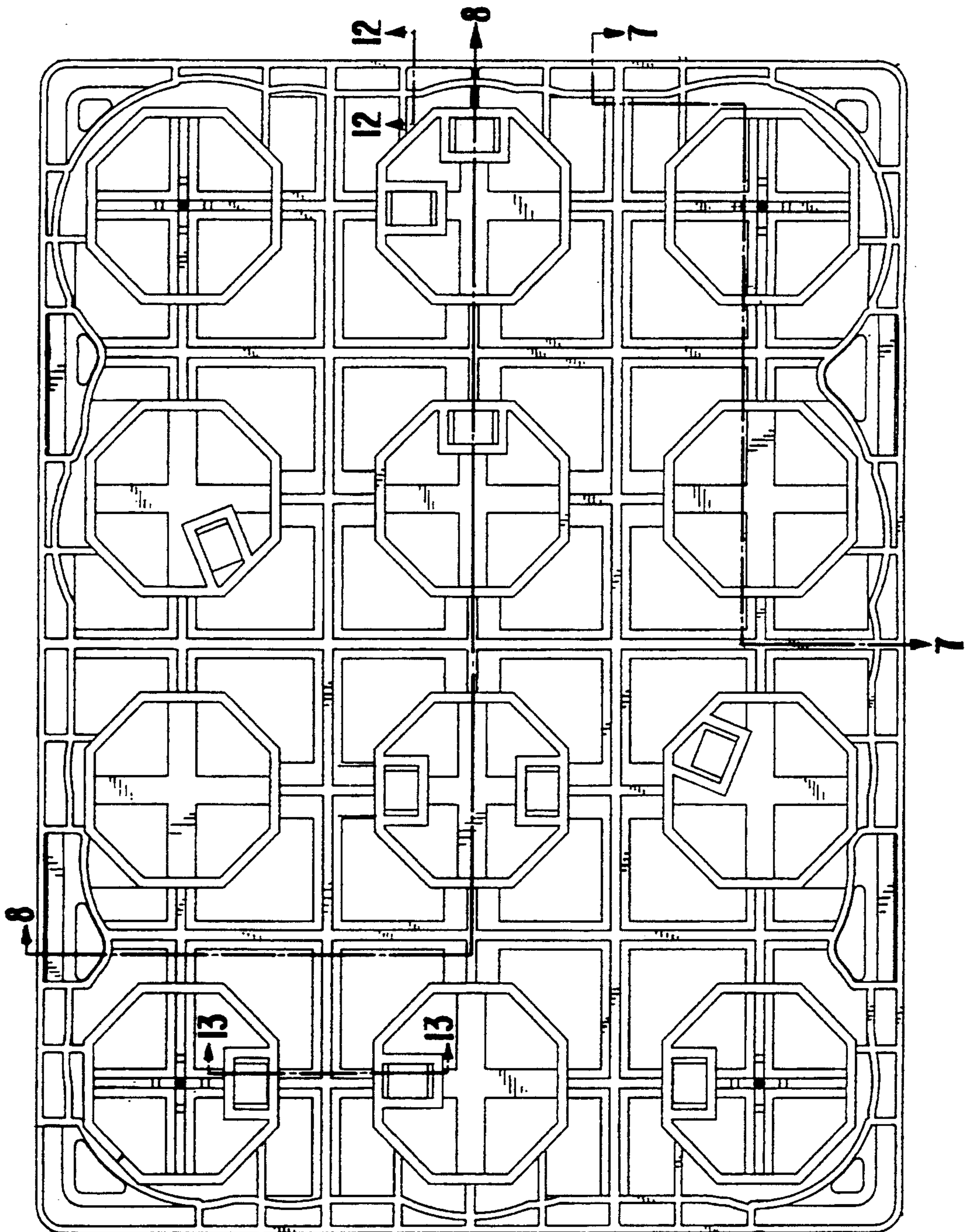

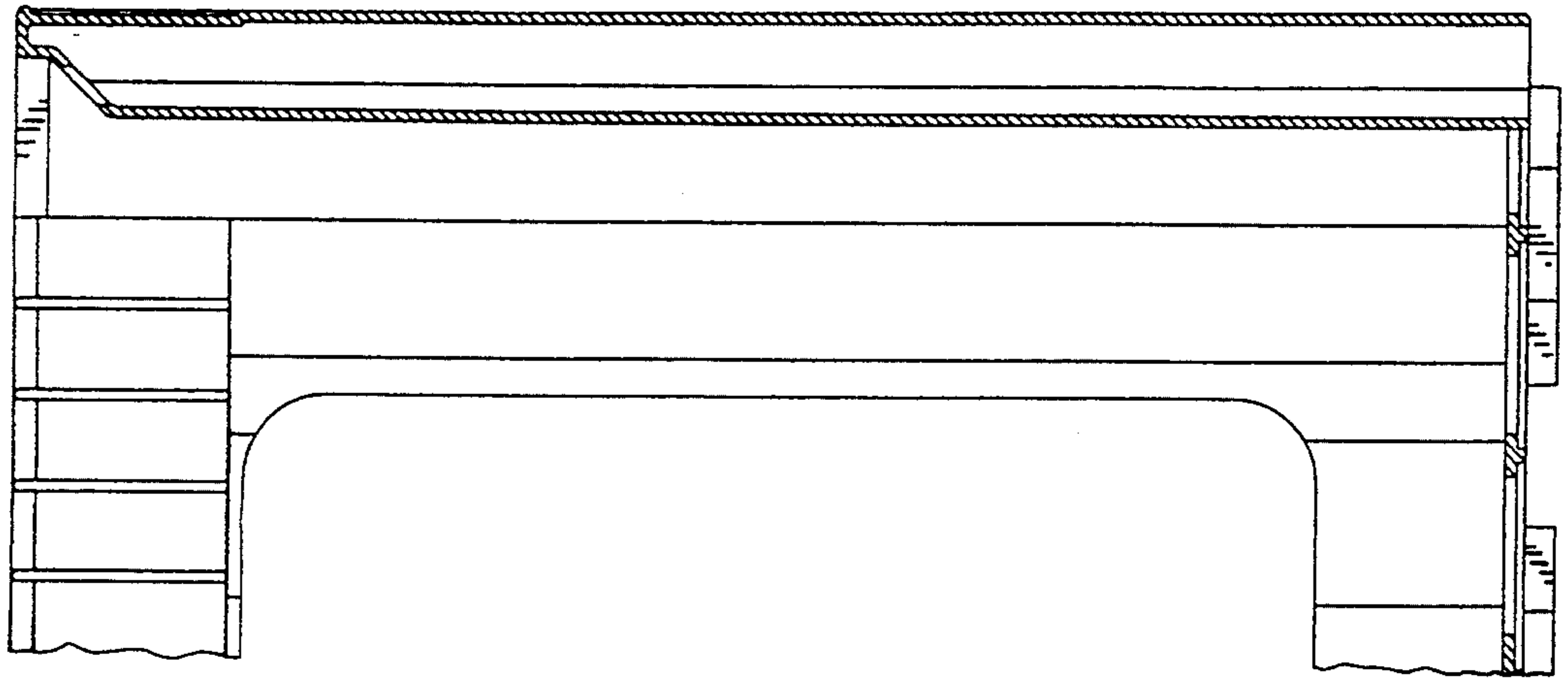

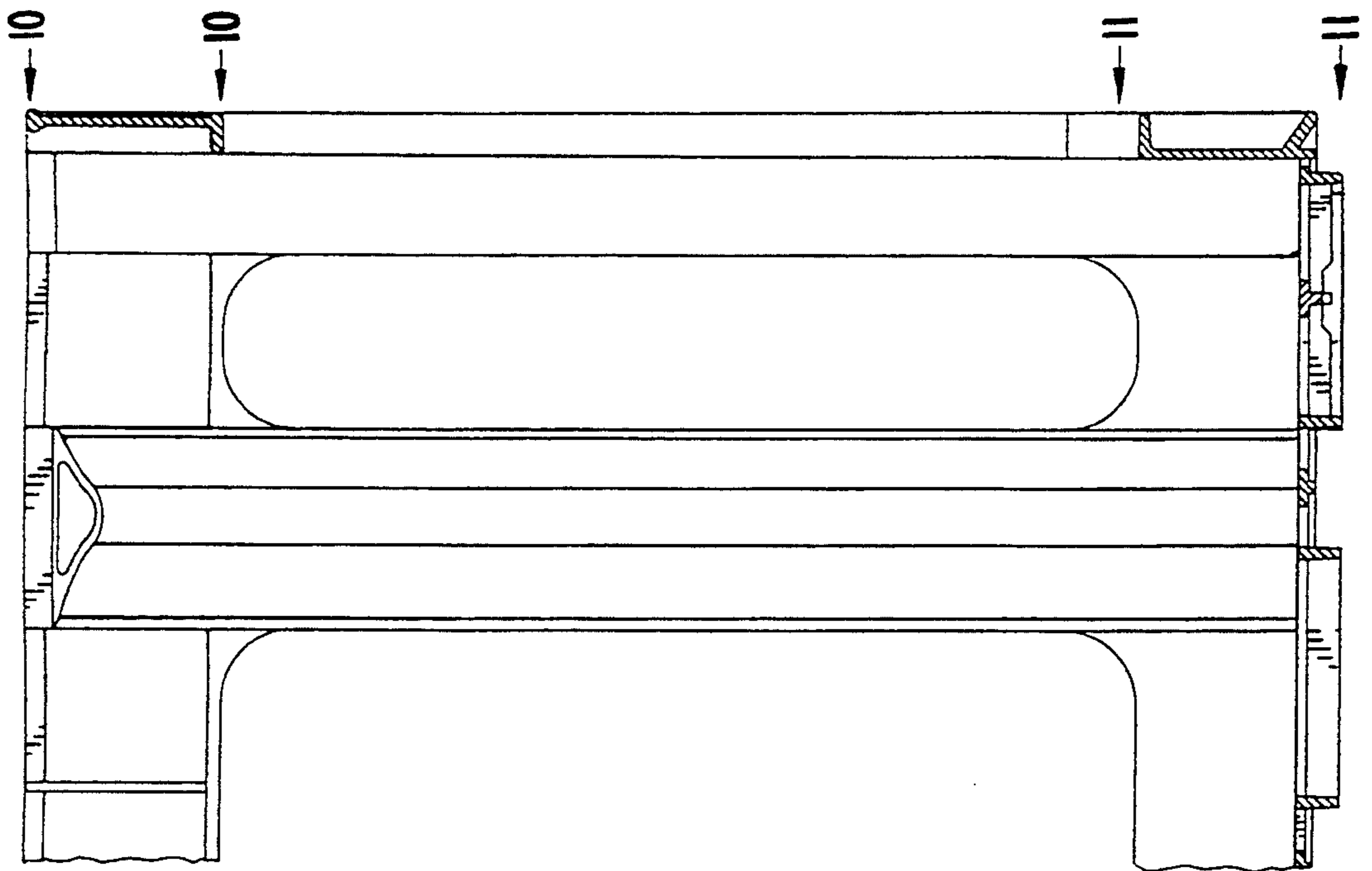

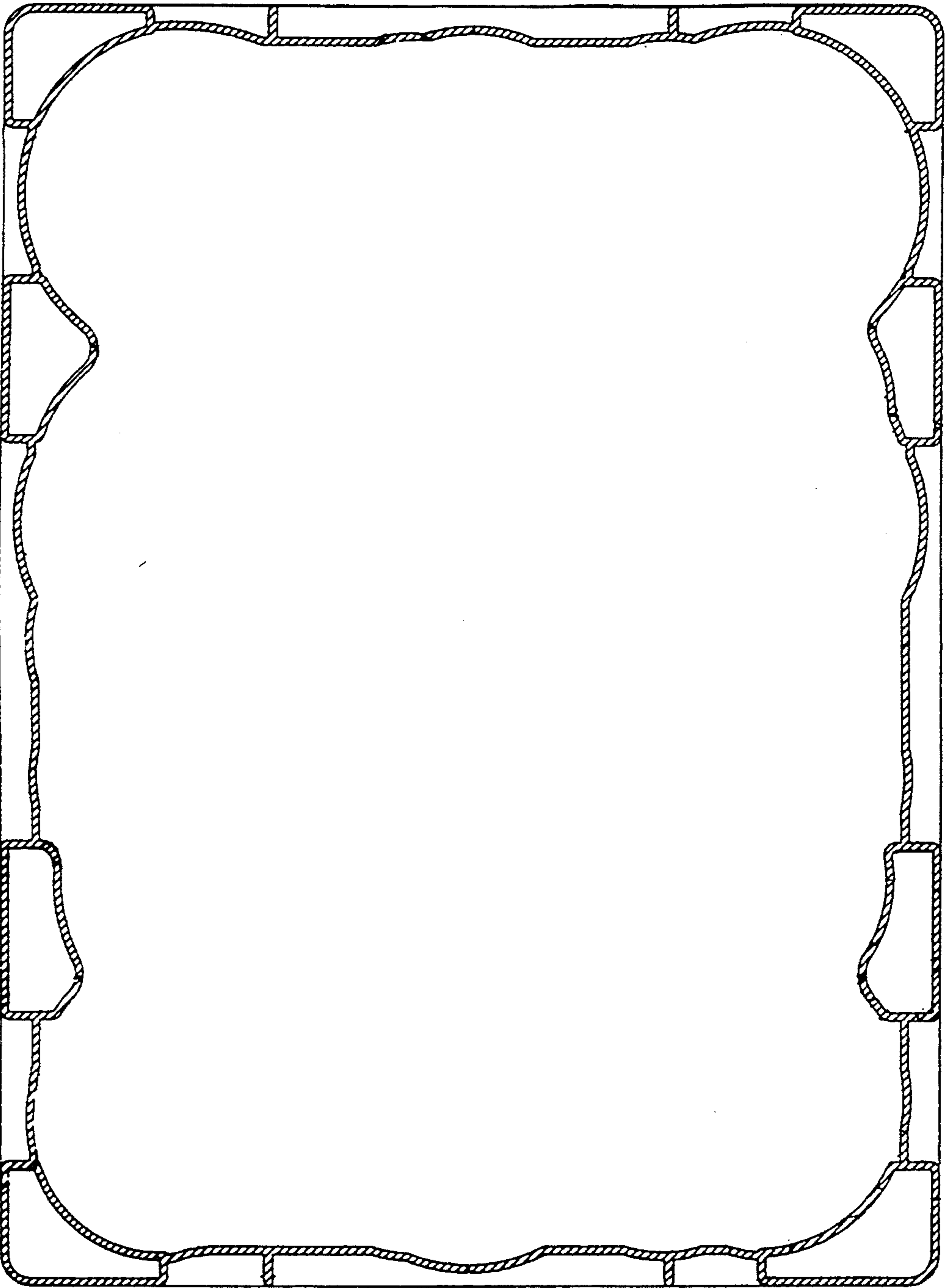

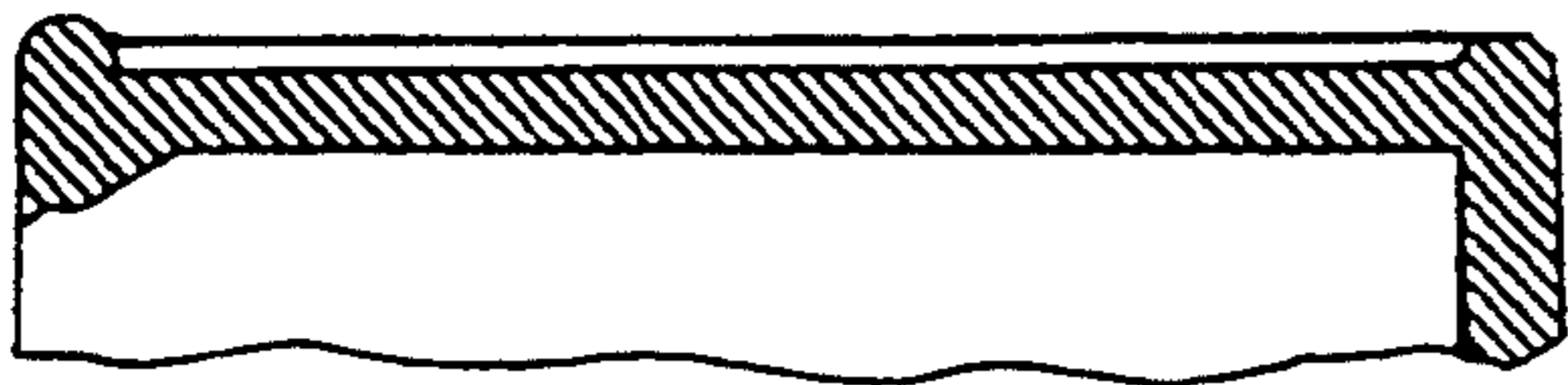

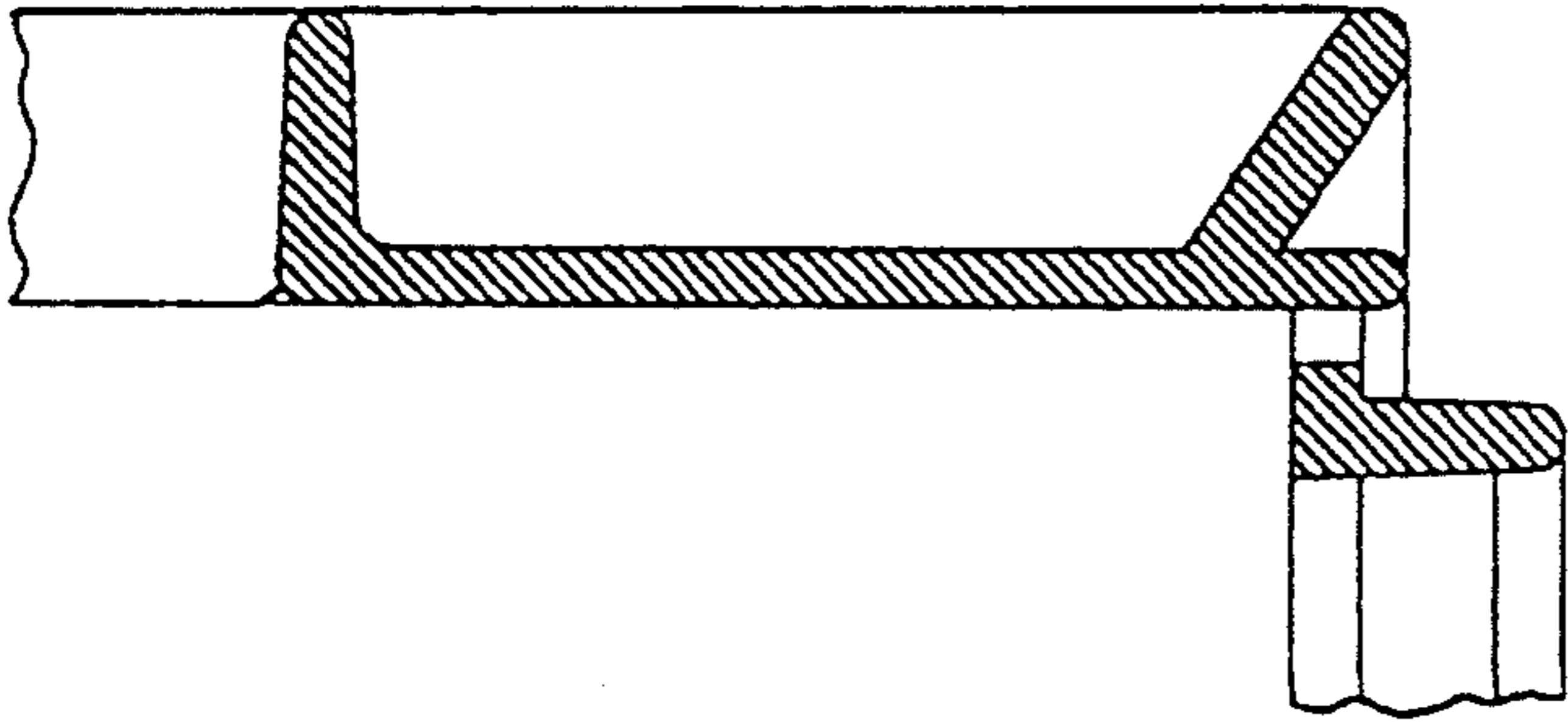

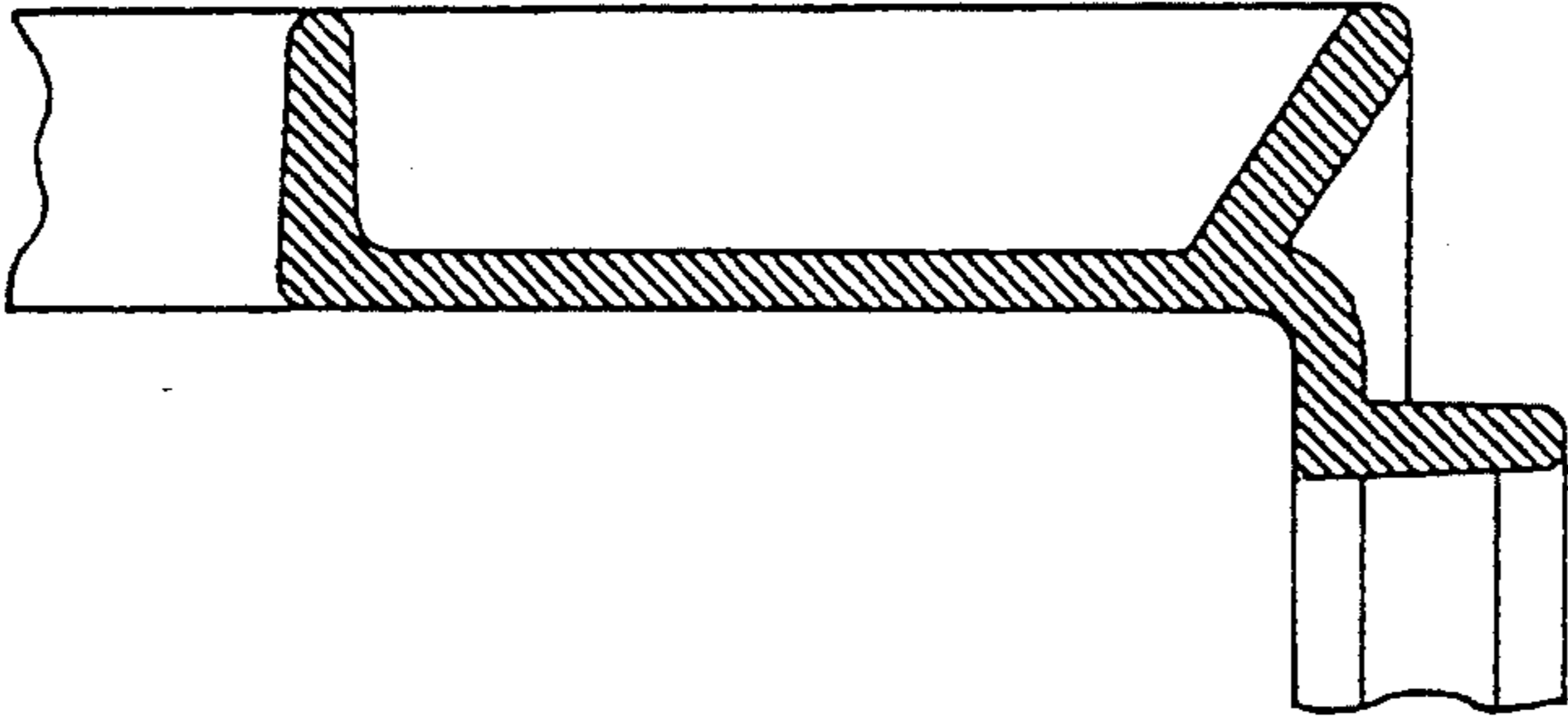

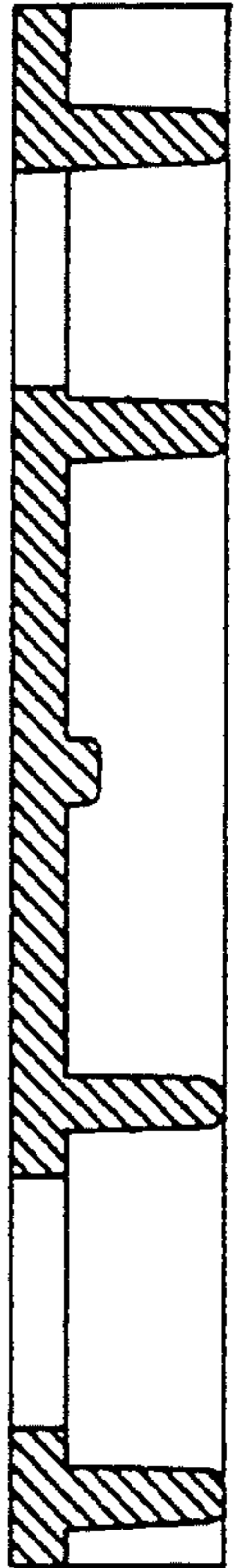
