FIG. 3 is a perspective view thereof; with the flexible container shown in fully folded position;

FIG. 4 is a reduced scale front elevational view of FIG. 1;

FIG. 5 is a reduced scale rear elevational view of FIG. 1;

FIG. 6 is a reduced scale left side elevational view FIG. 1;

FIG. 7 is a reduced scale right side elevational view FIG. 1;

FIG. 8 is a reduced scale top plan view of FIG. 1;

FIG. 9 is a reduced scale bottom plan view of FIG. 1;

FIG. 10 is a left side elevational view of FIG. 1; similar to FIG. 6 but shown in an enlarged scale; the right side elevational view being a mirror image thereof;

FIG. 11 is a left side elevational view of FIG. 2; the right side elevational view being a mirror image thereof;

FIG. 12 is a left side elevational view of FIG. 3; the right side elevational view being a mirror image thereof;

FIG. 13 is a reduced scale front elevational view of FIG. 12; and,

FIG. 14 is a reduced scale rear elevational view of FIG. 12.

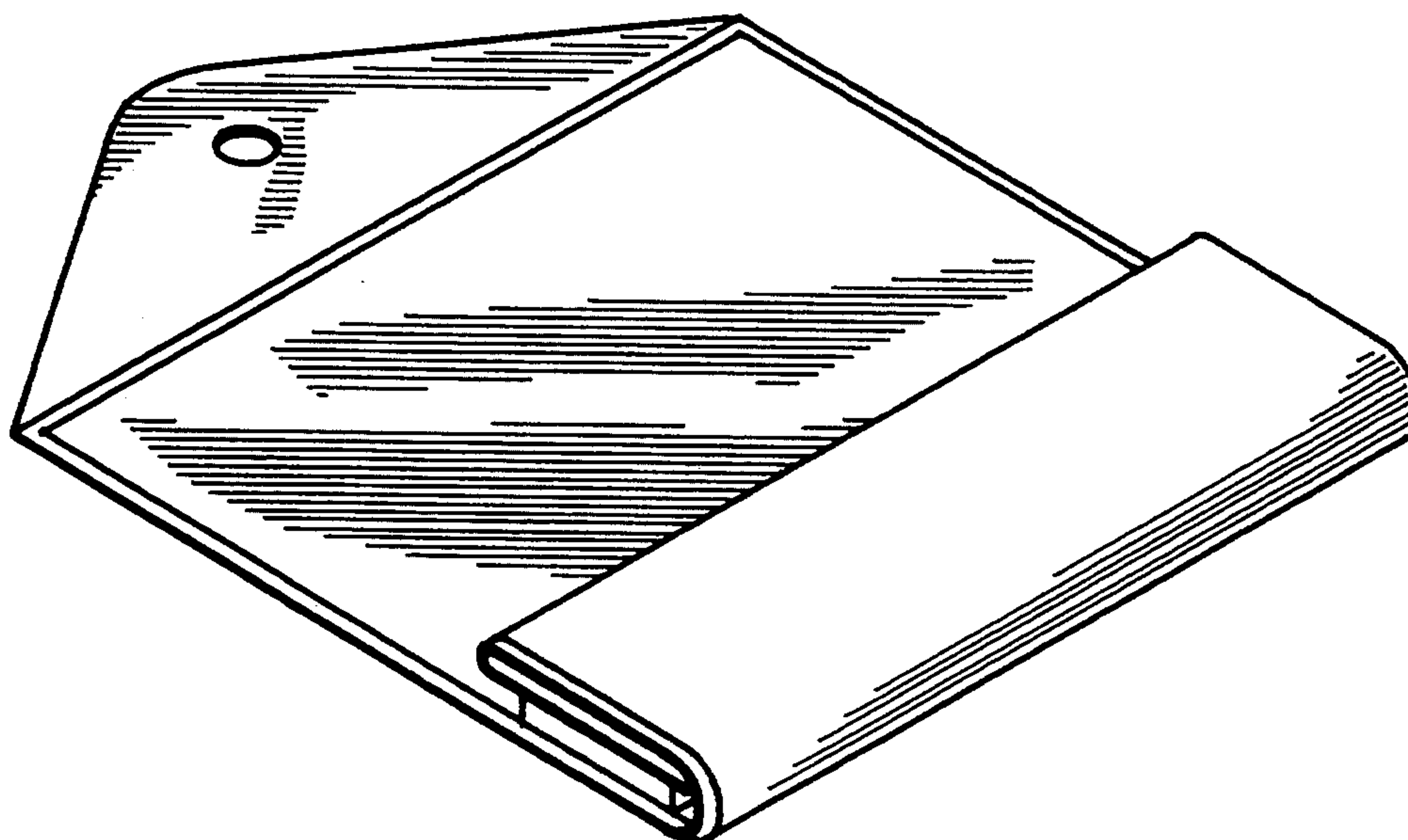

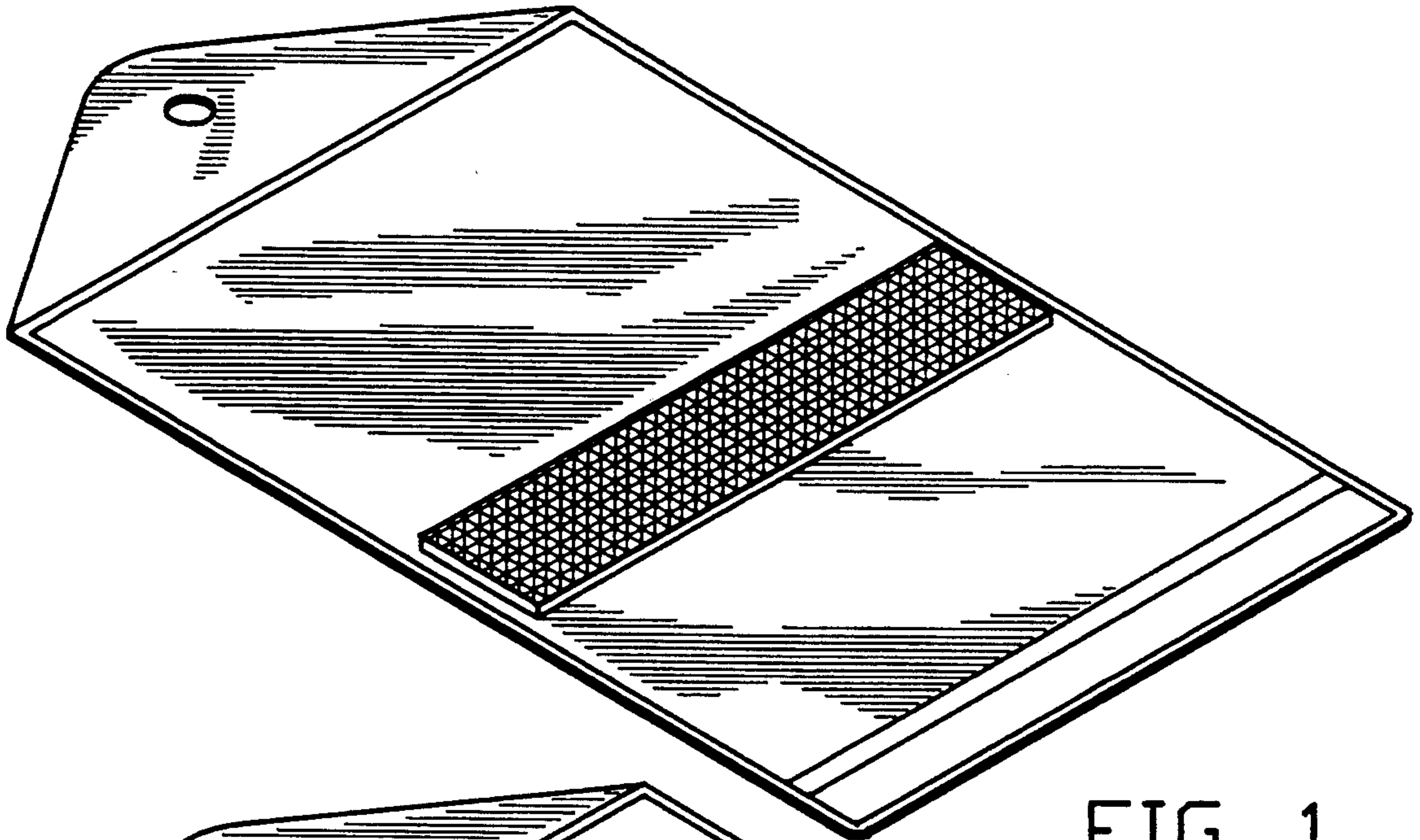

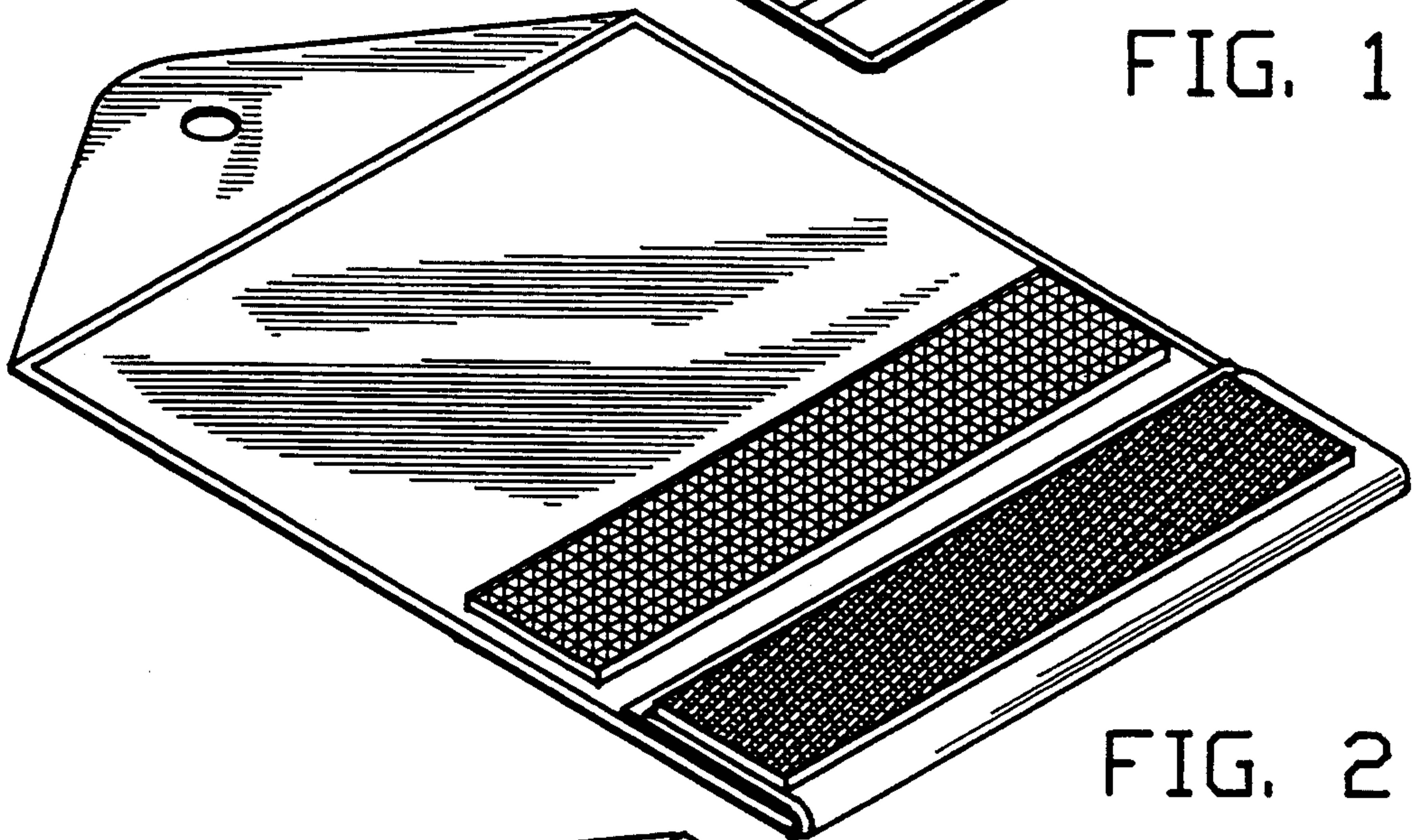

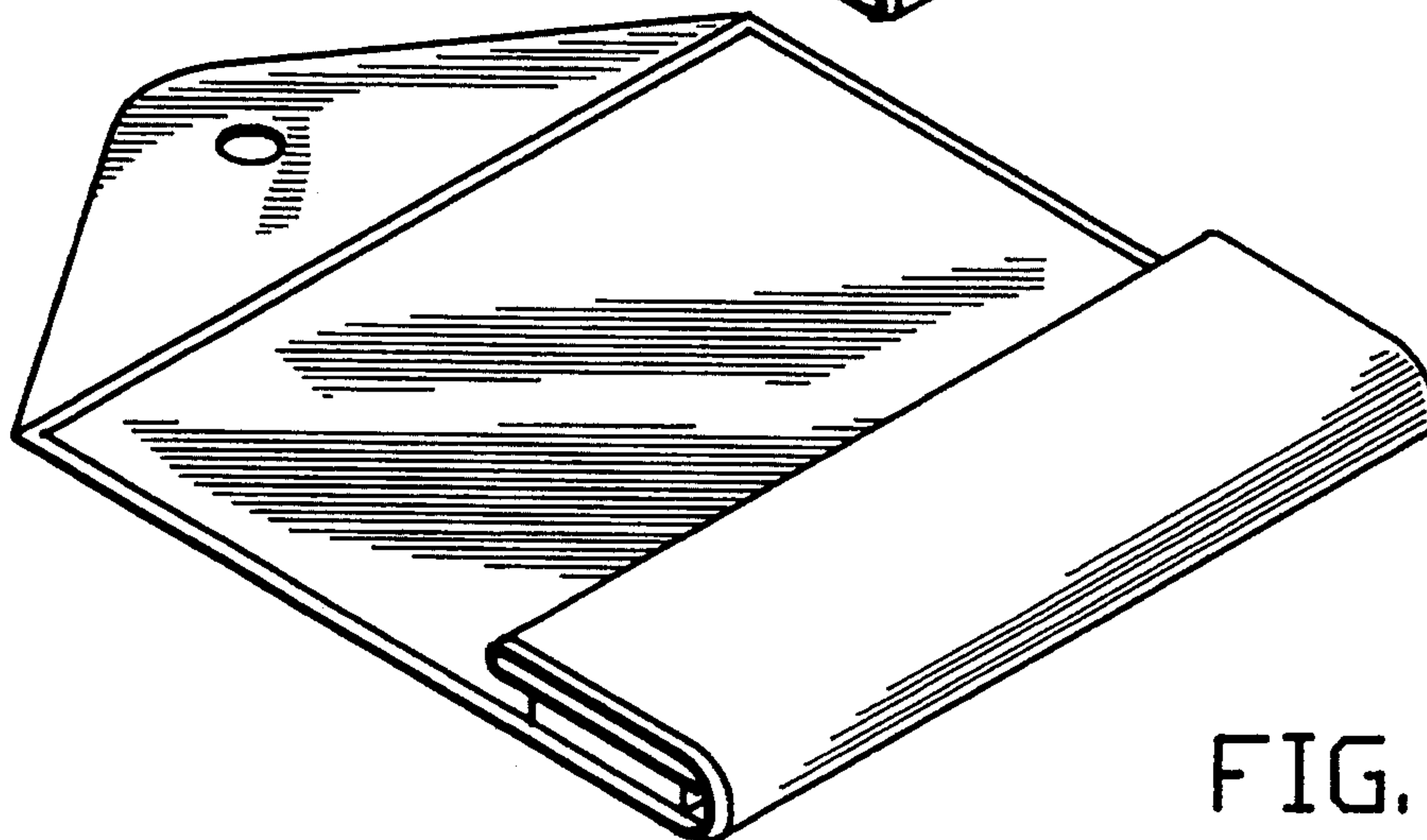

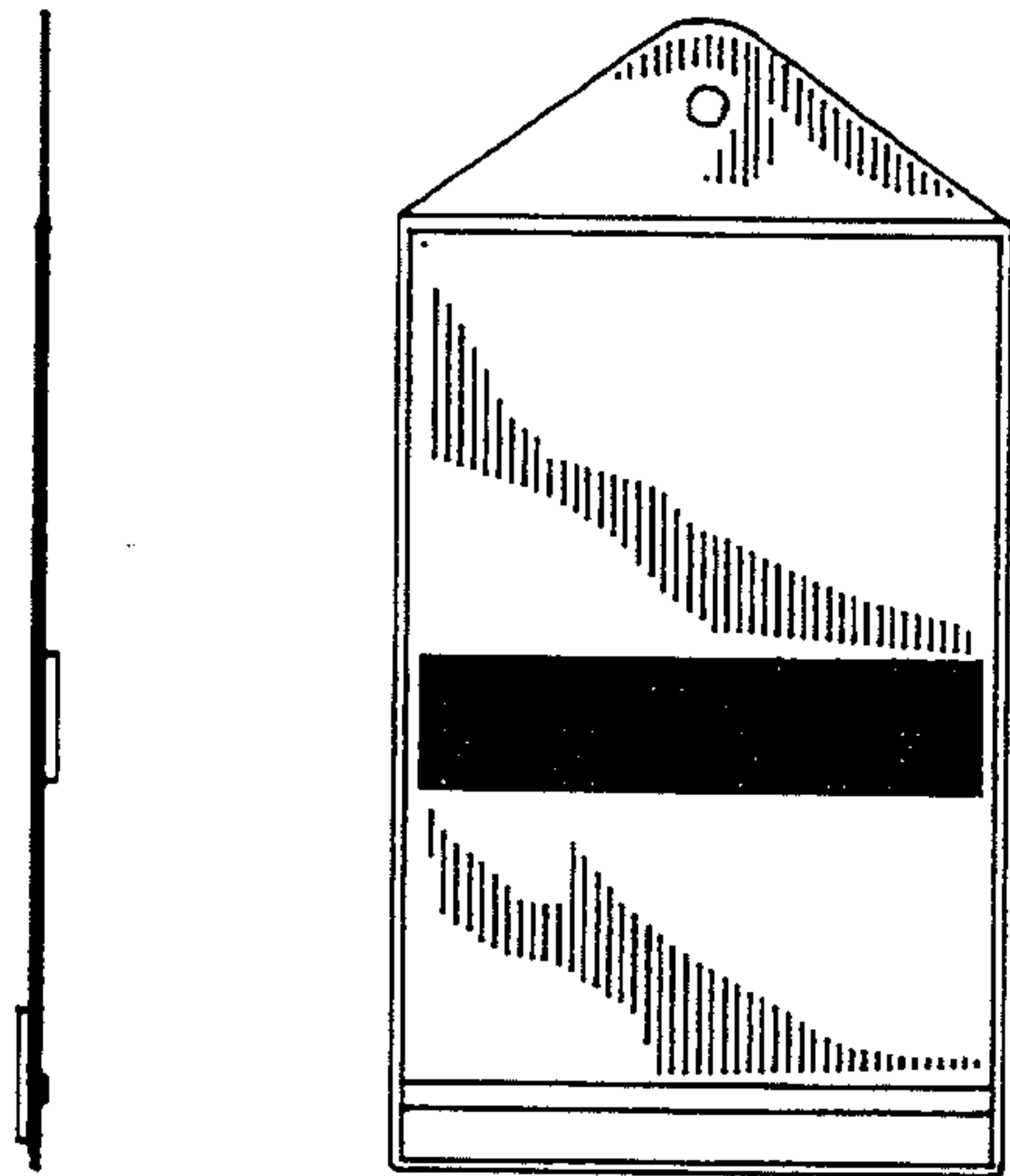

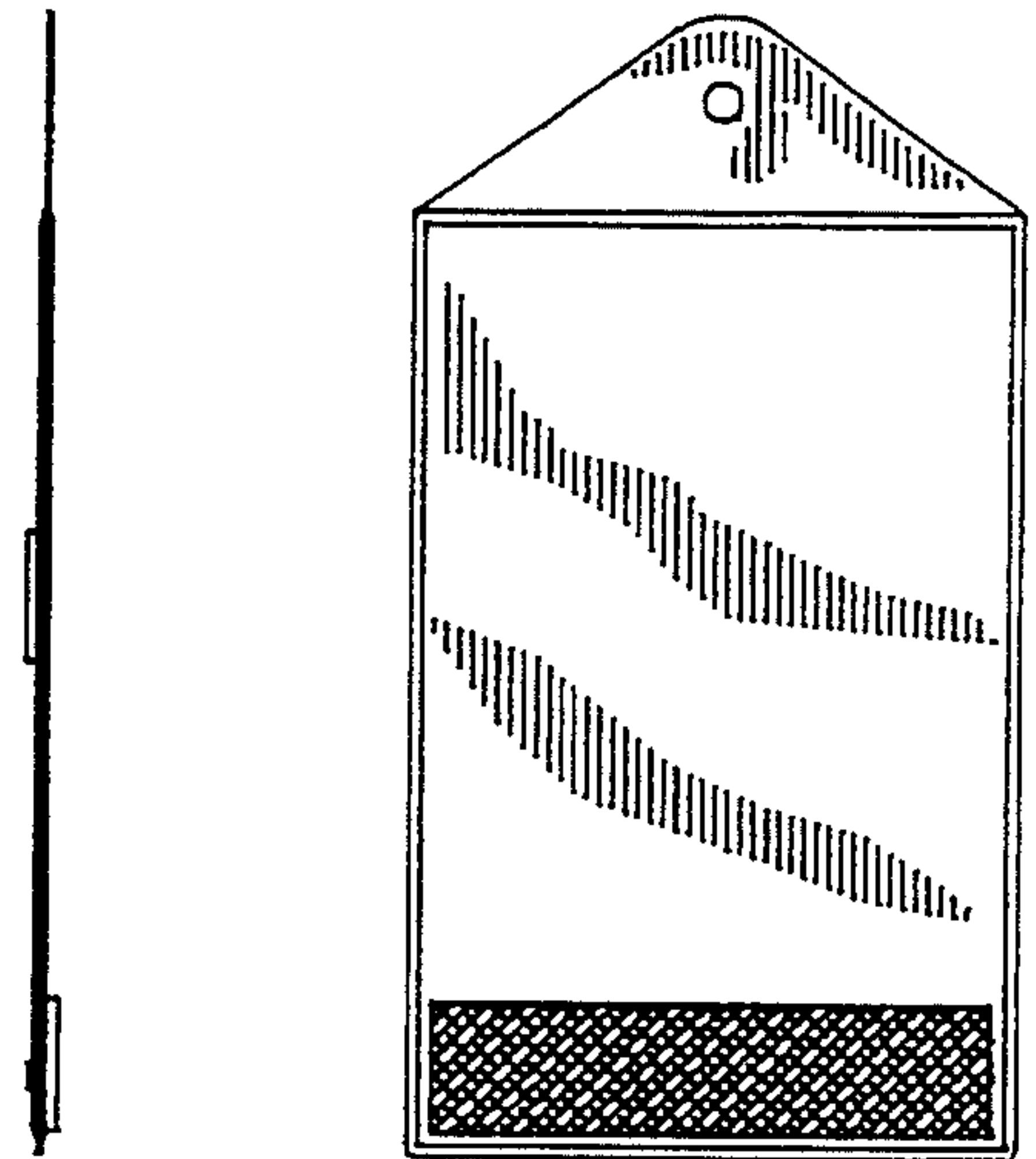

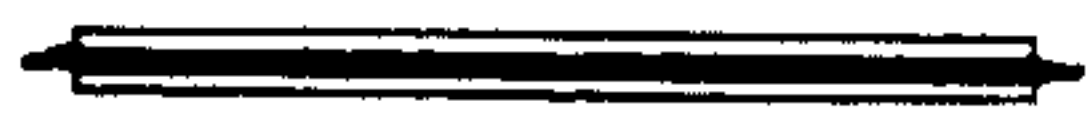

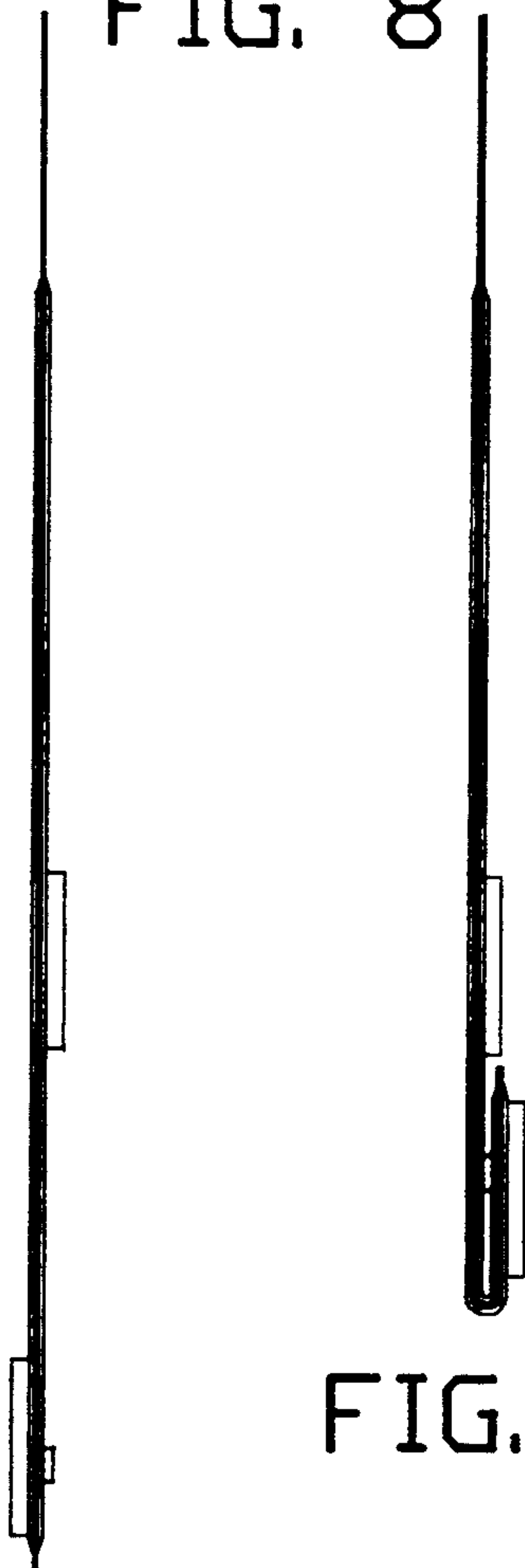

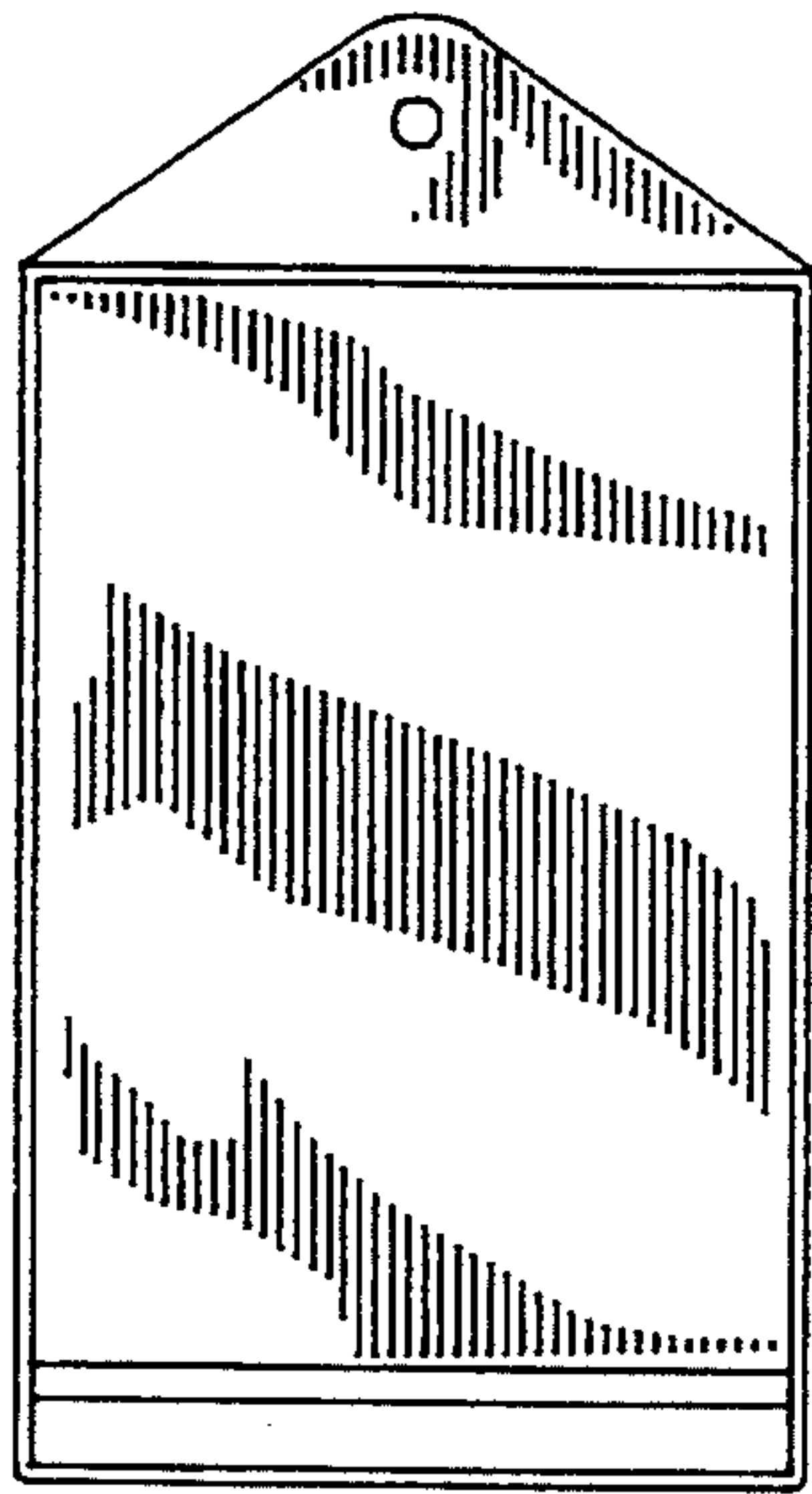

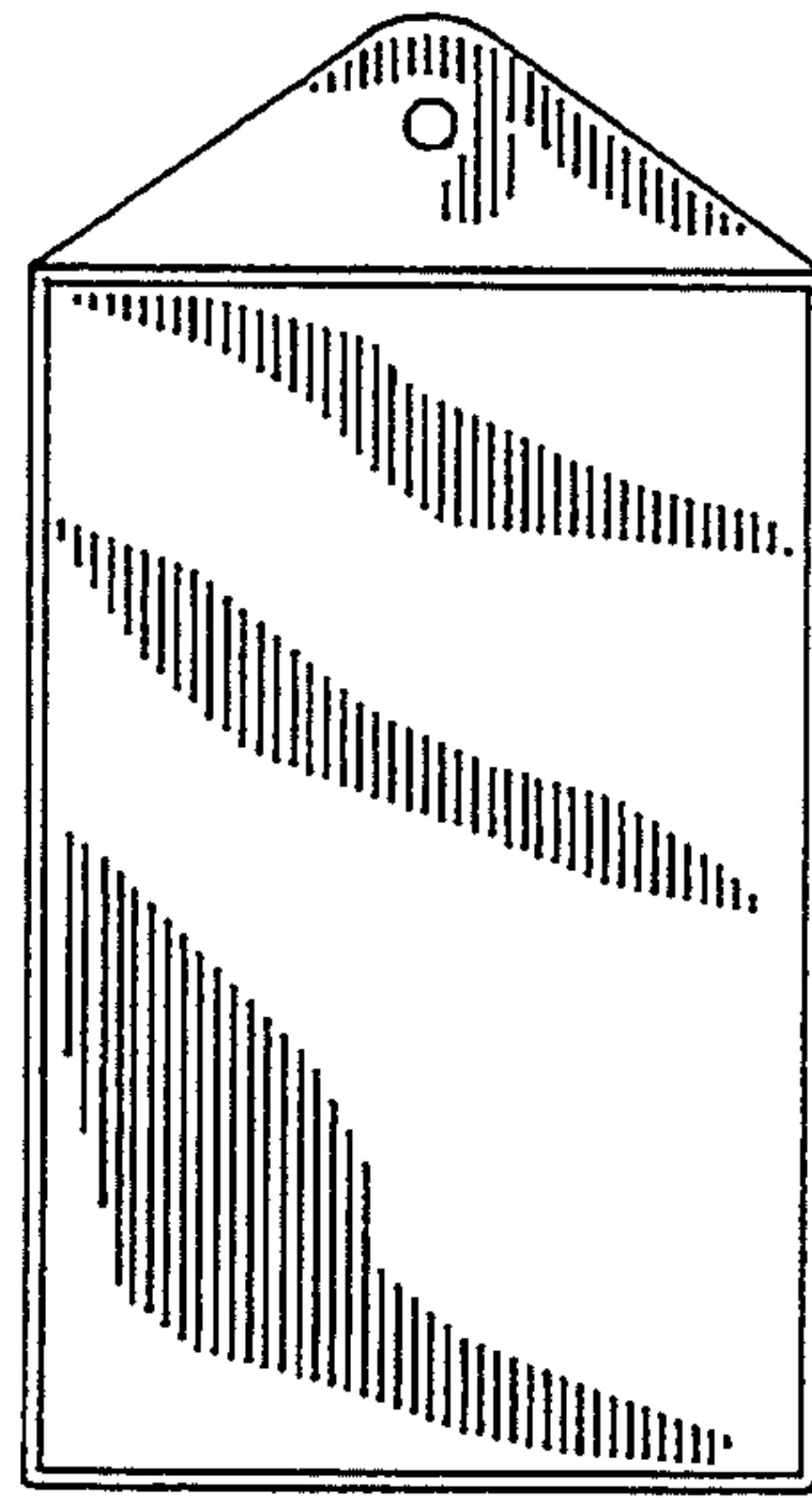
