[57] **CLAIM**

The ornamental design for a 35 mm camera as shown and described.

DESCRIPTION

FIG. 1 is a front, top and right side perspective view of a 35 mm camera showing my new design; FIG. 2 is a front elevational view thereof; FIG. 3 is a top plan view thereof; FIG. 4 is a left side elevational view thereof; FIG. 5 is a right side elevational view thereof; FIG. 6 is a rear elevational view thereof; FIG. 7 is a bottom plan view thereof; FIG. 8 is a top, plan view of a second embodiment of a 35 mm camera shown in FIG. 1; FIG. 9 is a left side elevational view thereof; FIG. 10 is a right side elevational view thereof; FIG. 11 is a rear elevational view thereof; FIG. 12 is a bottom plan view thereof; FIG. 13 is a front, top and right side perspective view thereof with the lens system retracted; and, FIG. 14 is a similar perspective view thereof with the lens system projected forwardly.

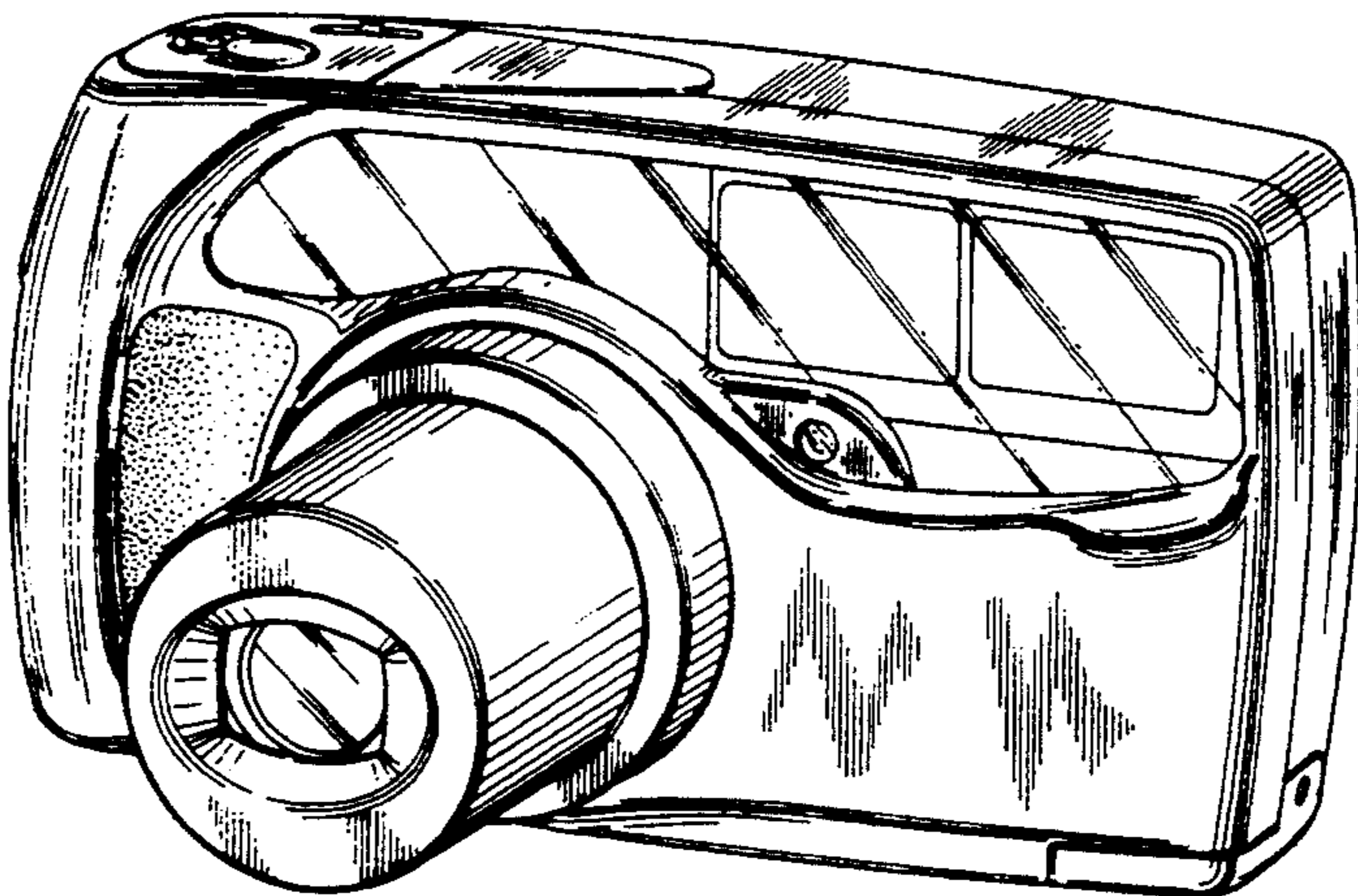
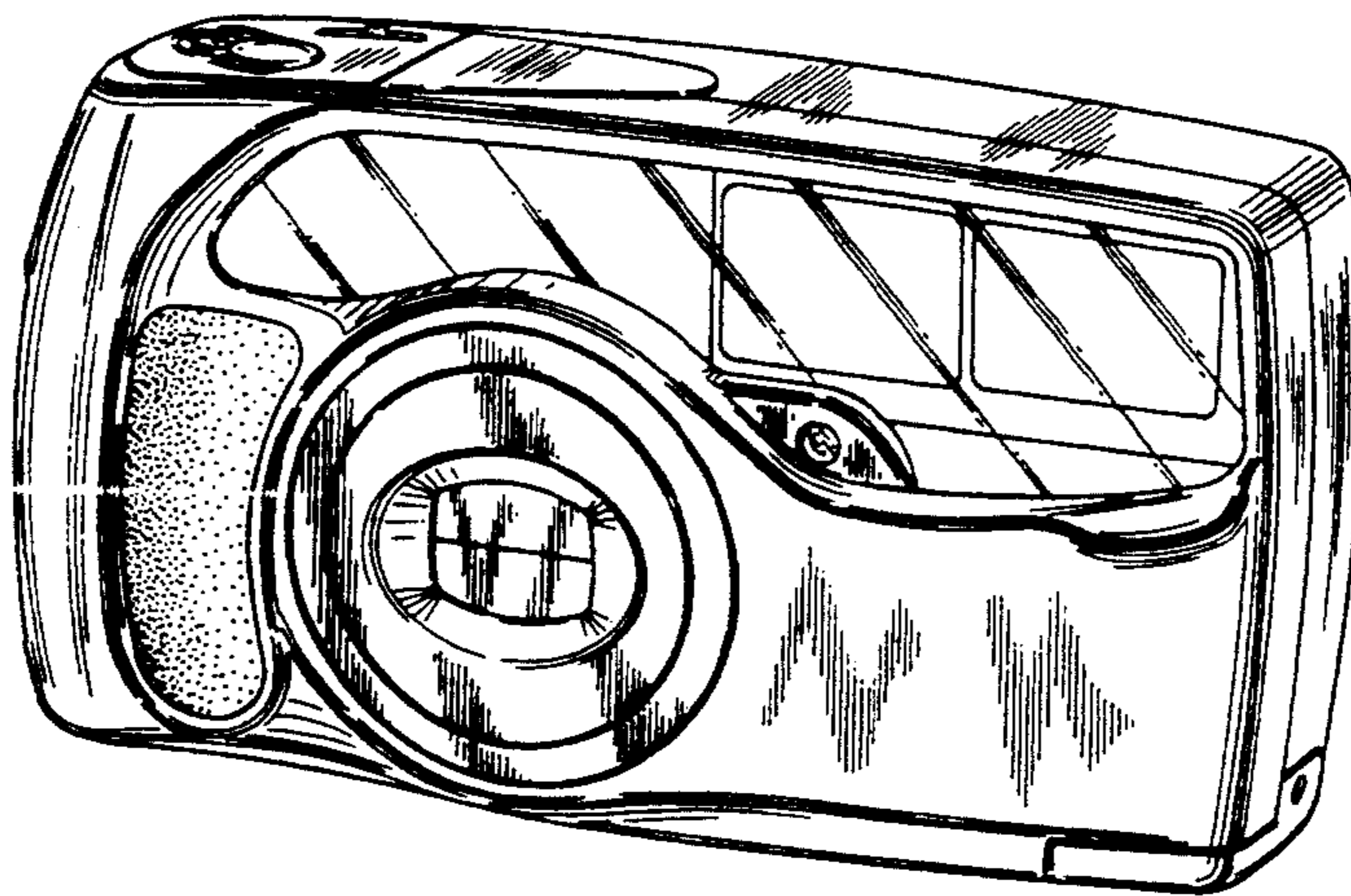

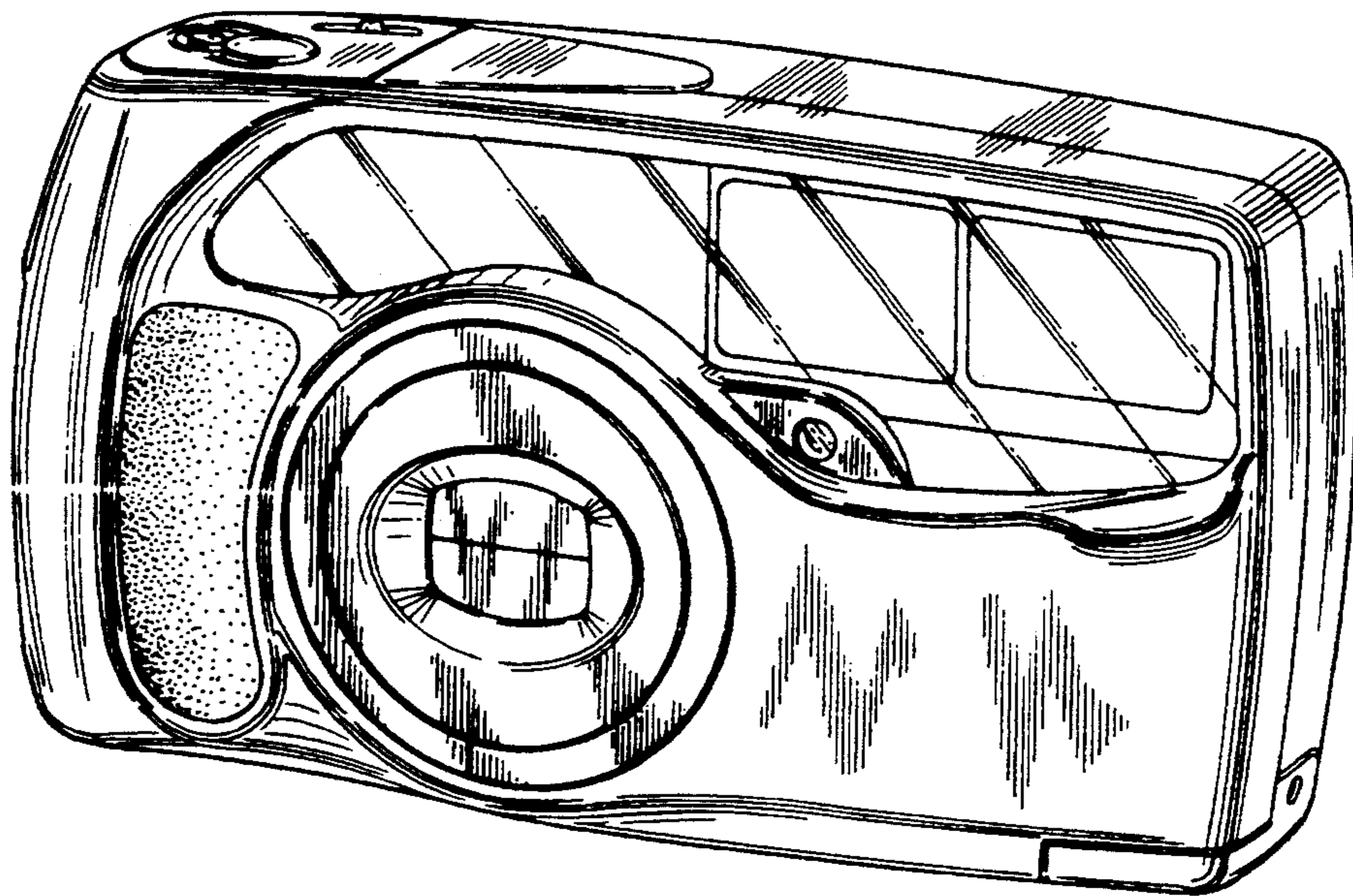

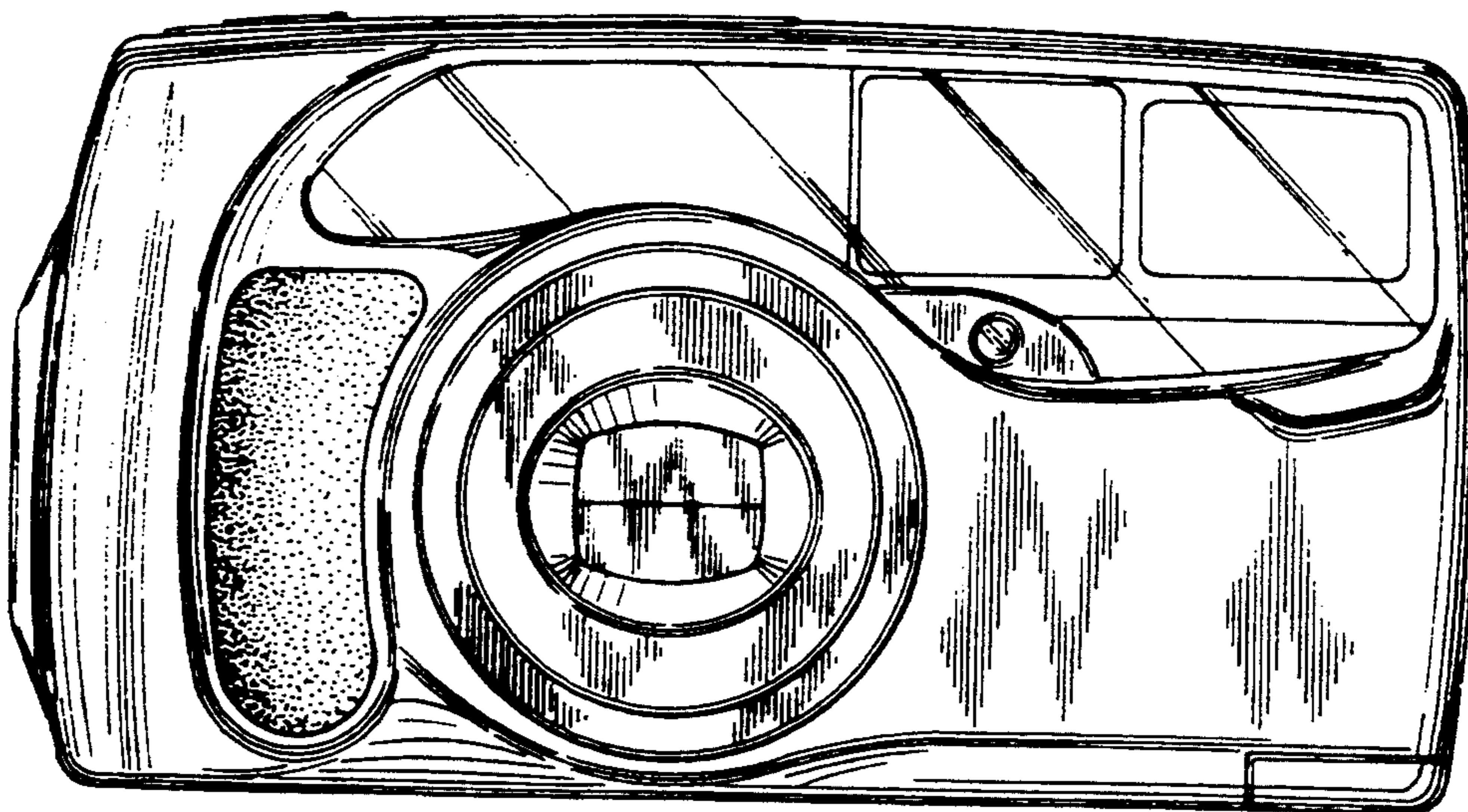

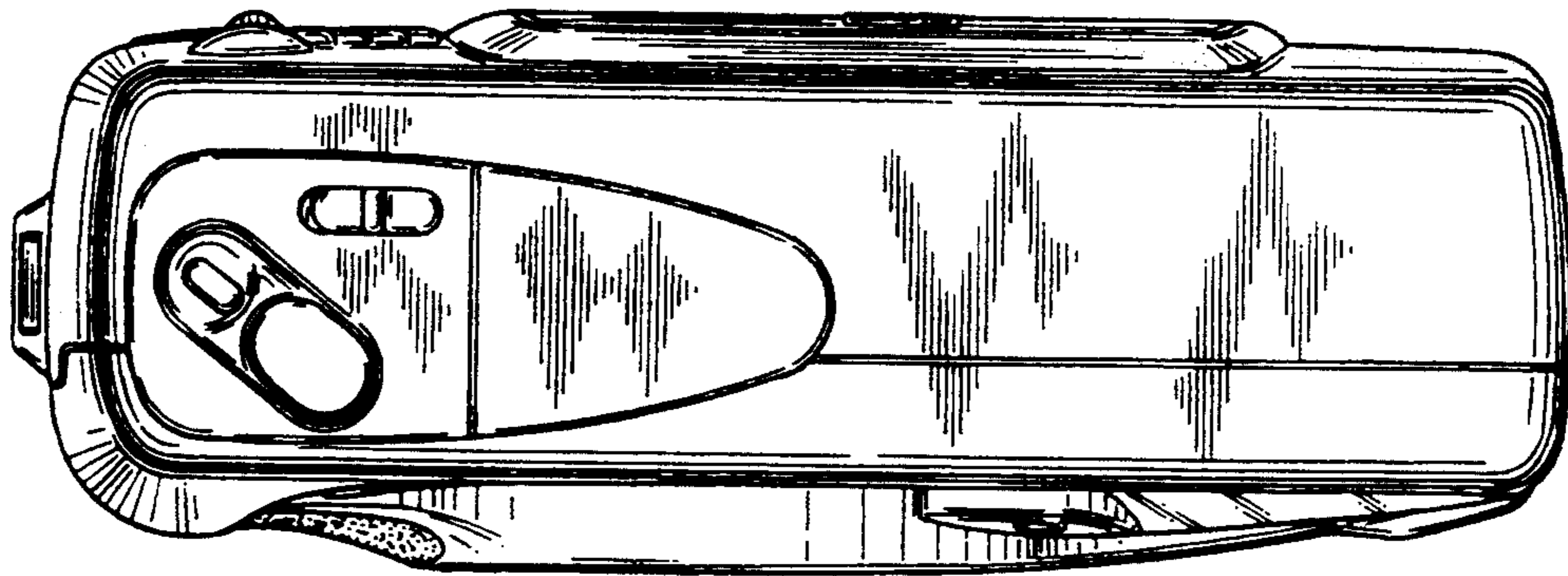

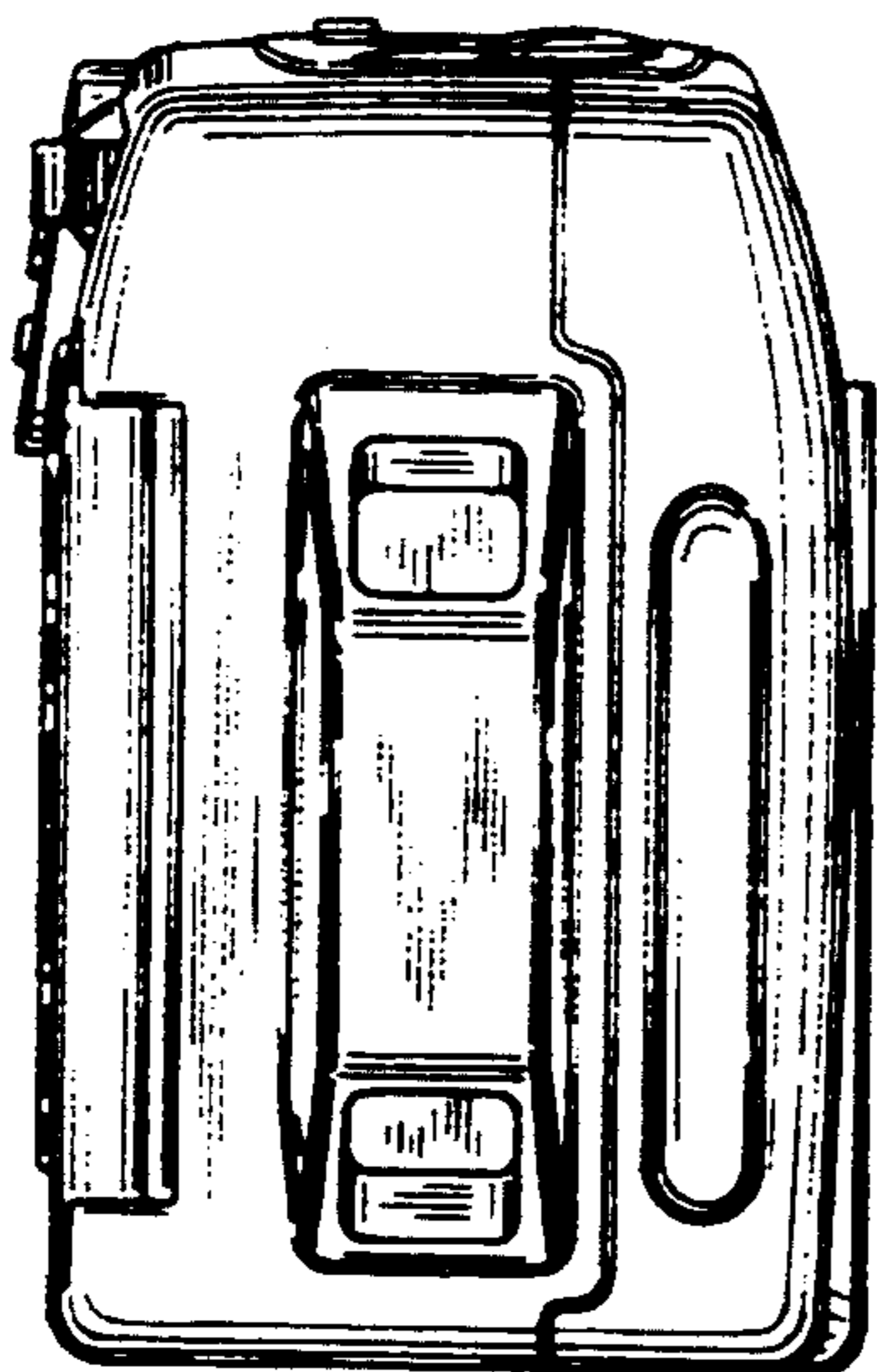

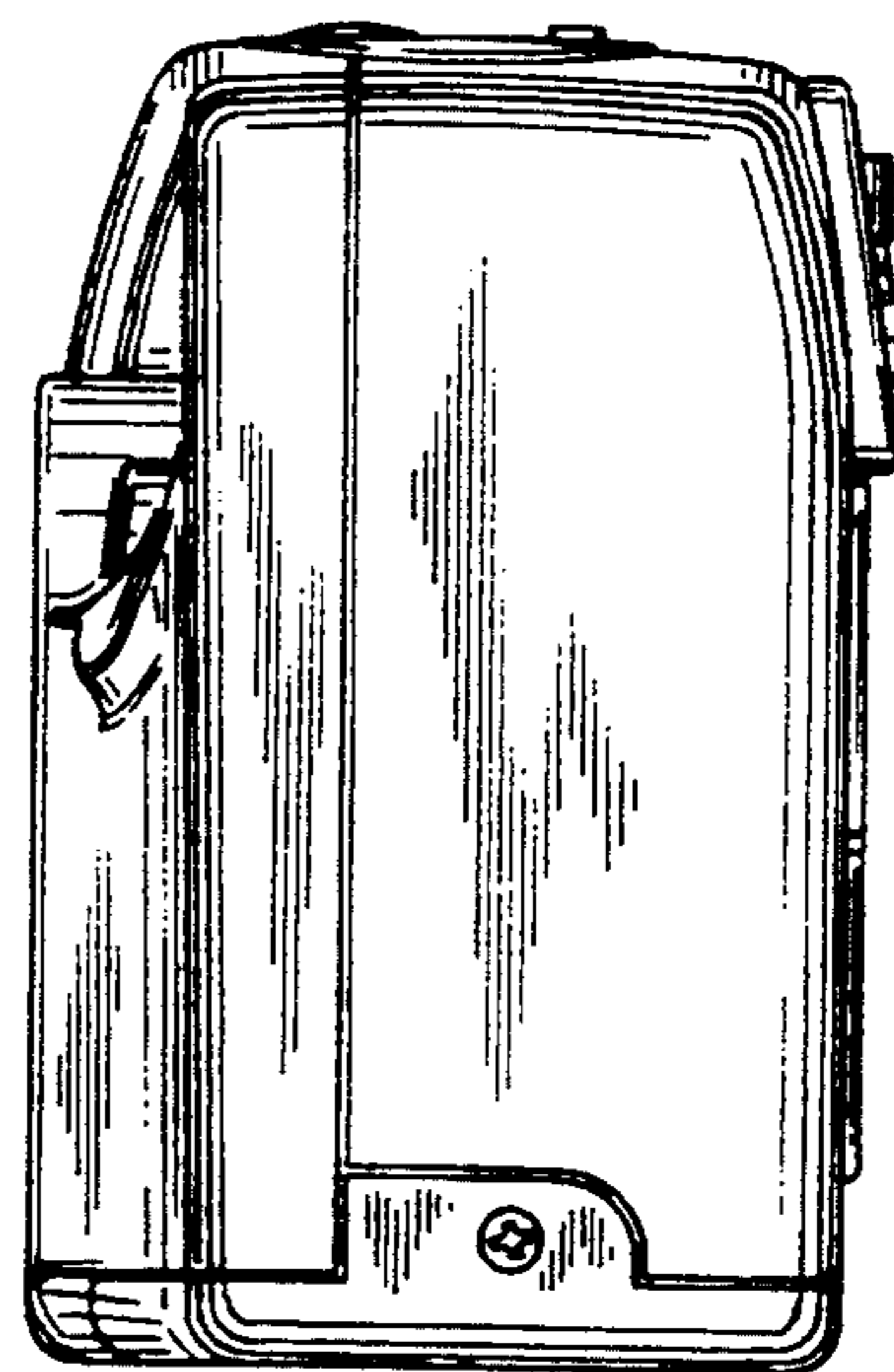

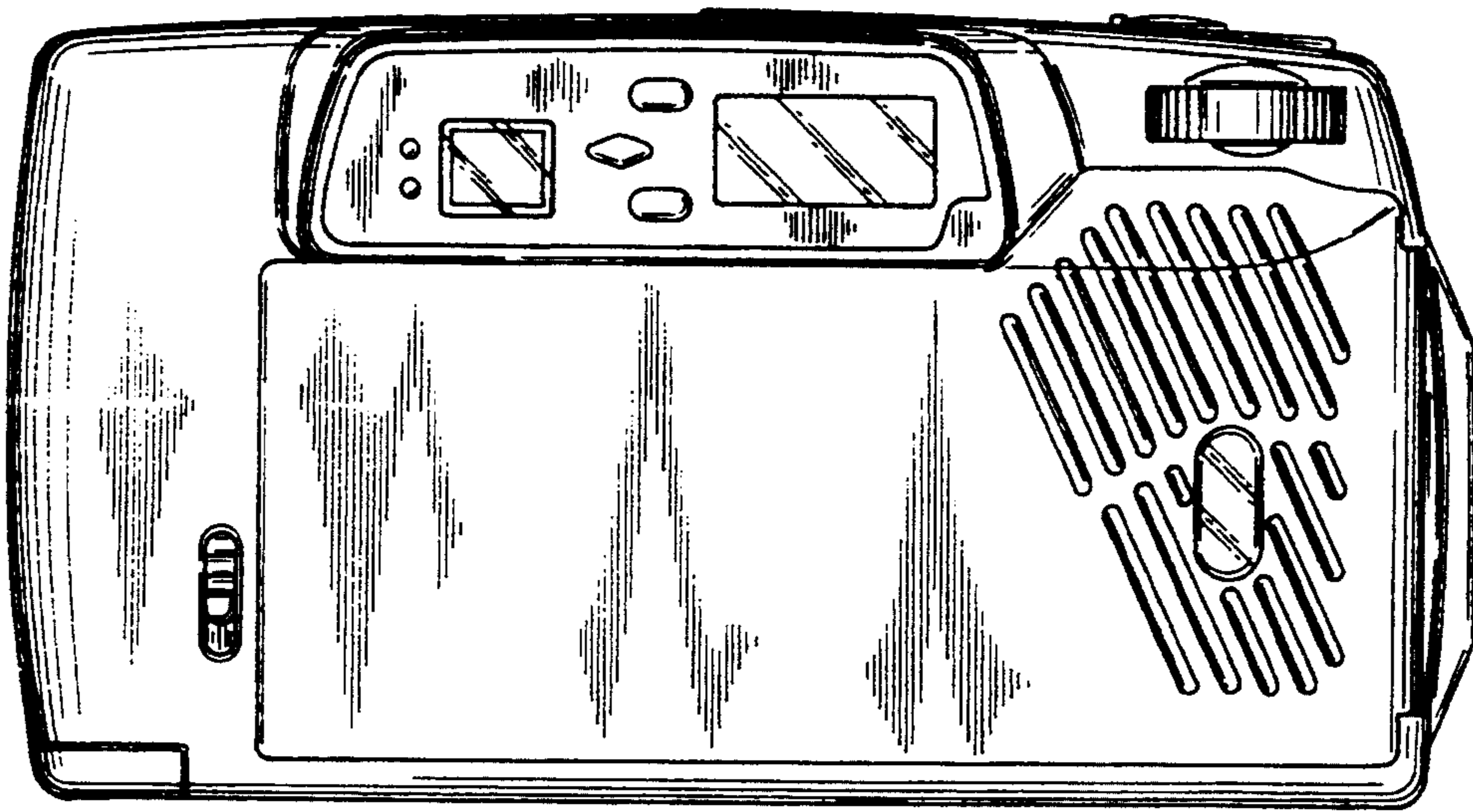

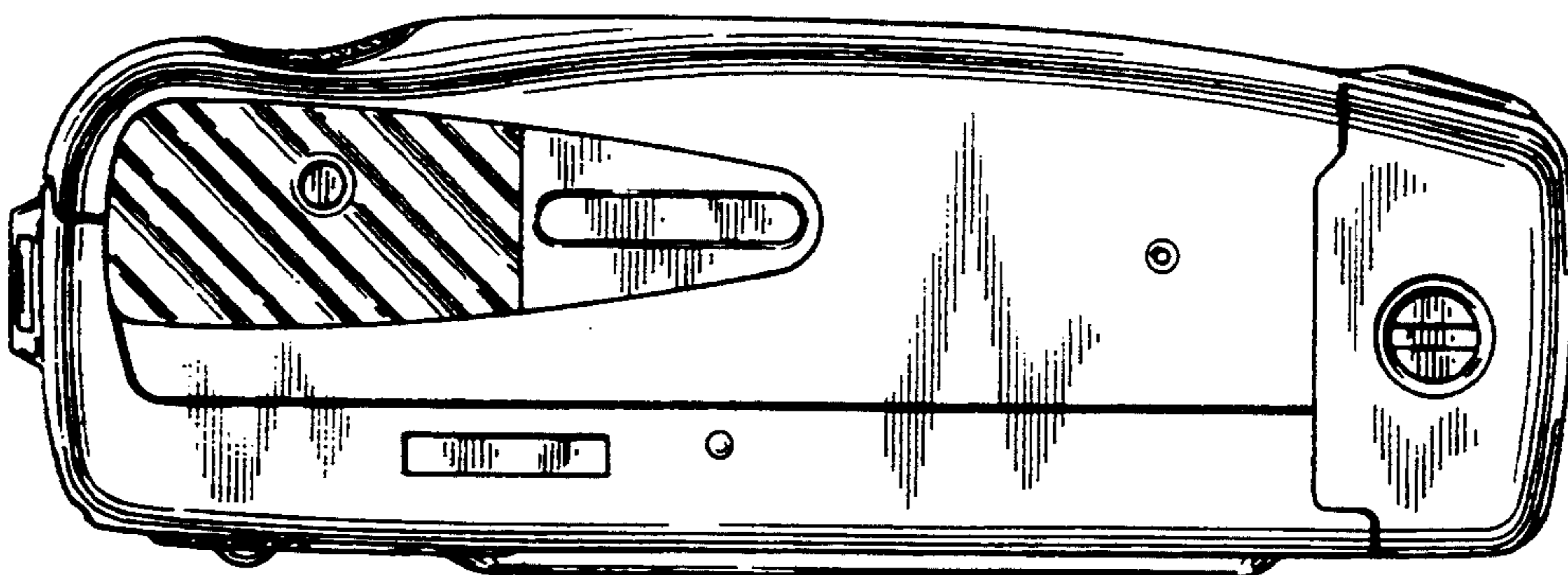

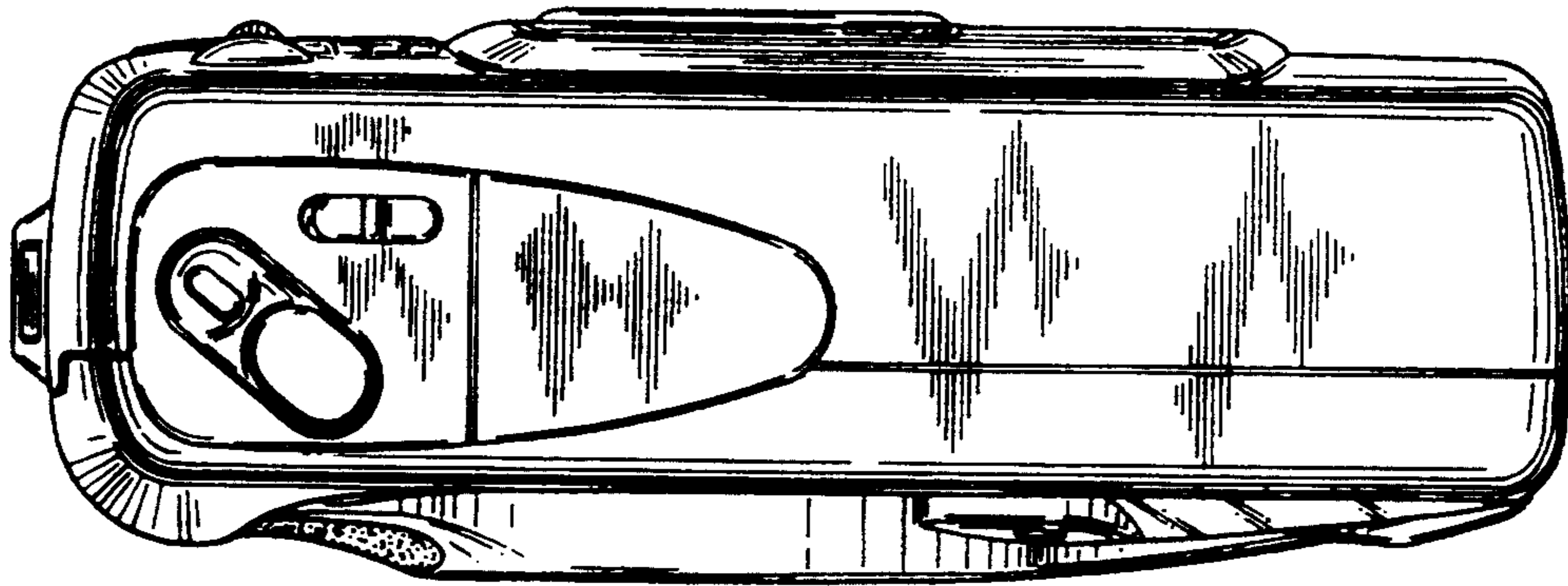

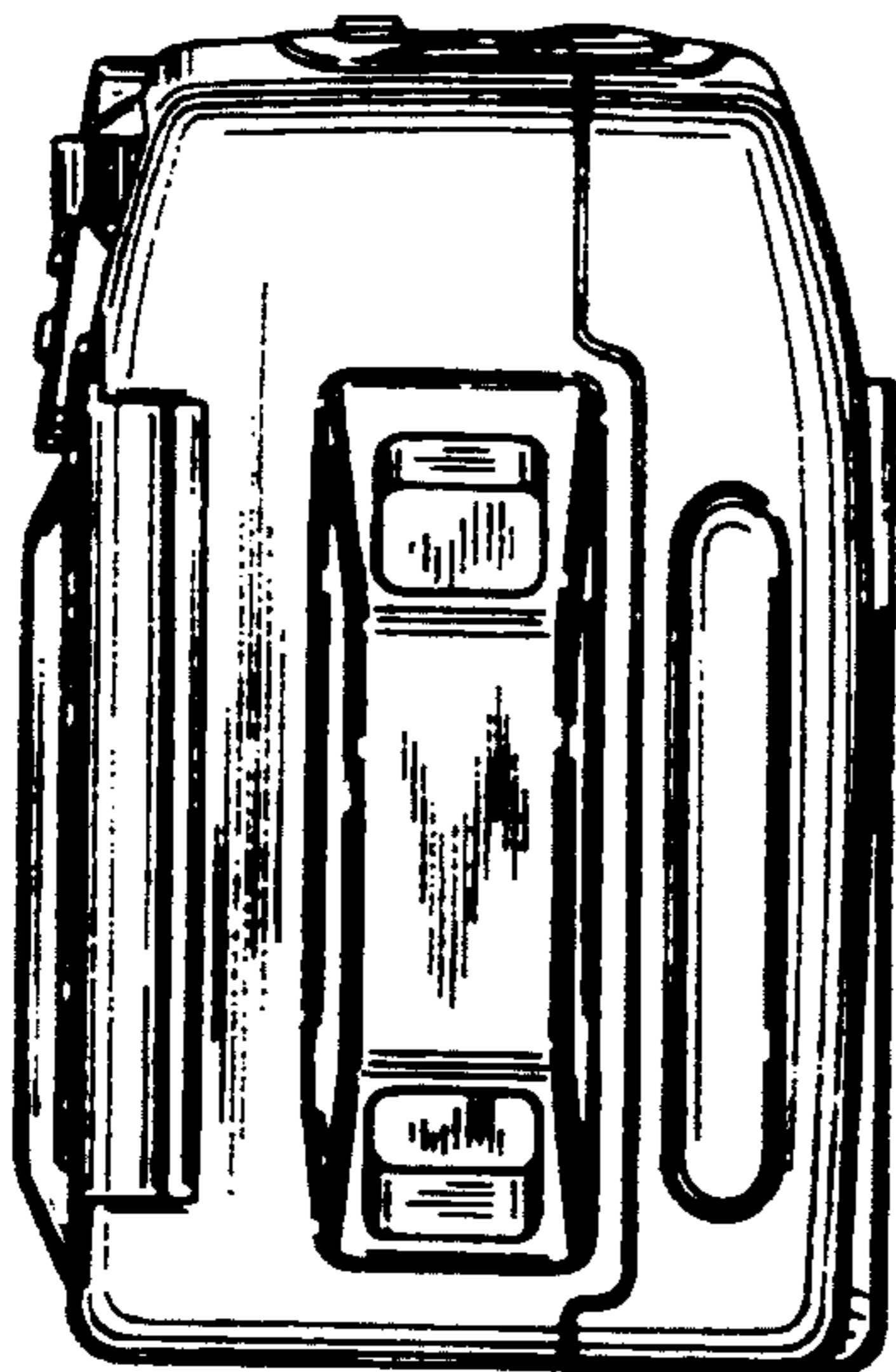

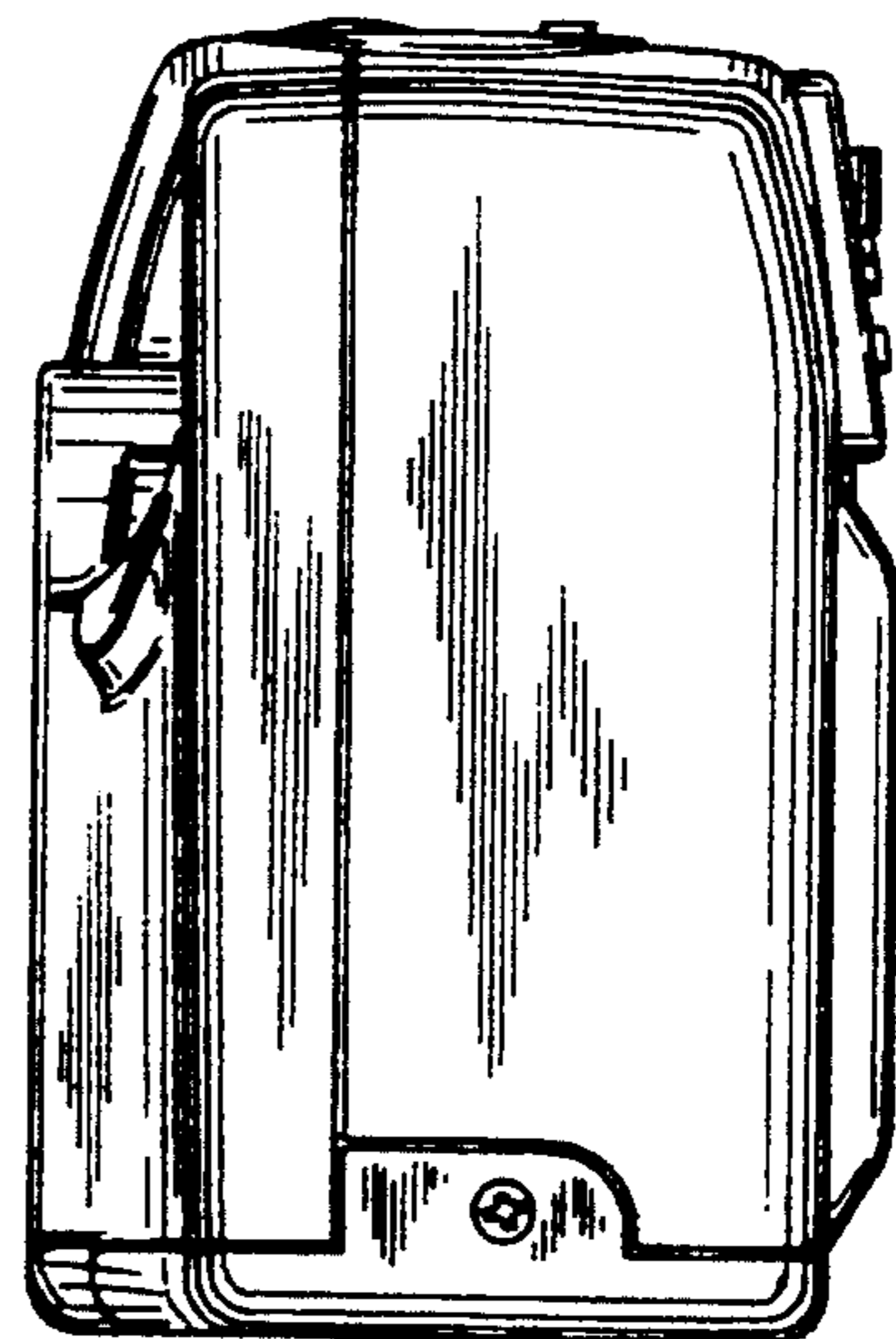

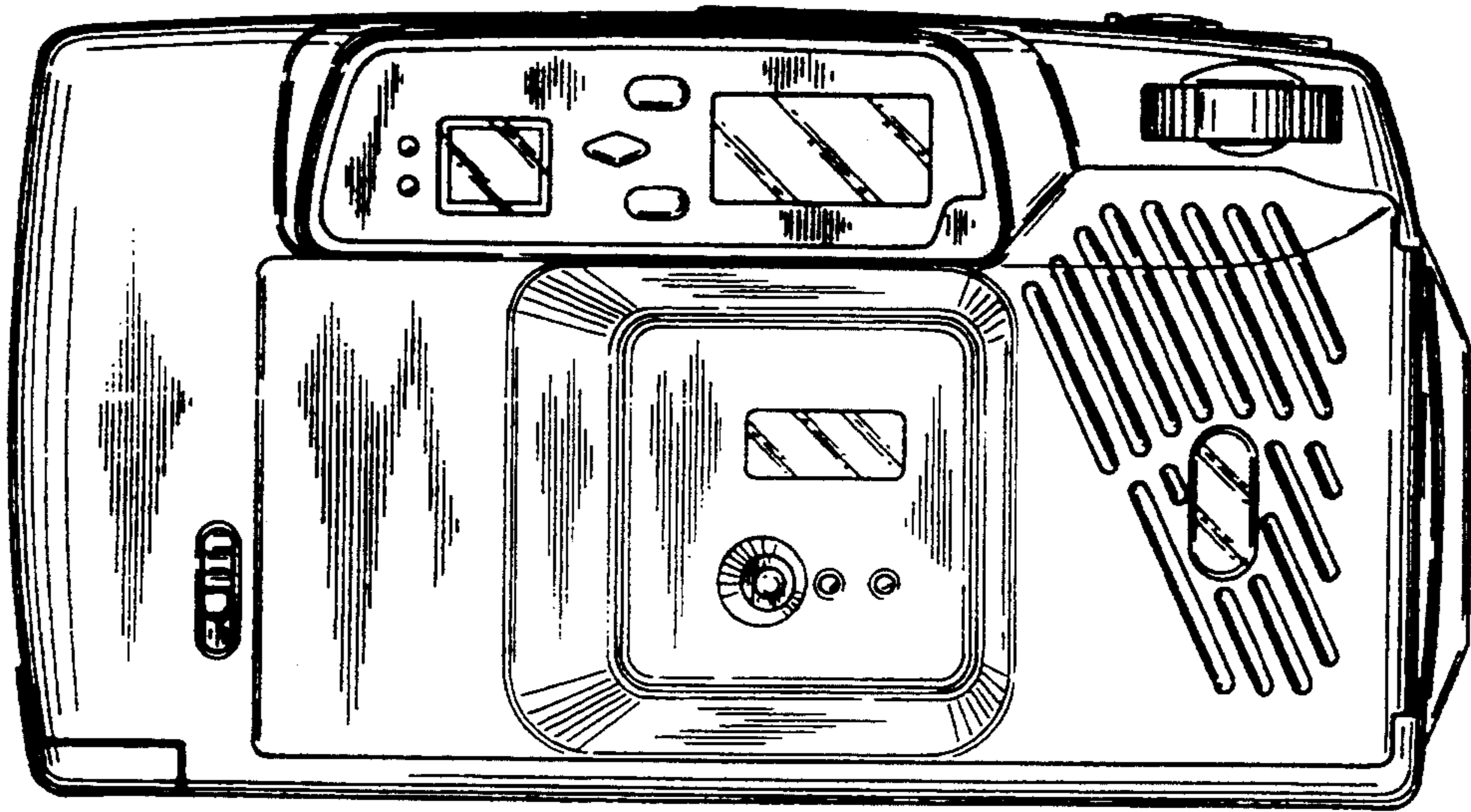

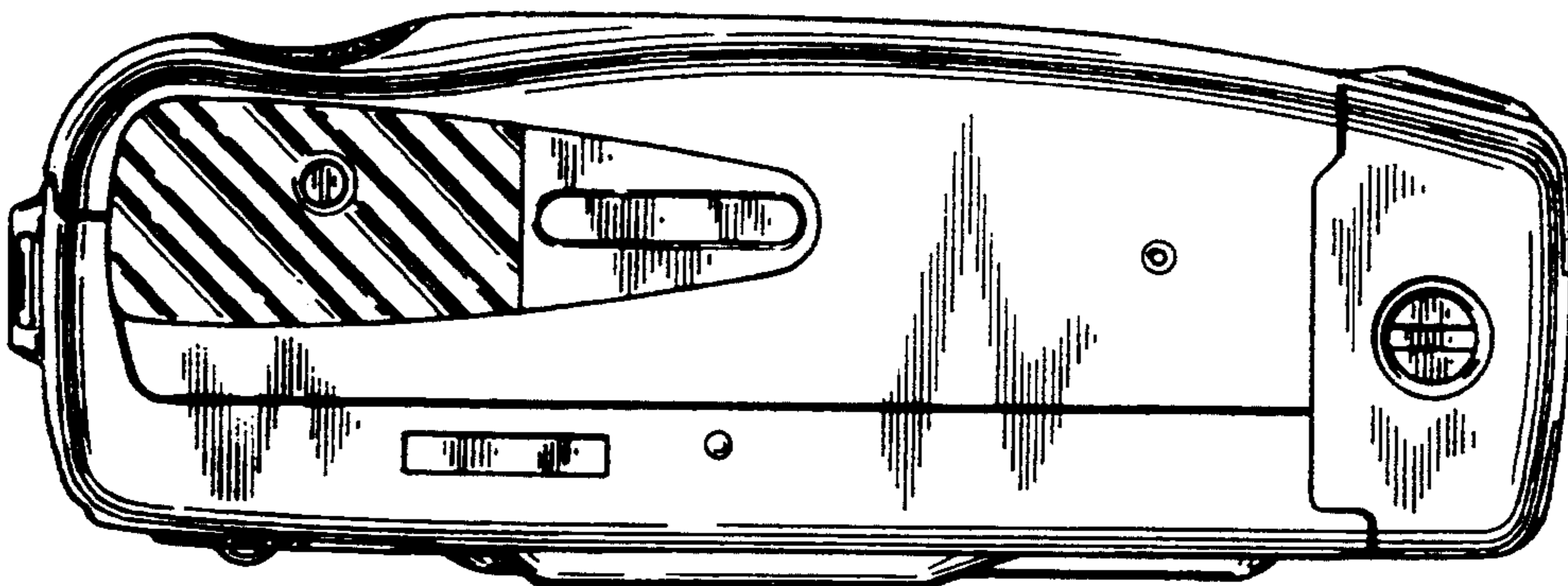

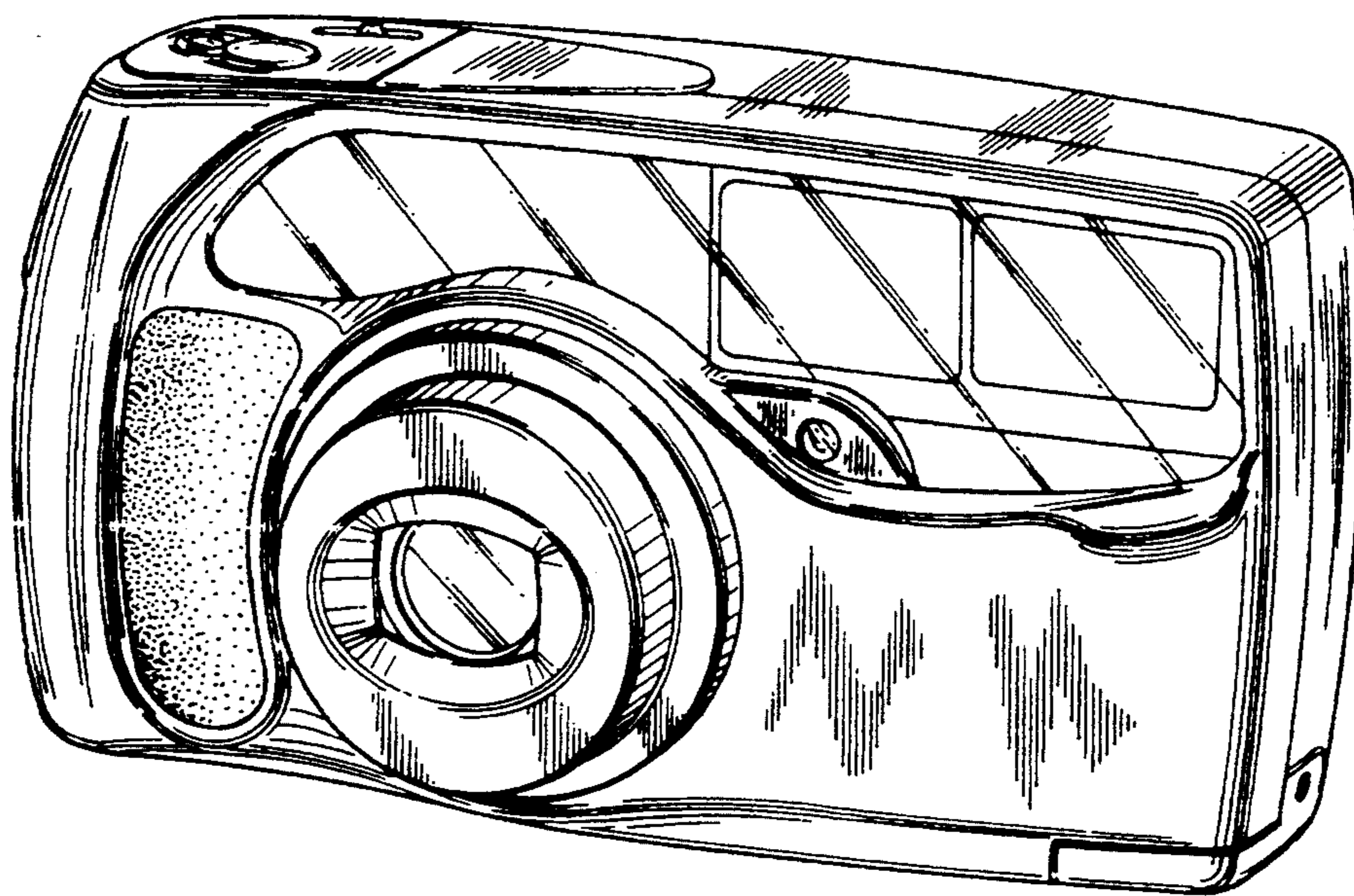
