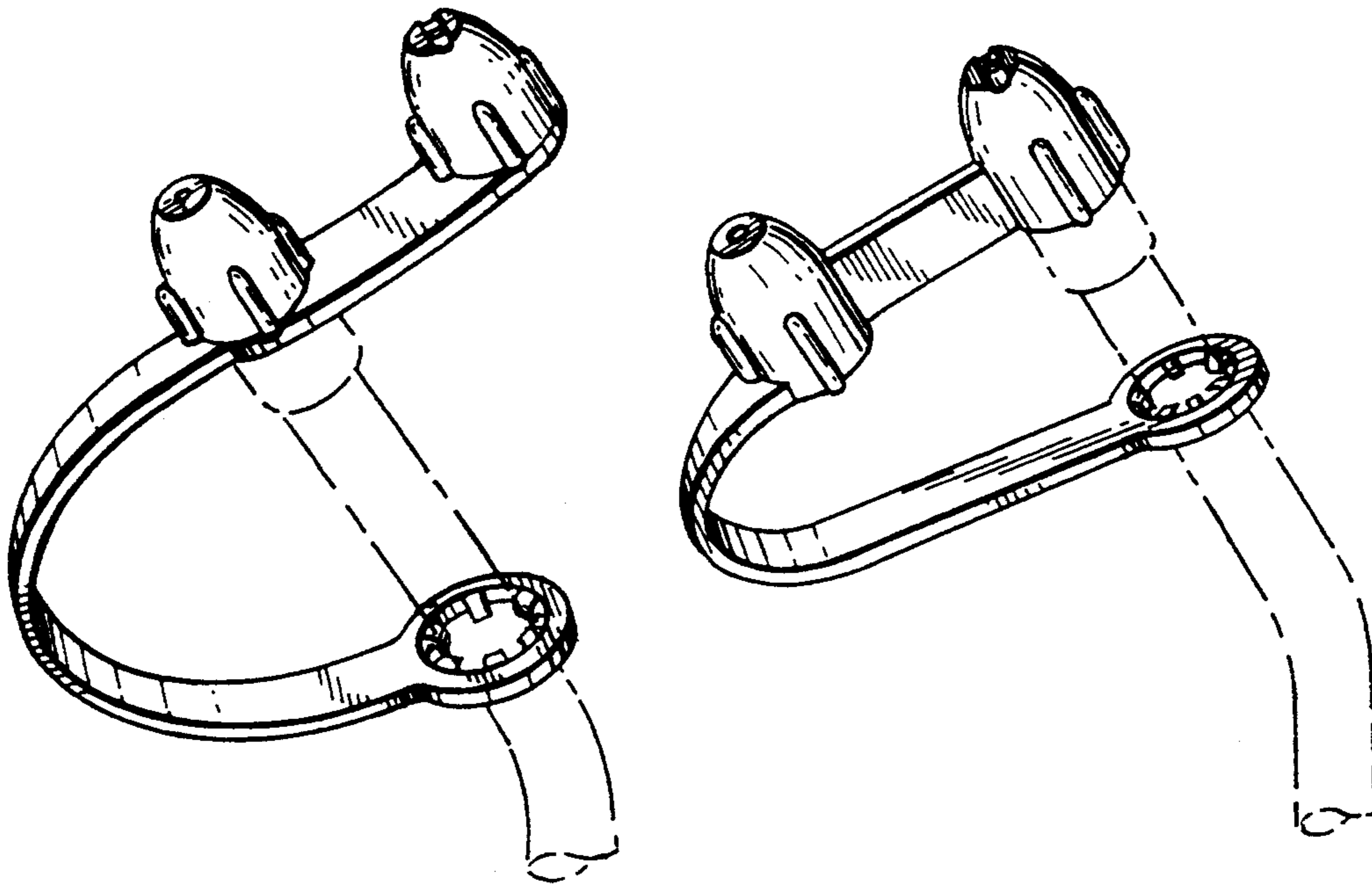

[57] **CLAIM**

The original design for multiple nozzle on a flexible strap for a garden sprayer, as shown and described.

**DESCRIPTION**

FIG. 1 is a top plan view of a multiple nozzle on a flexible strap for a garden sprayer showing my design; FIG. 2 is a side elevational view thereof; FIG. 3 is a bottom plan view thereof; FIG. 4 is a left end view thereof; FIG. 5 is a right end view thereof; FIG. 6 is a perspective view thereof; the broken line showing is for illustrative purposes only and forms no part of the claimed design; FIG. 7 is a top plan view of a multiple nozzle on a flexible strap for a garden sprayer showing another embodiment of my design; FIG. 8 is a side elevational view thereof; FIG. 9 is a bottom plan view thereof; FIG. 10 is a left end view thereof; FIG. 11 is a right end view thereof; FIG. 12 is perspective view thereof; the broken line showing is for illustrative purposes only and forms no part of the claimed design.



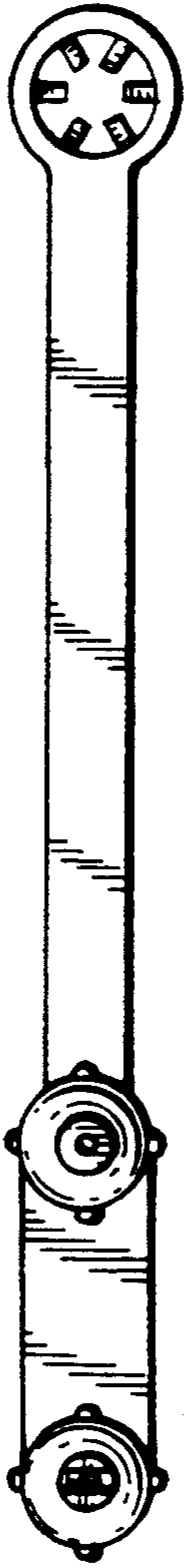

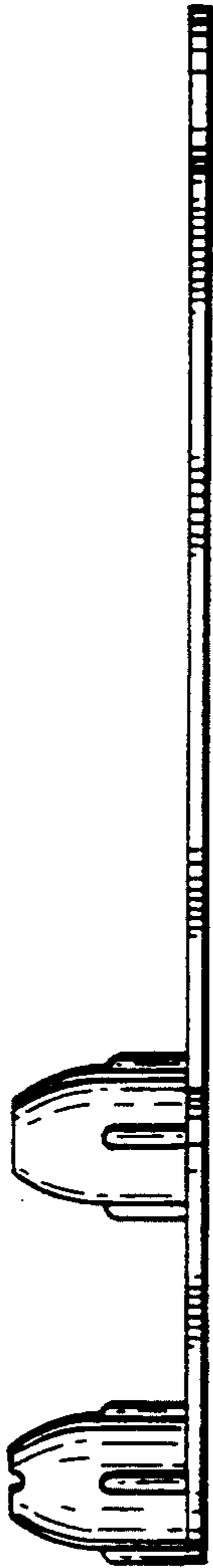

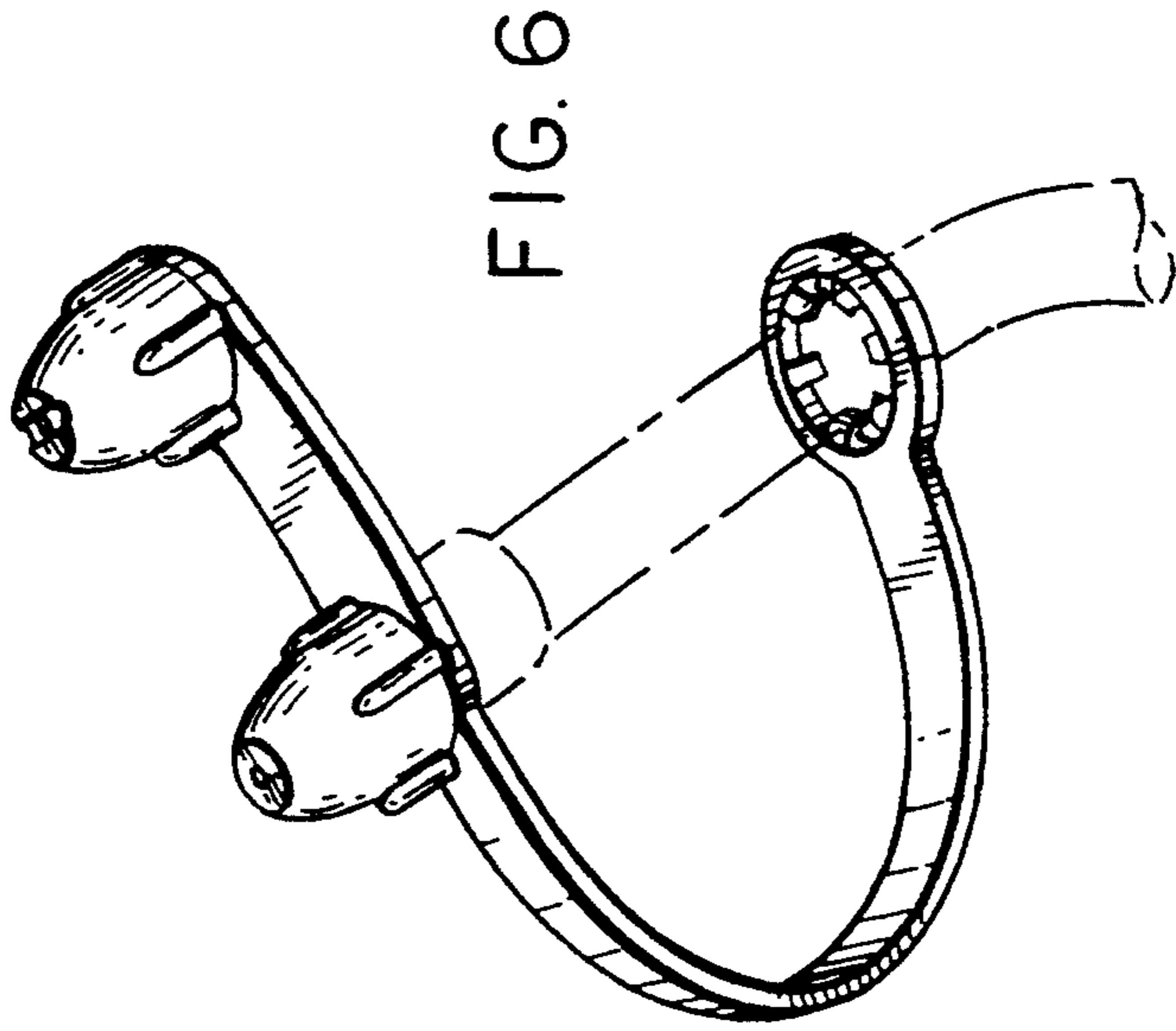

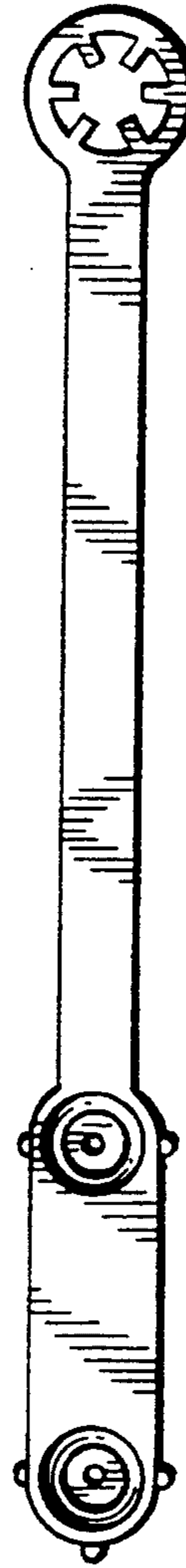

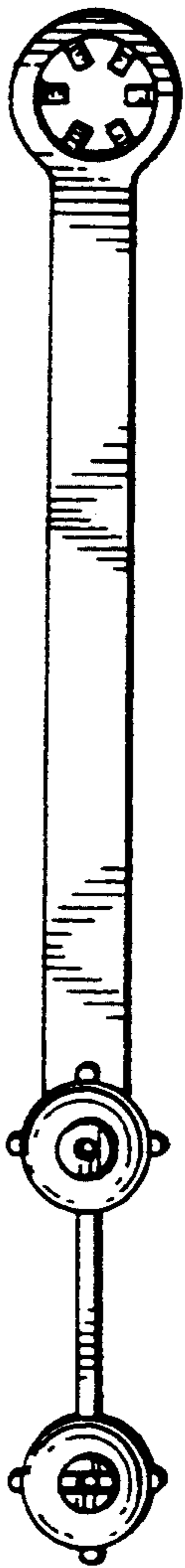

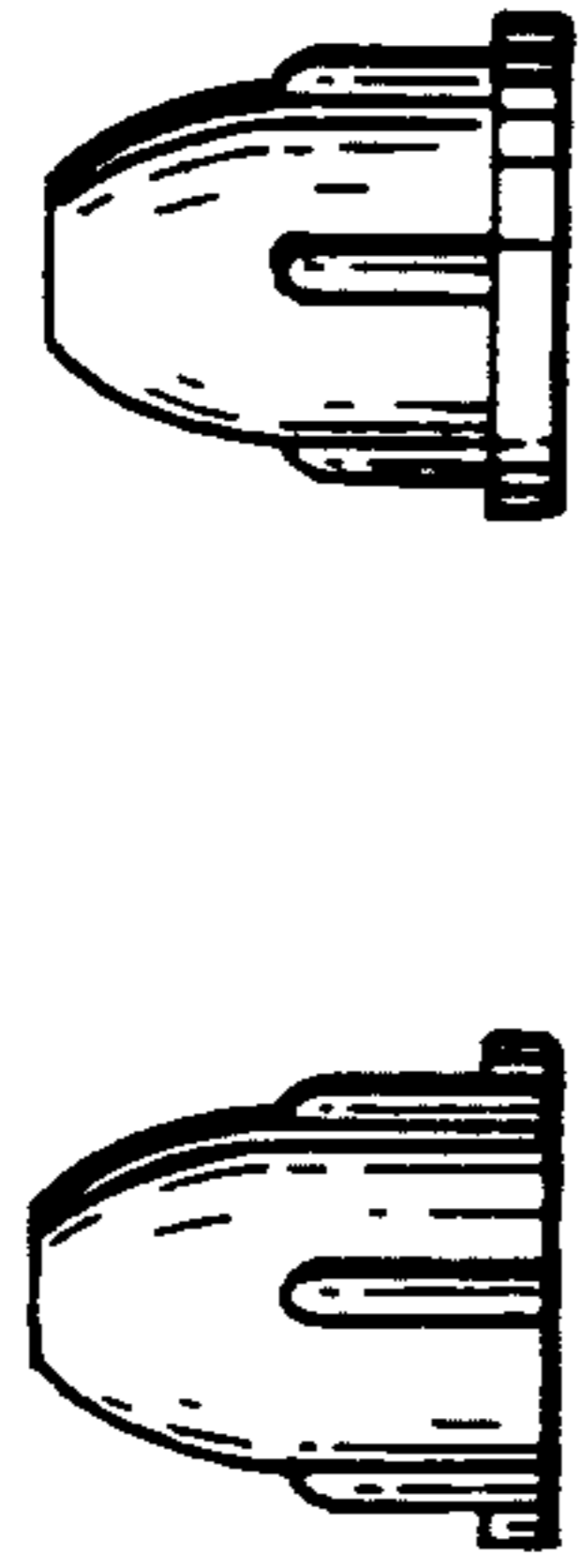

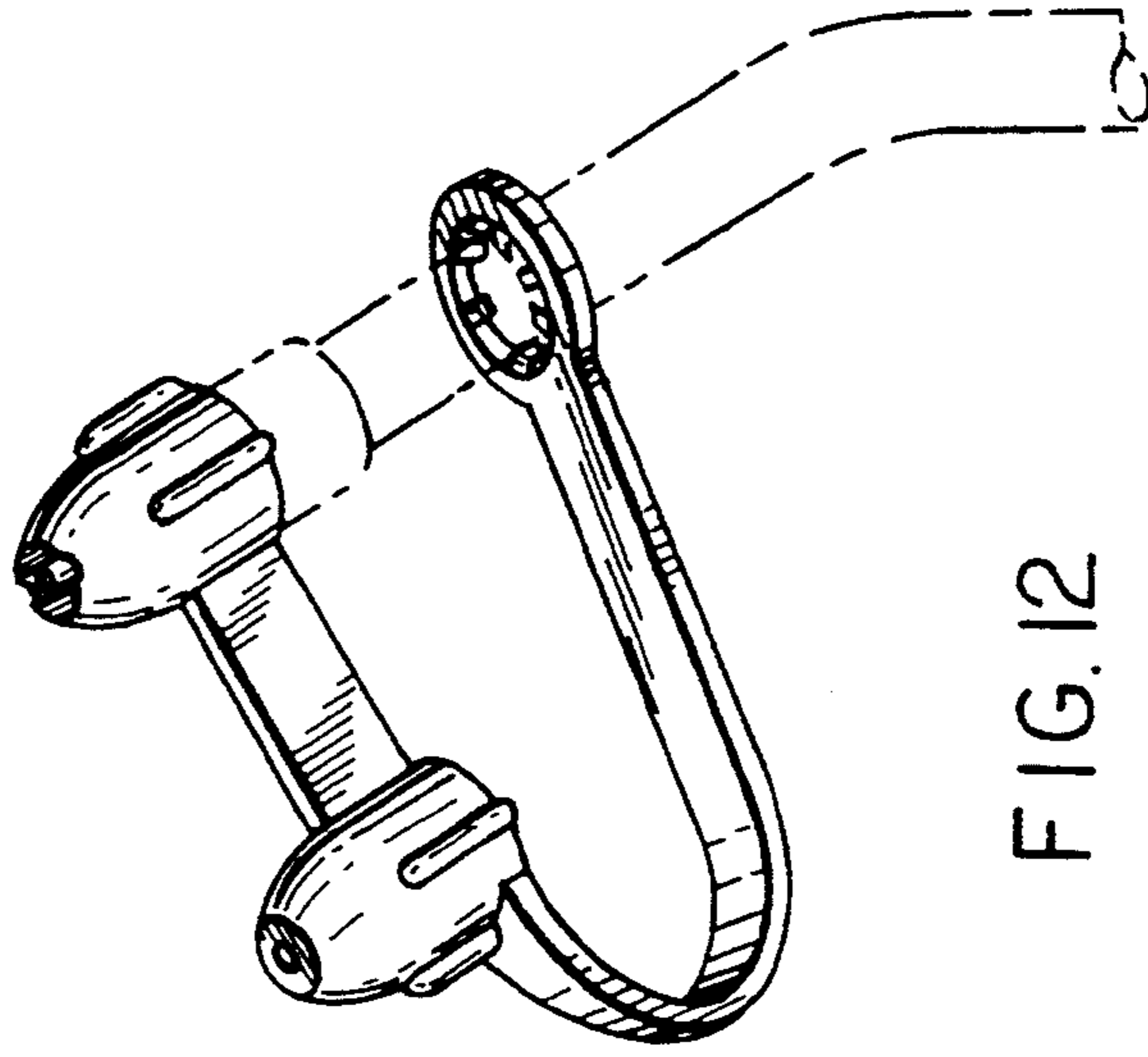
