The ornamental design for a cushioned sofa, as shown and described.

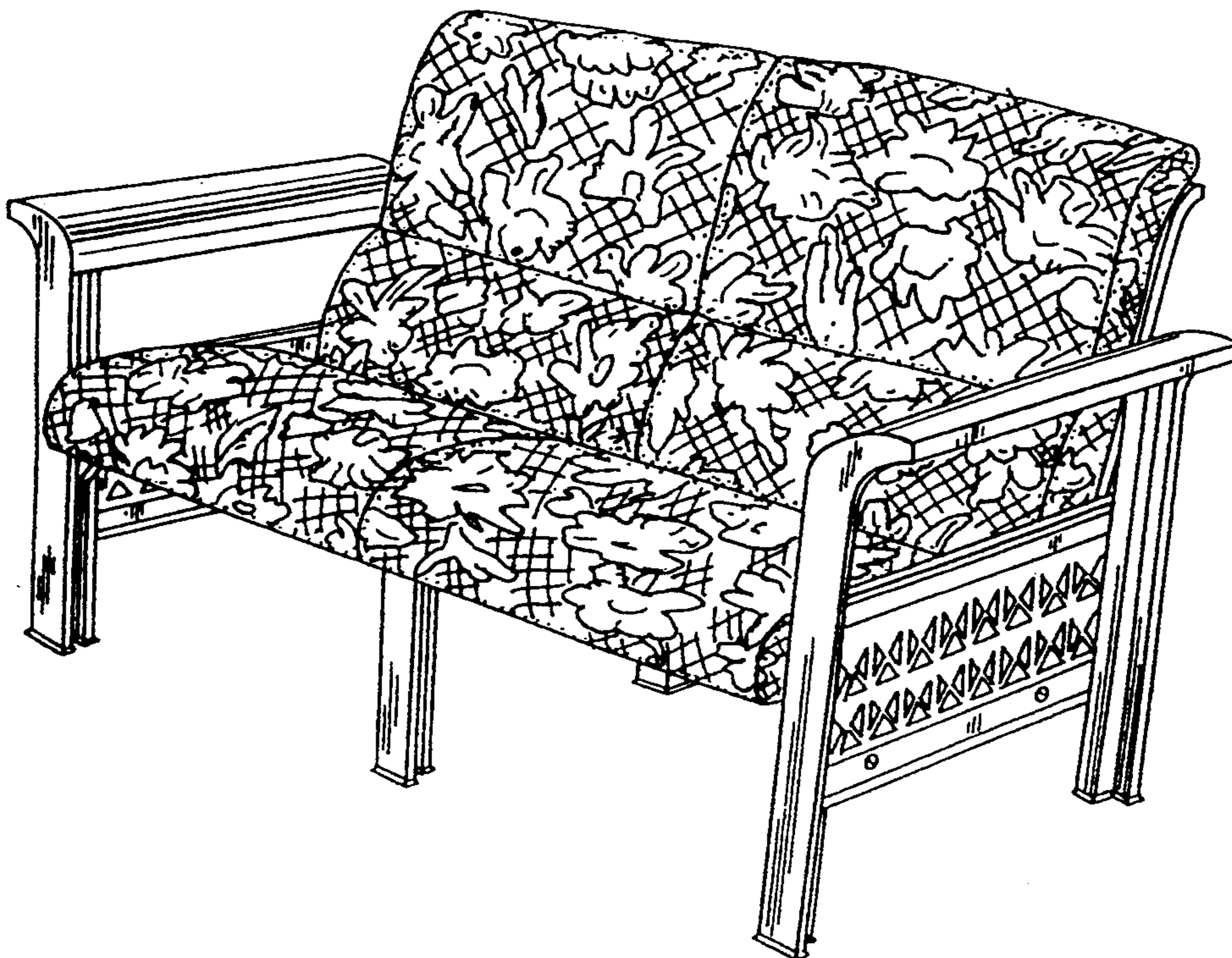
### DESCRIPTION

FIG. 1 is a left front perspective view of a cushioned sofa showing my new design;

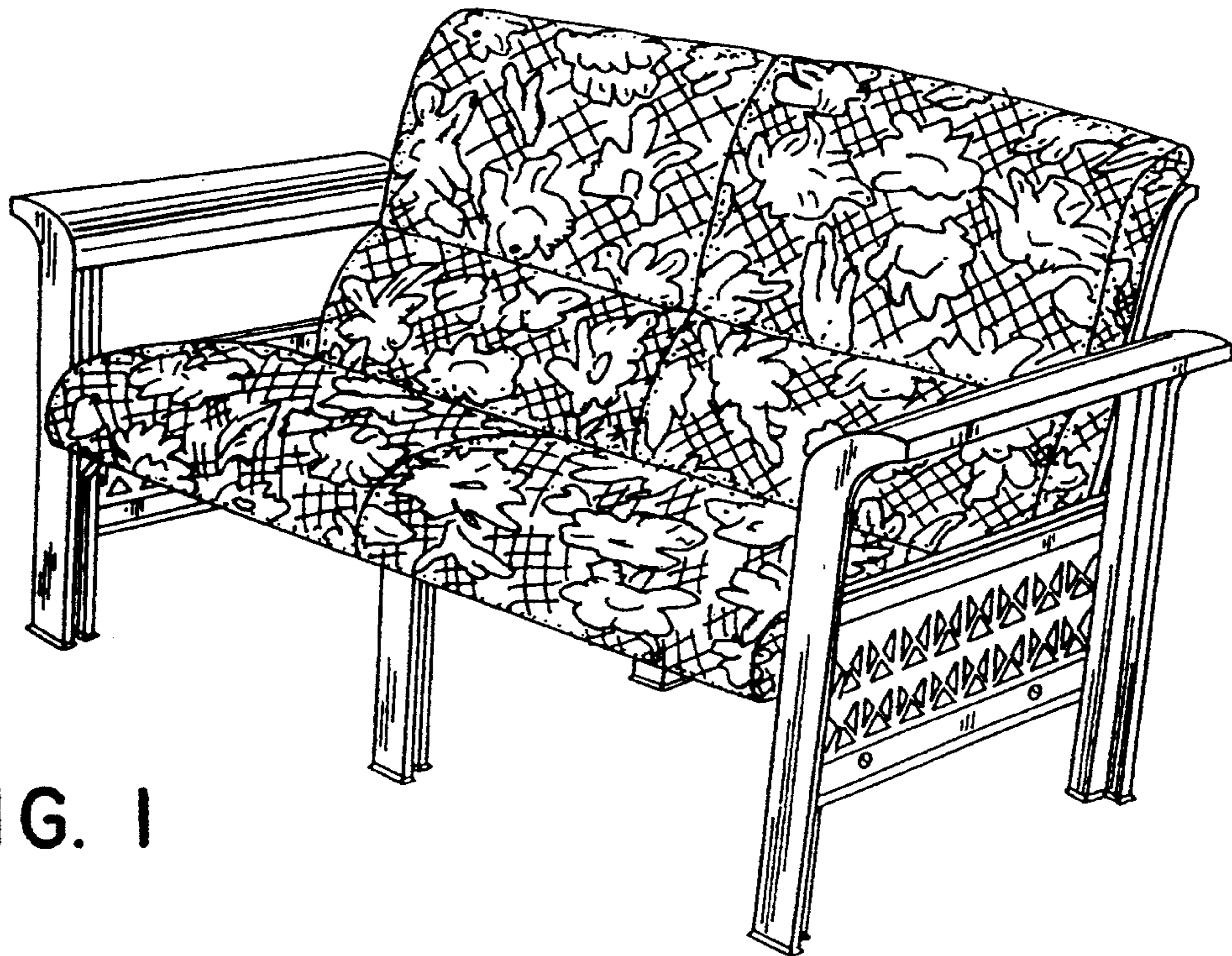

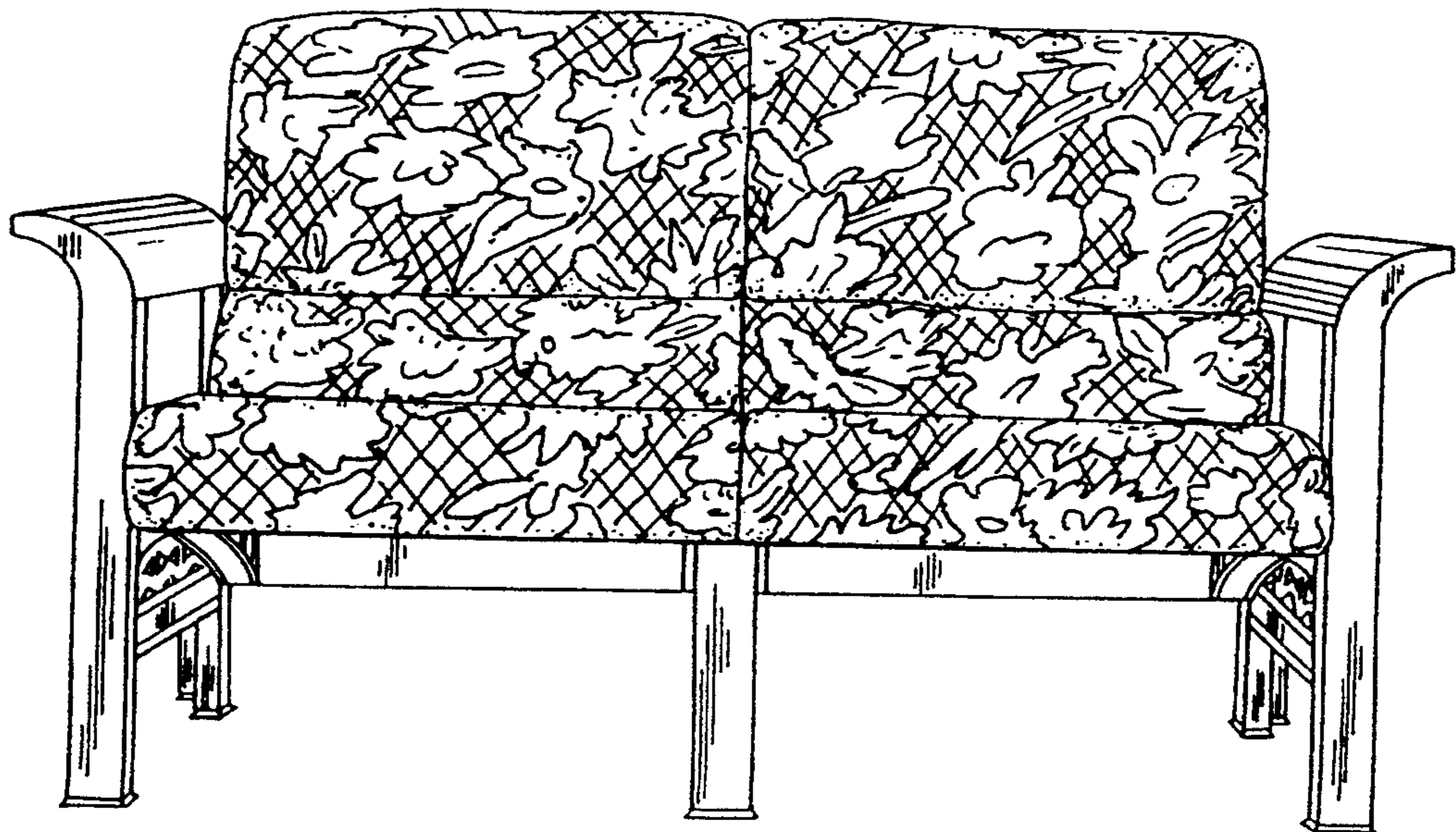

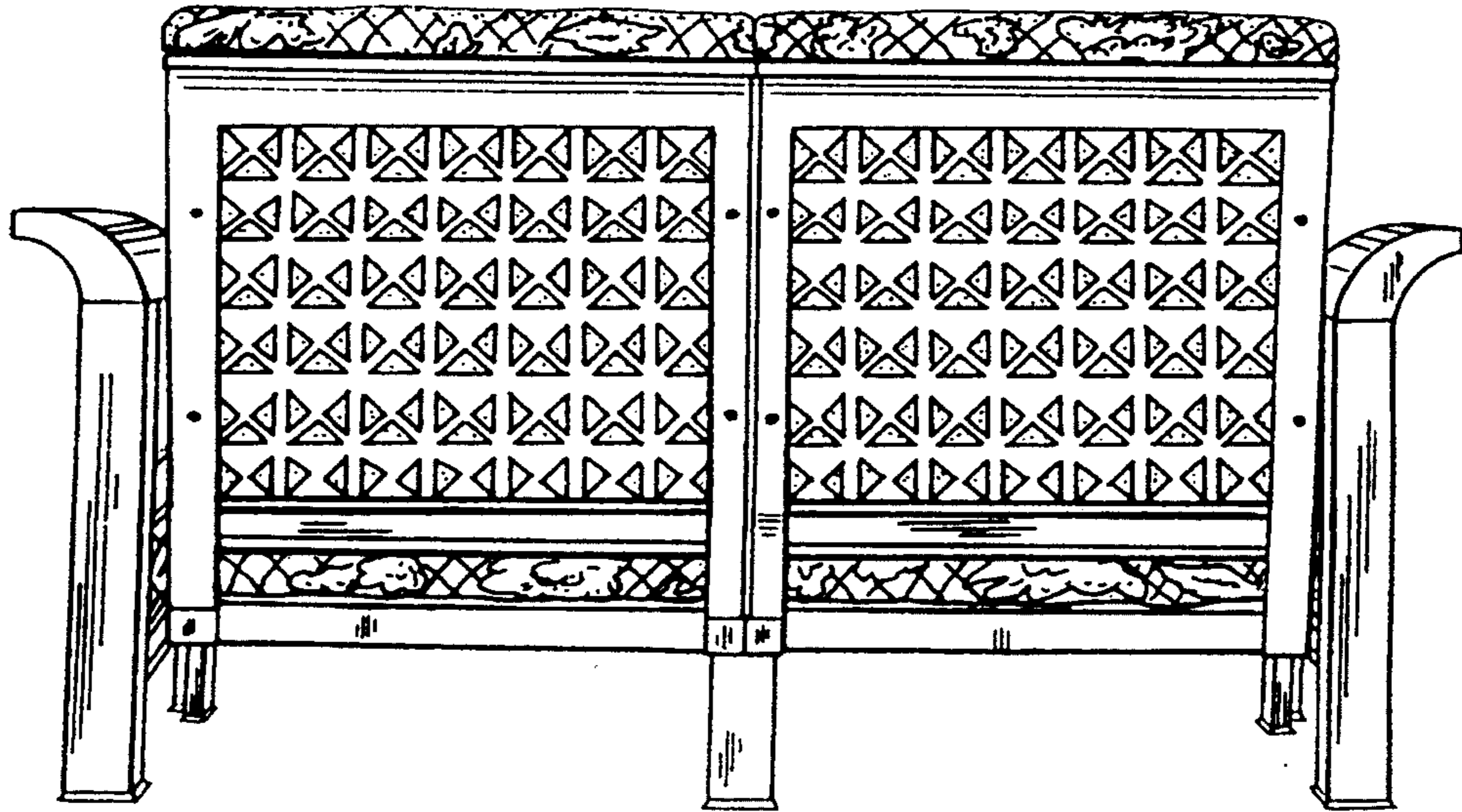

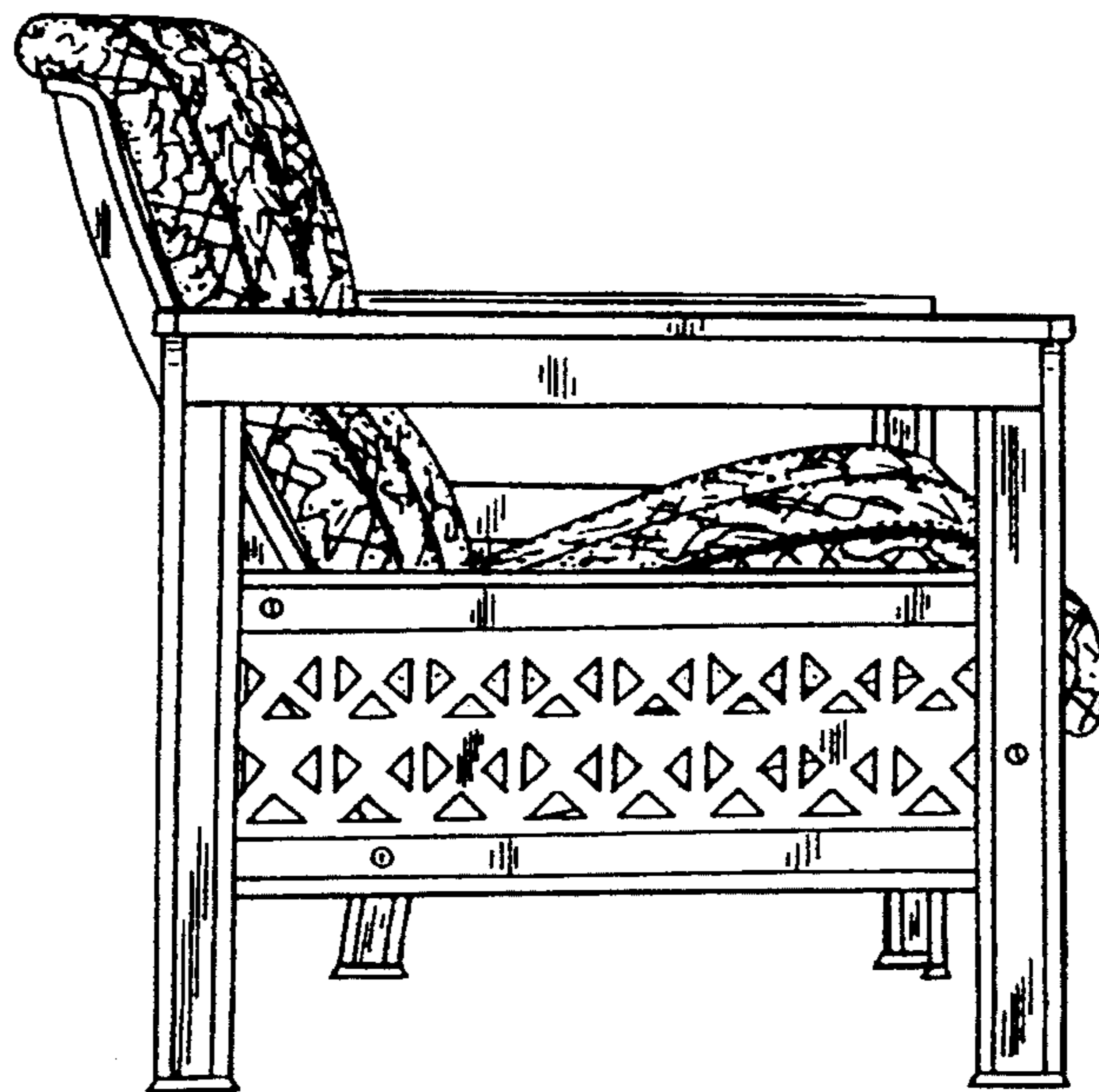

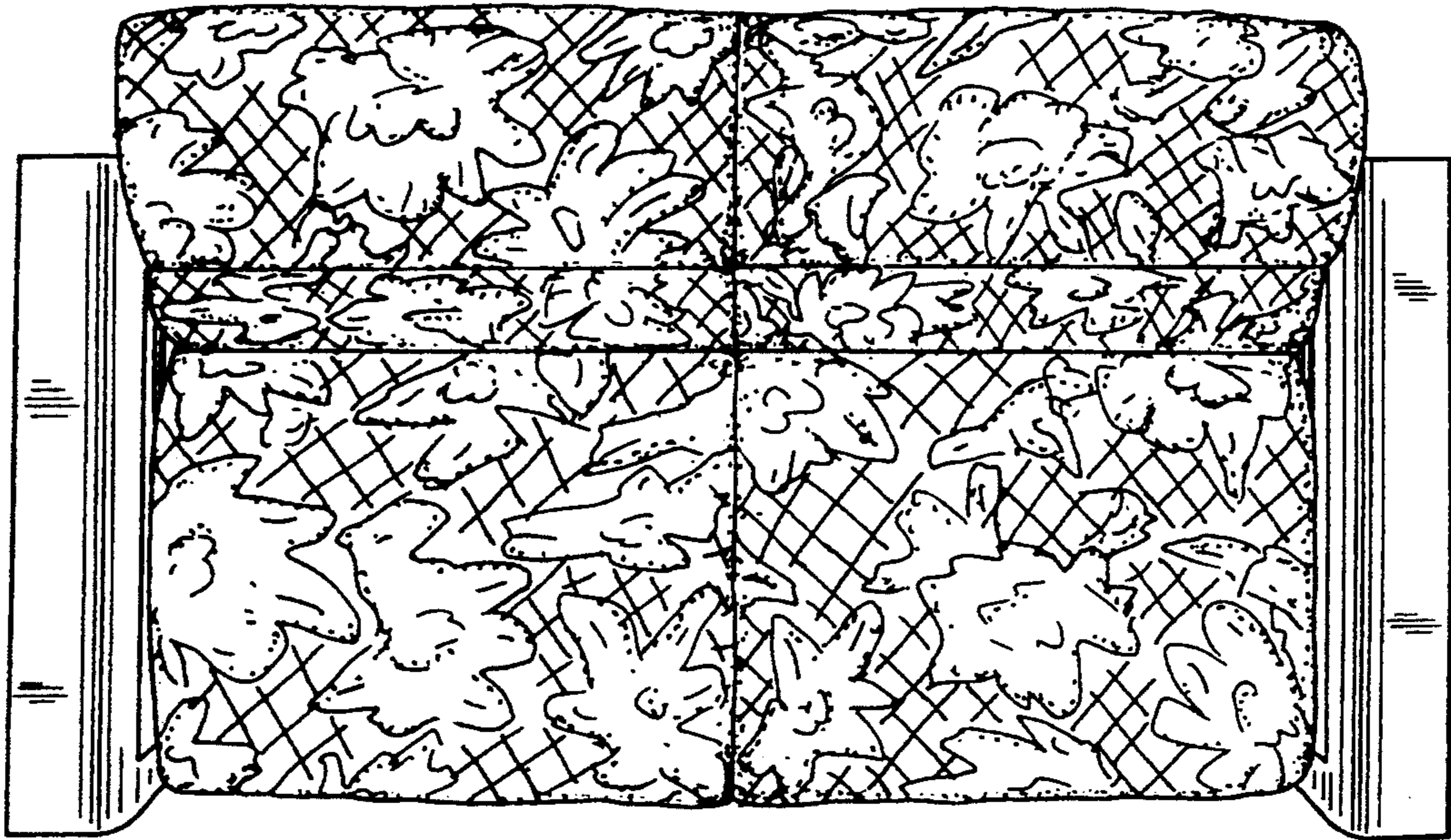

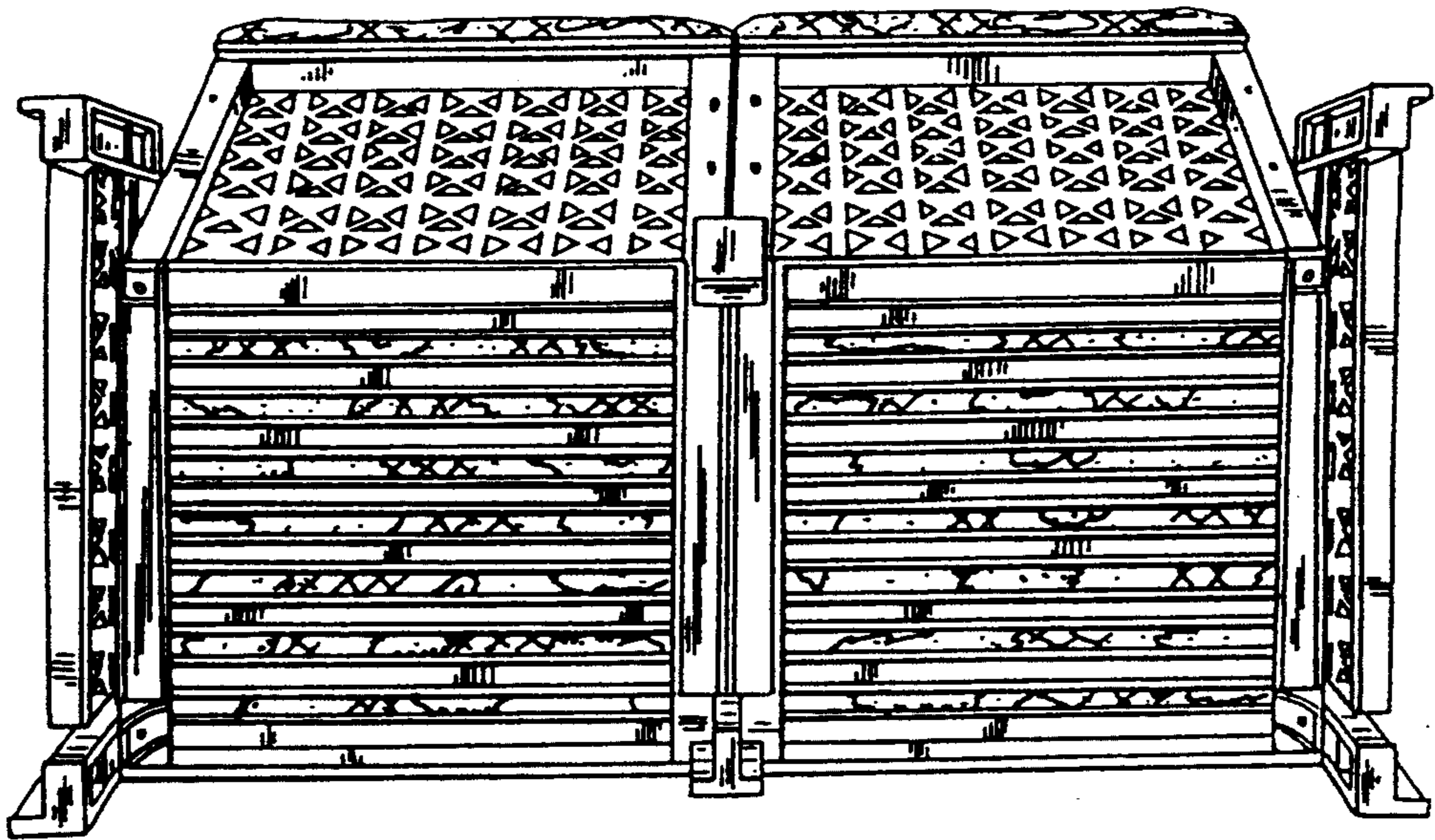
