FIG. 2 is a top plan view of the invention of FIG. 1;

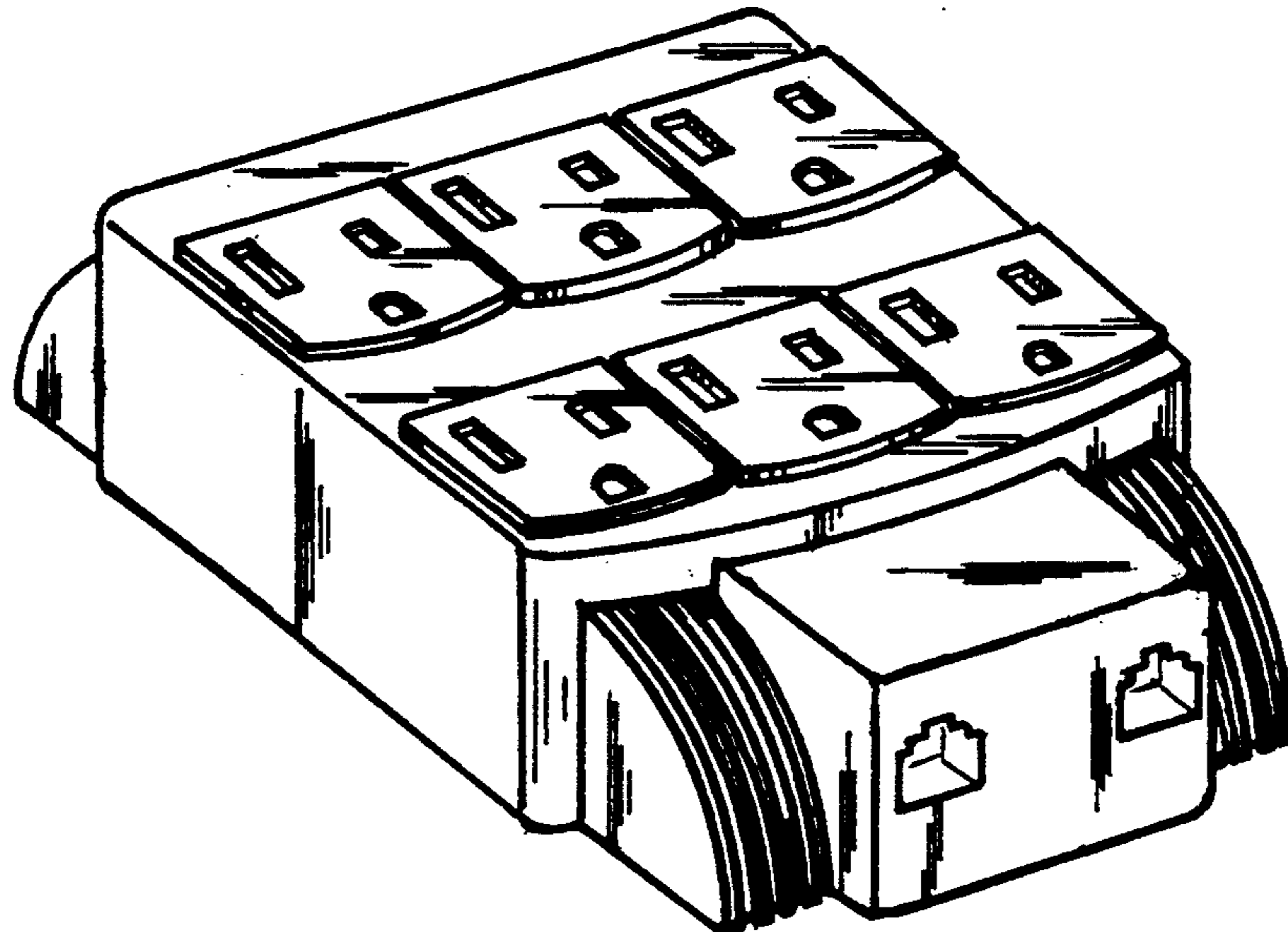
FIG. 3 is a side plan view of the invention of FIG. 1;

FIG. 6 is a back plan view of the invention of FIG. 1.



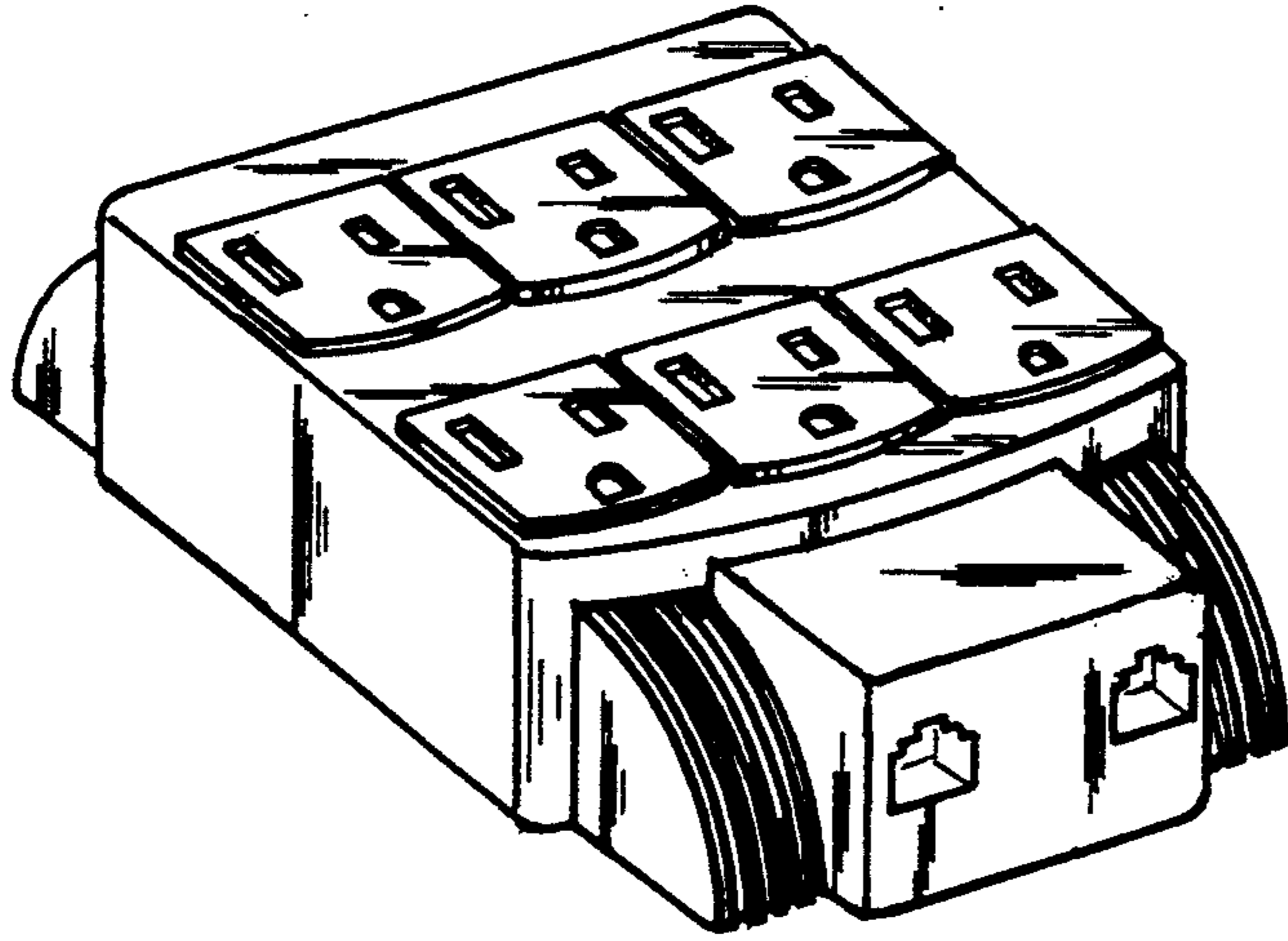

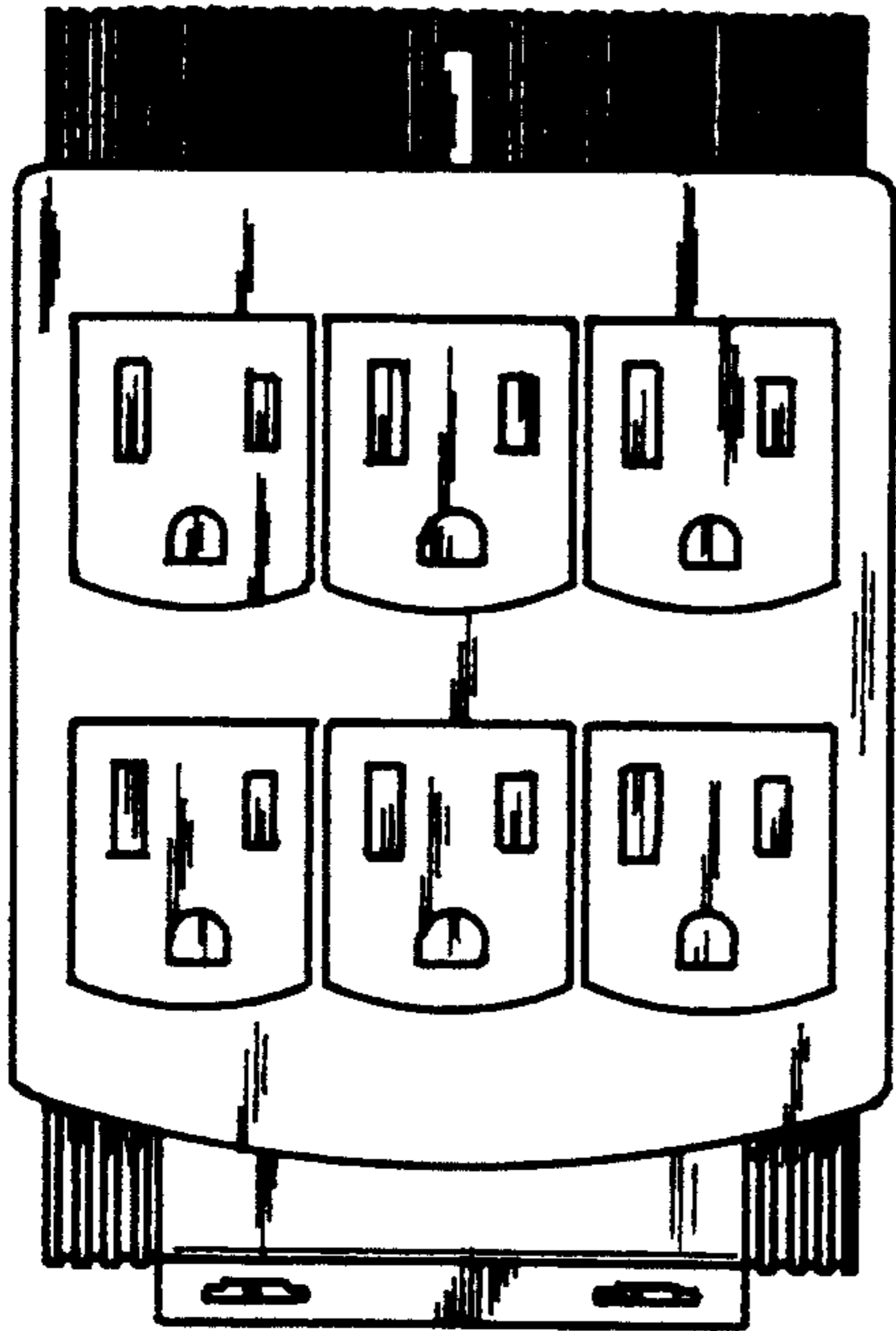

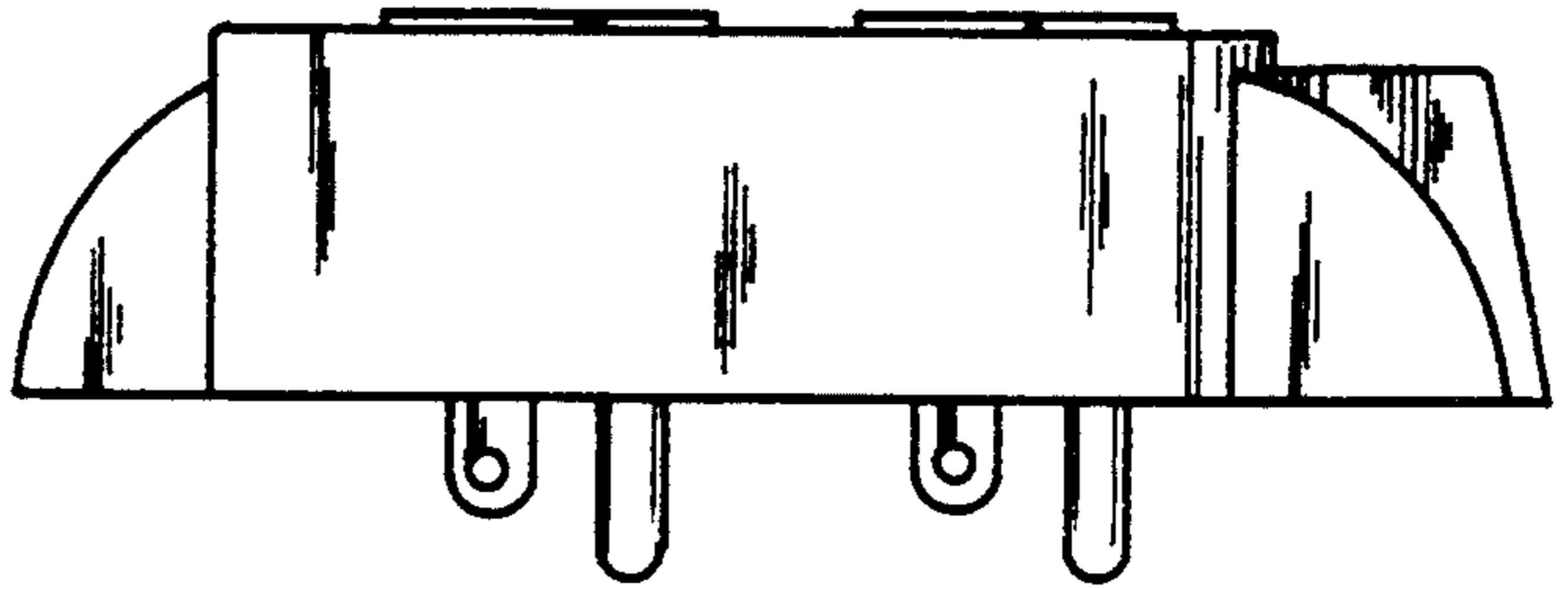

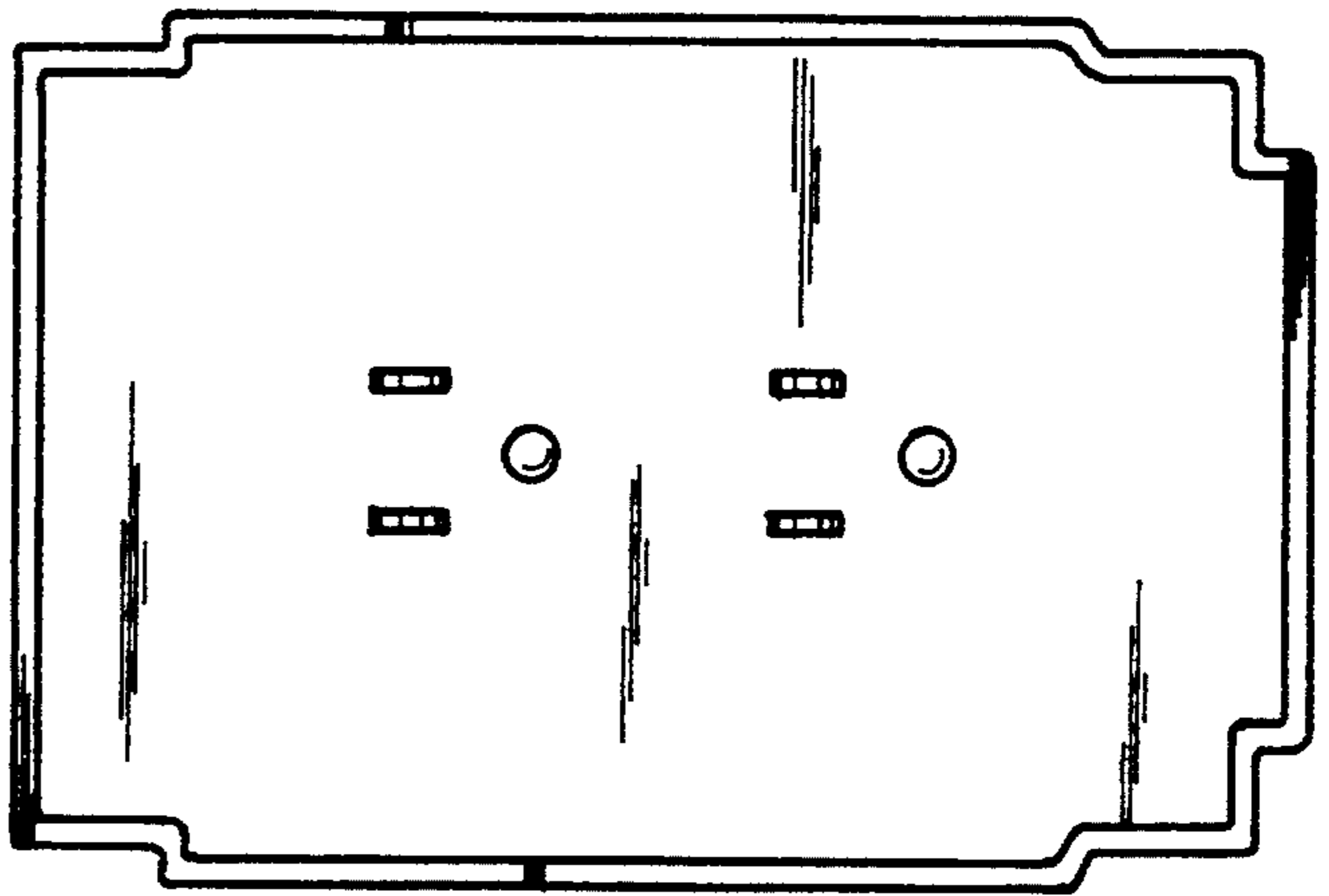

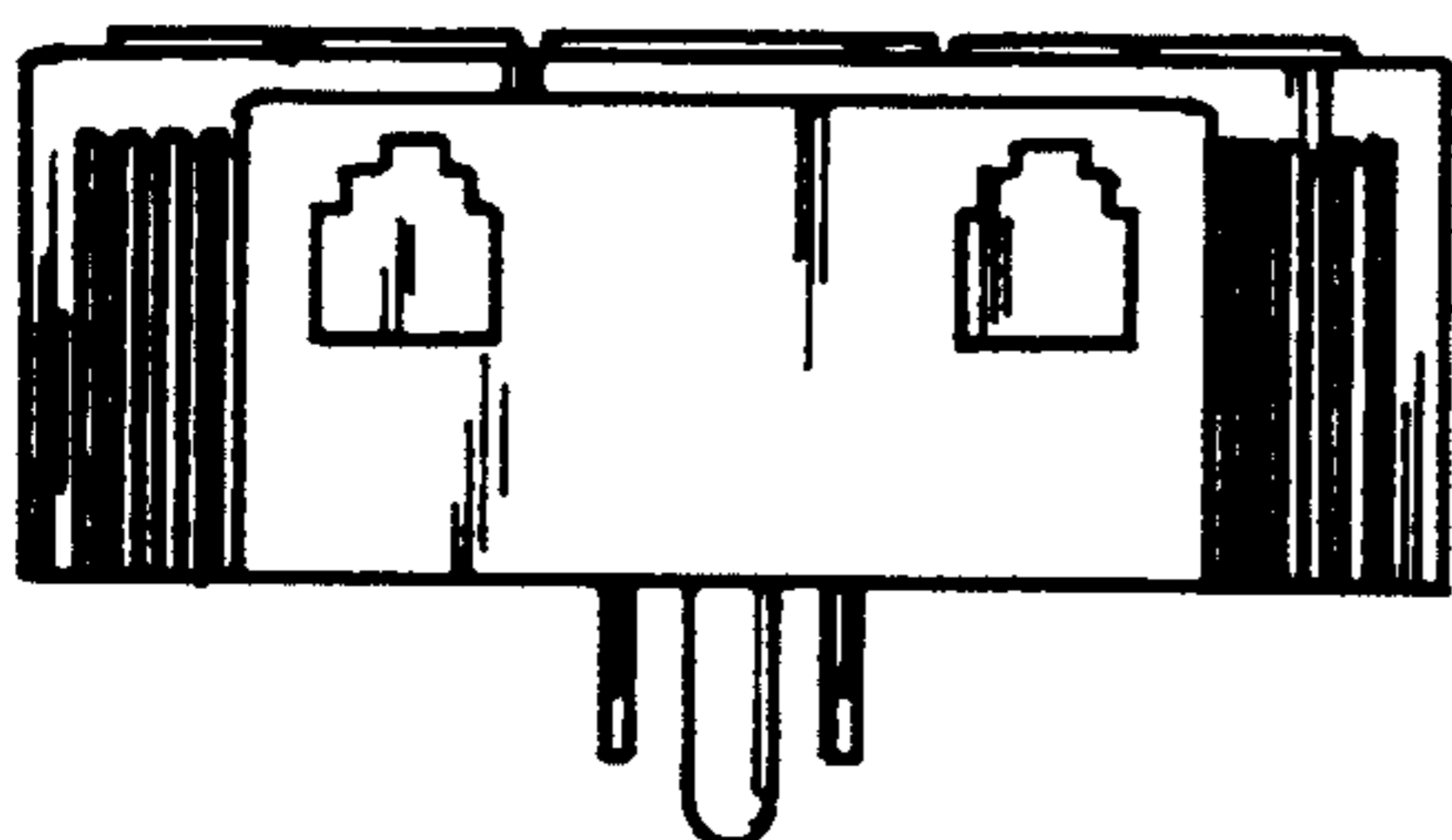

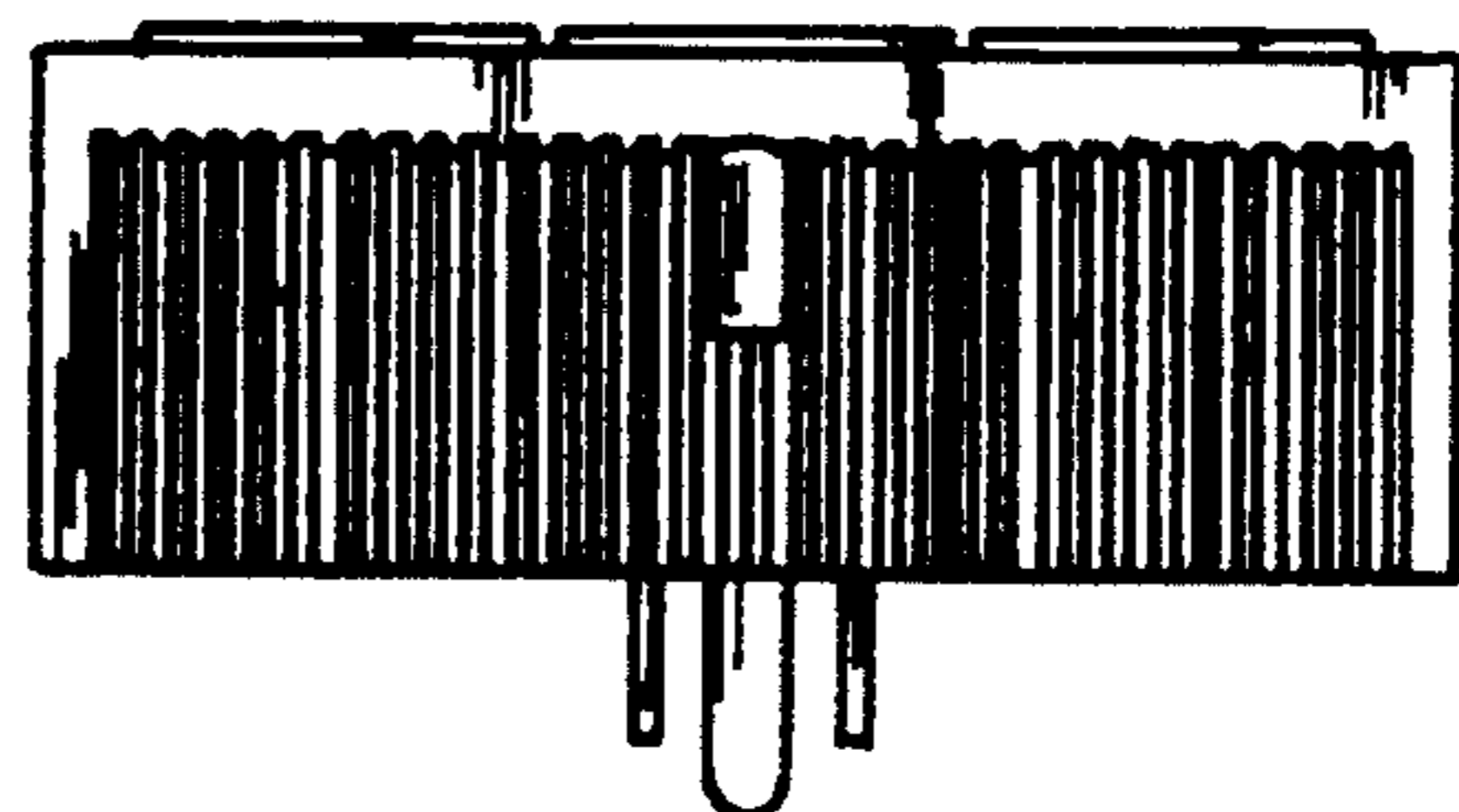
