[57] CLAIM

The ornamental design for a miniature hair trimmer with ring attachment for finger support, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a miniature hair trimmer with ring attachment for finger support showing our new design;

FIG. 3 is a bottom view thereof;

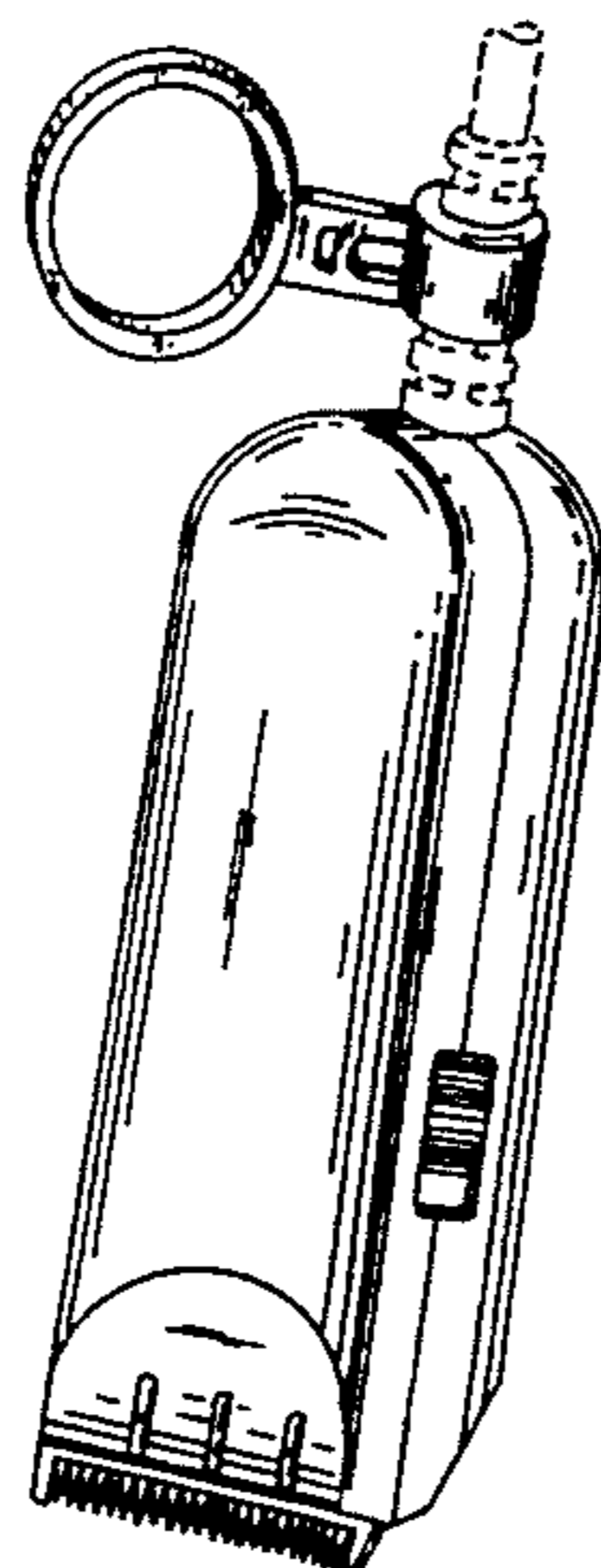
FIG. 4 is a right side view thereof;

The broken line showing the electrical cord is for illustrative purposes only and forms no part of the claimed design.



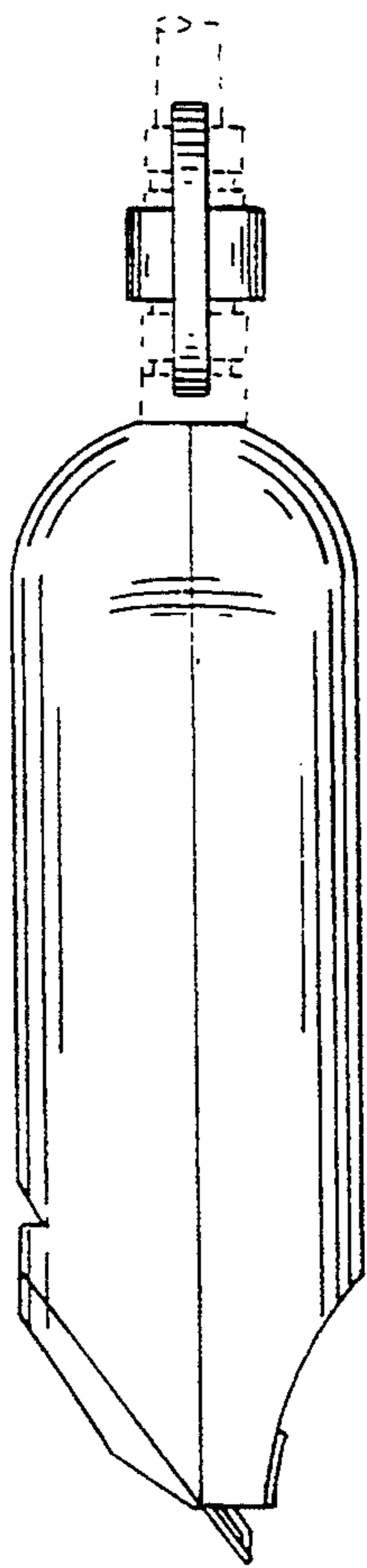

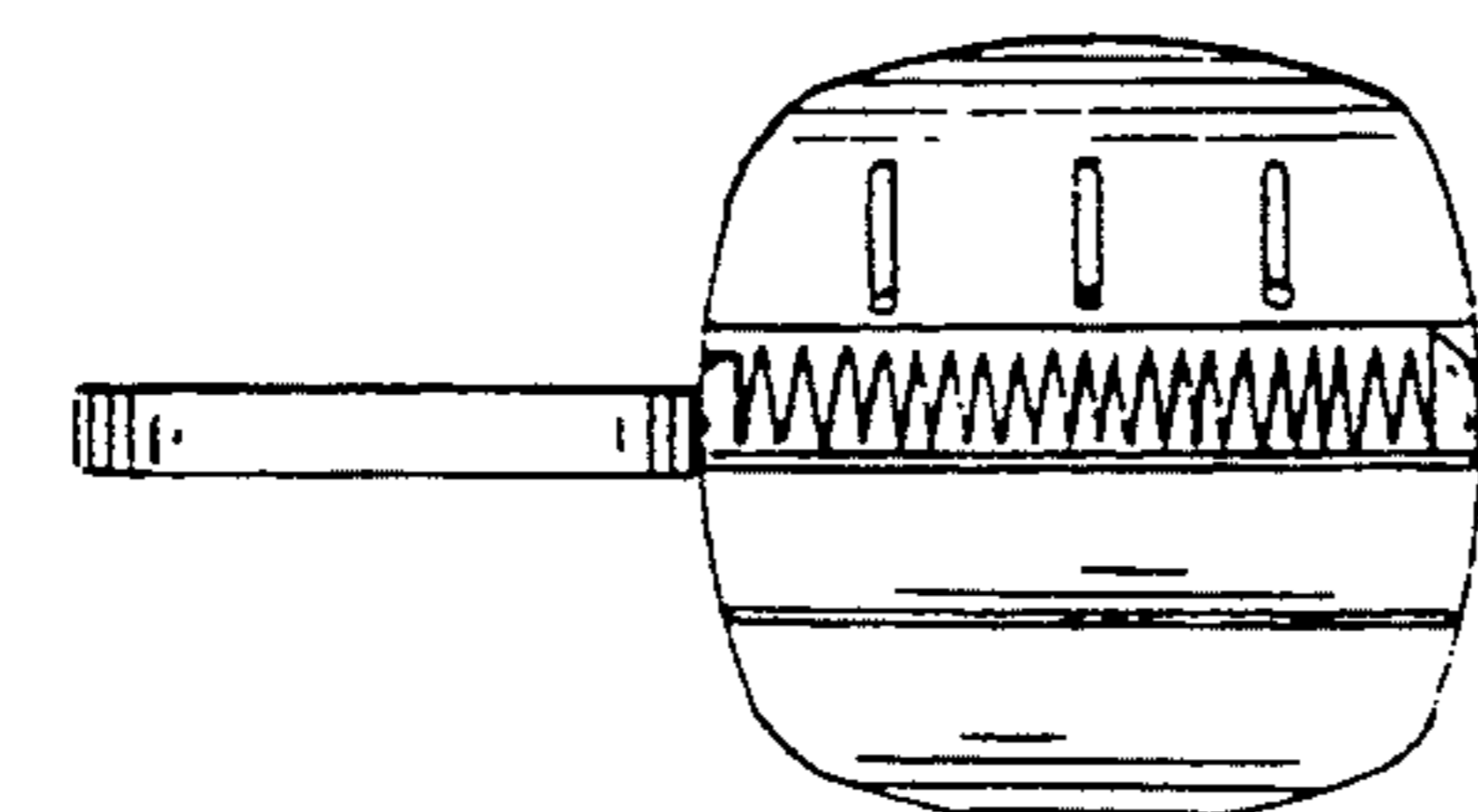

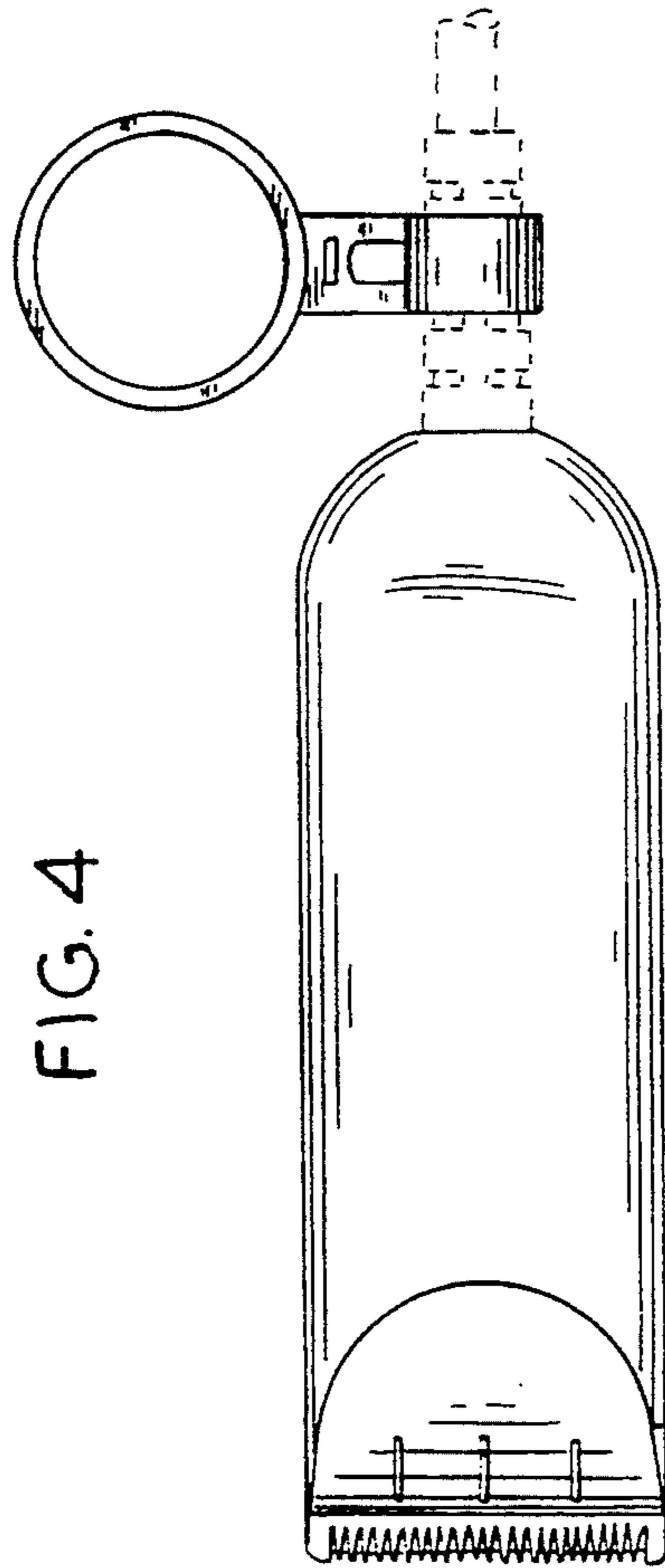

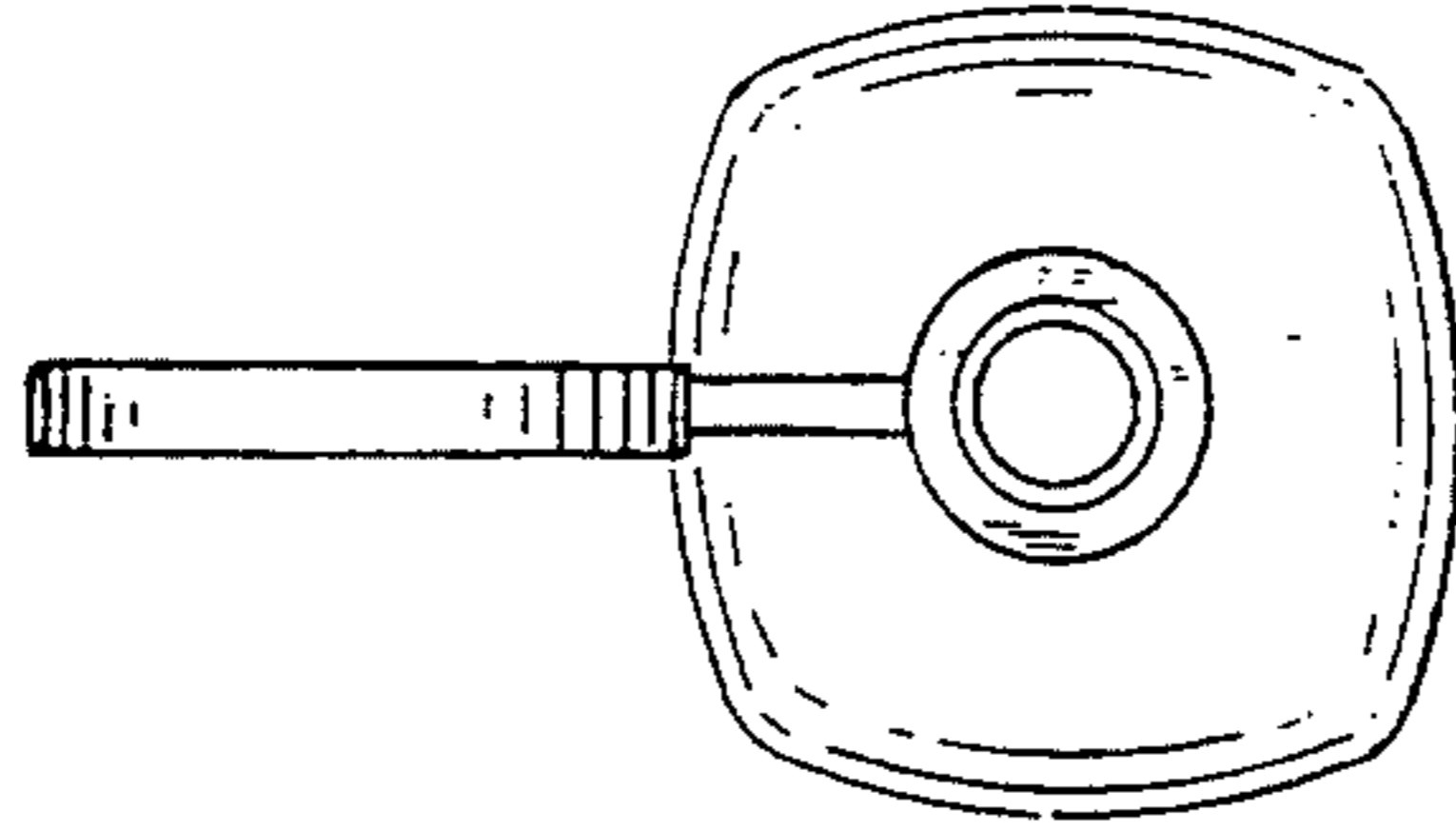

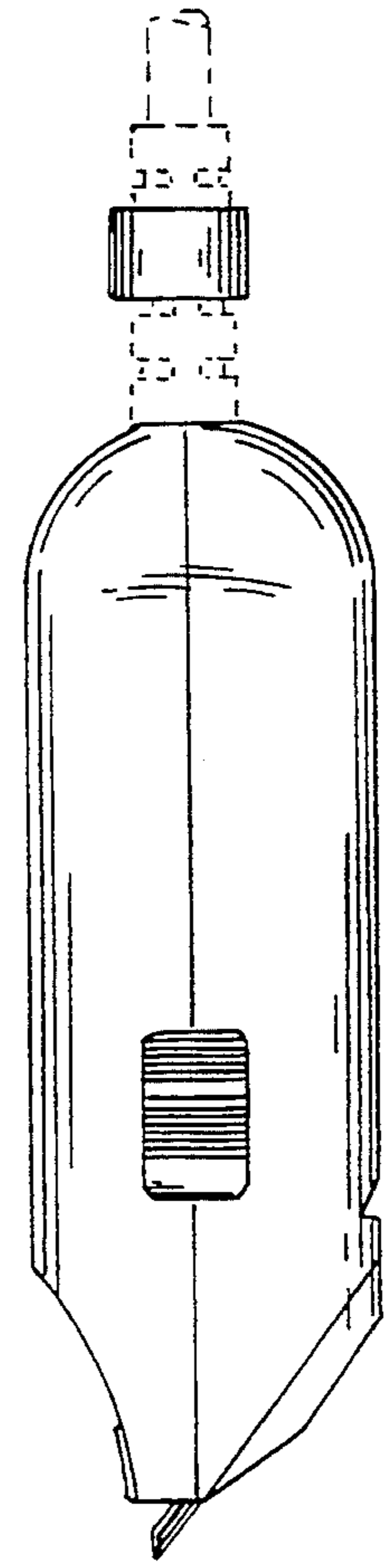

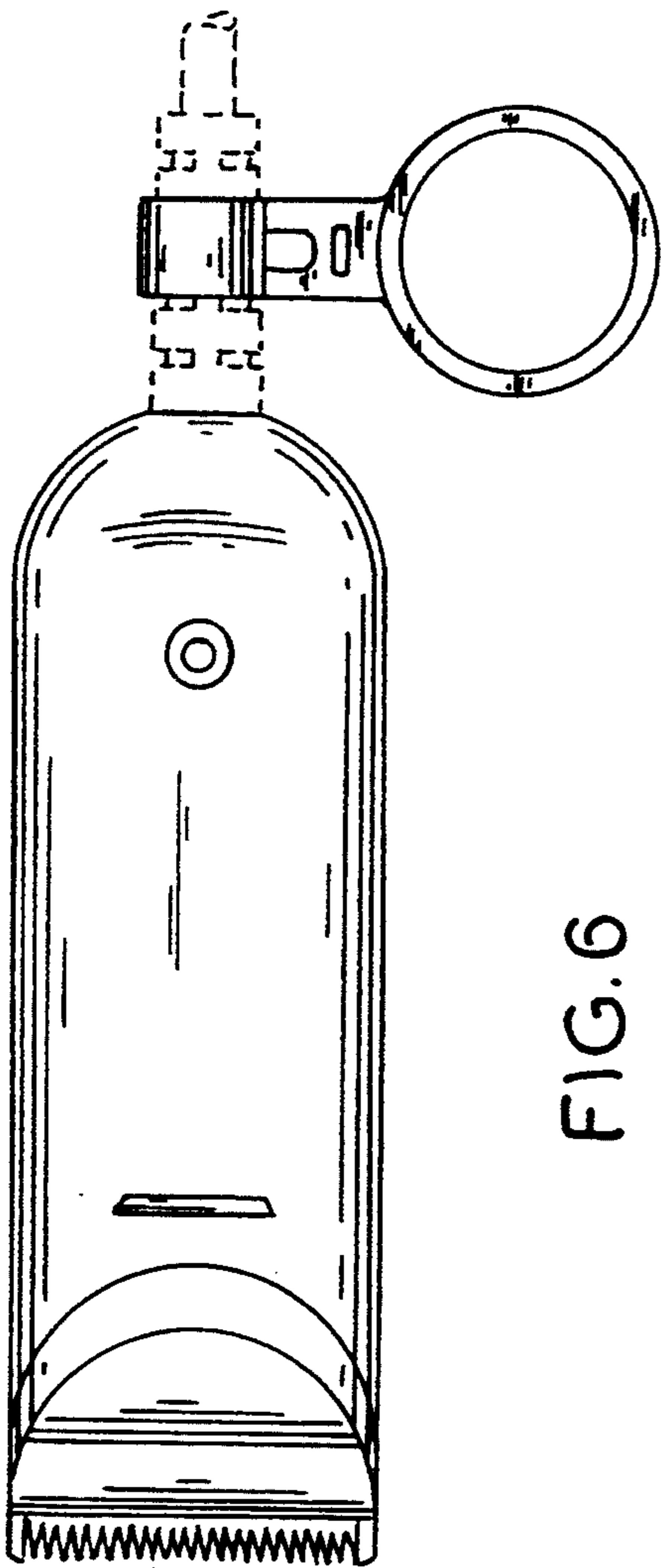

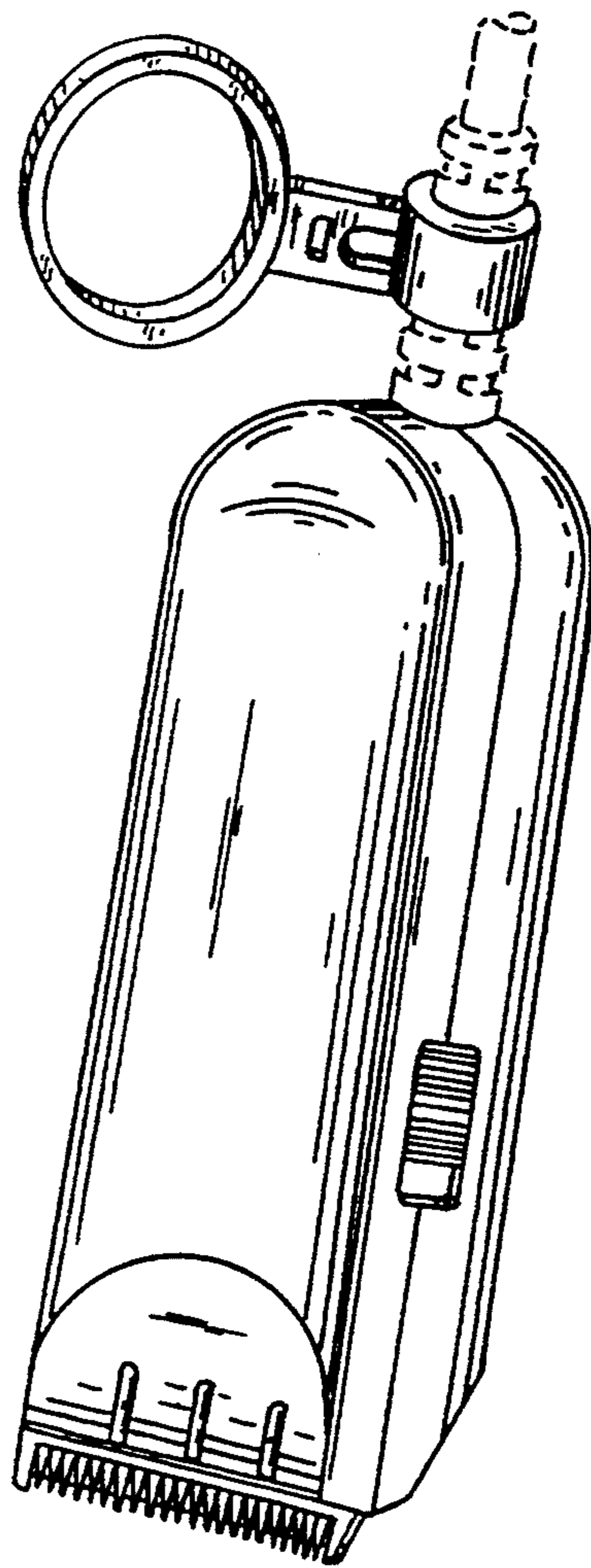
