[57] CLAIM

The ornamental design for a shoe sole, as shown and described.

DESCRIPTION

FIG. 1 is a right side elevational view of a shoe sole showing my new design;
 FIG. 2 is a left side elevational view thereof;
 FIG. 3 is a front elevational view thereof;
 FIG. 4 is a rear elevational view thereof;
 FIG. 5 is a bottom plan view thereof;
 FIG. 6 is a partial cross section taken along the line 6—6 of FIG. 1;
 FIG. 7 is a partial cross section taken along the line 7—7 of FIG. 1;
 FIG. 8 is a partial cross section taken along the line 8—8 of FIG. 1;
 FIG. 9 is a partial cross section taken along the line 9—9 of FIG. 1;
 FIG. 10 is a cross-sectional view taken along the line 10—10 of FIG. 1;
 FIG. 11 is a cross-sectional view taken along the line 11—11 of FIG. 5;
 FIG. 12 is a partial cross section taken along the line 12—12 of FIG. 5;
 FIG. 13 is a partial cross section taken along the line 13—13 of FIG. 5;
 FIG. 14 is a partial cross section taken along the line 14—14 of FIG. 5;
 FIG. 15 is a partial cross section taken along the line 15—15 of FIG. 5; and,

The broken line showing of a shoe upper in FIGS. 1-4 is for illustrative purposes only and forms no part of the claimed design.

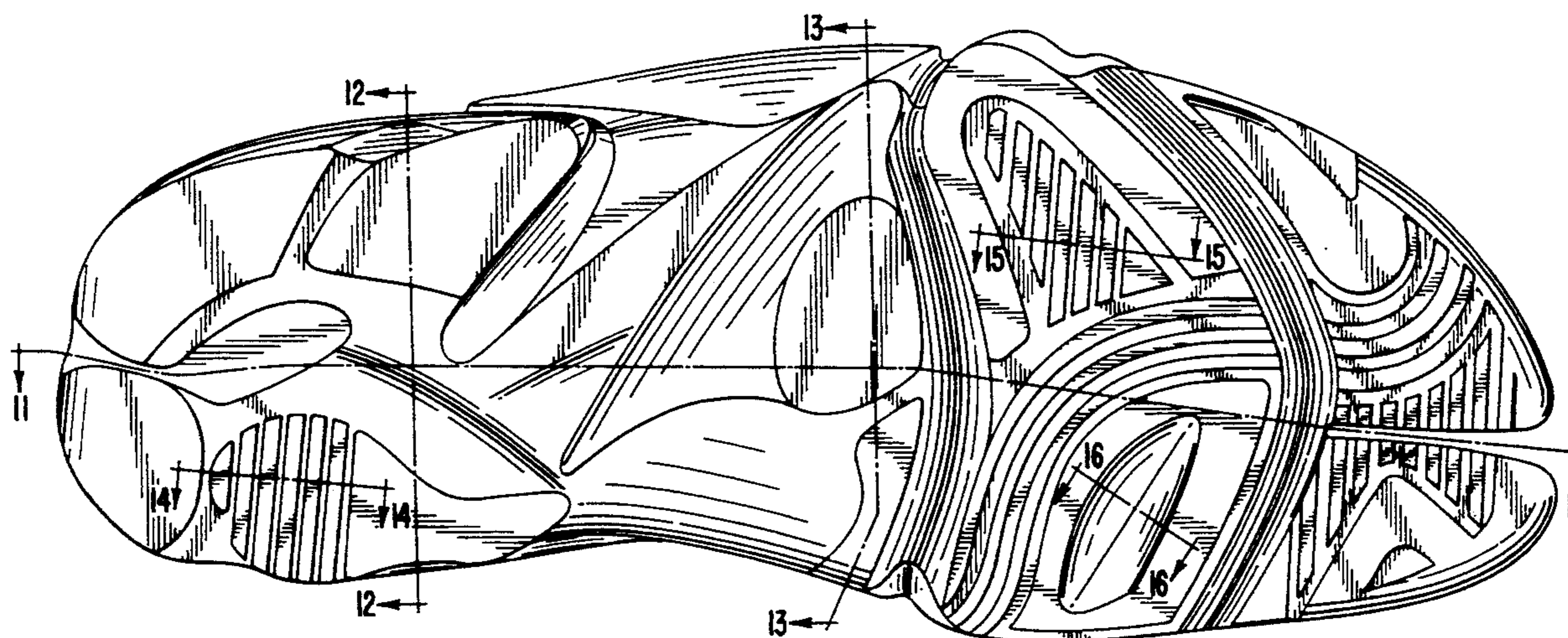
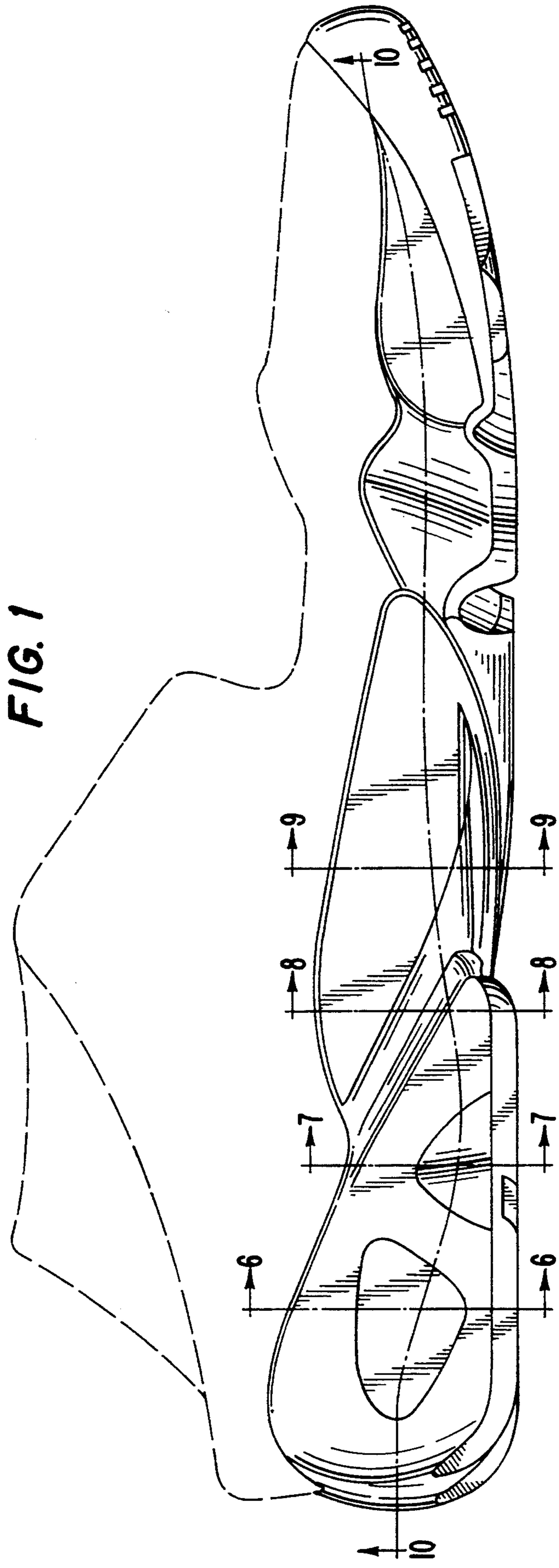

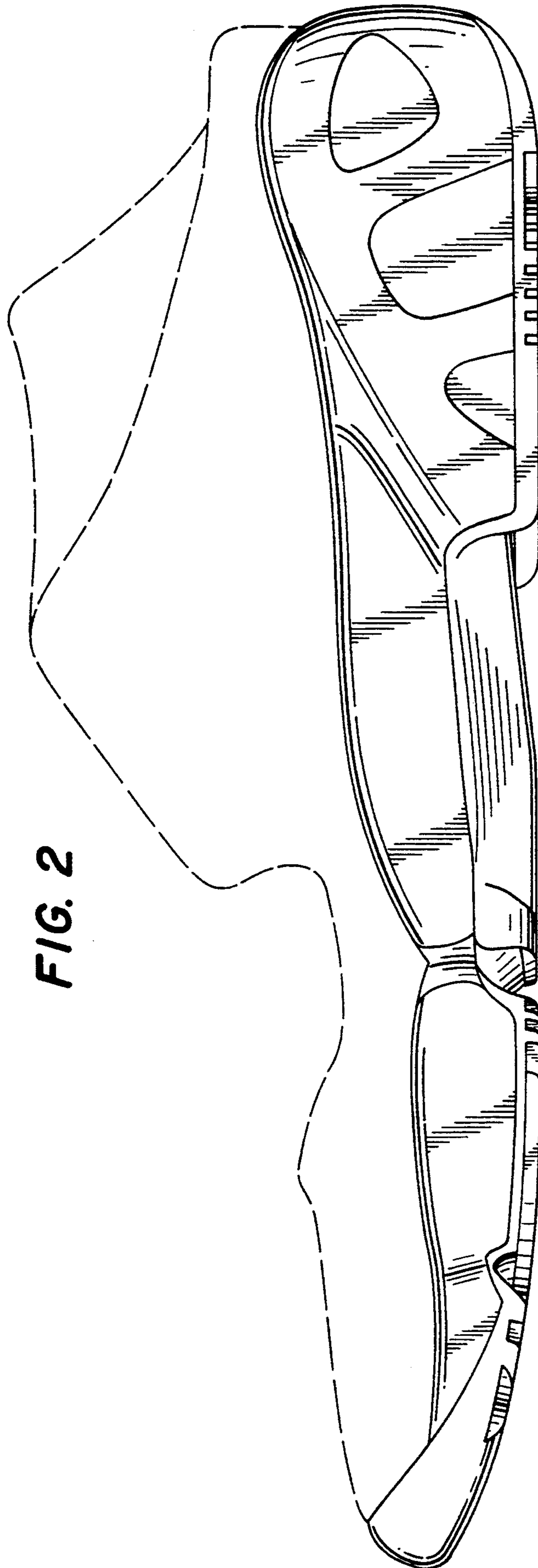

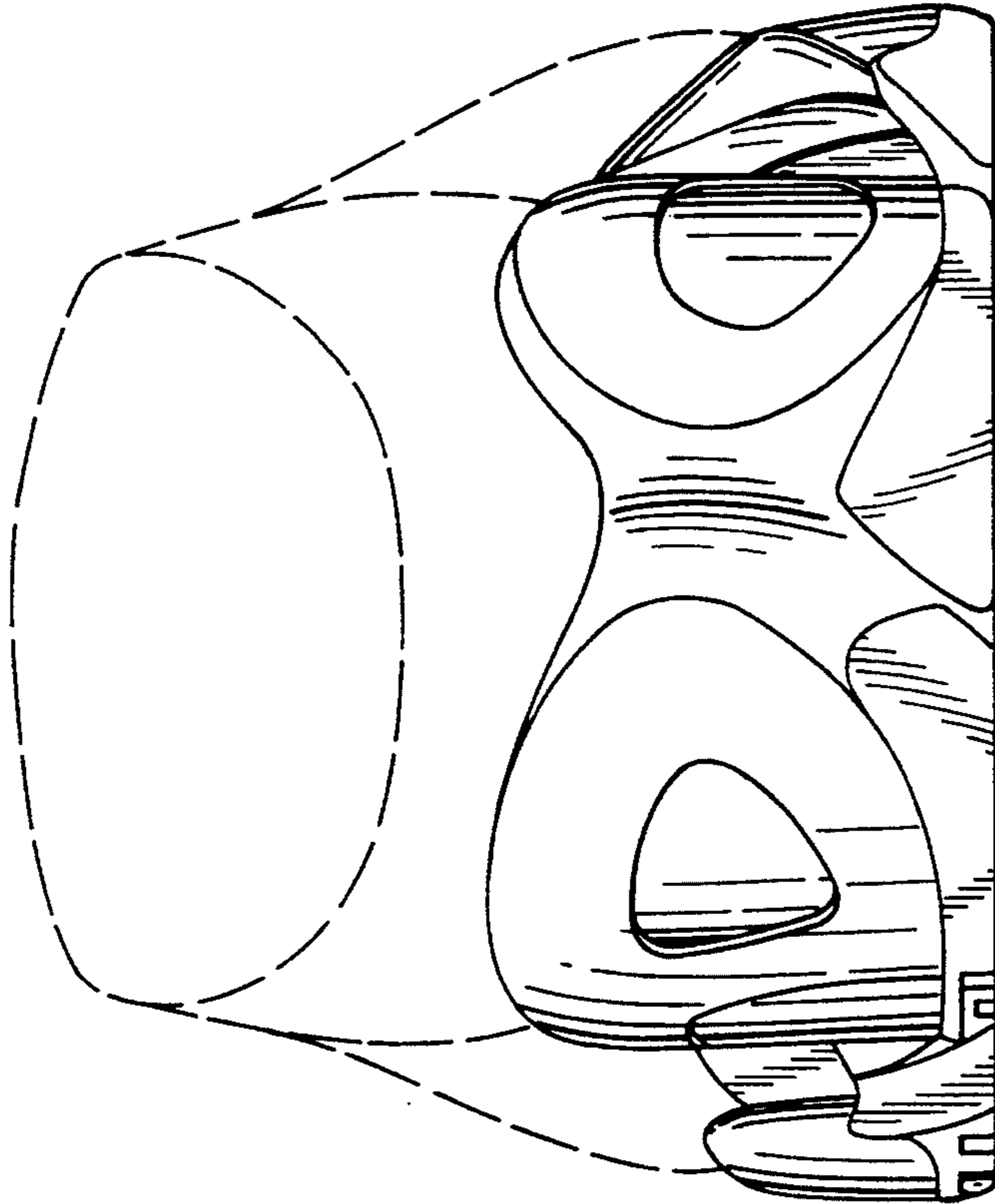

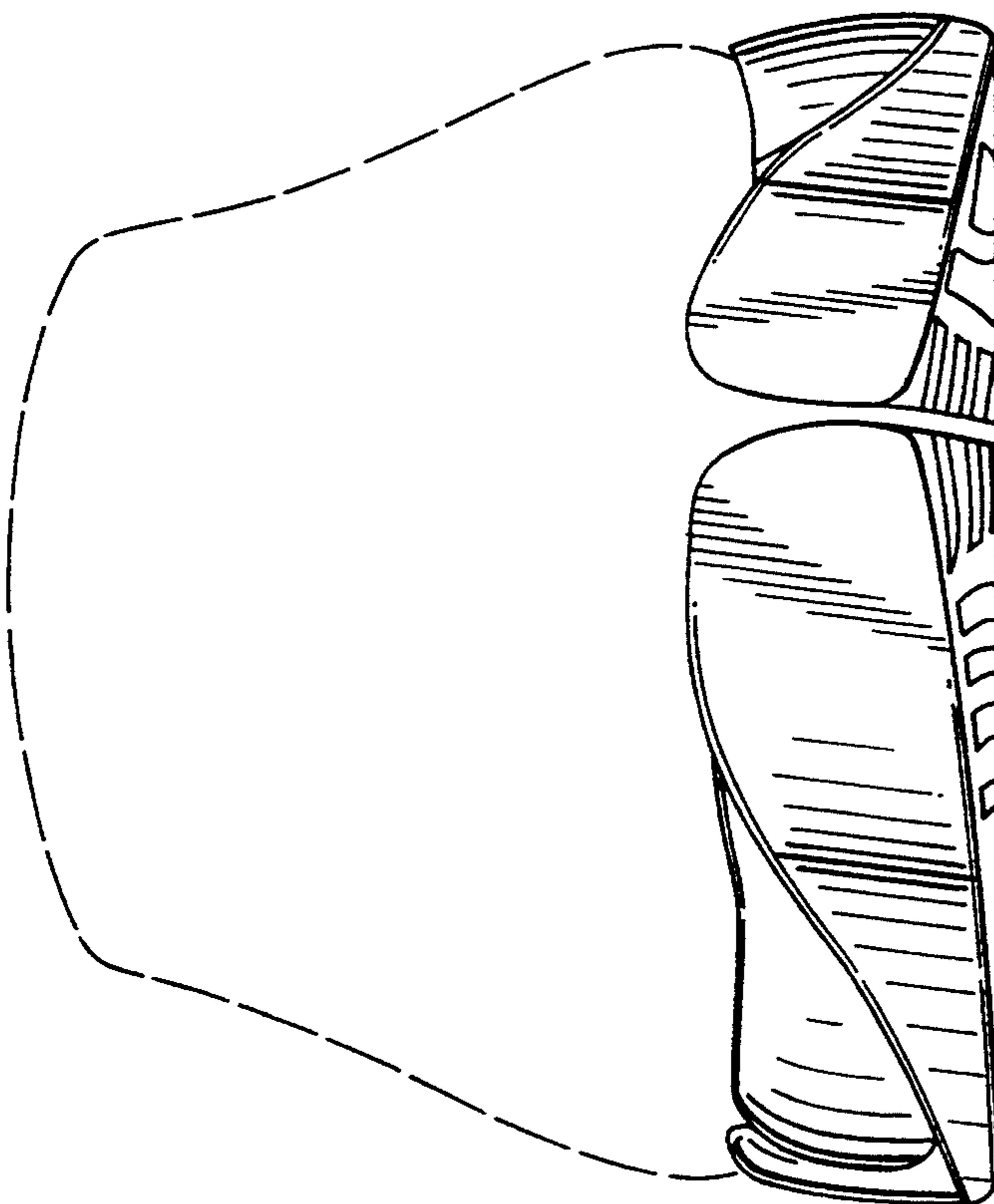

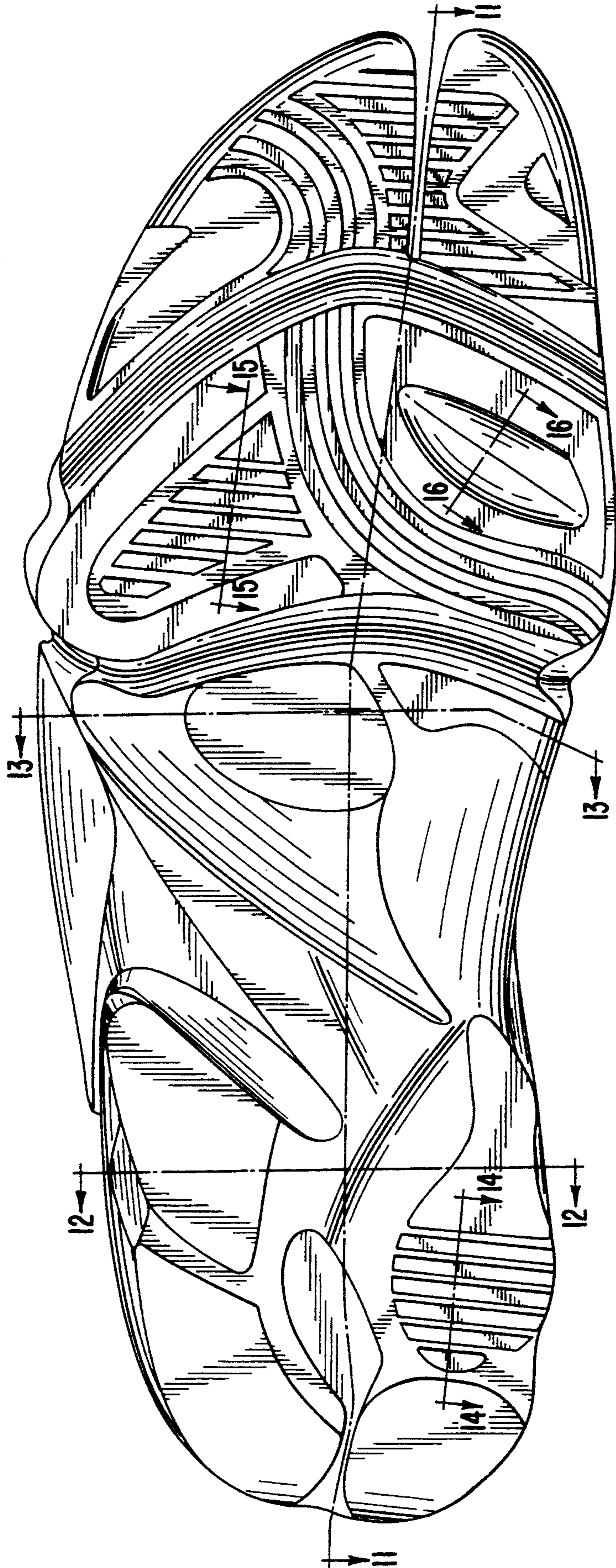

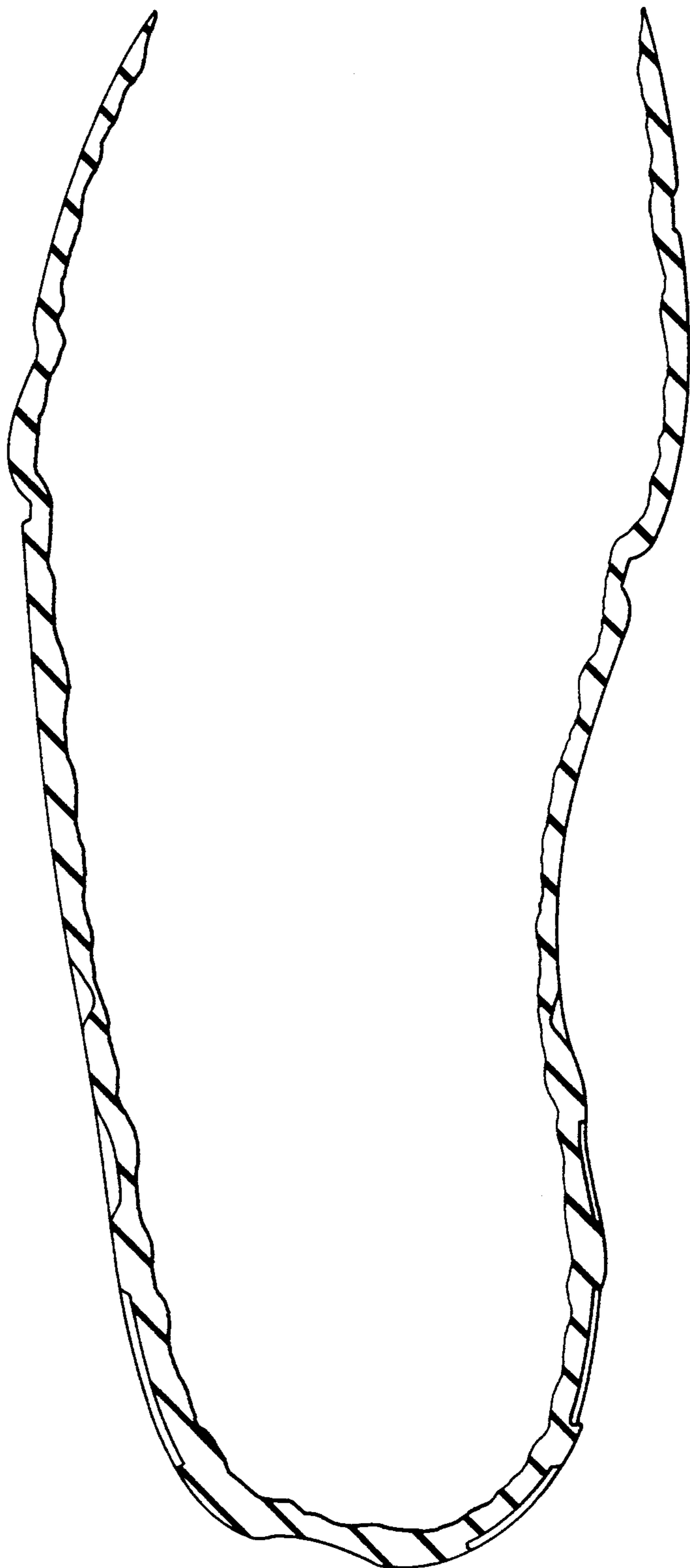

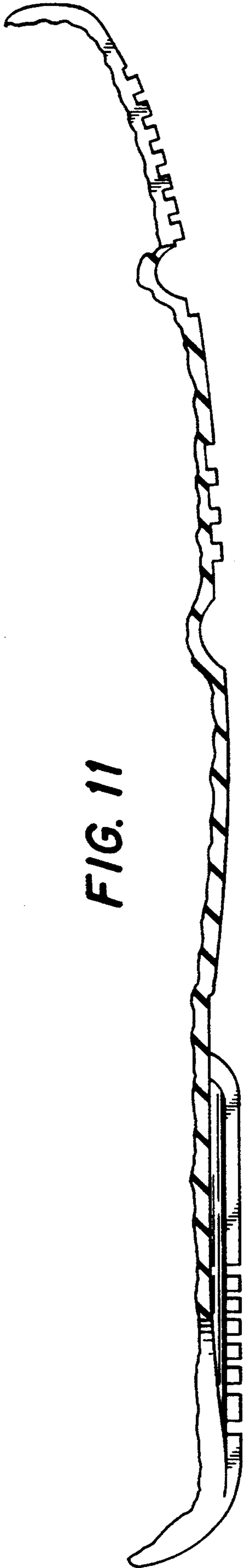
