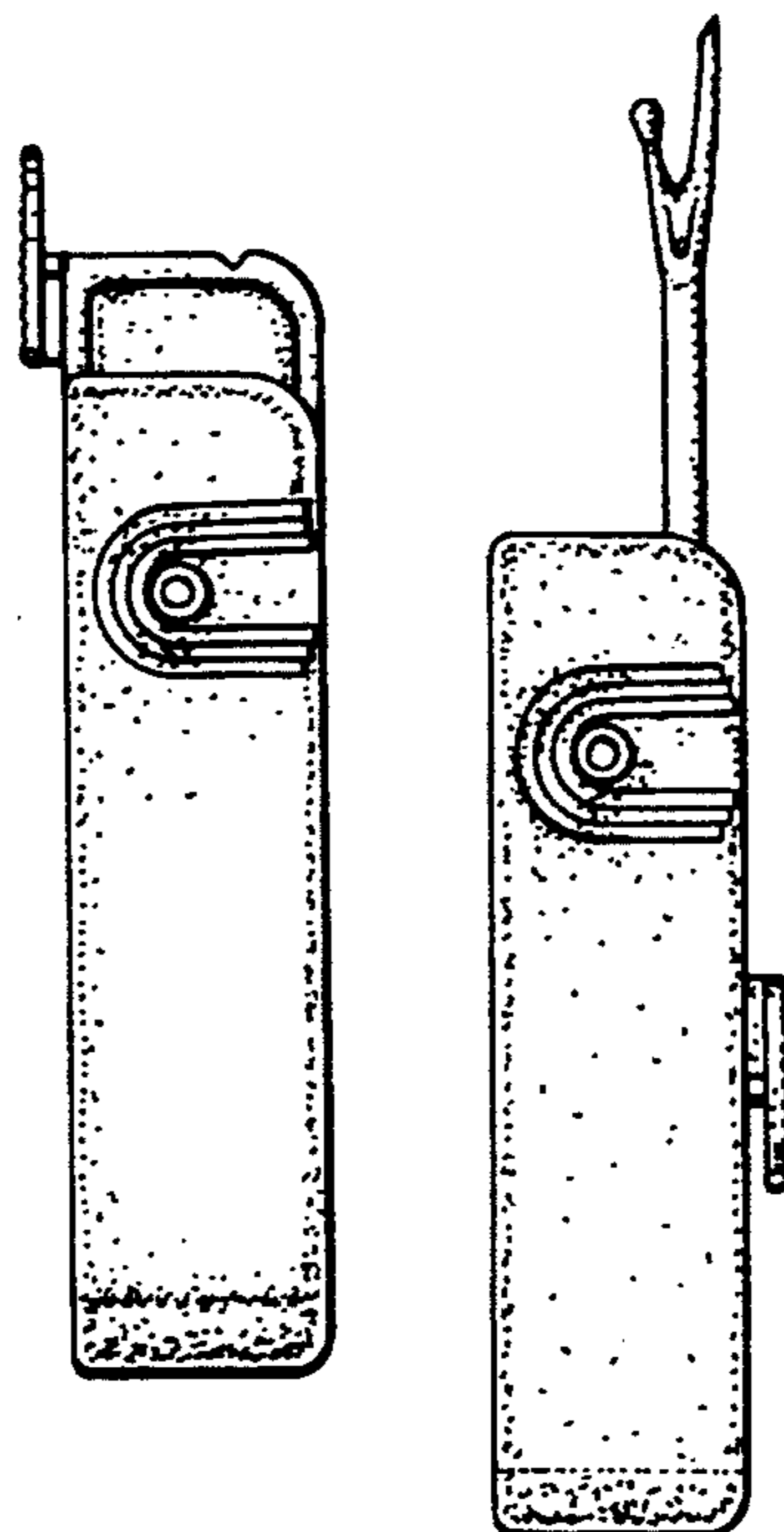

DESCRIPTION

FIG. 1 is a side view in elevation in closed configuration;
 FIG. 2 is a top plan view in closed configuration;
 FIG. 3 is a bottom plan view in closed configuration;
 FIG. 4 is a front view in elevation in closed configuration;
 FIG. 5 is a rear view in elevation in closed configuration;
 FIG. 6 is a side view in elevation in open configuration;
 FIG. 7 is a top plan view in open configuration;
 FIG. 8 is a bottom plan view in open configuration;
 FIG. 9 is a front view in elevation in open configuration; and,
 FIG. 10 is a rear view in elevation in open configuration.



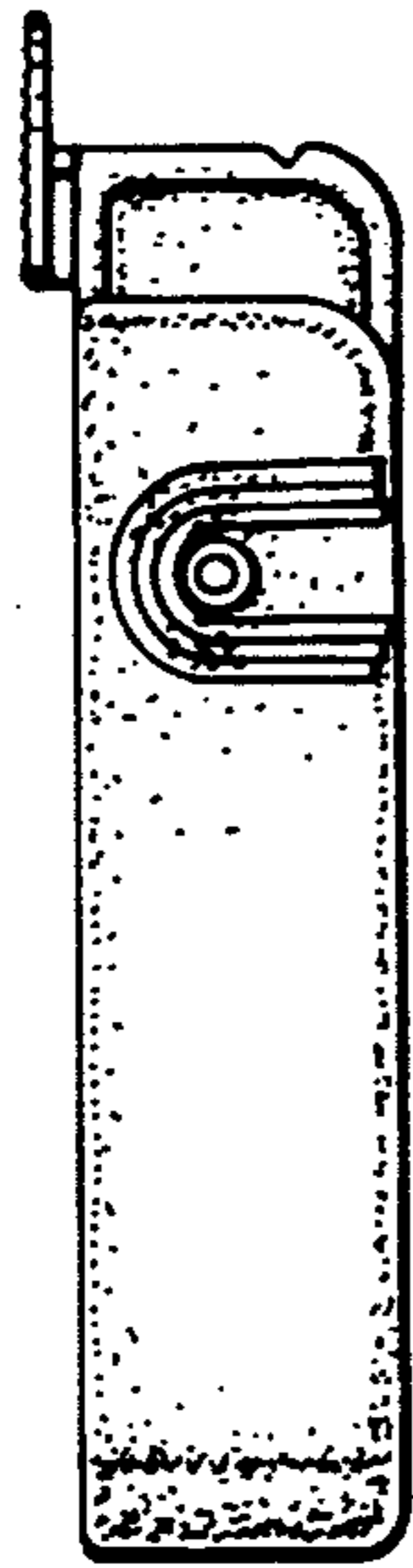

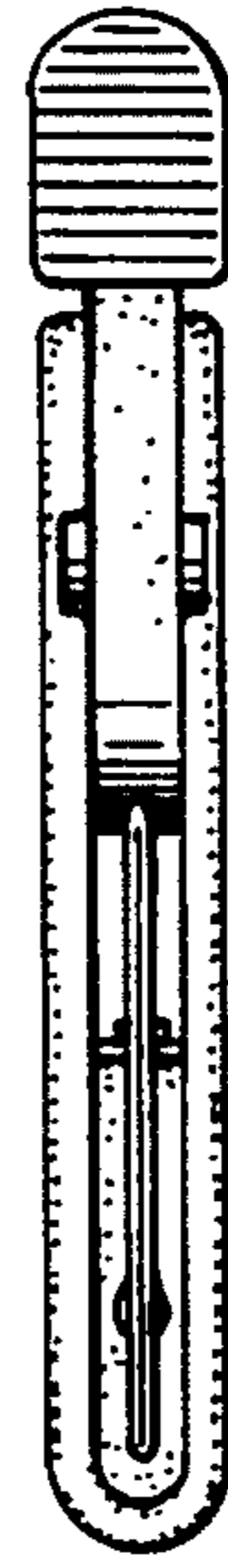

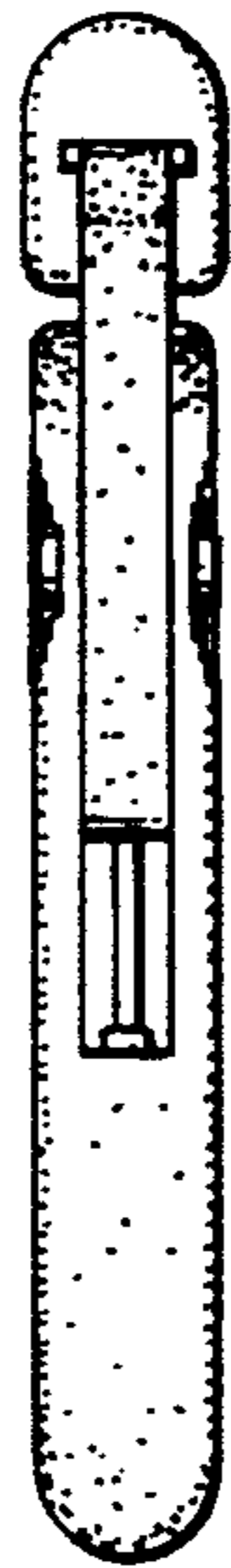

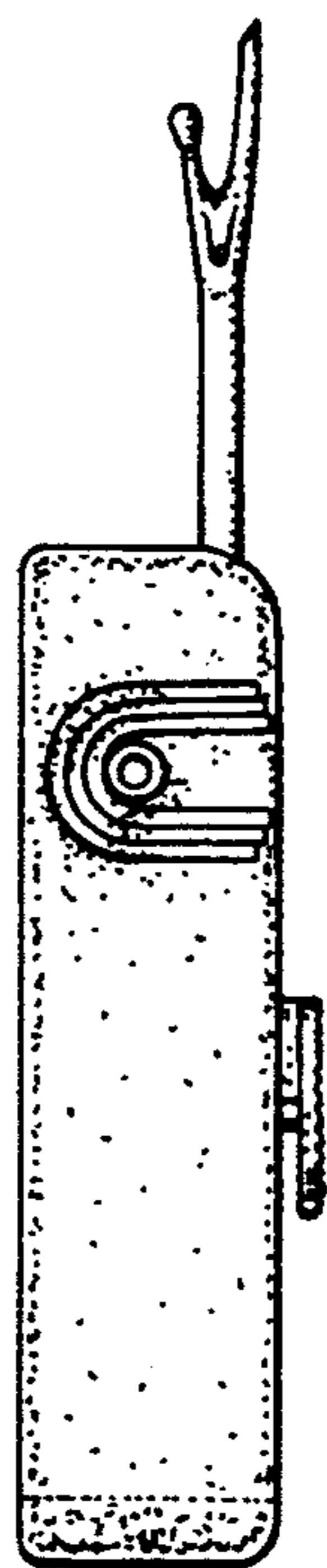

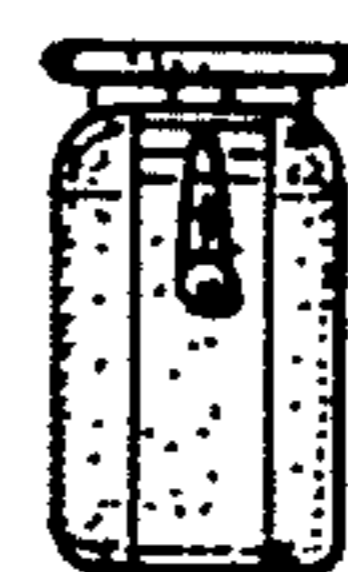

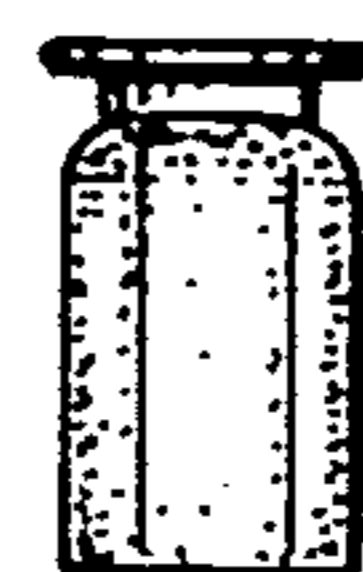
