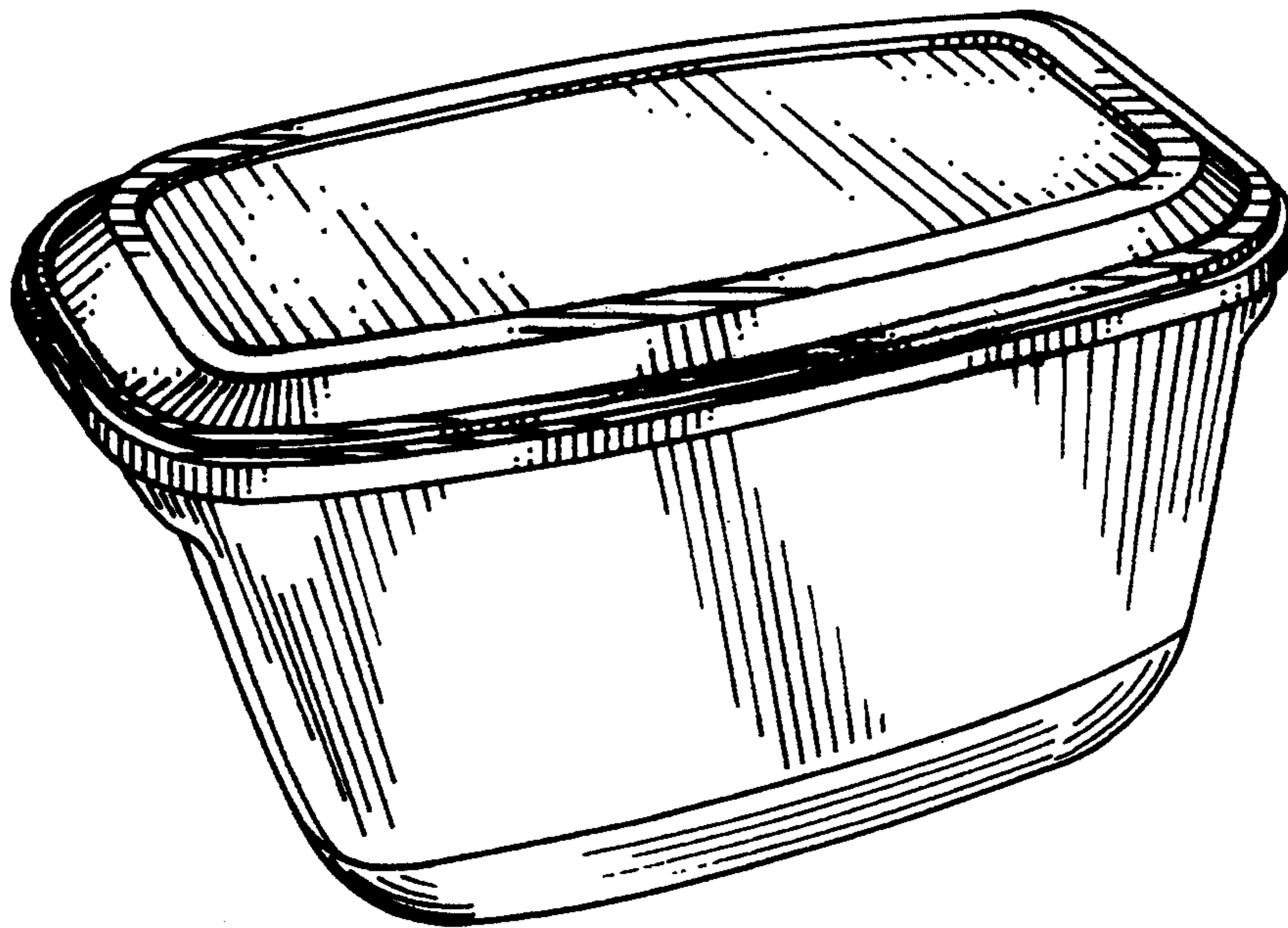

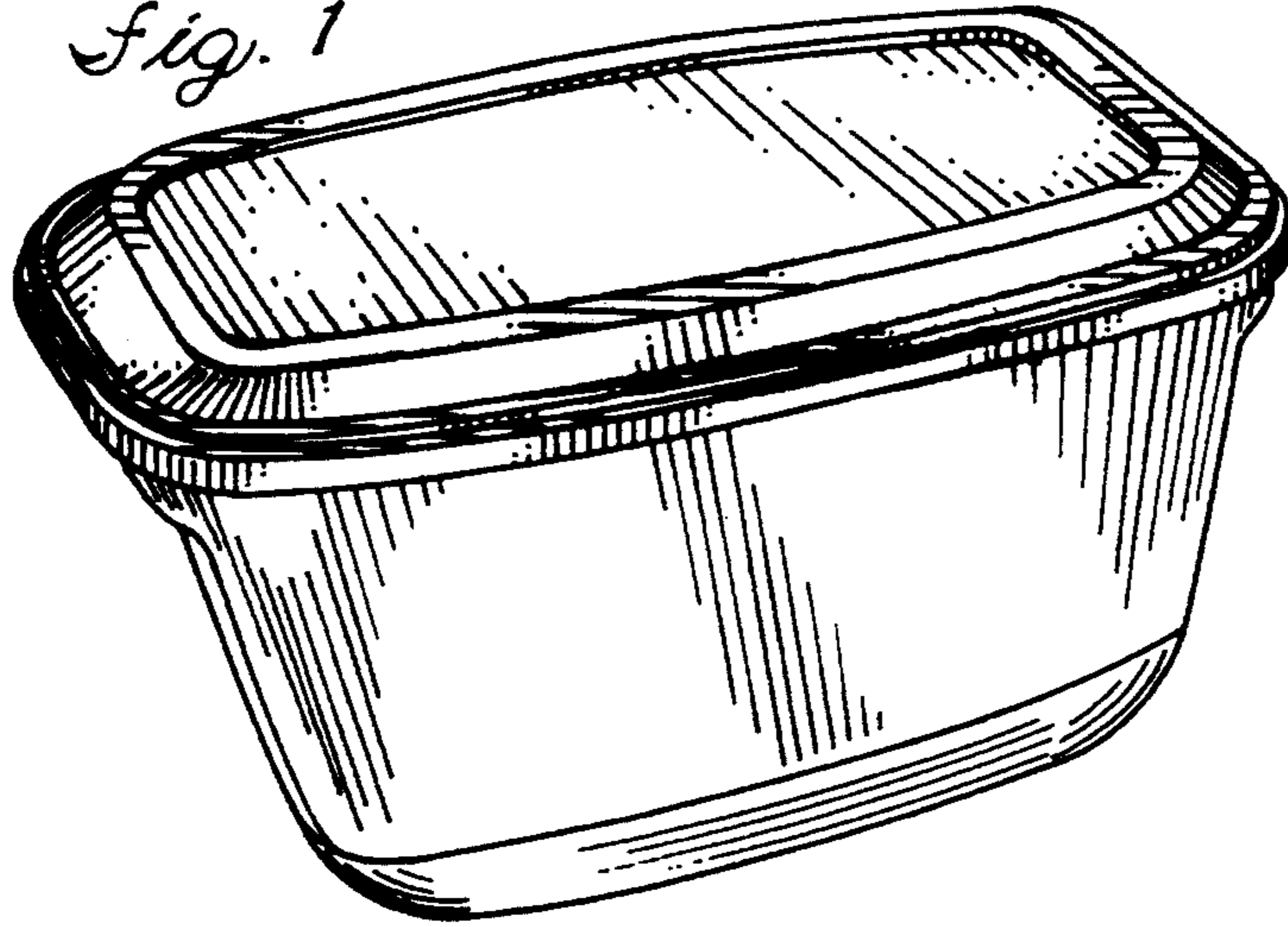

### DESCRIPTION

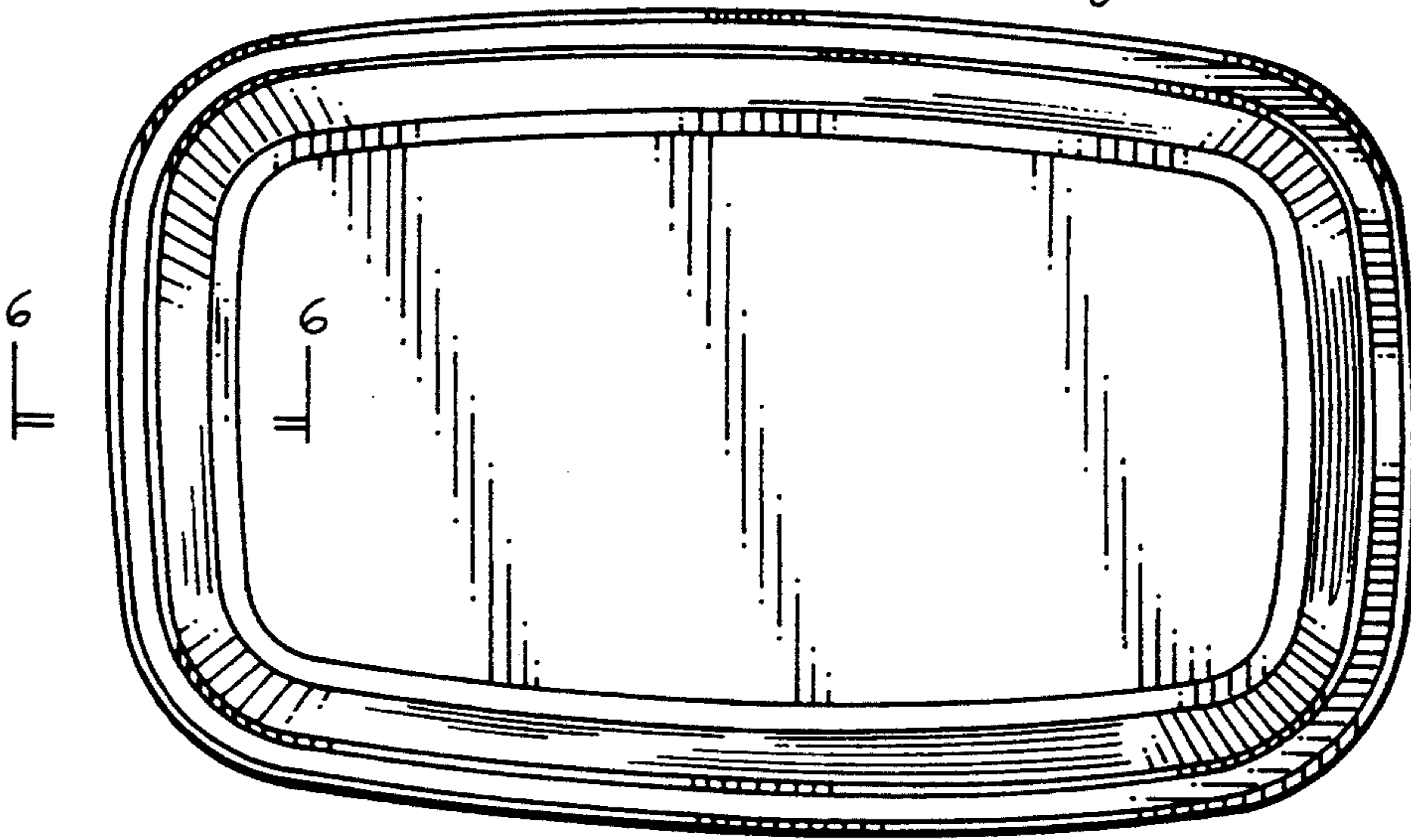
FIG. 1 is a perspective view of a container showing our new design;

FIG. 6 is a fragmentary cross-sectional view taken along line 6—6 of FIG. 2.



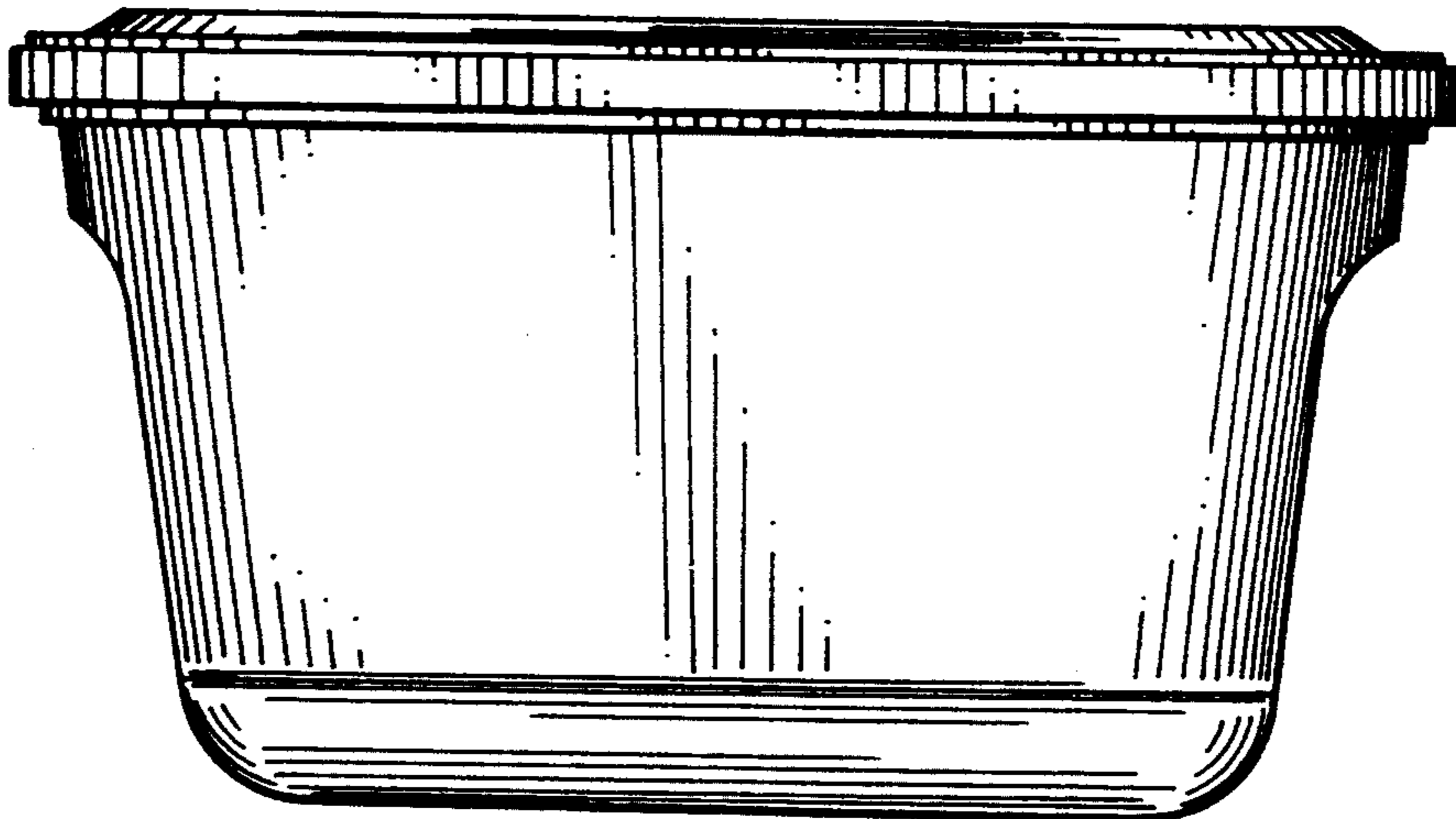

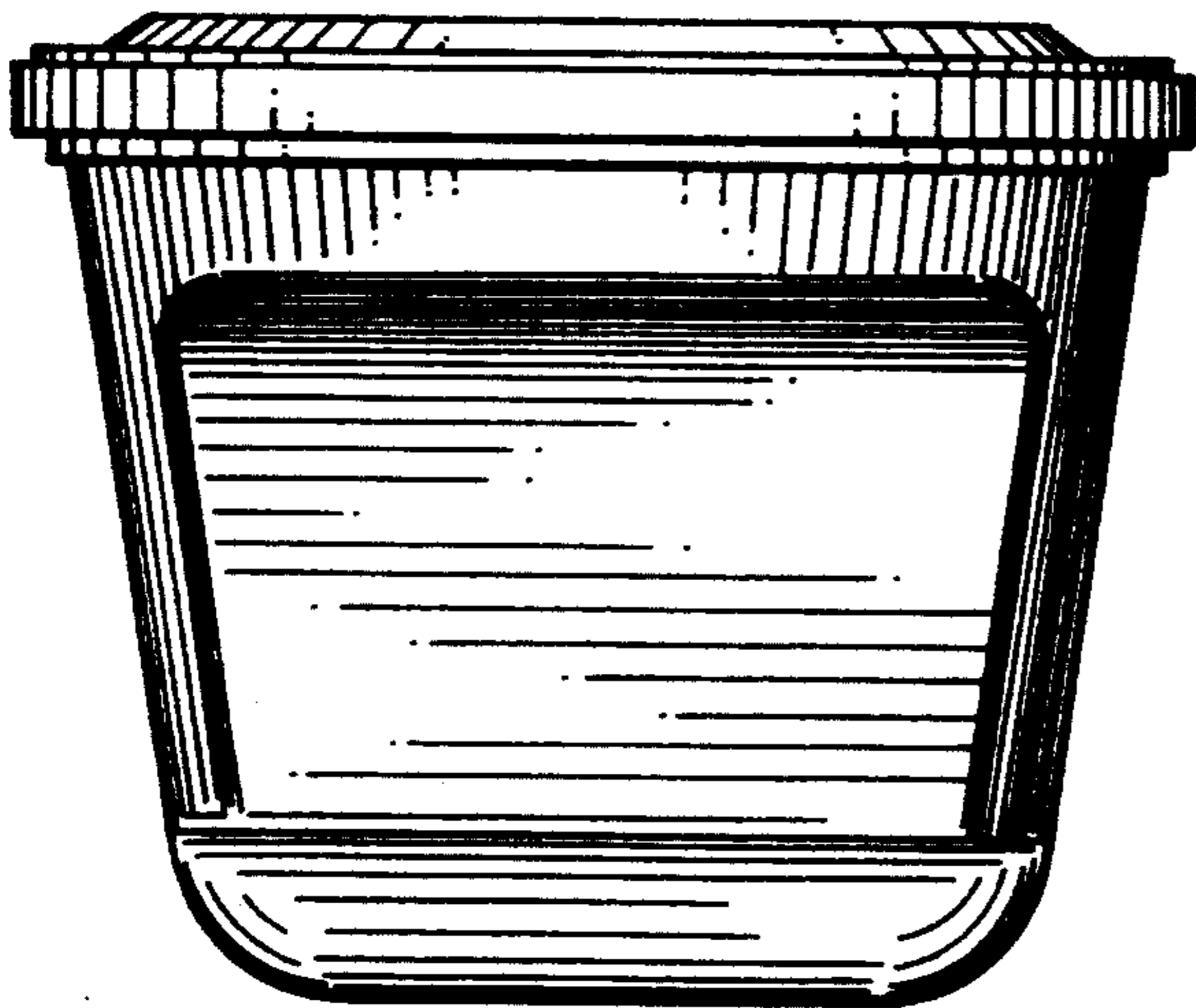
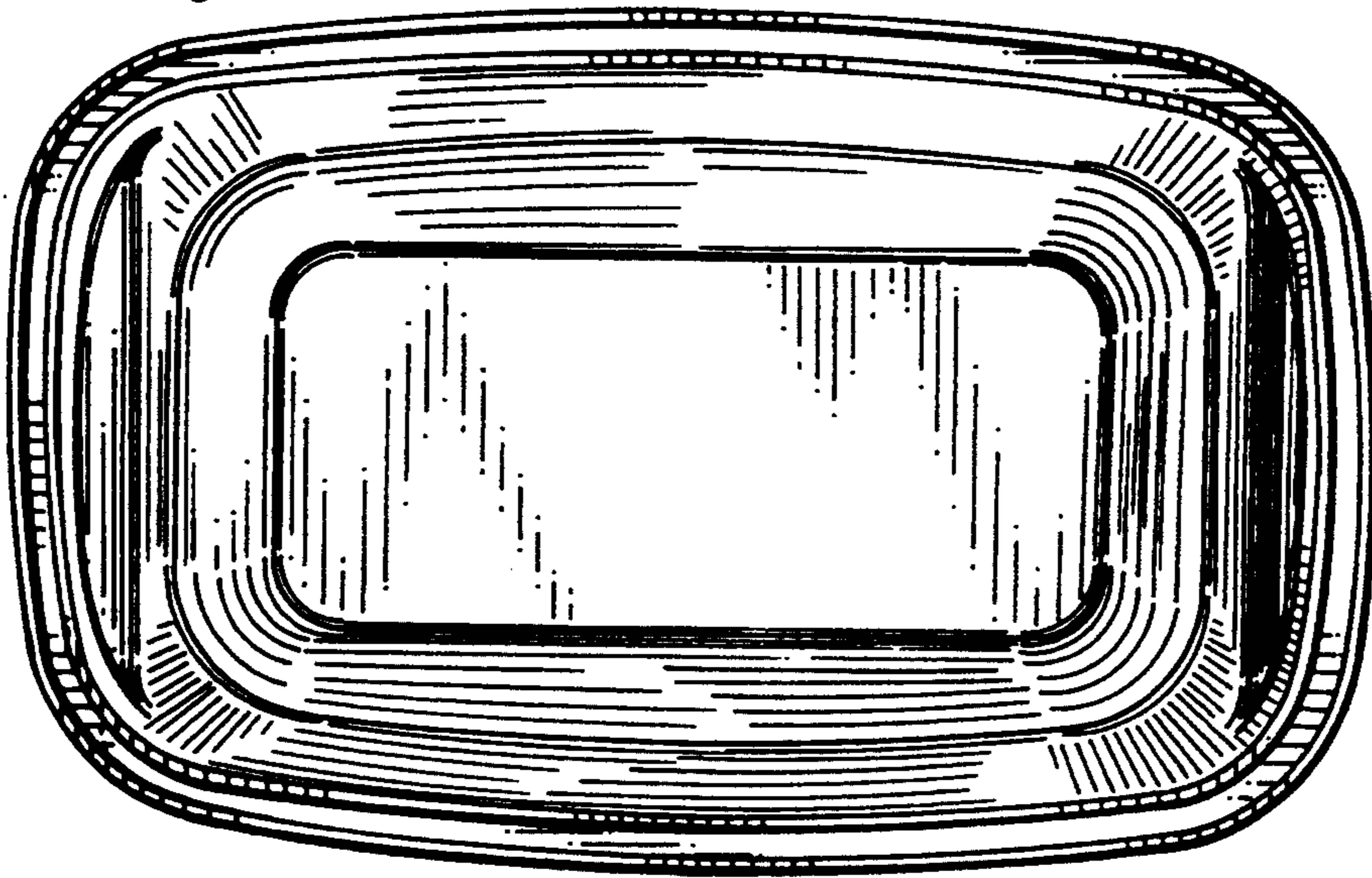

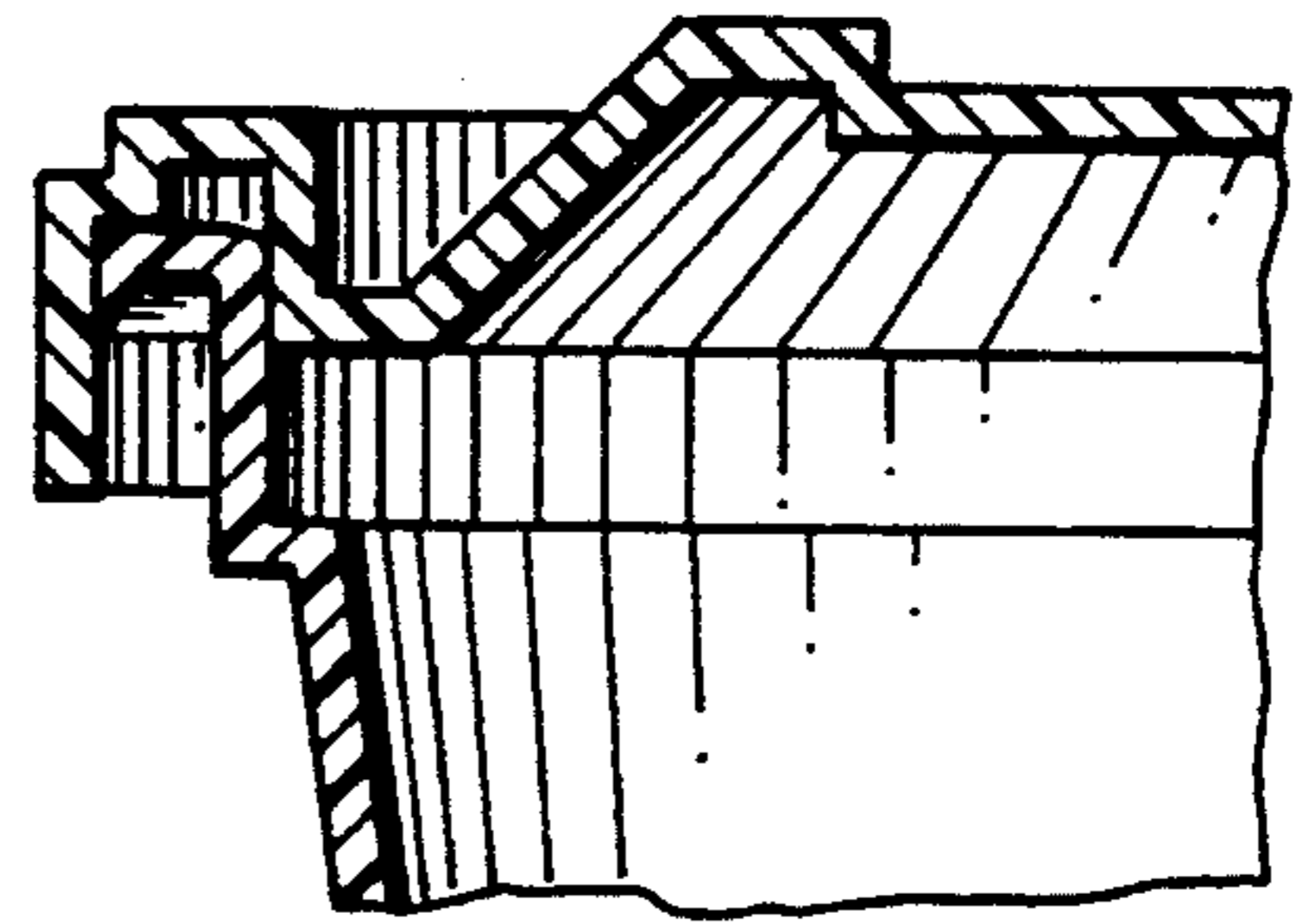
