The ornamental design for a sub-unit for data transmission, as shown and described.

### DESCRIPTION

FIG. 1 is a front, top and right side perspective view of a sub-unit for data transmission showing our new design;

FIG. 2 is a top plan view thereof;

FIG. 3 is a front elevational view thereof;

FIG. 4 is a left side elevational view thereof;

FIG. 5 is a right side elevational view thereof;

FIG. 14 is a right side elevational view thereof.

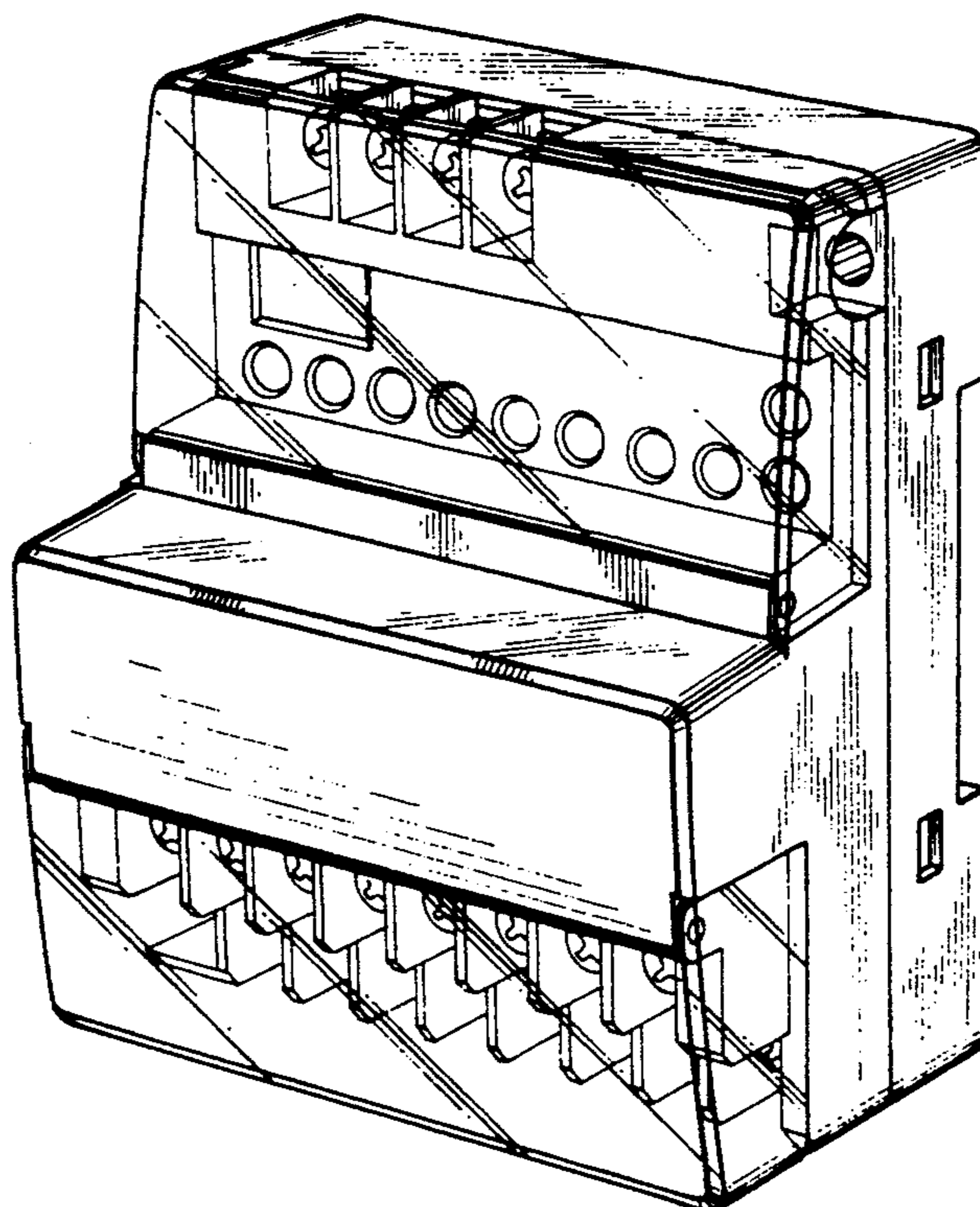

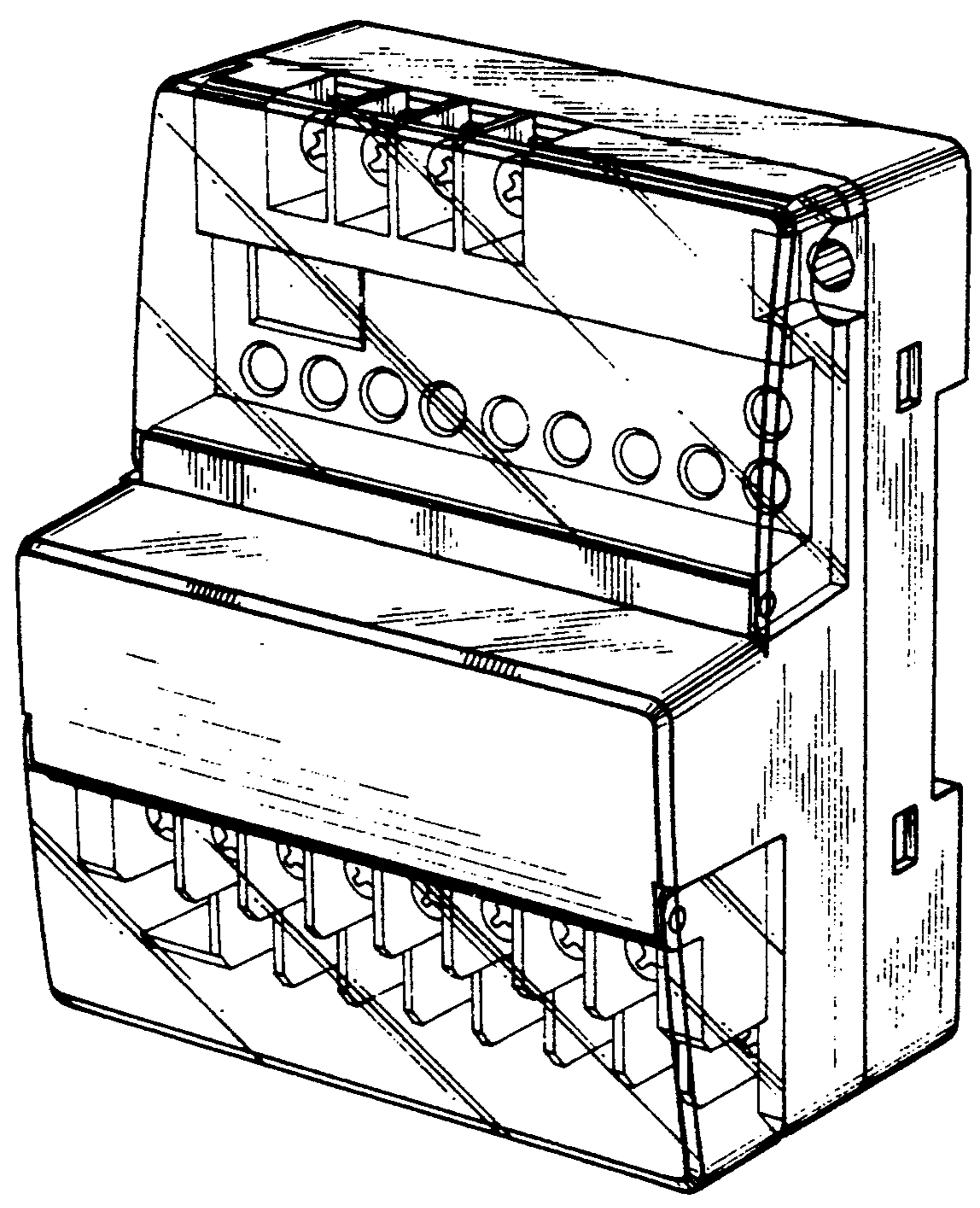
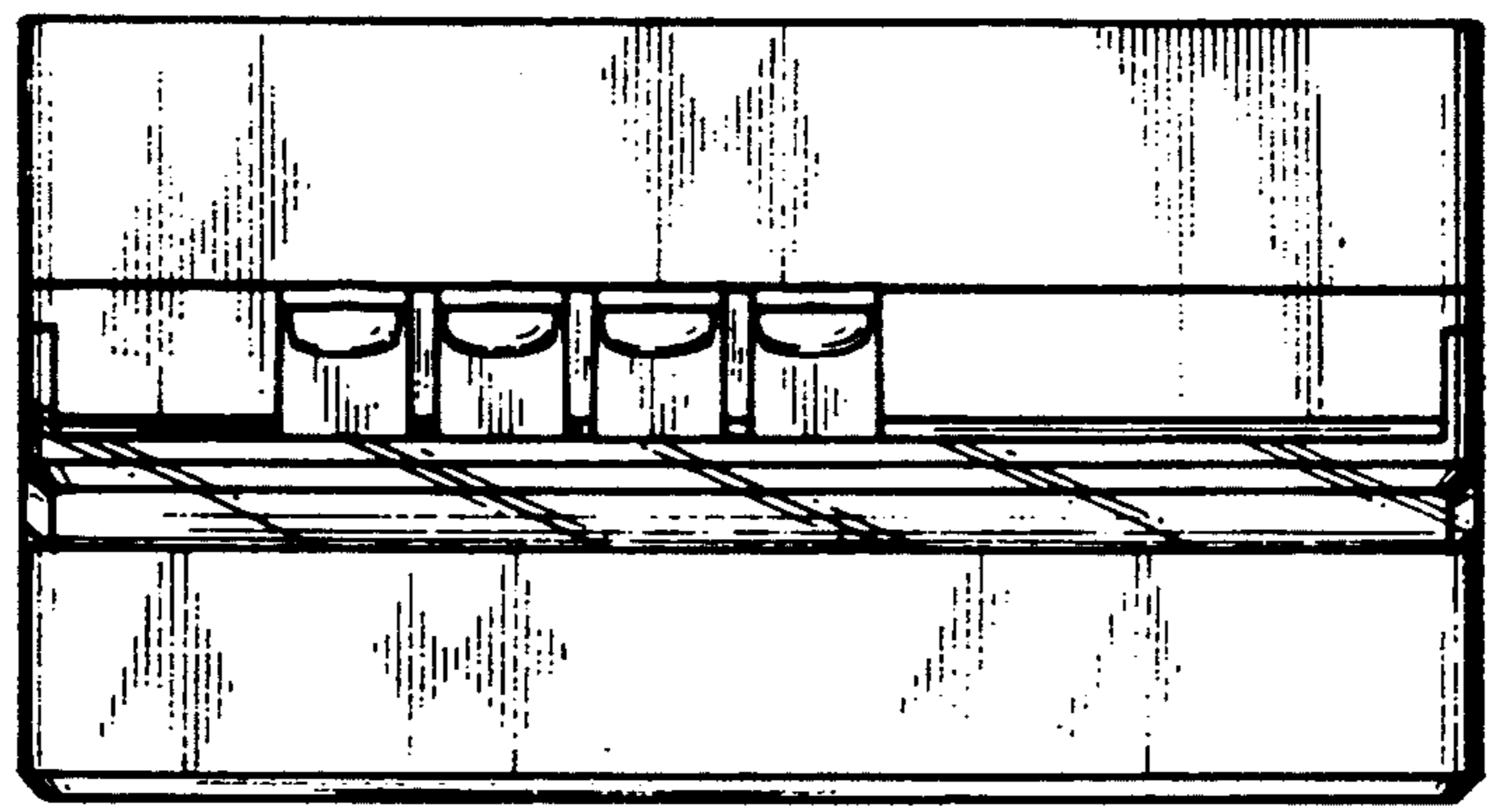
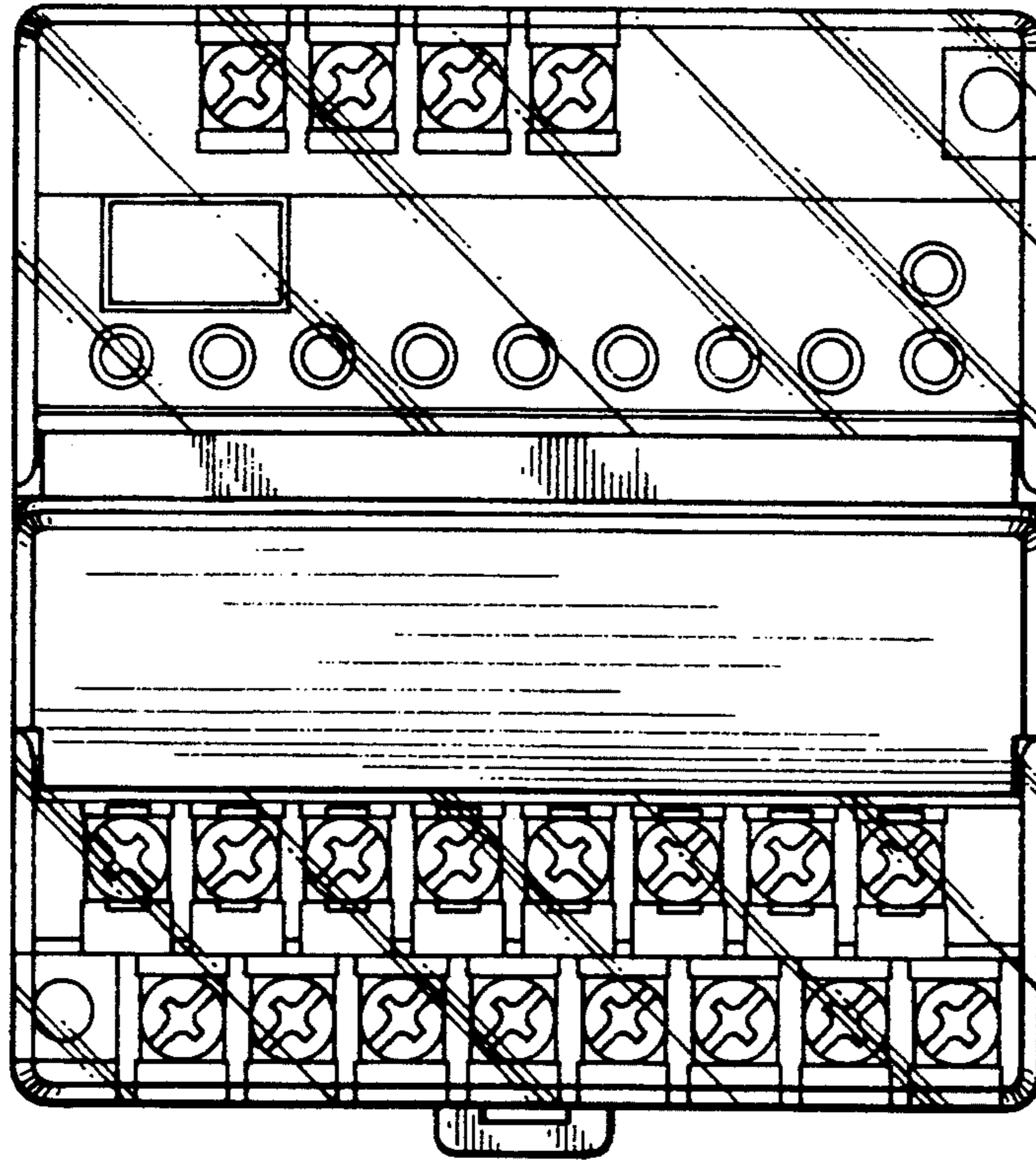


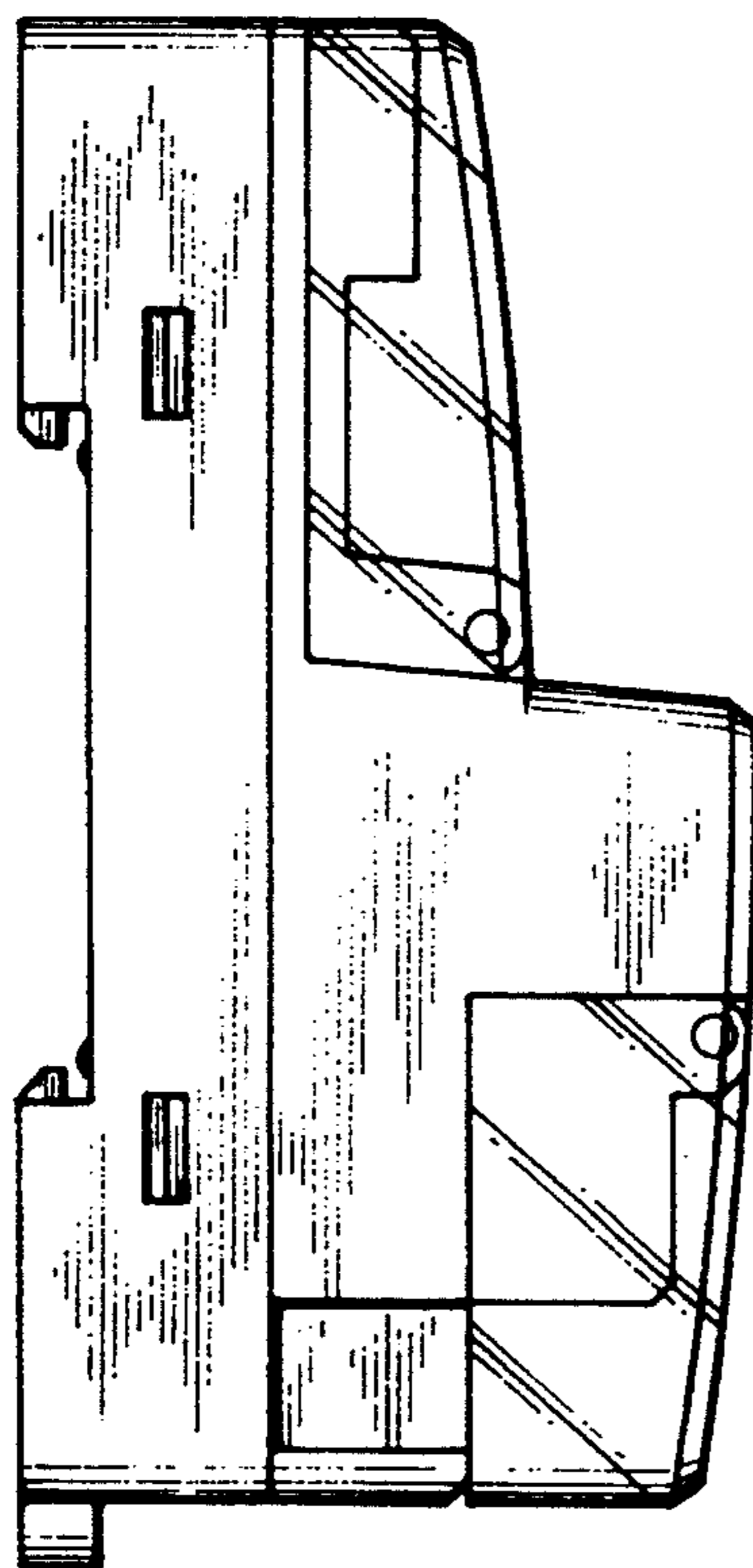

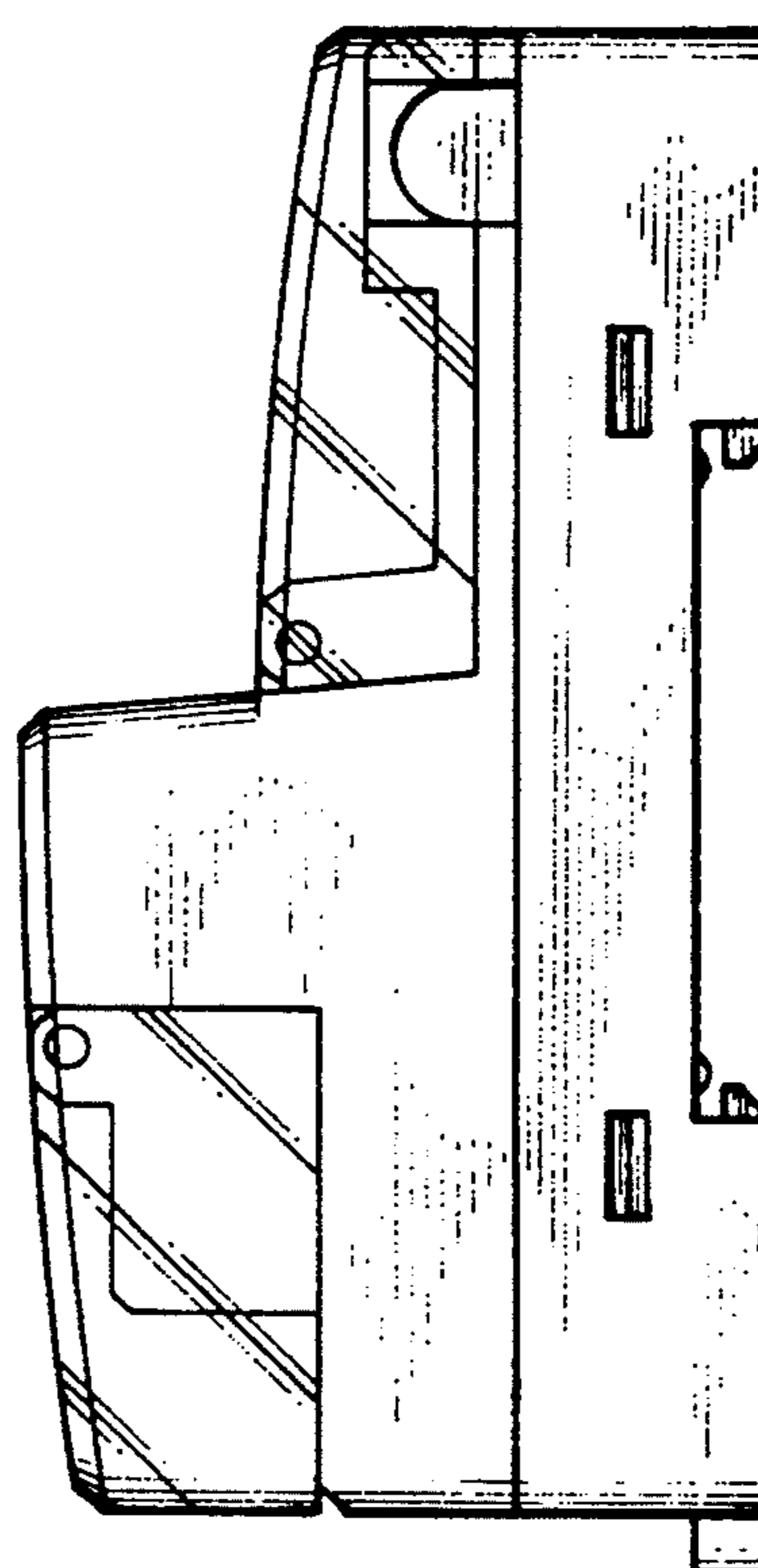

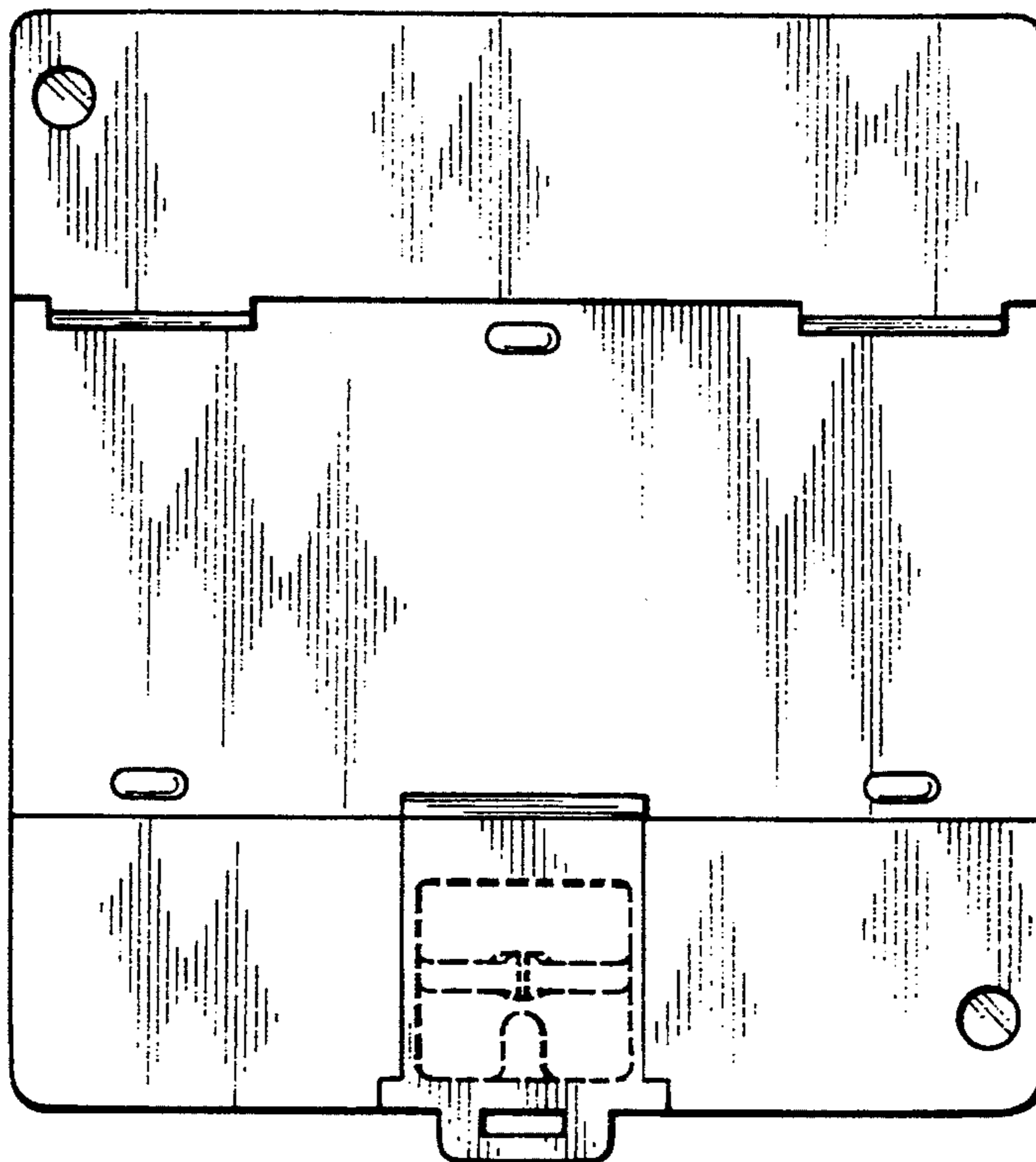

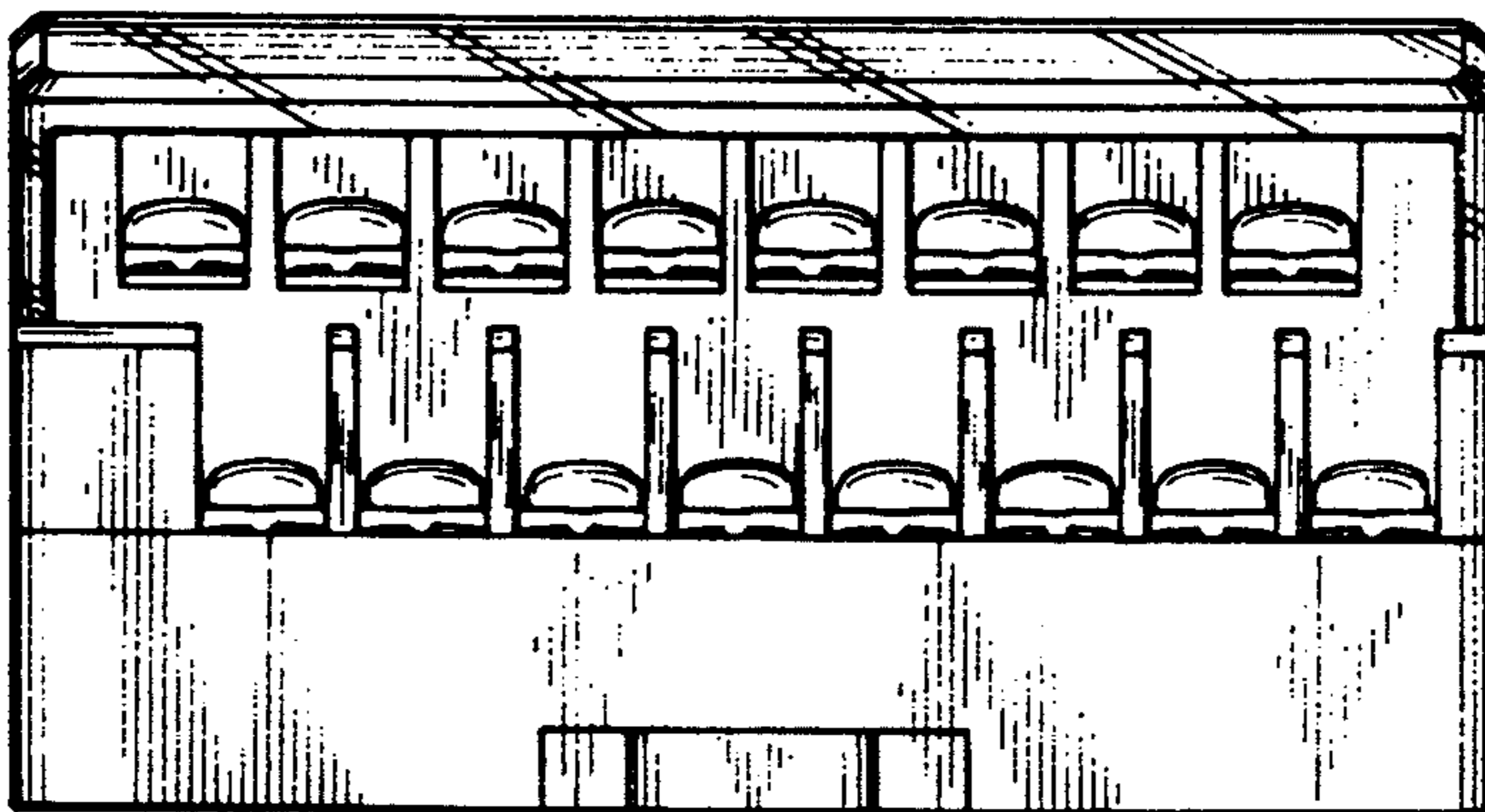

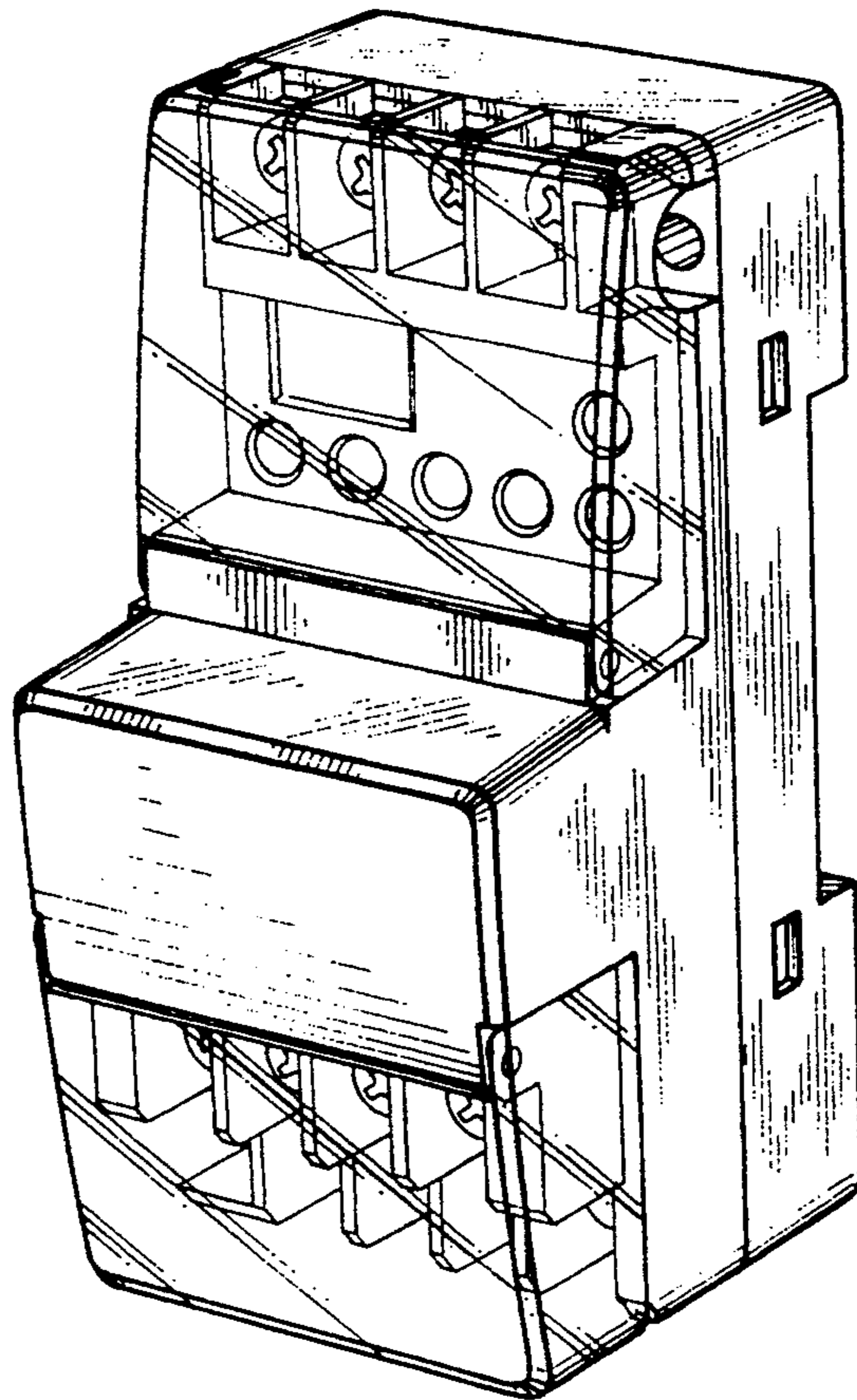

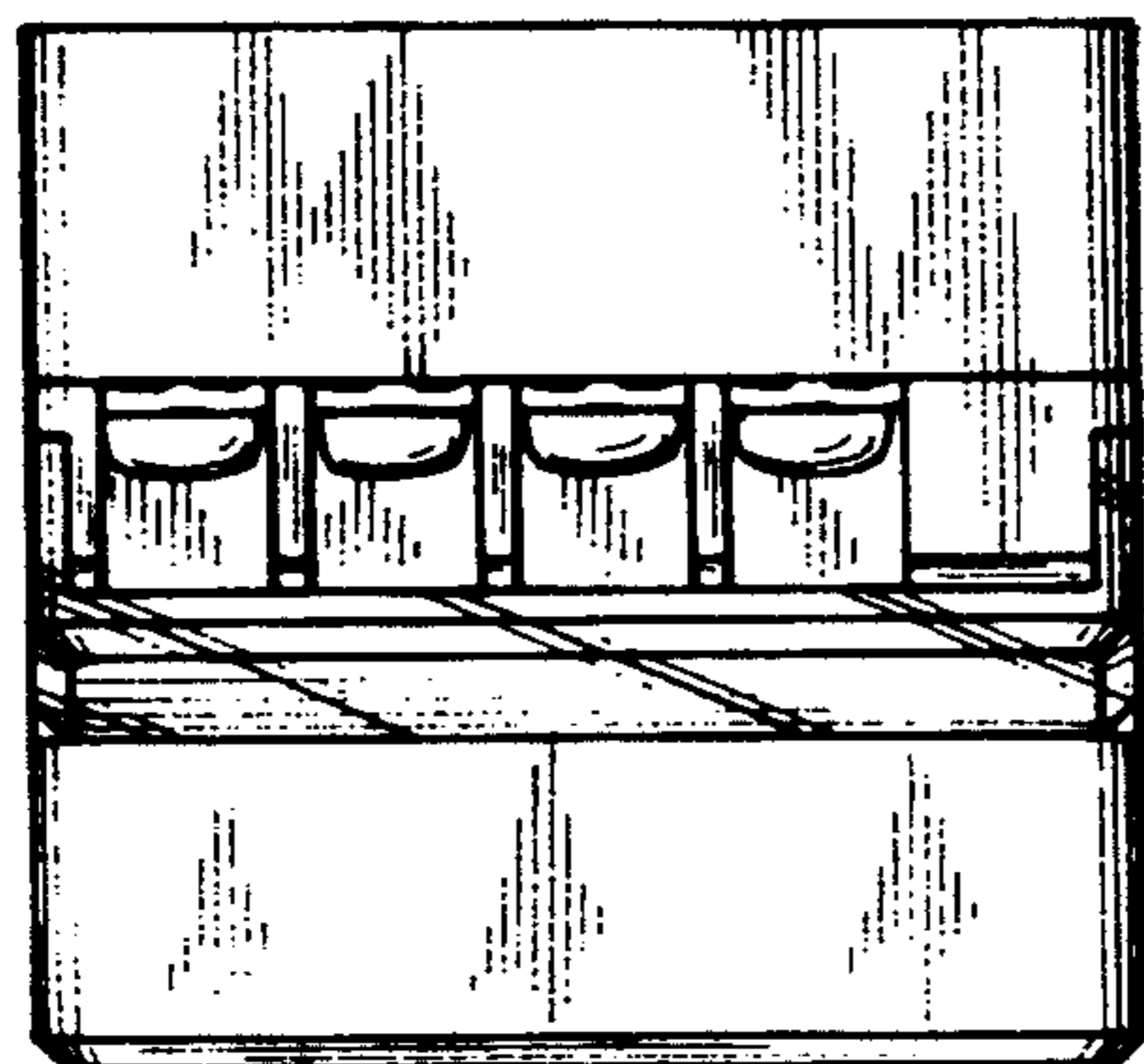

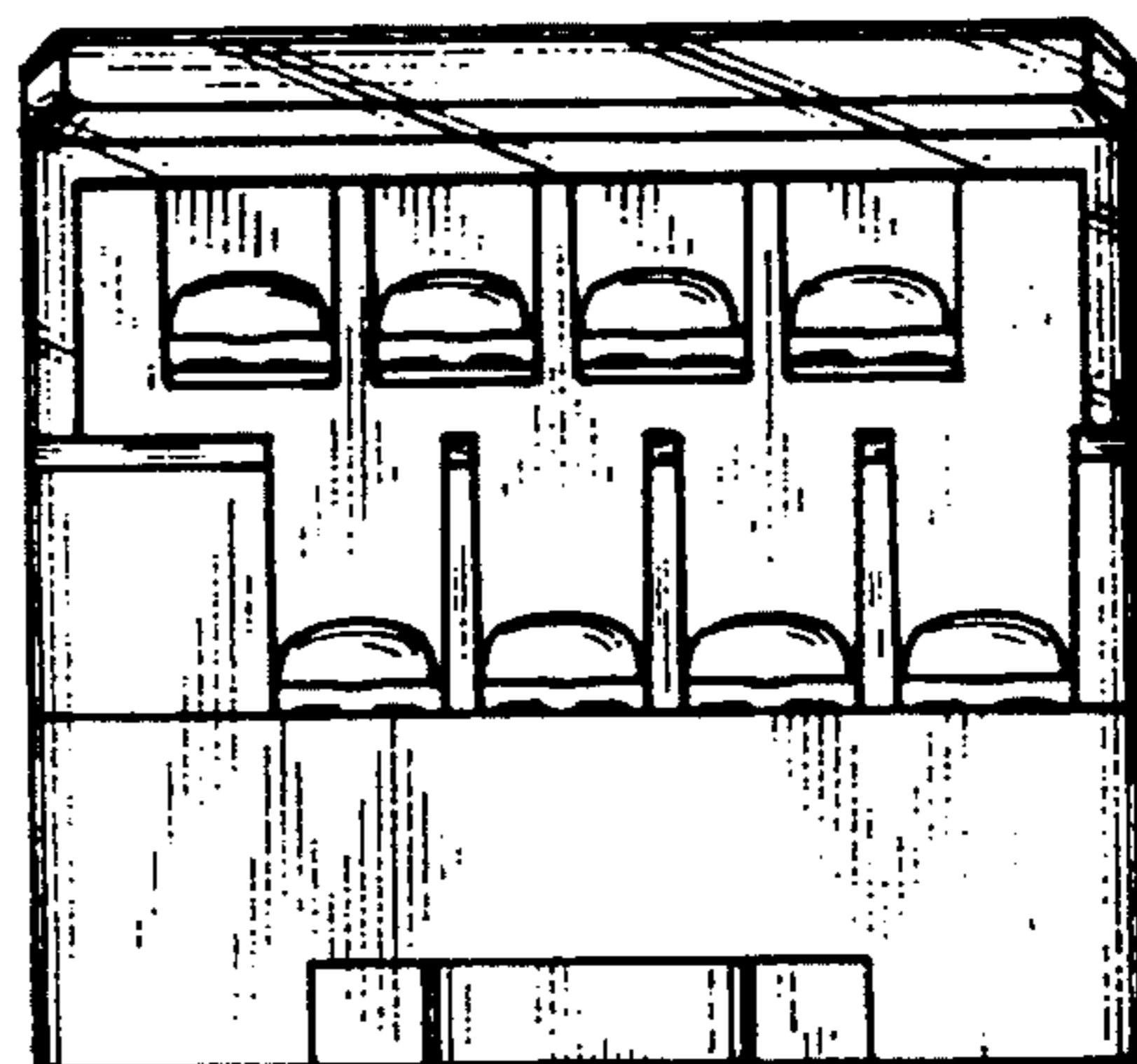

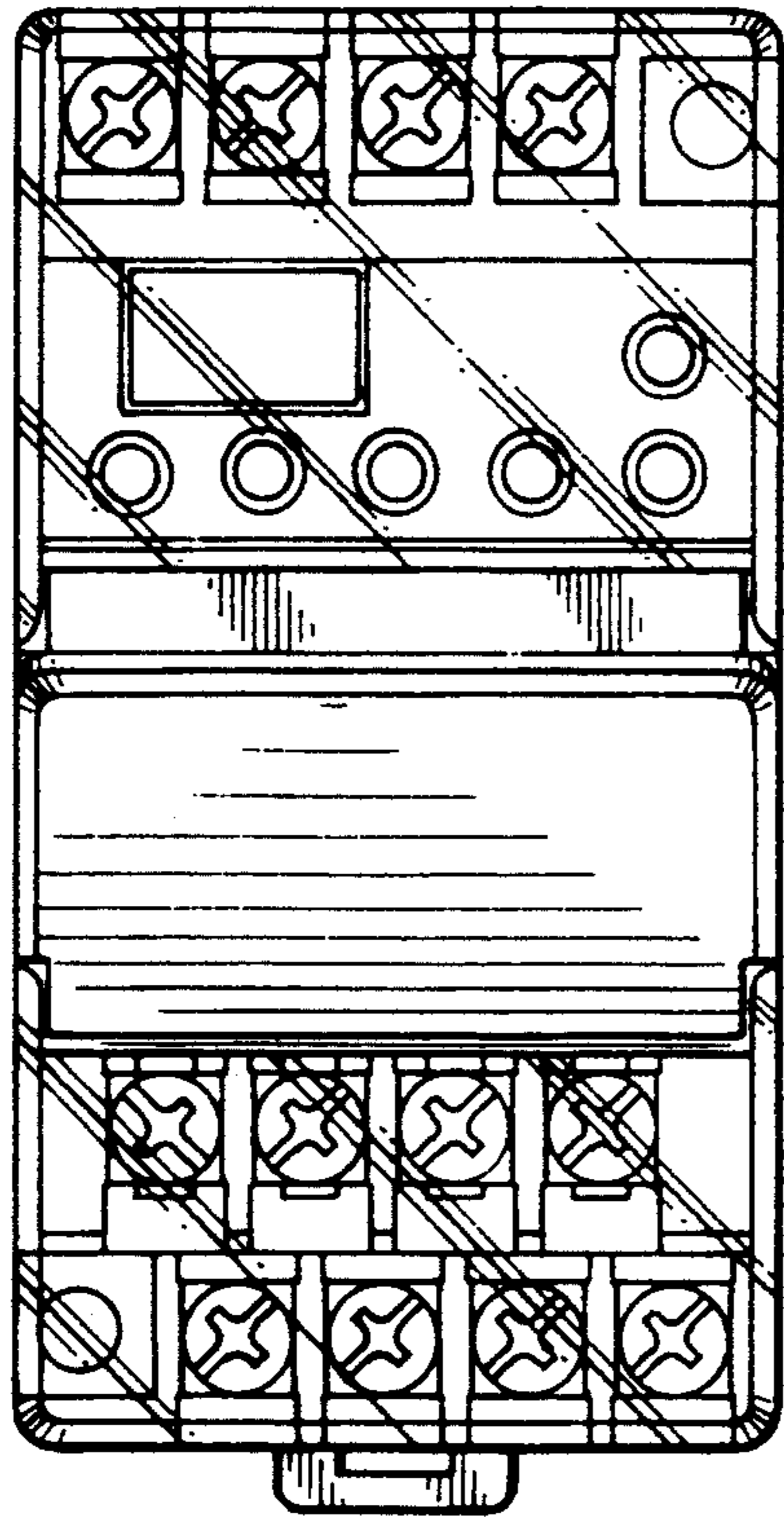

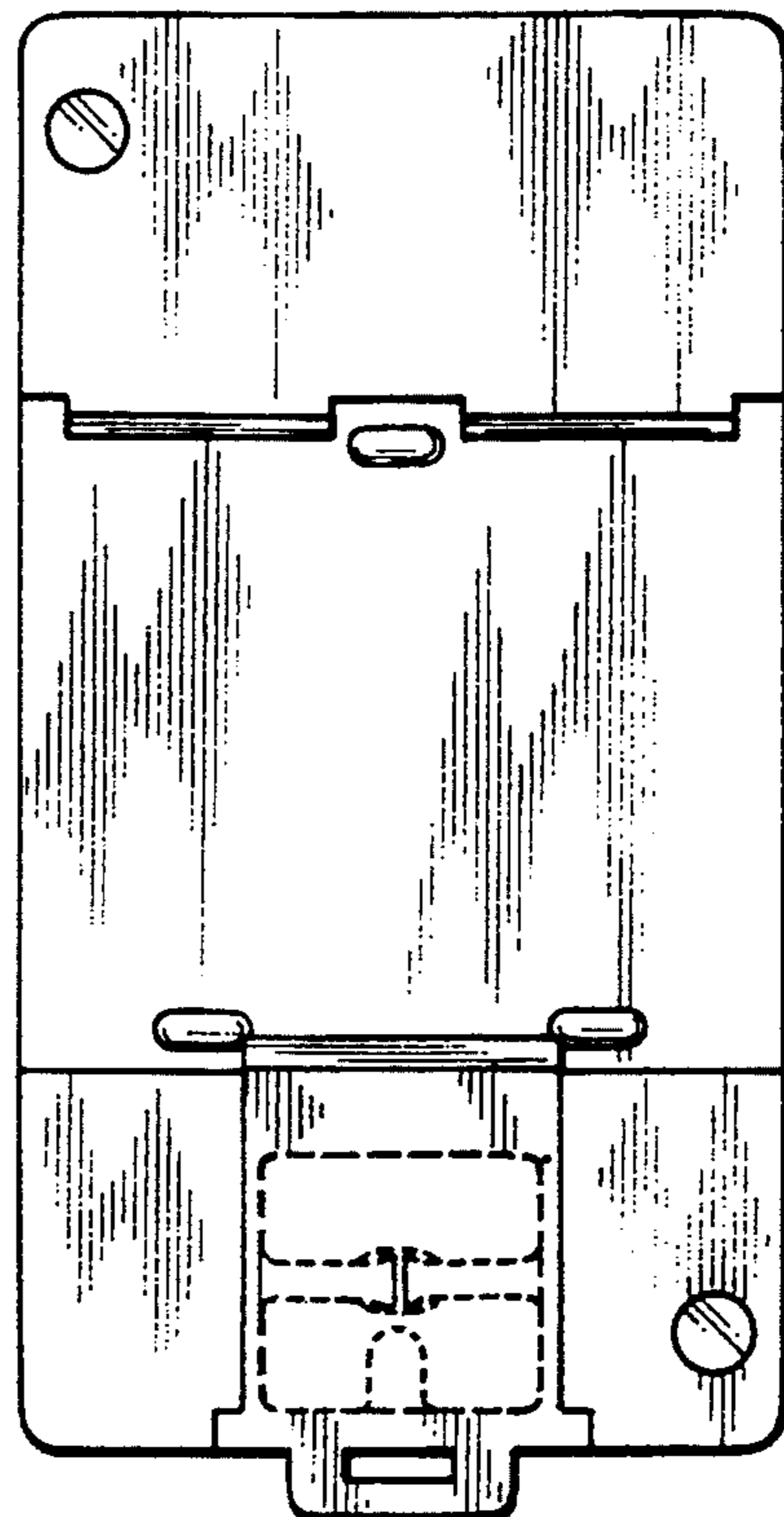

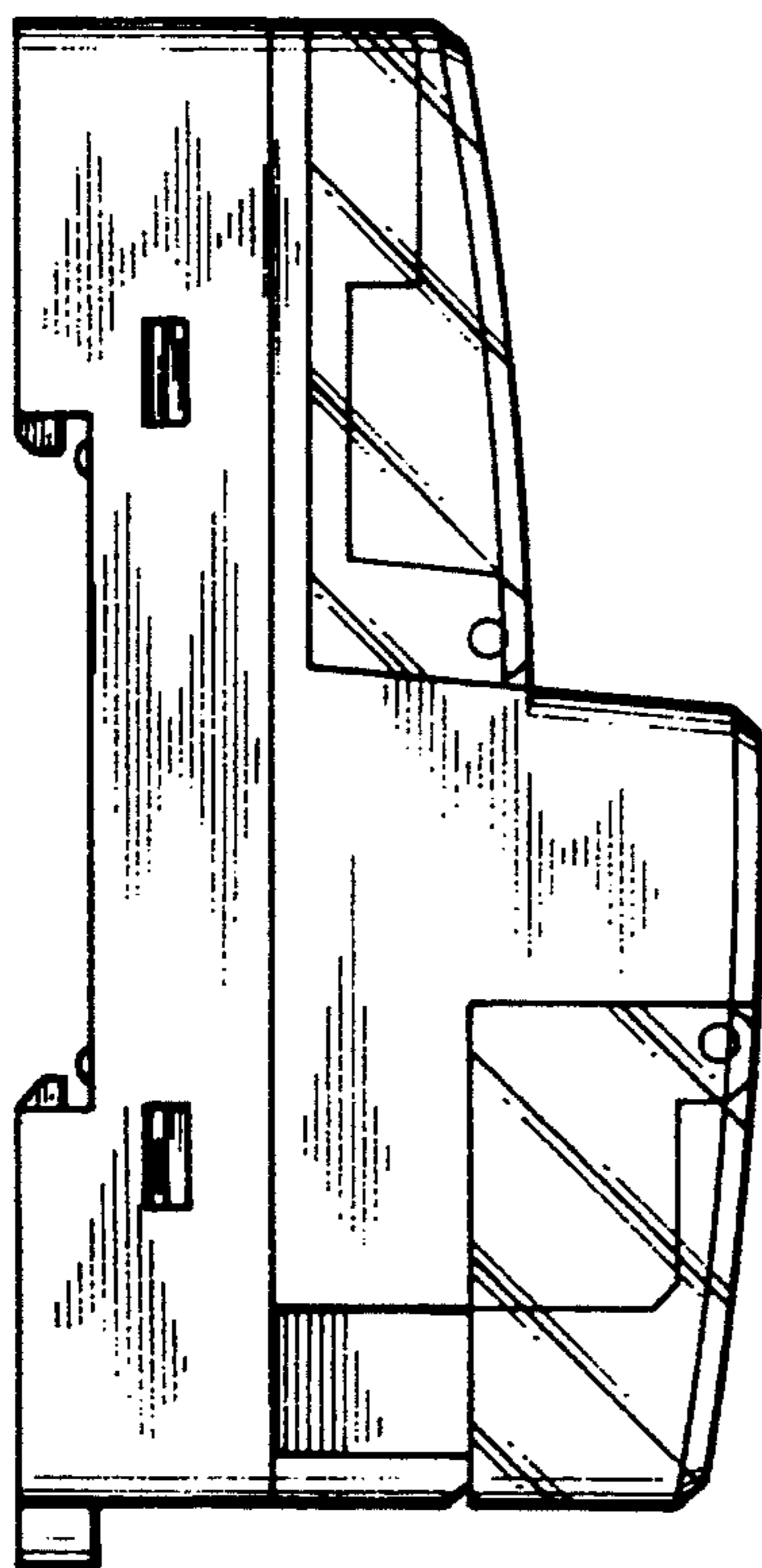
