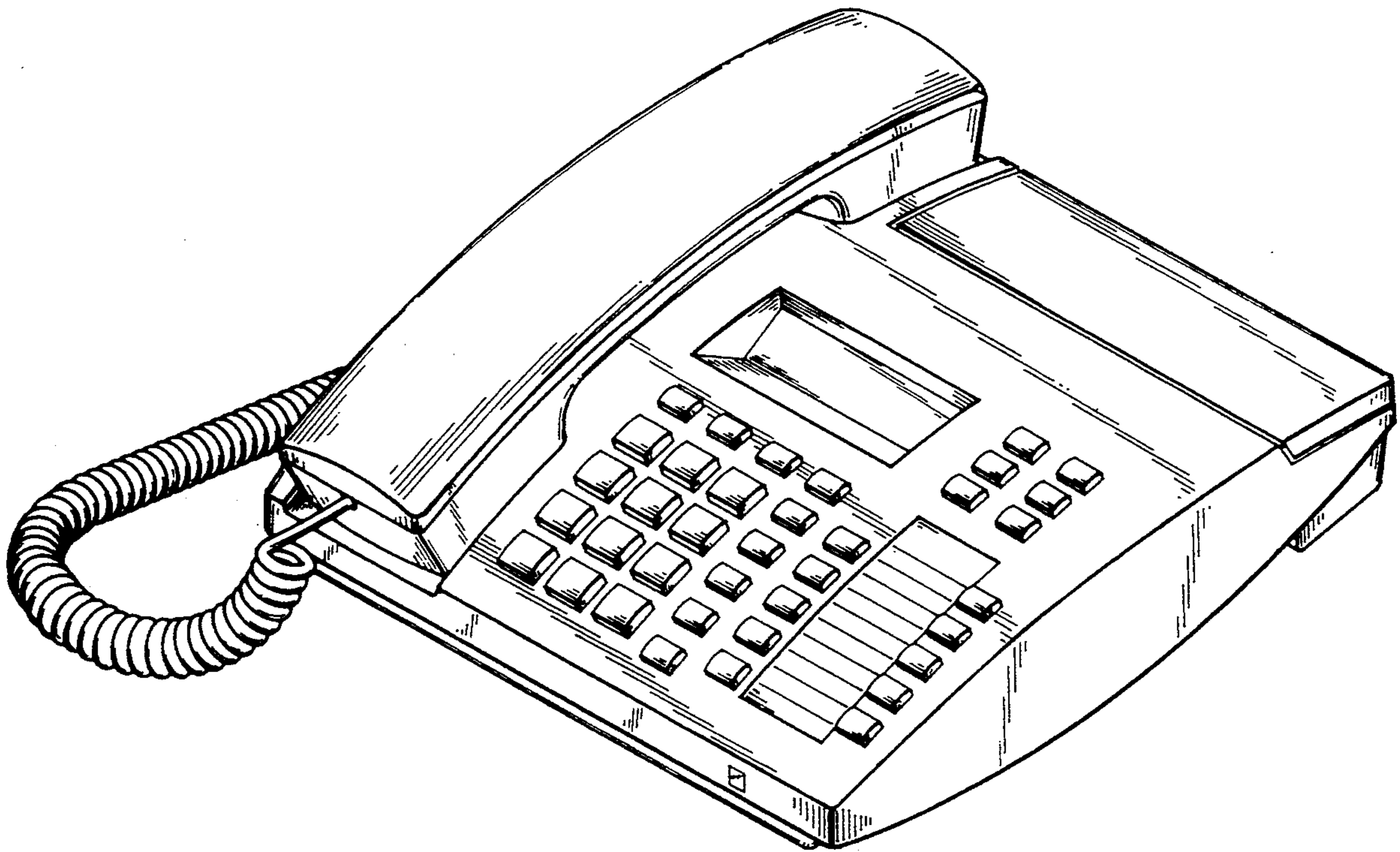

[57] **CLAIM**

The ornamental design for a telephone station, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view taken from the front right side of the telephone station showing my new design; FIG. 2 is a top plan view of the telephone station of FIG. 1 with the handpiece removed from the base unit; FIG. 3 is a top plan view of the telephone station of FIG. 1;
FIG. 4 is a front elevational view of the telephone station of FIG. 1;
FIG. 5 is a side elevational view of the left side of the telephone station of FIG. 4;
FIG. 6 is a side elevational view of the right side of the telephone station of FIG. 4;
FIG. 7 is a back elevational view of the telephone station of FIG. 1; and,
FIG. 8 is a bottom plan view of the telephone station of FIG. 1.



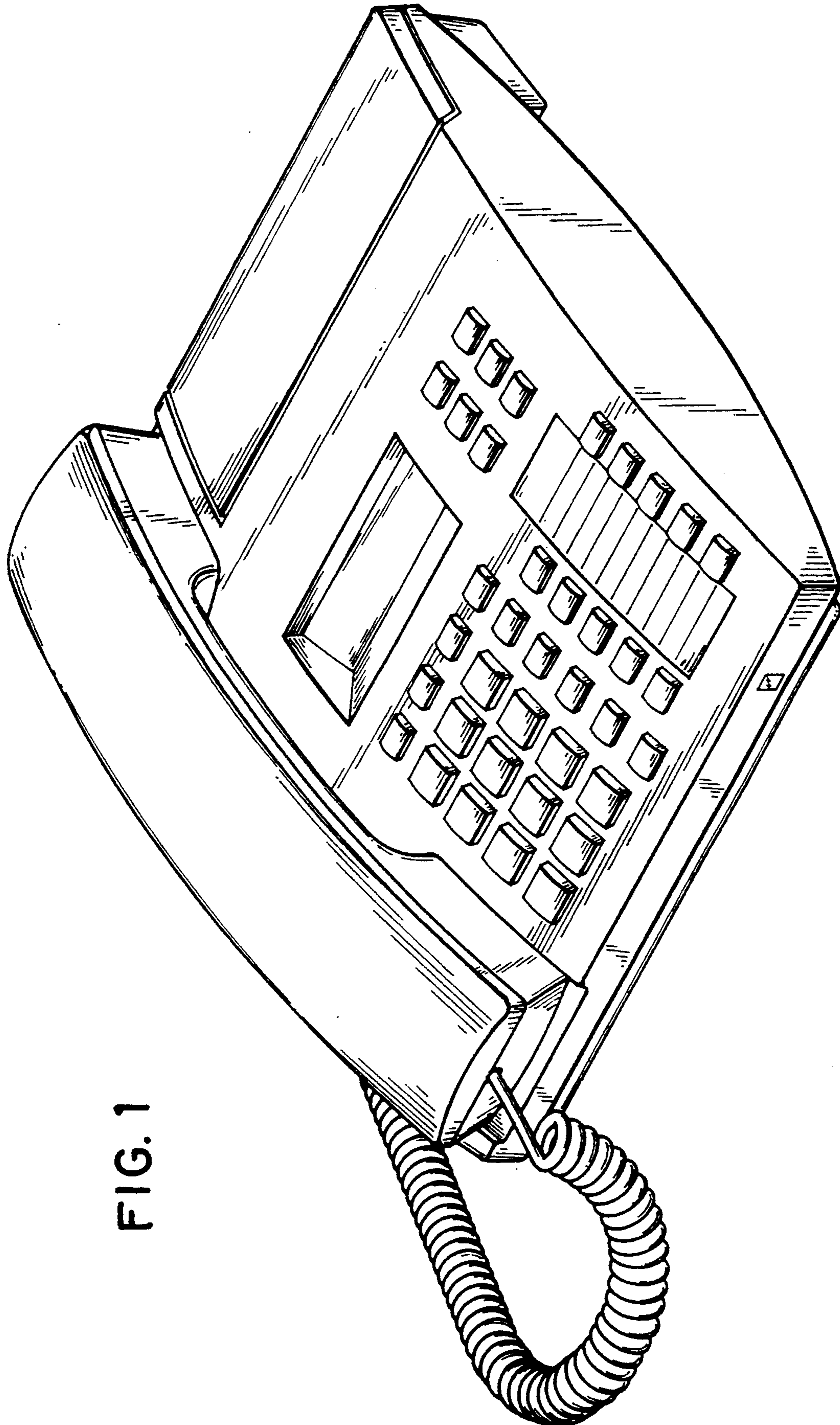

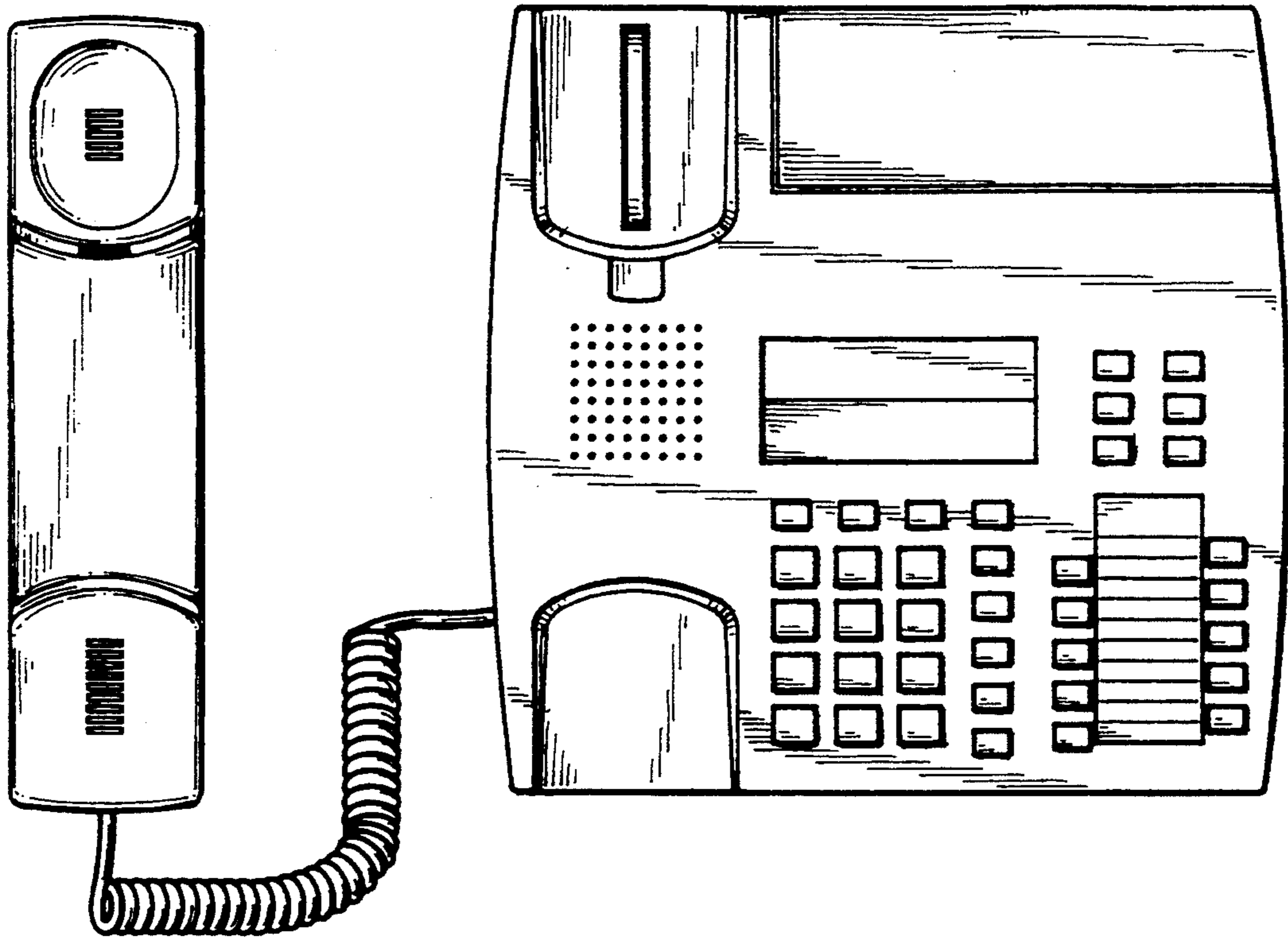

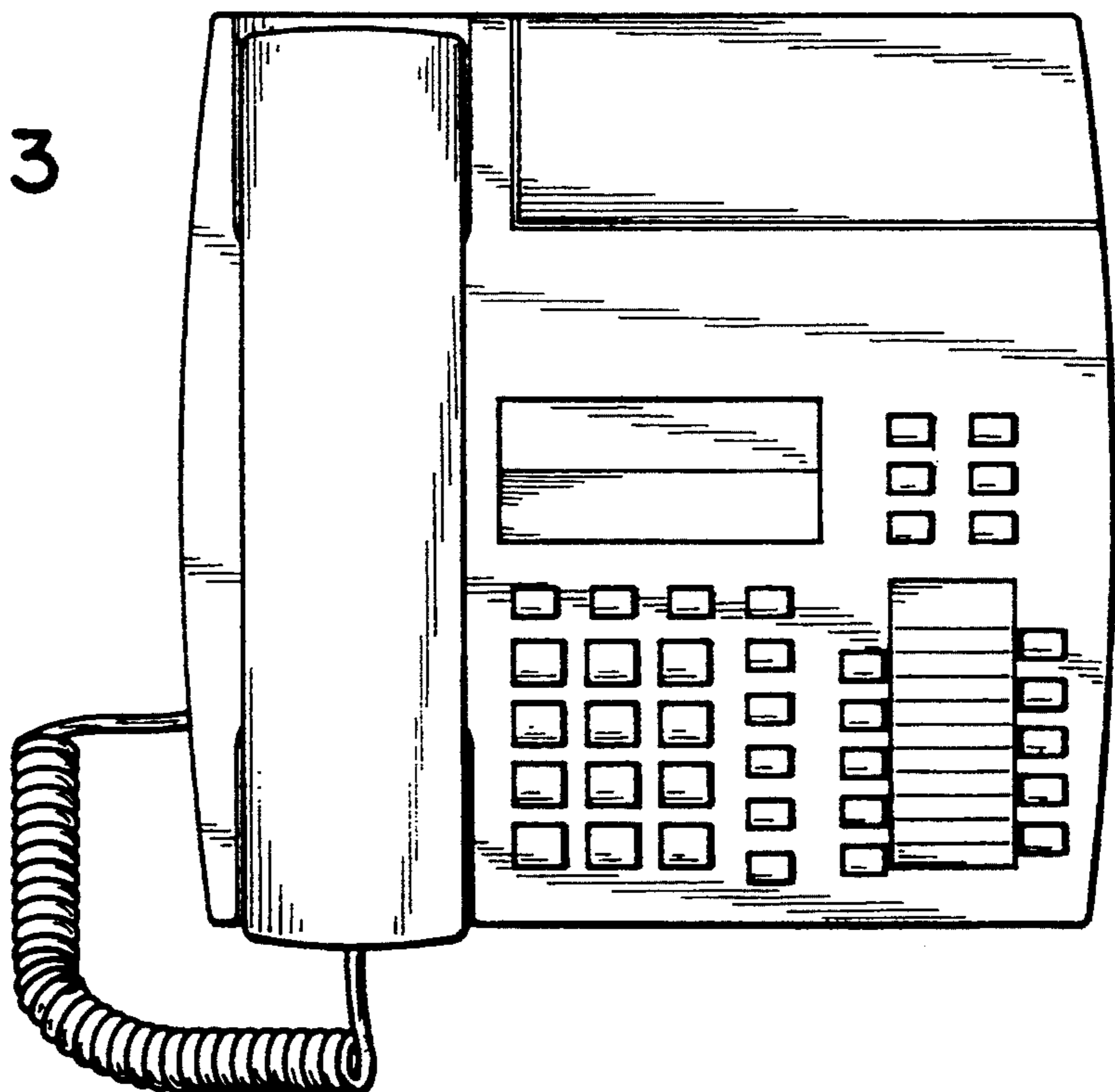

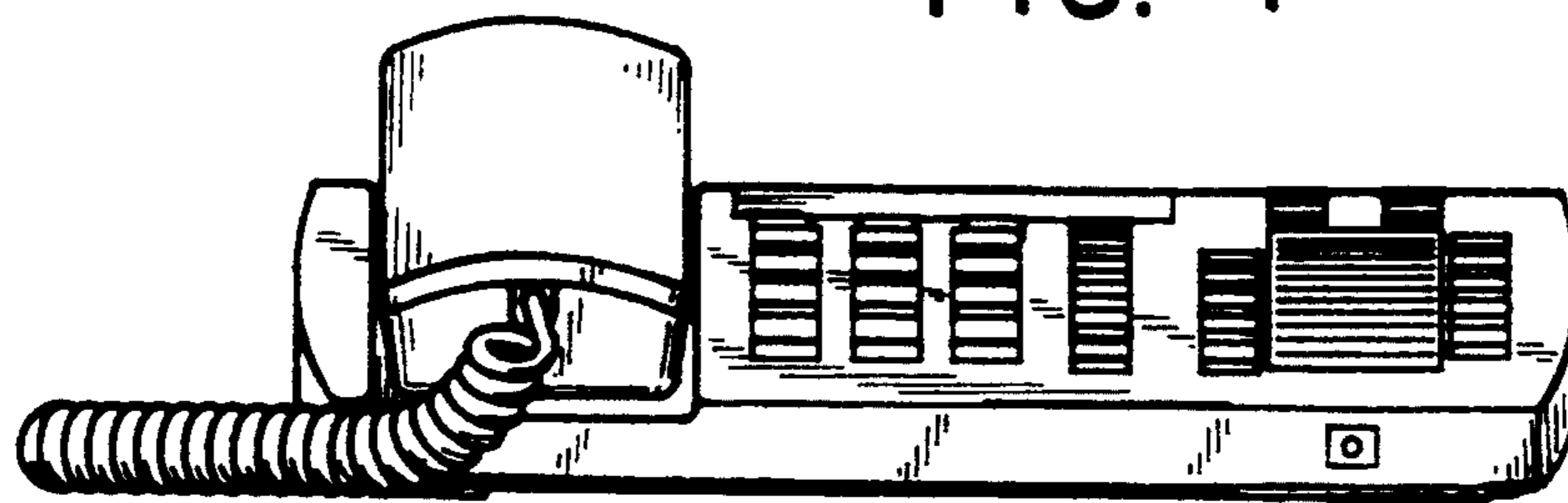

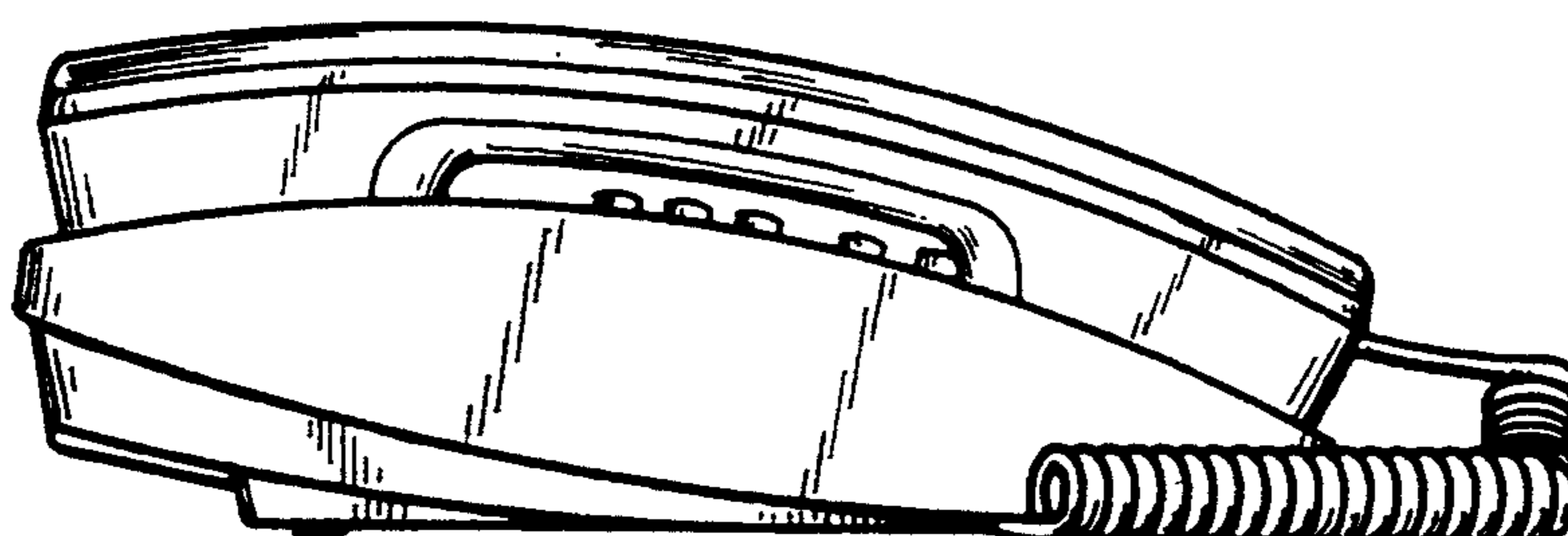

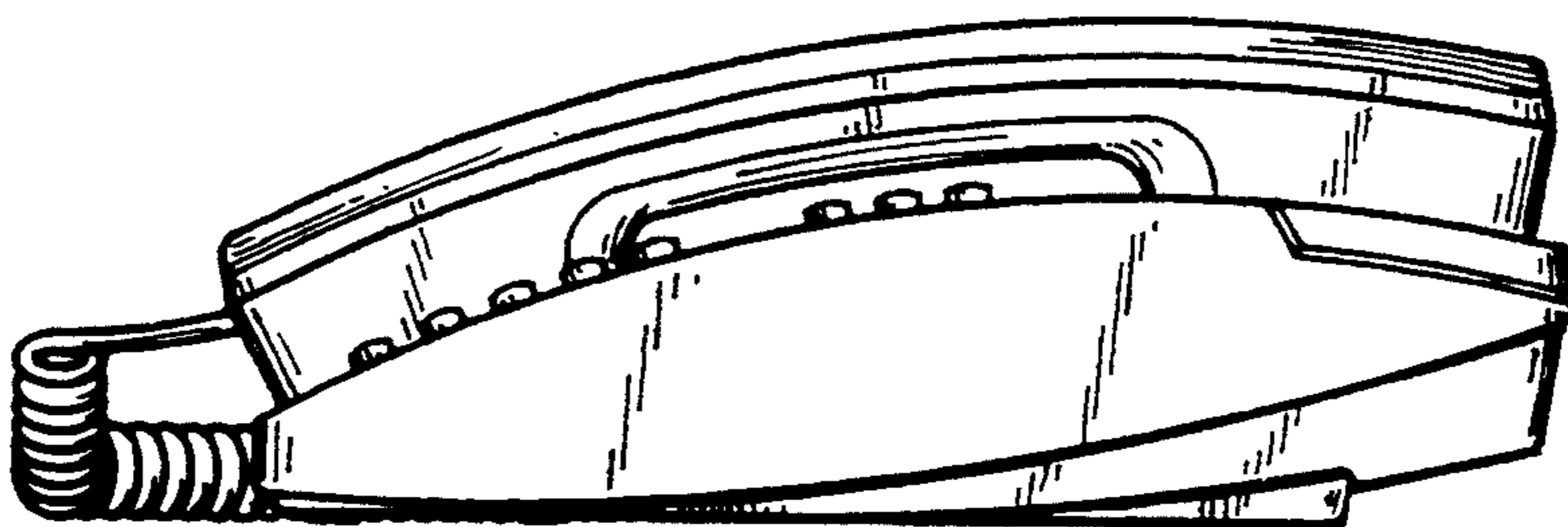

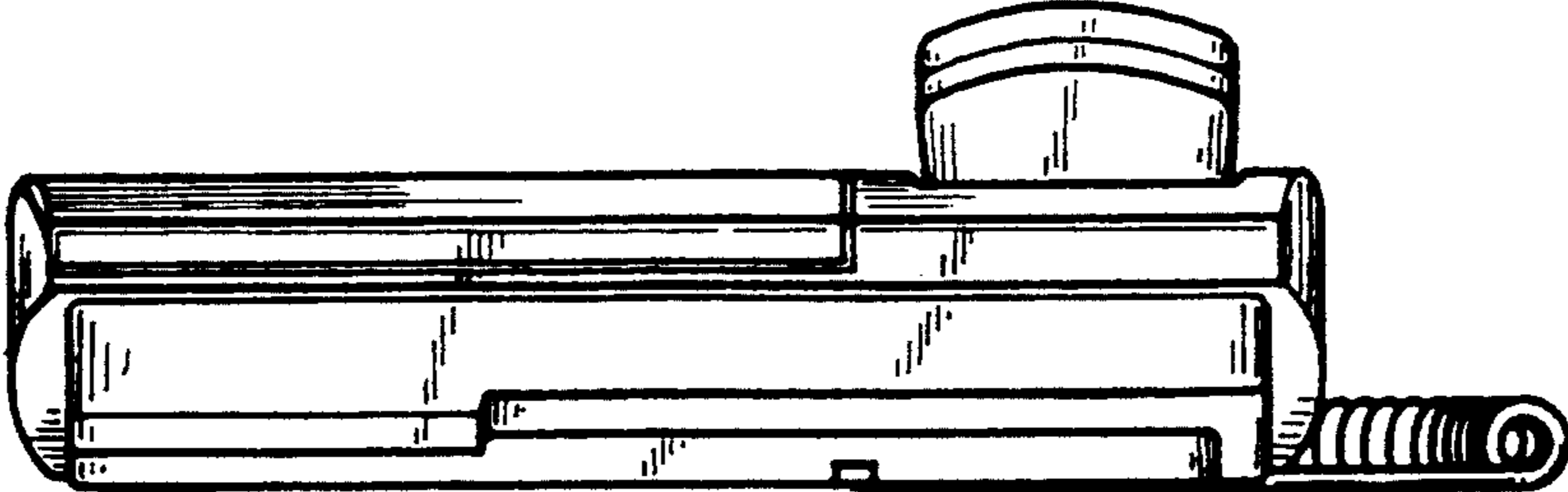
