 FIG. 3 is a side elevational view of the knee pad of FIG. 1.

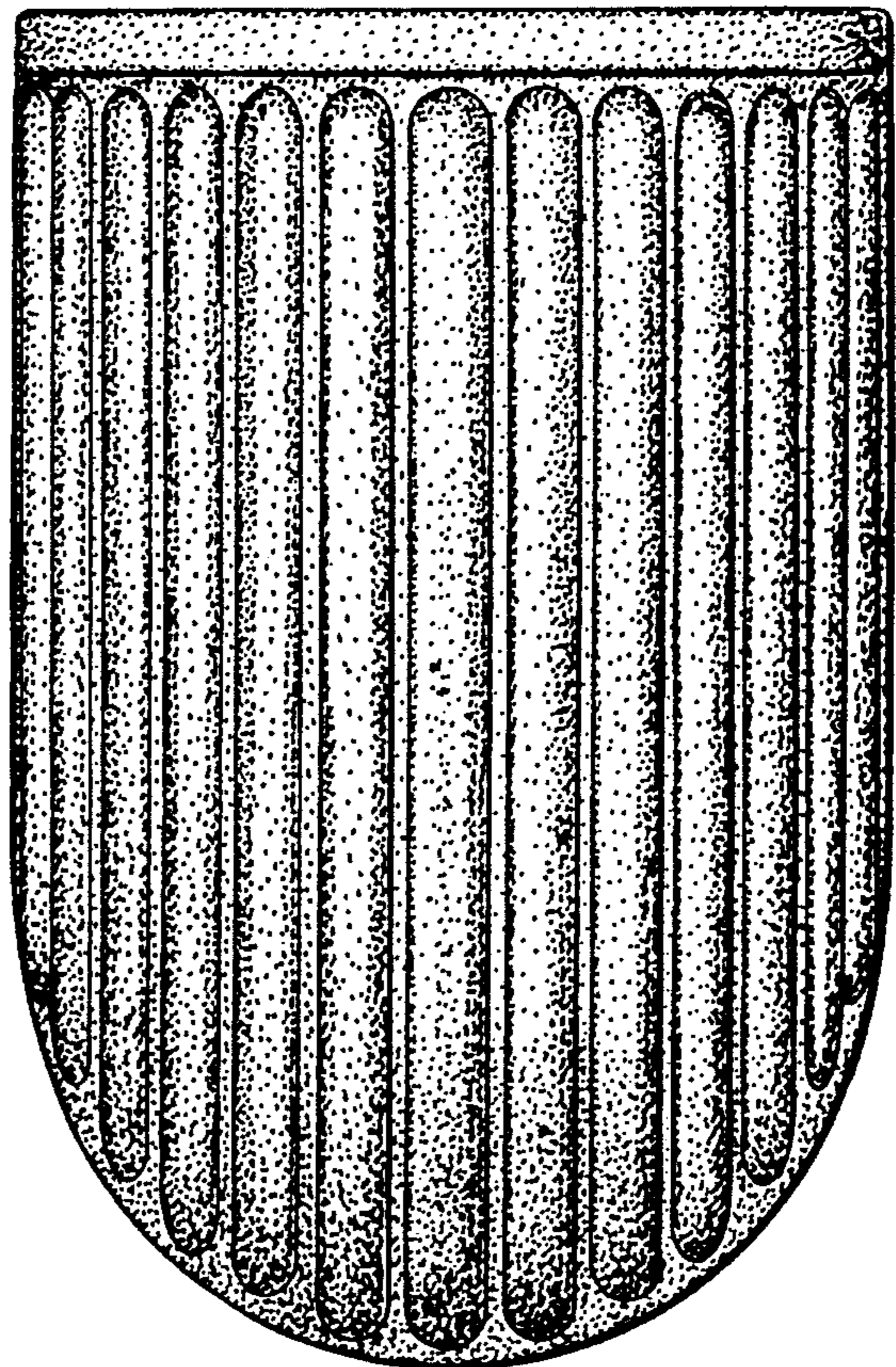
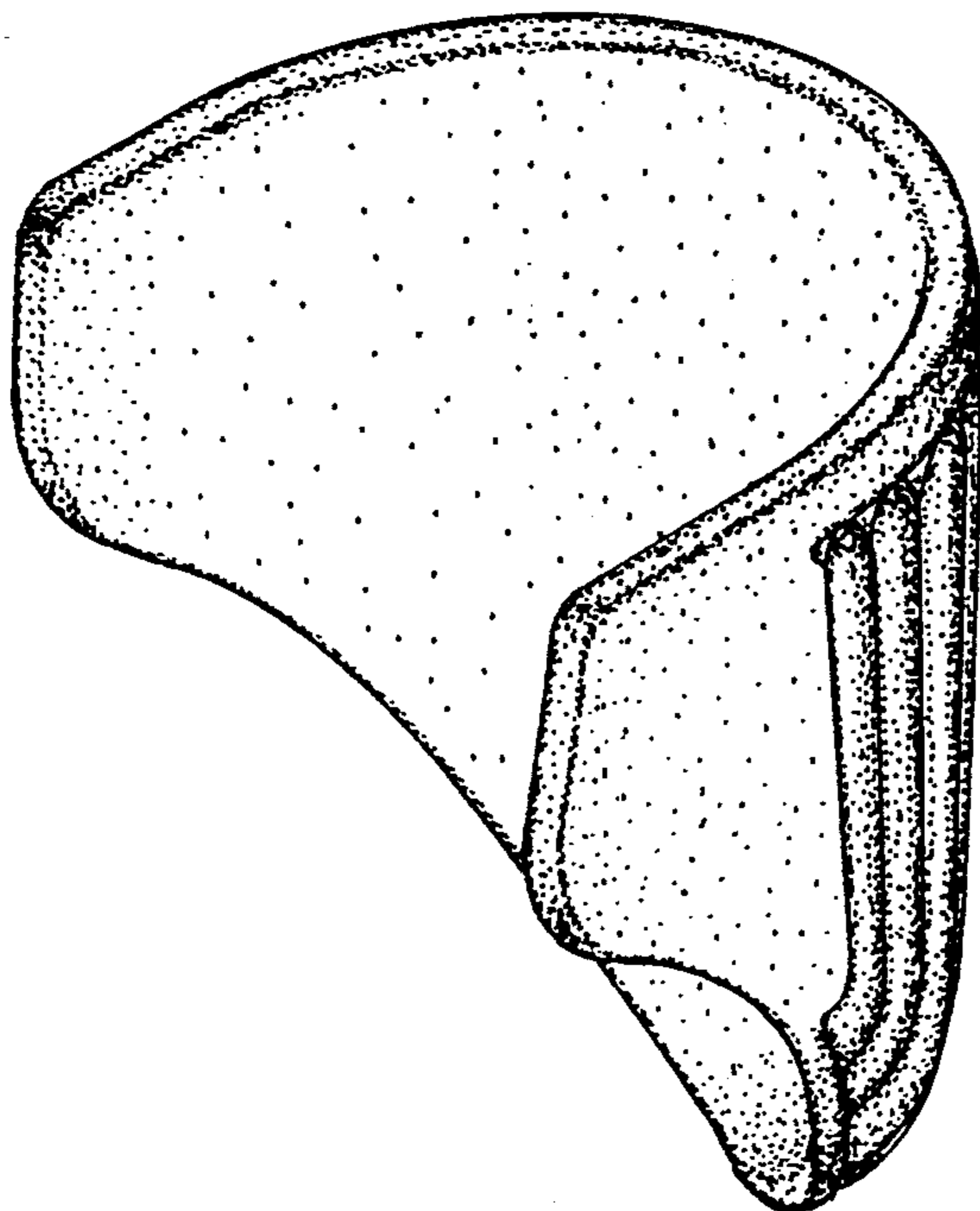

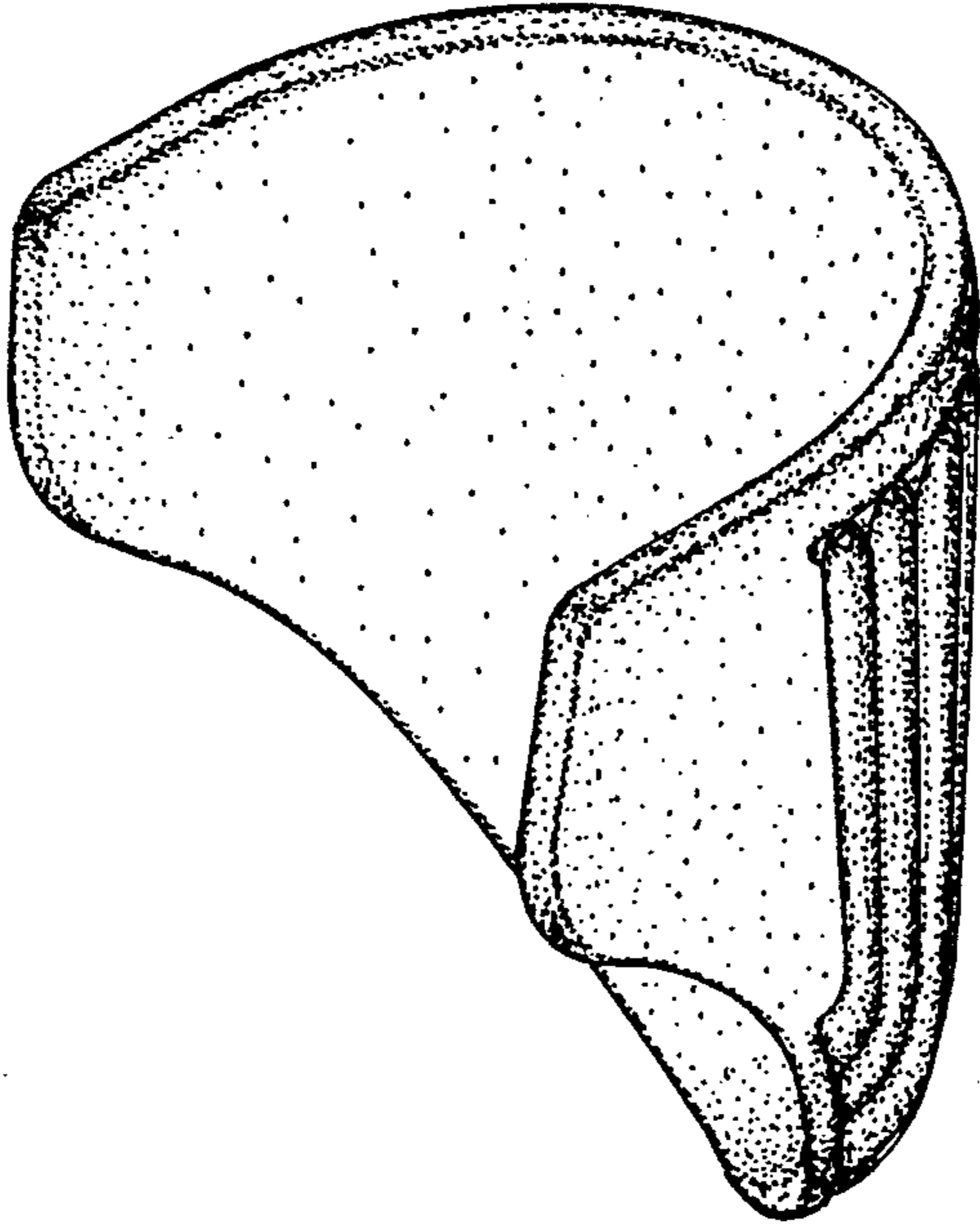

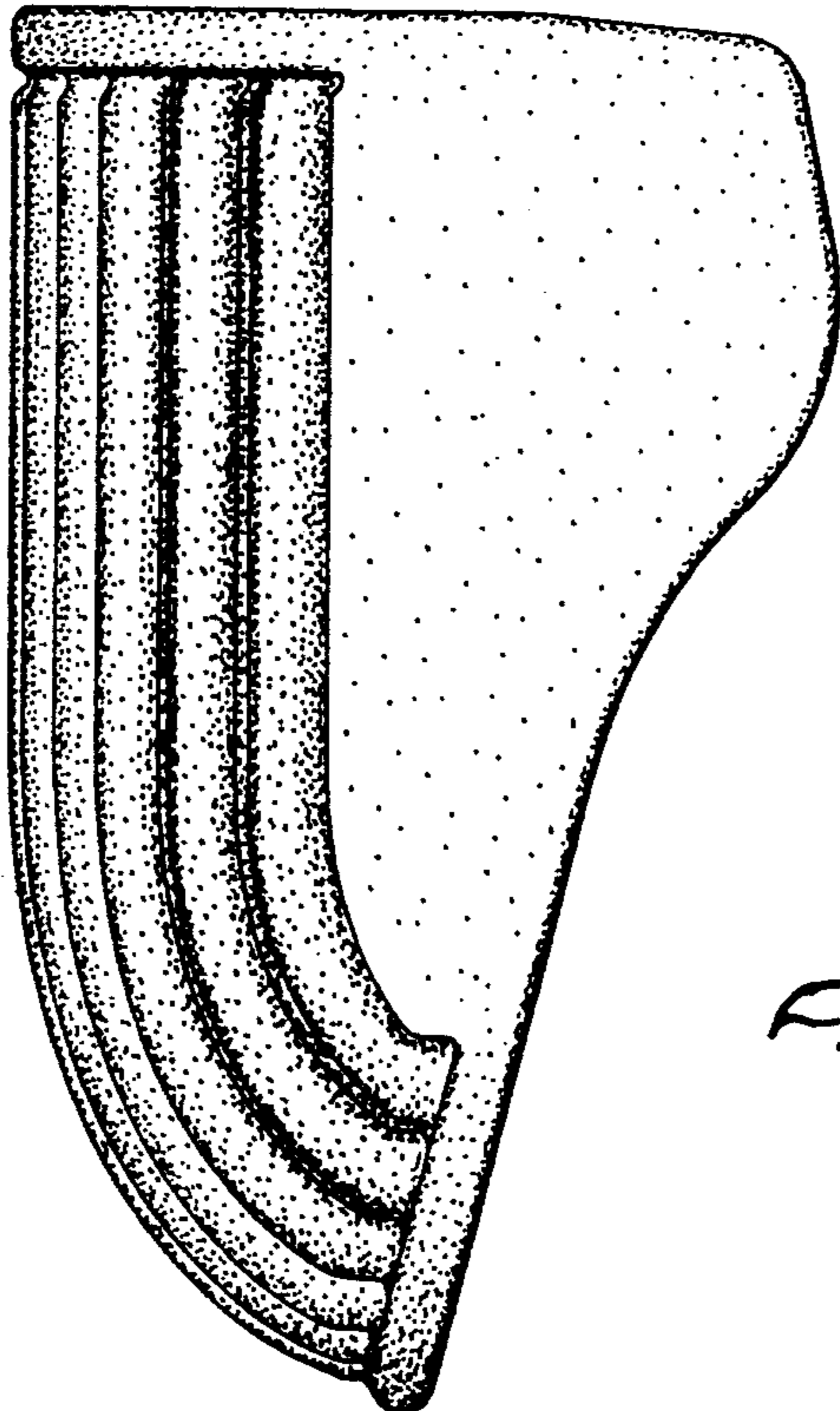
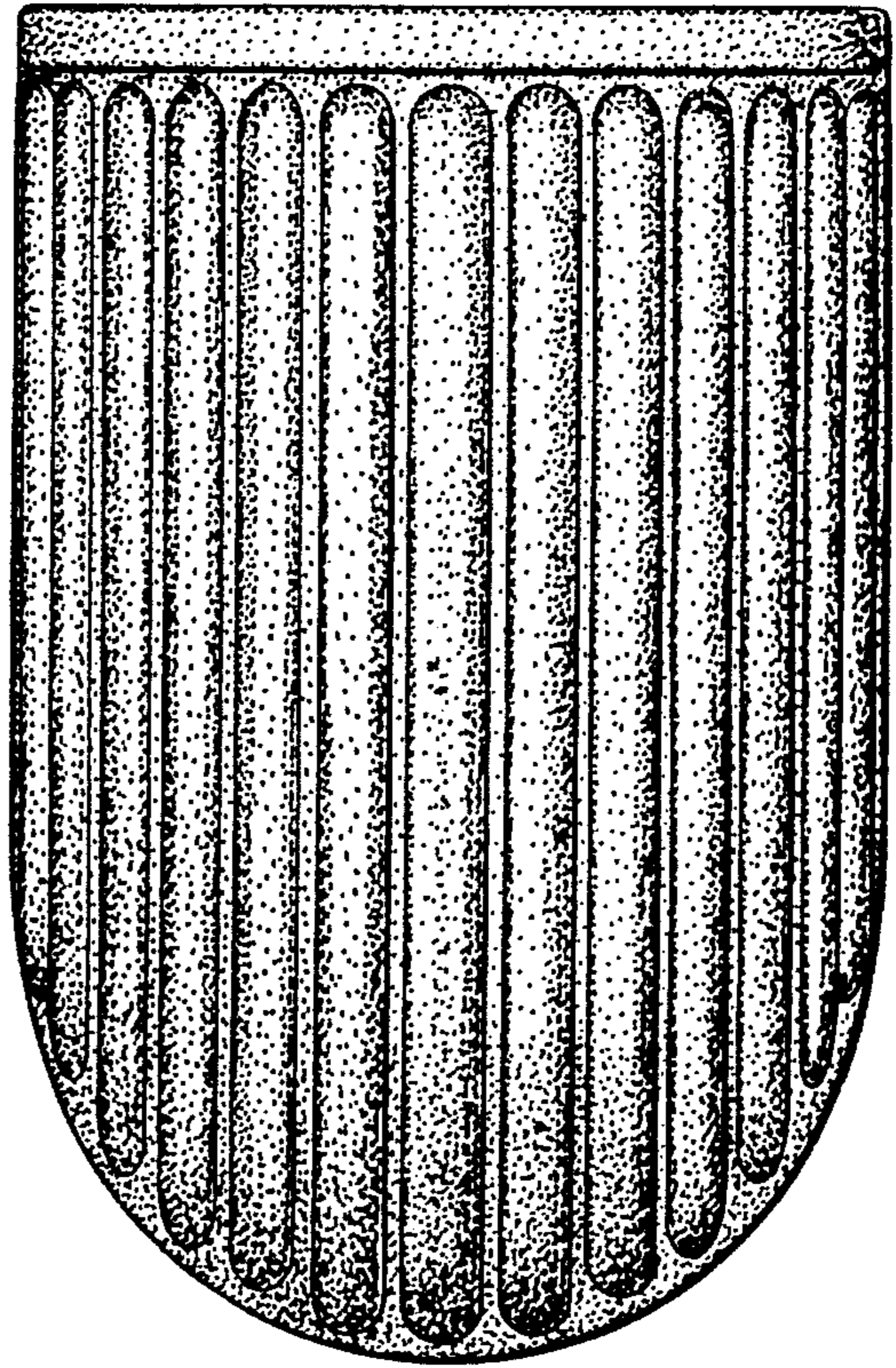
