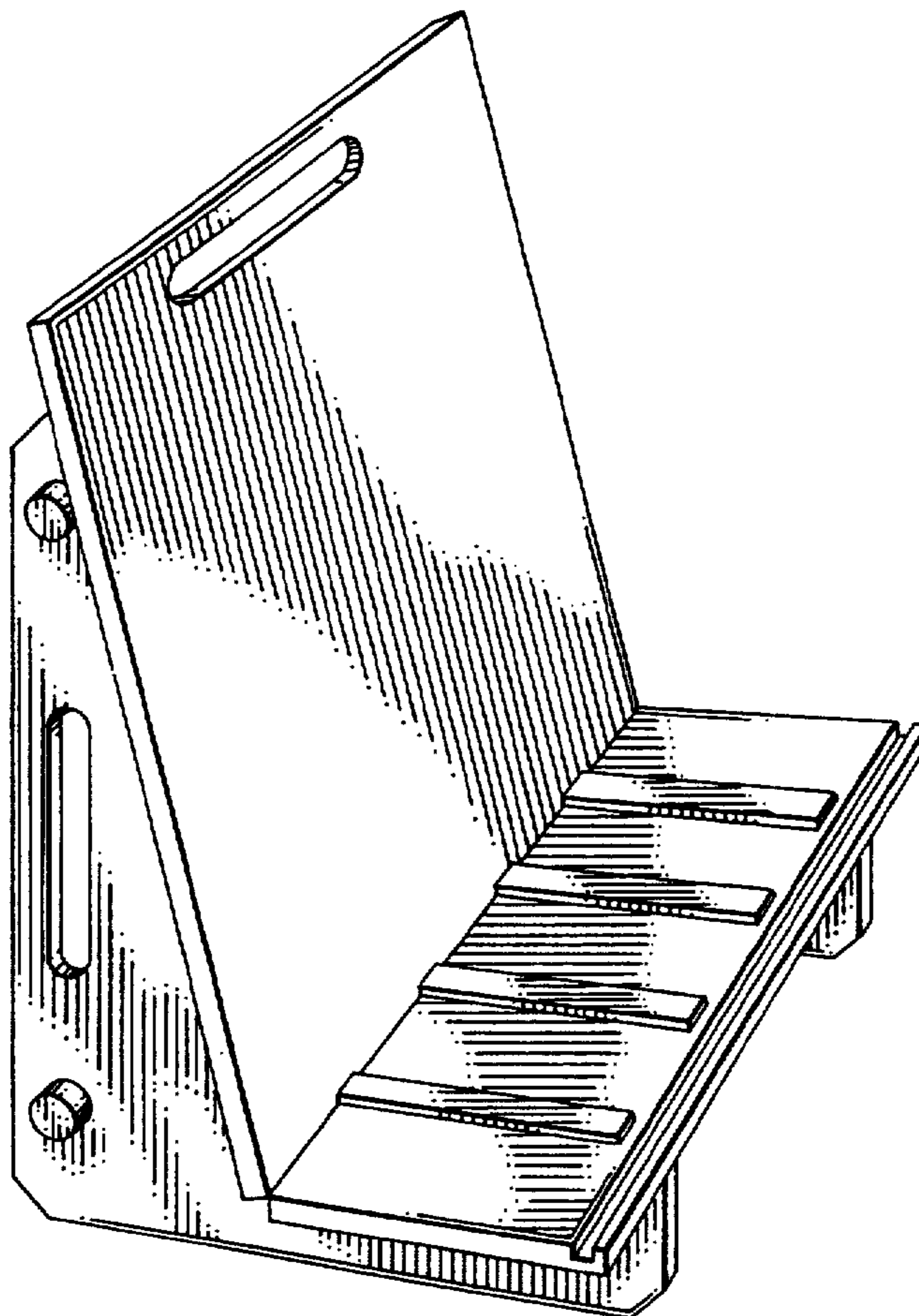

### [57] CLAIM

The ornamental design for inclined tote for printed circuit panels, as shown and described.

### DESCRIPTION

FIG. 1 is an upper right front perspective view of an inclined tote for printed circuit panels showing my new design;  
FIG. 2 is a reduced top plan view thereof;  
FIG. 3 is a right side elevational view of FIG. 2, the left side being a mirror image;  
FIG. 4 is a bottom plan view of FIG. 2; and,  
FIG. 5 is a rear elevational view of FIG. 2.



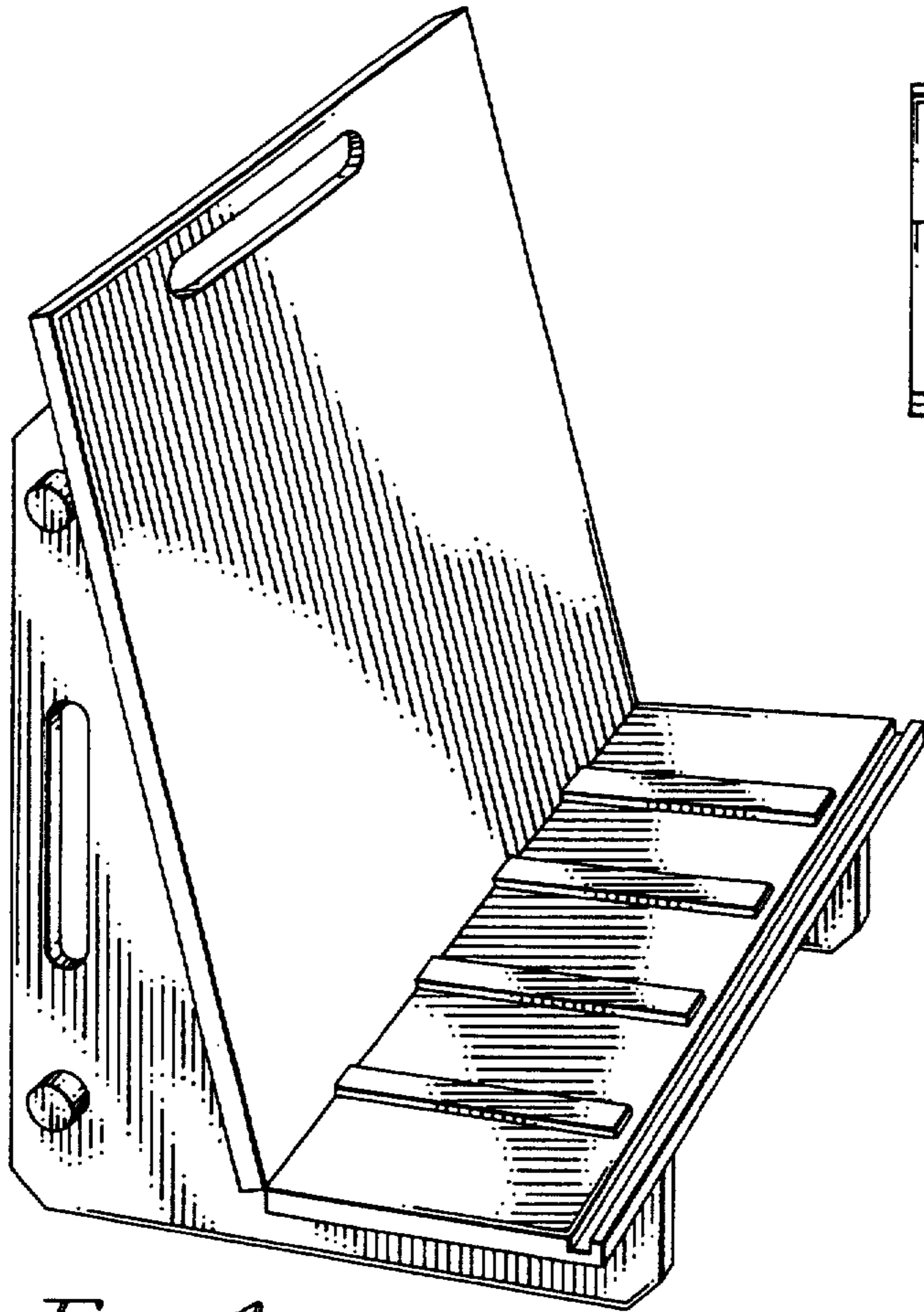

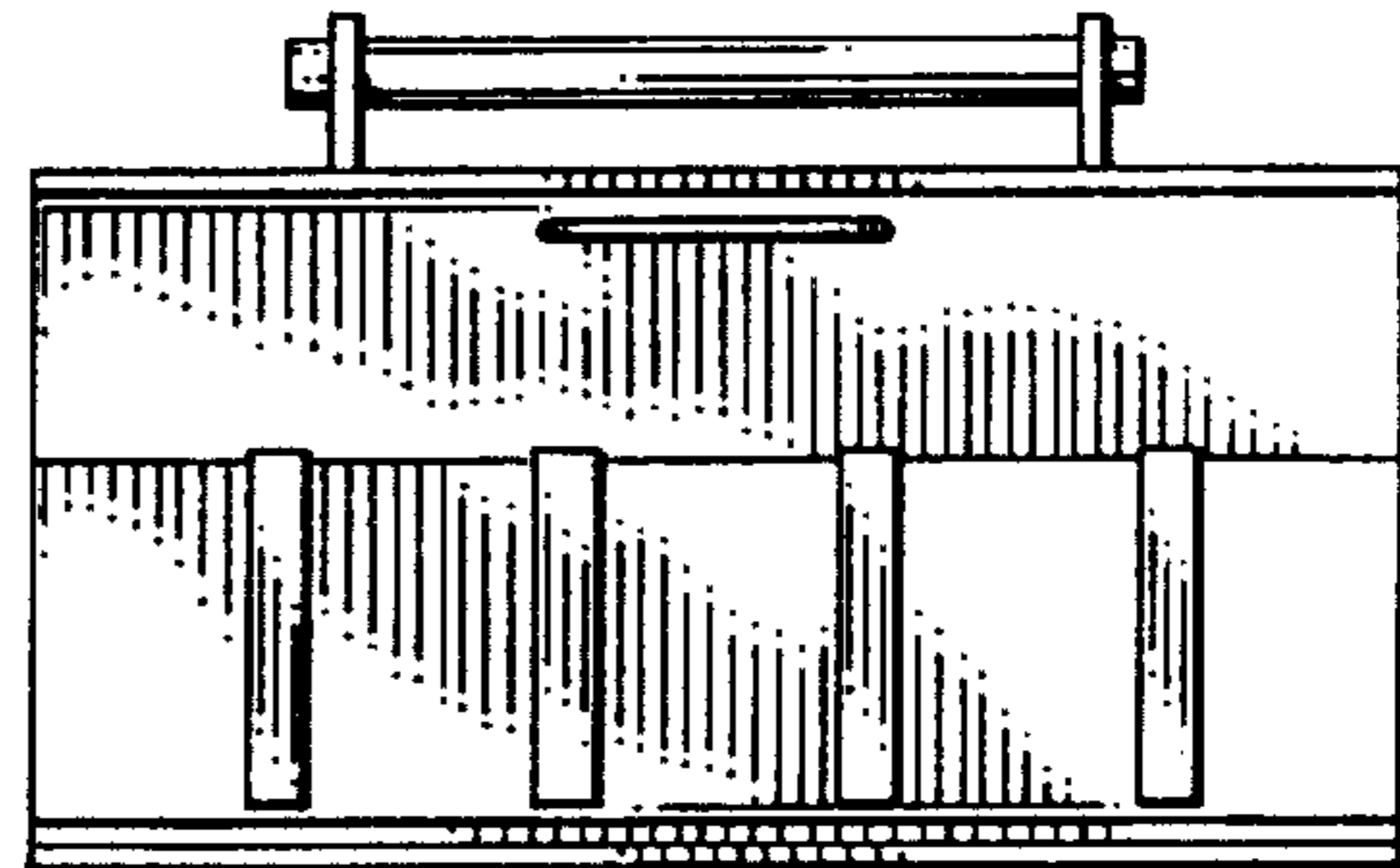

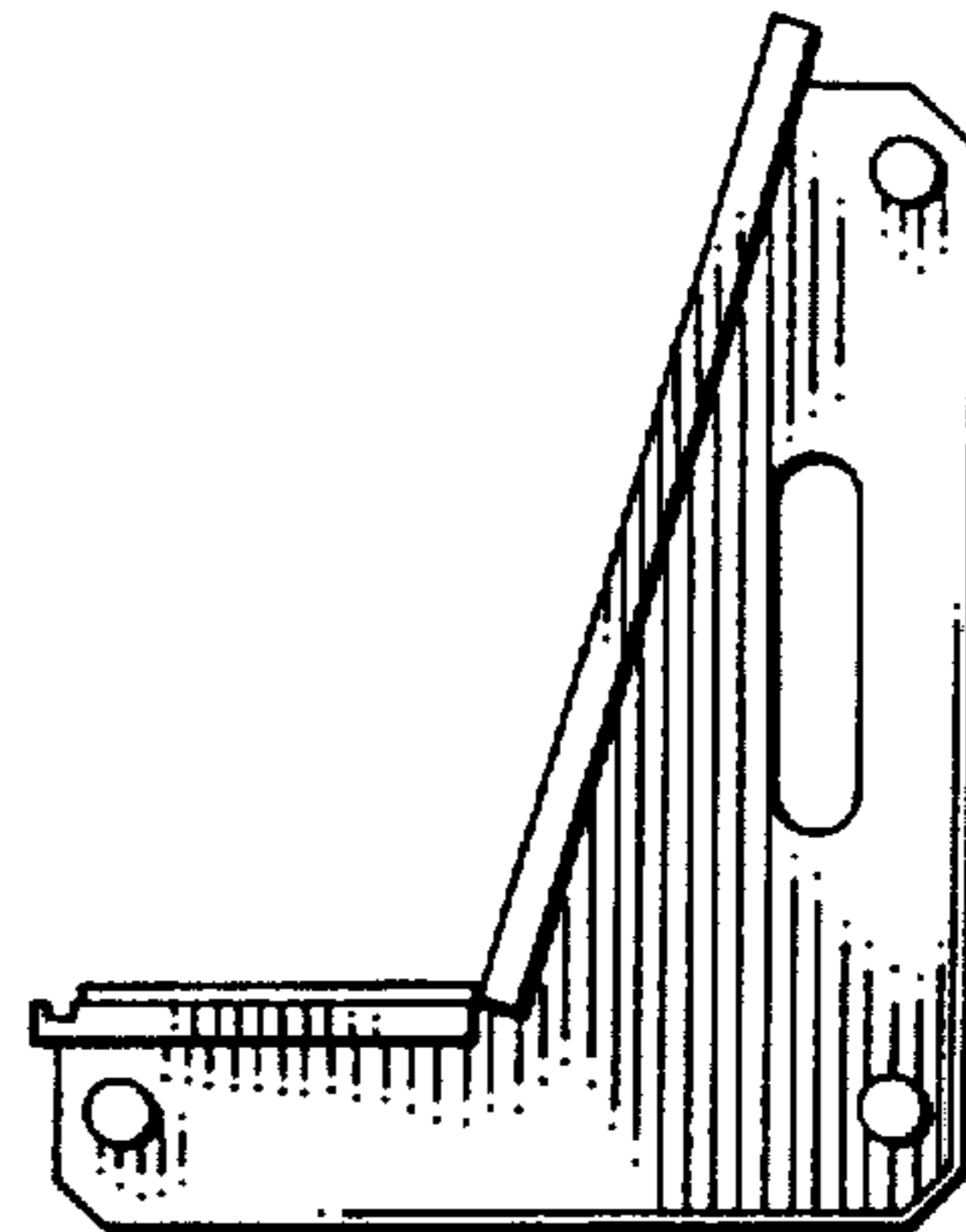

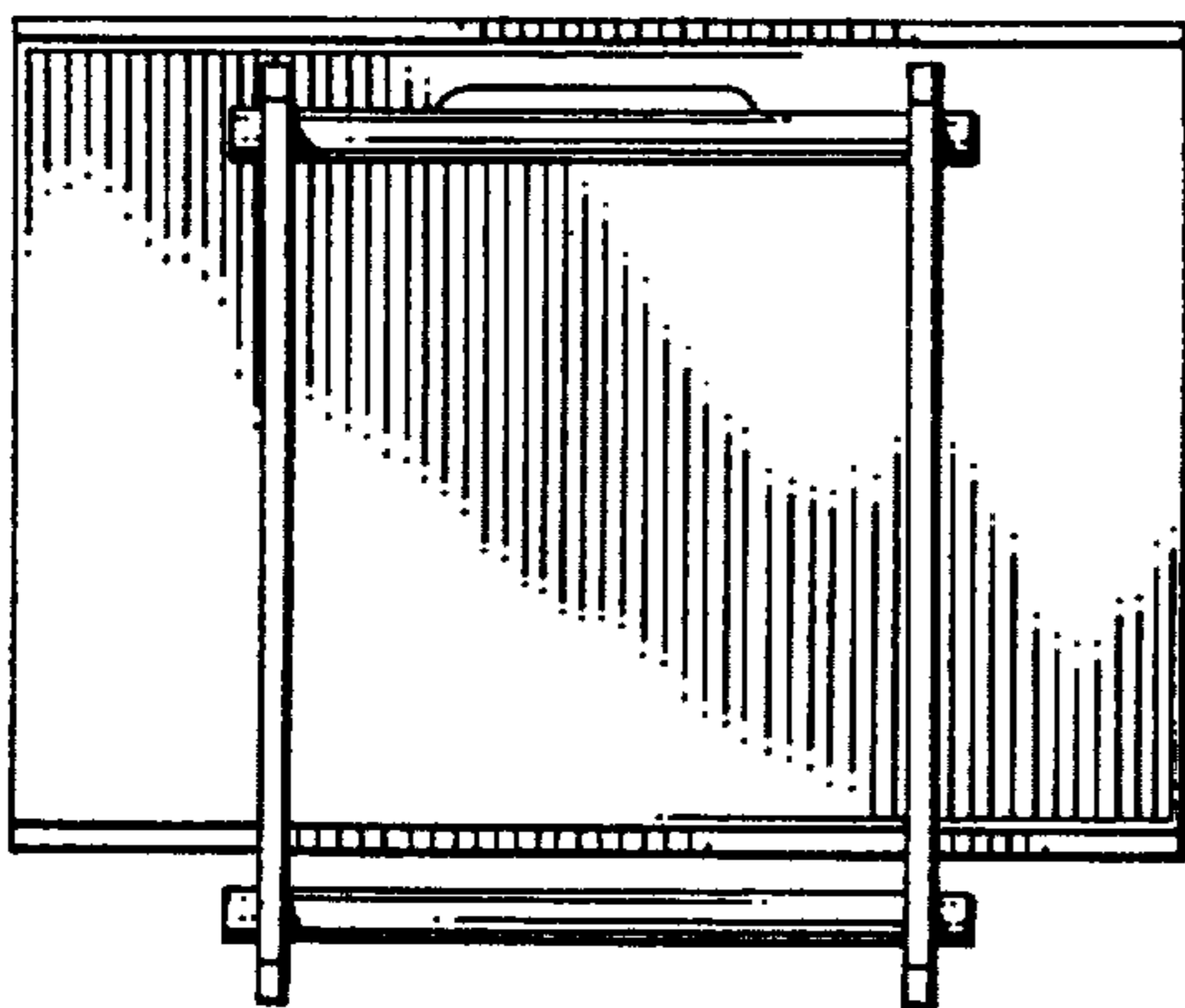

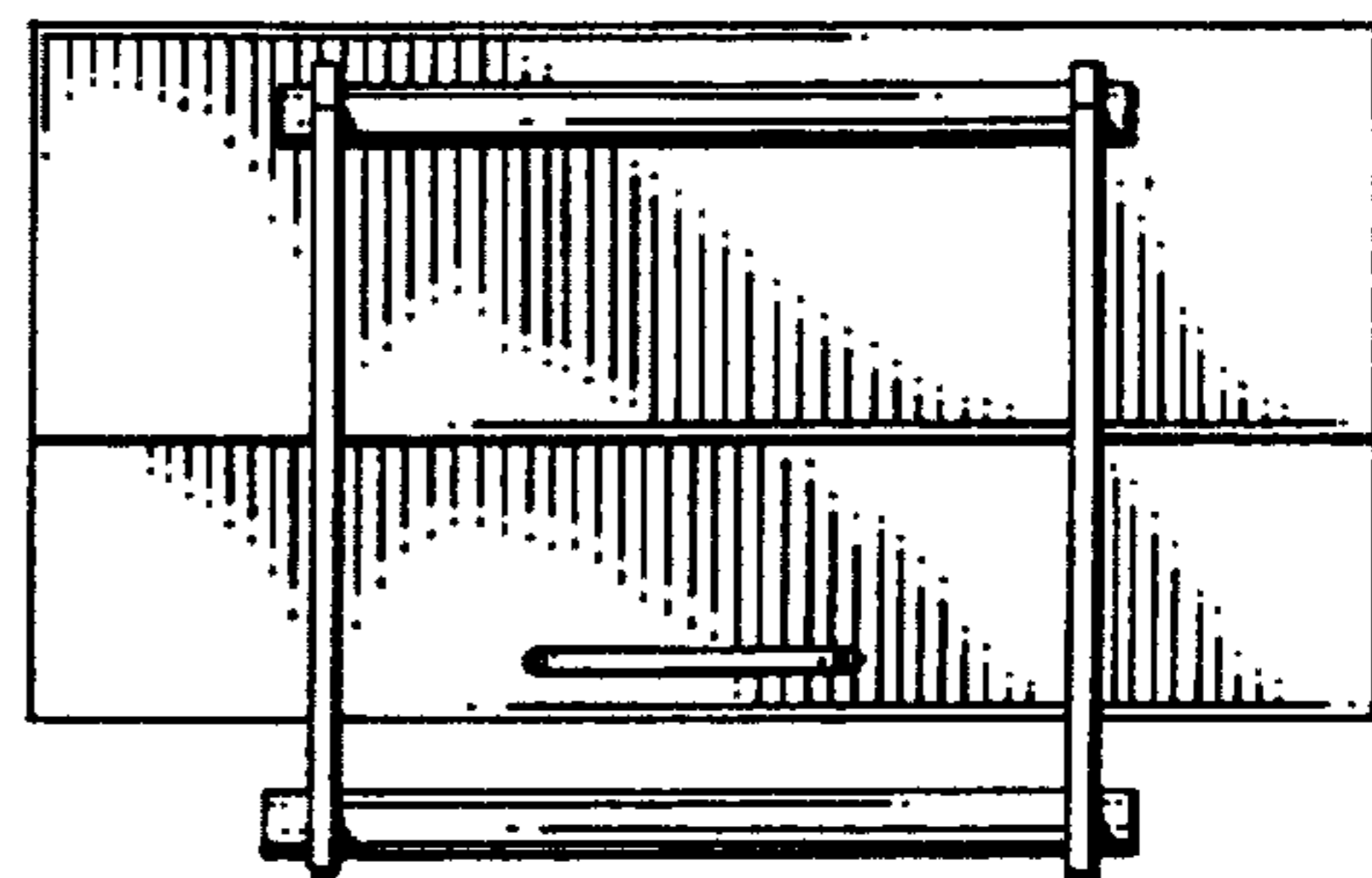
