## DESCRIPTION

FIG. 1 is a front elevational view of a two-way radio showing our new design;

FIG. 2 is a right side elevational view of the two-way radio of FIG. 1;

FIG. 3 is a left side elevational view of the two-way radio of FIG. 1;

FIG. 4 is a rear elevational view of the two-way radio of FIG. 1;

FIG. 5 is a top plan view of the two-way radio of FIG. 1;

FIG. 6 is a bottom plan view of the two-way radio of FIG. 1;

FIG. 7 is a front elevational view of an alternative embodiment of a two-way radio showing our new design;

FIG. 8 is a right side elevational view of the two-way radio of FIG. 7;

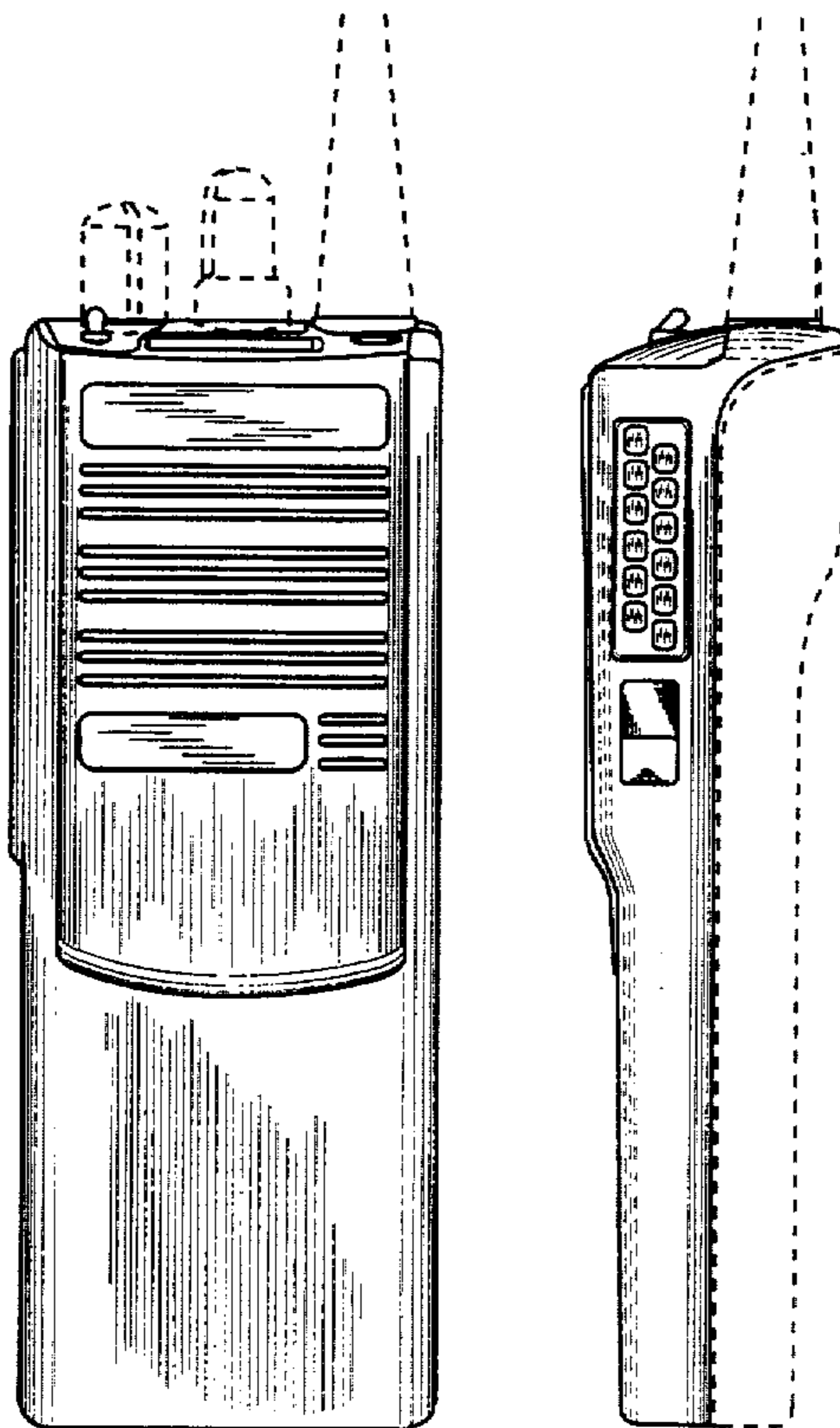
FIG. 9 is a left side elevational view of the two-way radio of FIG. 7;

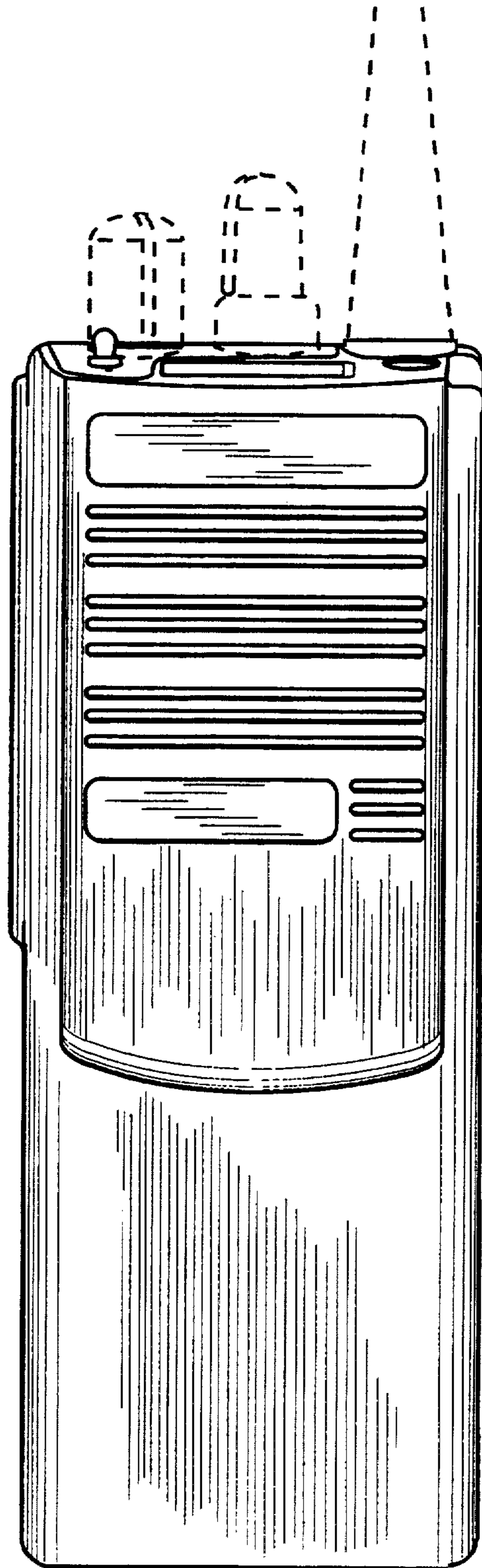
FIG. 10 is a rear elevational view of the two-way radio of FIG. 7;

FIG. 11 is a top plan view of the two-way radio of FIG. 7; and,

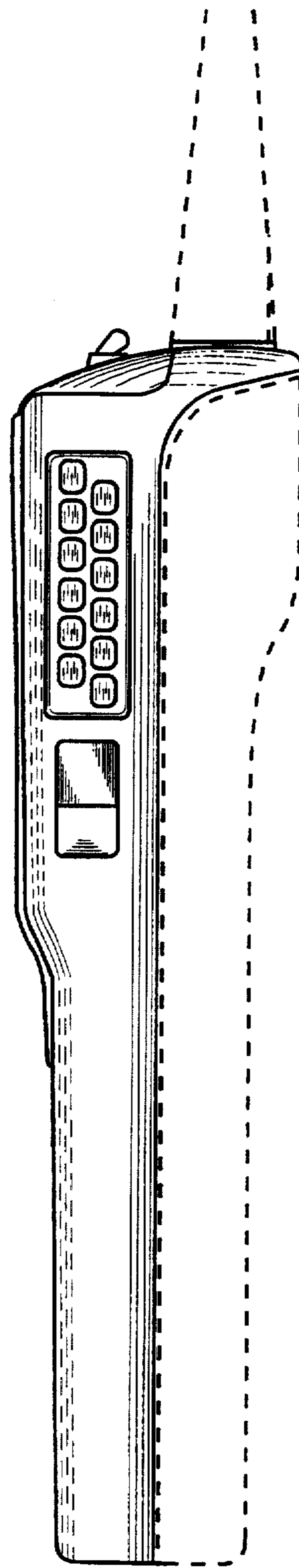
FIG. 12 is a bottom plan view of the two-way radio of FIG. 7.

The broken line showing of the knobs and the antenna is for illustrative purposes only and forms no part of the claimed design.

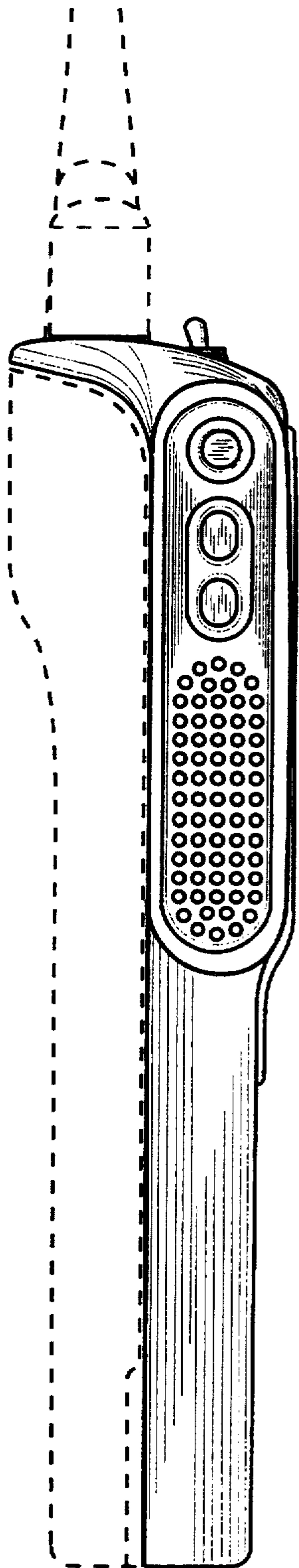




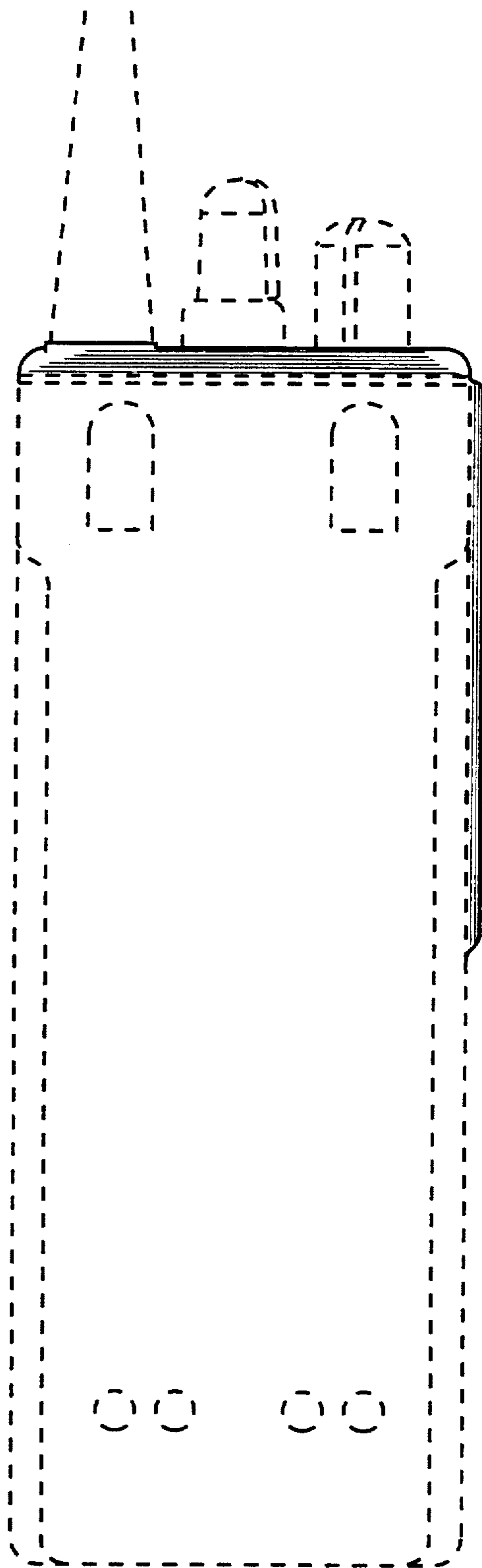

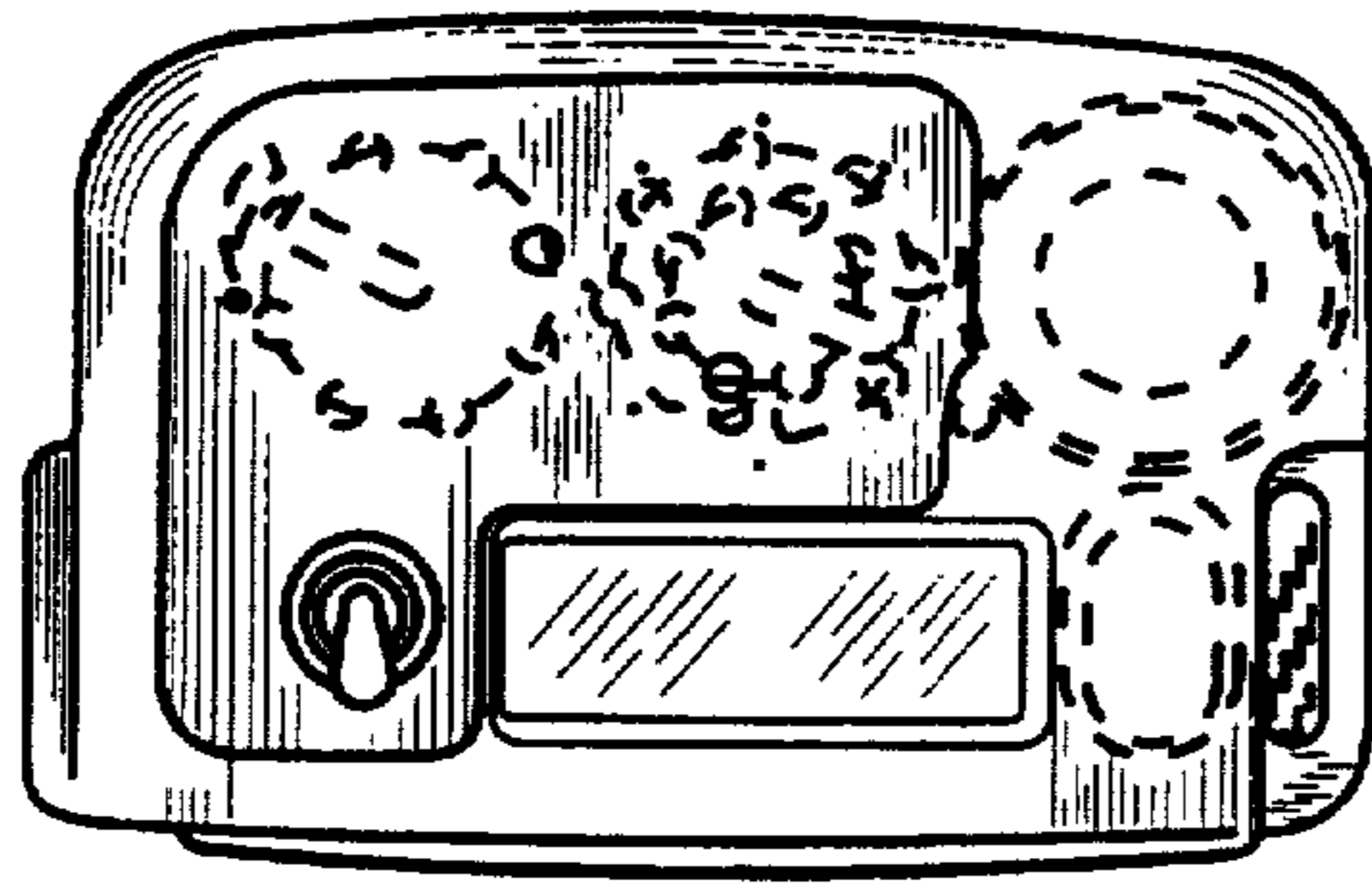

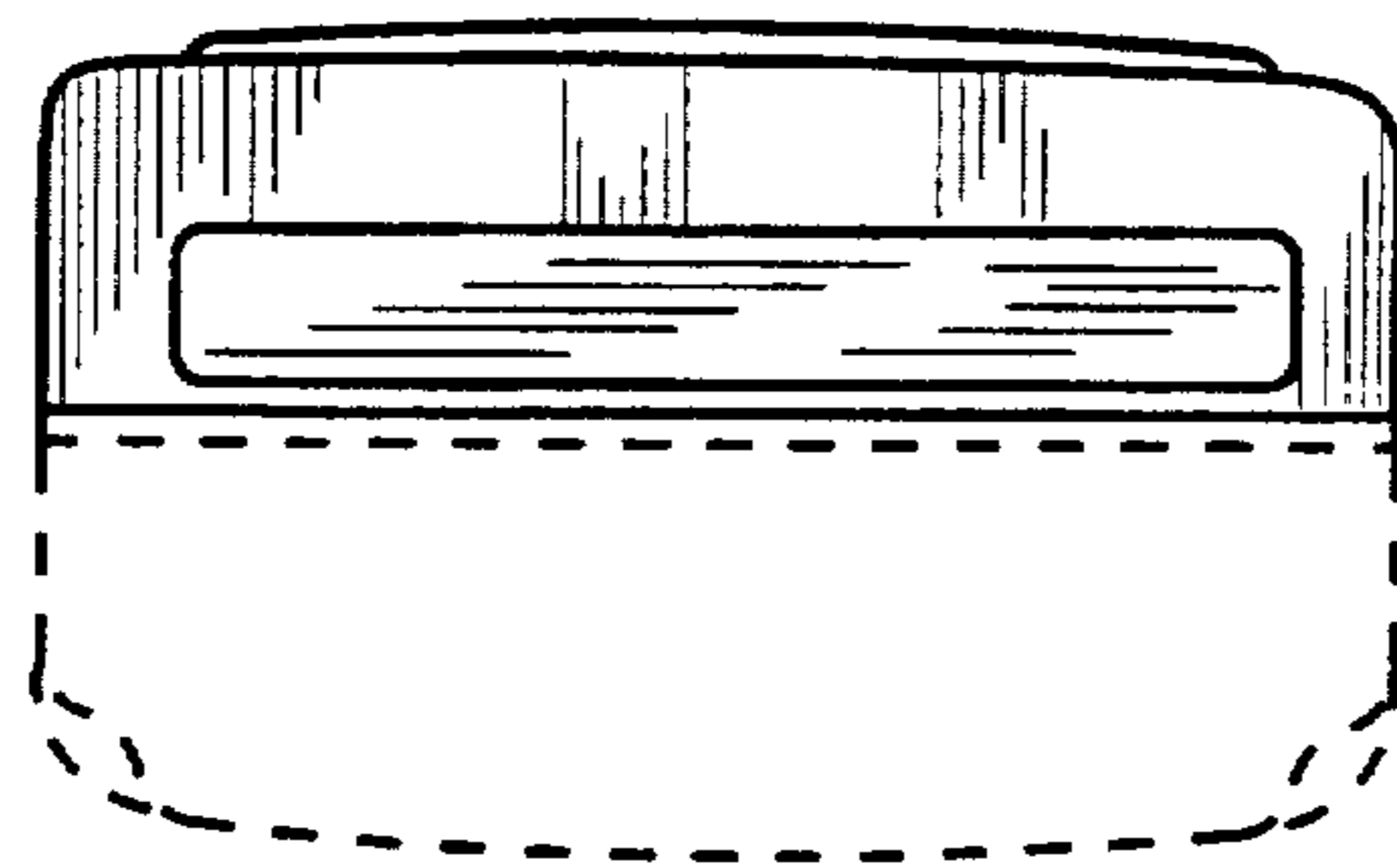

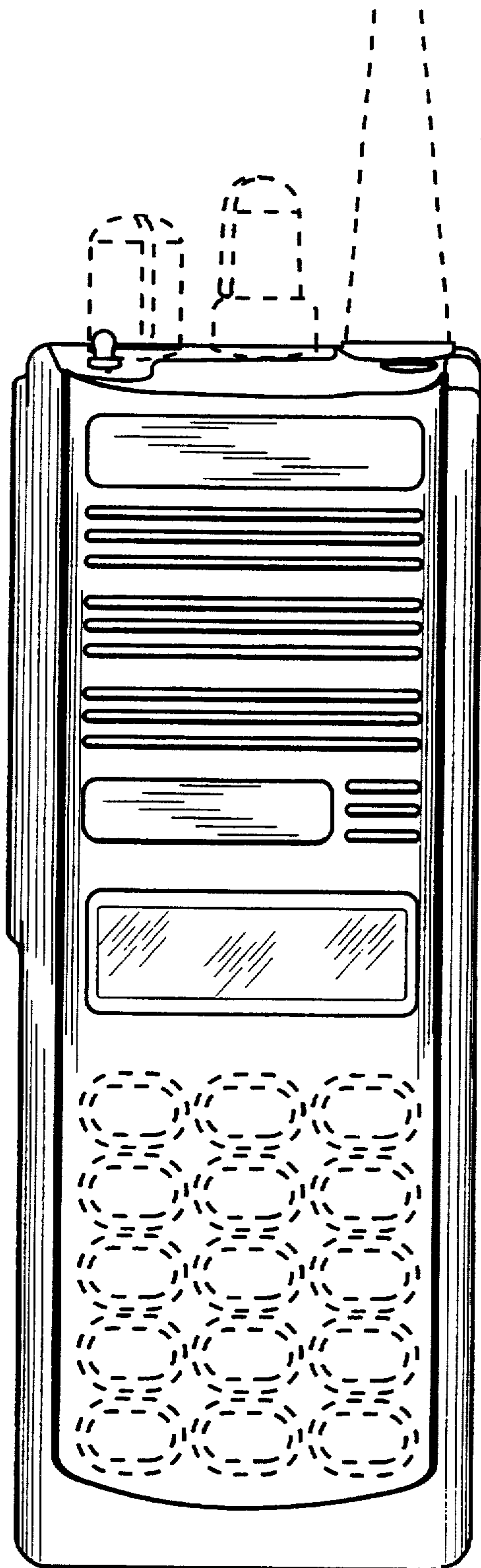

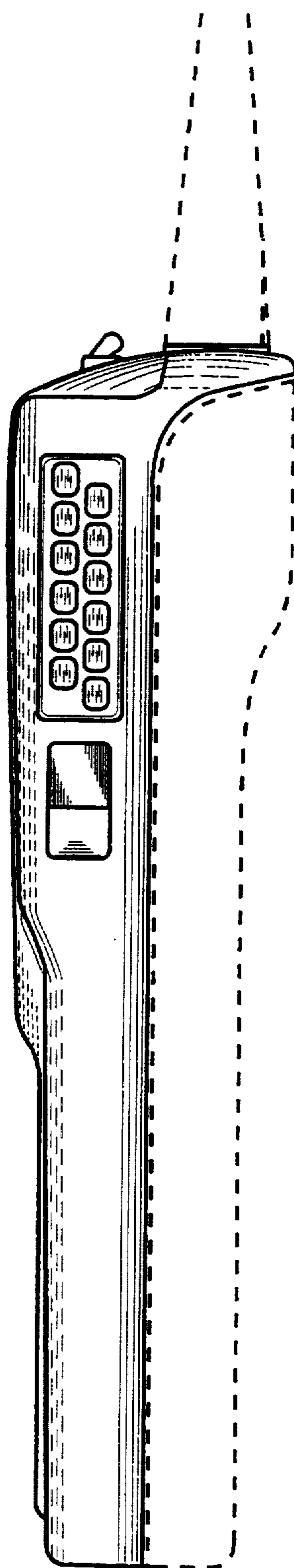

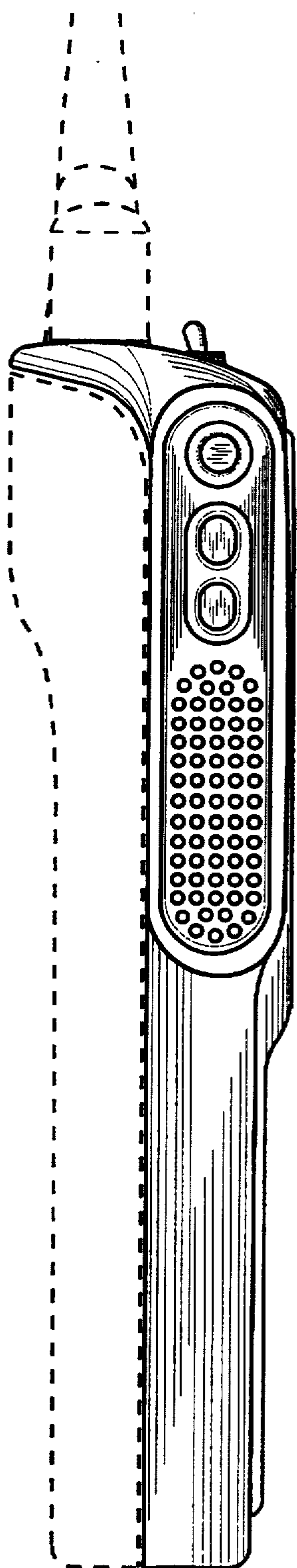

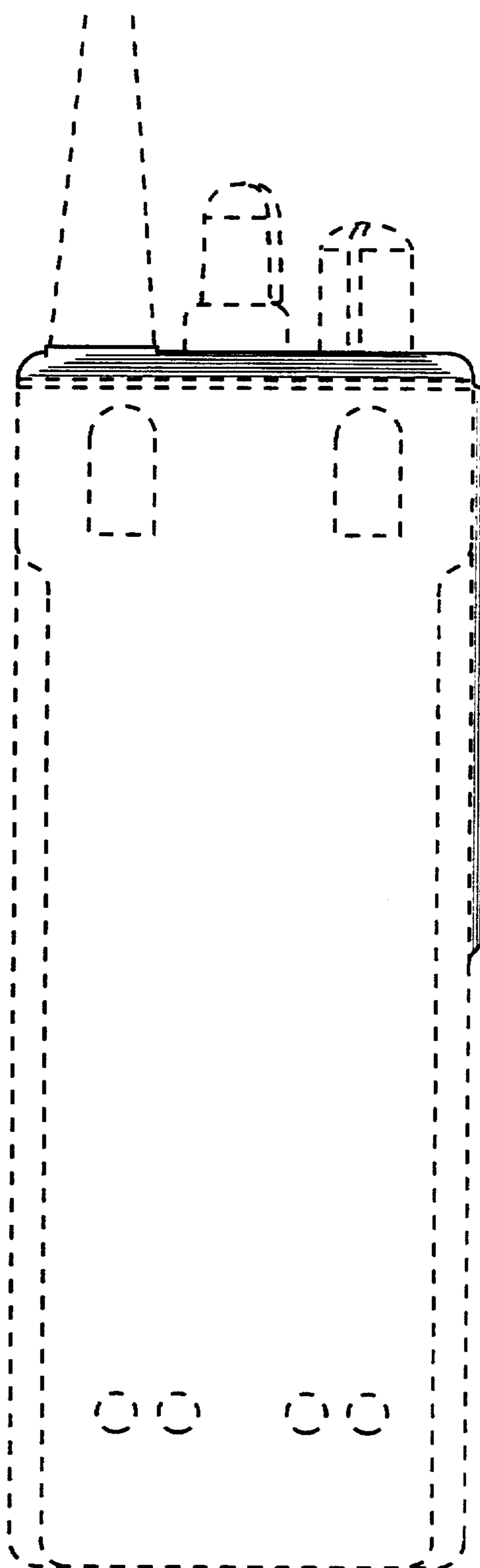

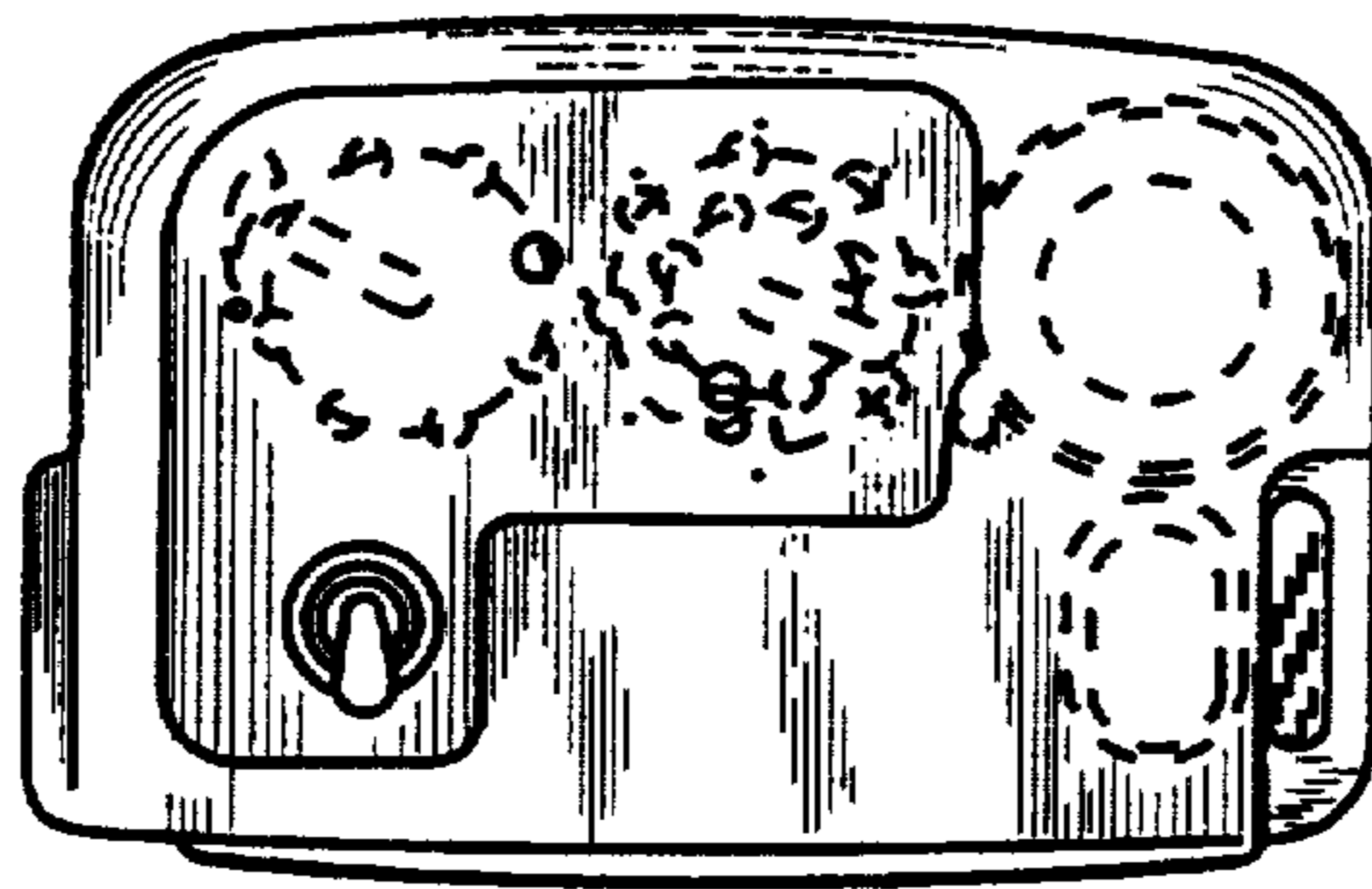

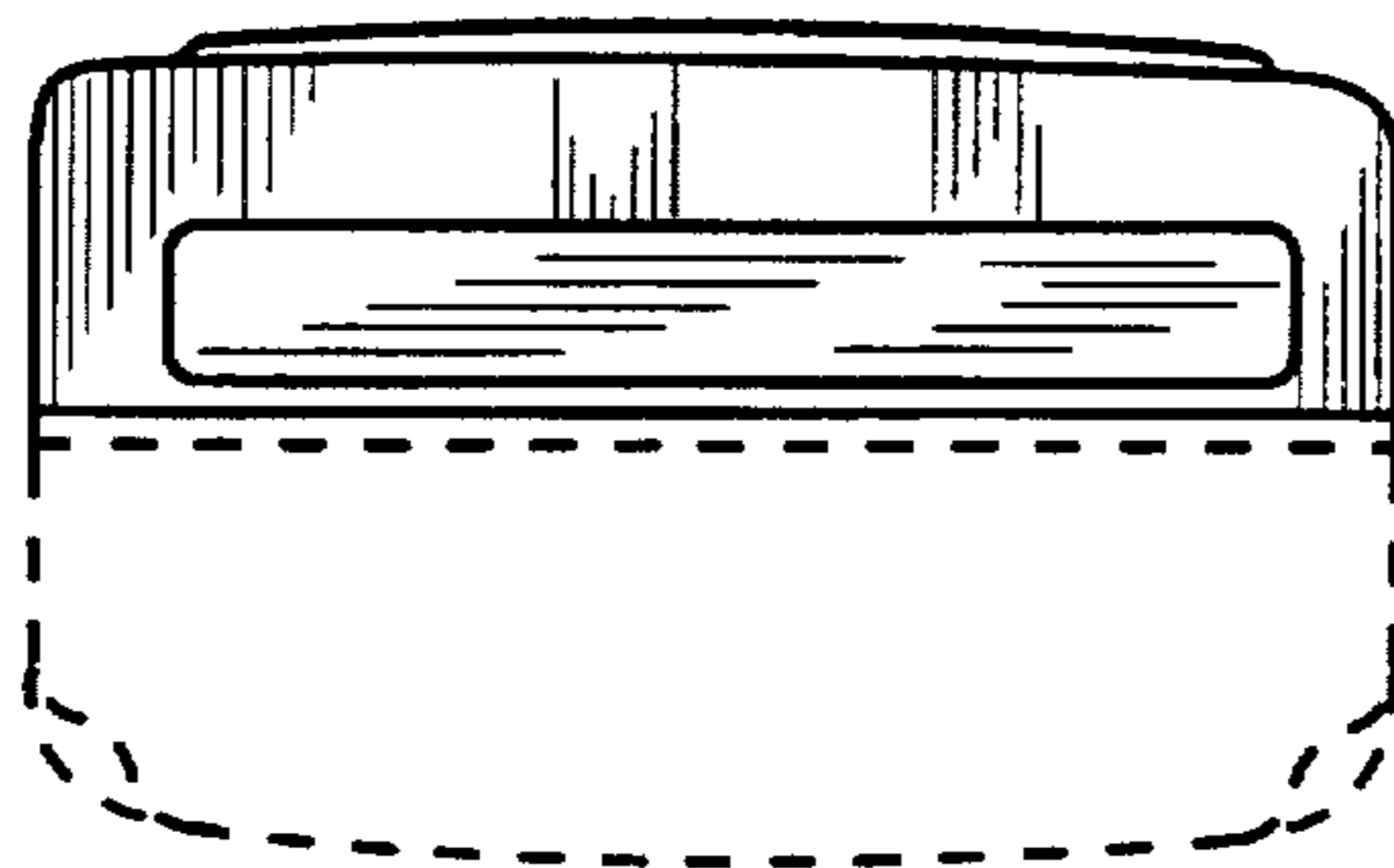
