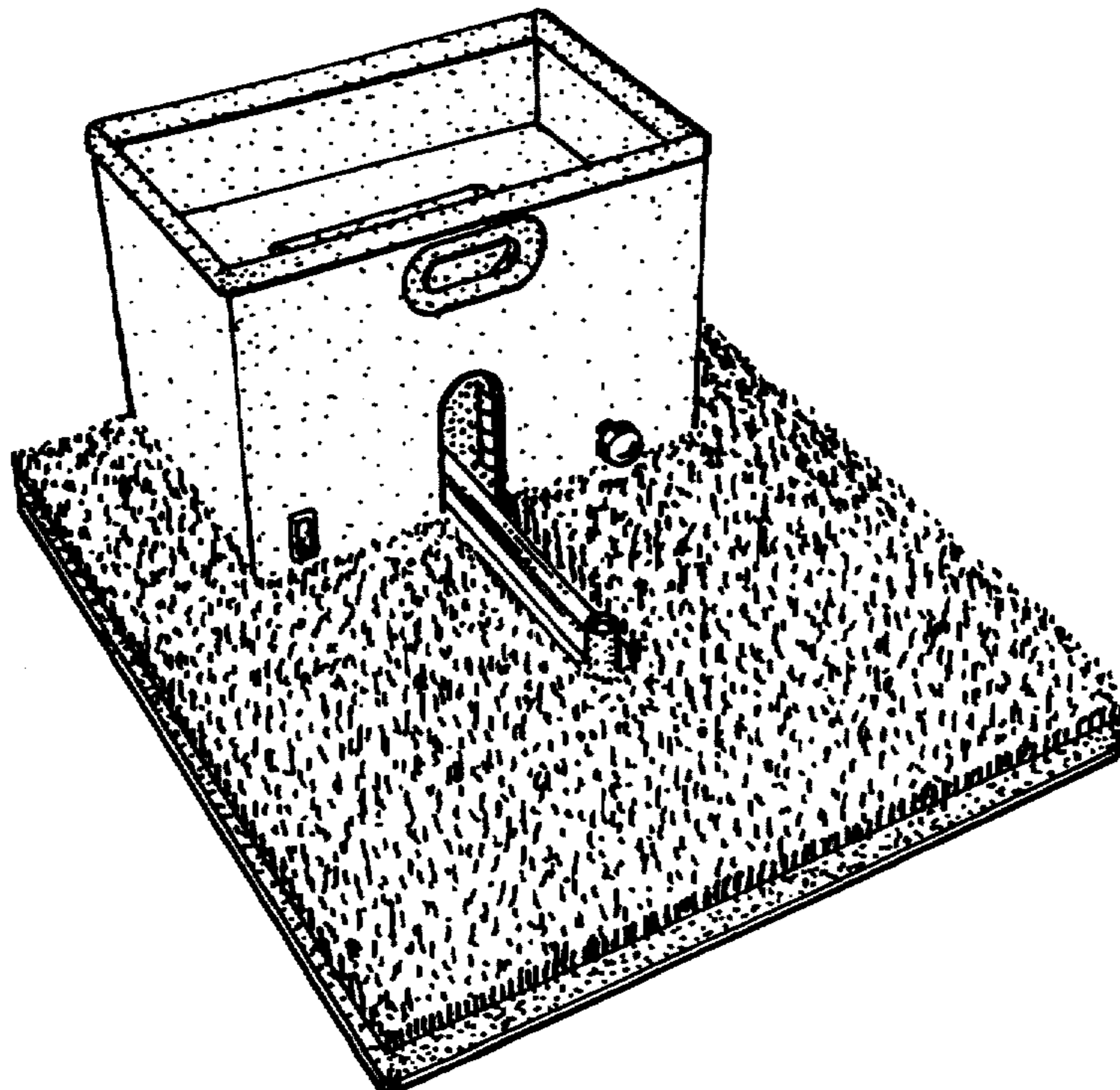

 The rear view of the upright housing portion shown in FIGS. 8 and 9 are the same as FIG. 5.



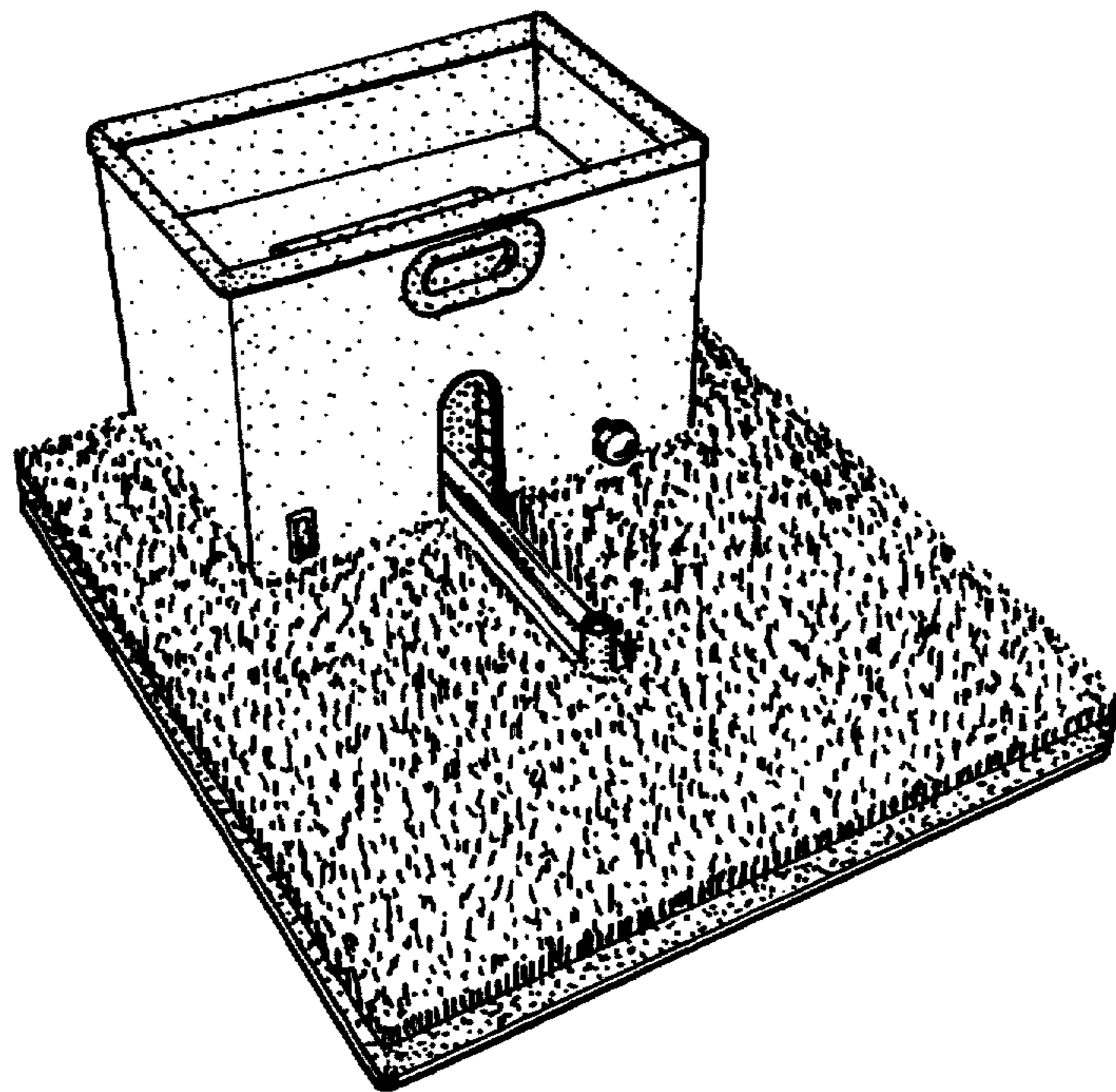

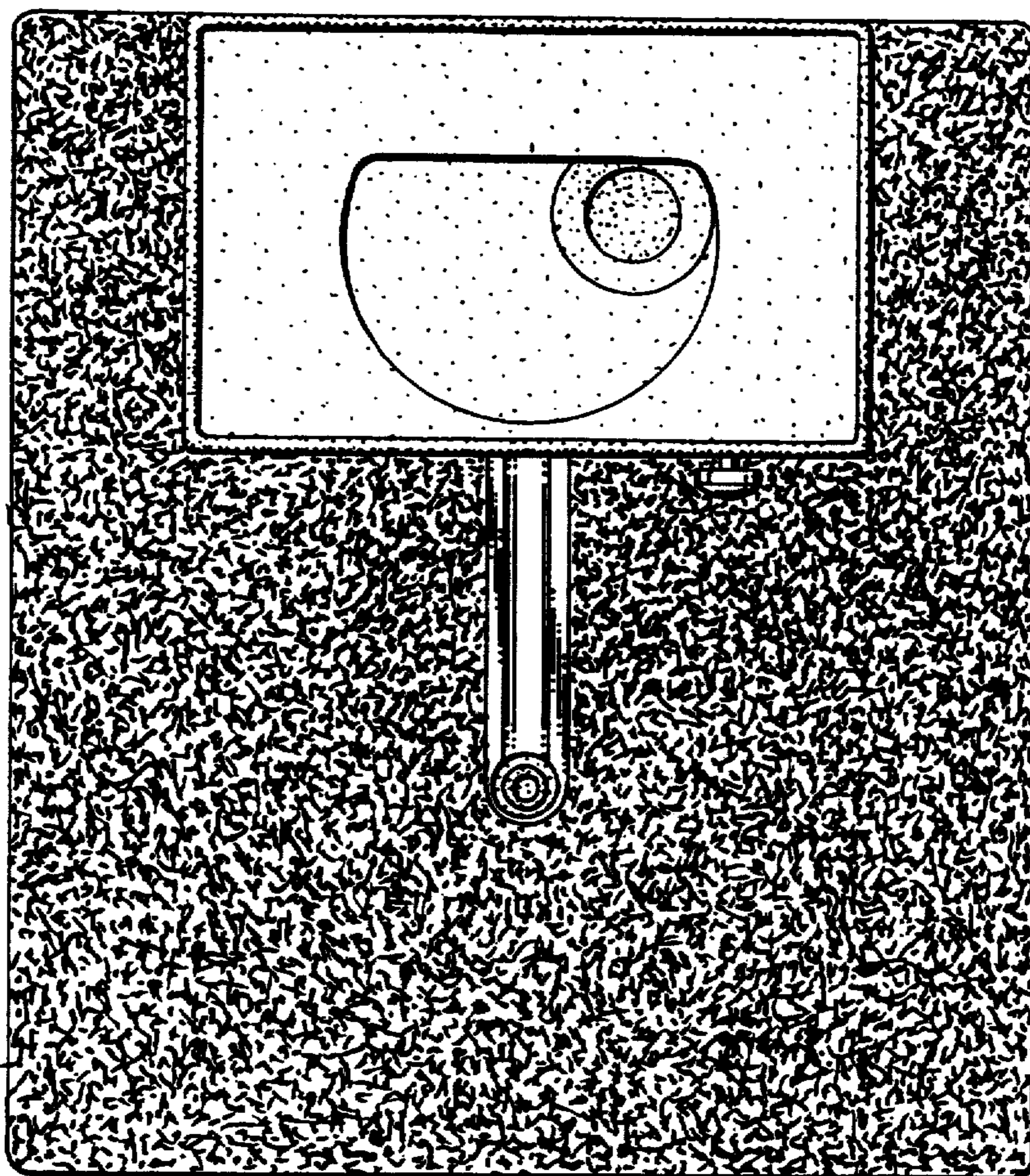

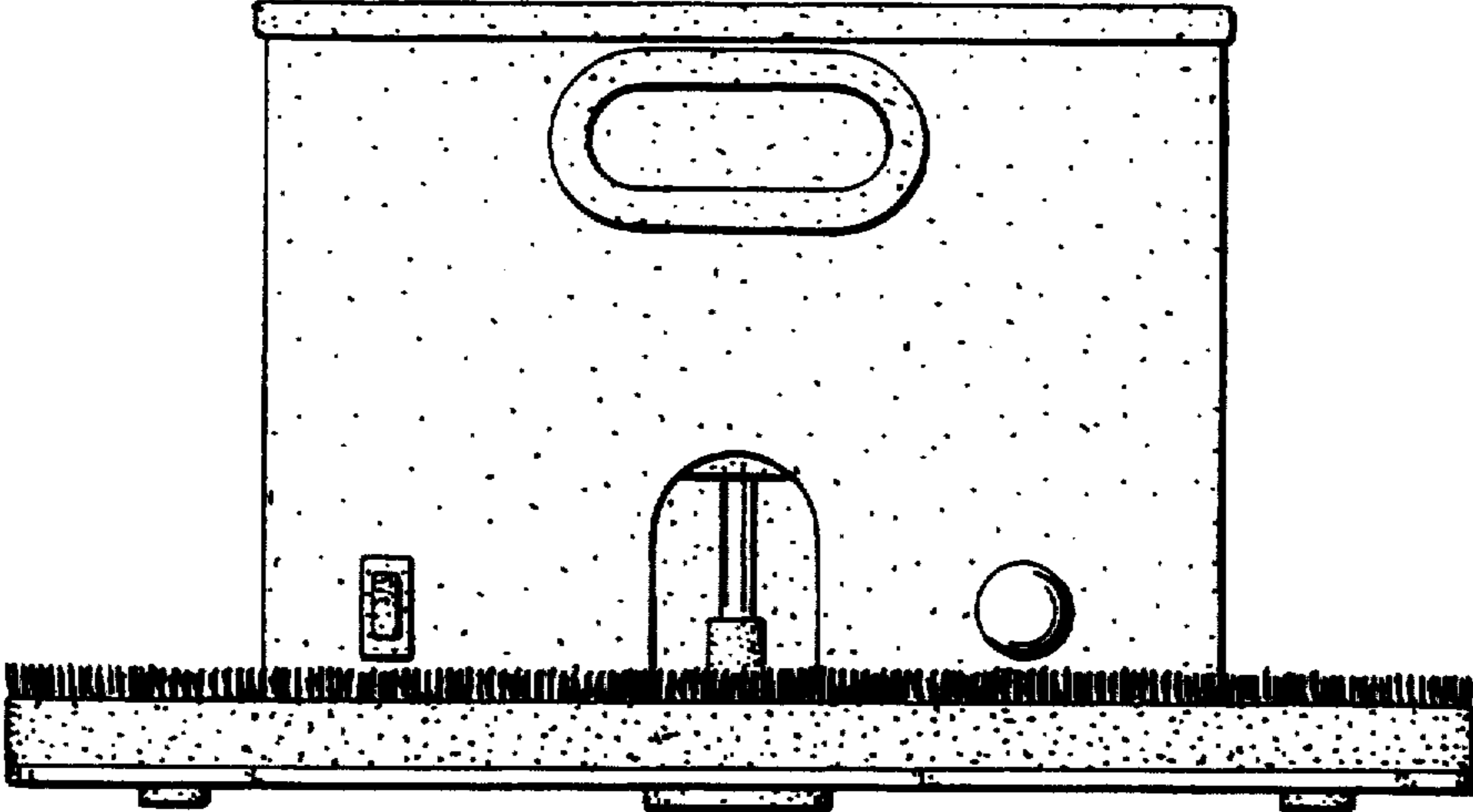

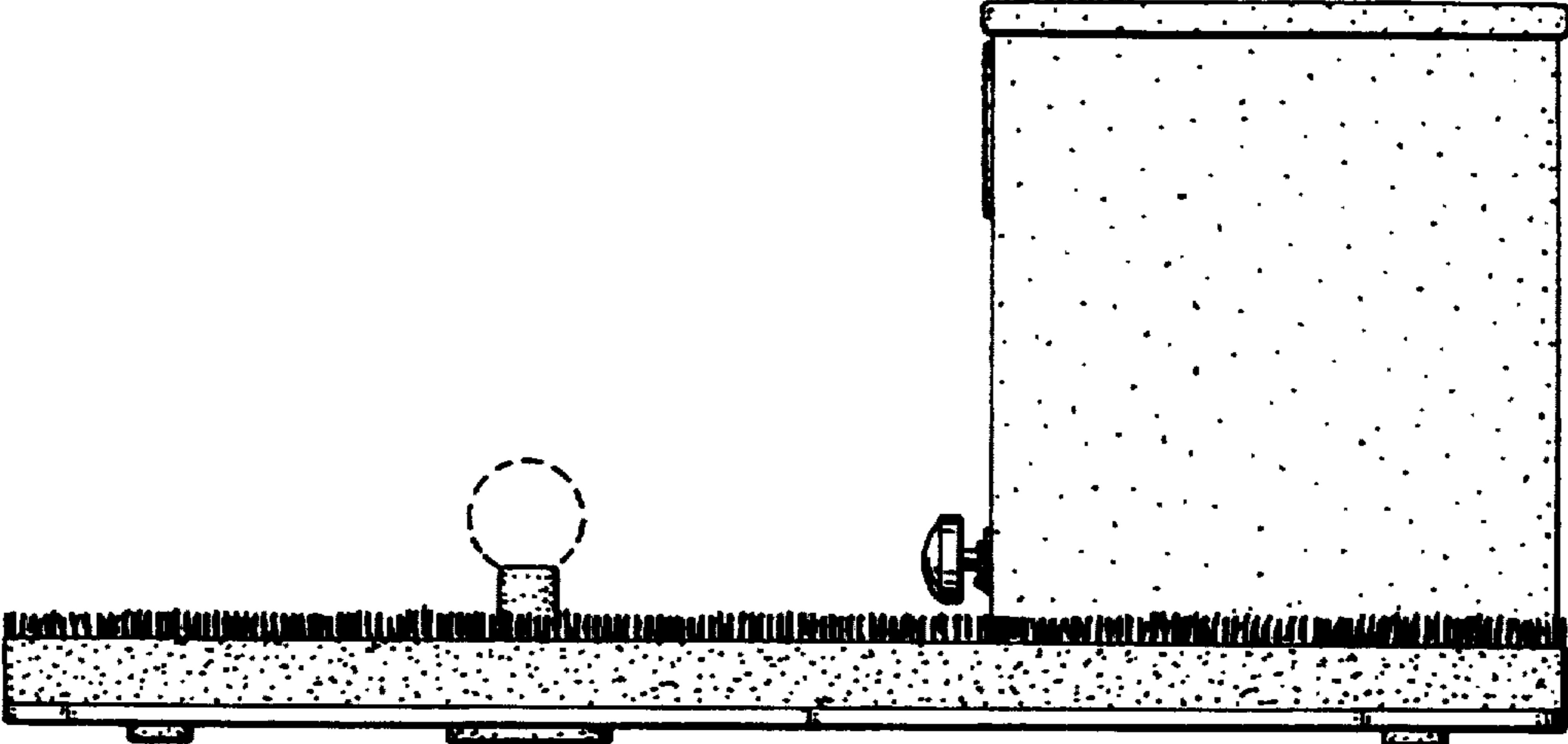

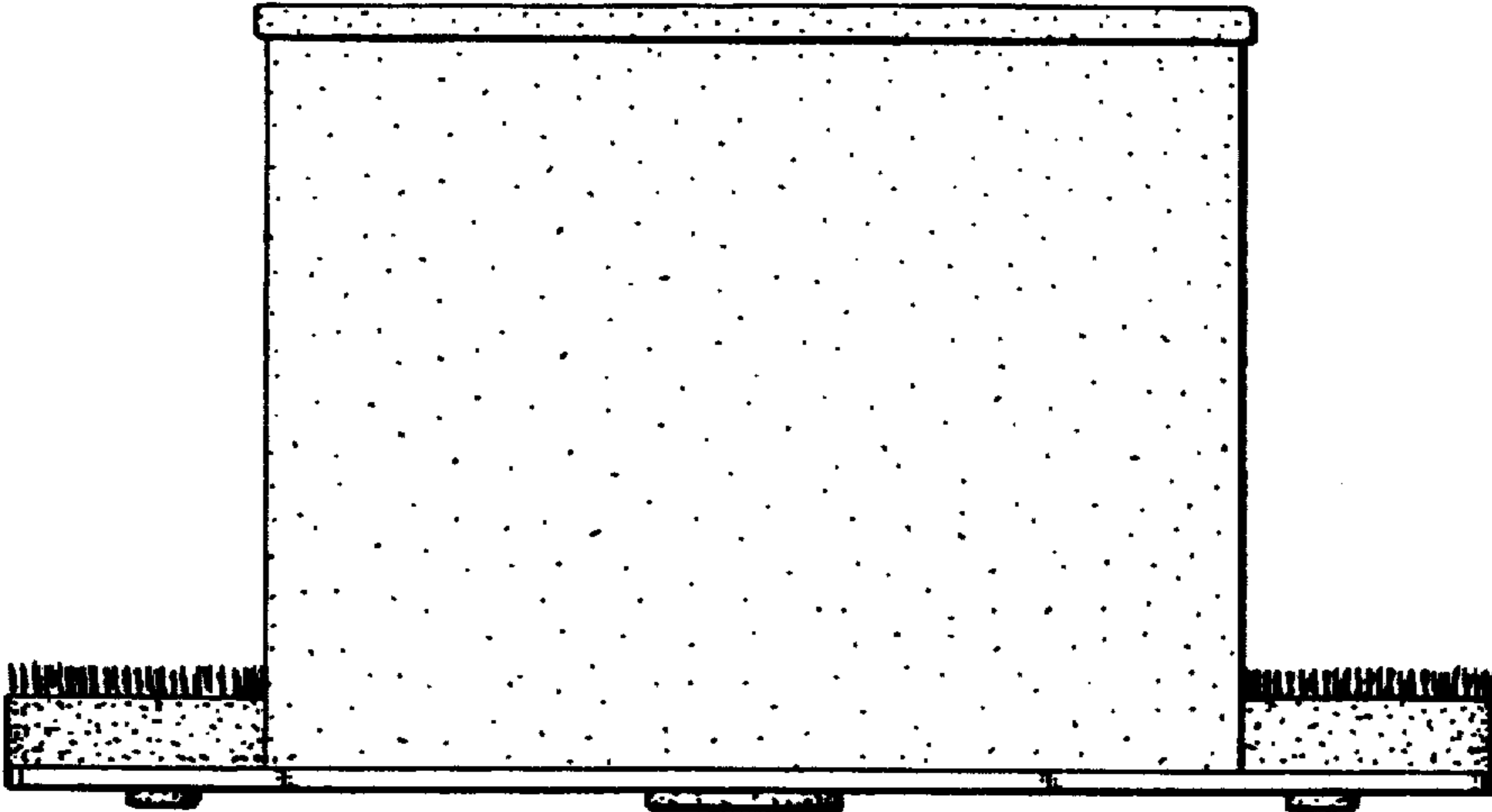

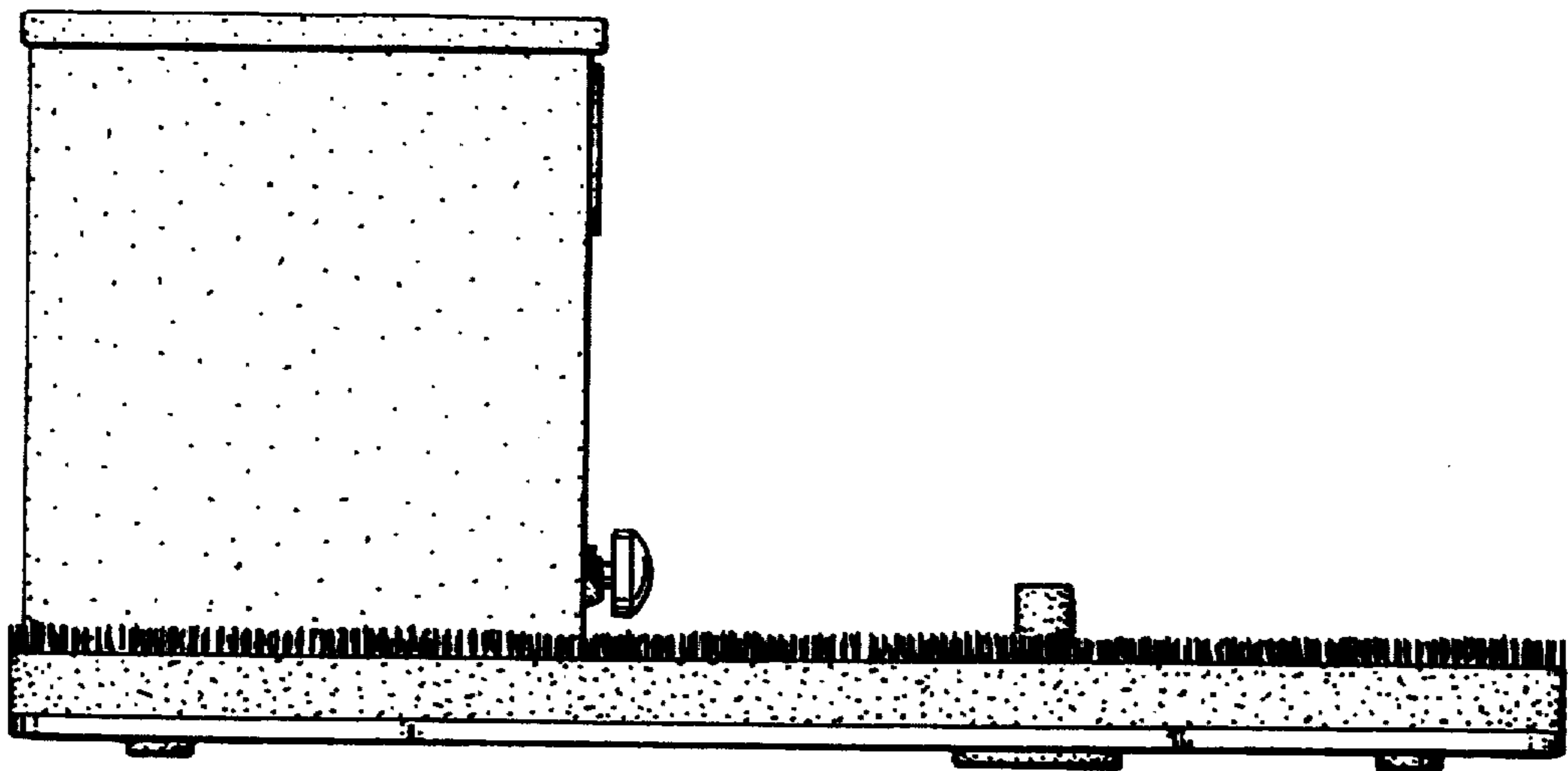

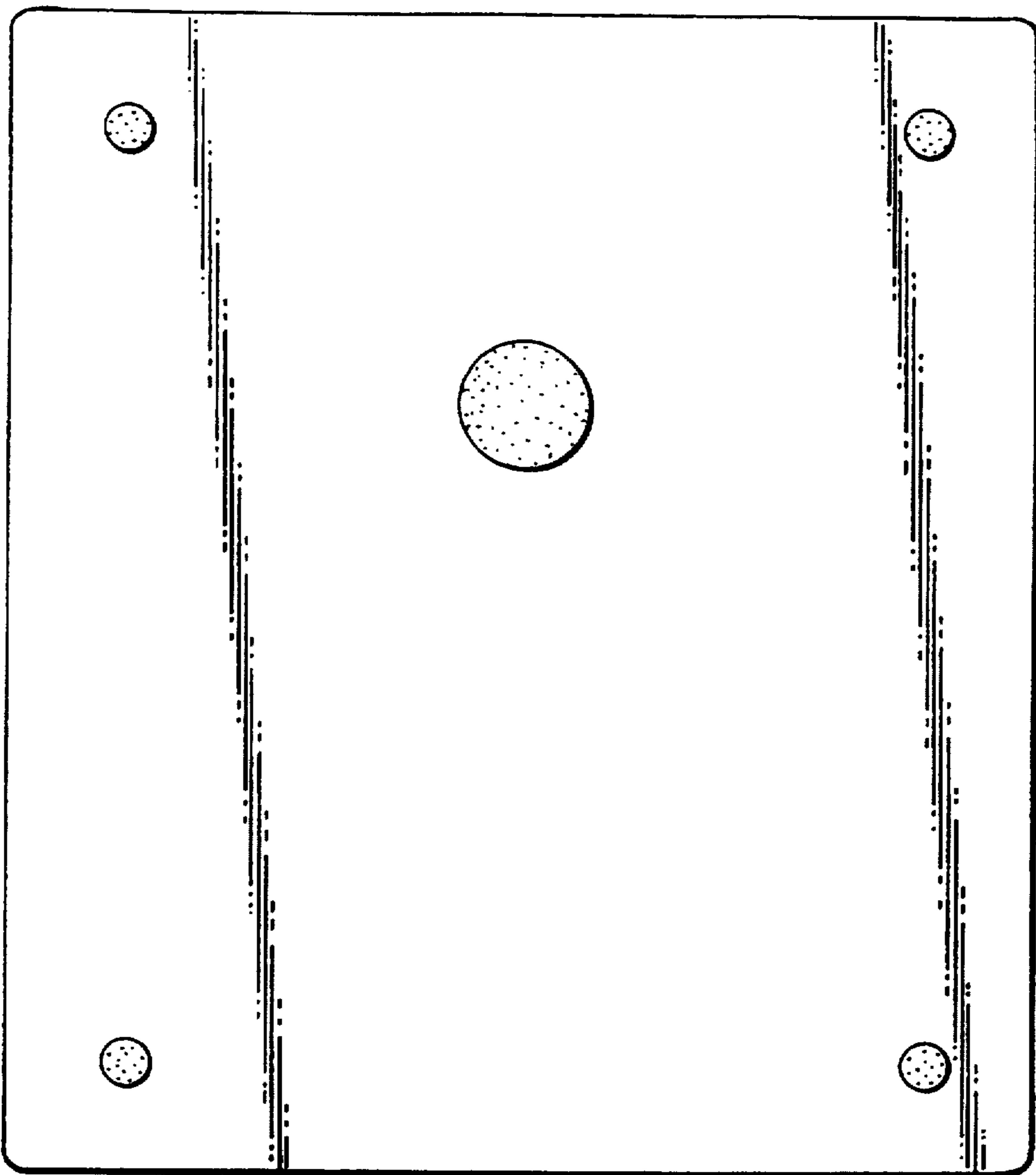

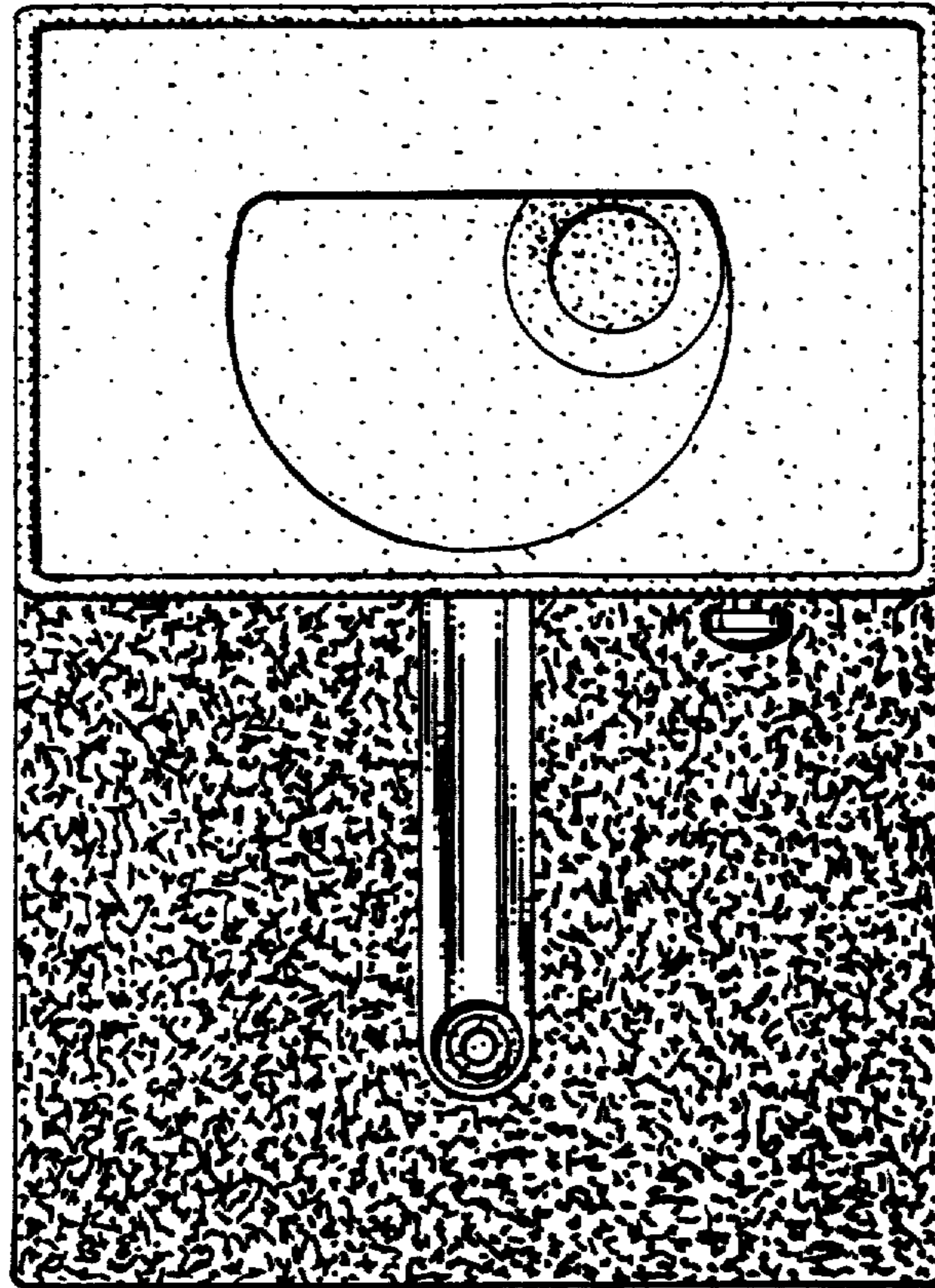

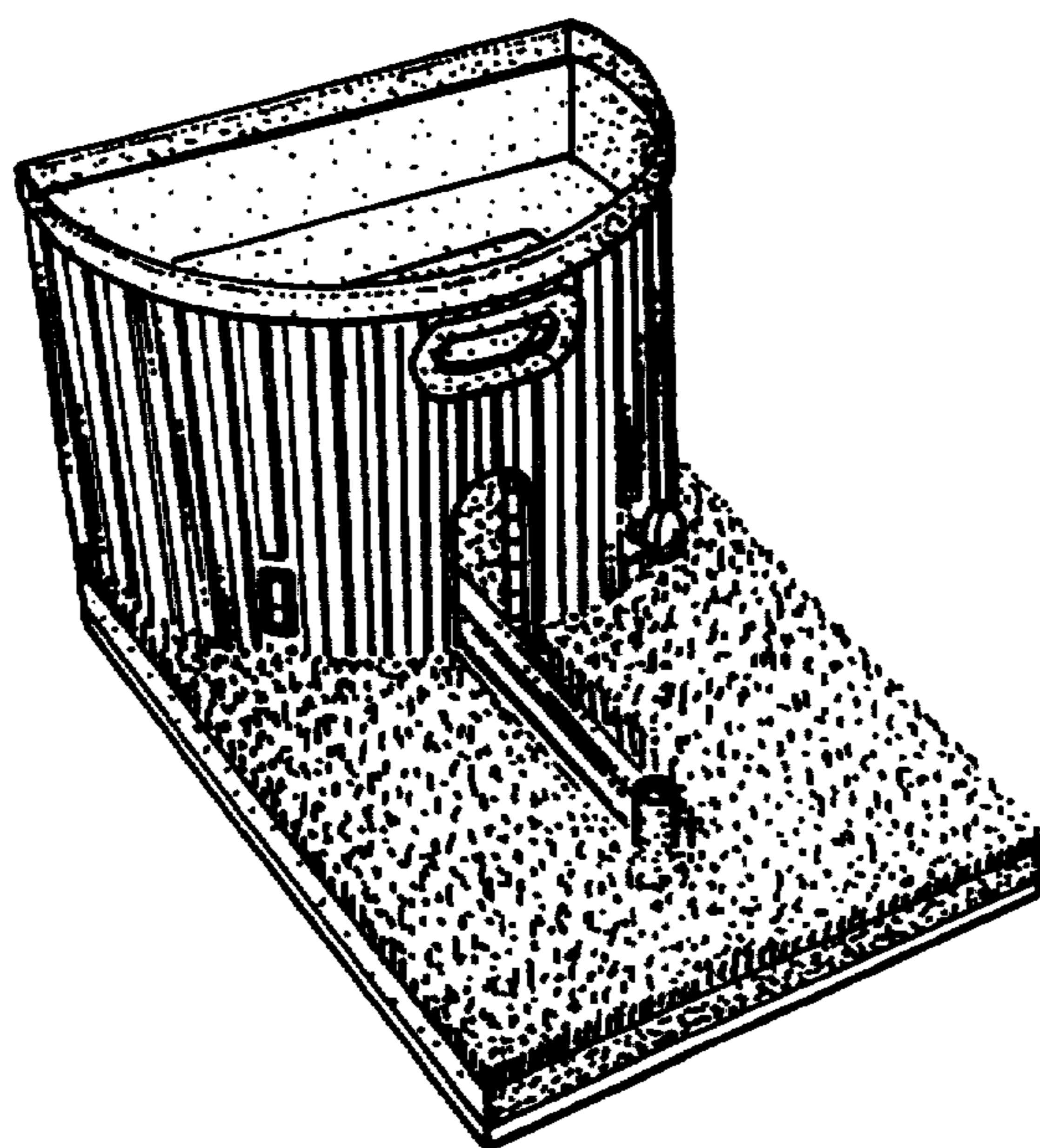
