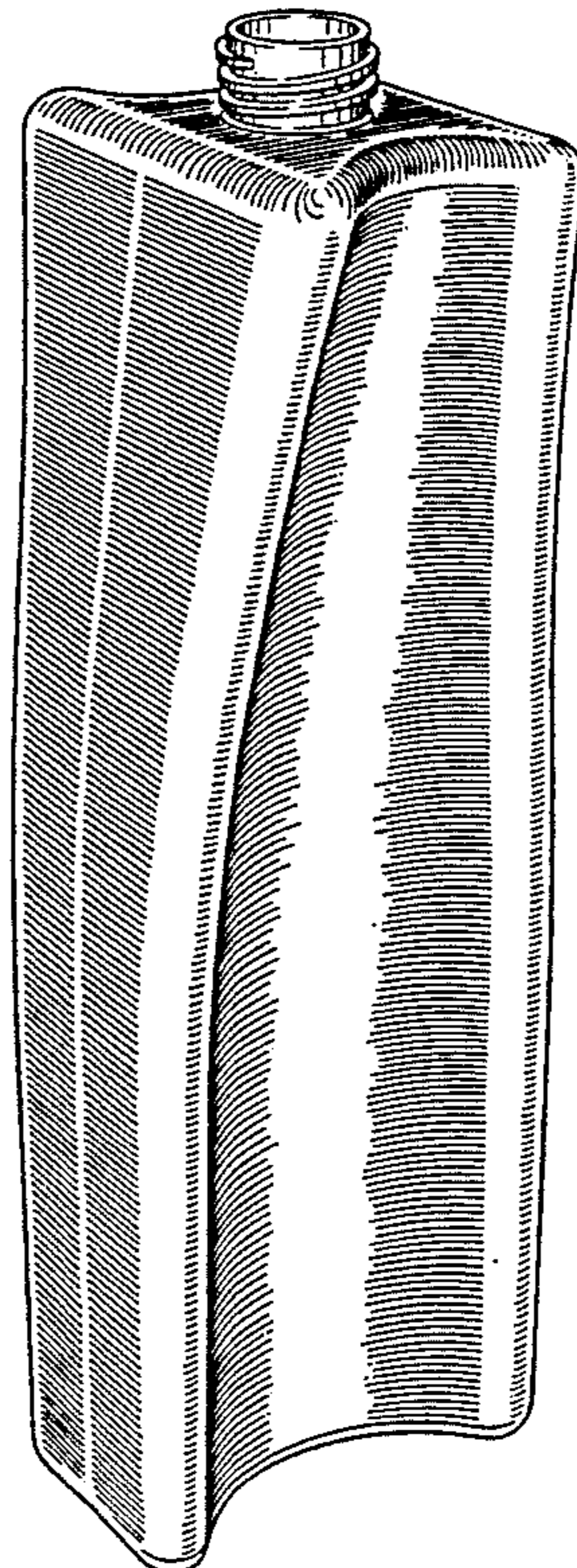

[57] **CLAIM**

The ornamental design for a chiller bottle, as shown and described.

DESCRIPTION

FIG. 1 is a side perspective view from above of my inventive chiller bottle;
 FIG. 2 is a front perspective view from below;
 FIG. 3 is a front view, the view from the rear being the same;
 FIG. 4 is a side view, the view from the other side being the same;
 FIG. 5 is a top plan view;
 FIG. 6 is a bottom plan view;
 FIG. 7 is a cross-sectional view along the lines and the direction of arrows 7-7 of FIG. 3;
 FIG. 8 is a cross-sectional view along the lines and the direction of arrows 8-8 of FIG. 3;
 FIG. 9 is a cross-sectional view along the lines and the direction of arrows 9-9 of FIG. 3; and,
 FIG. 10 is a cross-sectional view along the lines and the direction of arrows 10-10 of FIG. 3.



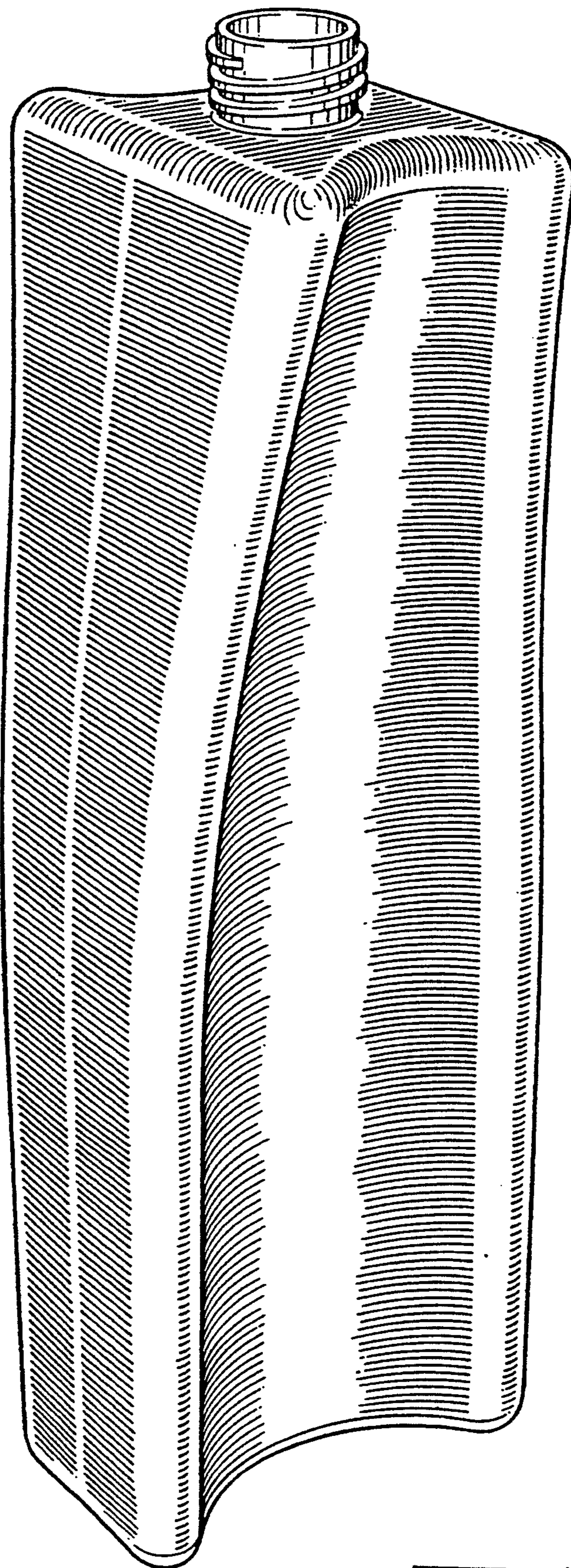

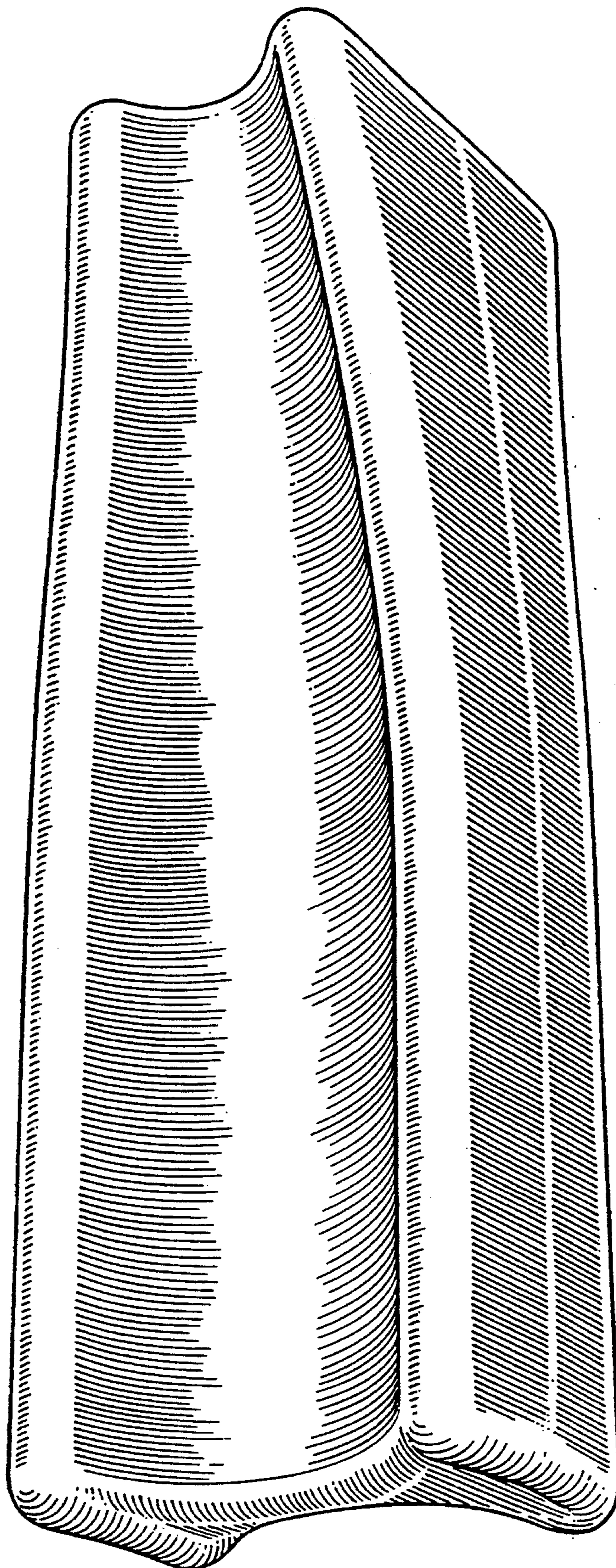

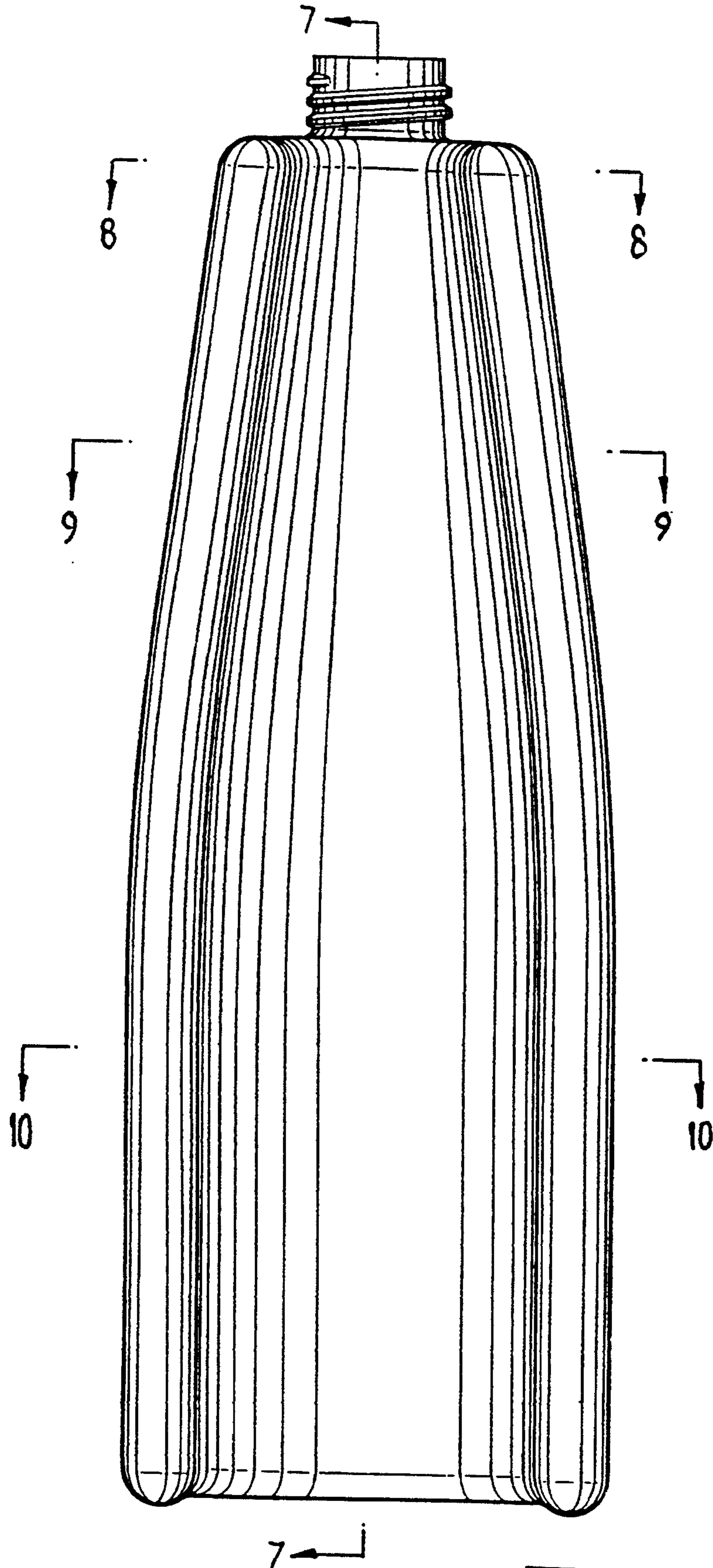

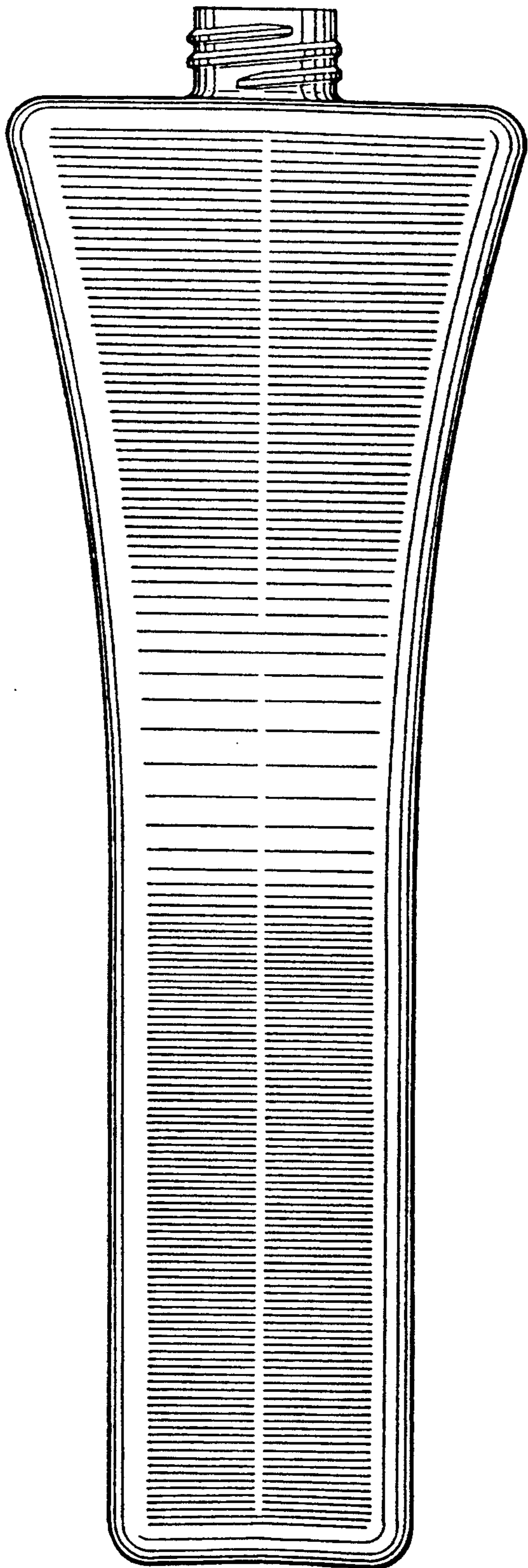

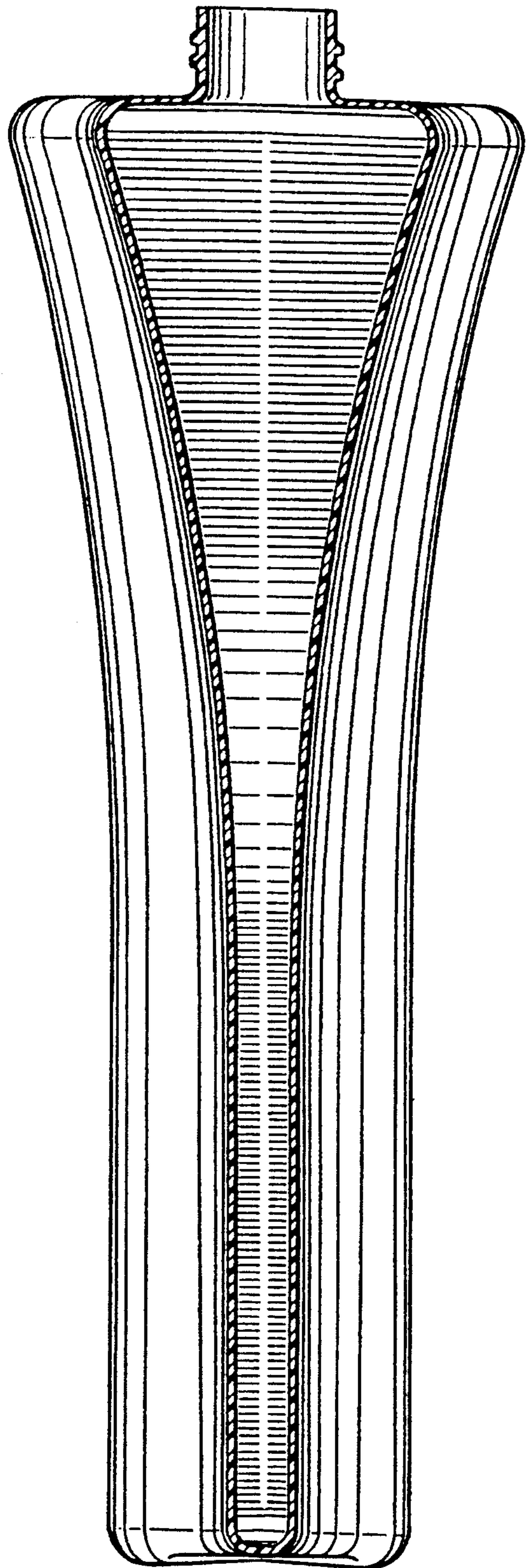

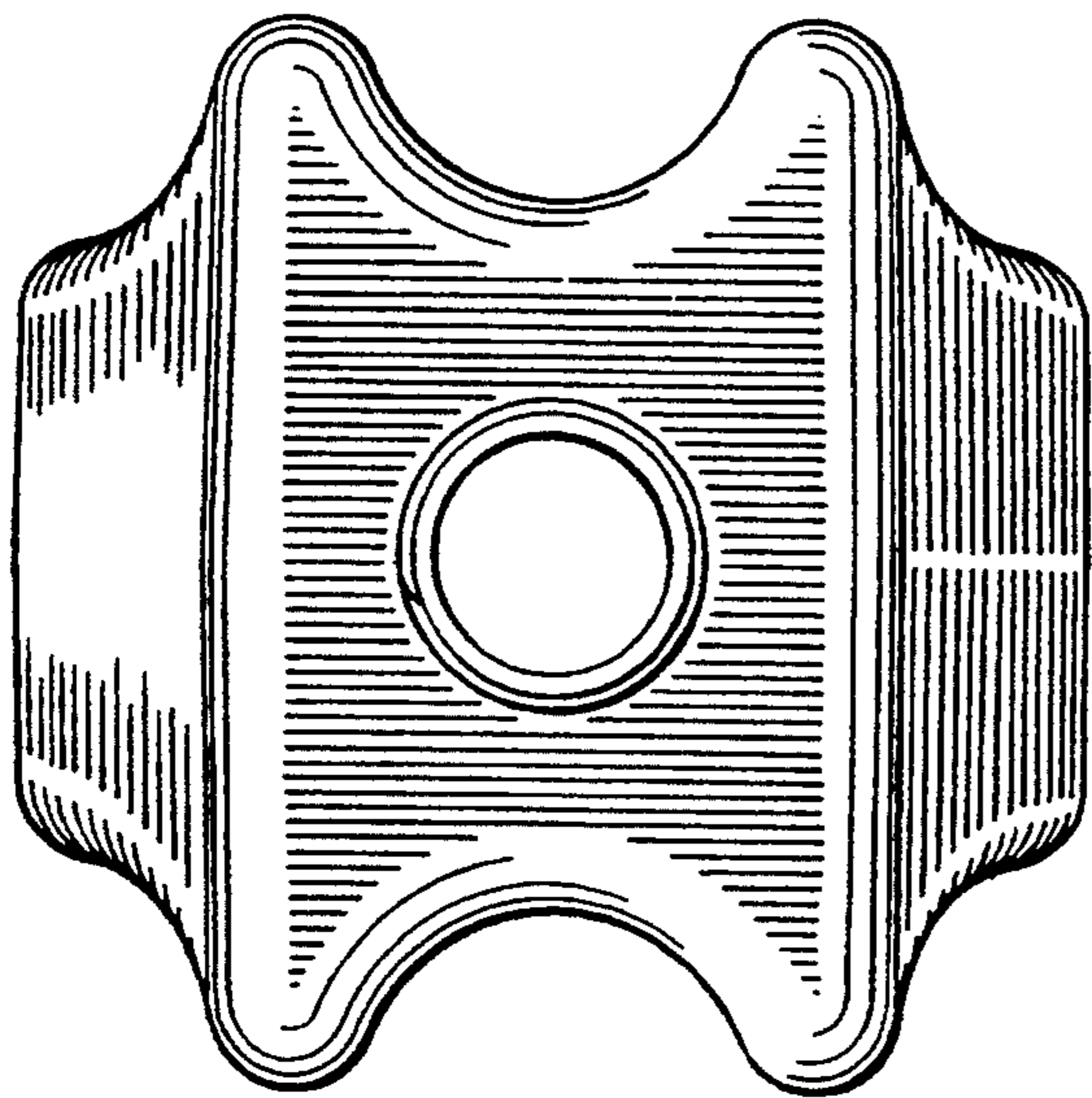

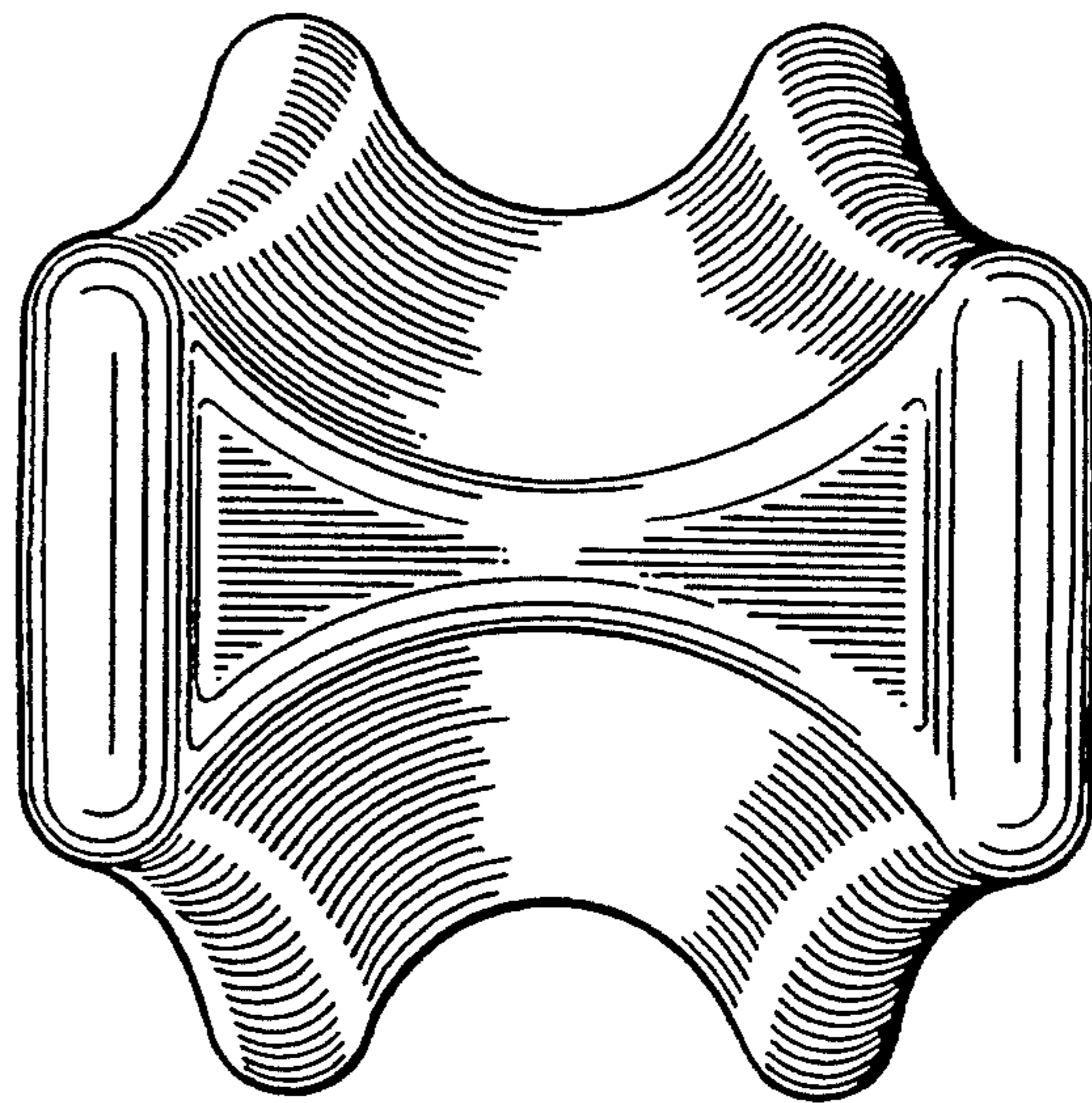

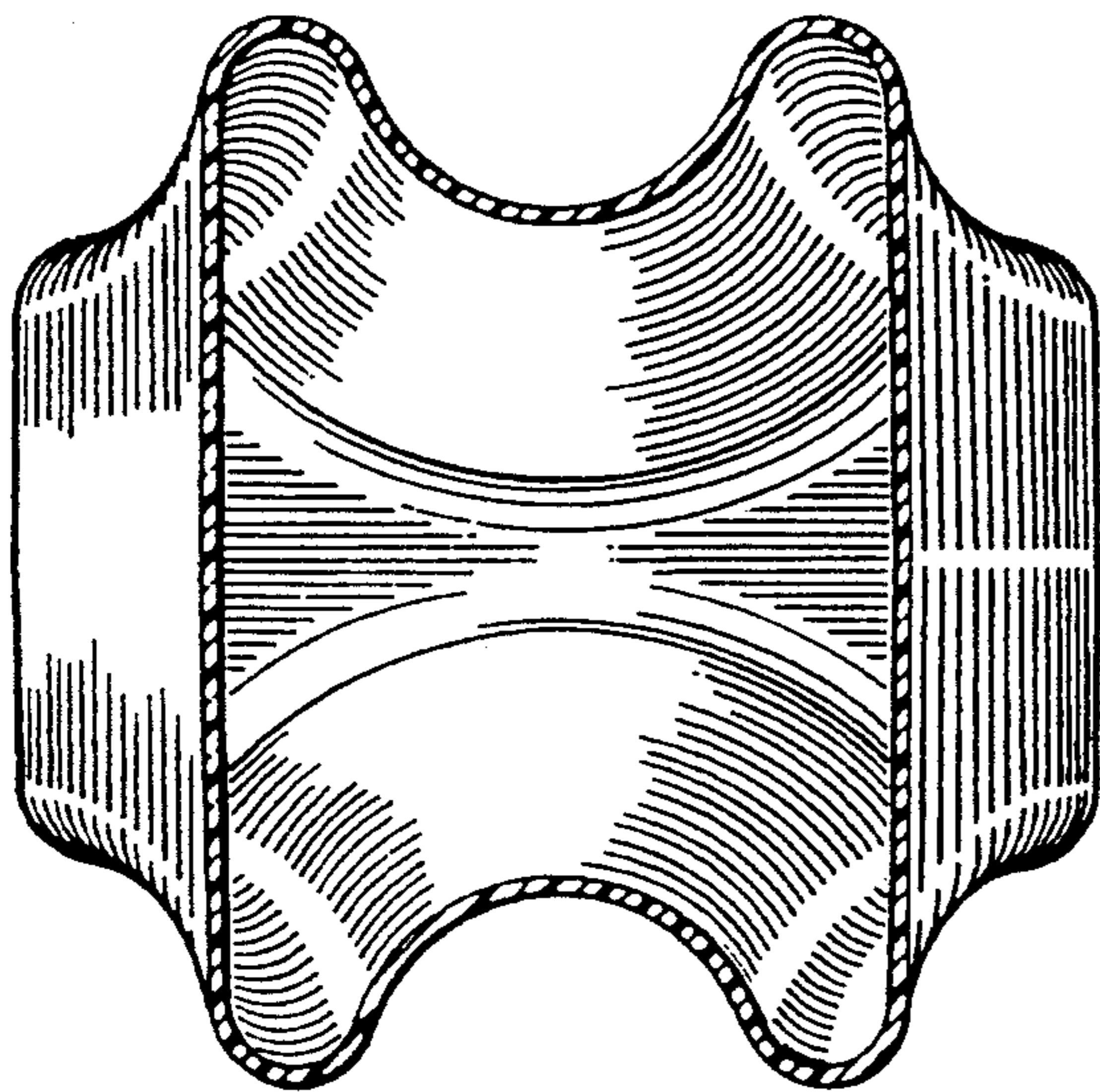

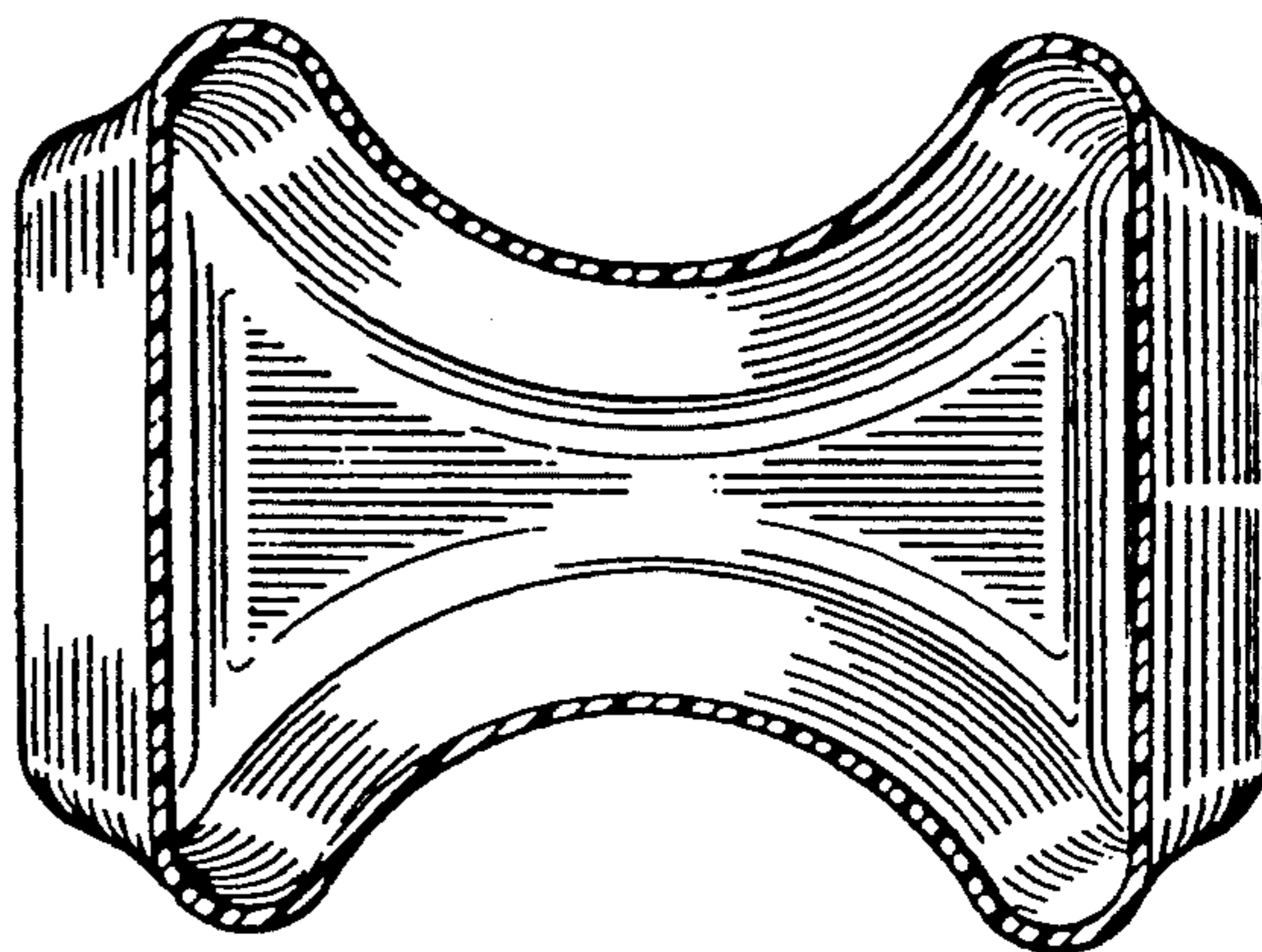

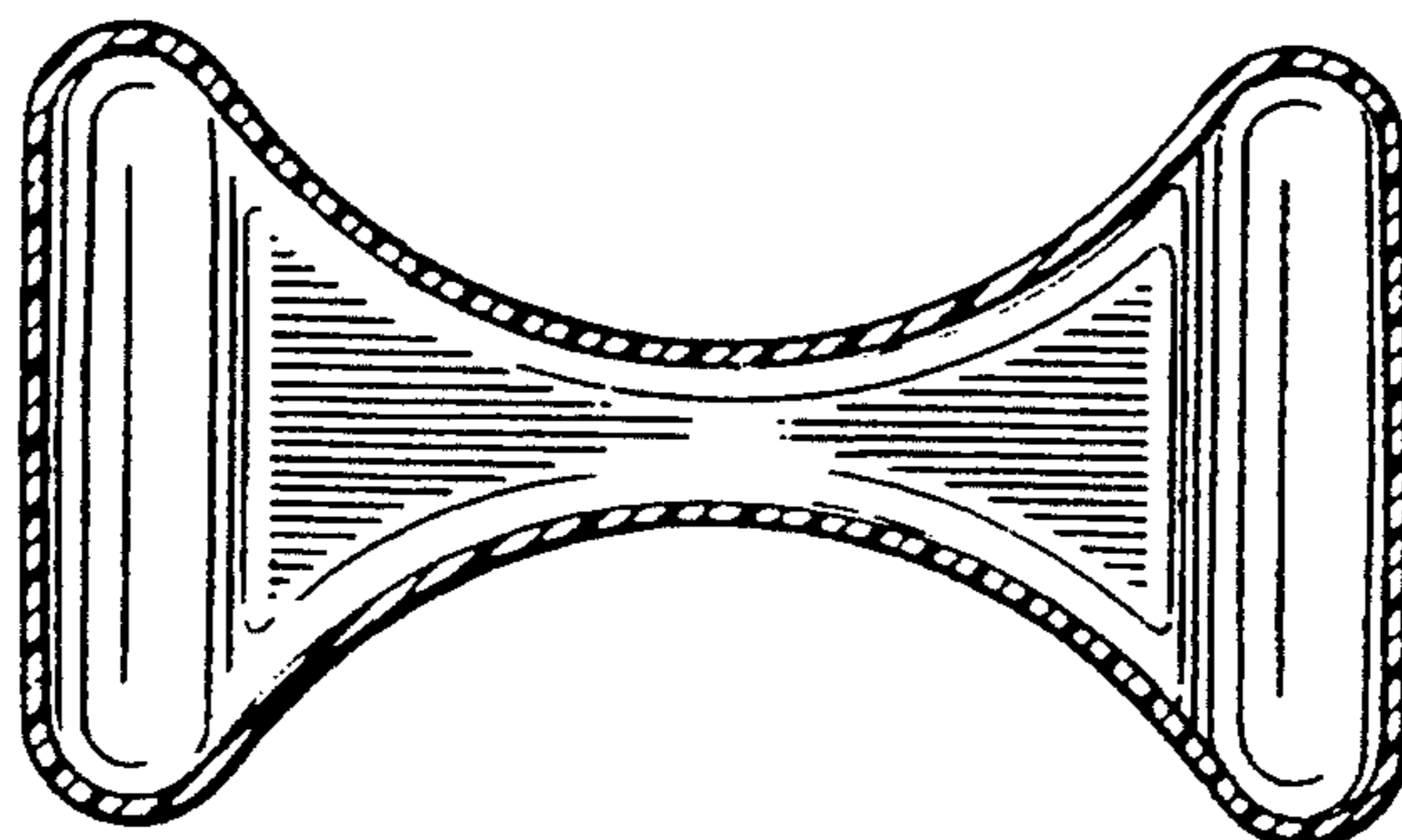
