[57] CLAIM

The ornamental design for a wine rack, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a wine rack according to the invention, showing a first form of my new design; FIG. 2 is a top plan view of the invented wine rack, according to FIG. 1;

FIG. 3 is a rear elevational view of the invented wine rack according to FIG. 1;

FIG. 4 is a right side elevational view of the invented wine rack according to FIG. 1, the left side elevational view being a mirror image thereof;

FIG. 5 is a front elevational view of the invented wine rack according to FIG. 1;

FIG. 6 is a bottom plan view of the invented wine rack according to FIG. 1;

FIG. 7 is a perspective view of still another form of my wine rack. The part not shown is the same as that shown in FIG. 1;

FIG. 8 is a perspective view similar to FIG. 1, but showing another design for the hanging apparatus of my wine rack. The part not shown is the same as that shown in FIG. 1;

FIG. 9 is a perspective view similar to FIG. 1, but showing still another design for the hanging apparatus of my wine rack. The part not shown is the same as that shown in FIG. 1;

FIG. 10 is a perspective view similar to FIG. 1, but showing still another another design for the hanging apparatus of my wine rack. The part not shown is the same as that shown in FIG. 1;

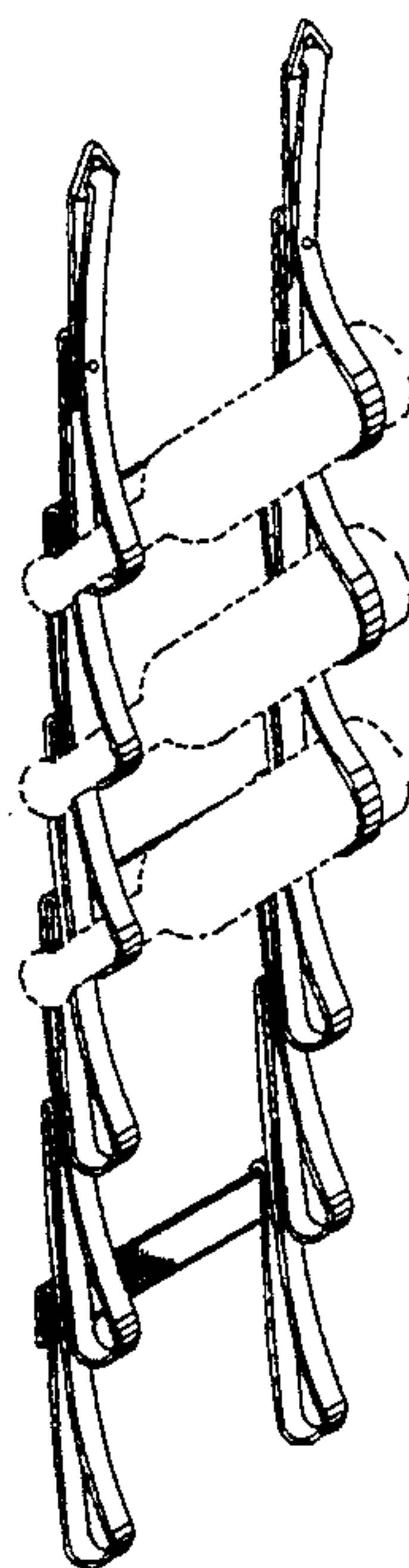

The bottles are shown in broken lines for illustrative purposes only and form no part of the claimed design.



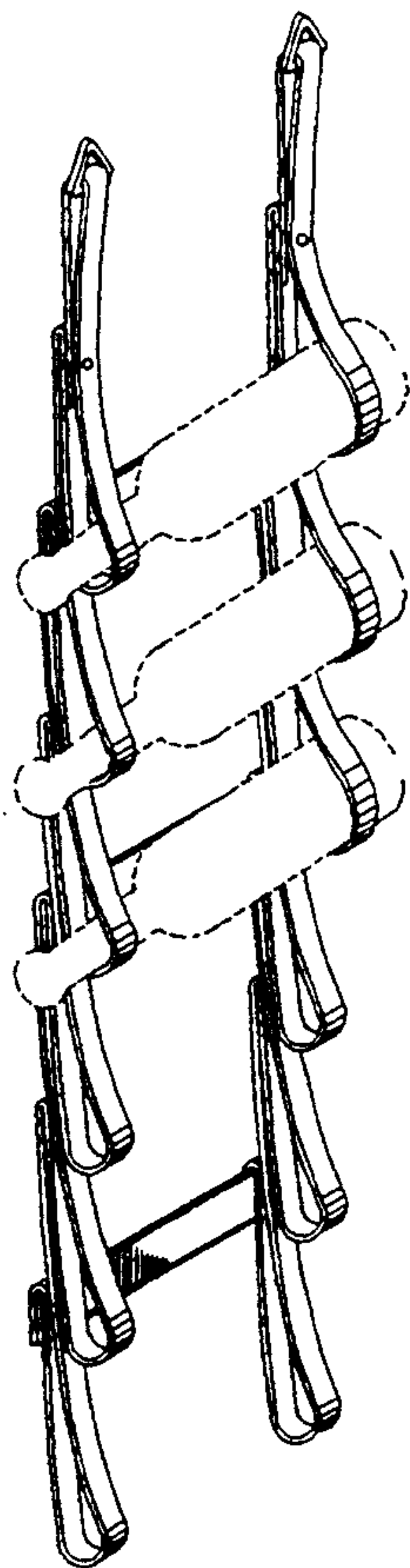

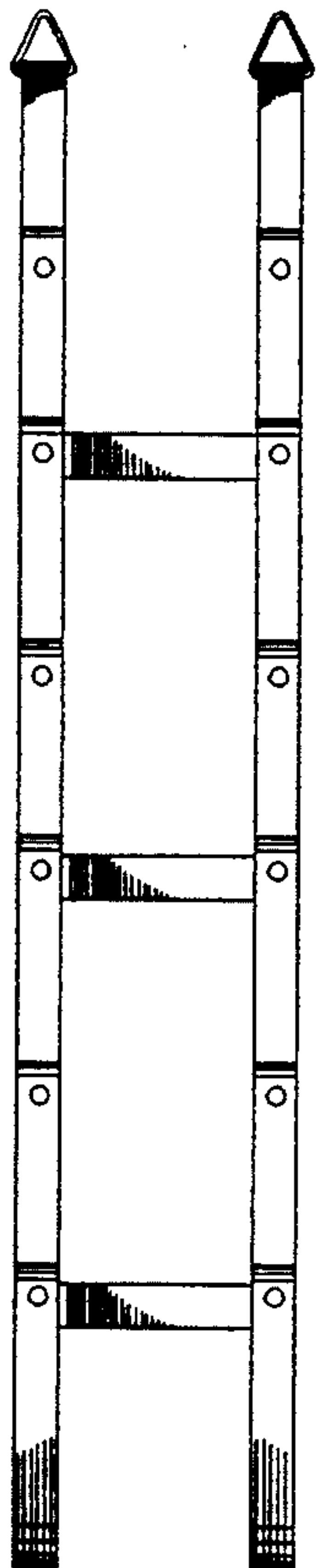

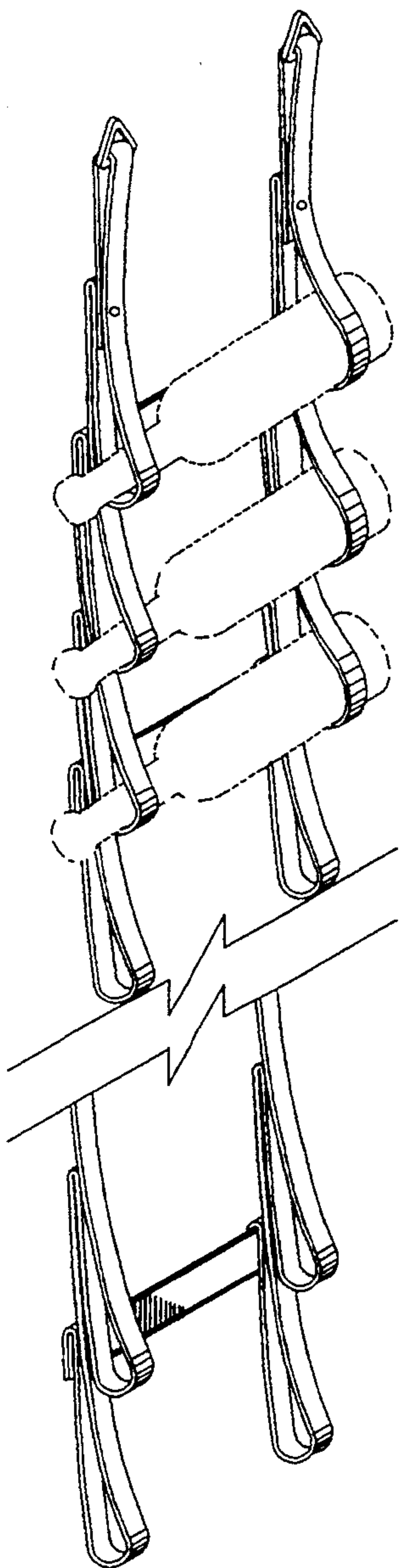

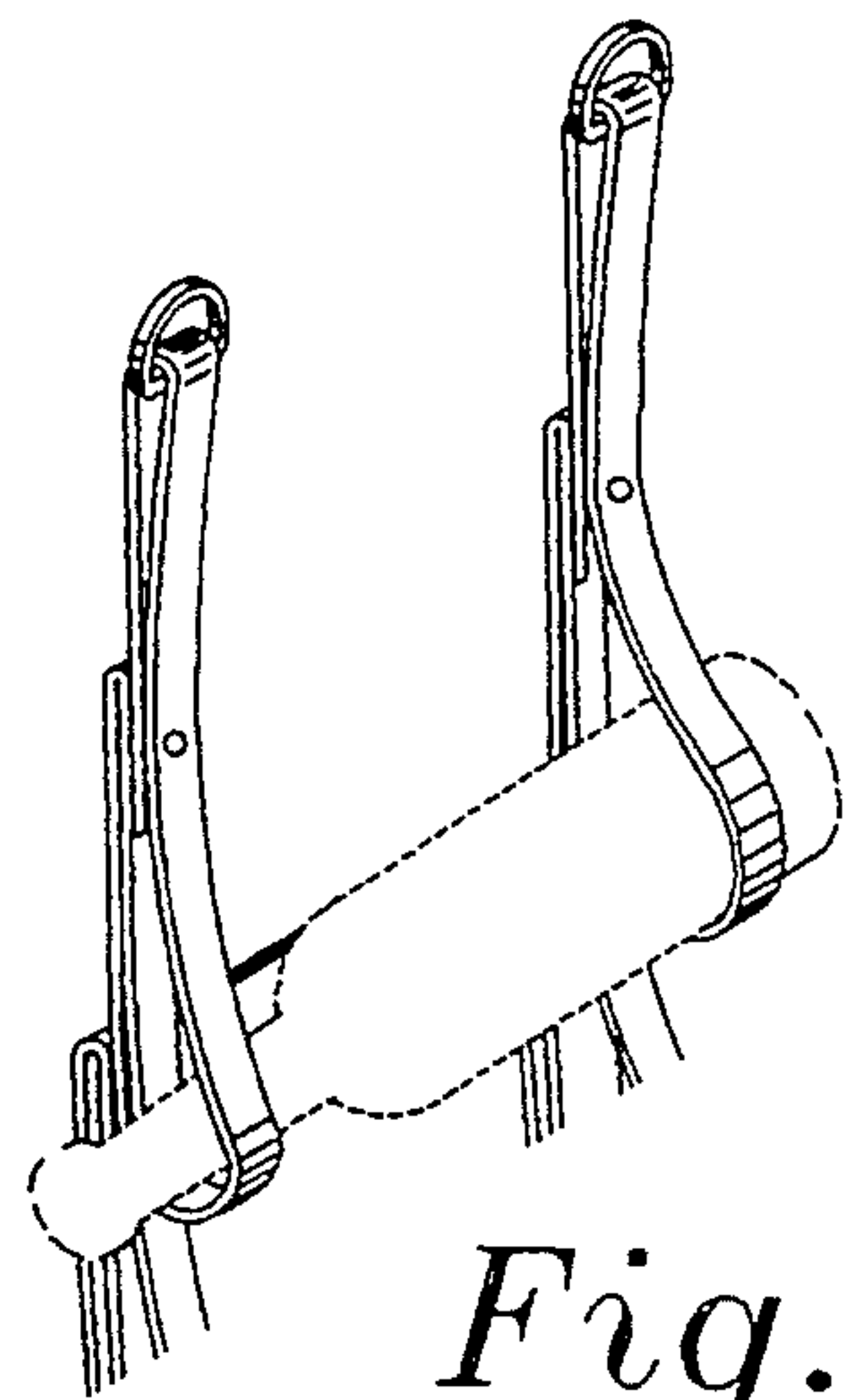

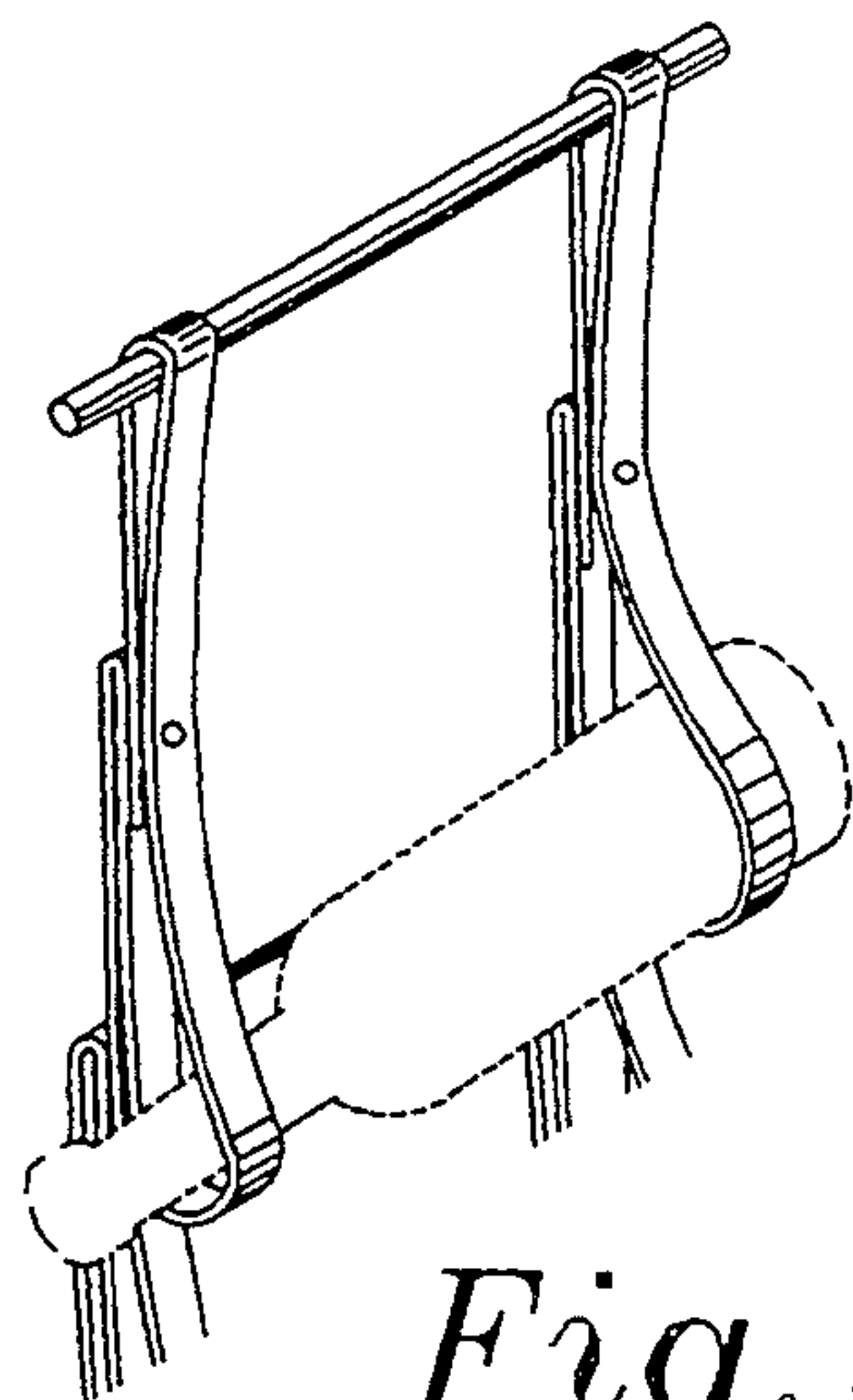

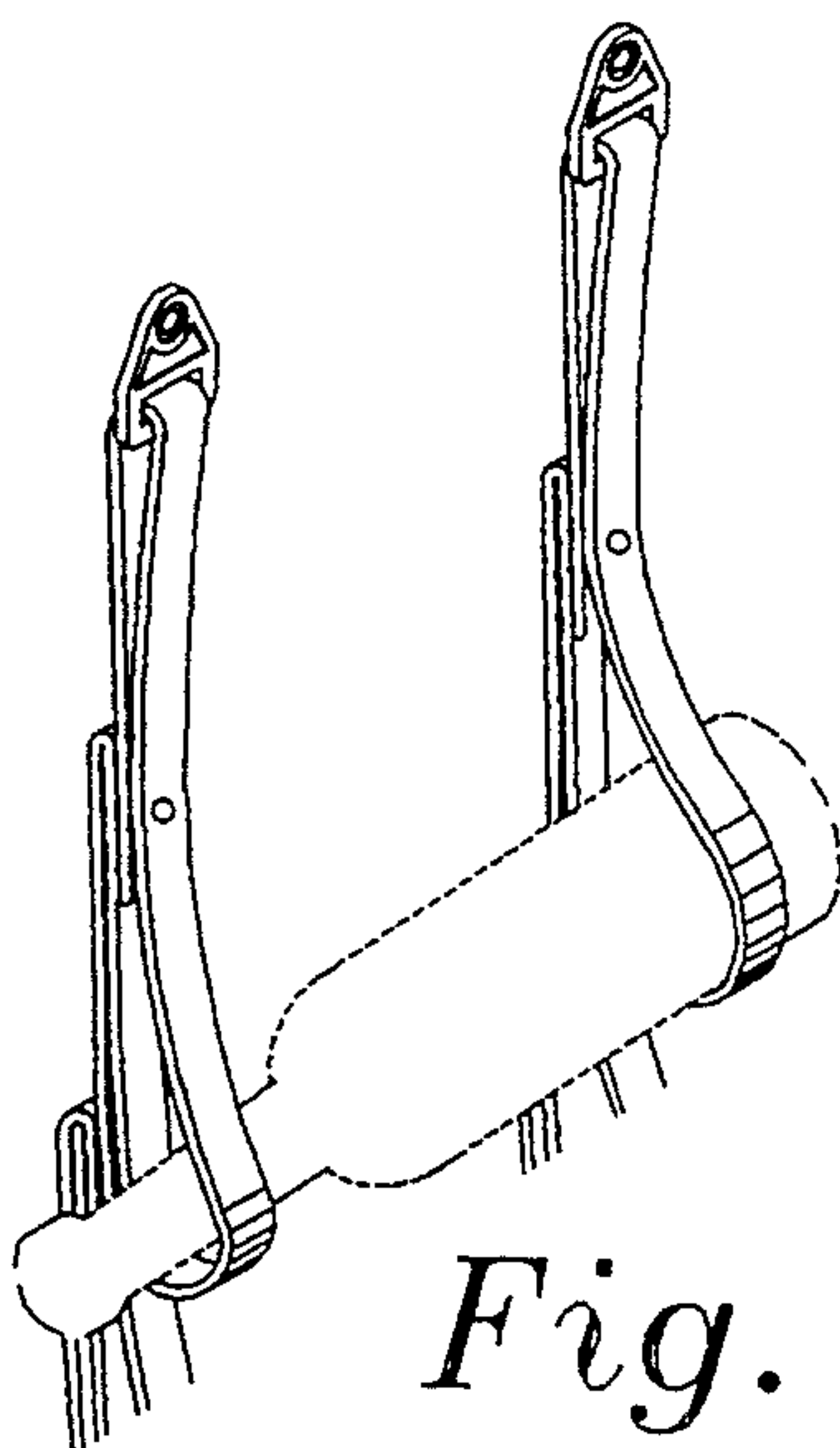

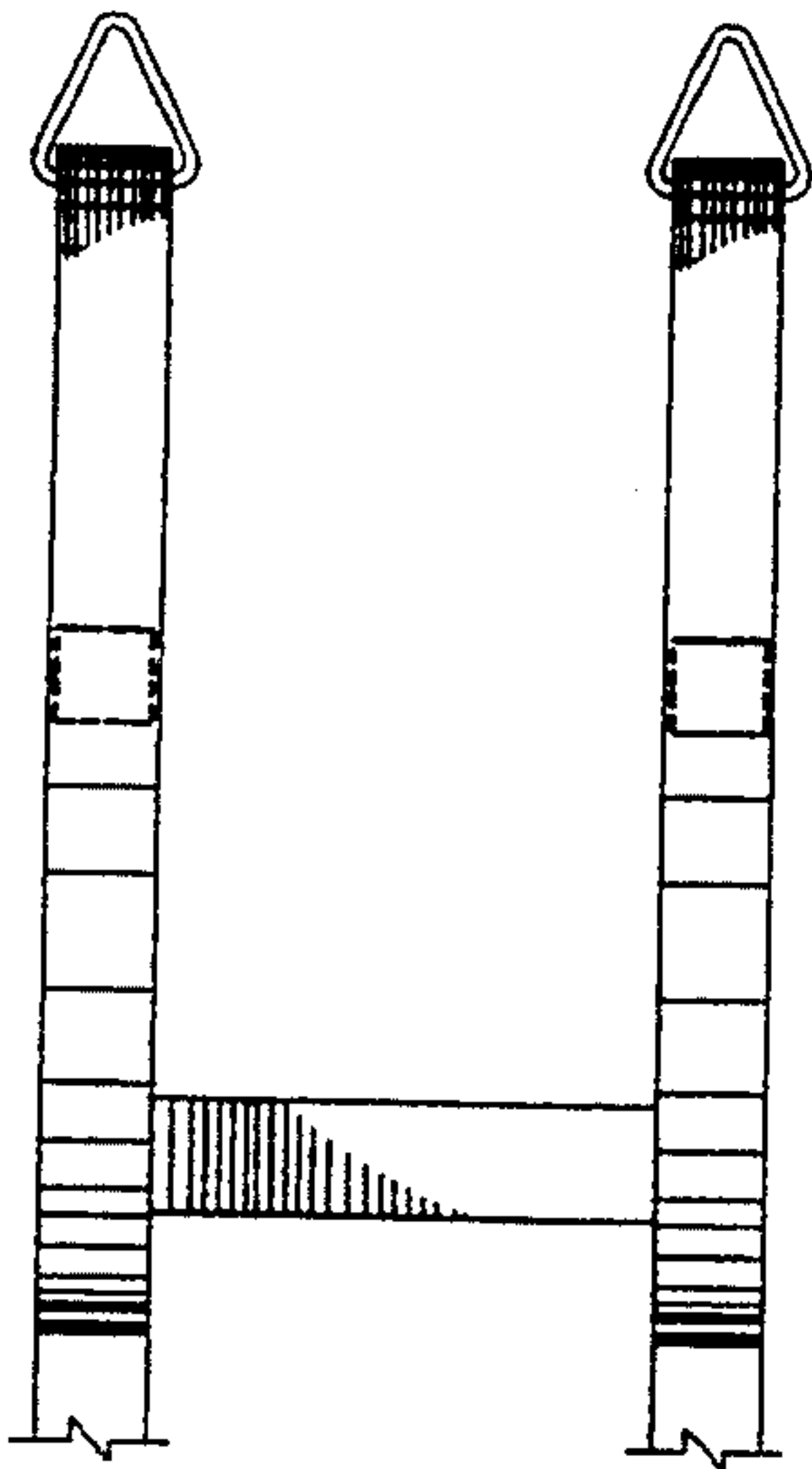

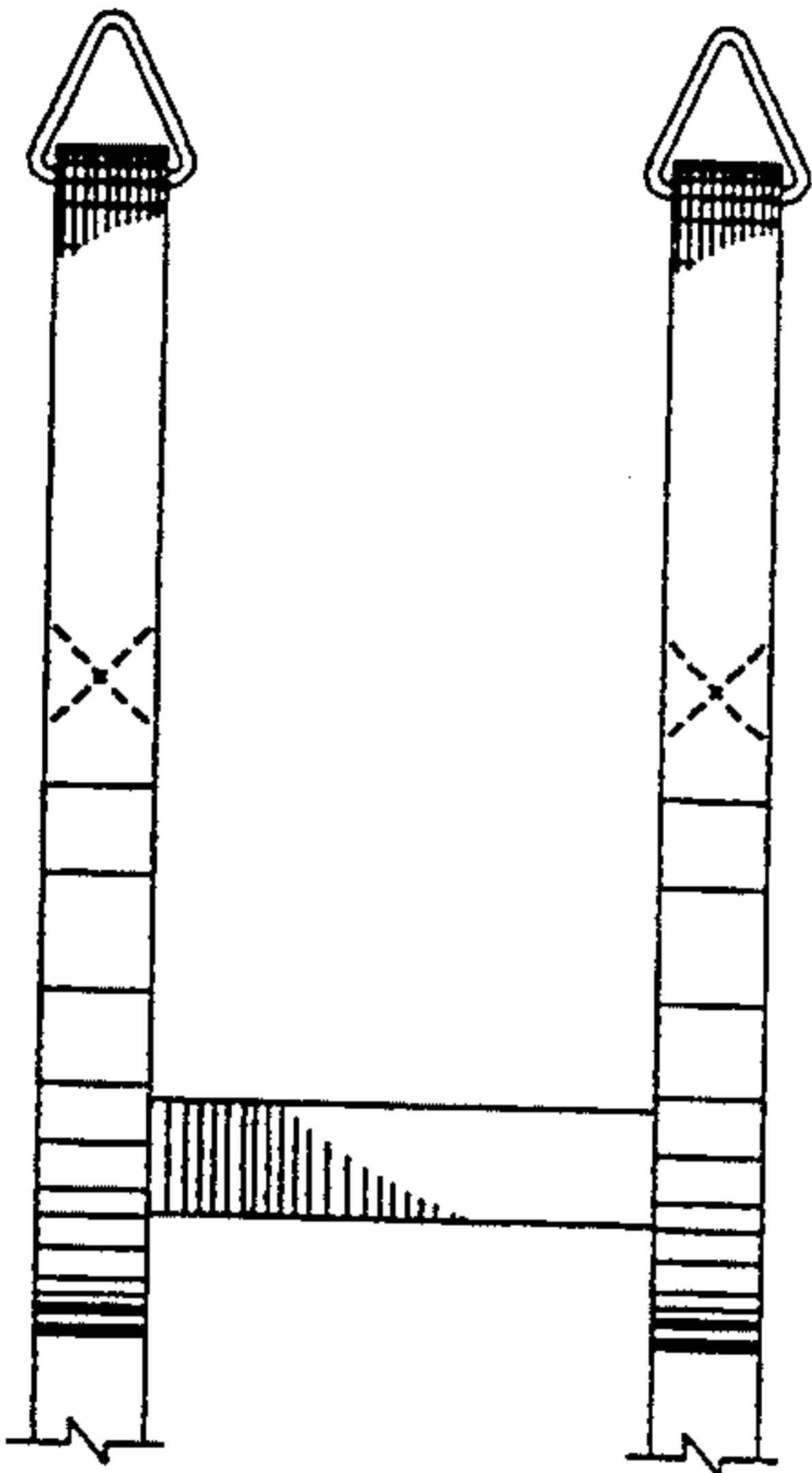

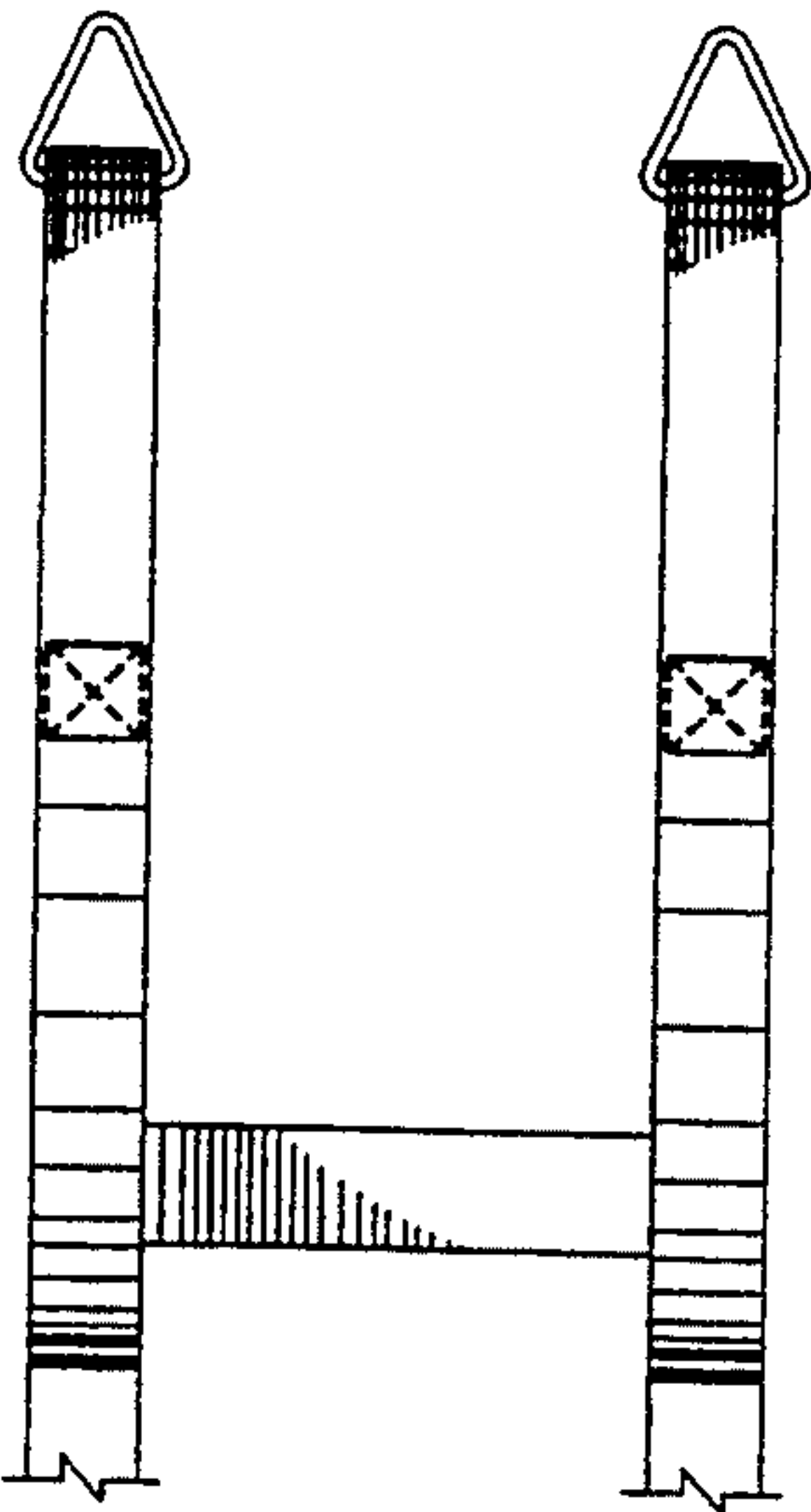

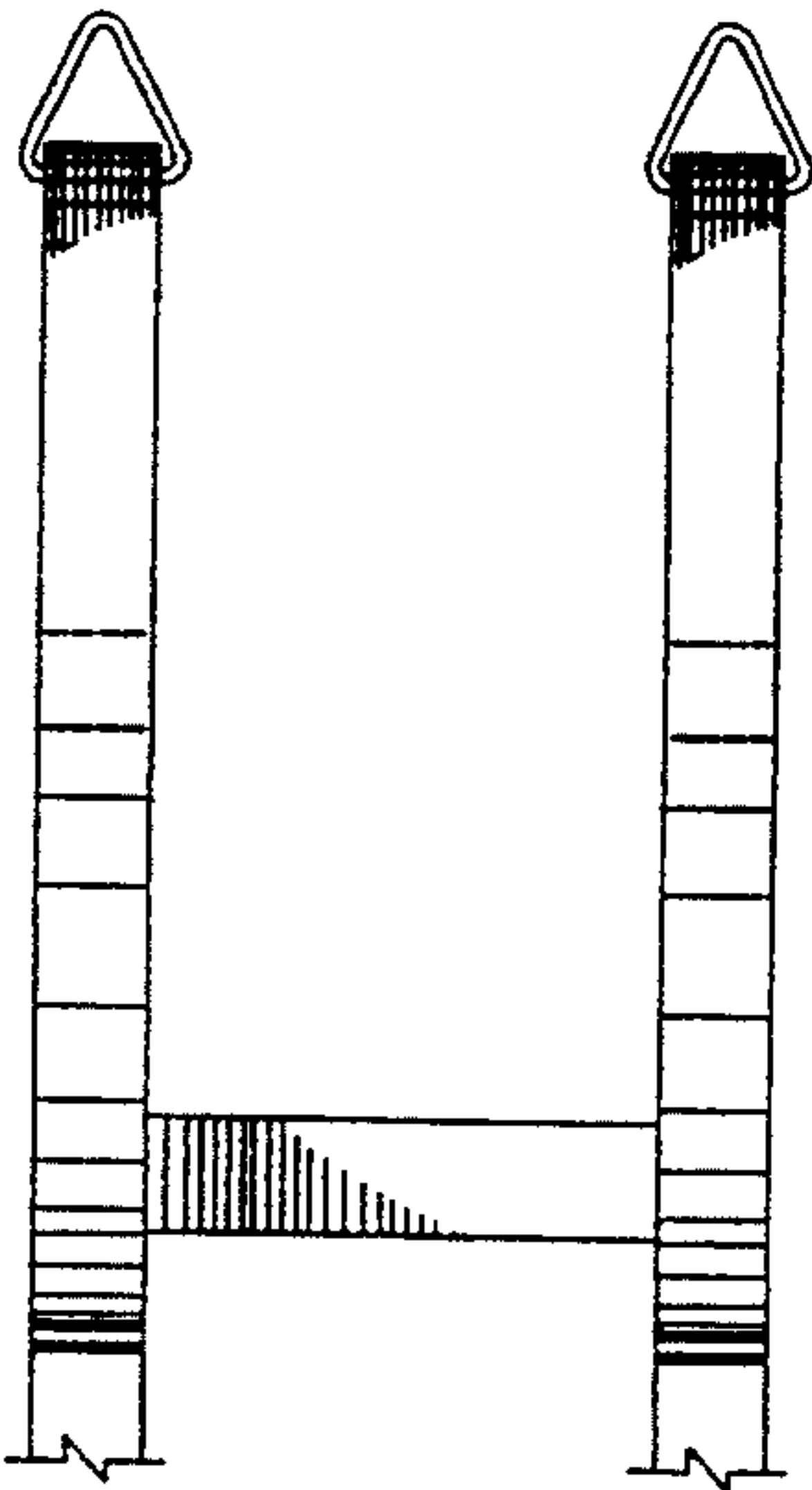

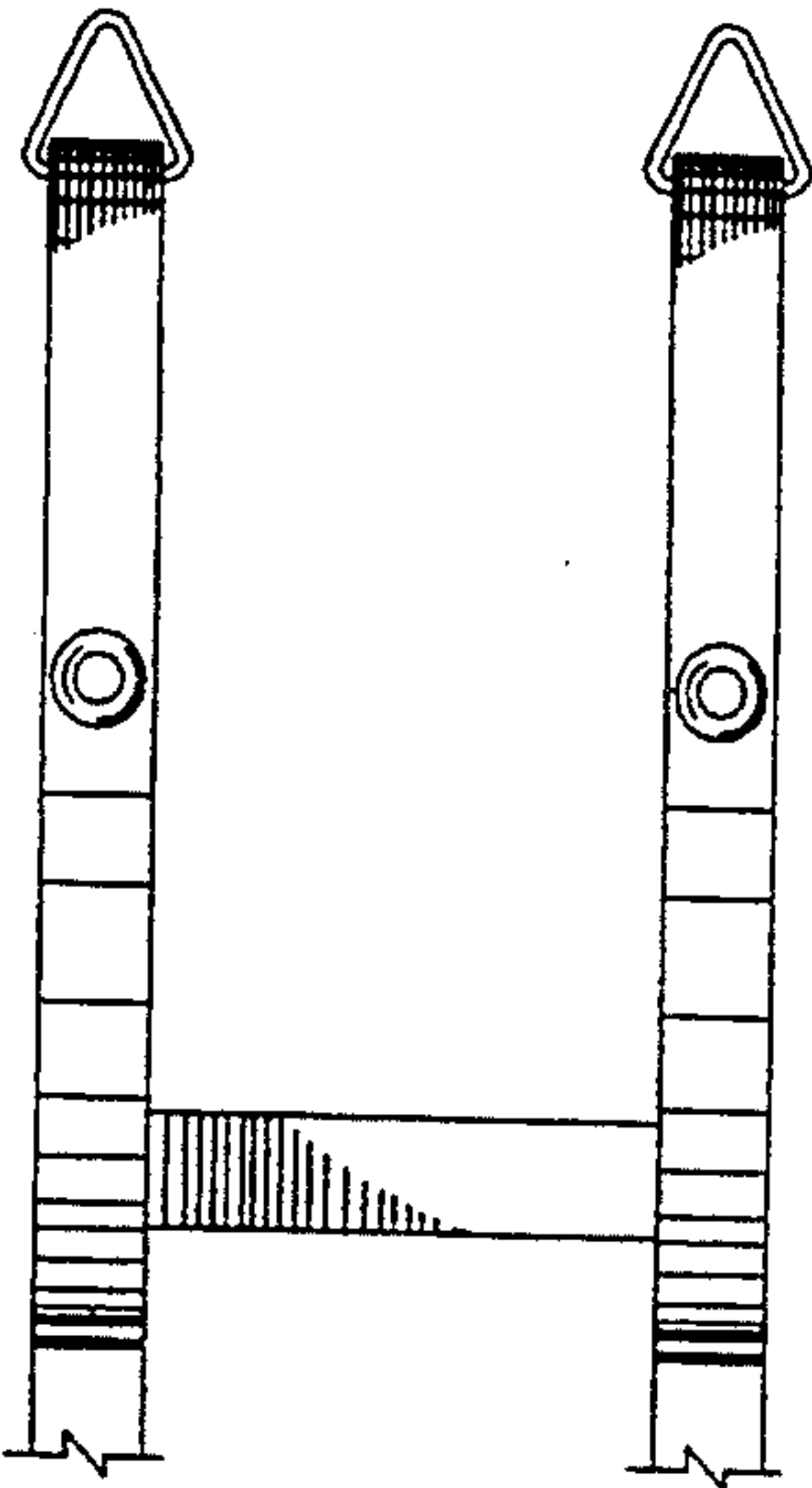
