## DESCRIPTION

FIG. 1 is a perspective view of a stud and clasp package showing my new design;  
 FIG. 2 is a front view thereof;  
 FIG. 3 is a rear view thereof;  
 FIG. 4 is a right-side elevational view thereof;  
 FIG. 5 is a left-side elevational view thereof;  
 FIG. 6 is a bottom view thereof; and,  
 FIG. 7 is a top view thereof.

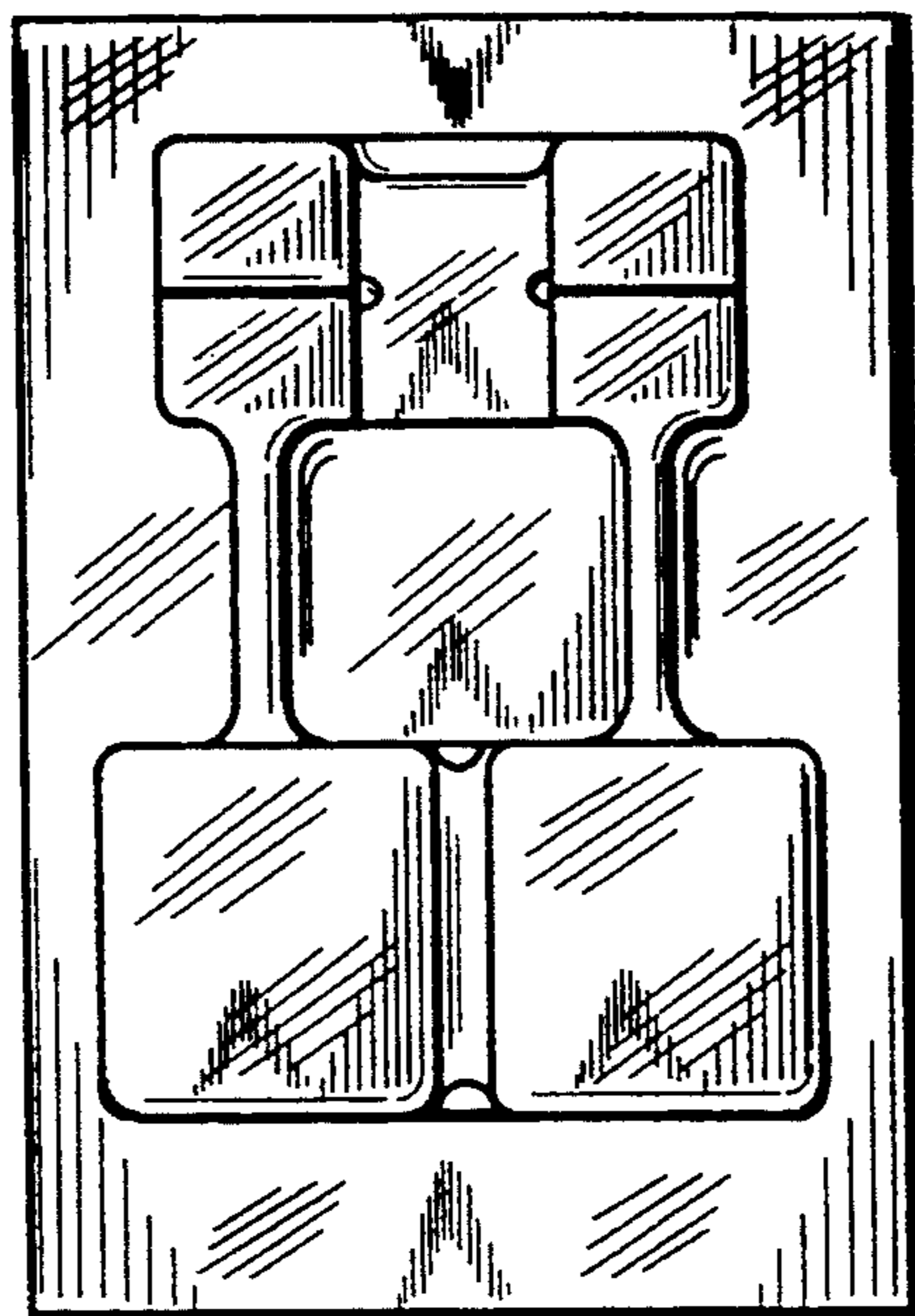

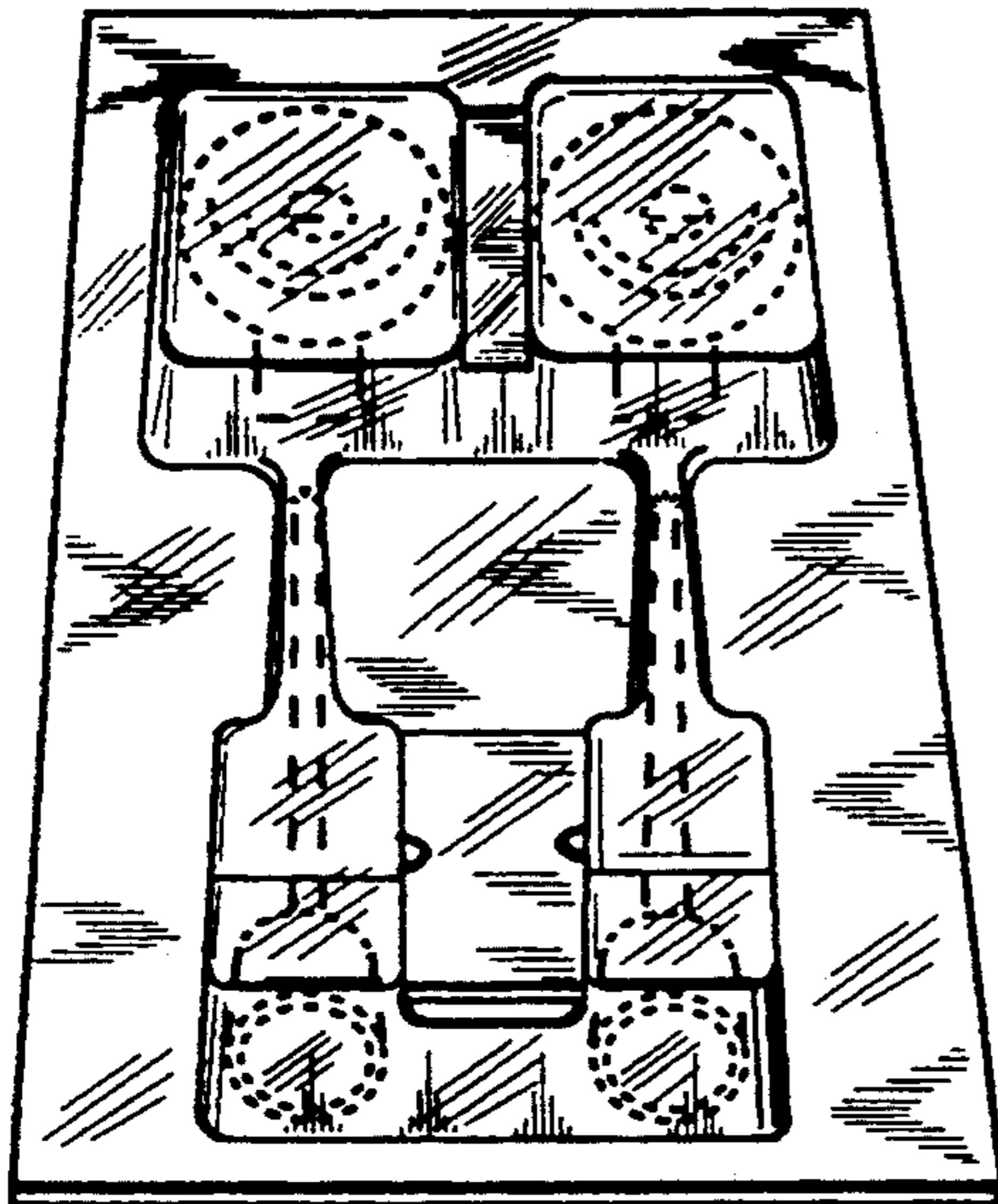

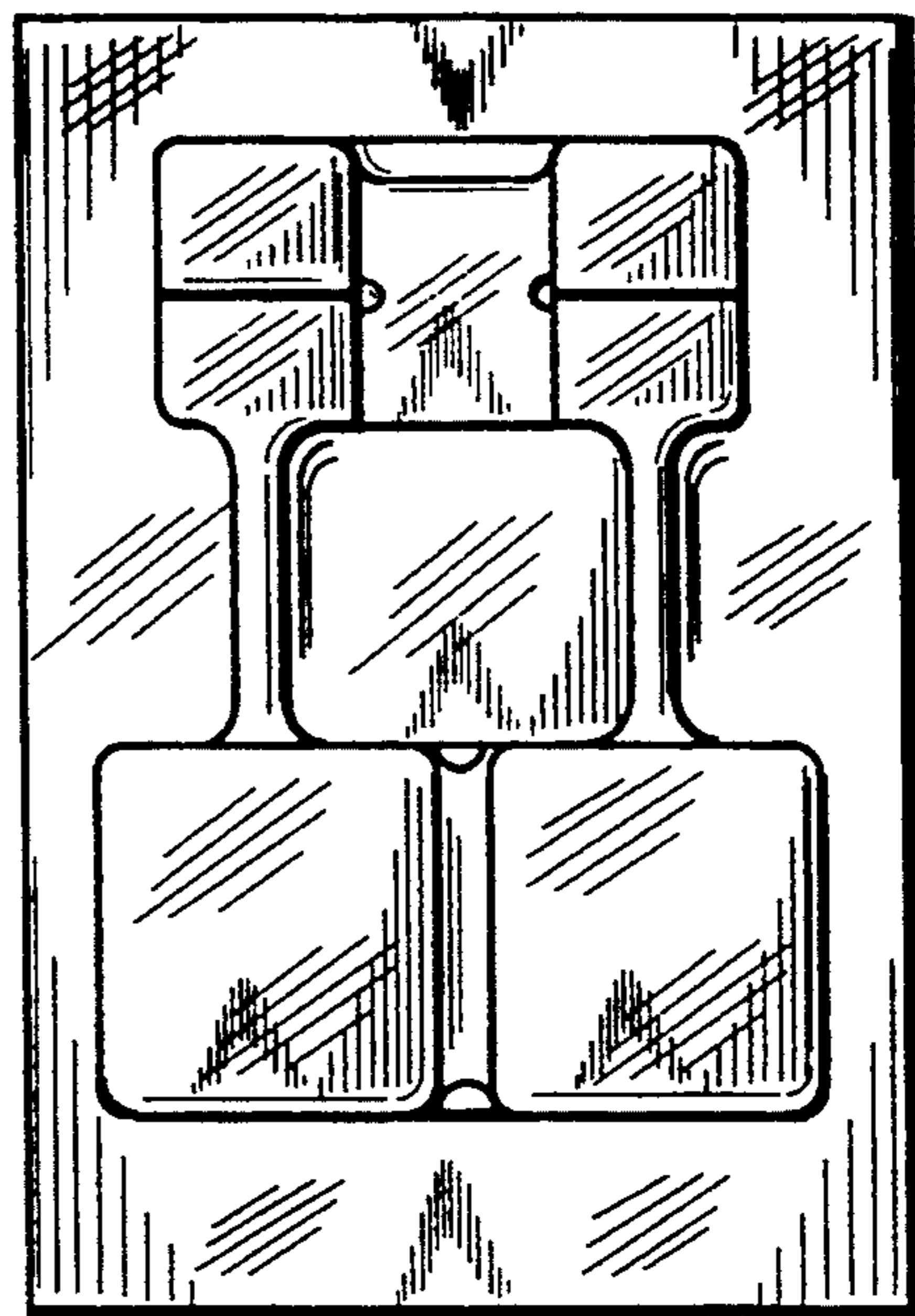

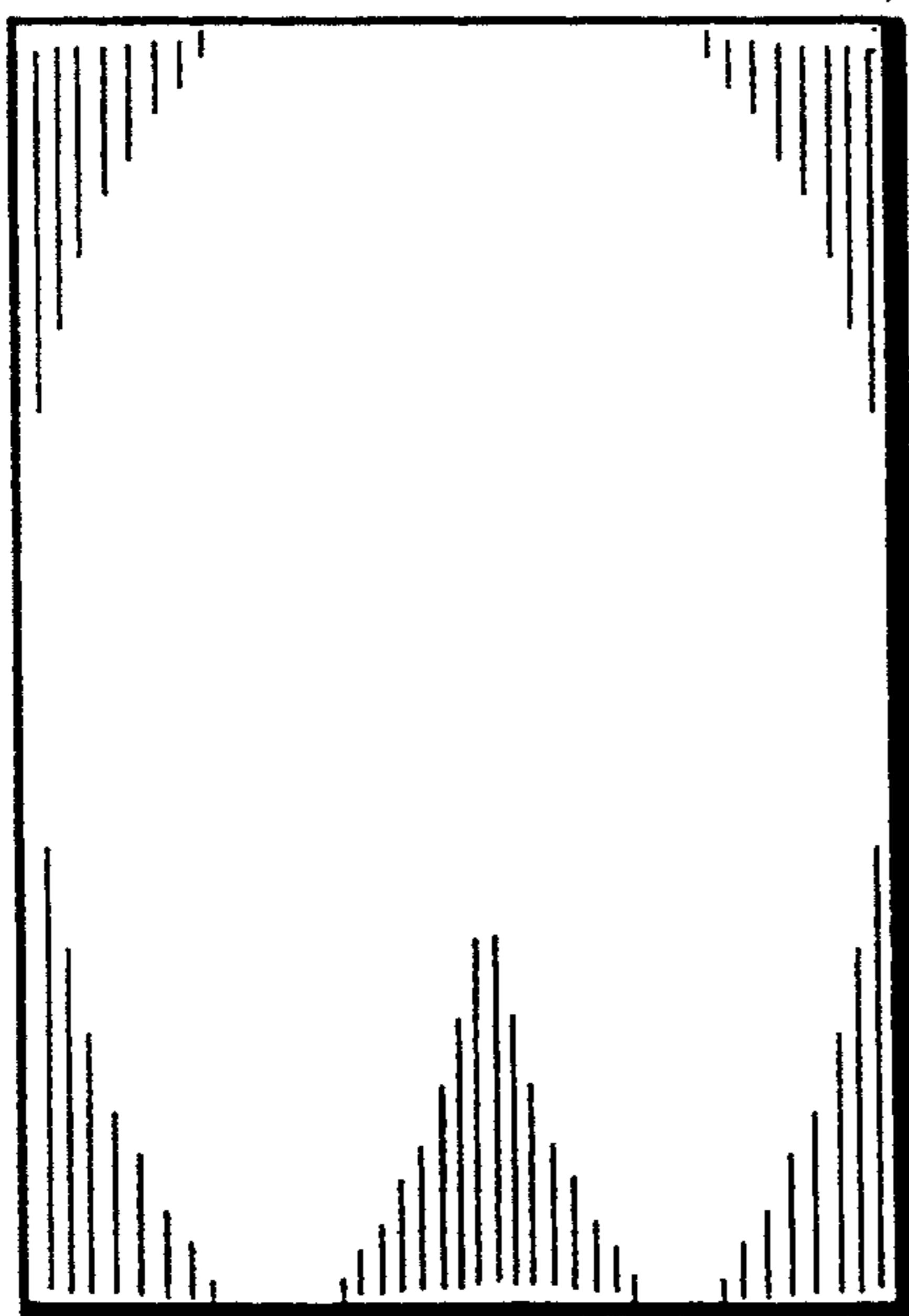
