FIG. 2 is a front elevational view thereof;

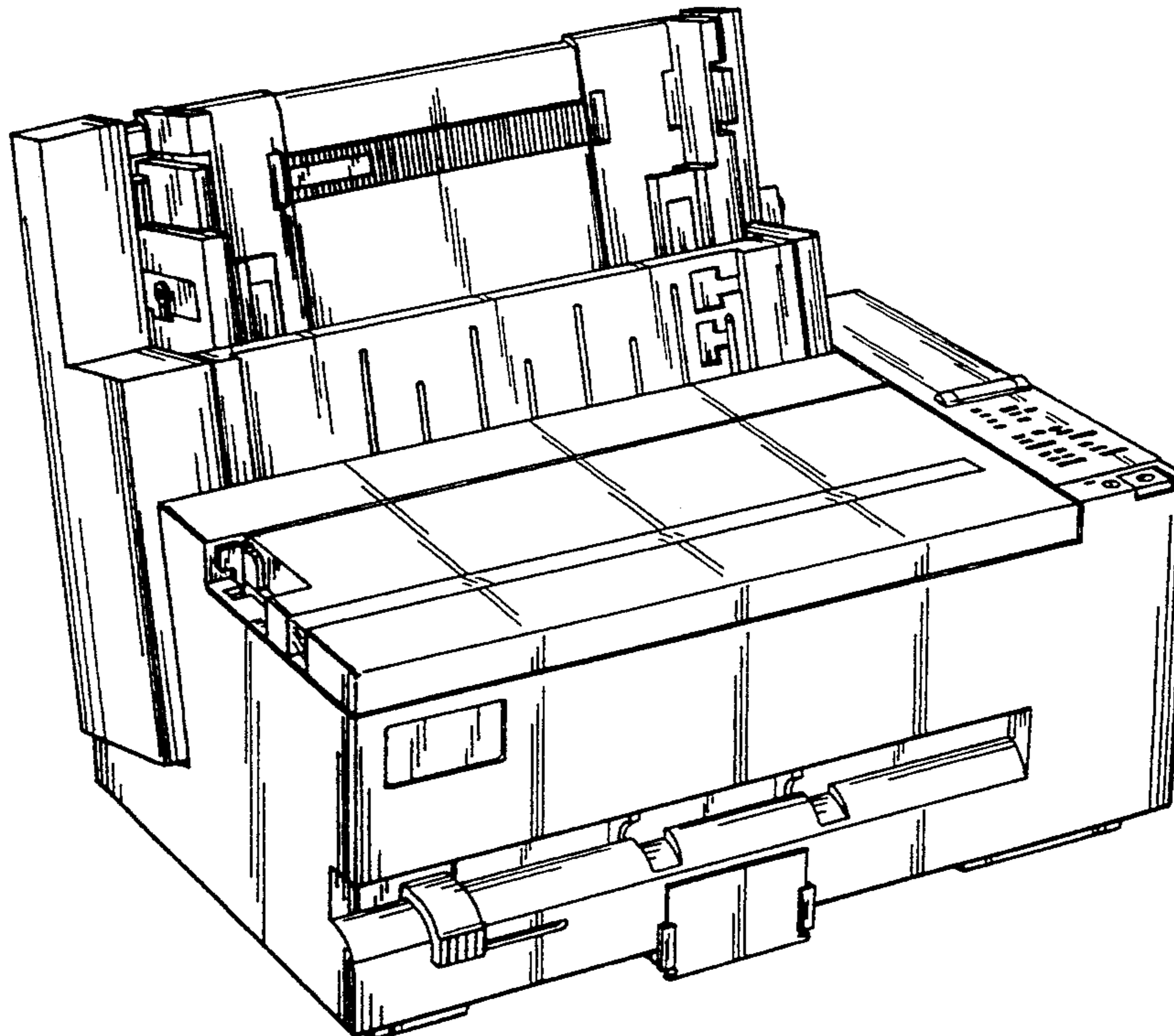
FIG. 3 is a right side elevational view thereof;

FIG. 7 is a top, front, left side perspective view of the embodiment.



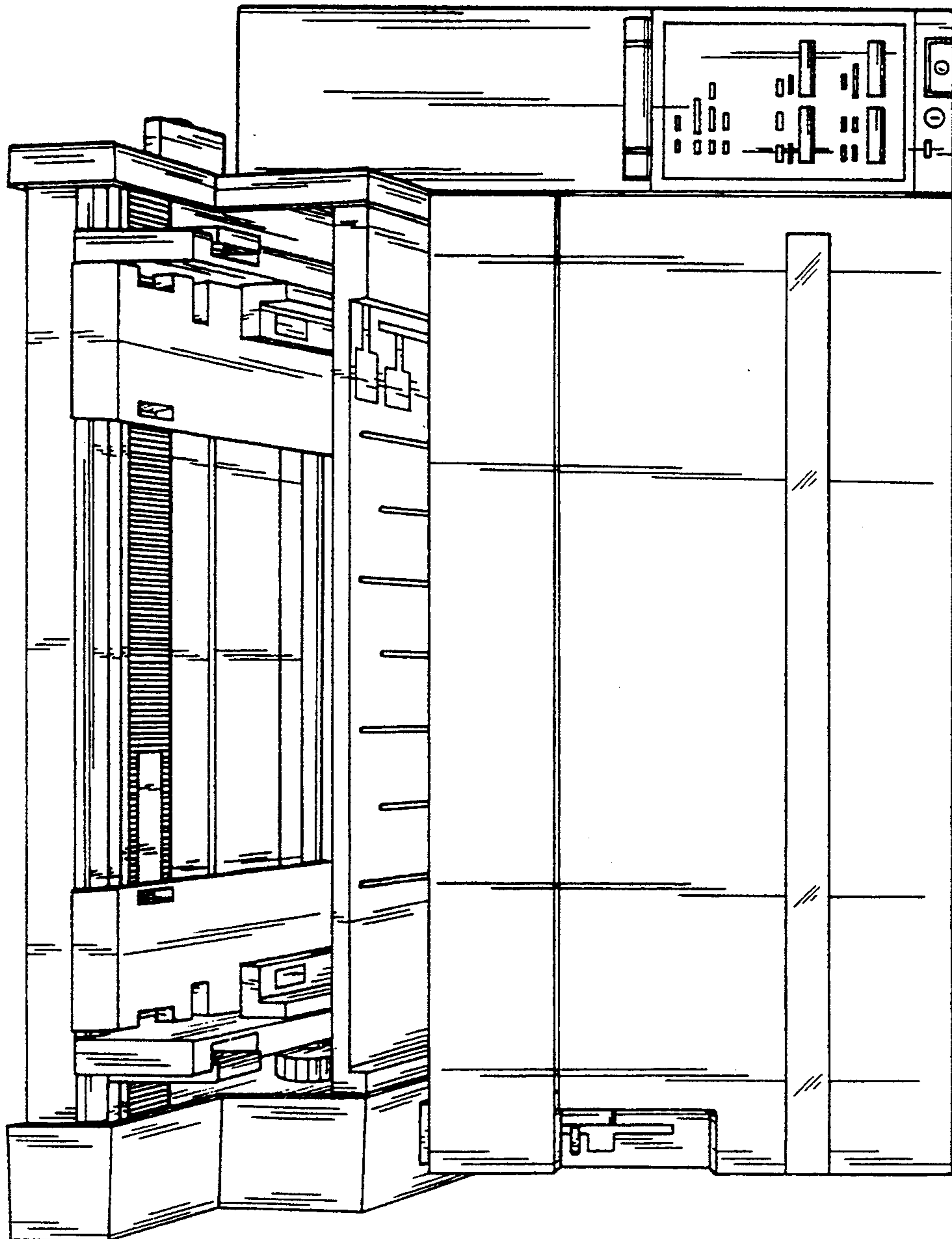

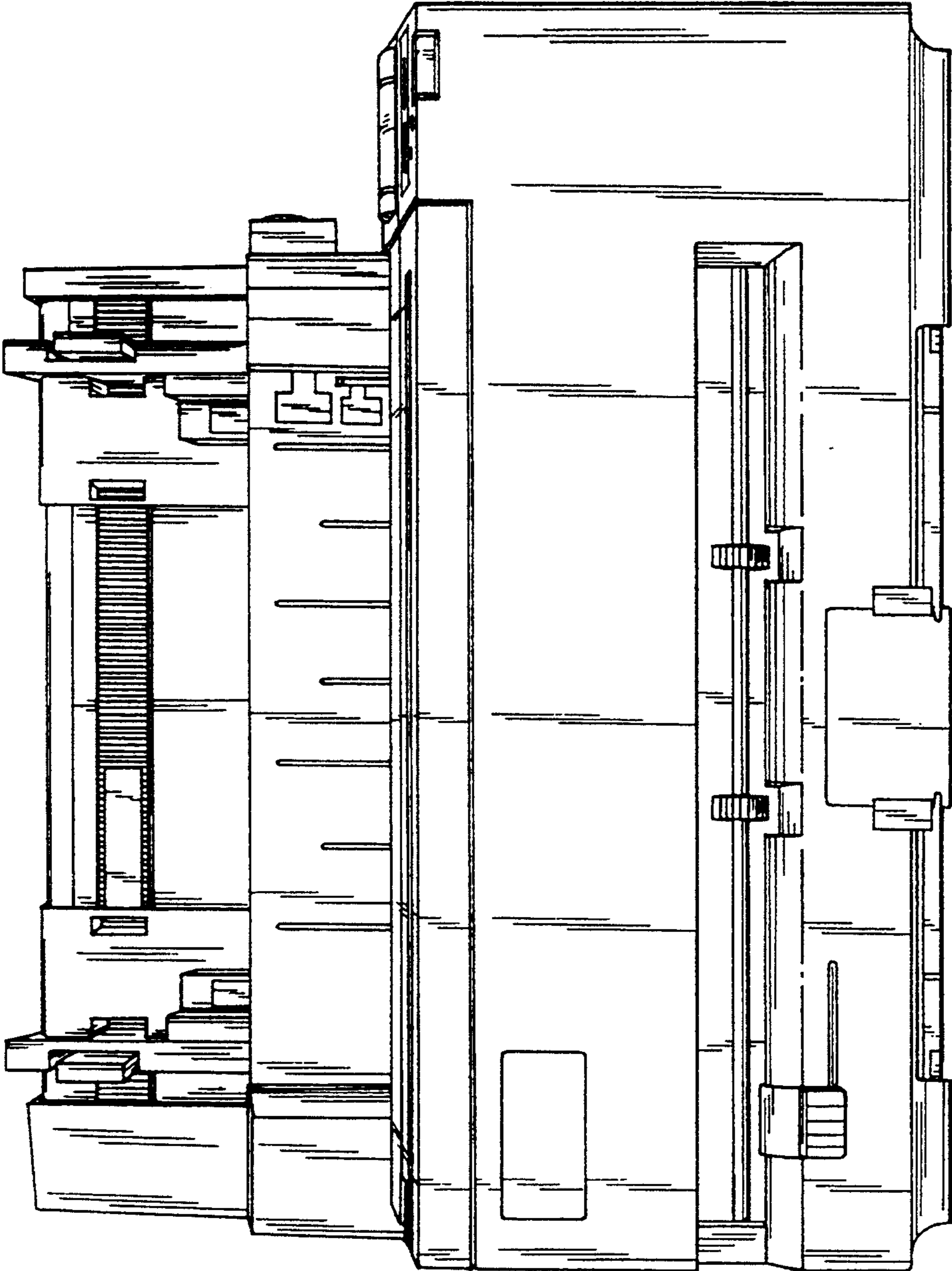

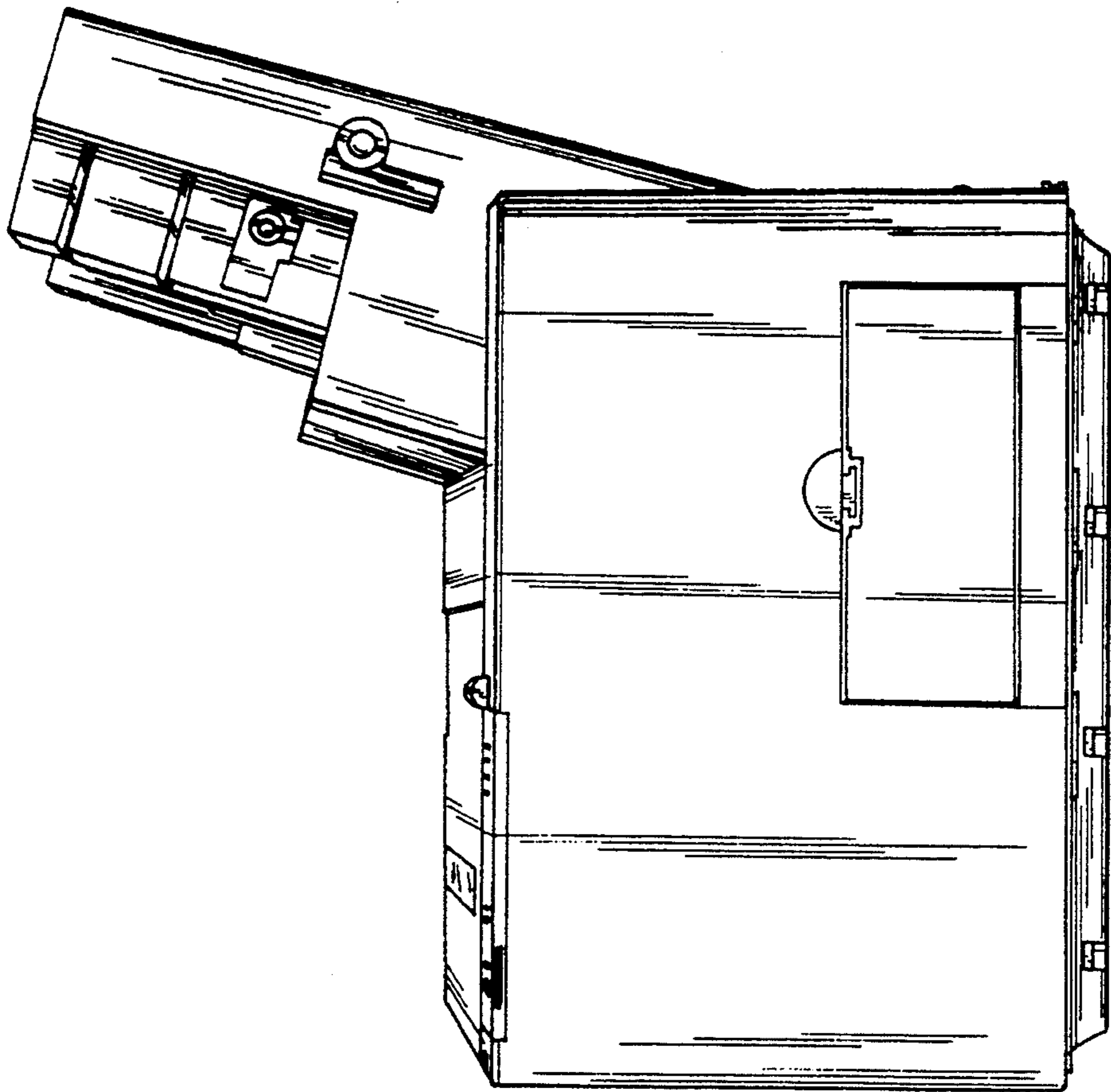

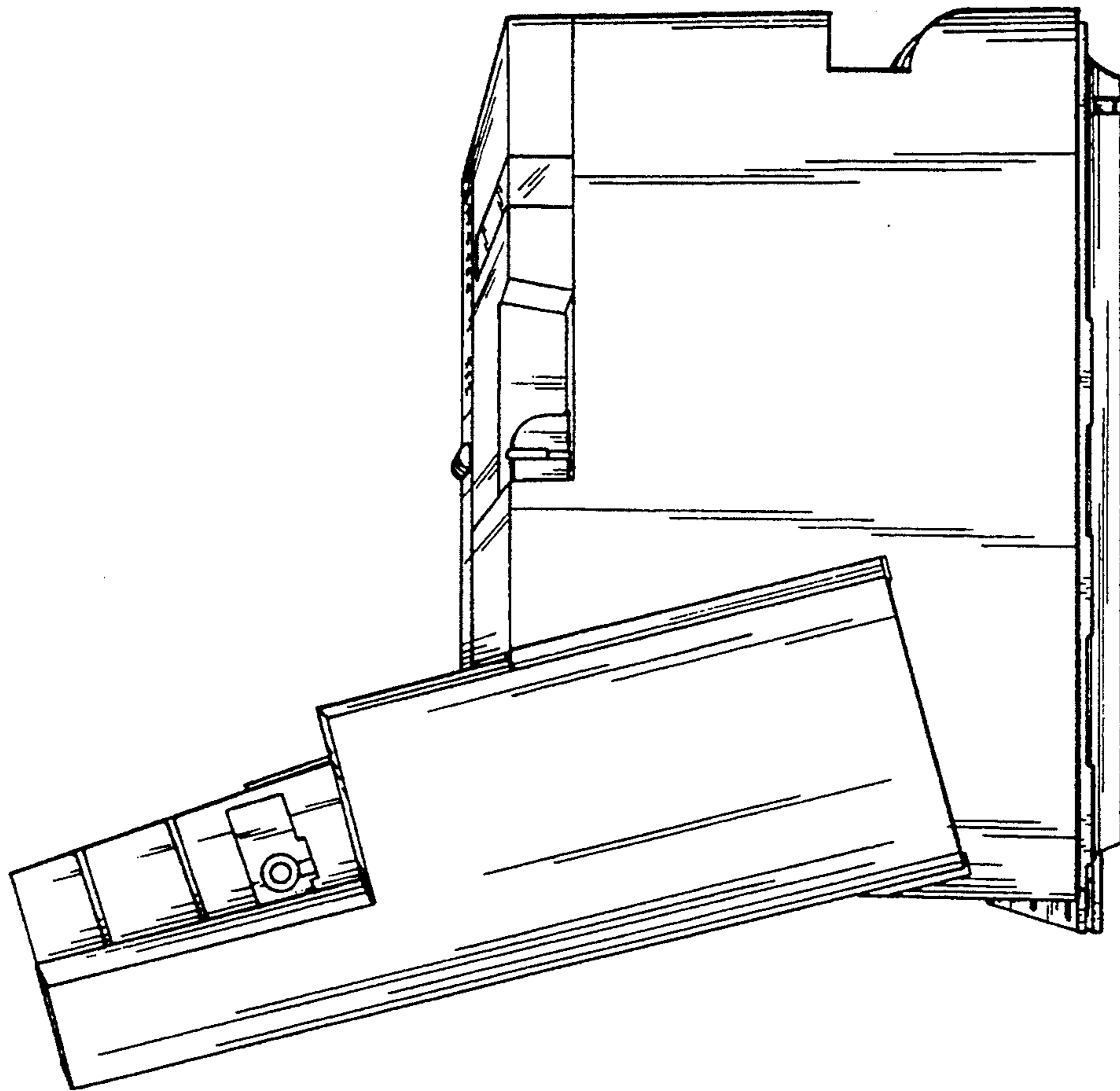

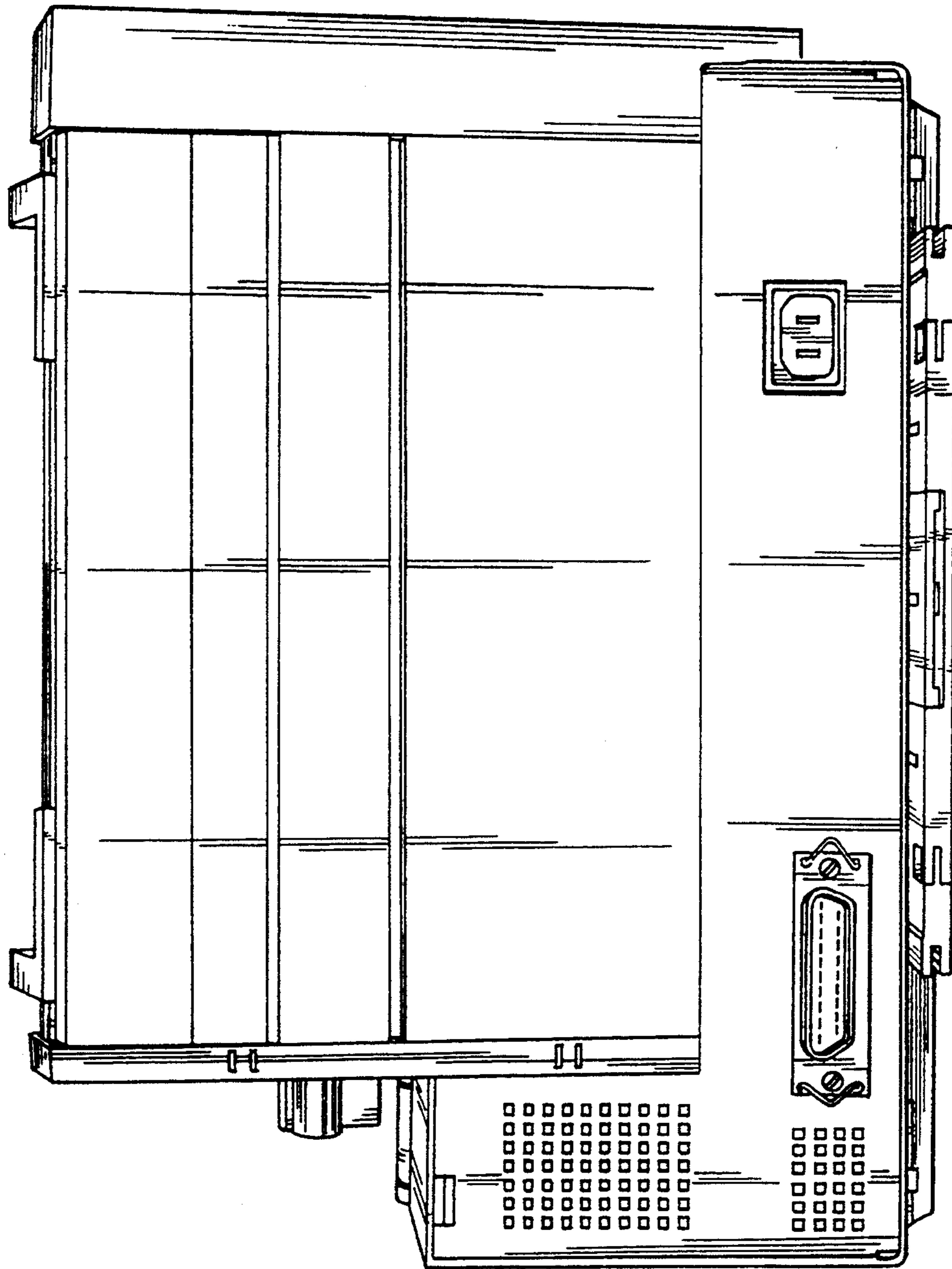

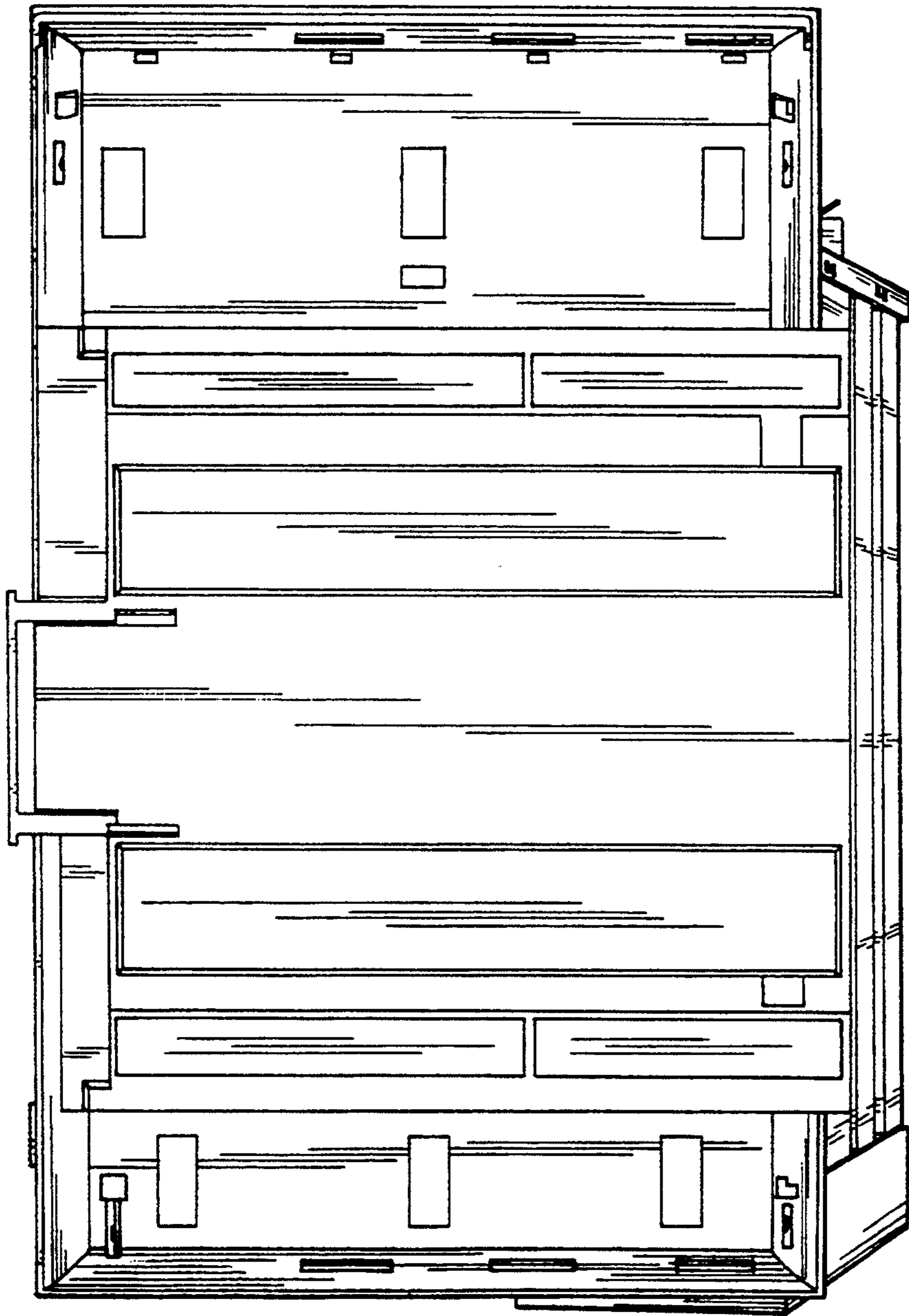

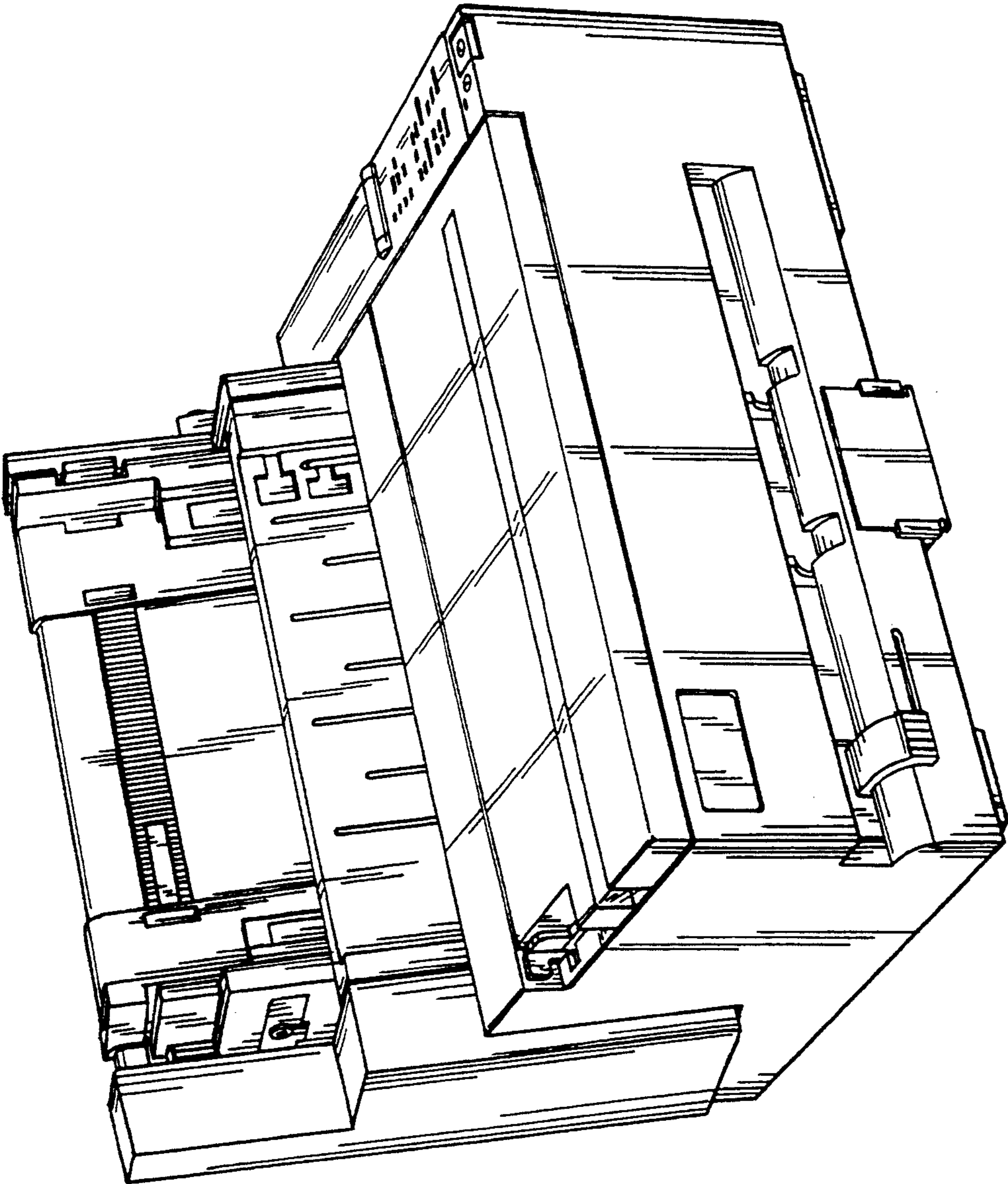
