terminate length.

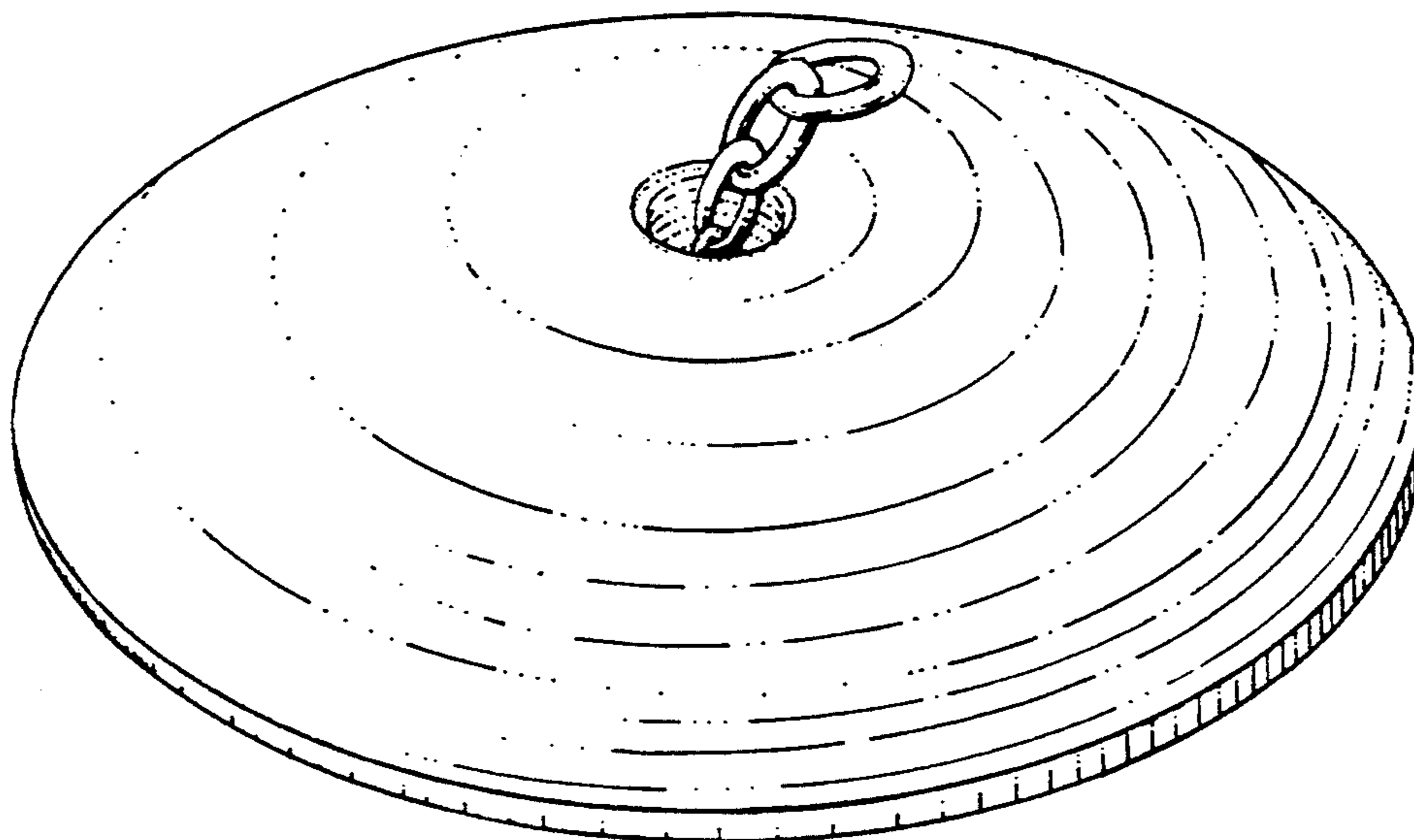

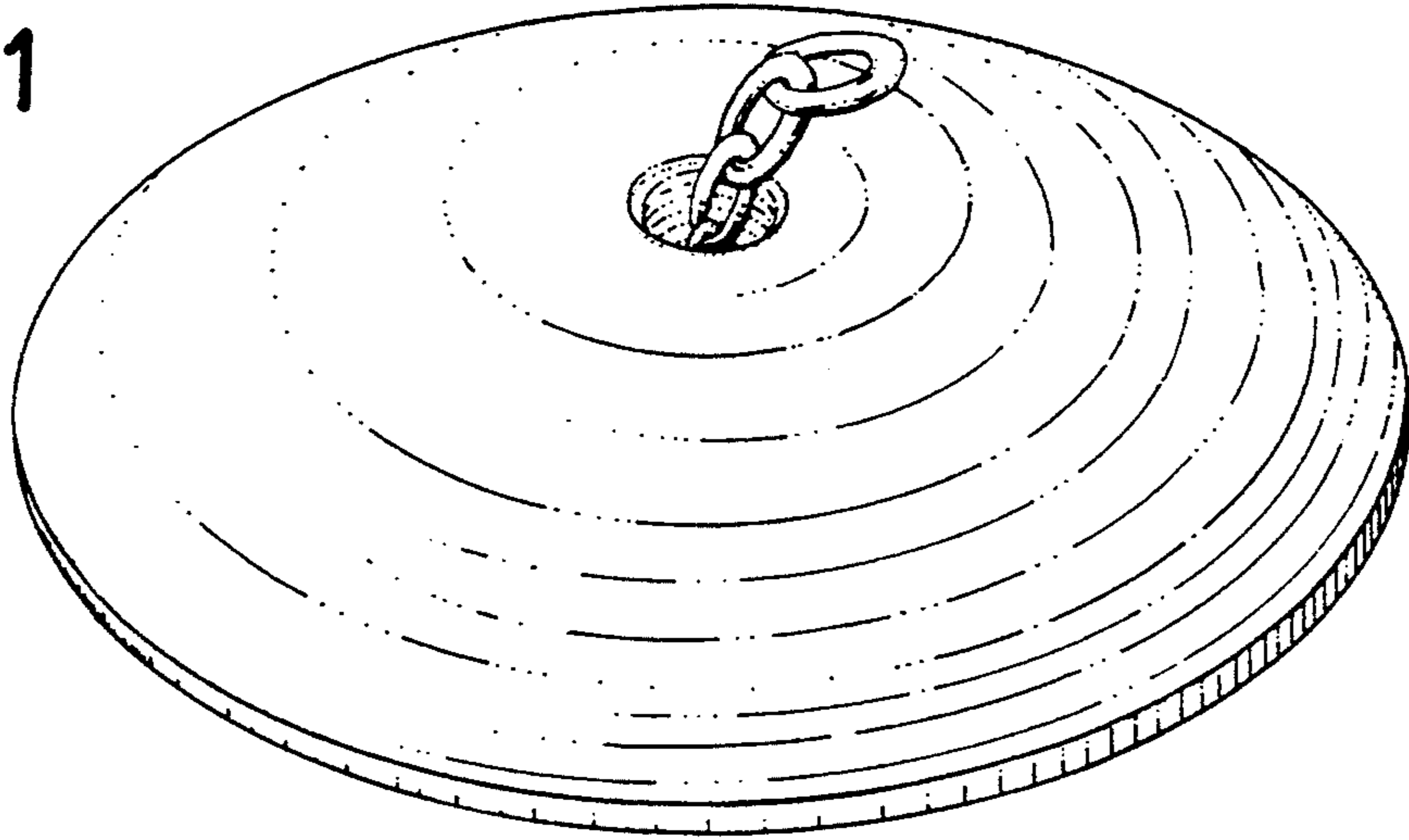

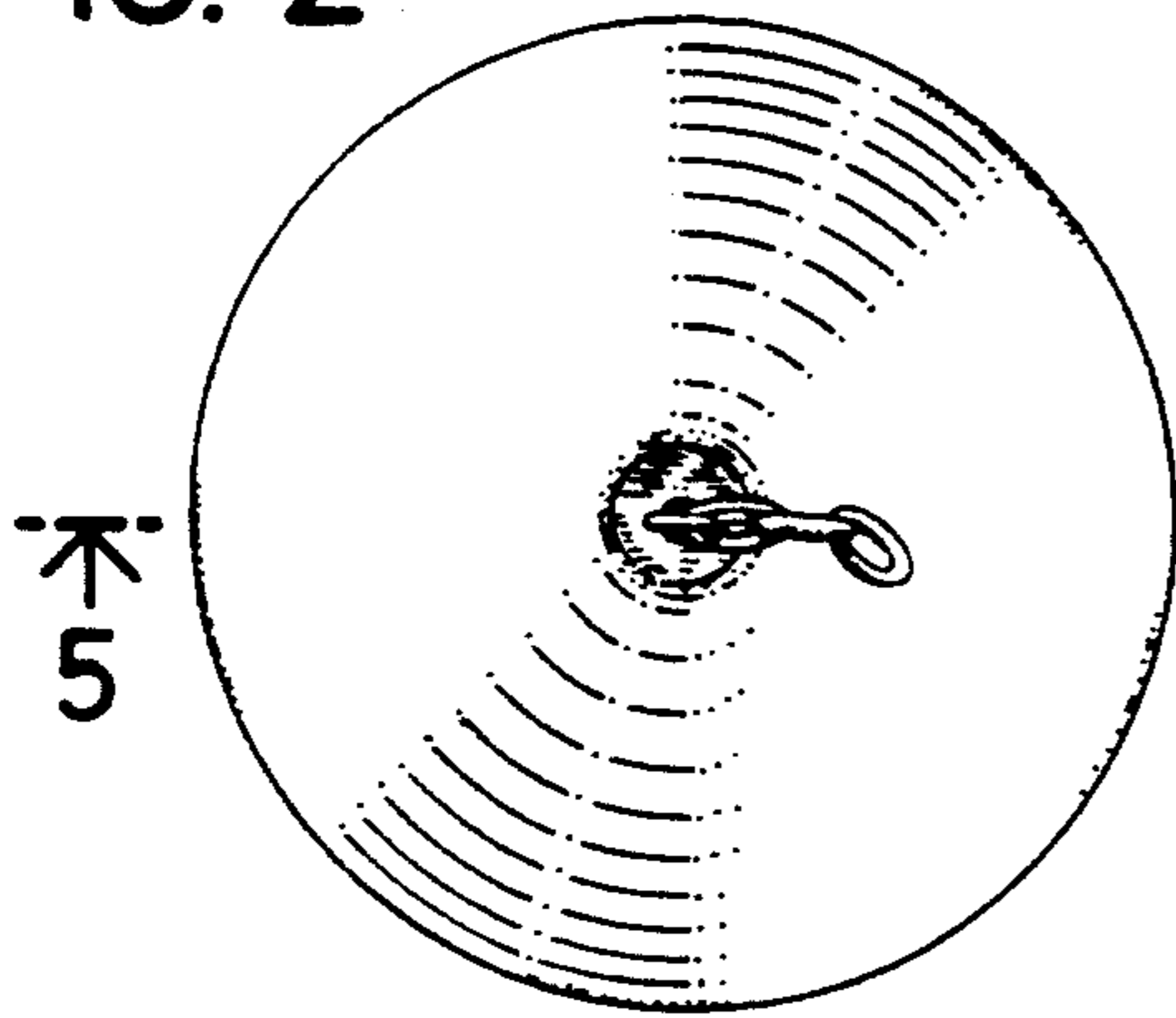

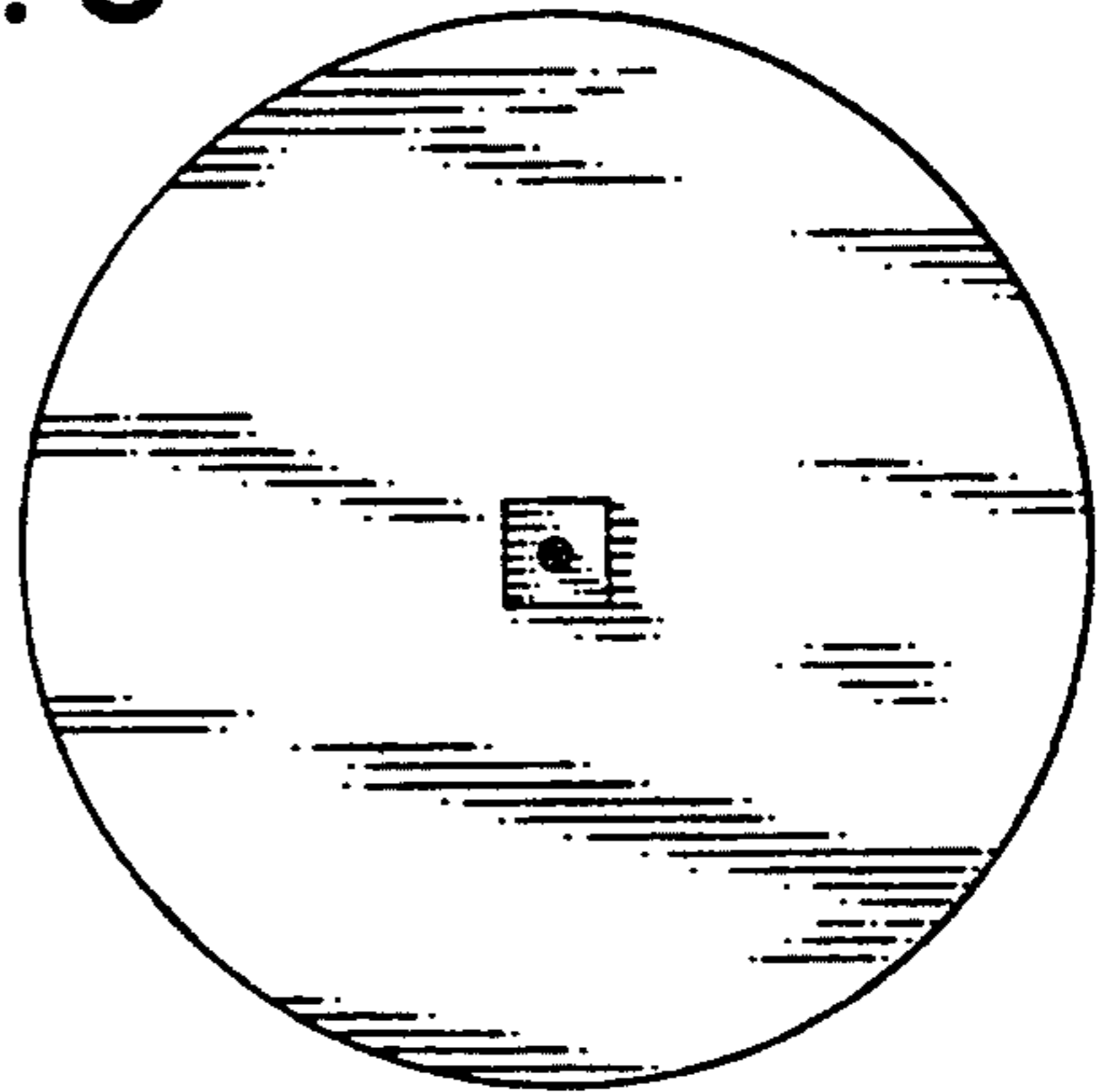

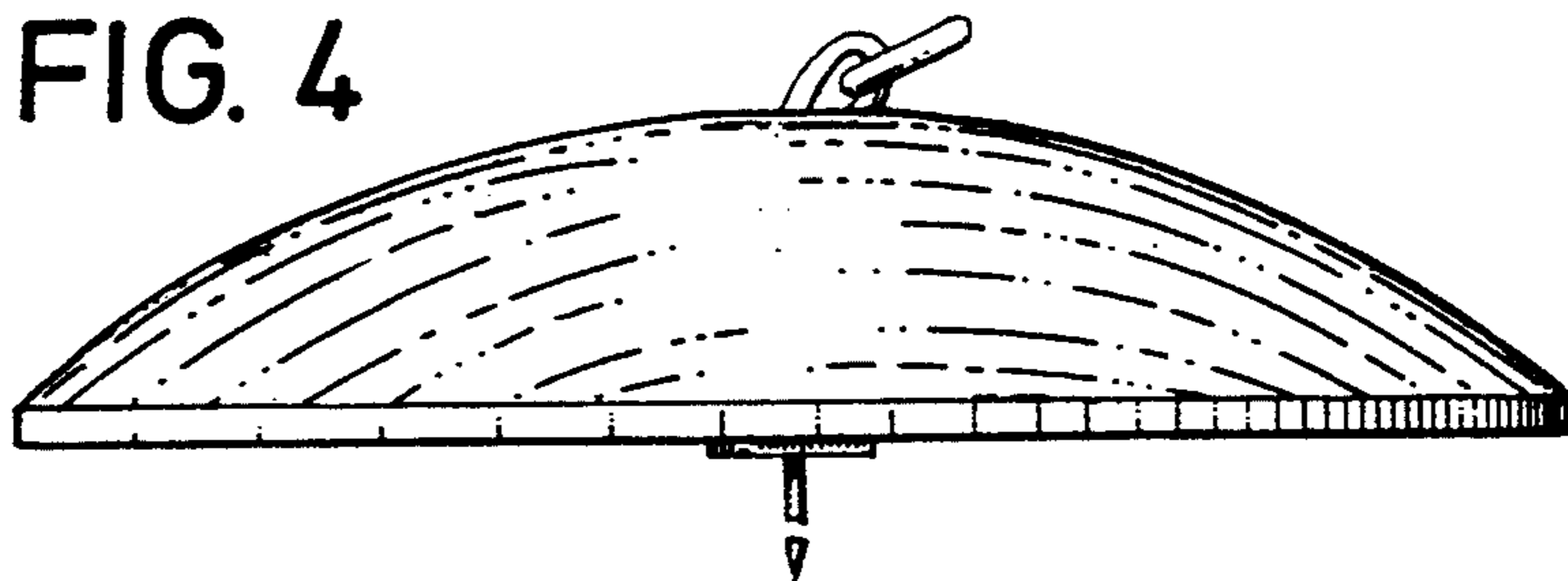
