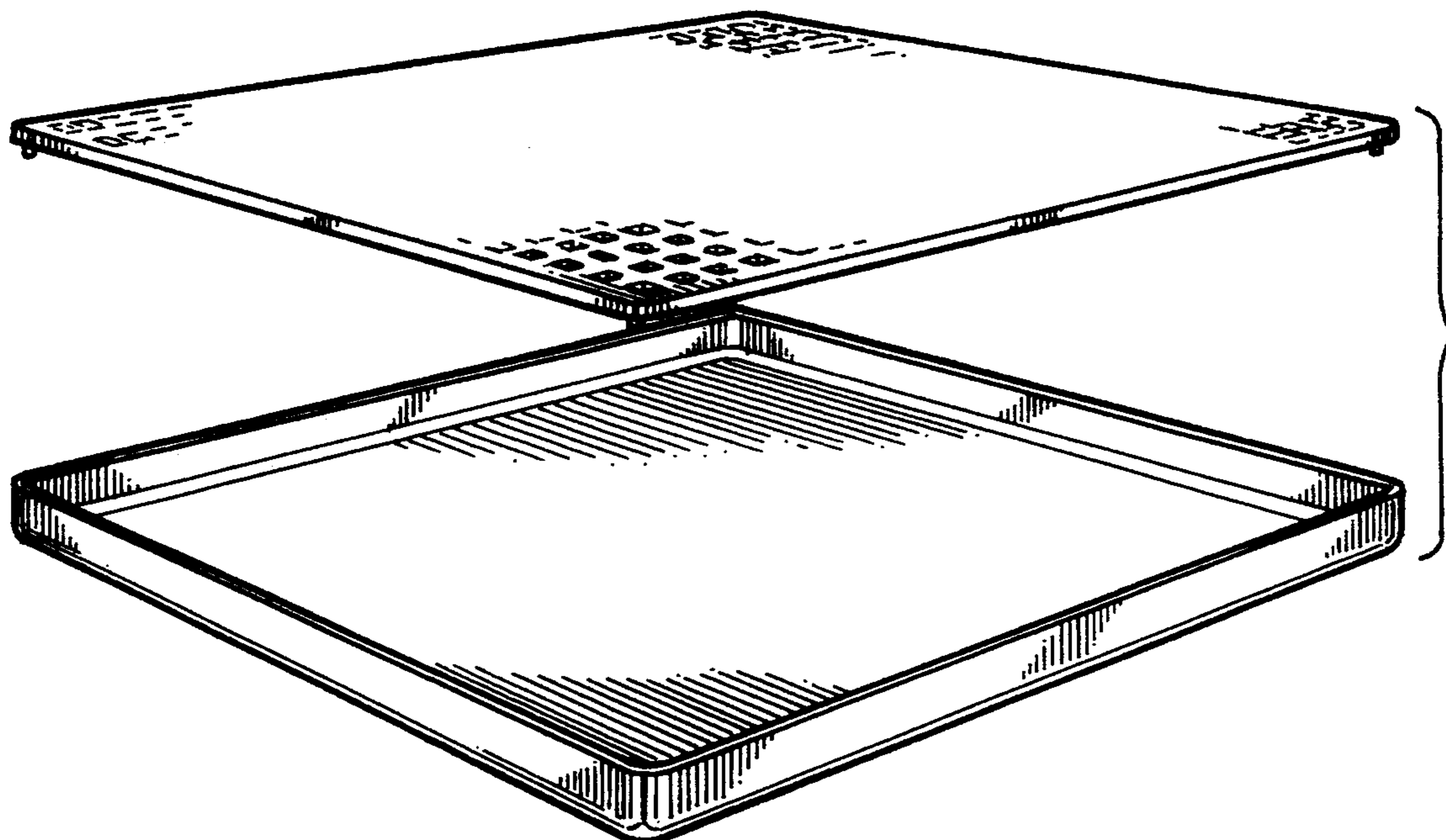

[57] **CLAIM**

The ornamental design for a mat for use adjacent to litter box, as shown and described.

**DESCRIPTION**

FIG. 1 is an exploded top, front and right side perspective view of a mat for use adjacent to litter box;  
 FIG. 2 is a front elevational view, the rear elevational view, not shown, being a mirror image thereof;  
 FIG. 3 is a cross-sectional view taken on line 3—3 of FIG. 4;  
 FIG. 4 is a top plan view thereof;  
 FIG. 5 is a right side elevational view, the left side elevational view, not shown, being a mirror image, thereof;  
 FIG. 6 is a cross-sectional view taken on line 6—6 of FIG. 4;  
 FIG. 7 is a bottom plan view thereof; and,  
 FIG. 8 is a bottom plan view of the underside of the grid plate thereof.



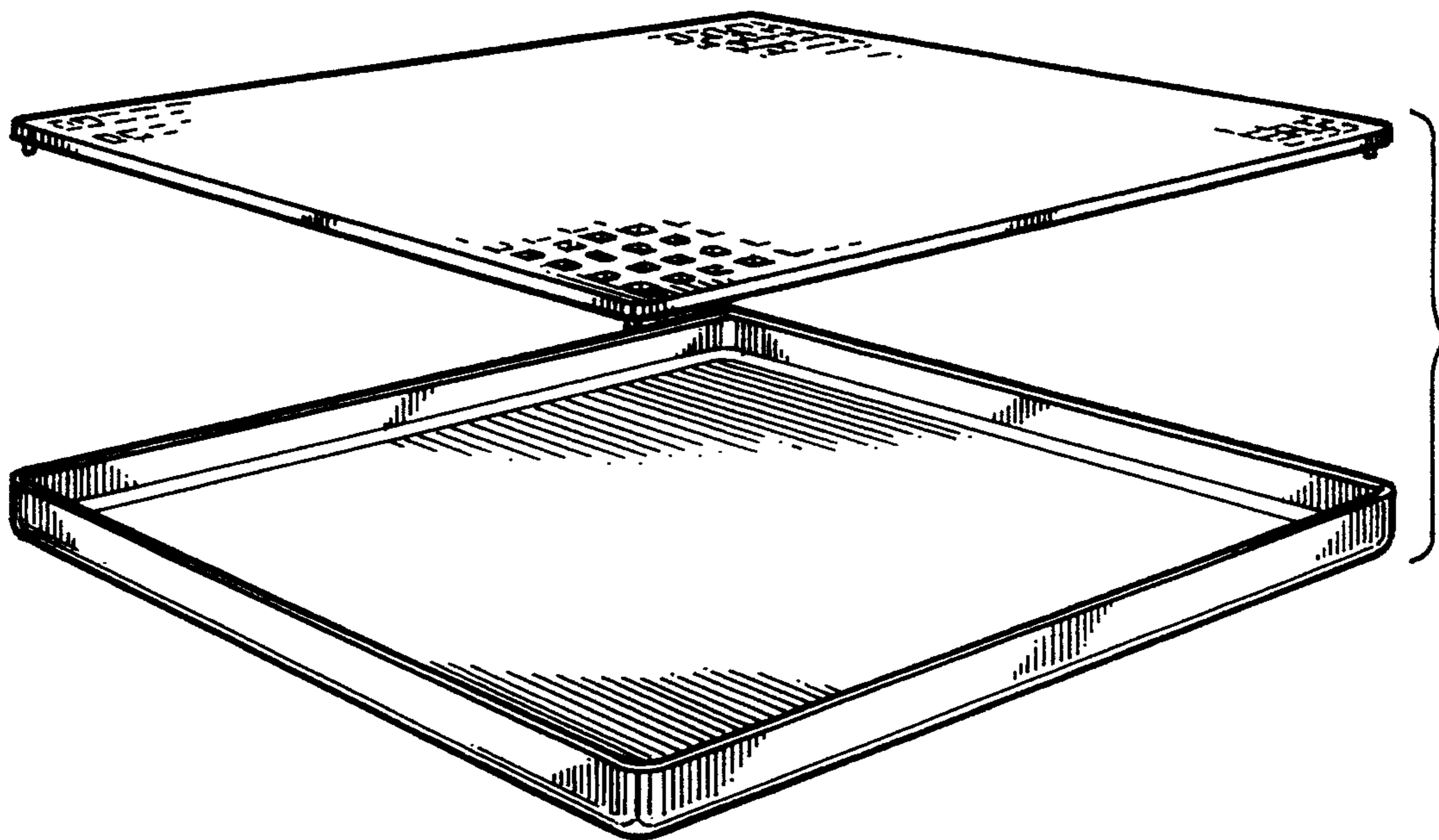

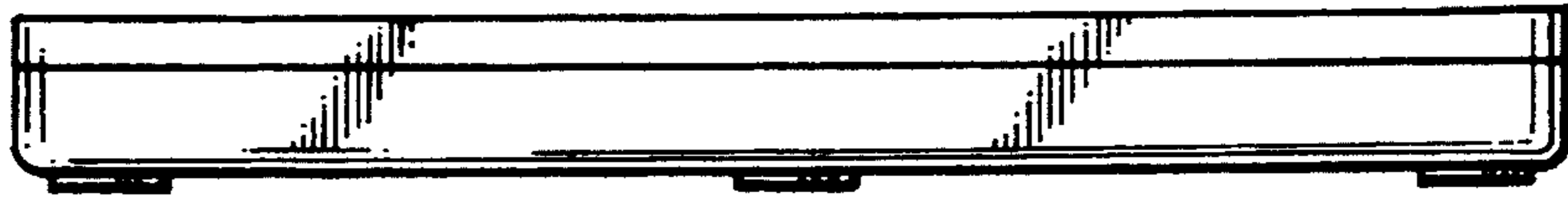

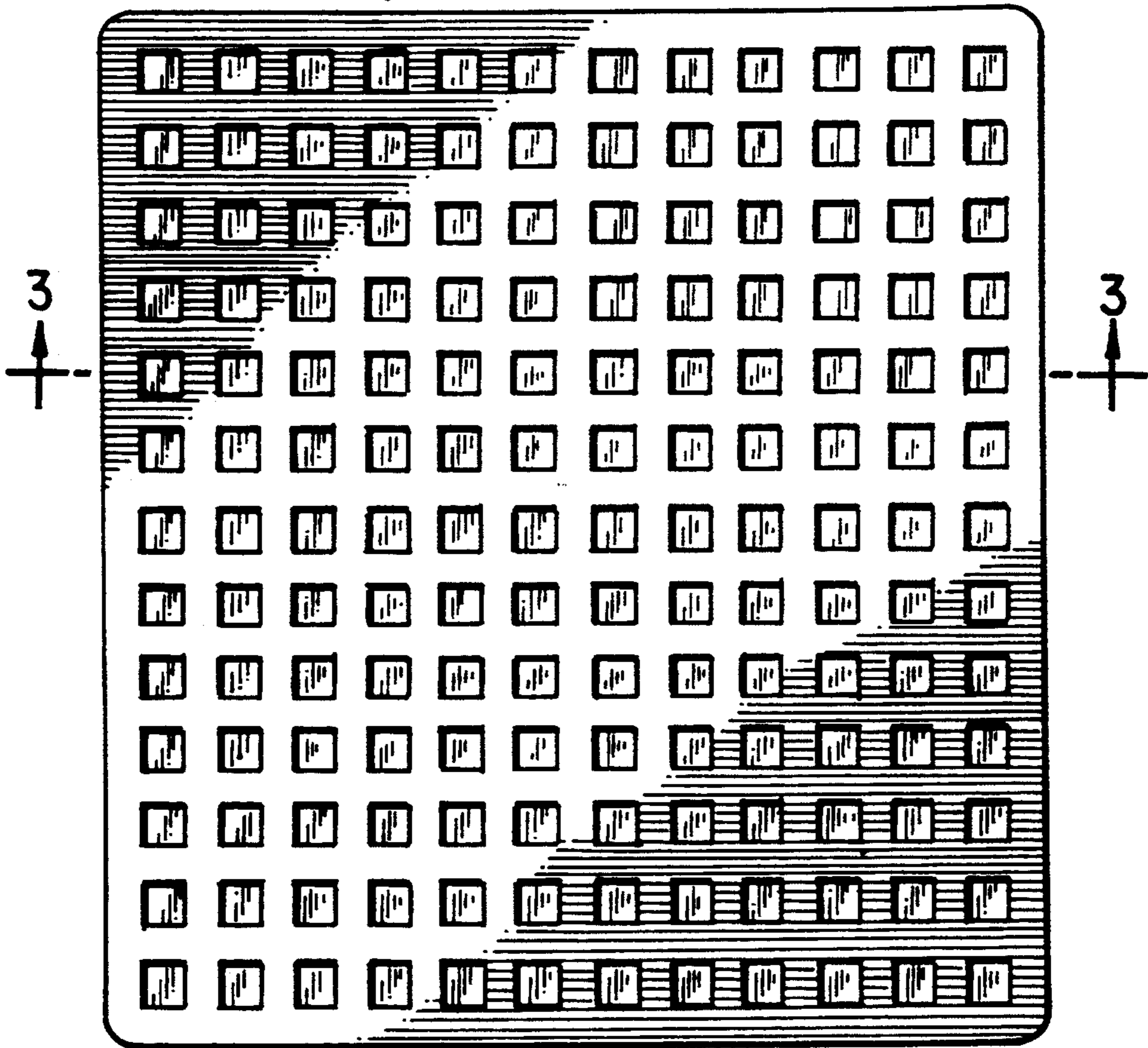

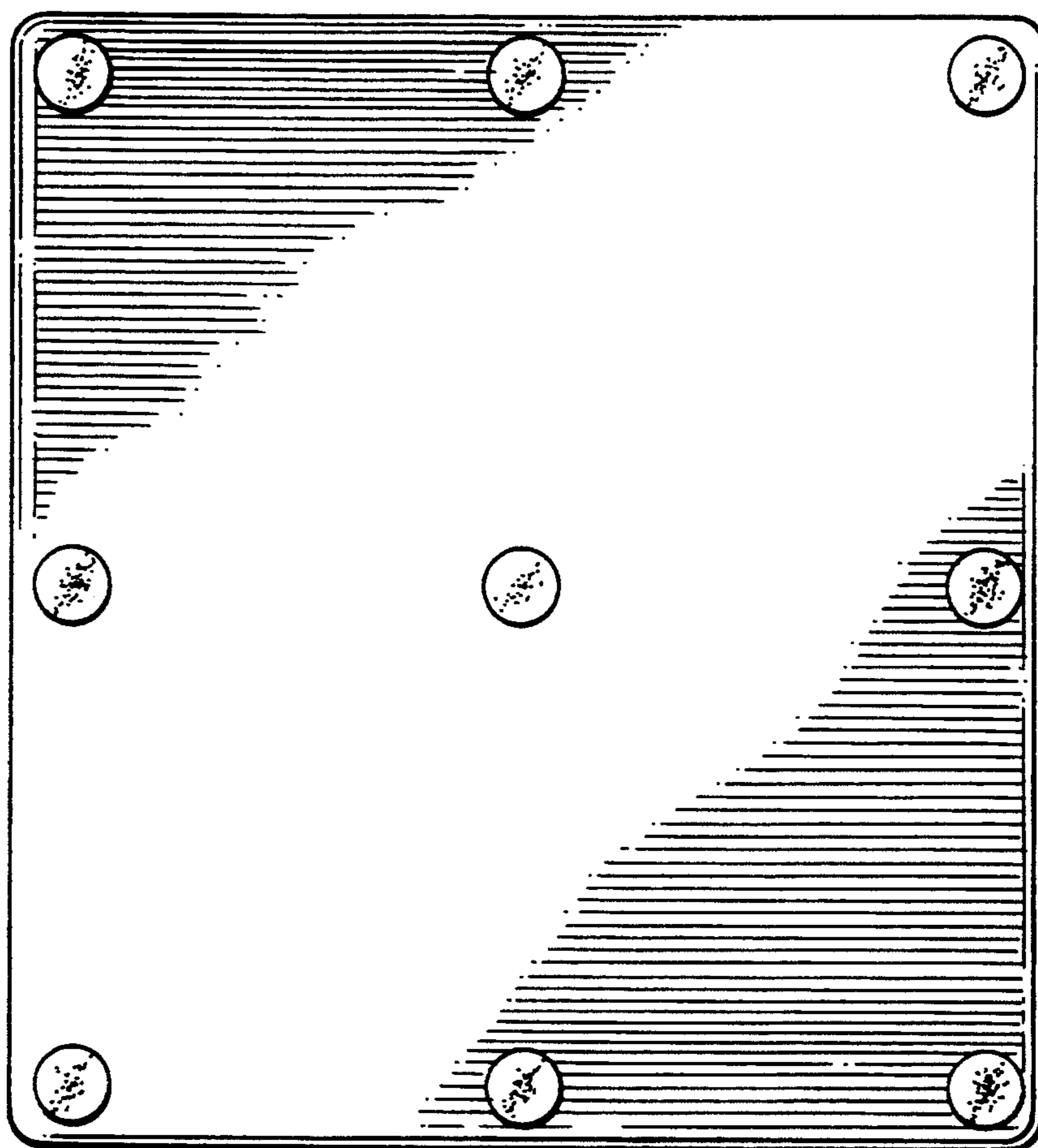

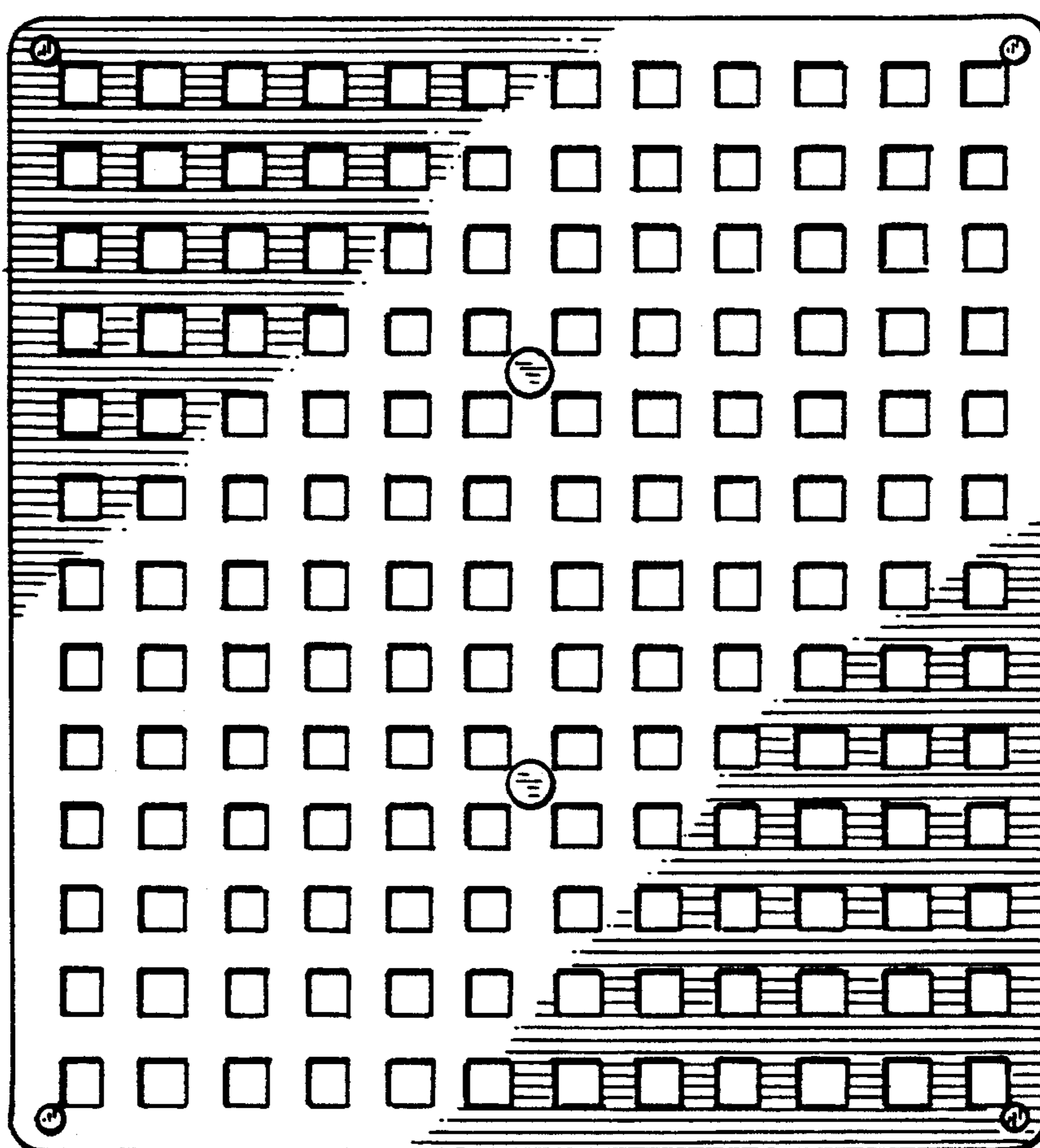
