FIG. 1 is a top left front perspective view of a integral handle for trash container showing my new design. The broken lines are for illustrative purposes only and form no part of the claimed design;

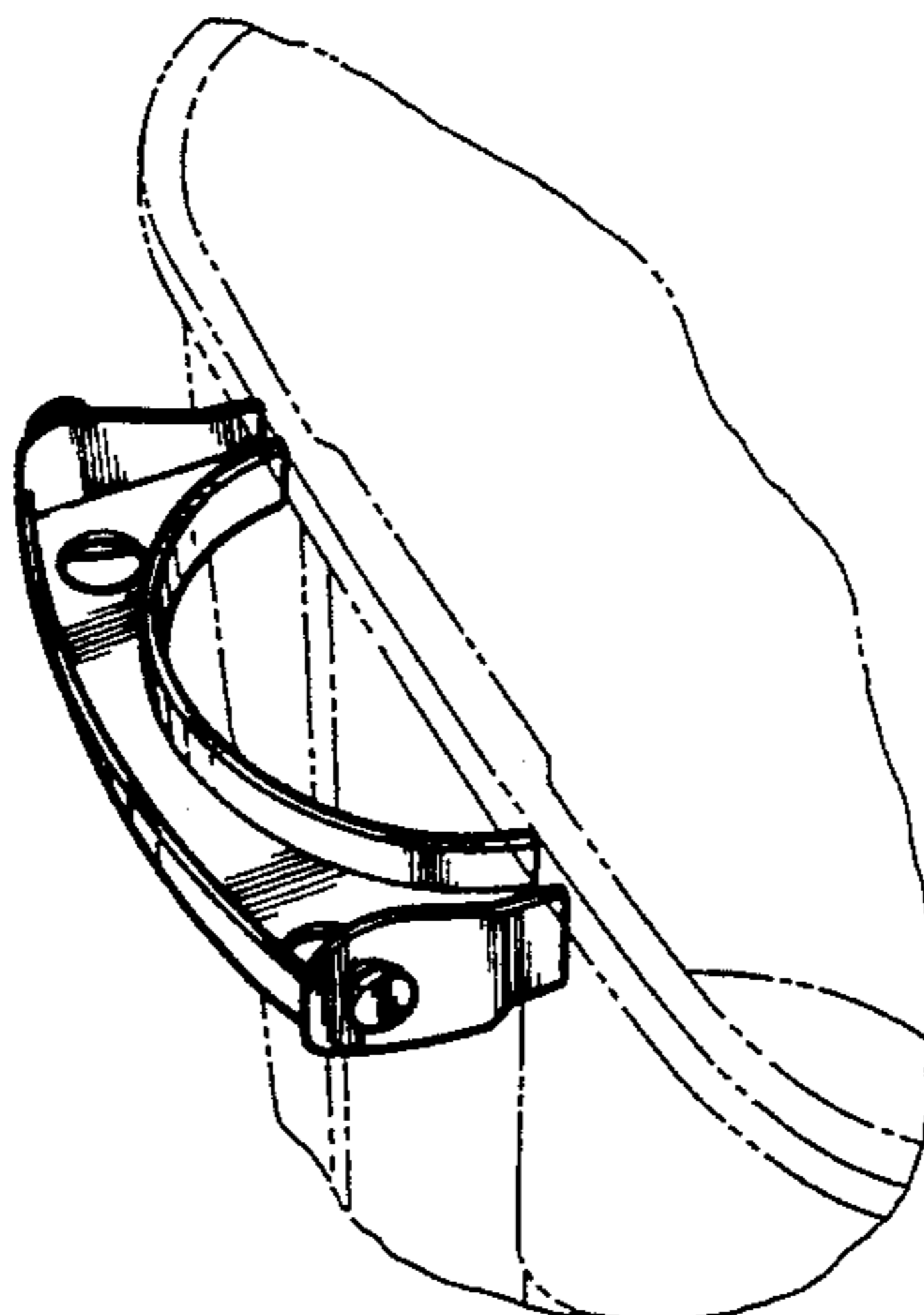
FIG. 2 is a top plan view thereof;

FIG. 6 is a rear elevational view thereof.



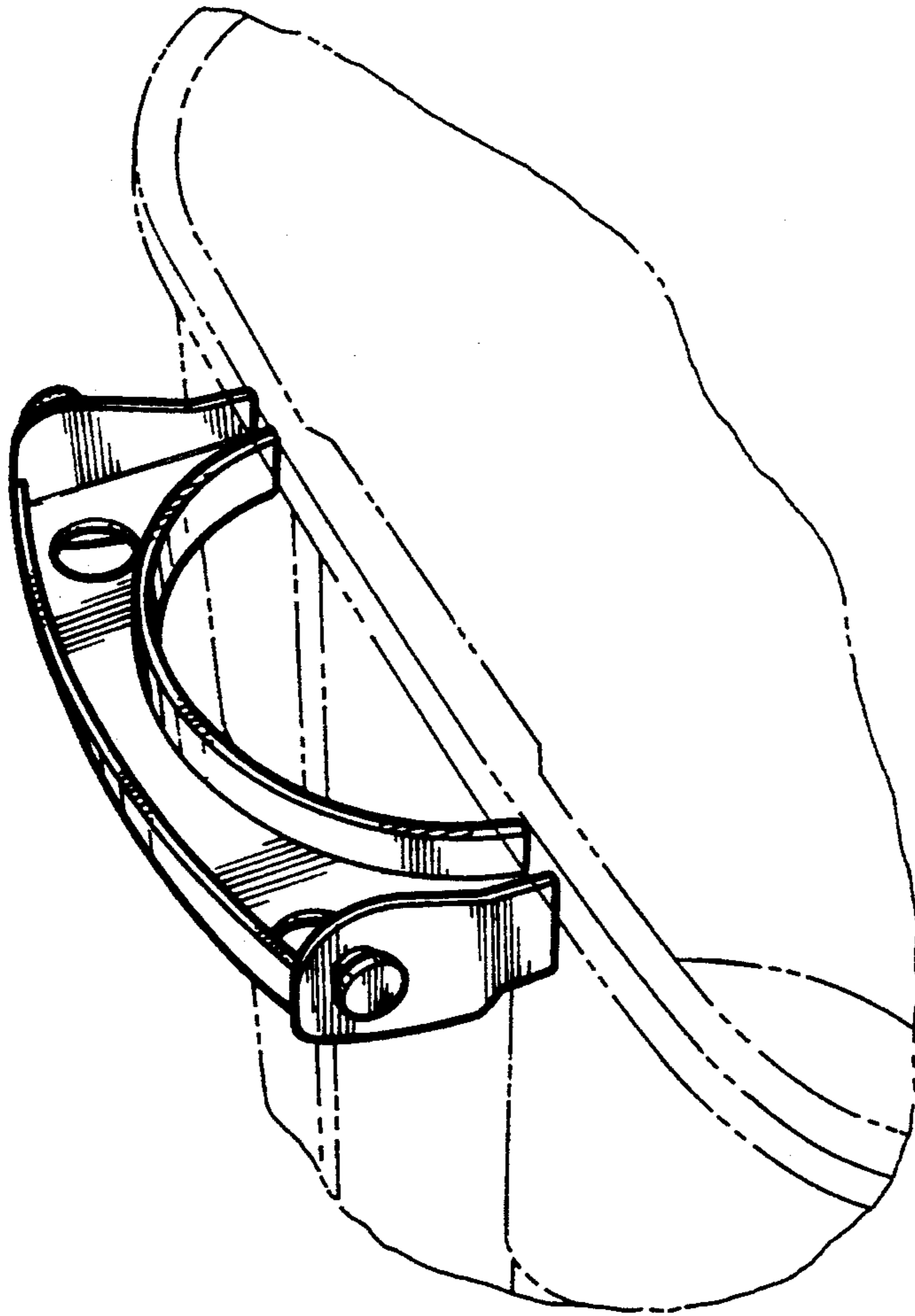

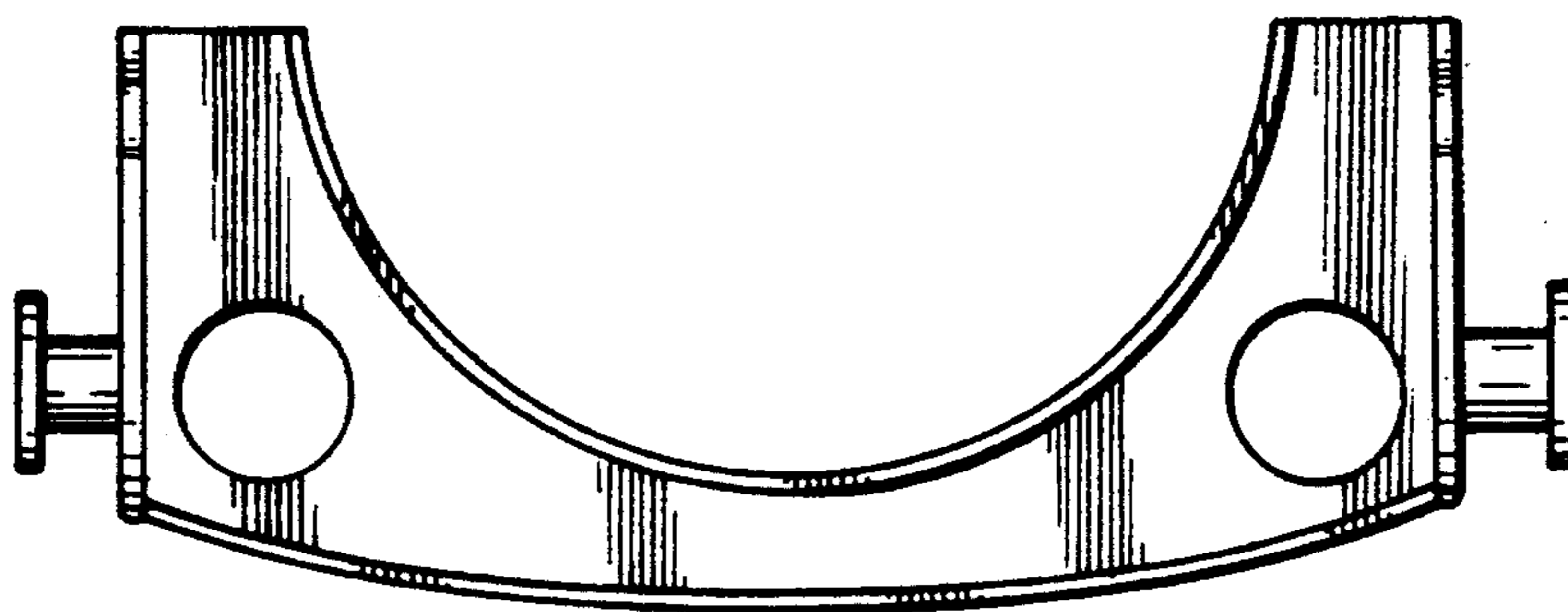

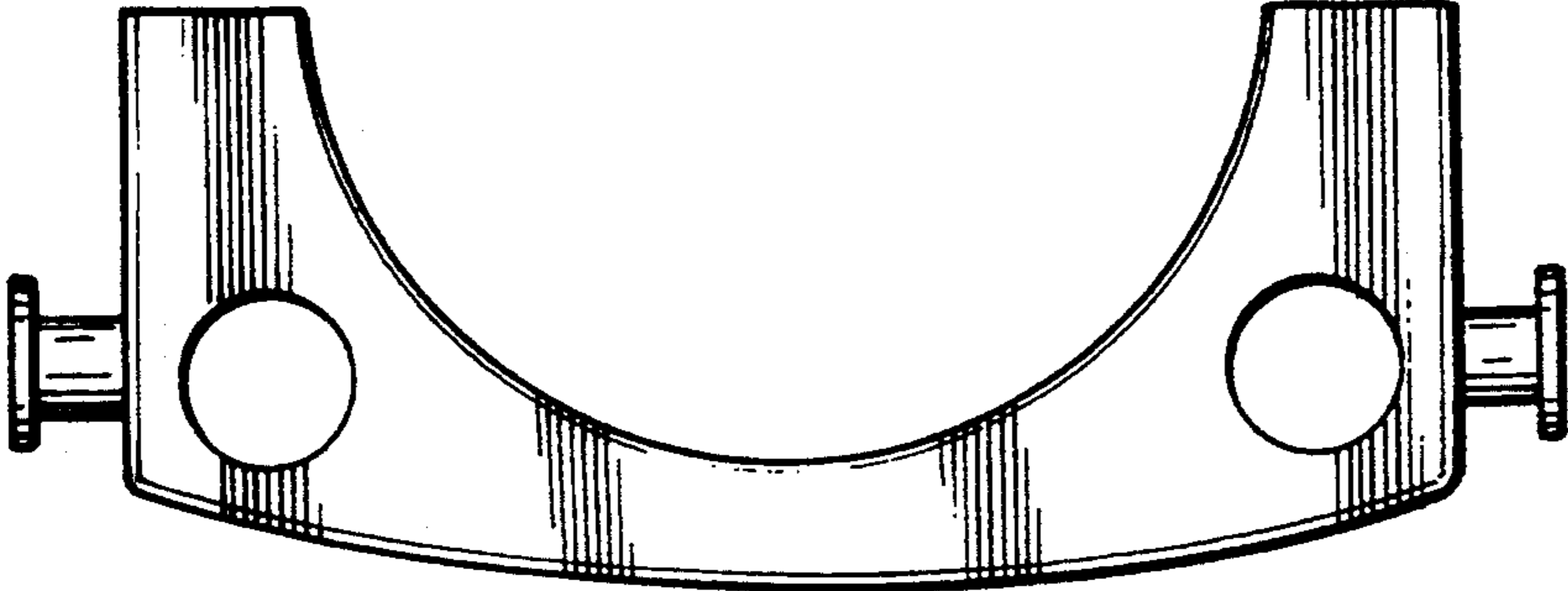

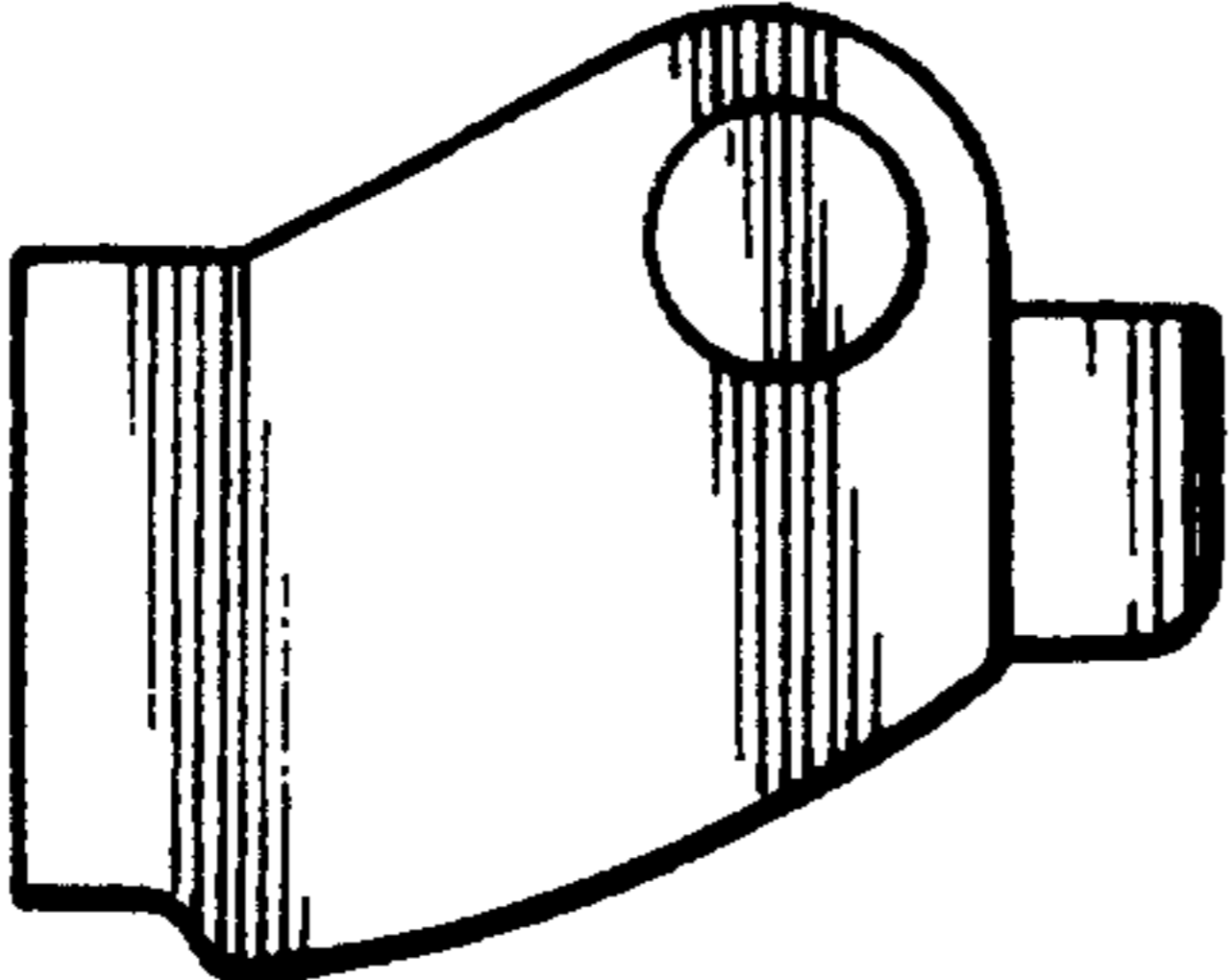

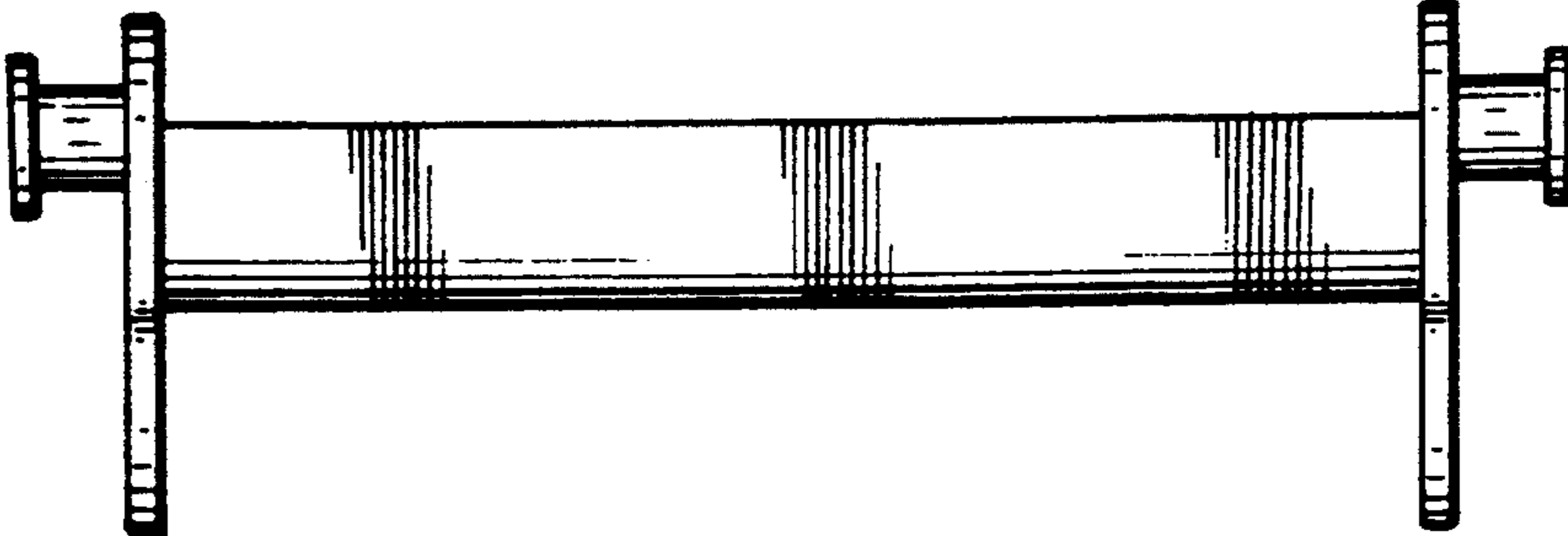

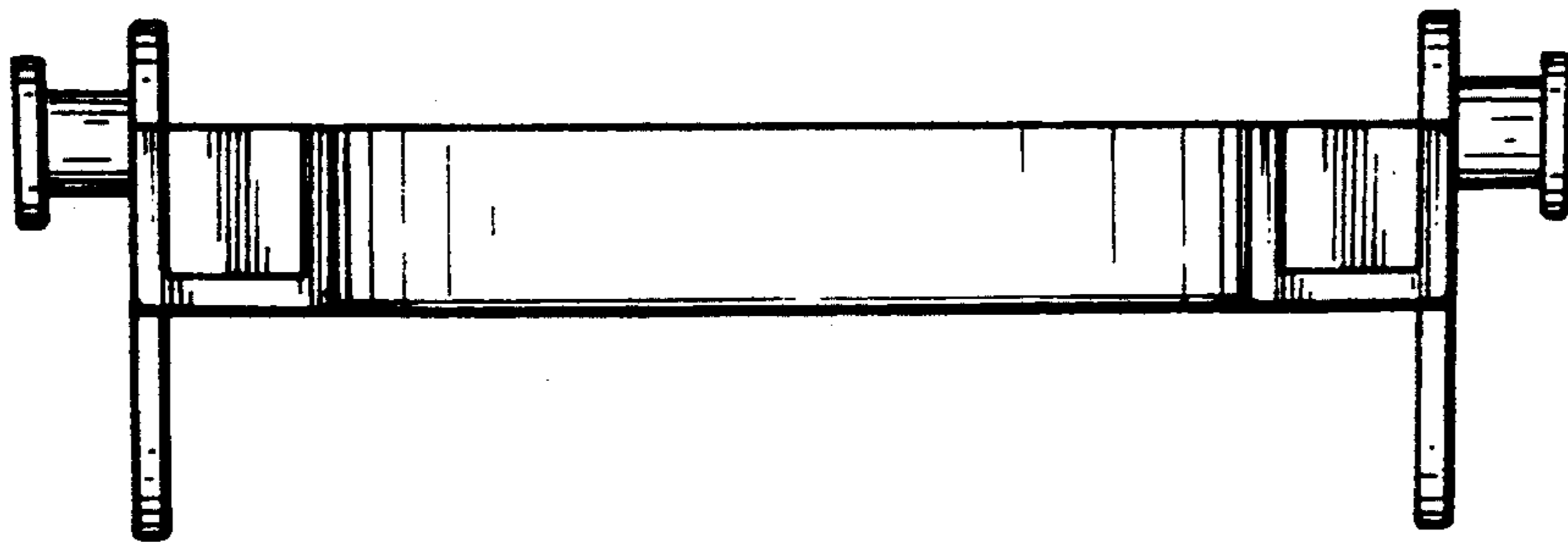
