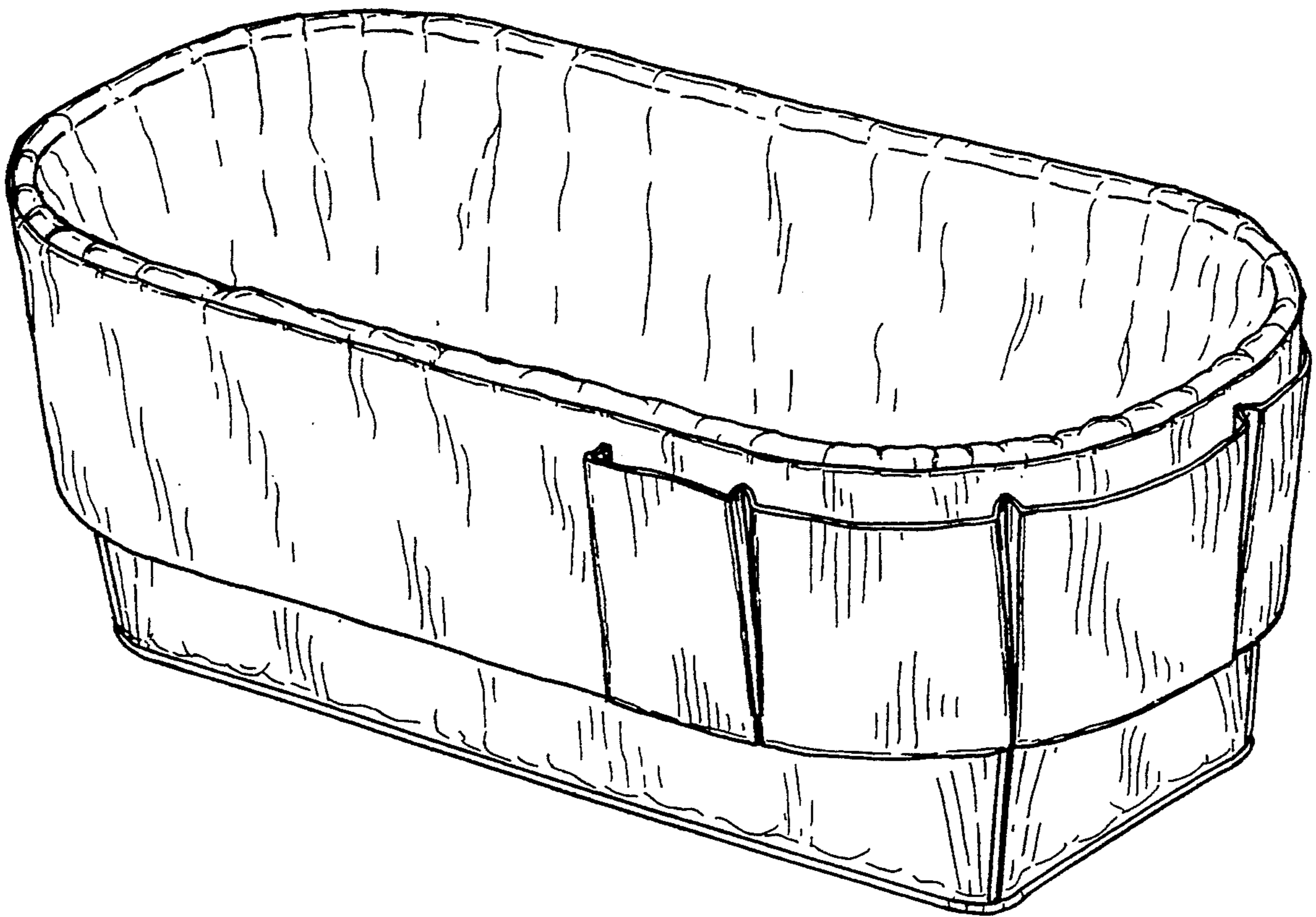

DESCRIPTION

FIG. 1 is a perspective view of a combined bassinet liner and organizer, showing our new design;
 FIG. 2 is a front elevational view thereof;

 FIG. 7 is a bottom plan view thereof.



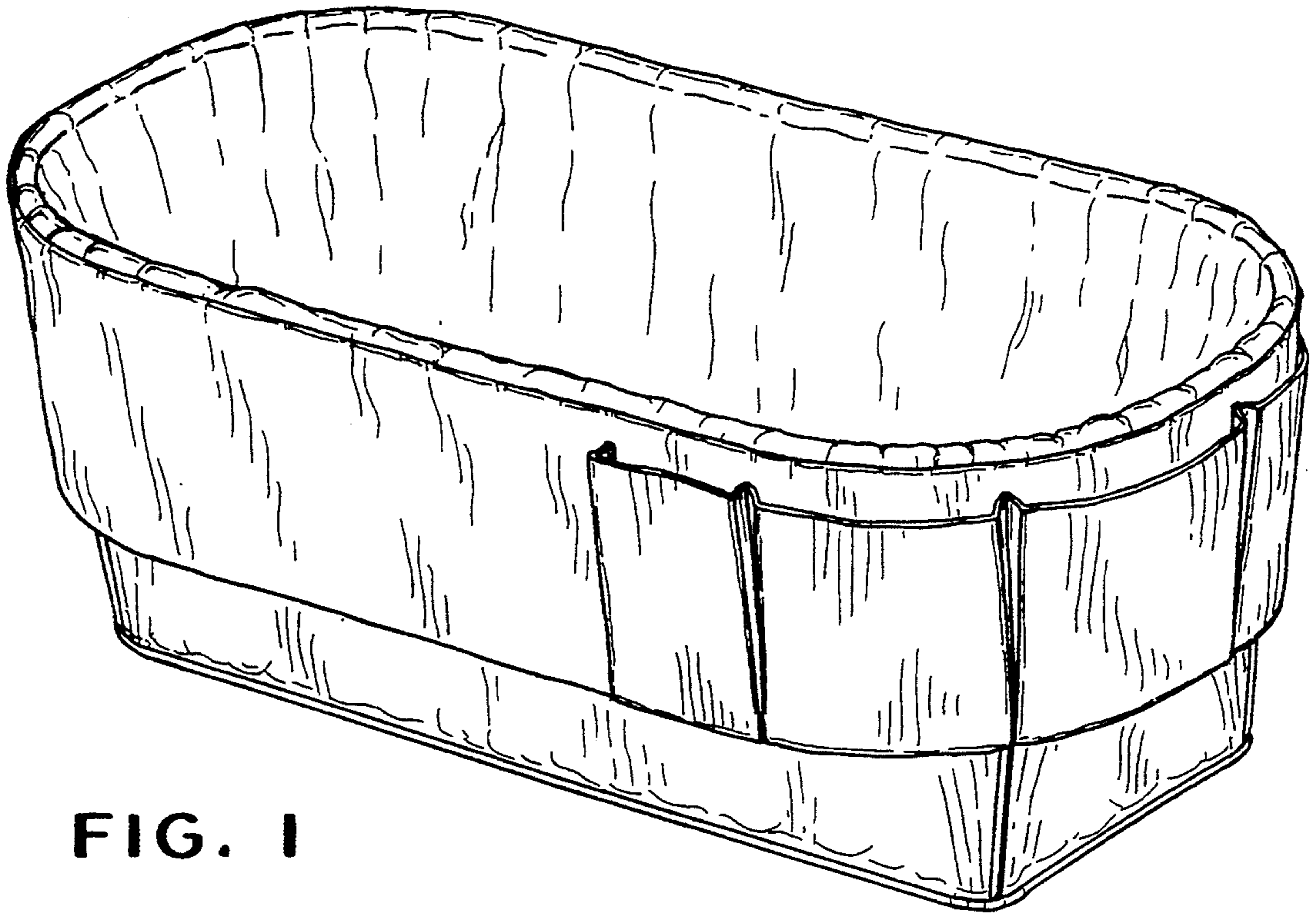

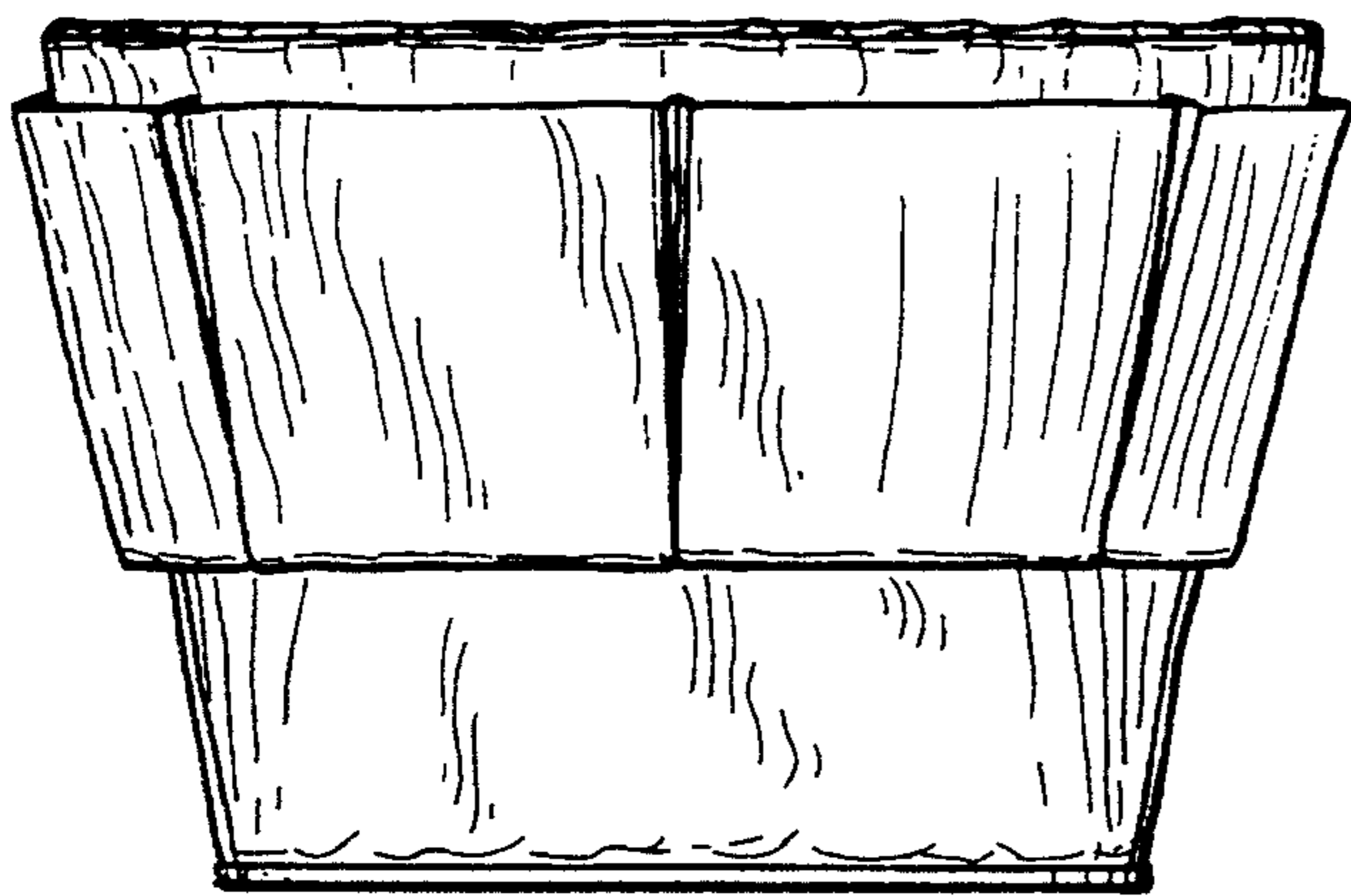

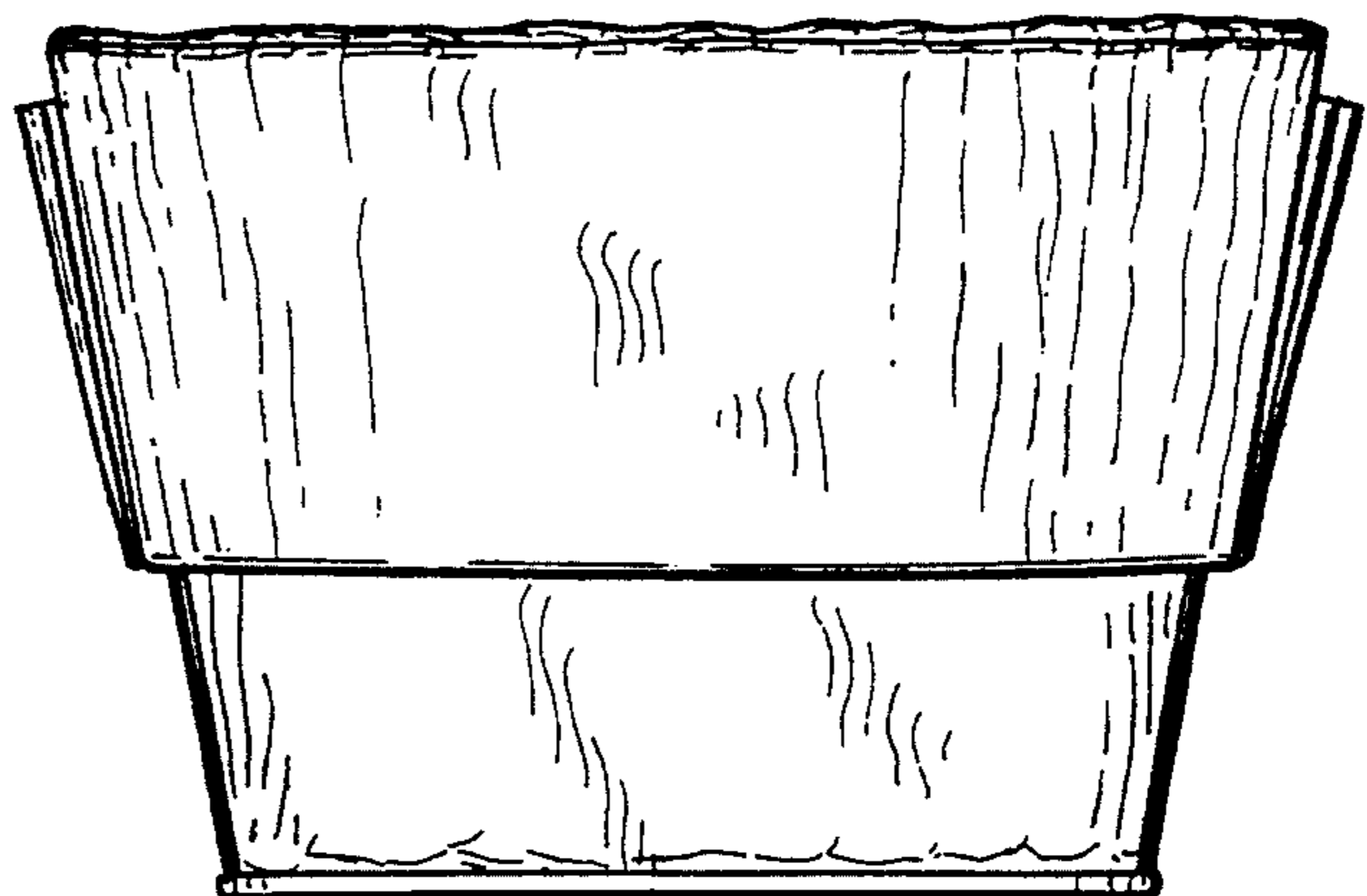

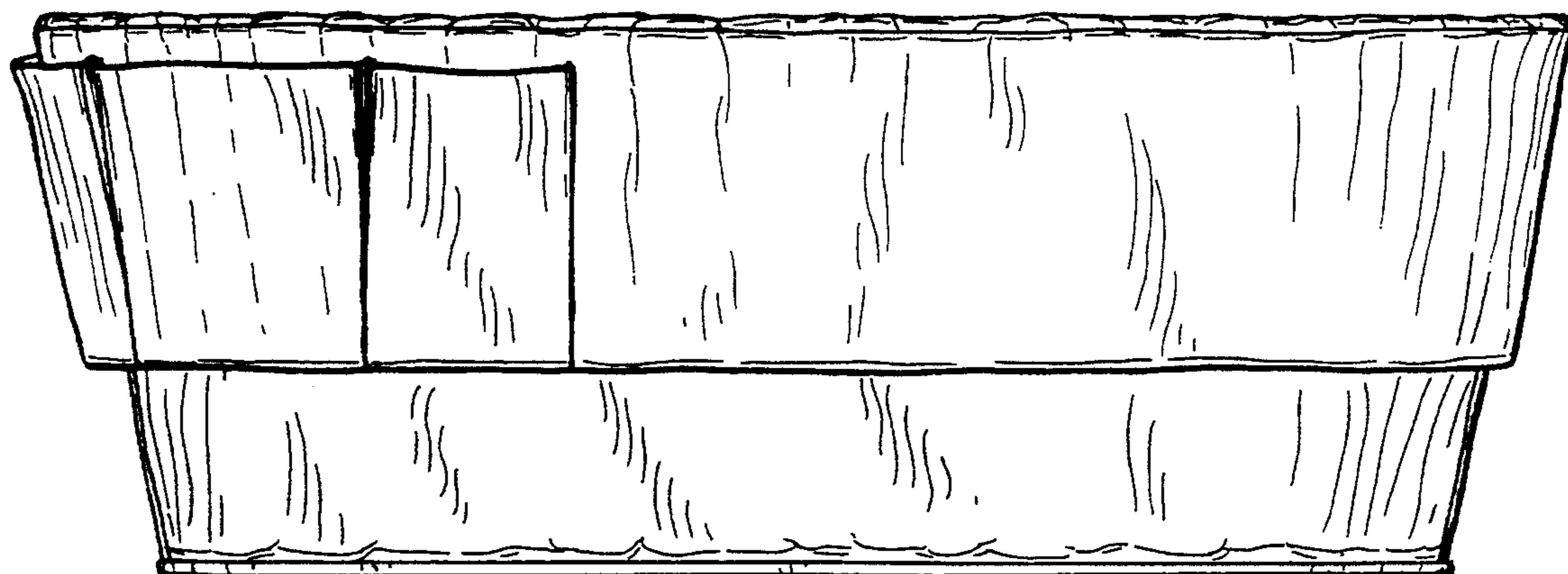

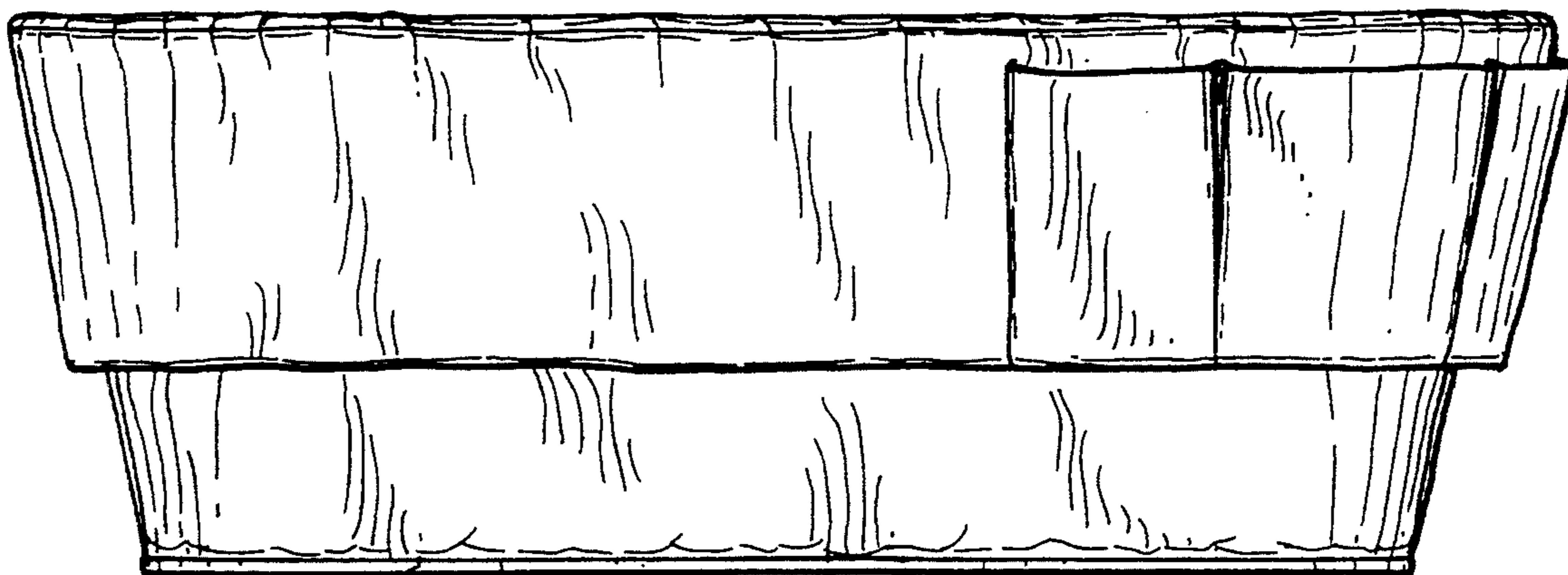

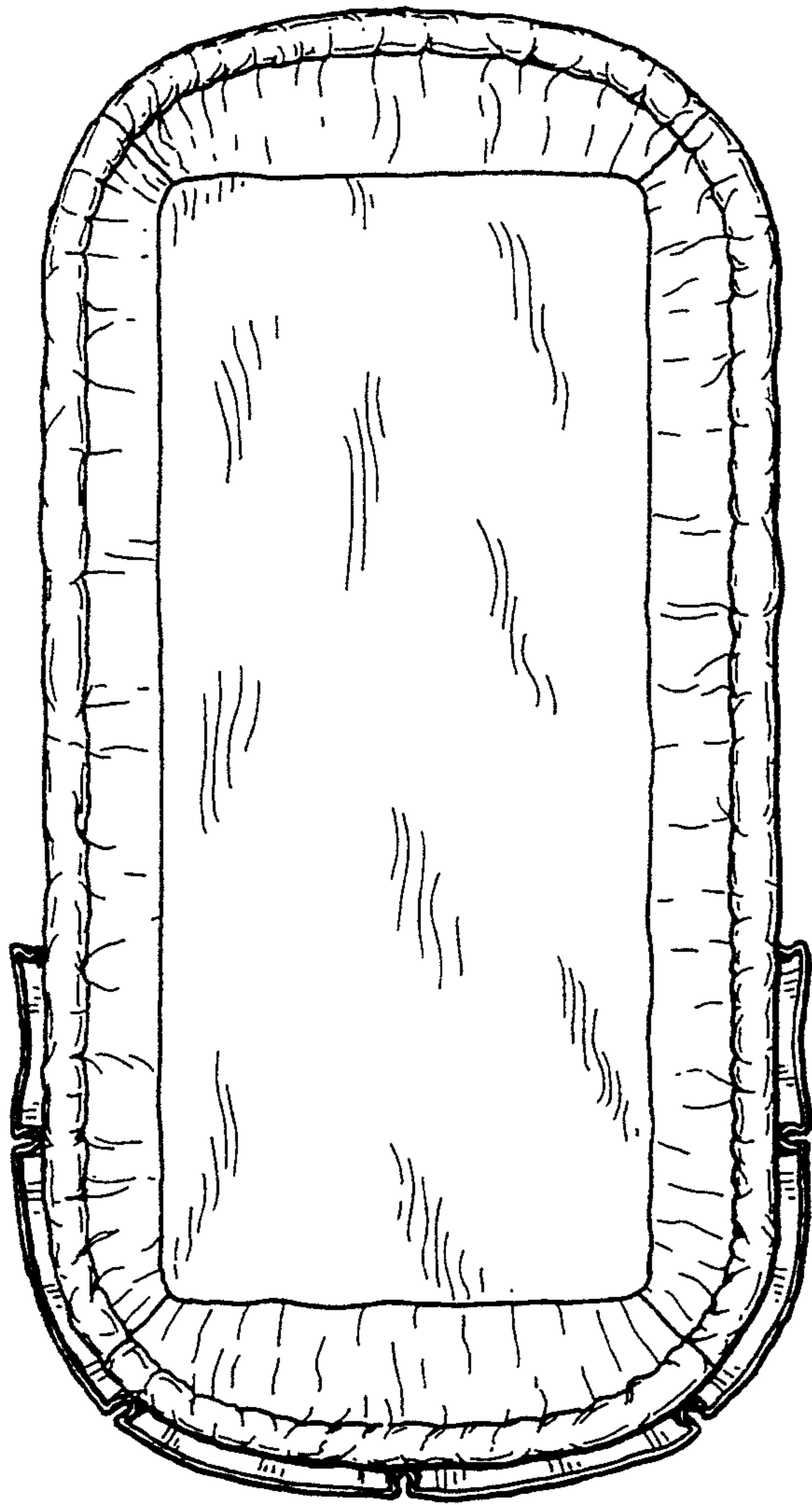

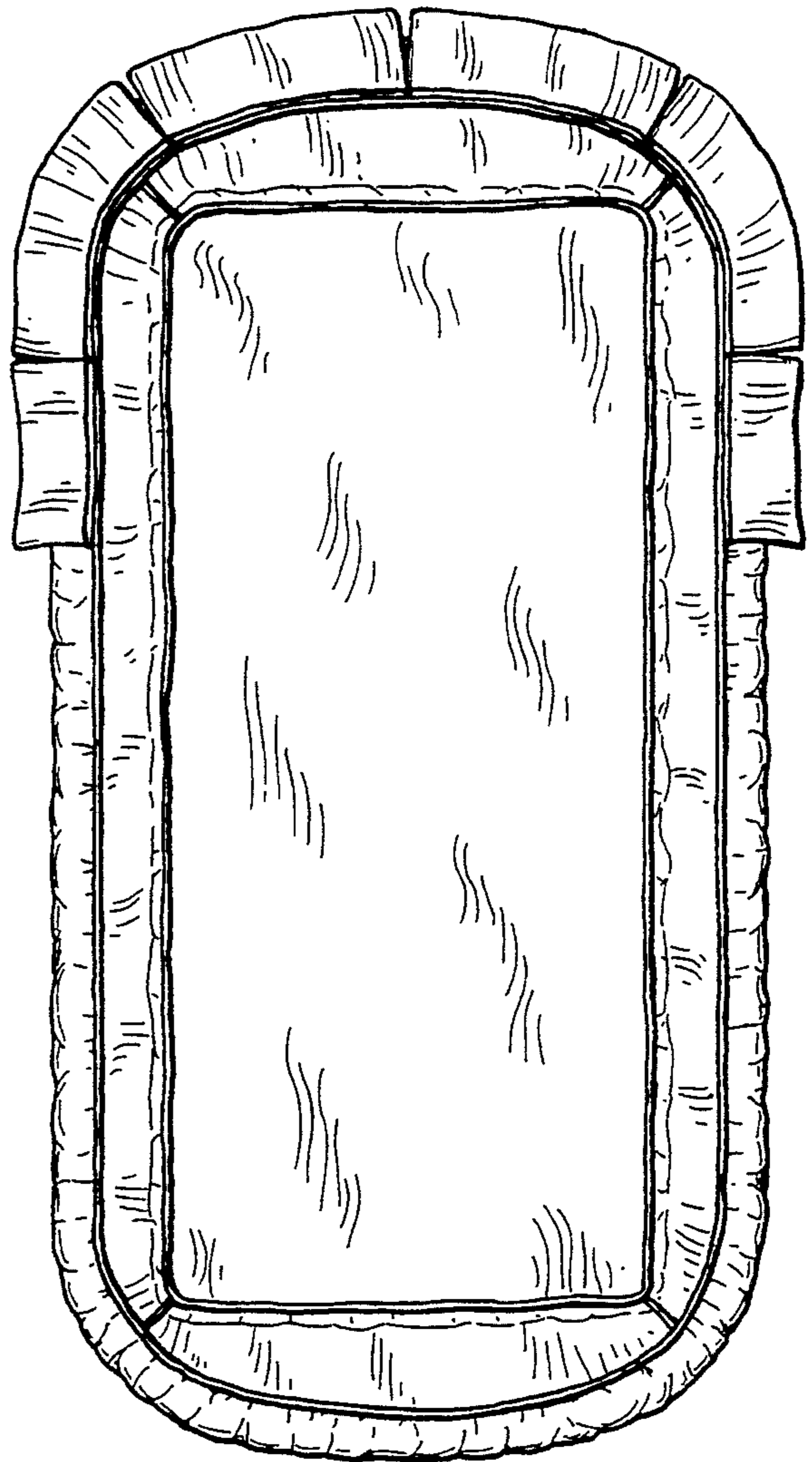
