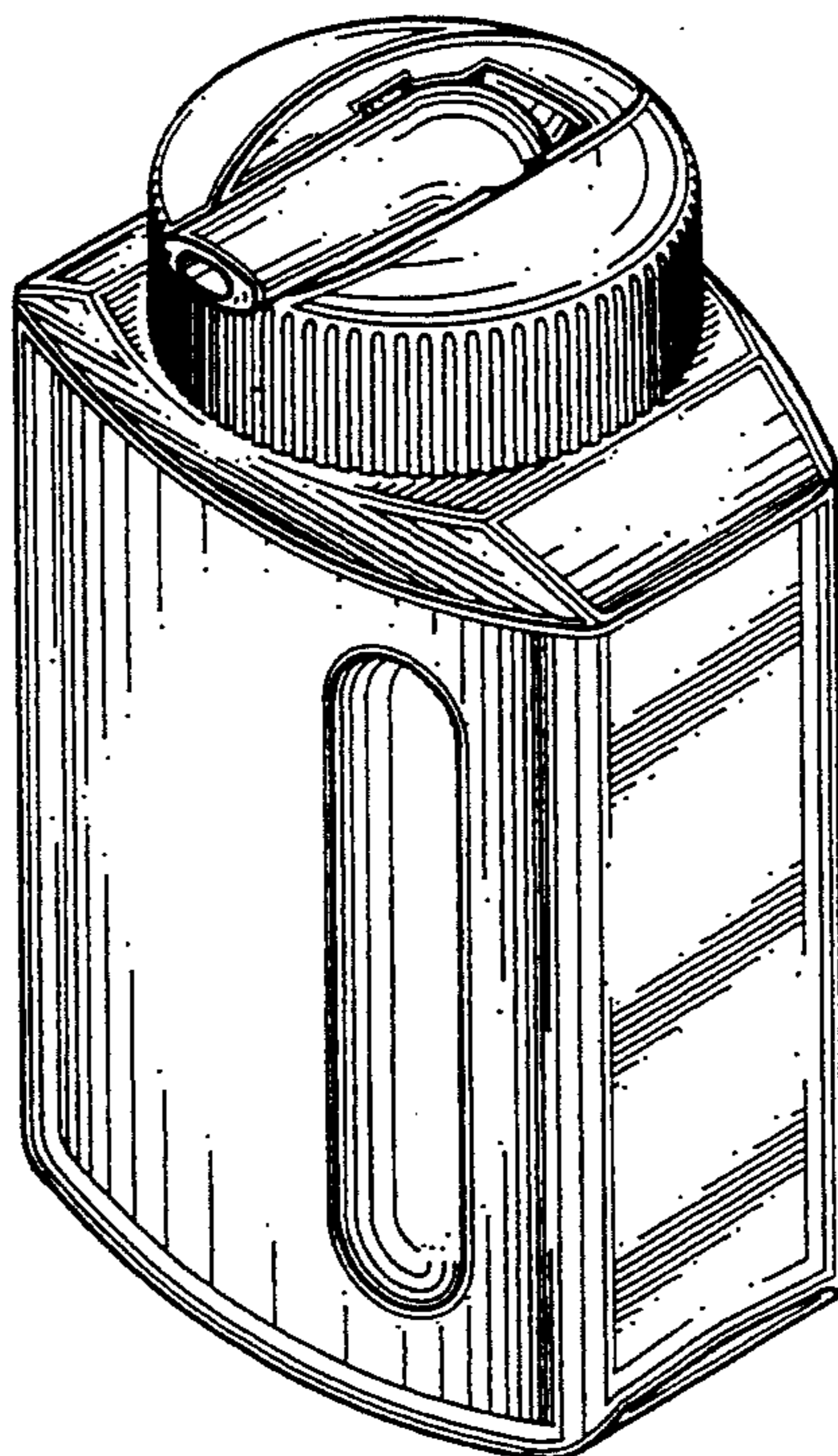

[57] **CLAIM**

The ornamental design for a beverage bottle, as shown and described.

DESCRIPTION

FIG. 1 is a top right front perspective view of a beverage bottle showing my new design; FIG. 2 is a top plan view thereof; FIG. 3 is a front elevational view thereof; FIG. 4 is a rear elevational view thereof; FIG. 5 is a bottom plan view thereof; and, FIG. 6 is a right side elevational view thereof; the opposite side being a mirror image.



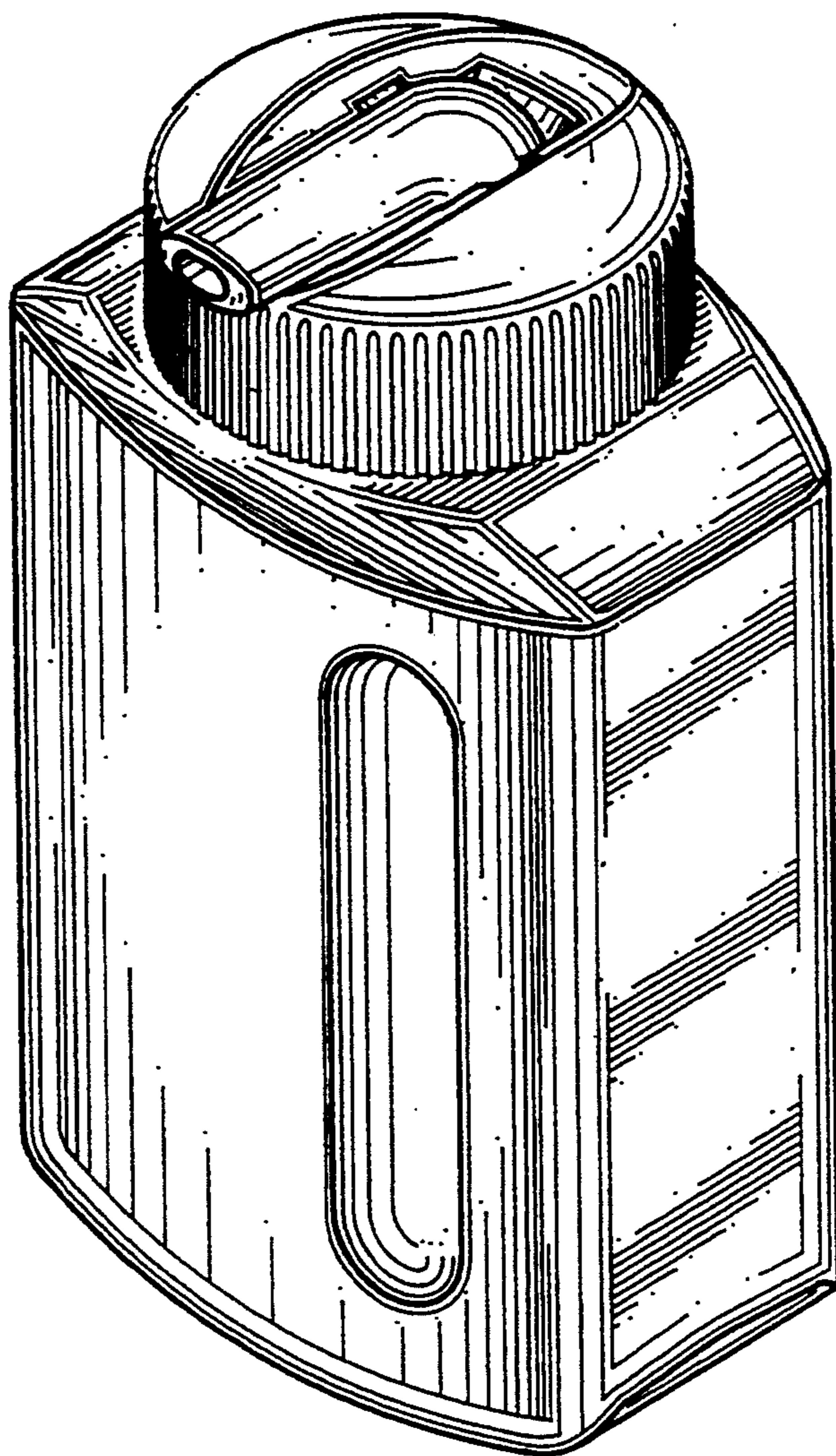

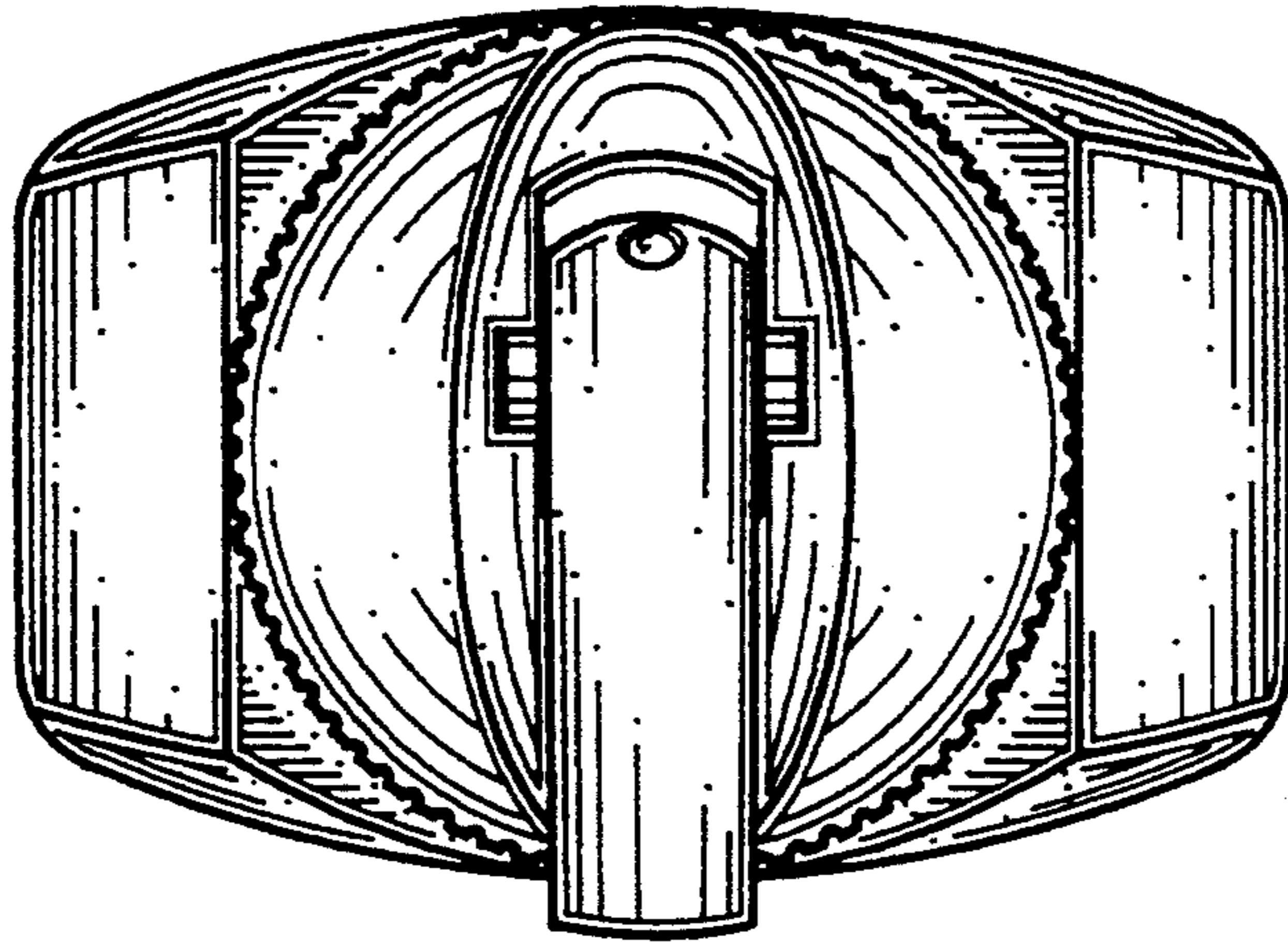

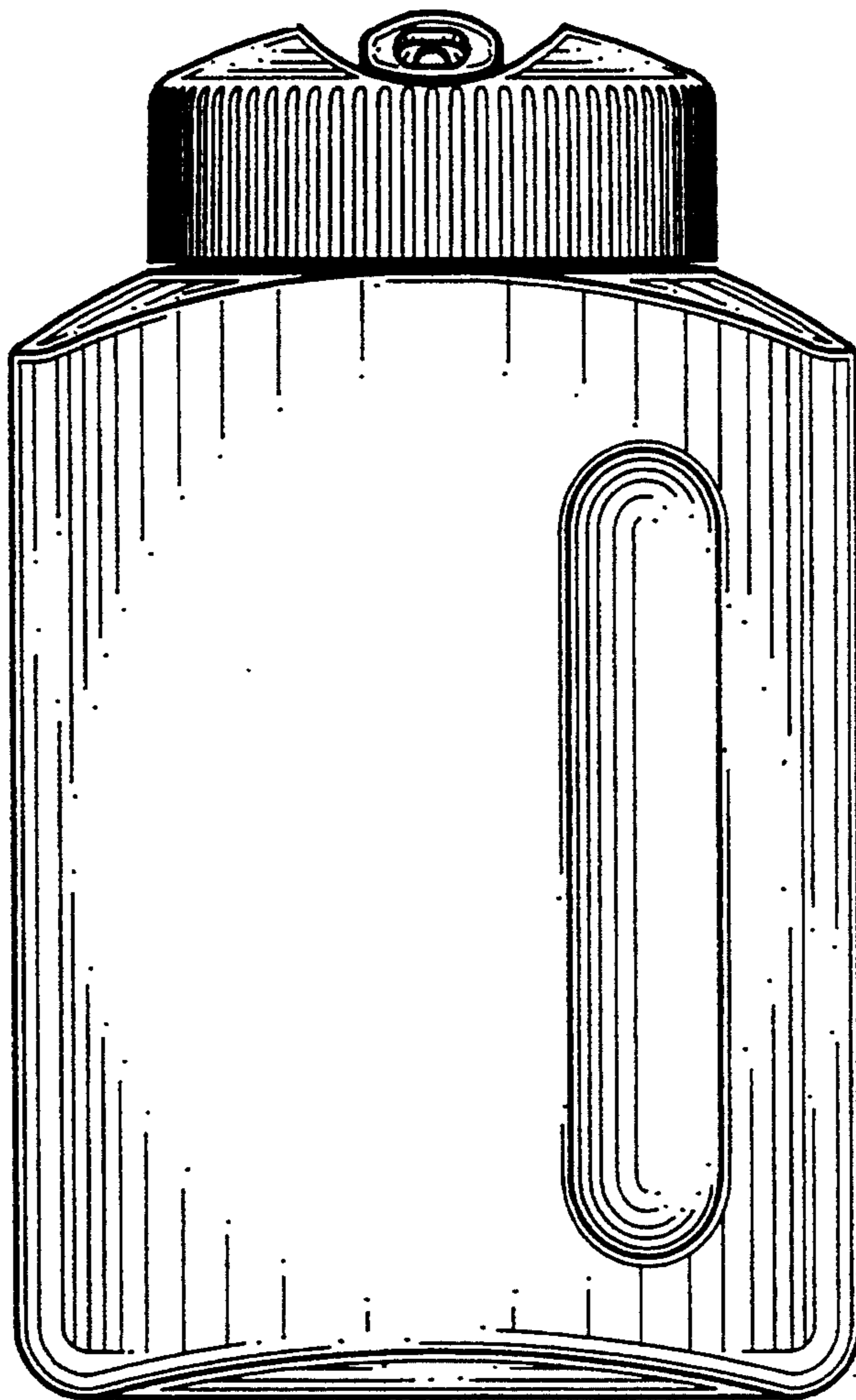

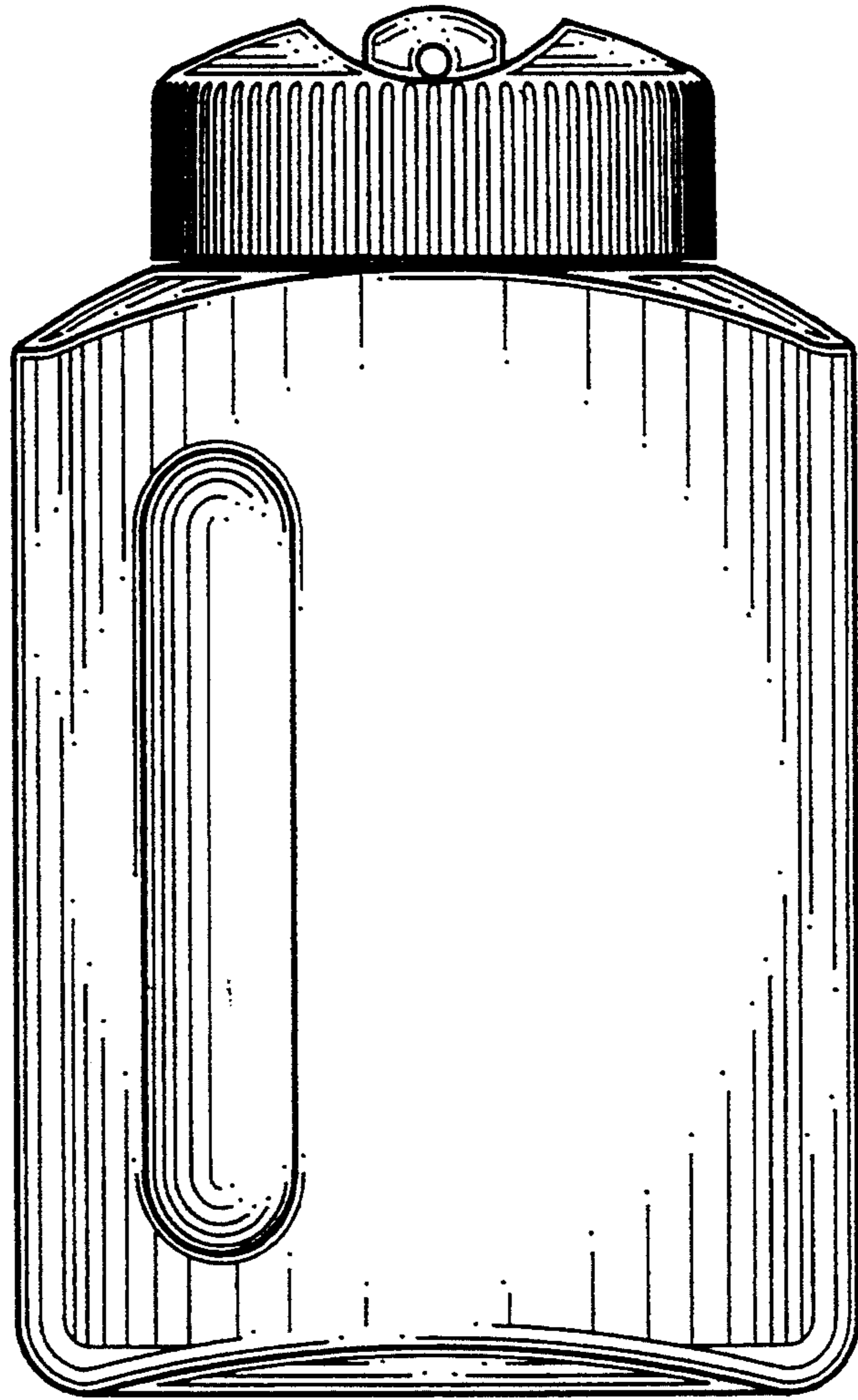

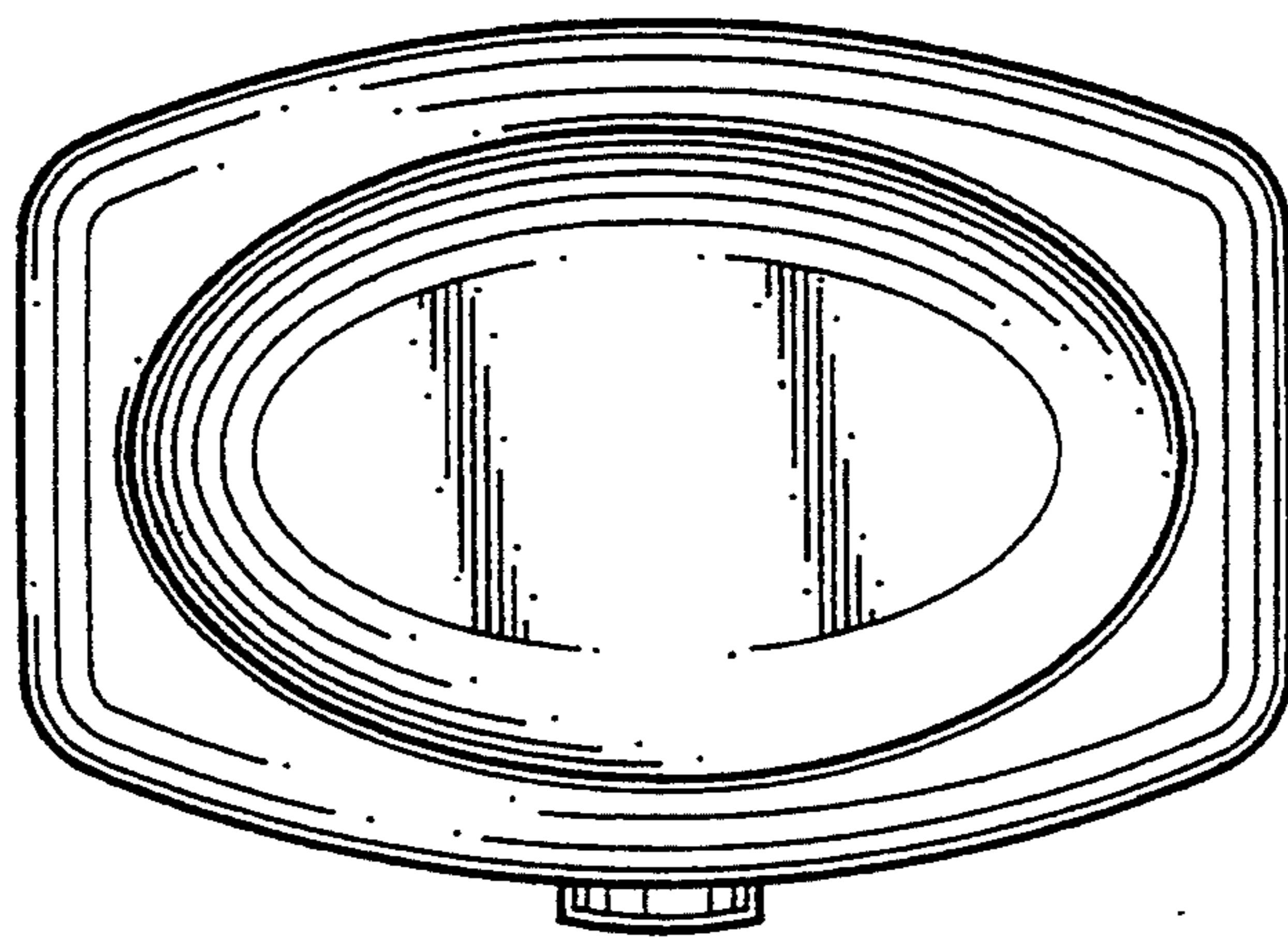

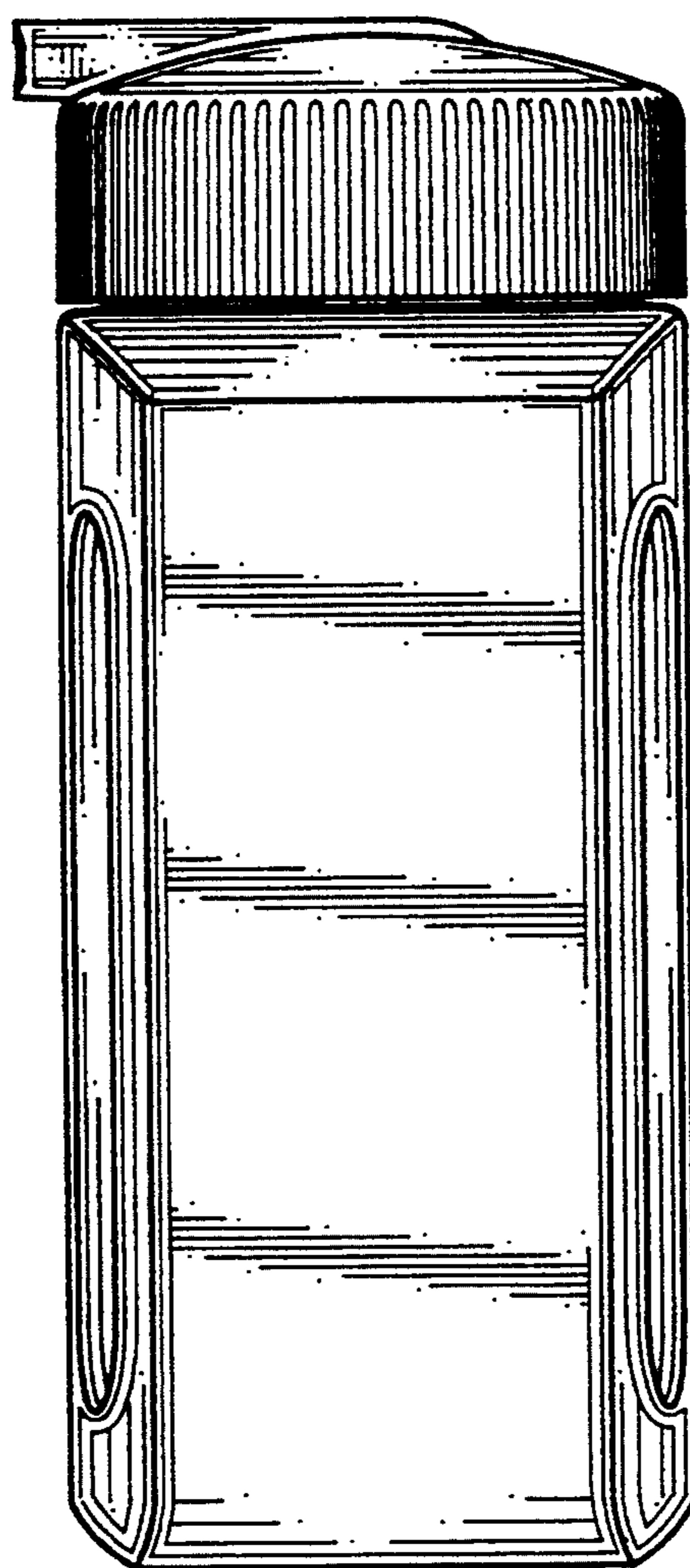
