[57] **CLAIM**

The ornamental design for dinnerware, as shown and described.

DESCRIPTION

FIG. 1 is a top front perspective view of a dinnerware showing my new design;

FIG. 2 is a top plan view thereof;

FIG. 3 is a bottom plan view thereof;

FIG. 4 is a front elevational view thereof; the rear elevational and side elevational views being a mirror image;

FIG. 5 is a partial cross-sectional view of the dinnerware taken along the line 5—5 of FIG. 2;

FIG. 6 is a top front perspective of an alternate embodiment of a dinnerware showing my new design;

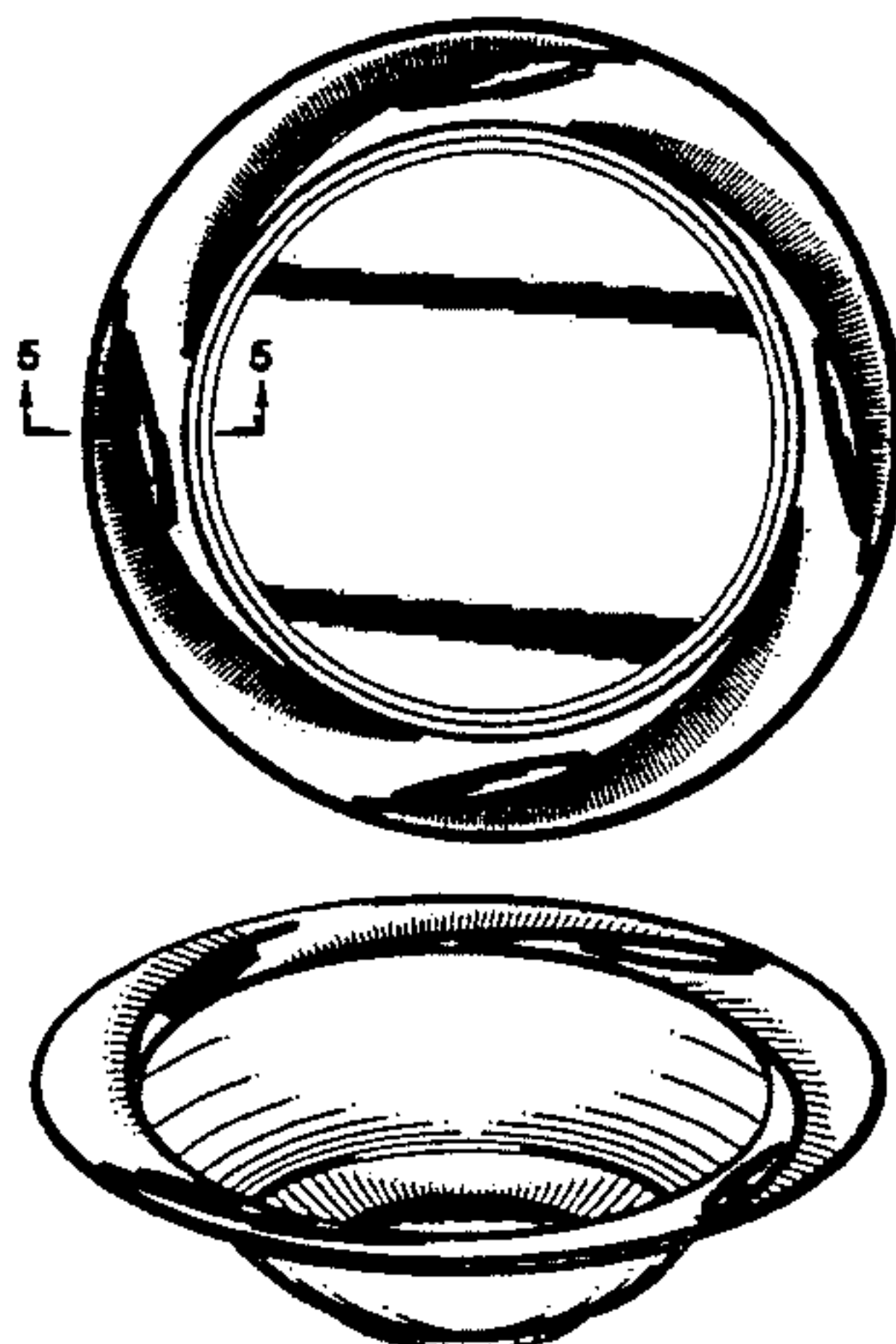
FIG. 7 is a top plan view of the alternate embodiment;

FIG. 8 is a front elevational view of an alternate embodiment; the rear elevational and side elevational views being a mirror image;

FIG. 9 is a partial cross-sectional view of the alternate embodiment of the dinnerware taken along the line 9—9 of FIG. 7; and,

FIG. 10 is a bottom plan view of an alternate embodiment.

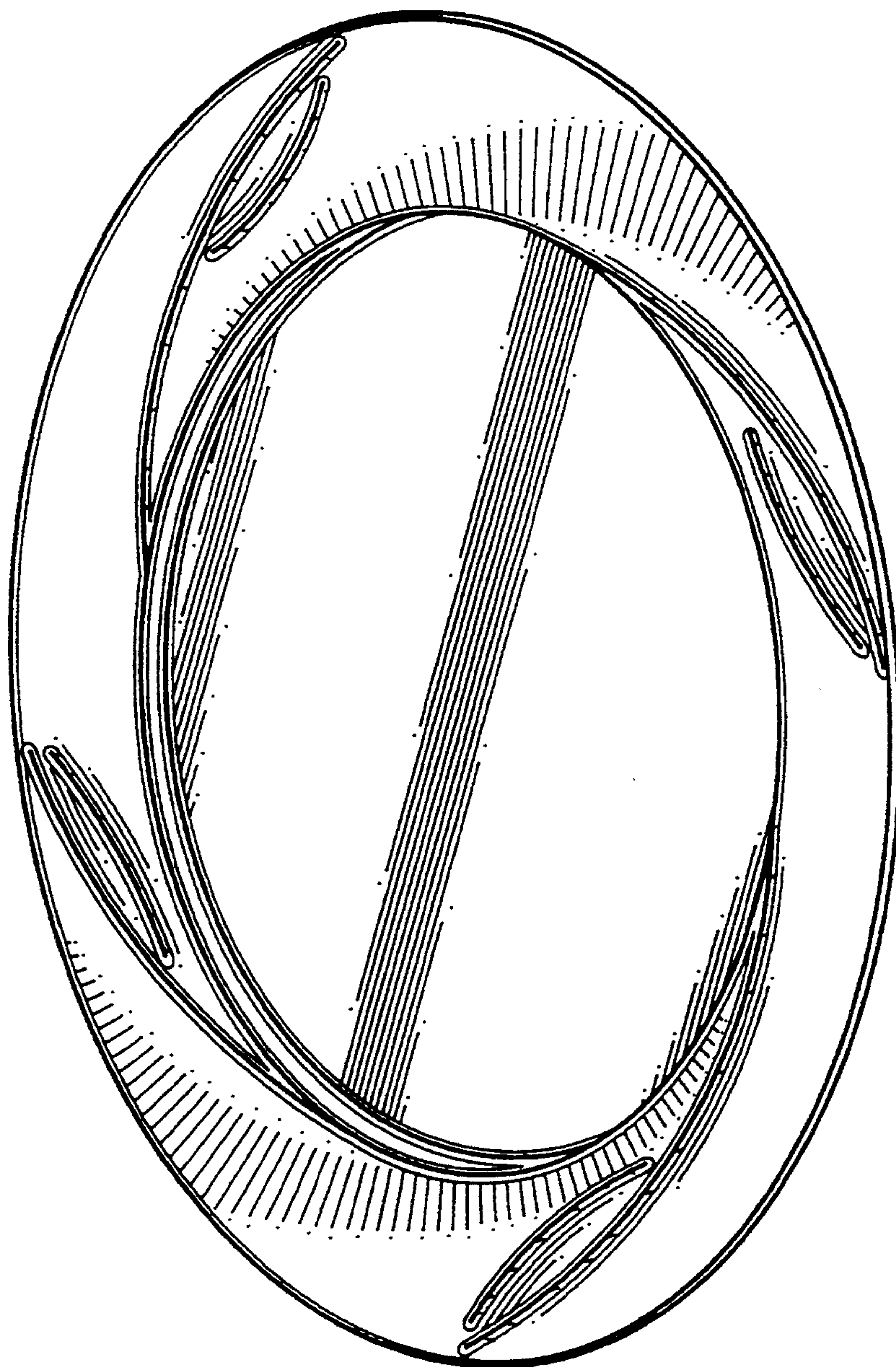

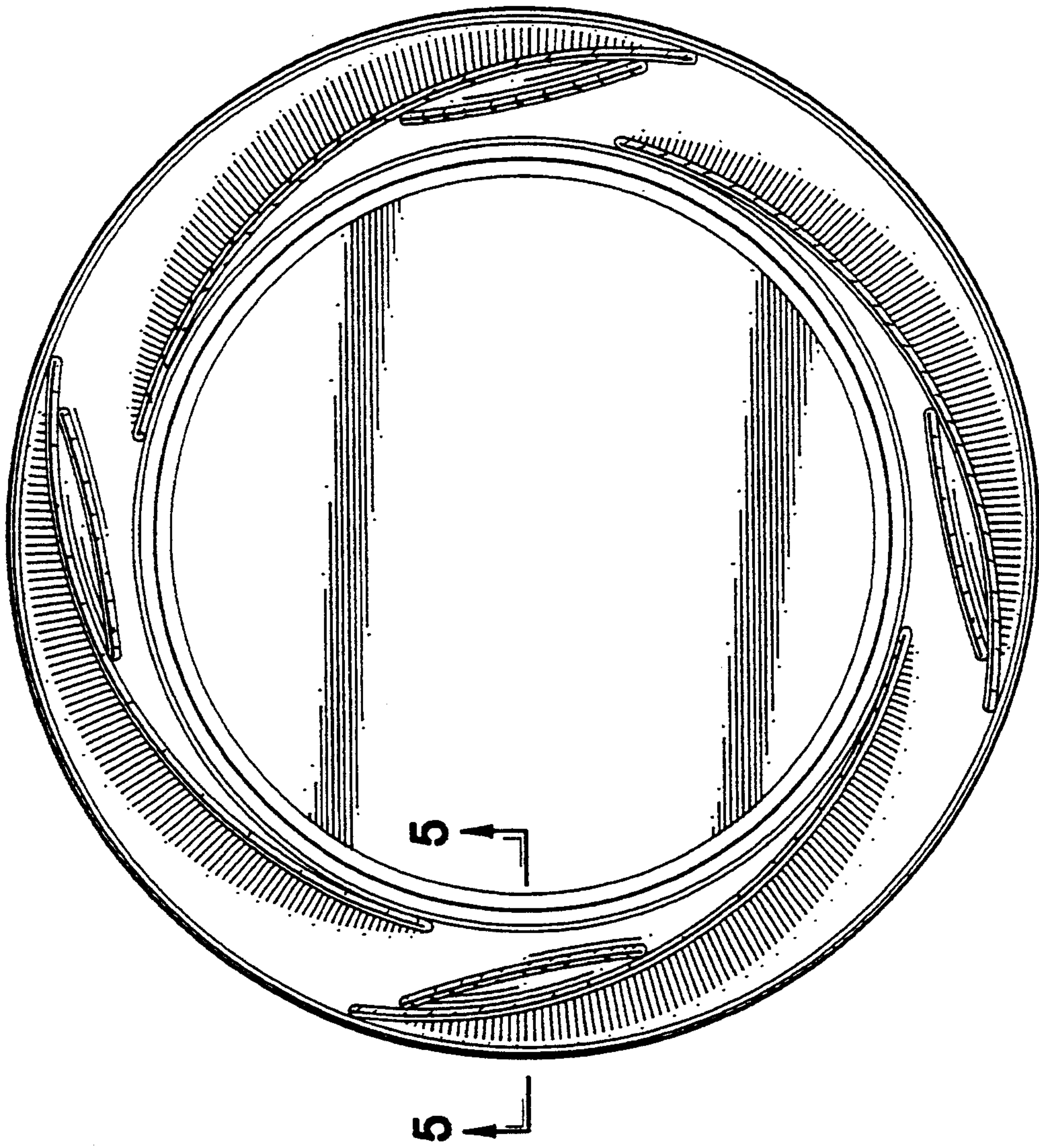

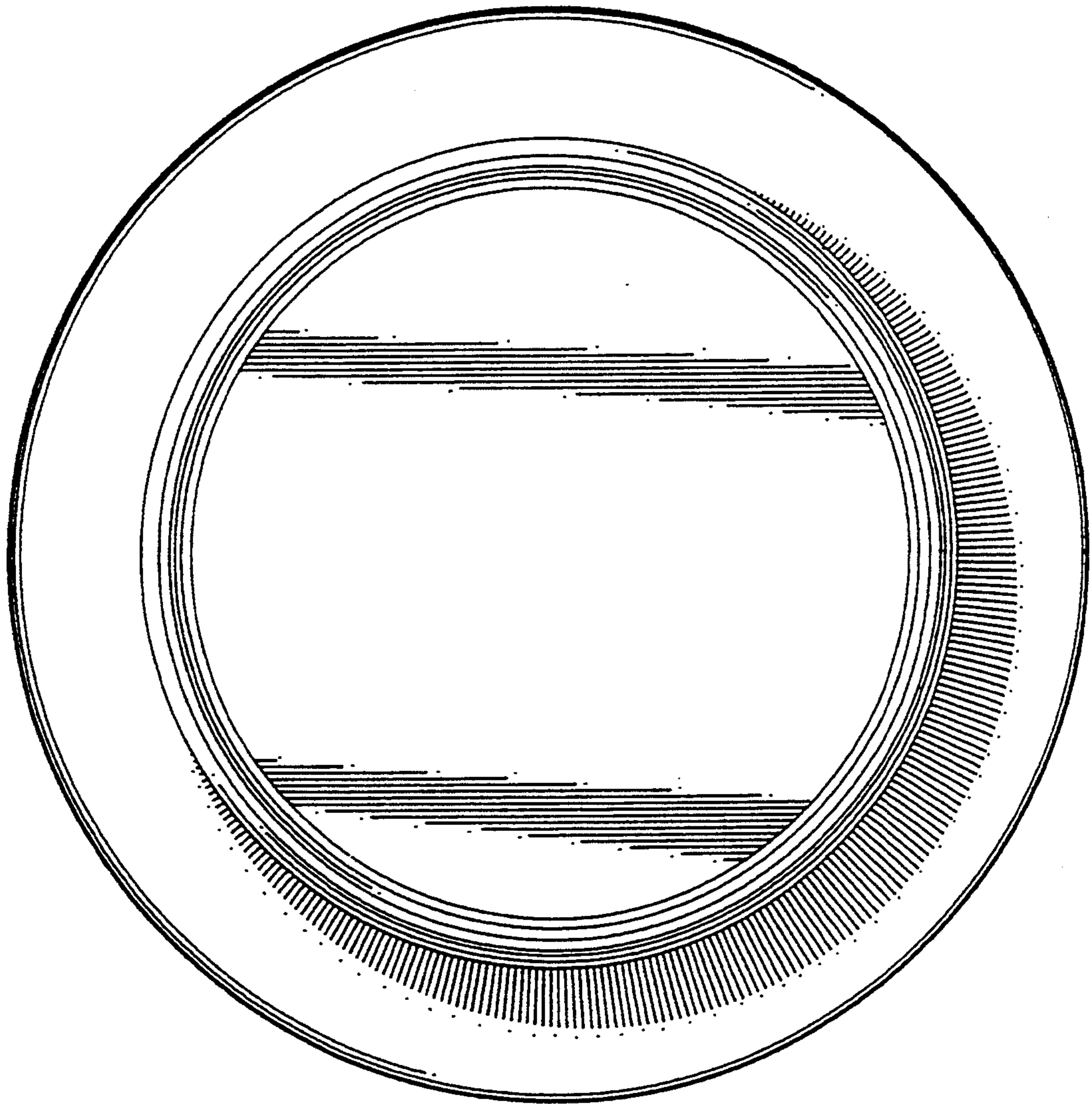

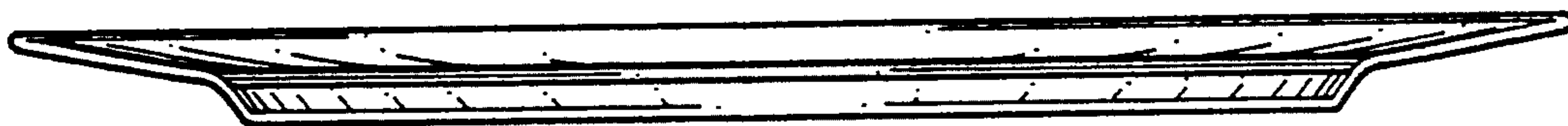

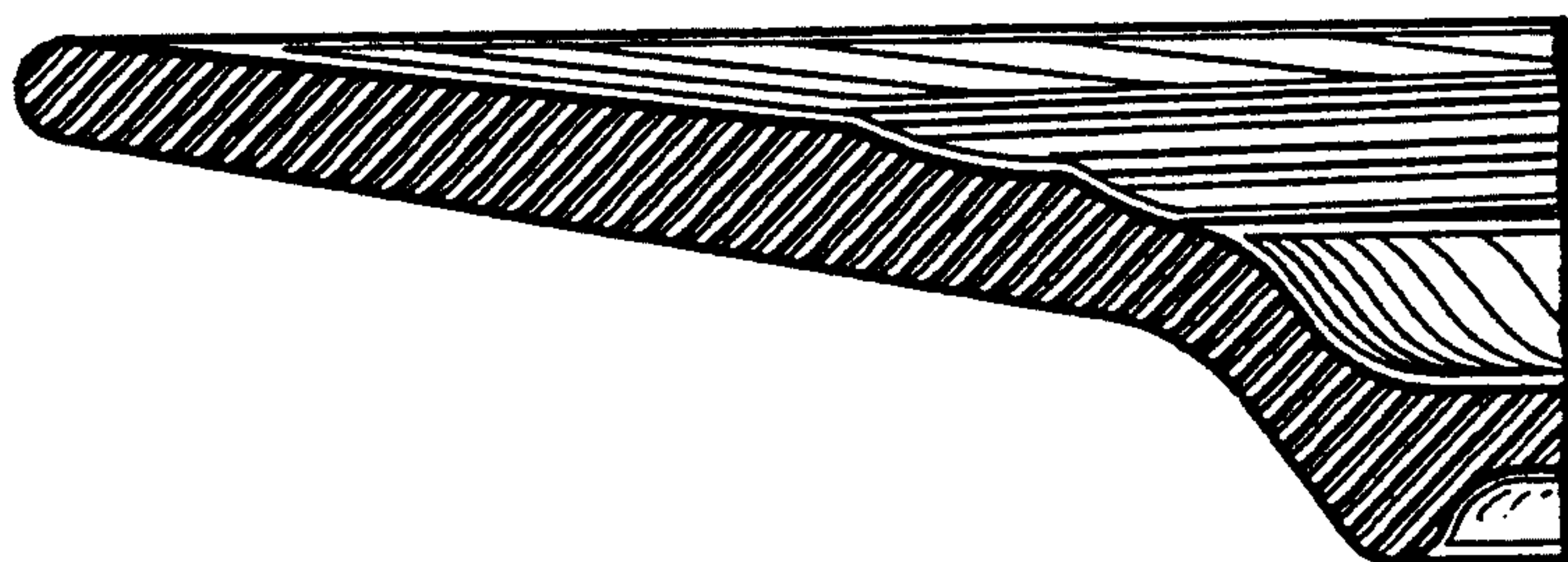

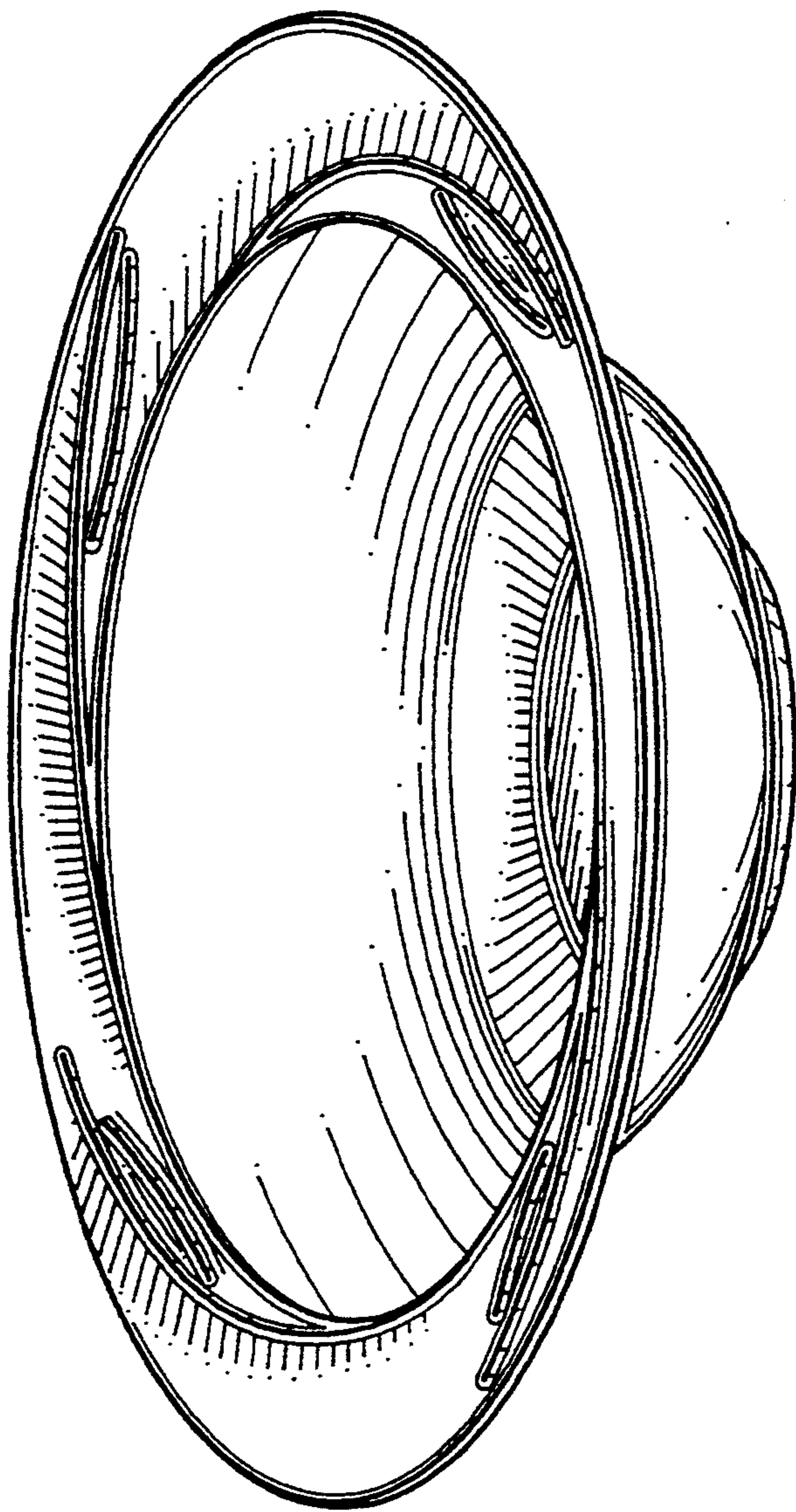

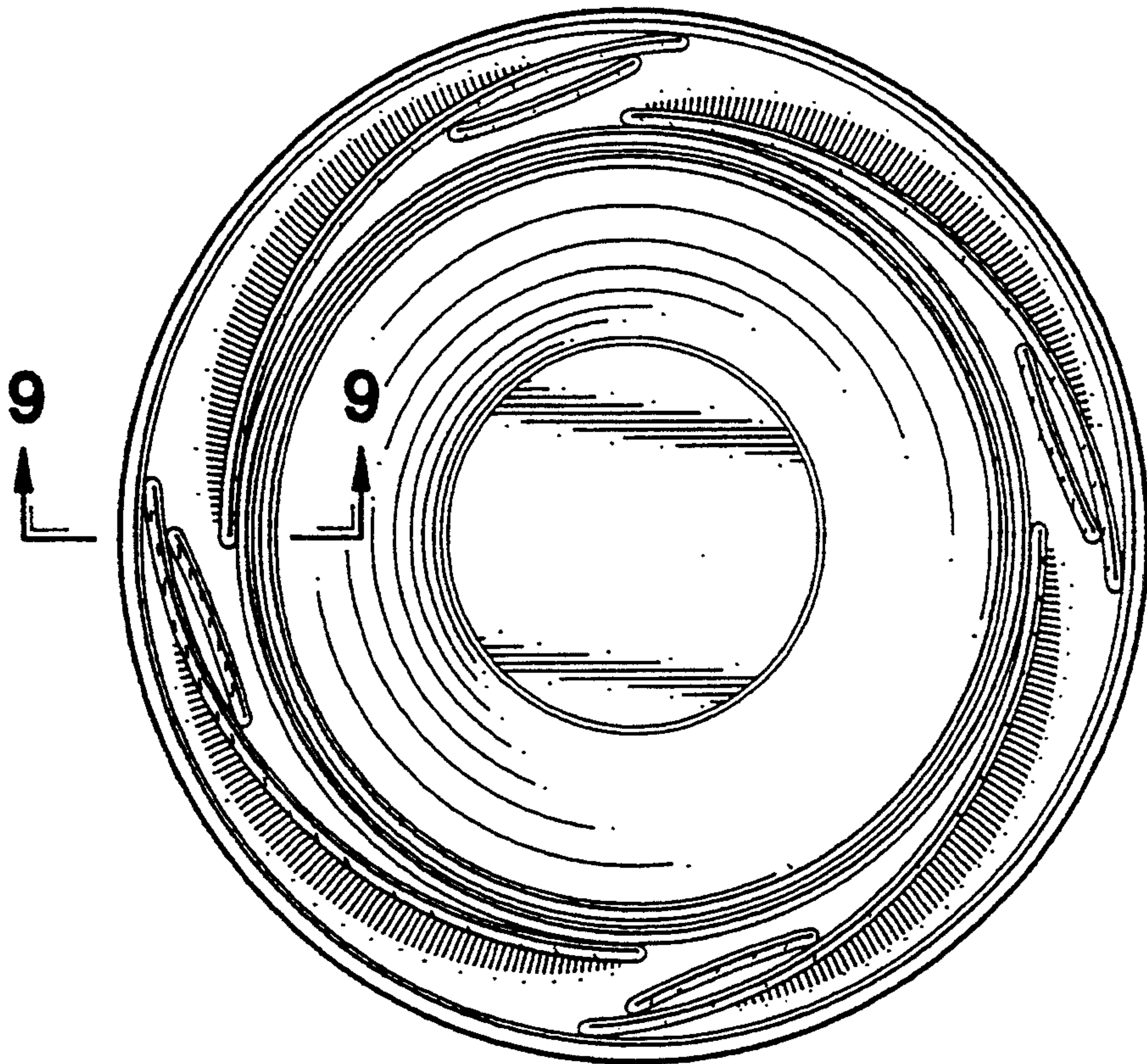

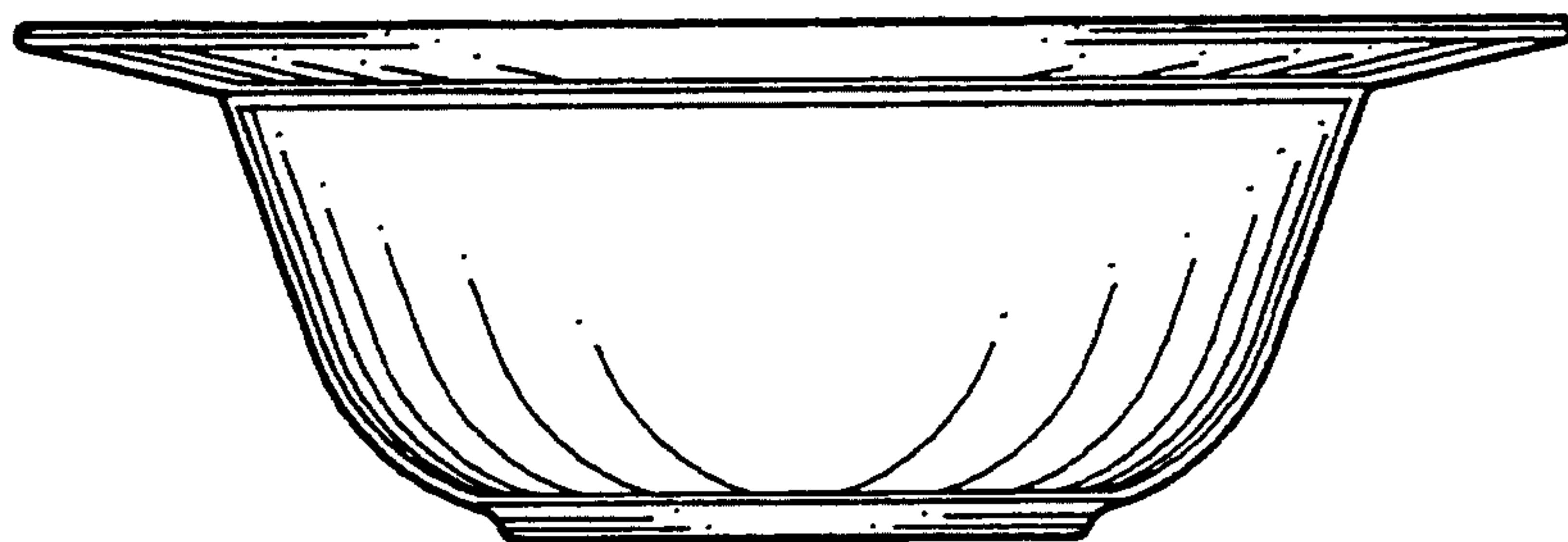

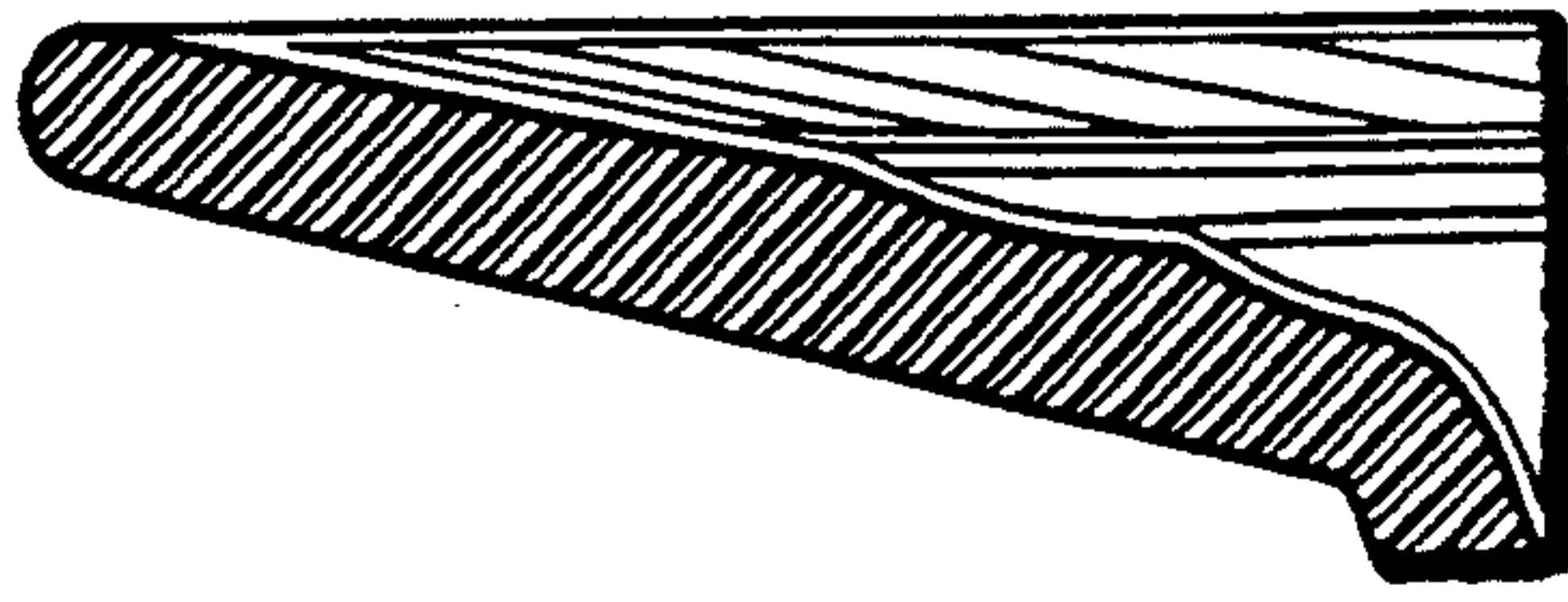

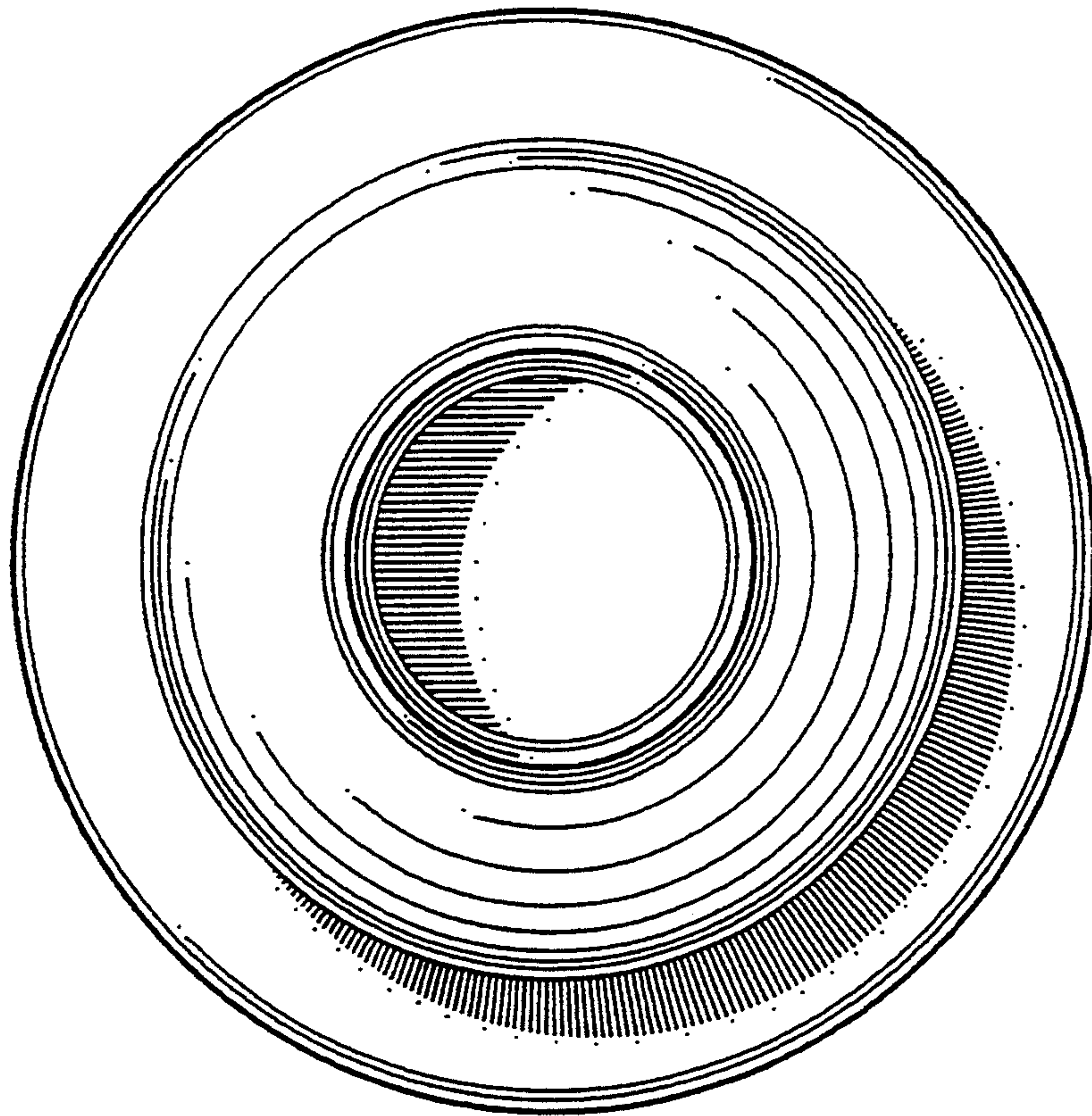
