The ornamental design for a lotion pump head, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of a lotion pump head showing my new design, the broken line drawing of the neck attachment is for illustrative purposes only and forms no part of the claimed design;

FIG. 2 is a top plan view thereof;

FIG. 3 is a right side elevation view thereof;

FIG. 4 is a left side elevation view thereof;

FIG. 5 is a rear elevation view thereof;

FIG. 6 is a front elevation view thereof; and,
