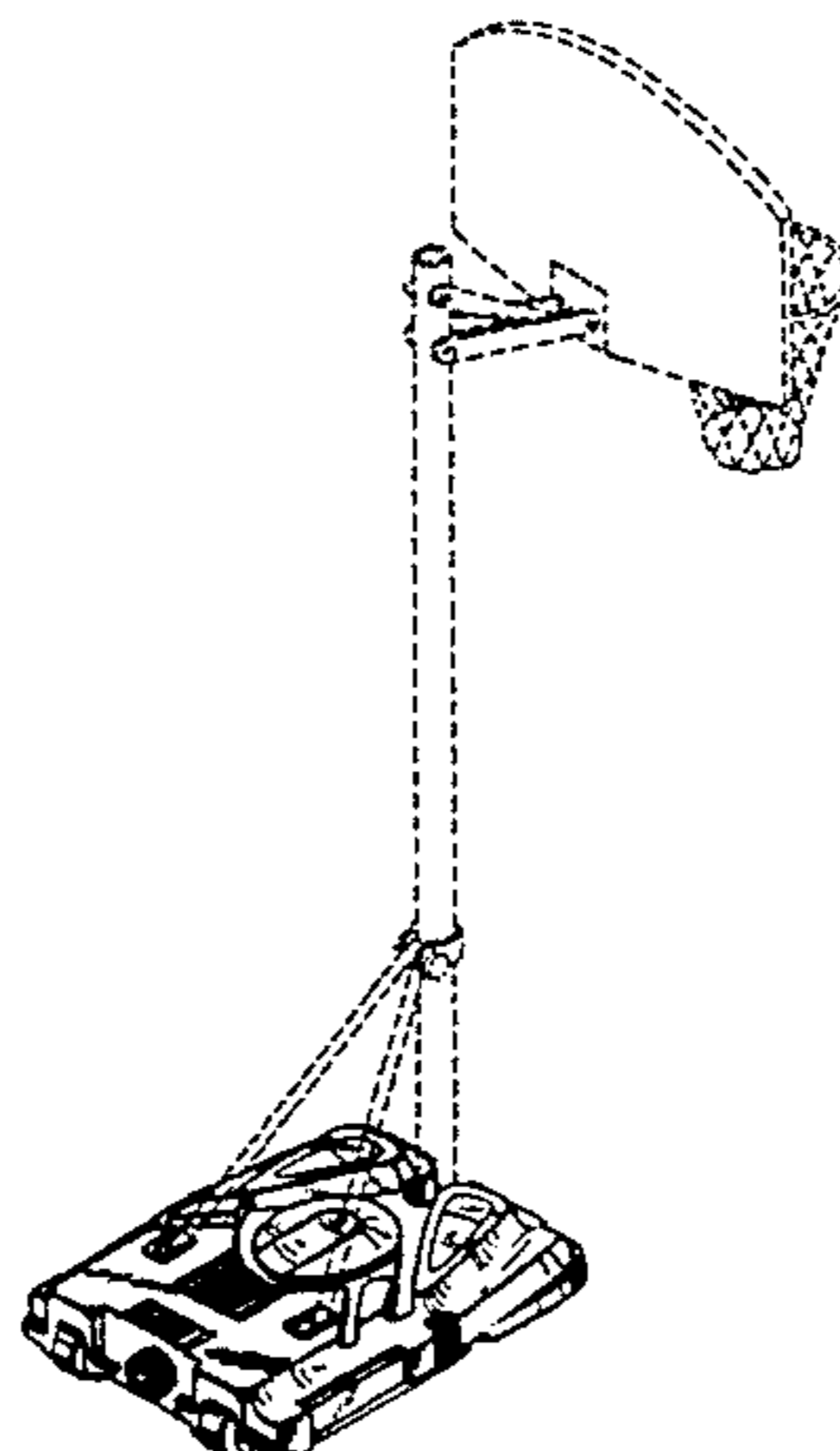

[57] CLAIM

The ornamental design for a base for a basketball goal, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a base for a basketball goal showing our new design;
 FIG. 2 is a top plan view thereof;
 FIG. 3 is a side elevation view thereof;
 FIG. 4 is a front elevation view thereof;
 FIG. 5 is a rear elevation view thereof; and,
 FIG. 6 is a bottom plan view thereof.
 The broken lines are for illustrative purposes only and form no part of the claimed design.

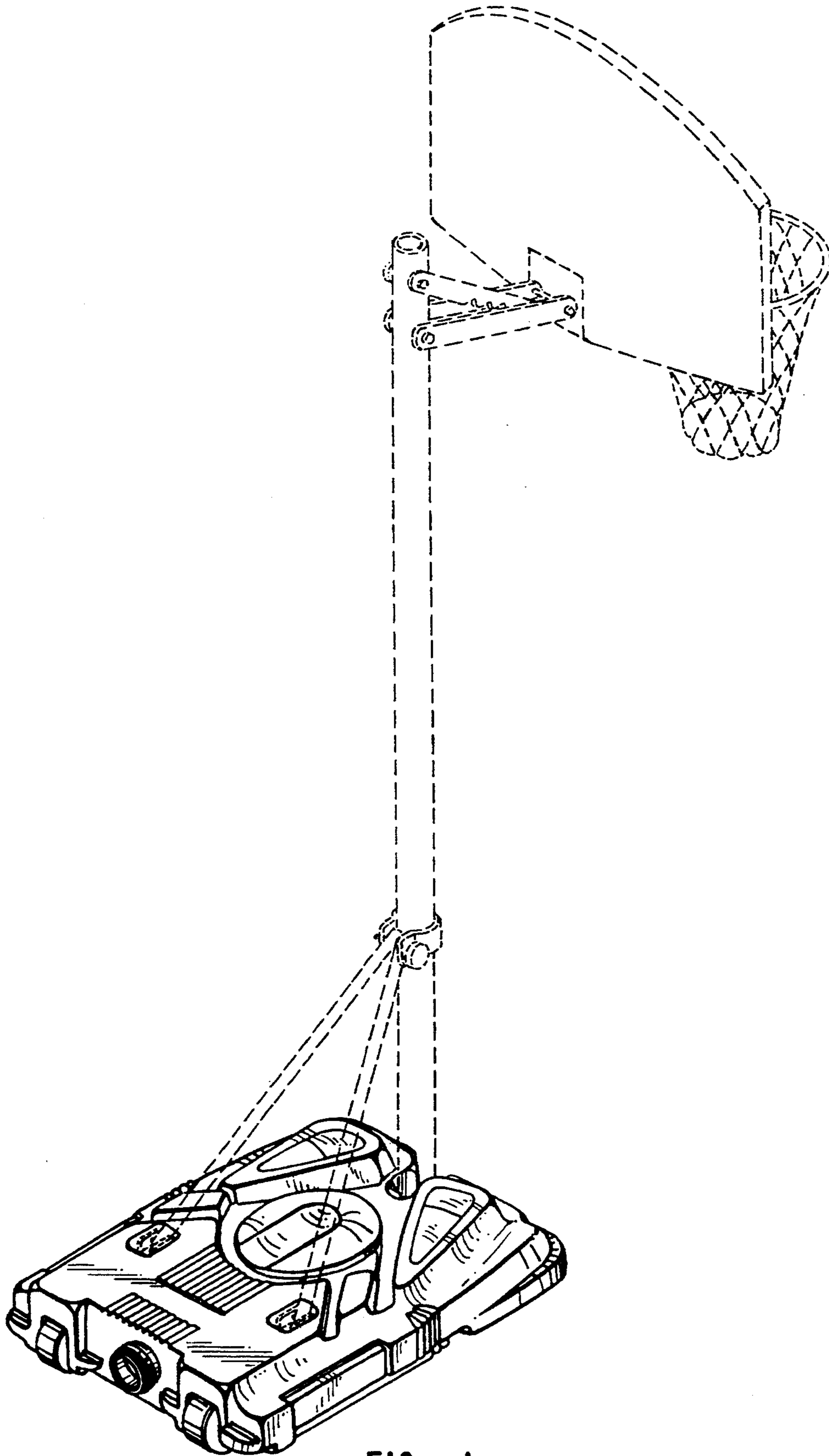

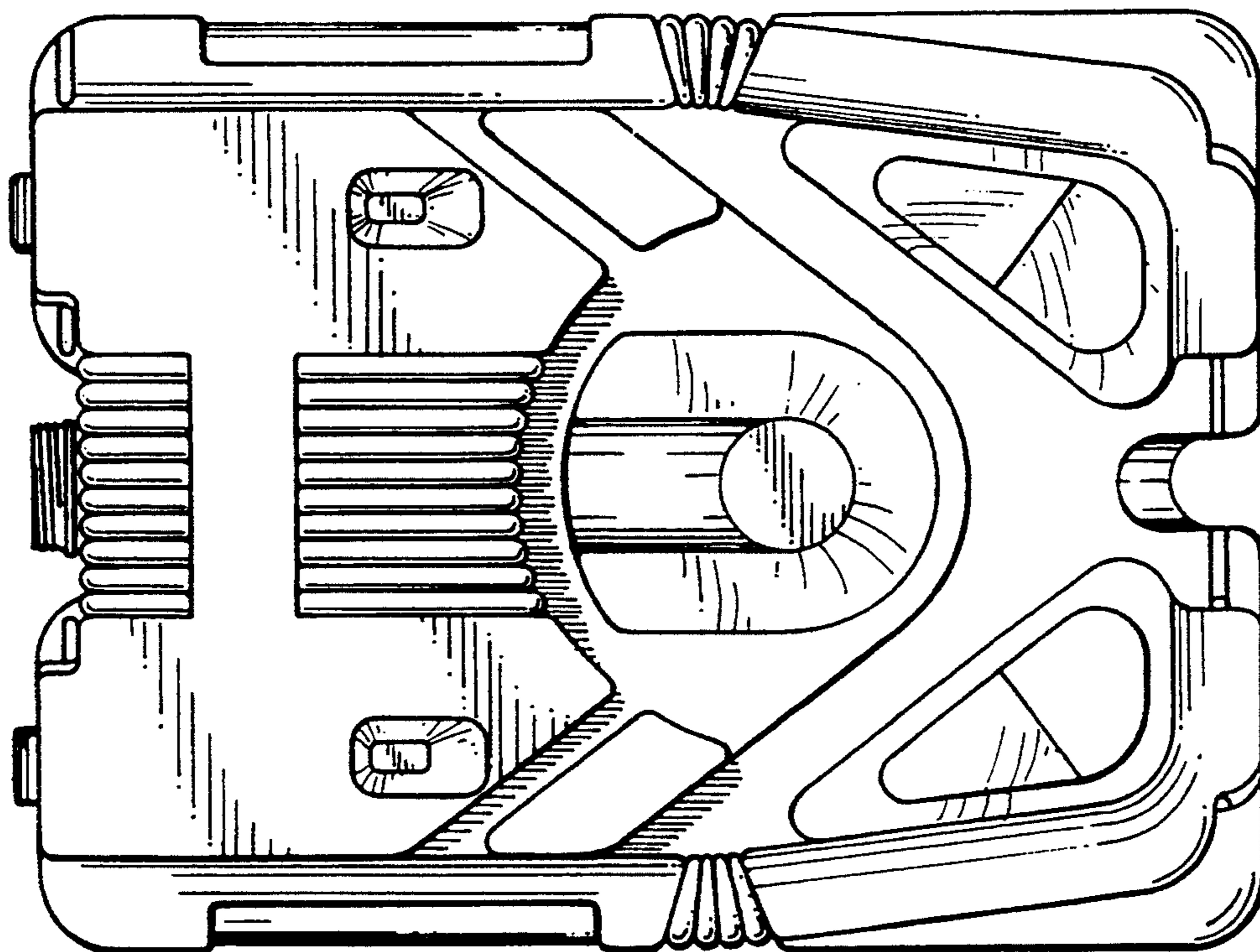

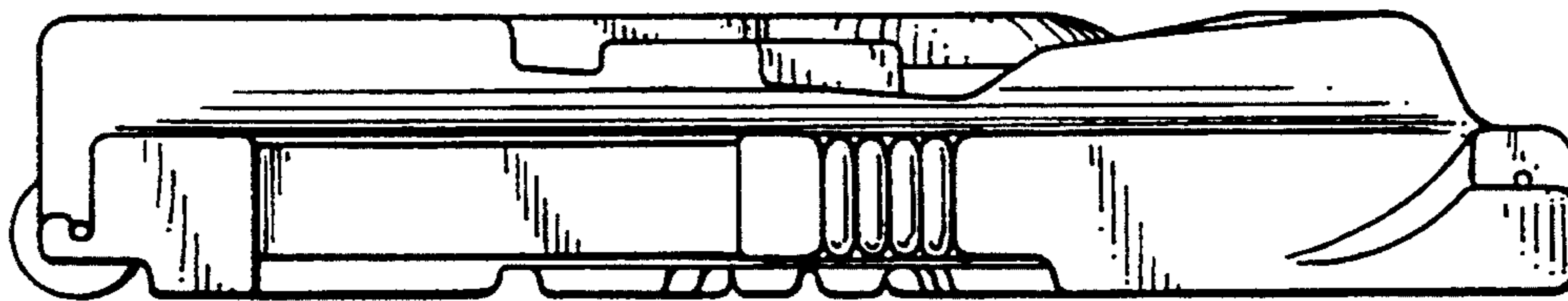

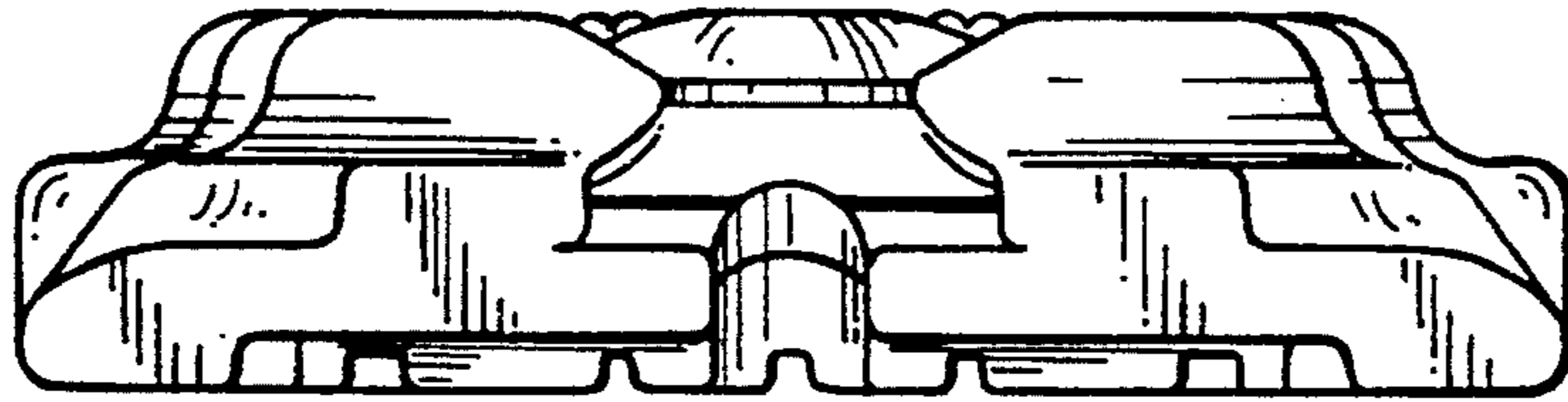

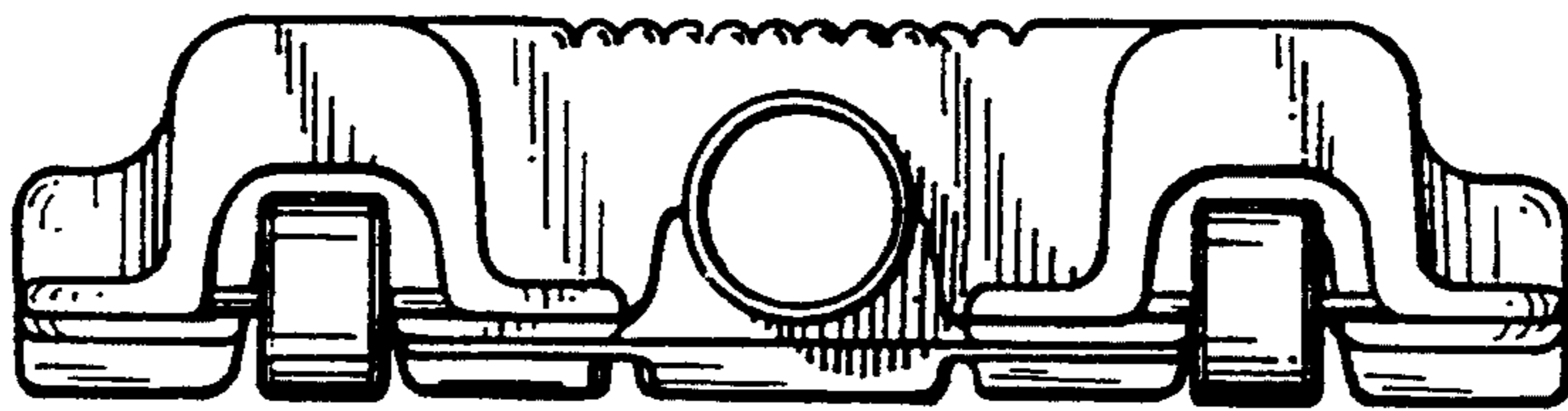

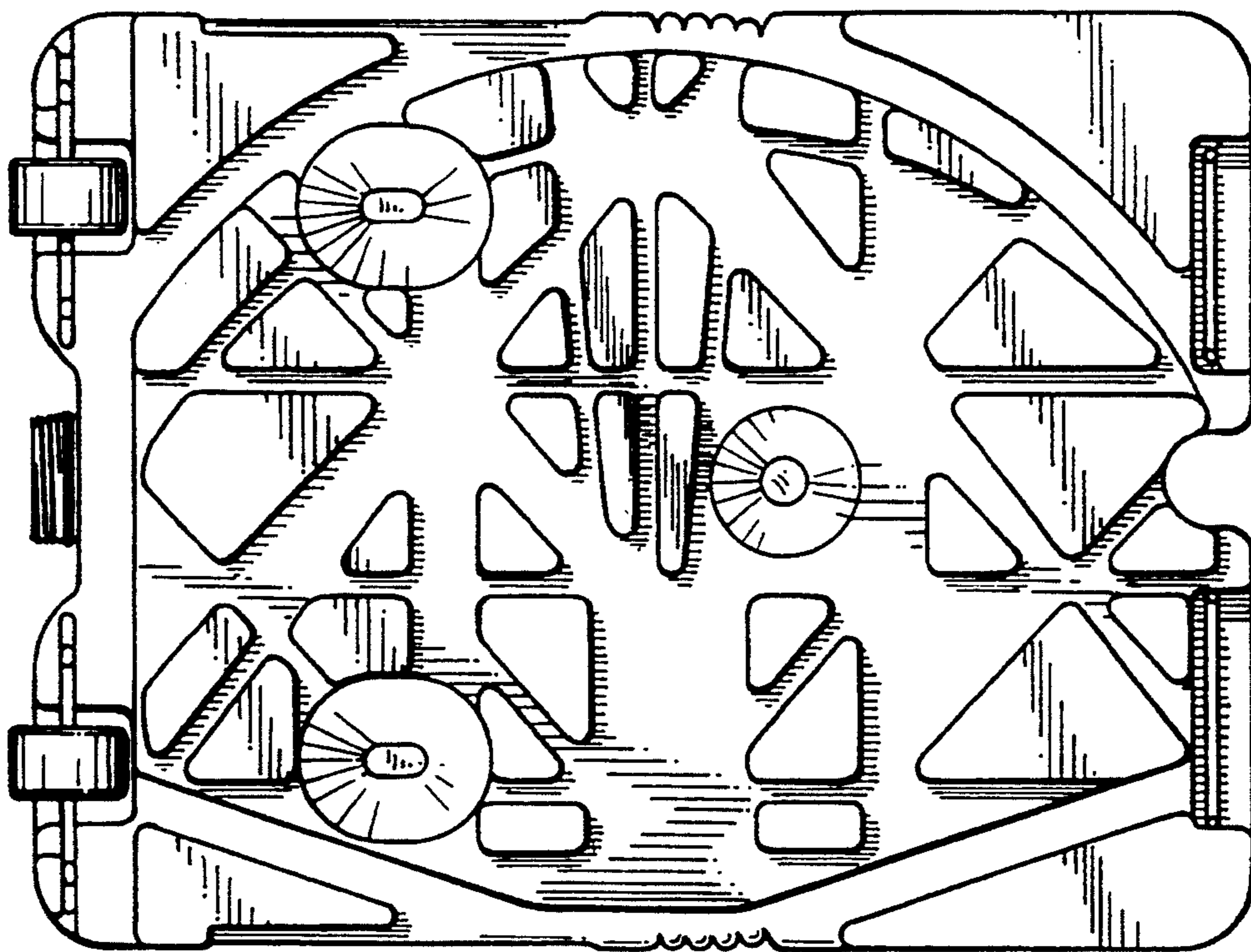
