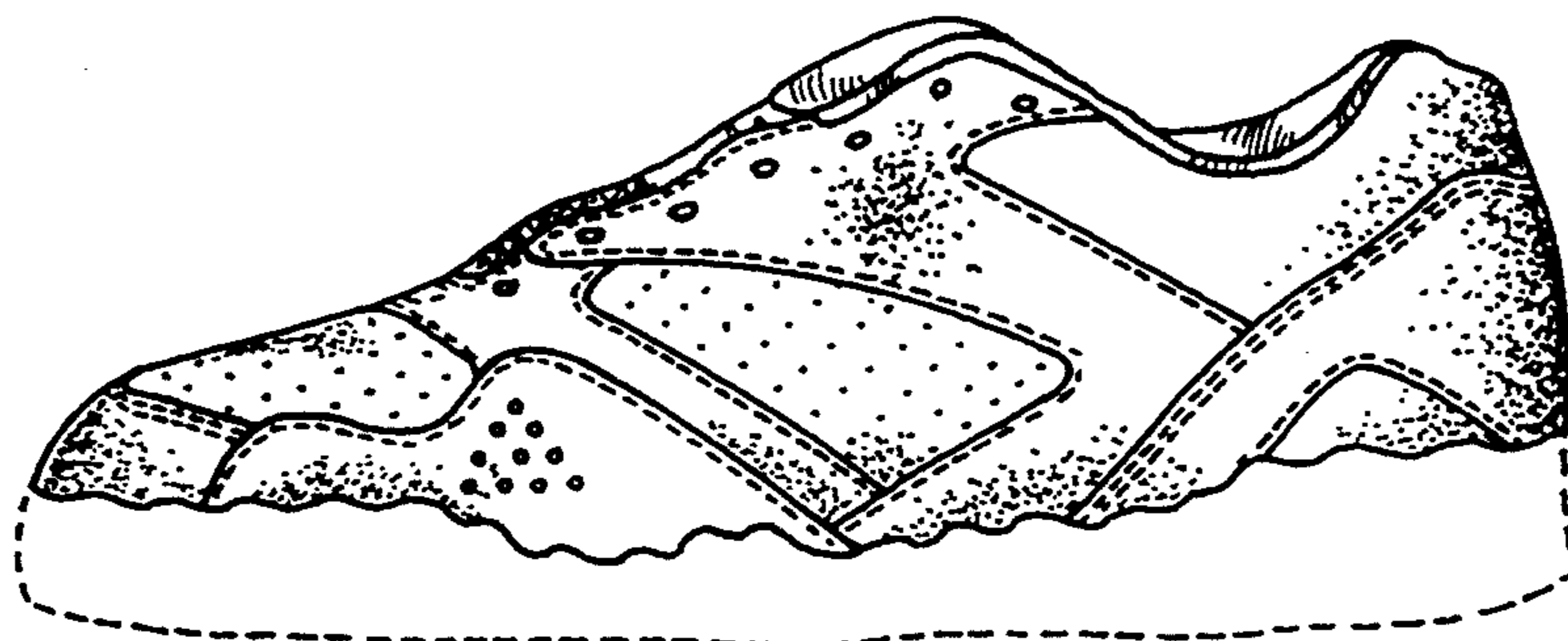
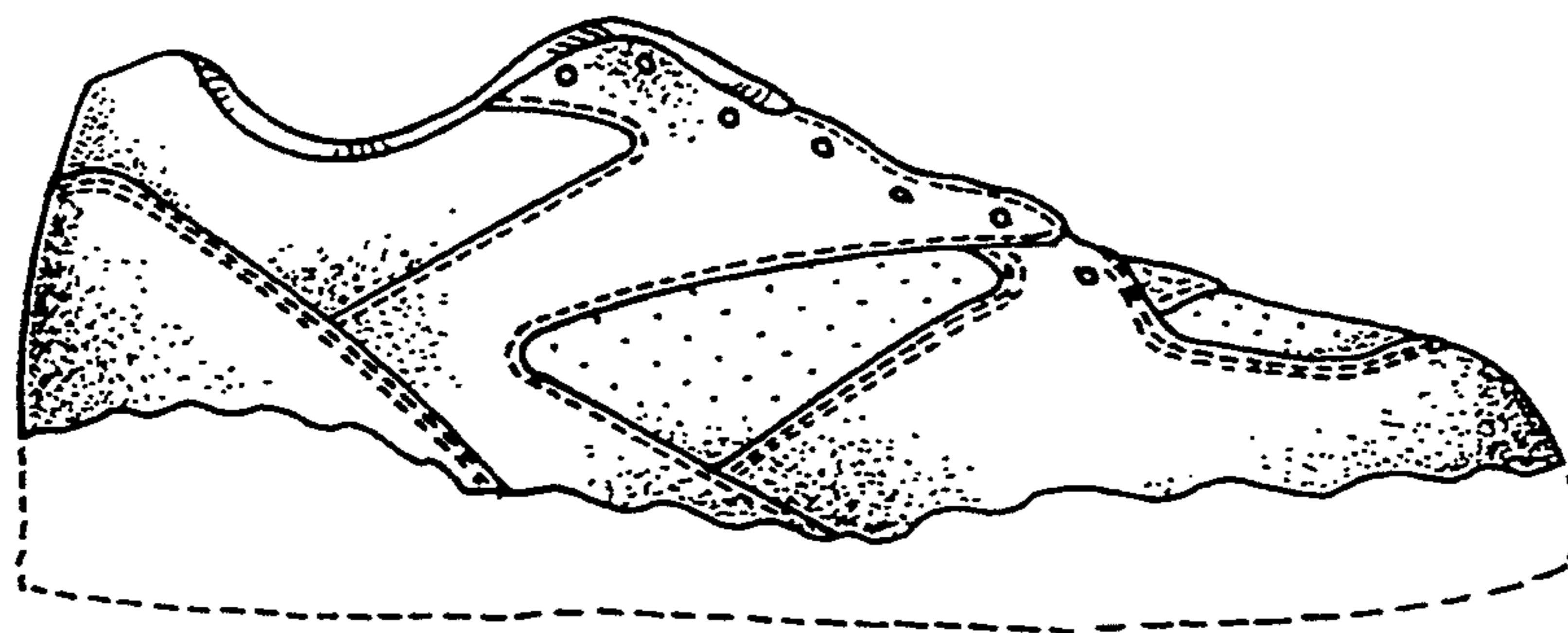

DESCRIPTION

FIG. 1 is left side elevational view of a shoe upper showing our new design;

 FIG. 10 is a rear elevational view thereof.



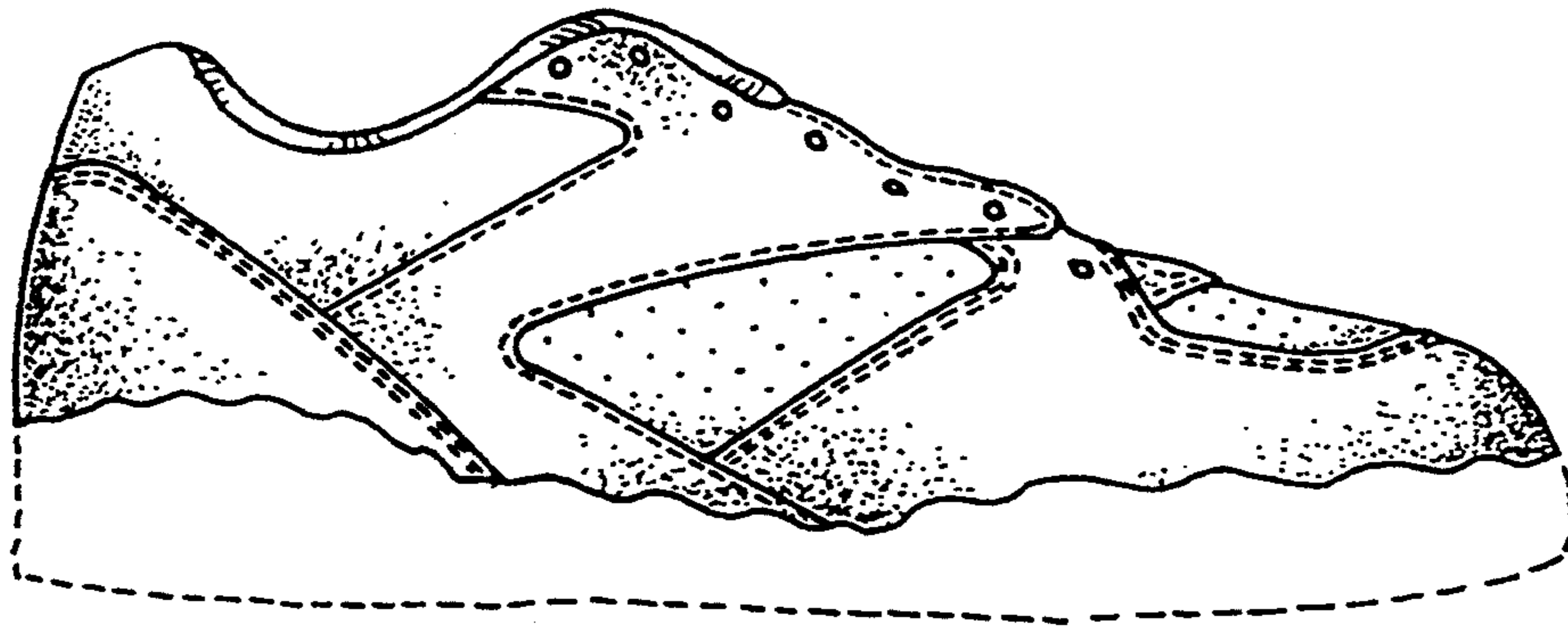

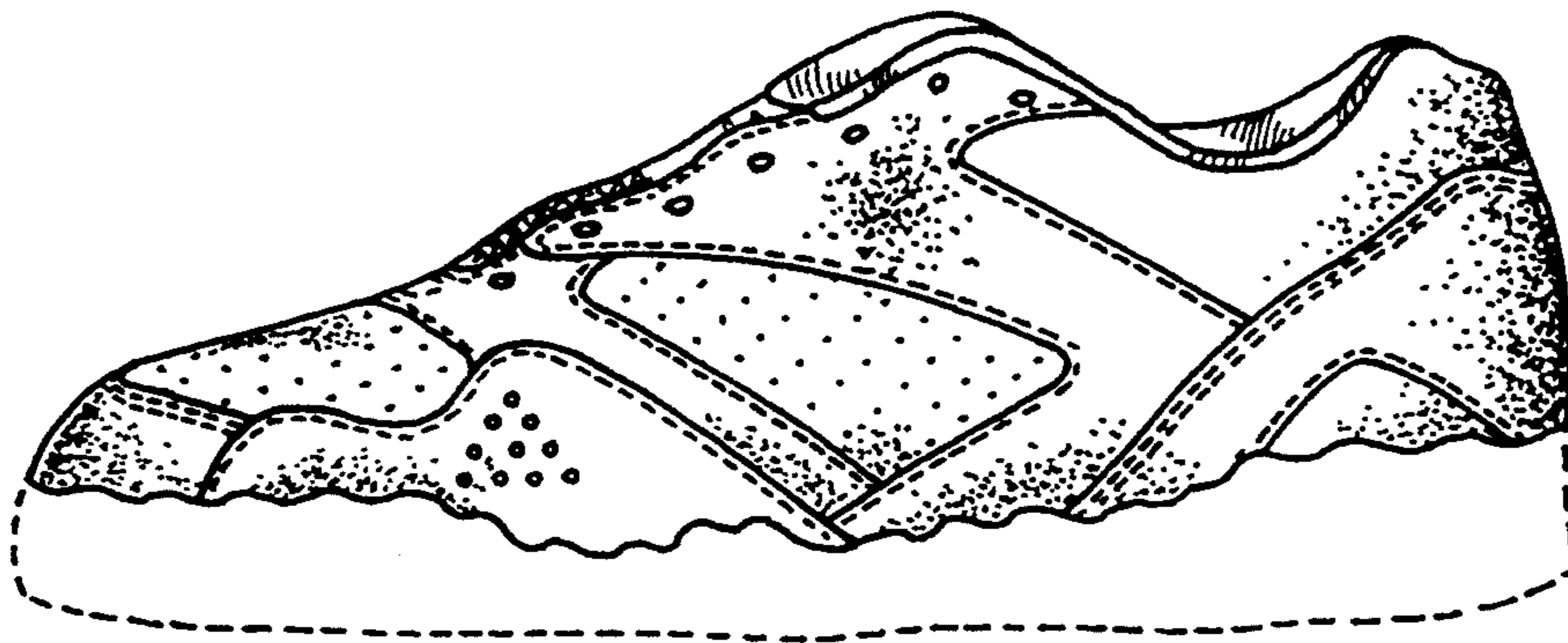

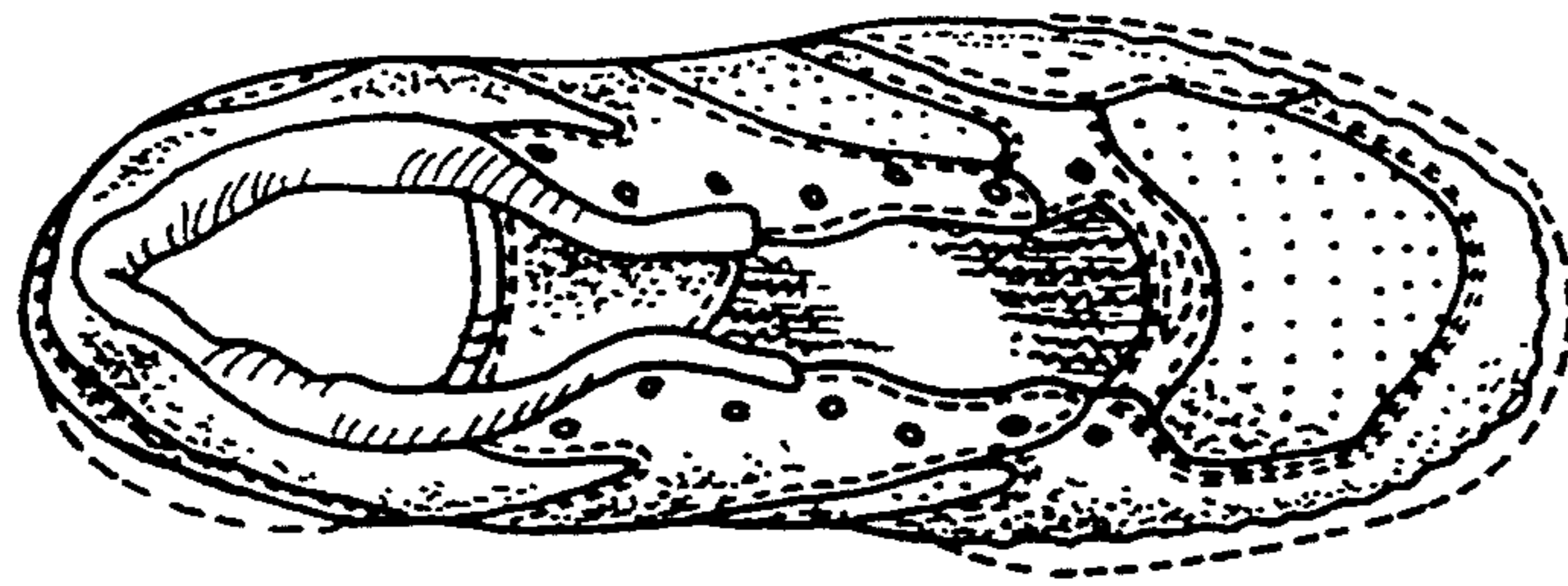

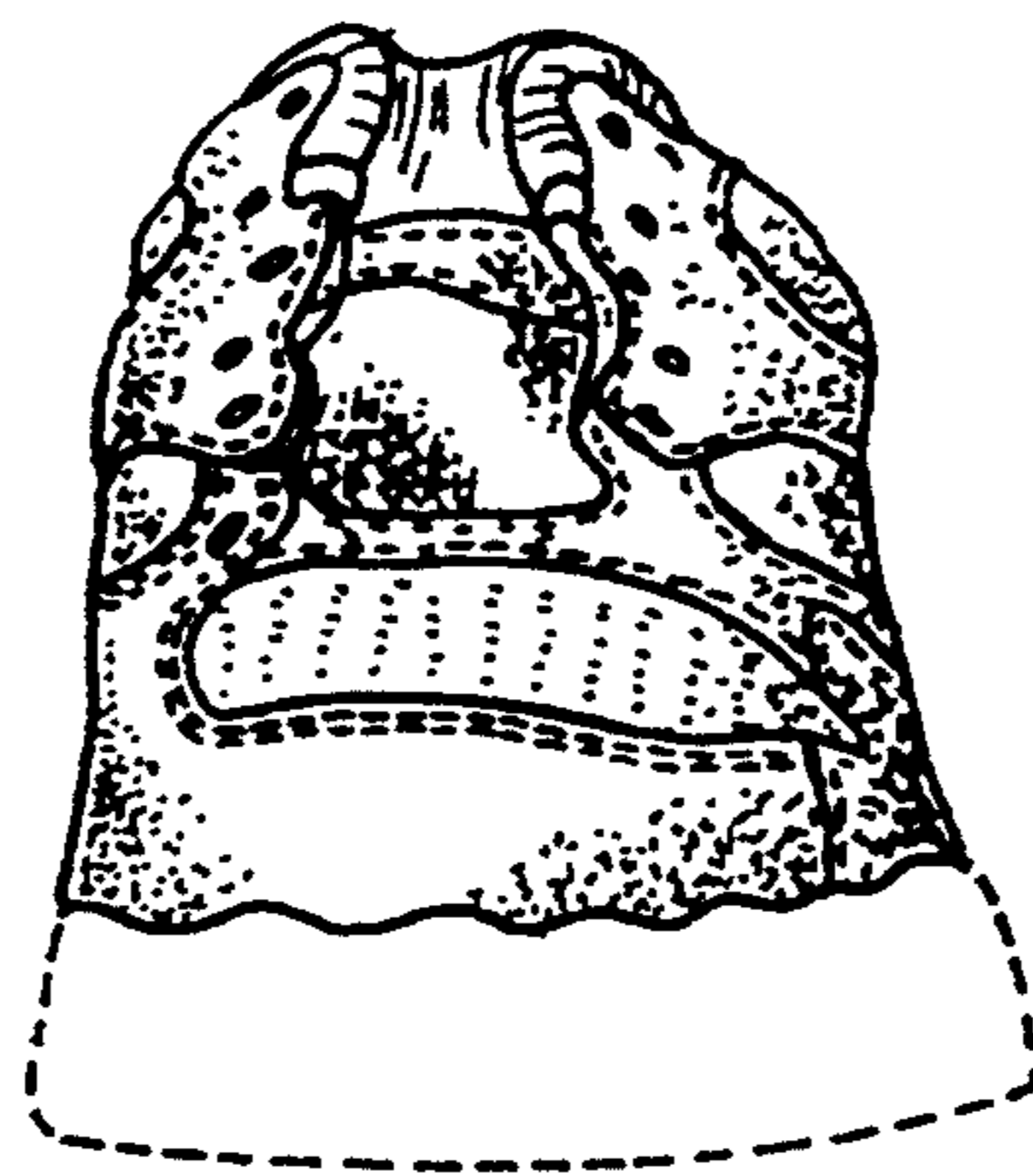

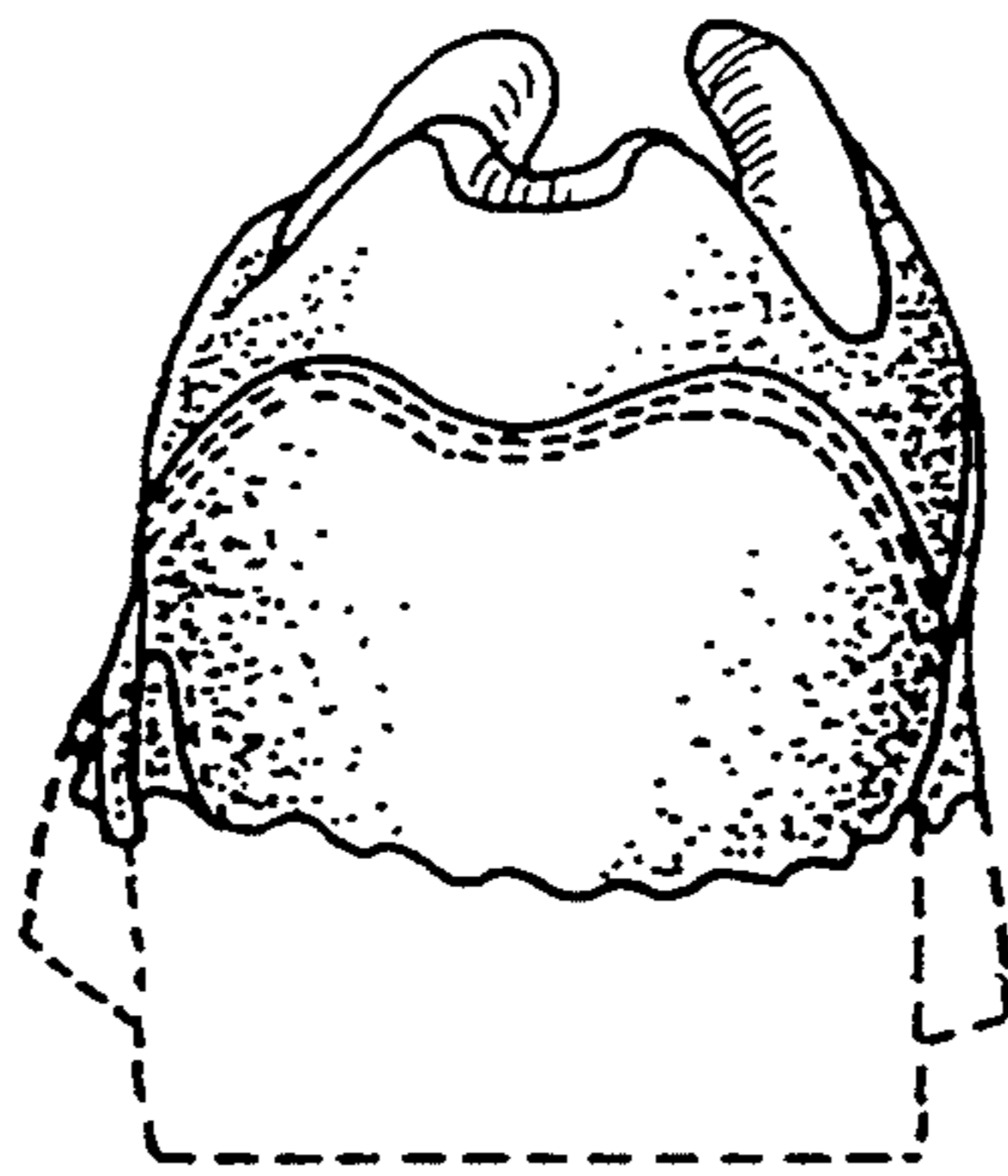

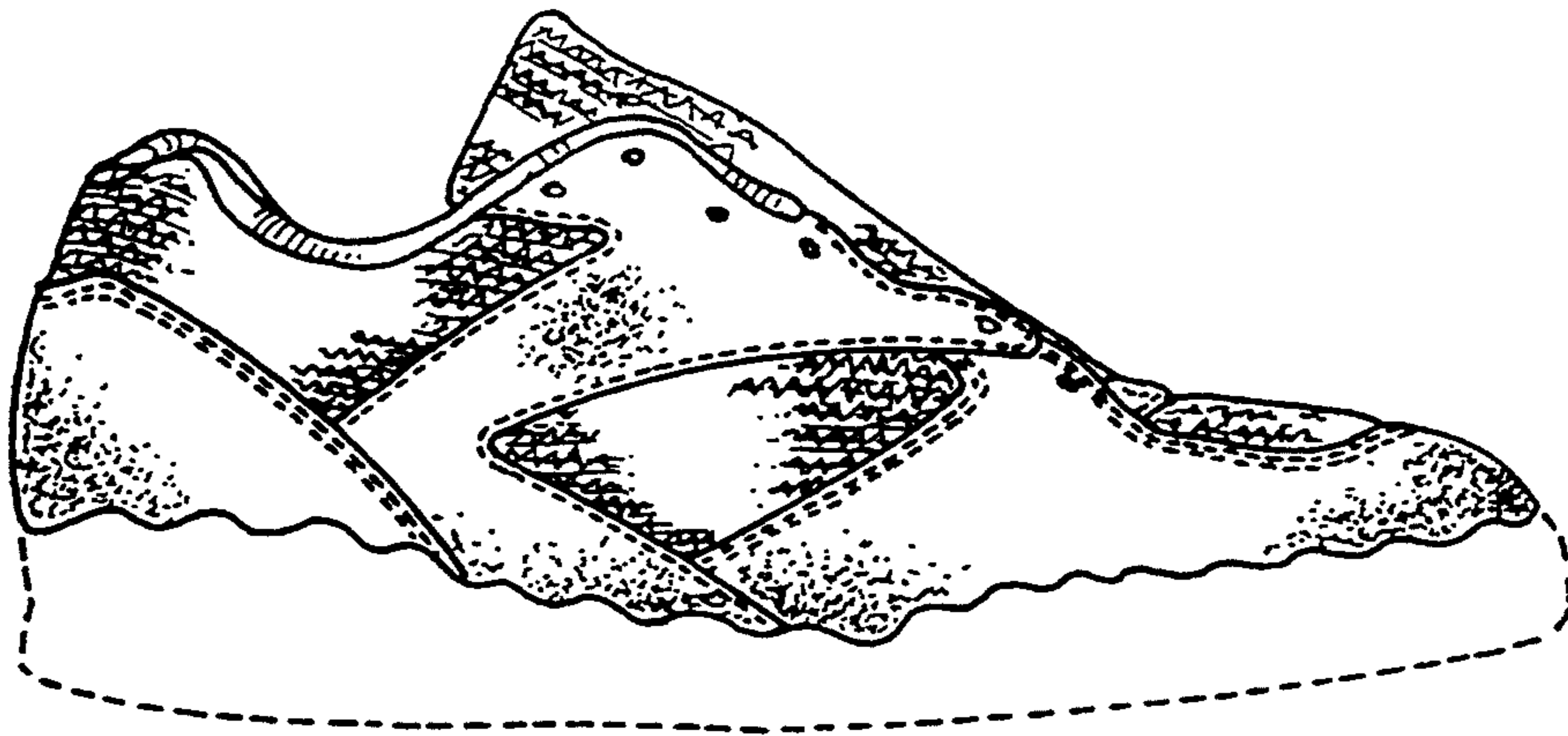

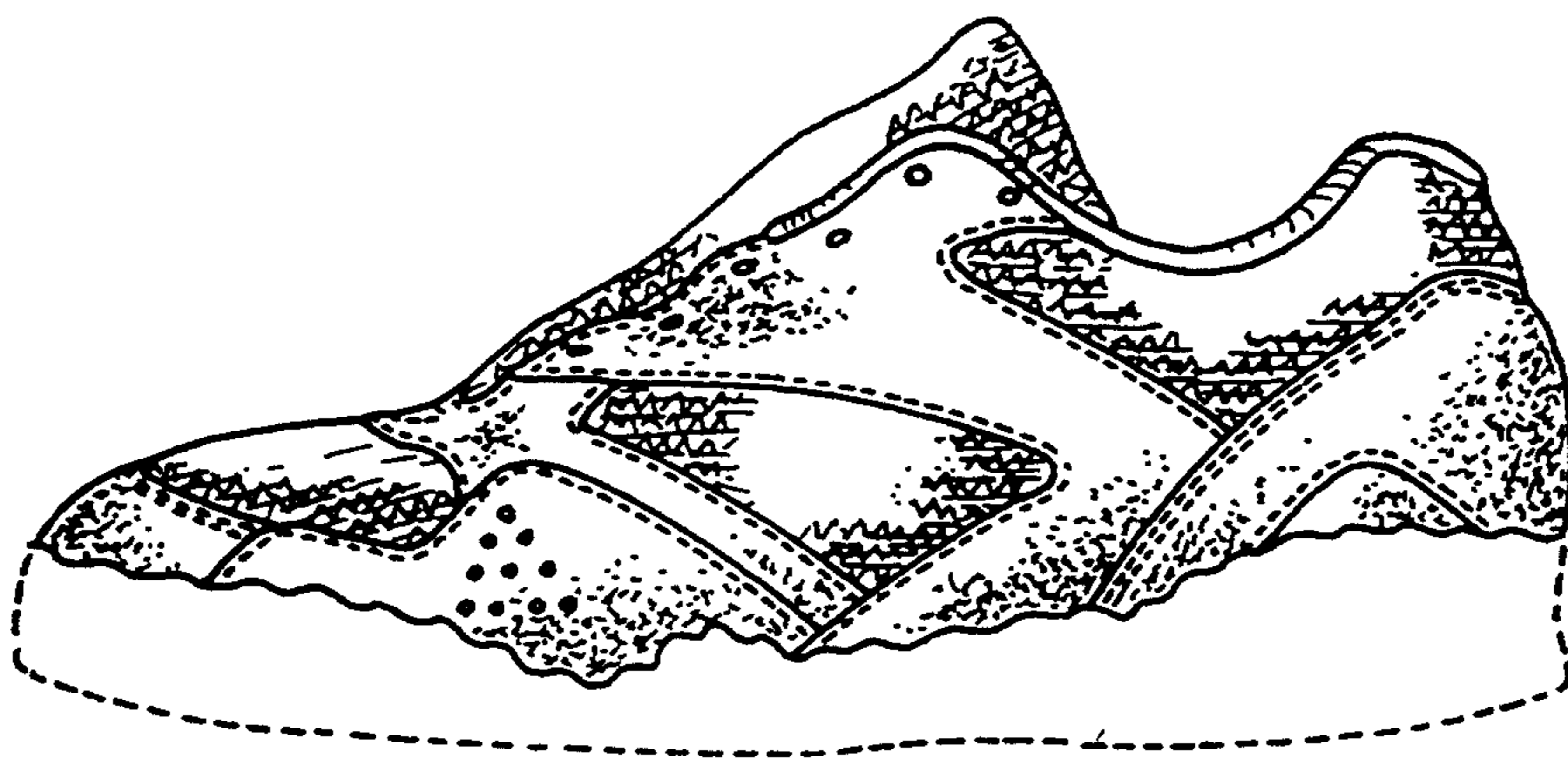

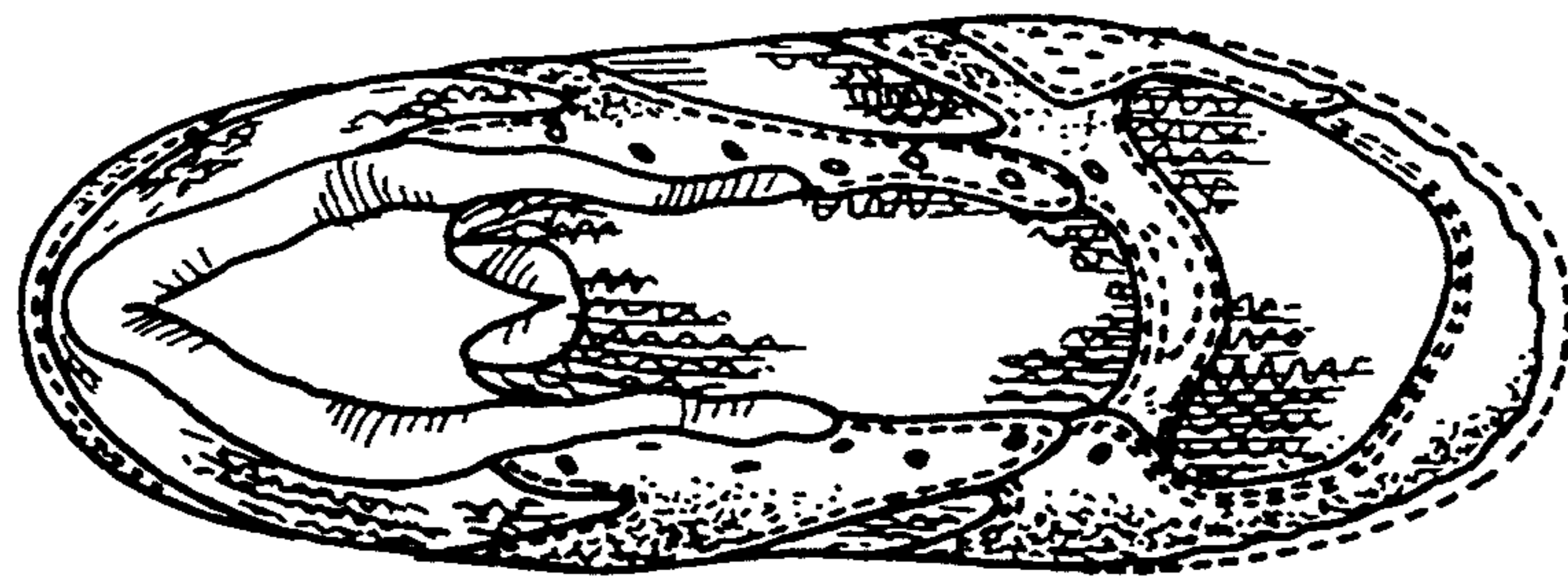

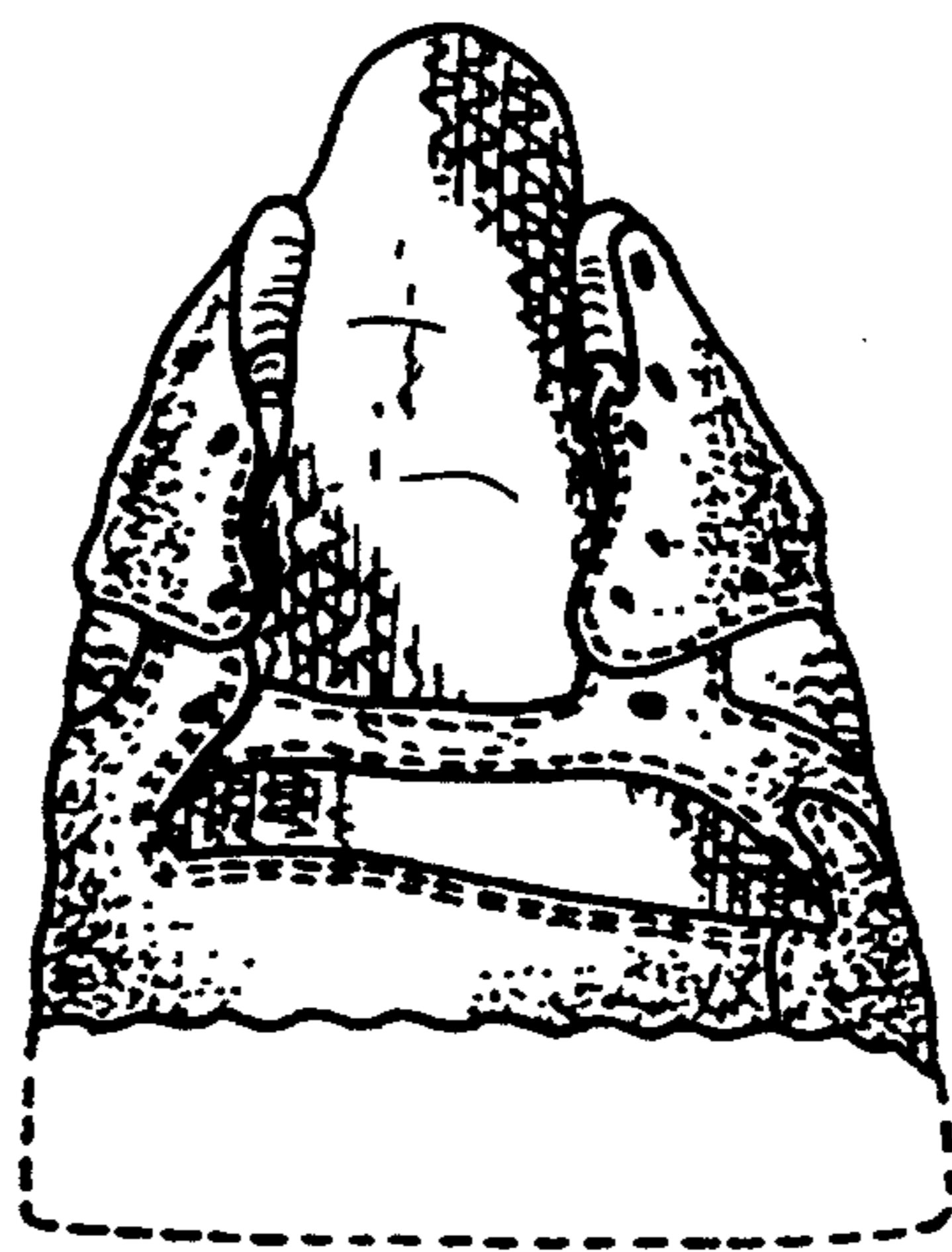

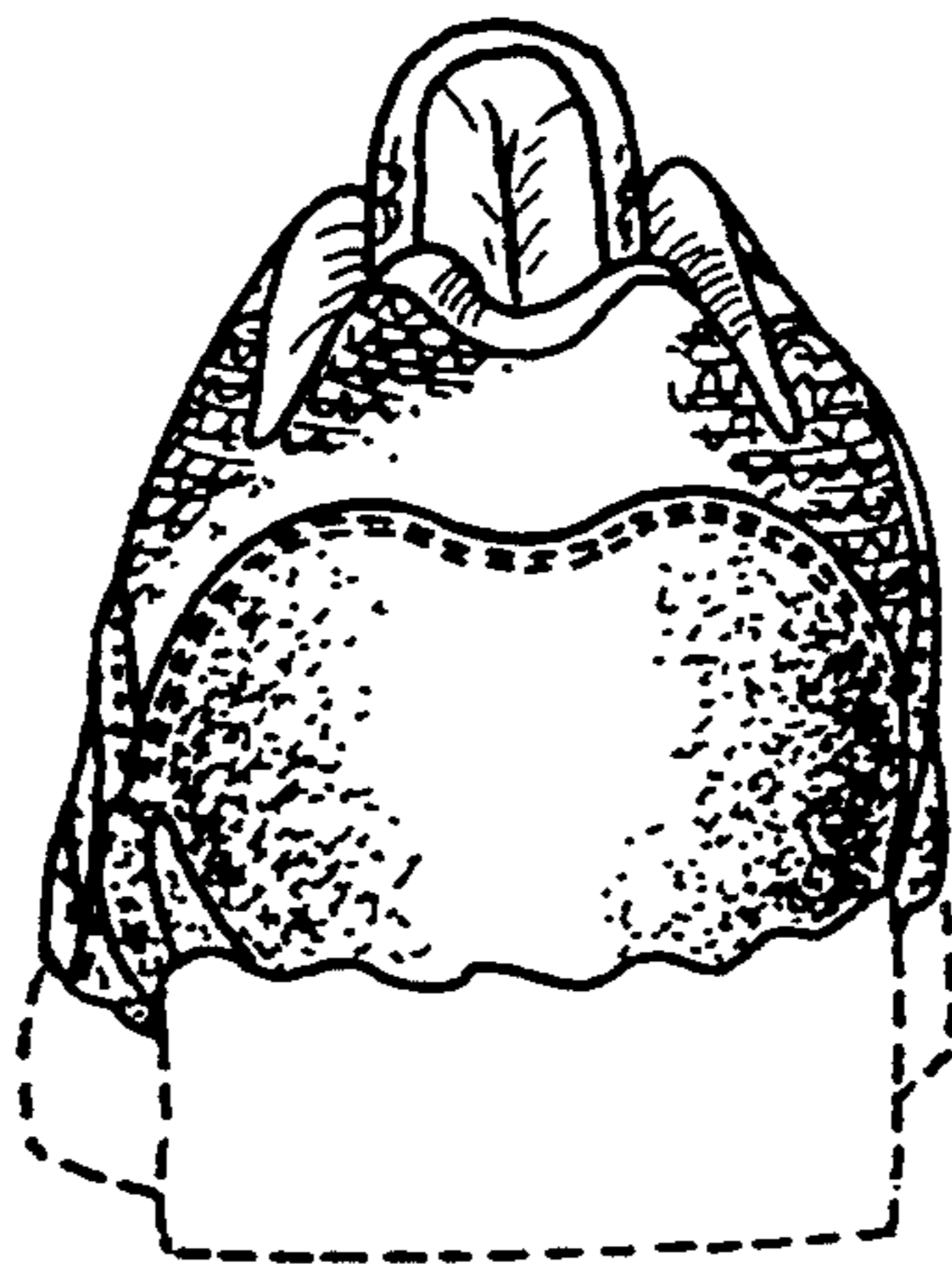
