DESCRIPTION

FIG. 1 is a front elevational view of a combined eyeglass case and wallet showing my new design;

FIG. 2 is a top plan view;

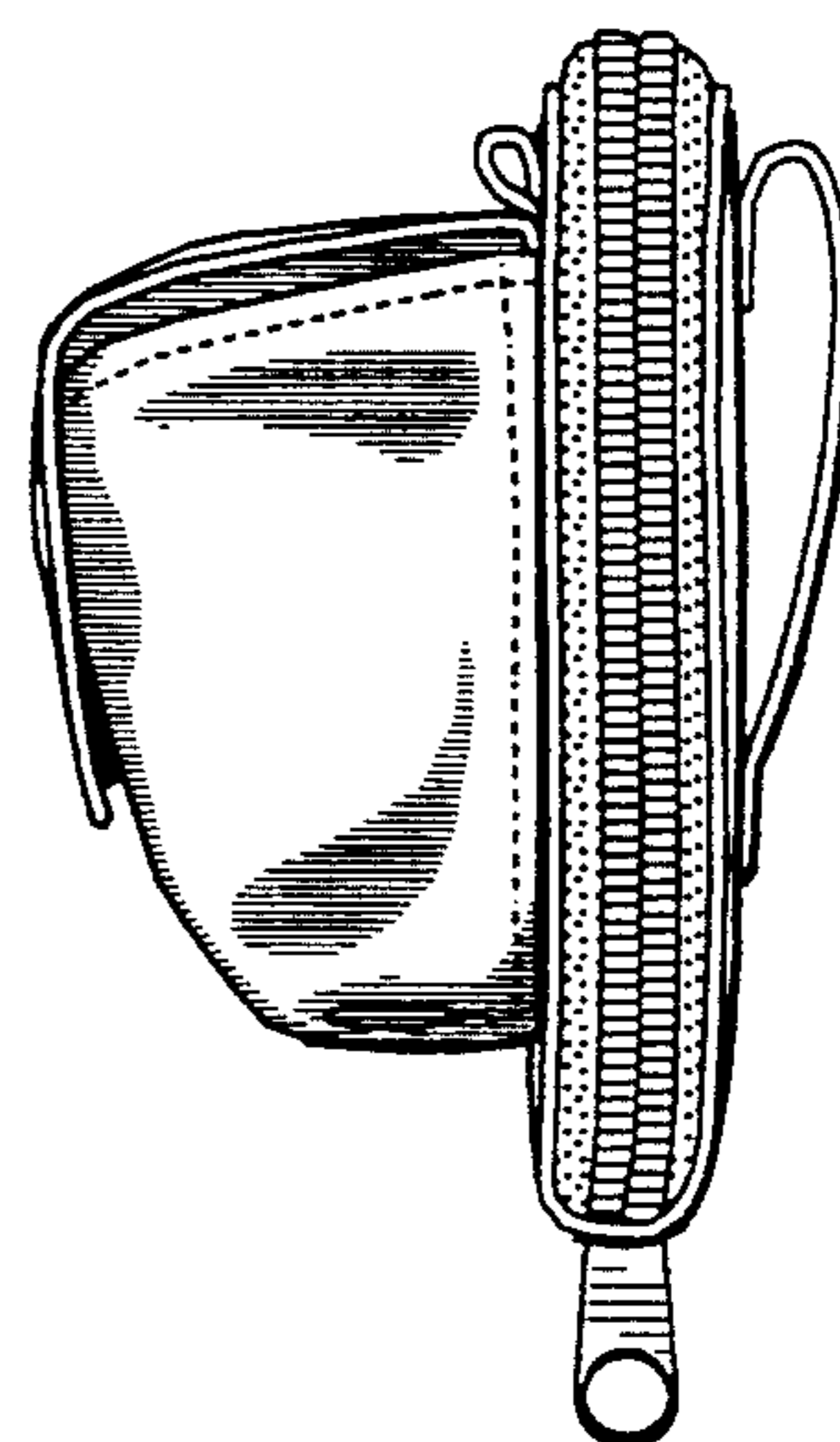
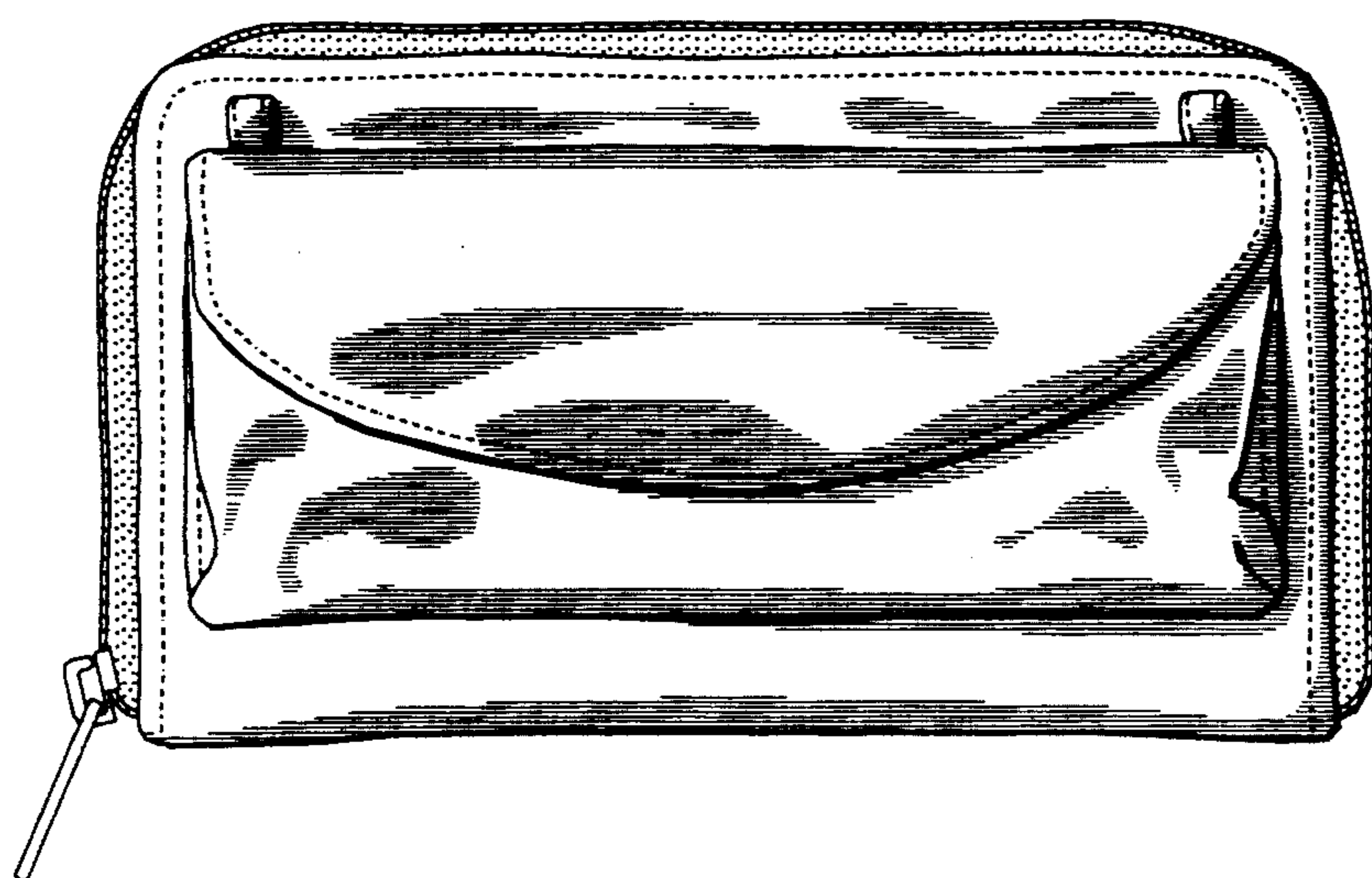
FIG. 3 is a rear elevational view;

The broken lines shown throughout the views are understood to represent conventional stitching.



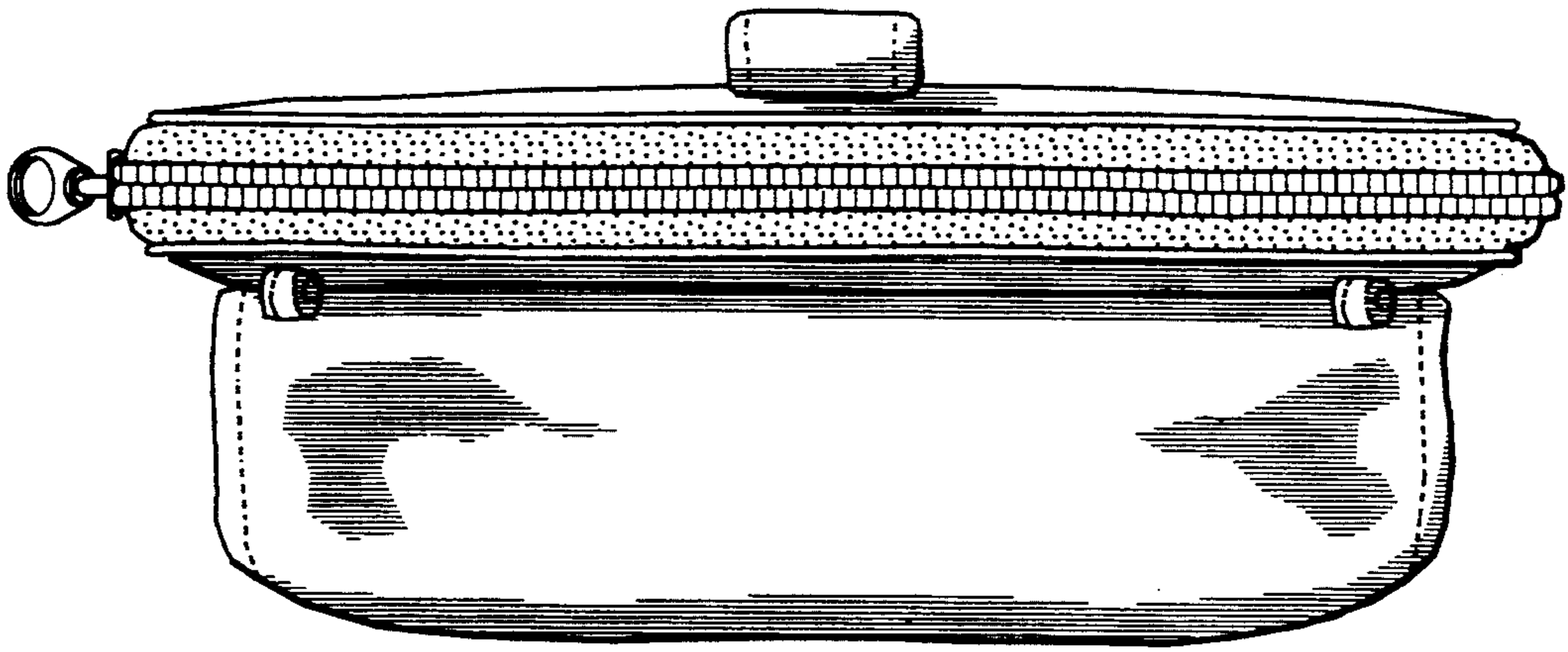

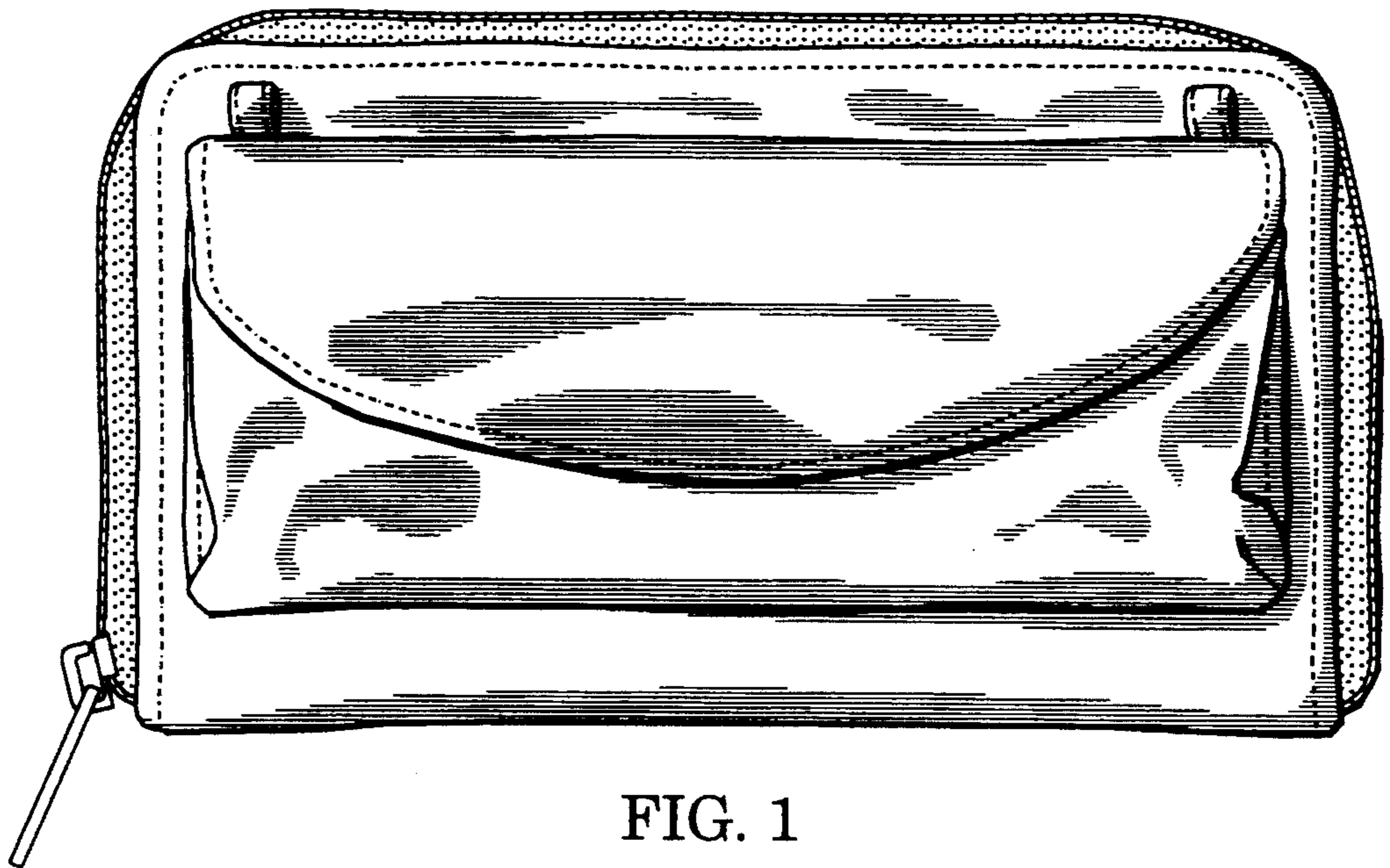

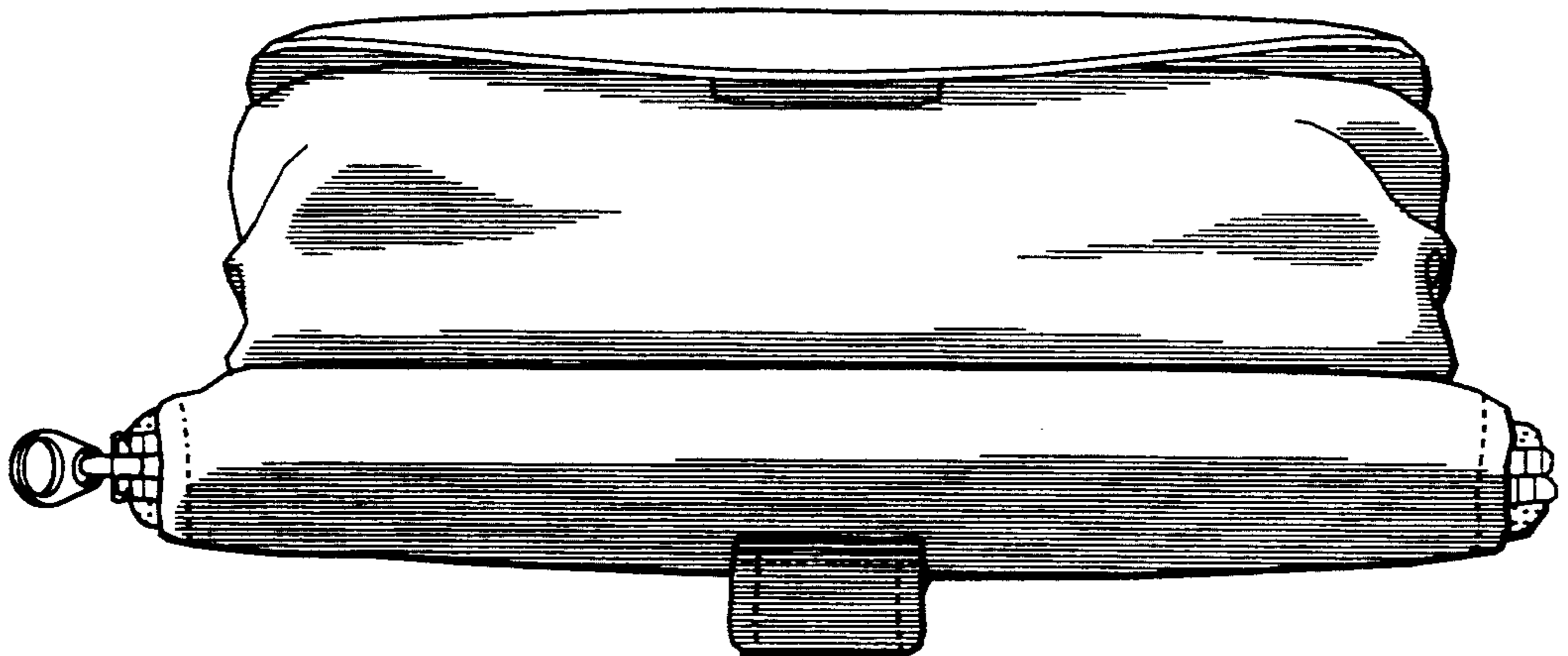

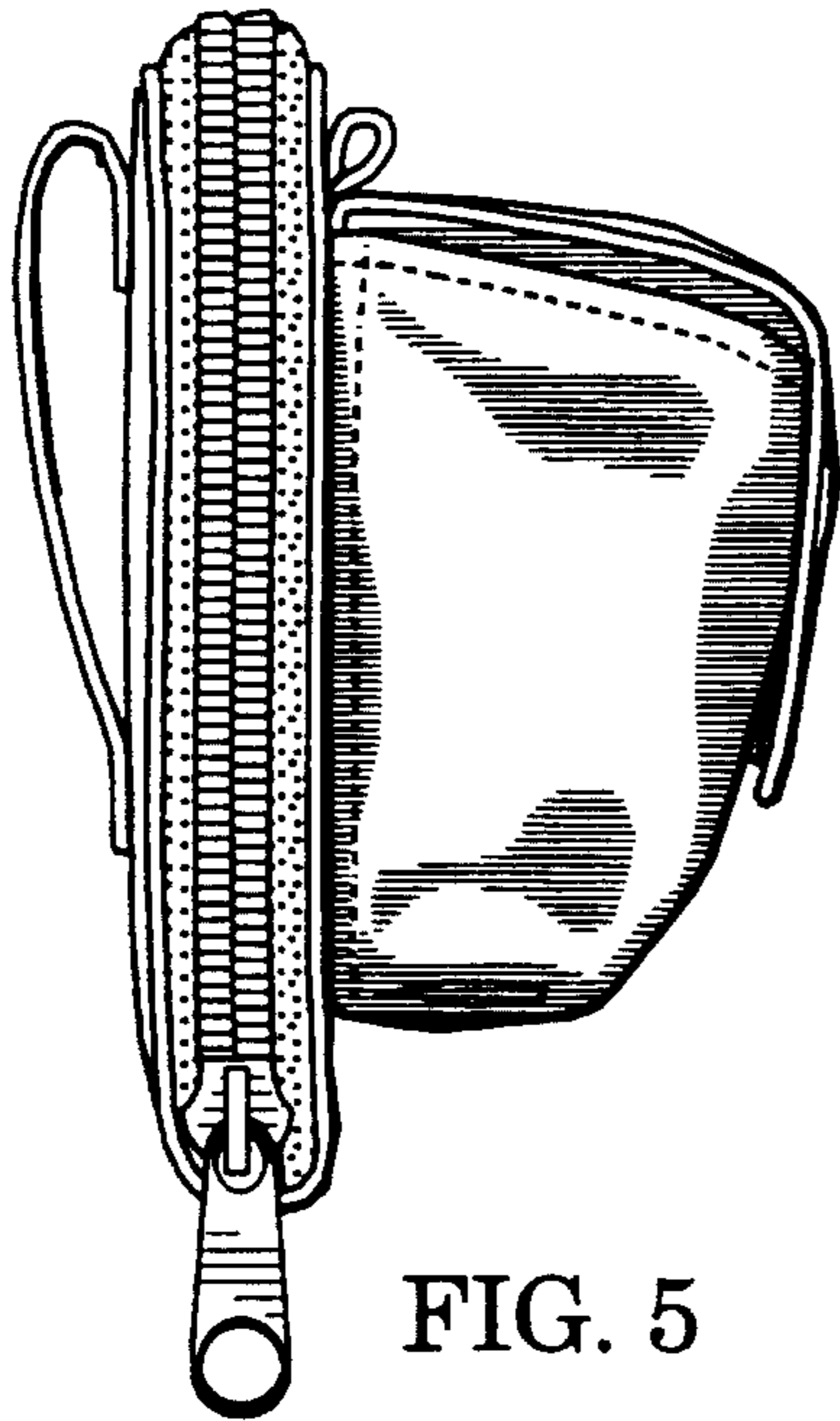

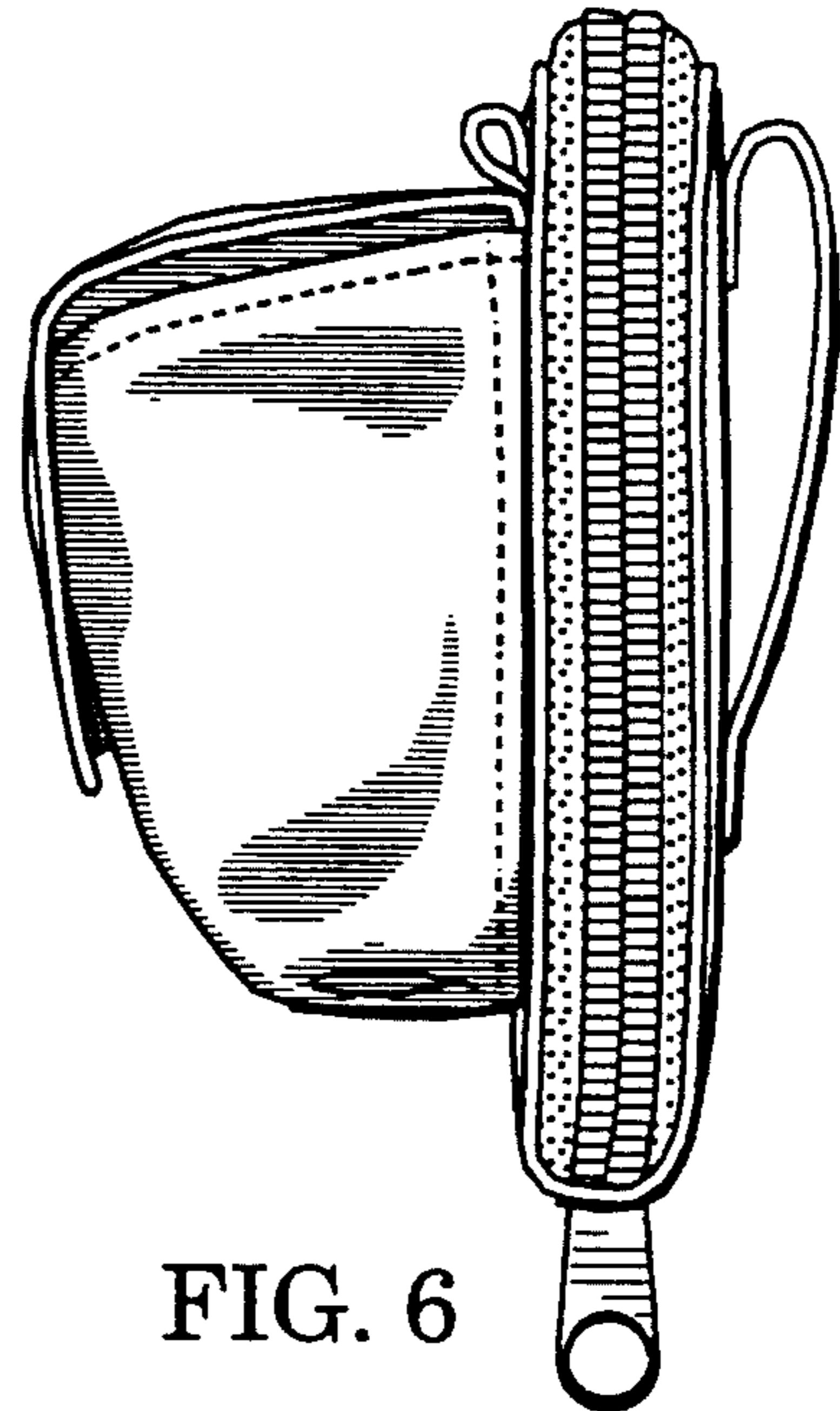

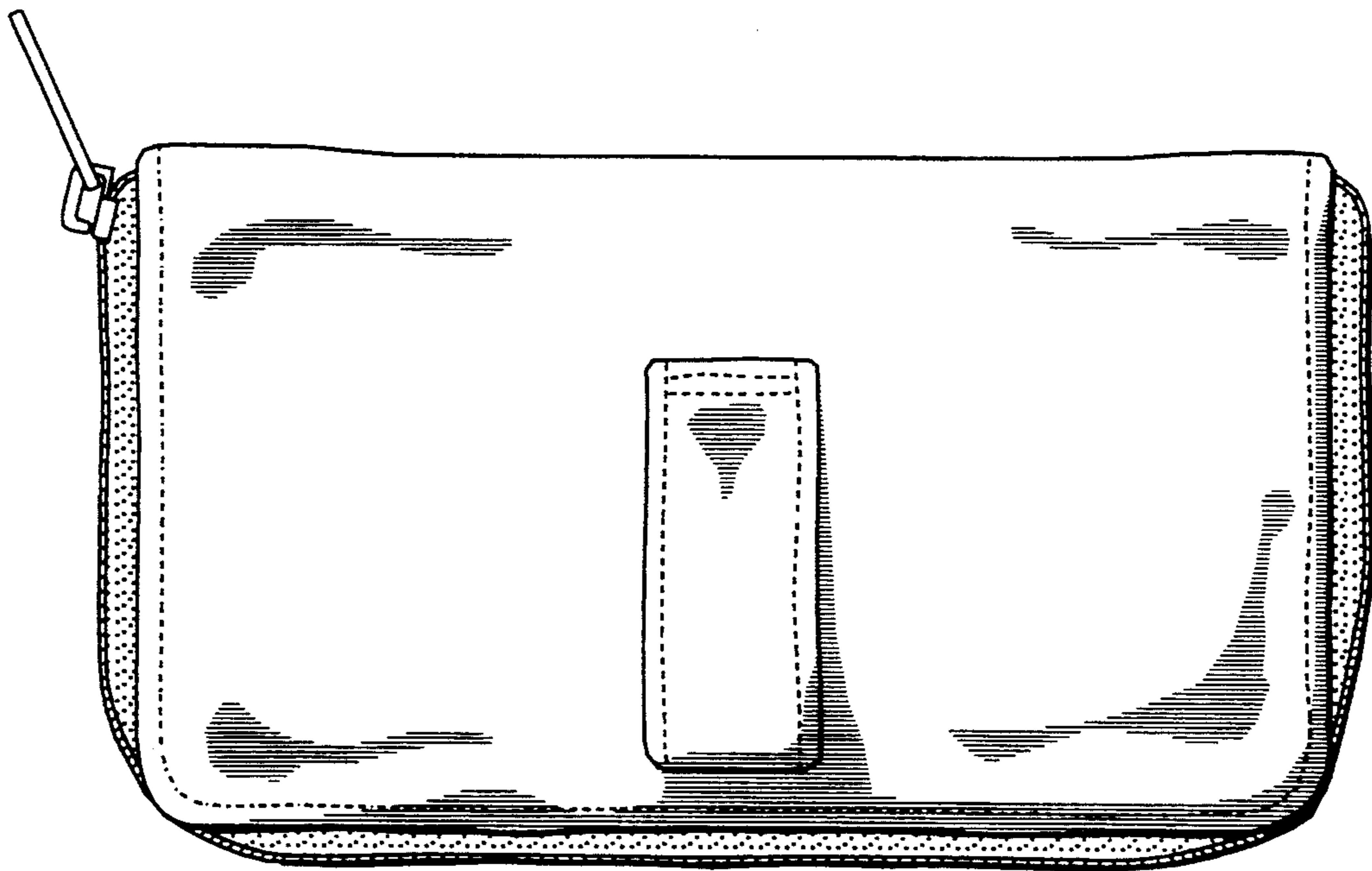
