The ornamental design for container with releasable lock, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a container with releasable lock showing our new design;
FIG. 2 is an exploded elevational view thereof;
FIG. 3 is a bottom plan view of a container cover; shown separately for clarity of illustration;
FIG. 4 is a bottom plan view of a container base; shown separately for clarity of illustration;
FIG. 5 is a top plan view of FIG. 3; and,
FIG. 6 is a top plan view of FIG. 4.

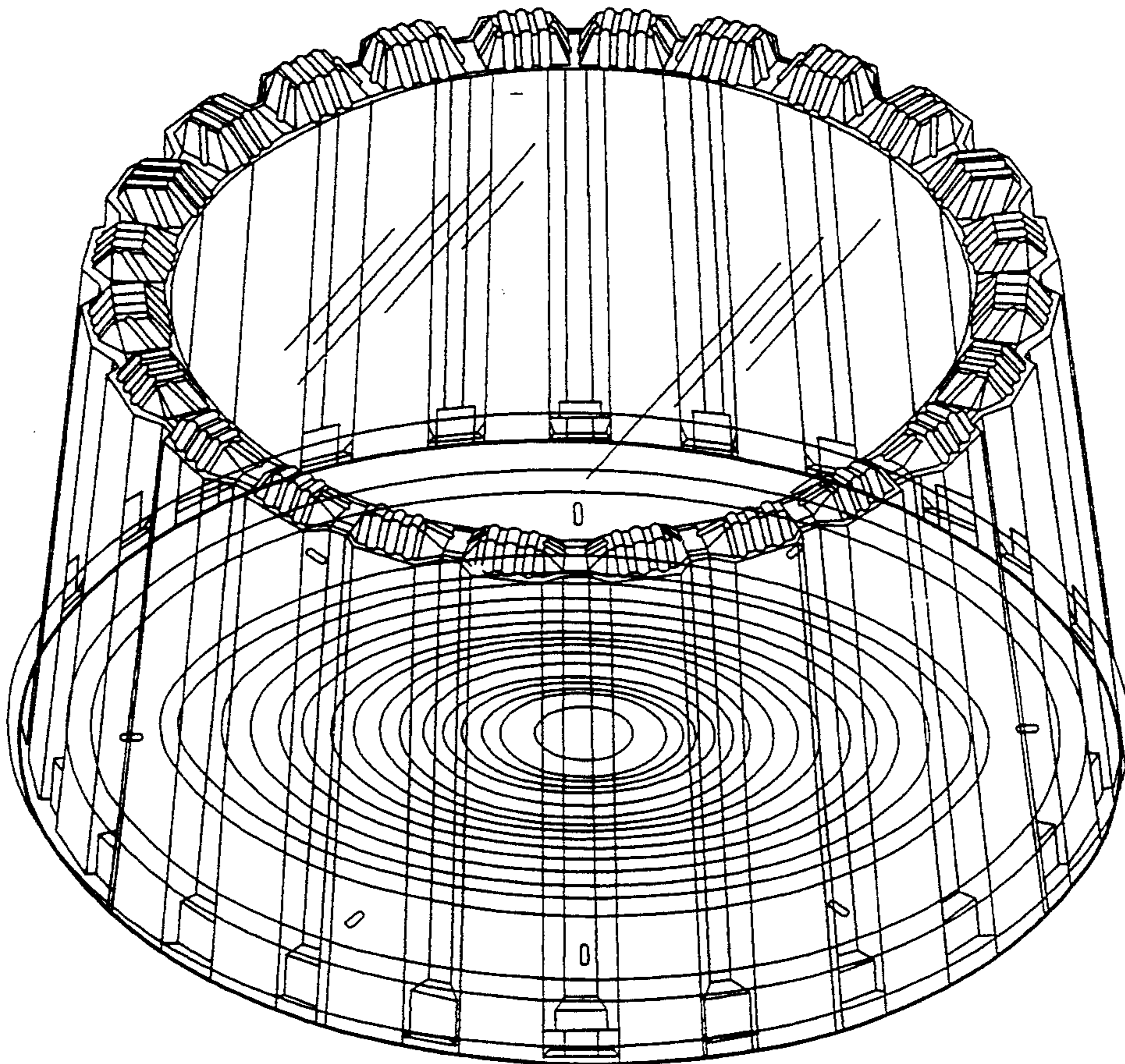

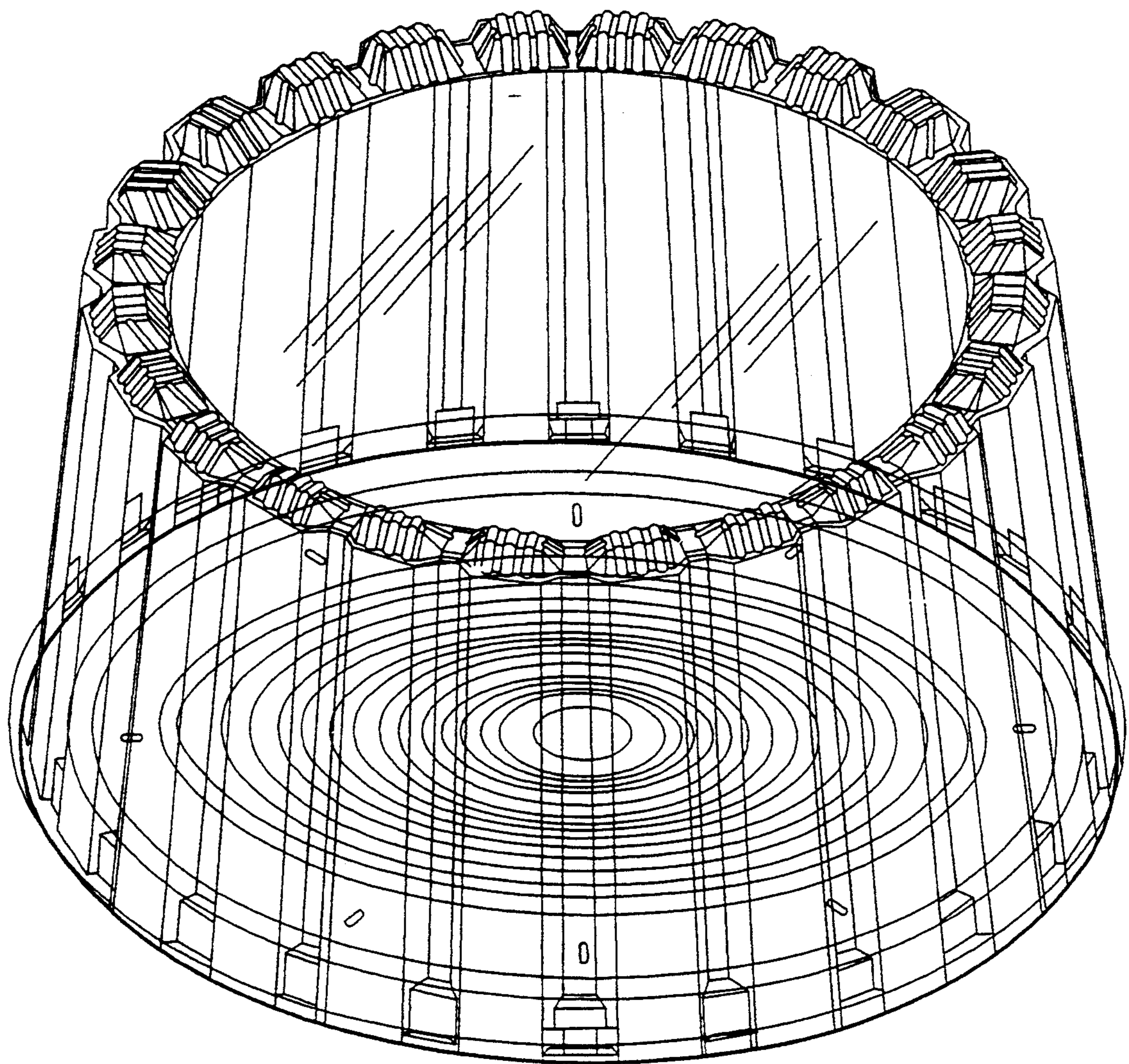

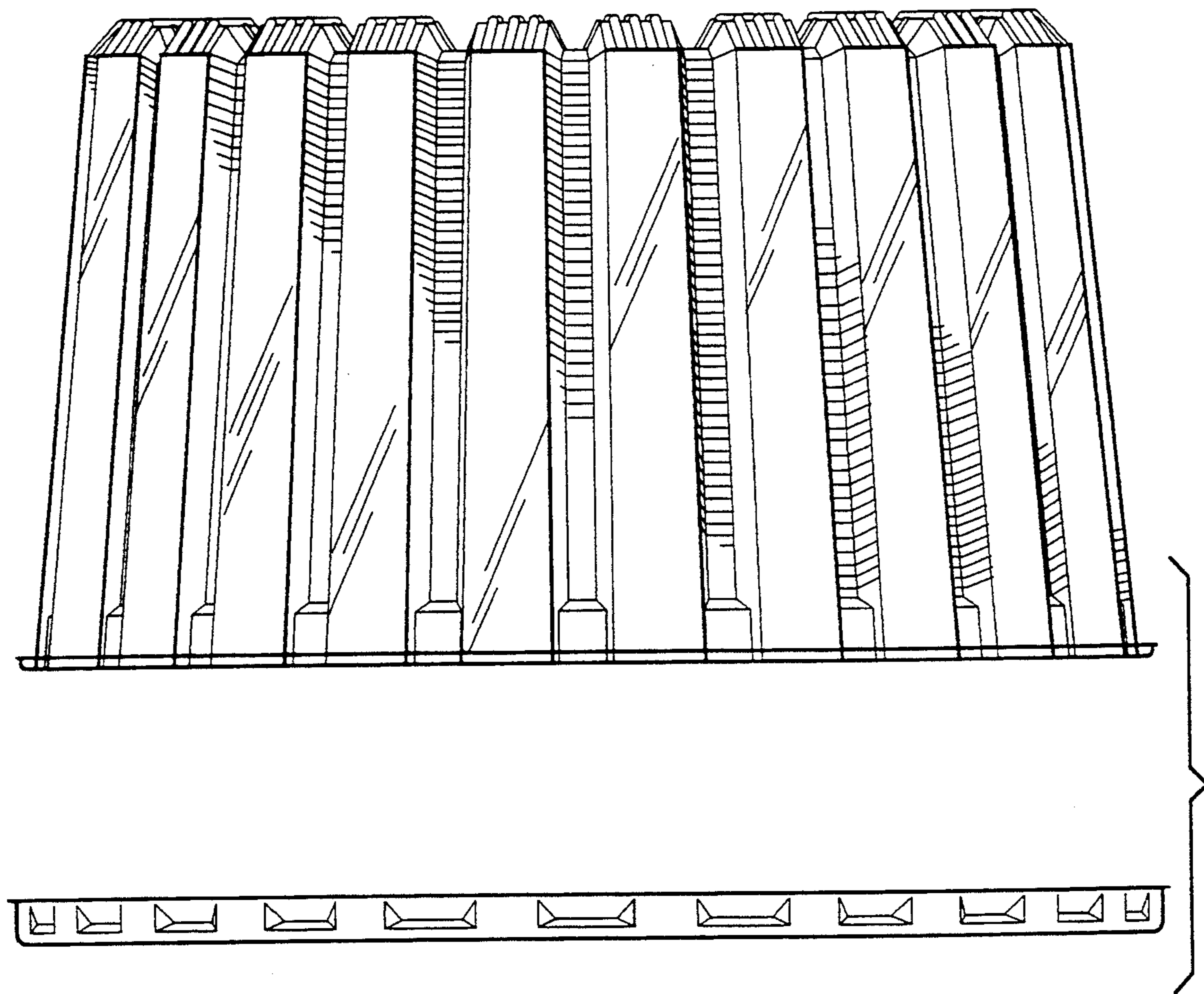

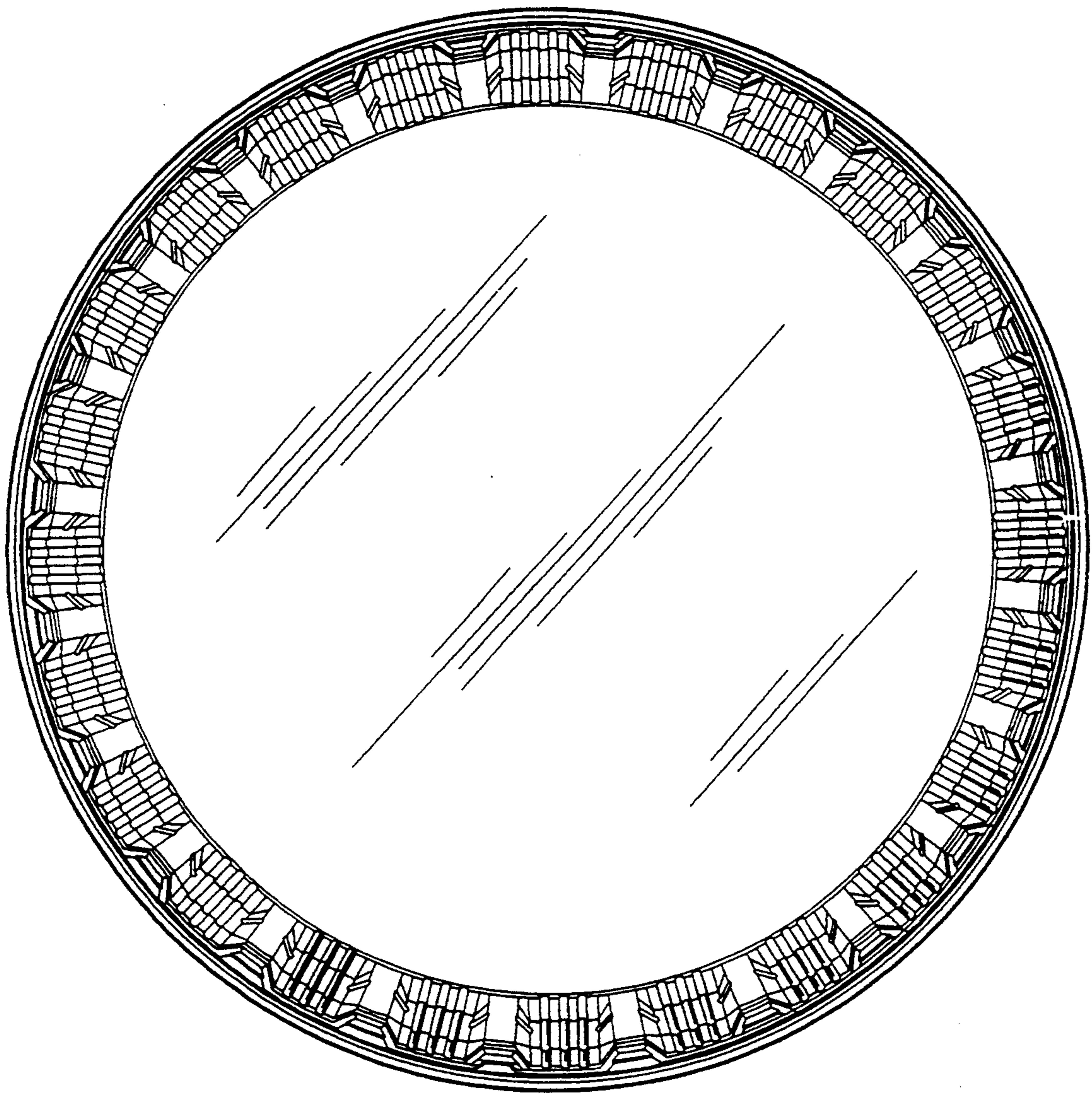

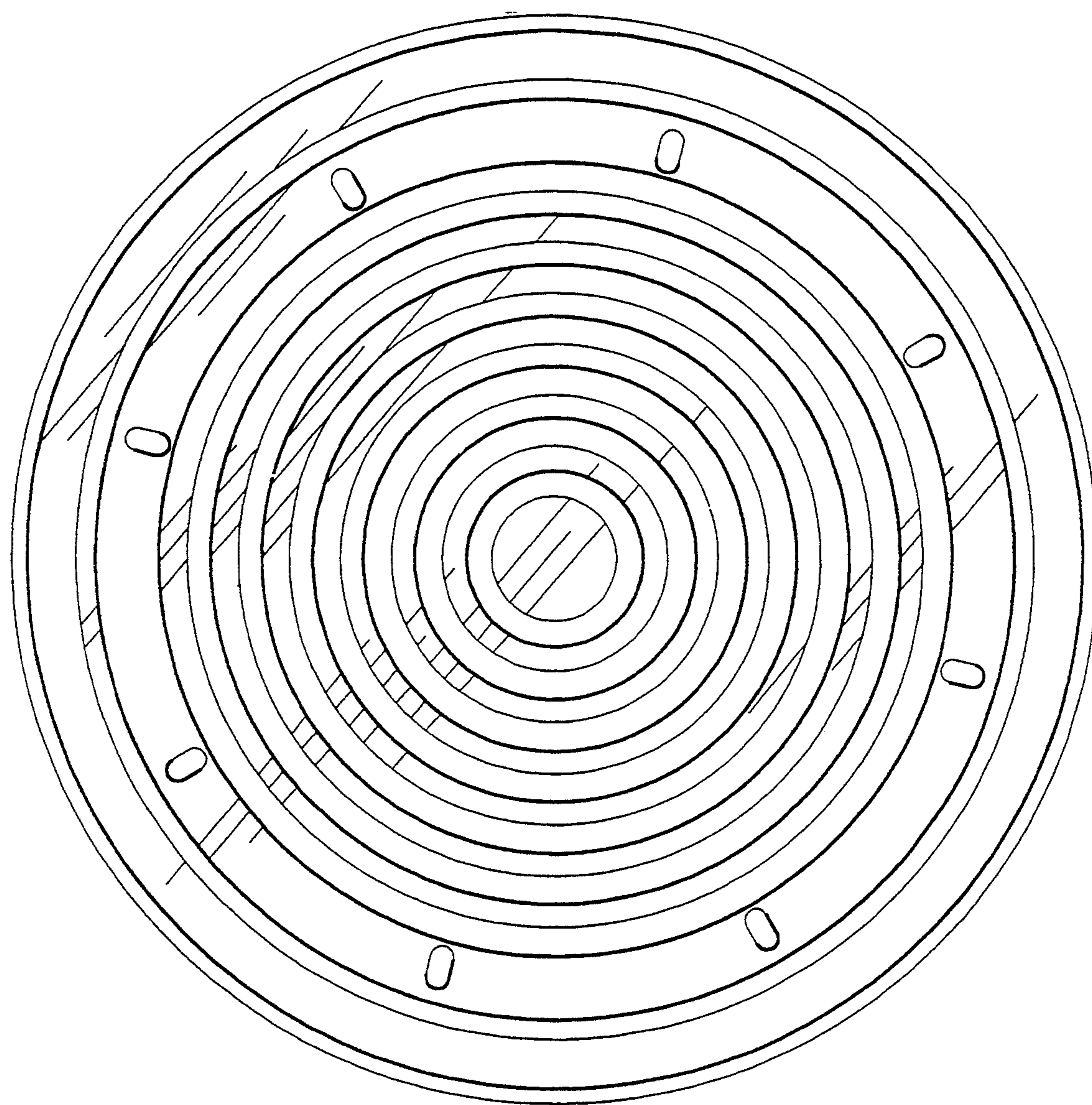

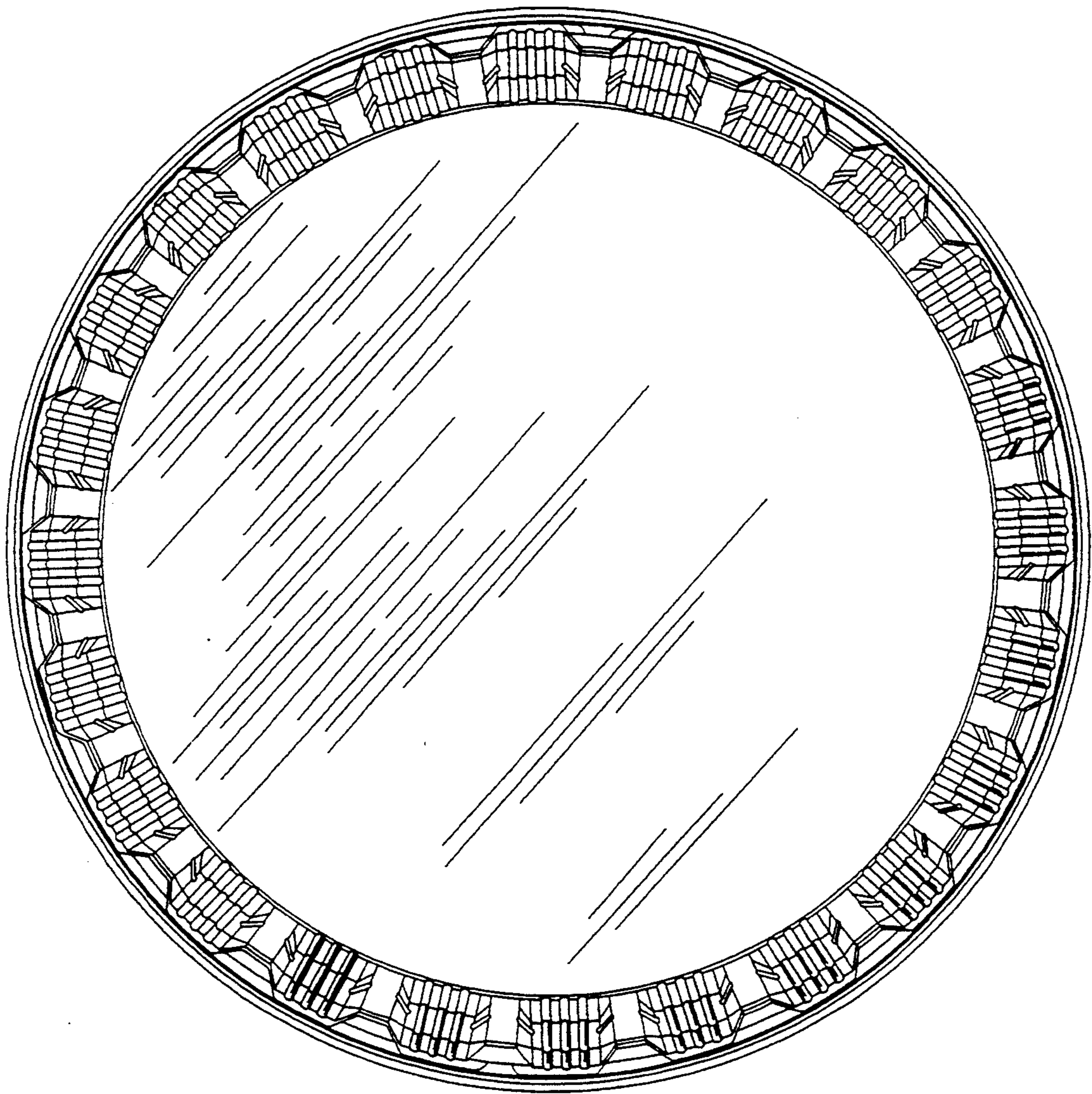
