The ornamental design for a educational board game, as shown and described.

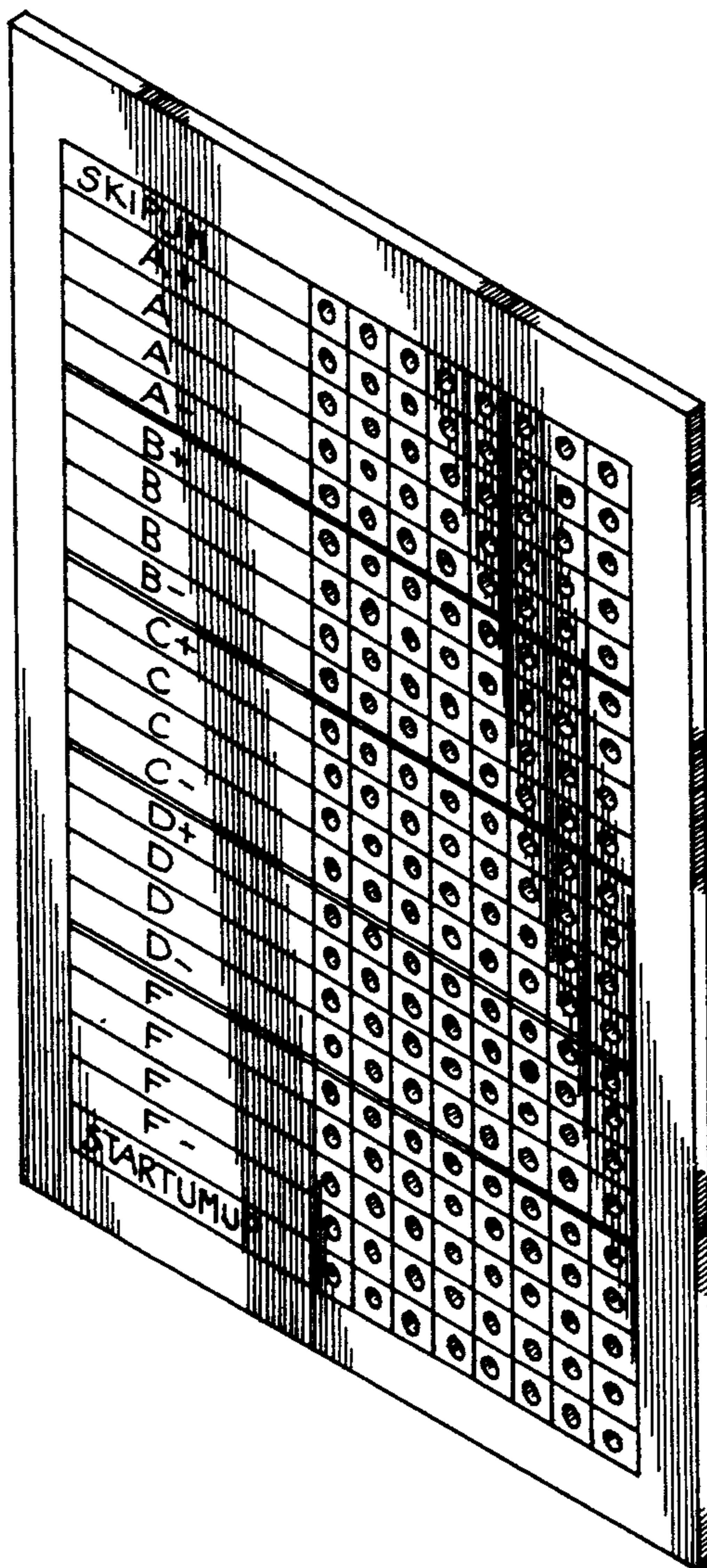
DESCRIPTION

FIG. 1 is a top plan view of the educational board game showing my new design;
FIG. 2 is a front end elevational view thereof, the rear being a mirror image of the front end shown in FIG. 2;
FIG. 3 is a side elevational view thereof, the side opposite being a mirror image of the side shown in FIG. 4;
FIG. 4 is a bottom plan view thereof; and,

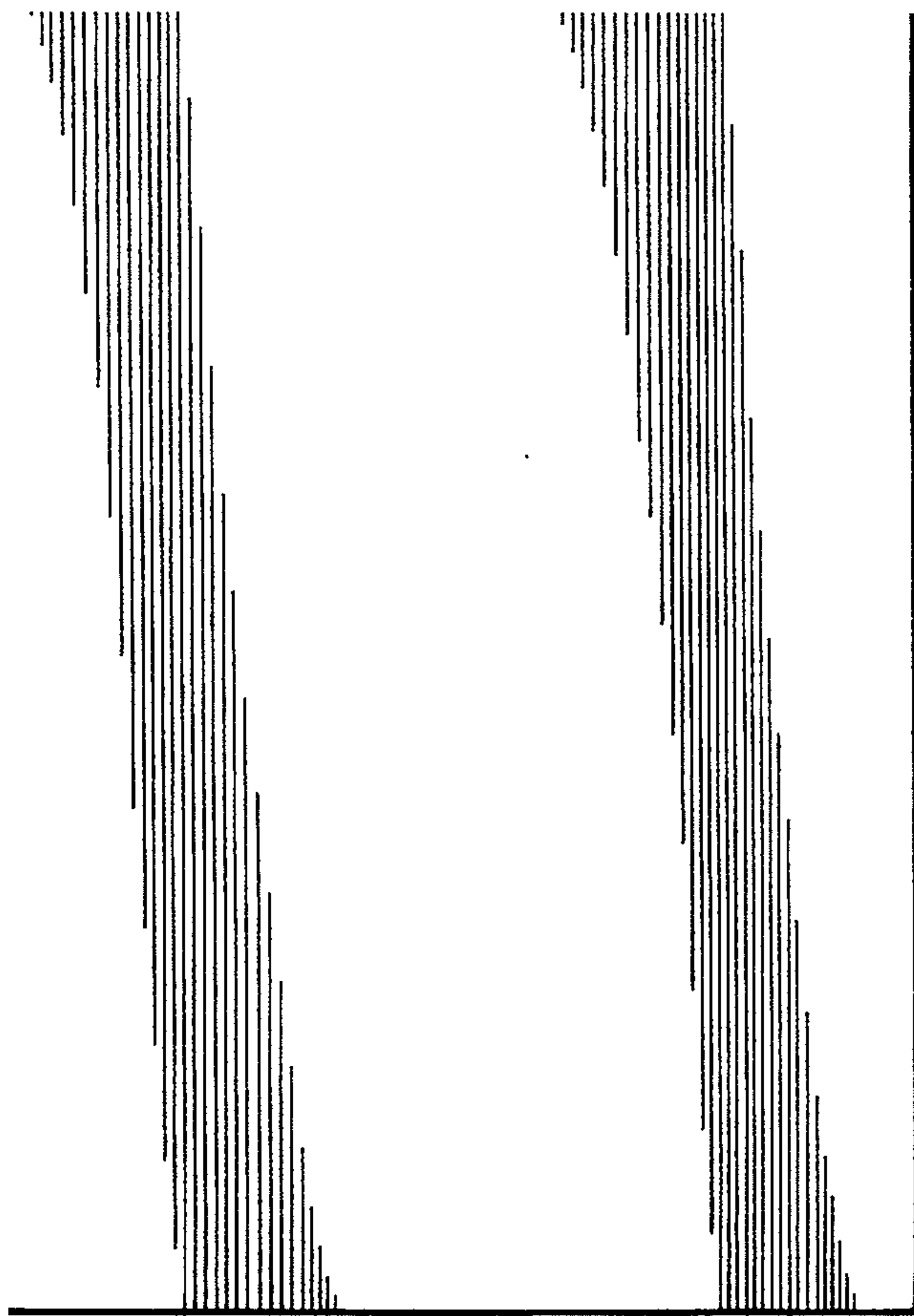

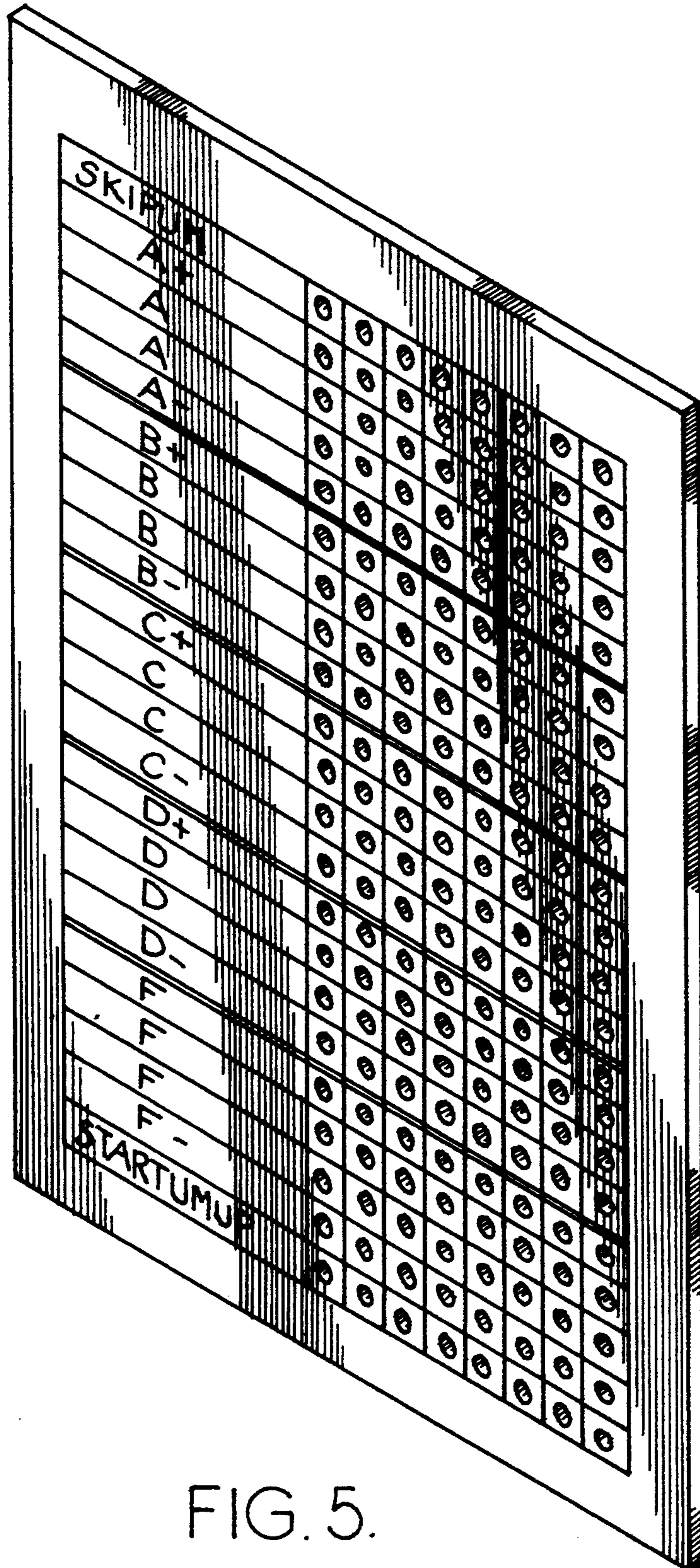
