FIG. 1 is a top perspective view of a sports glove, in use, showing my new design;

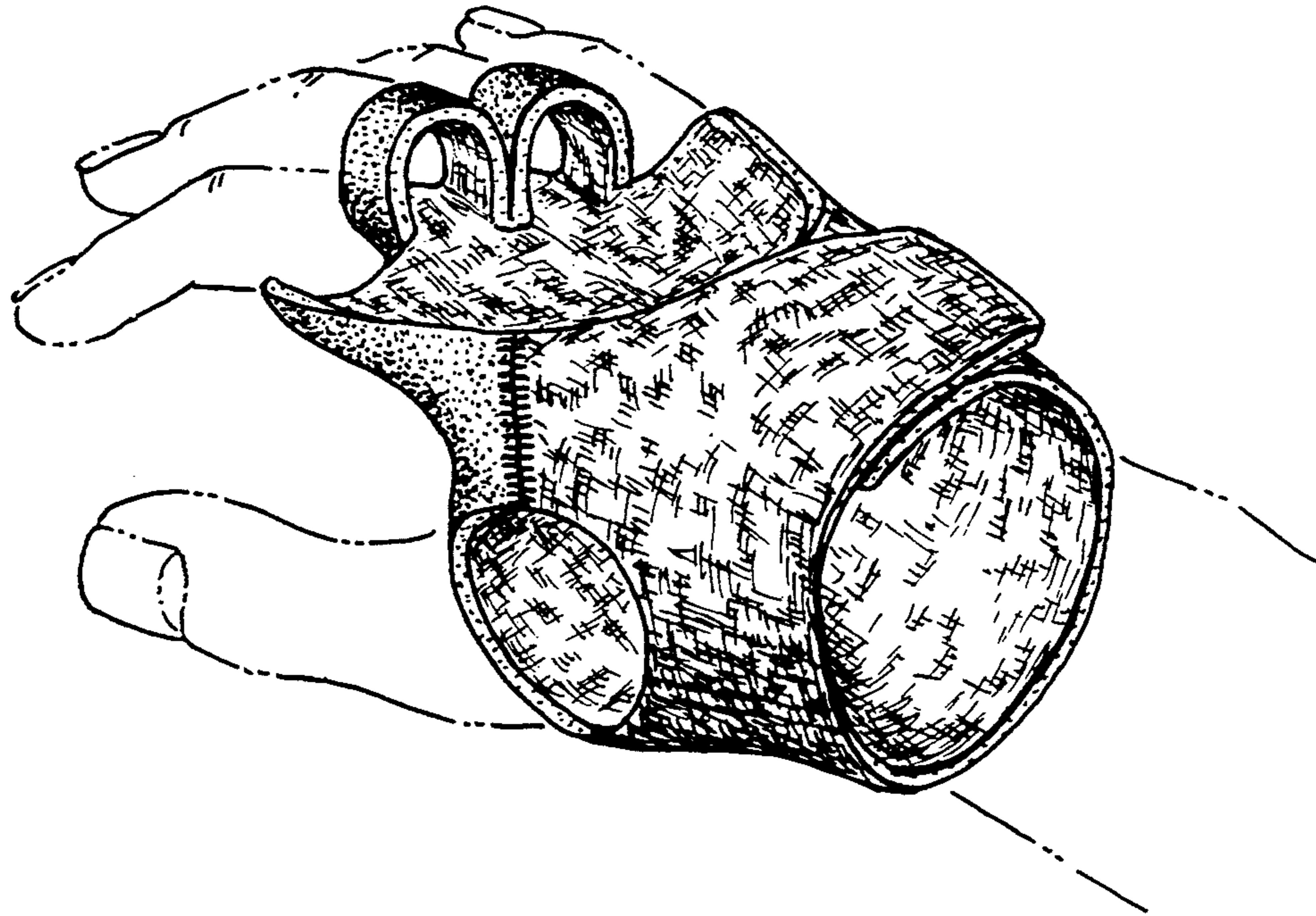
FIG. 2 is a bottom perspective view thereof;

FIG. 3 is a top perspective view in extended position;

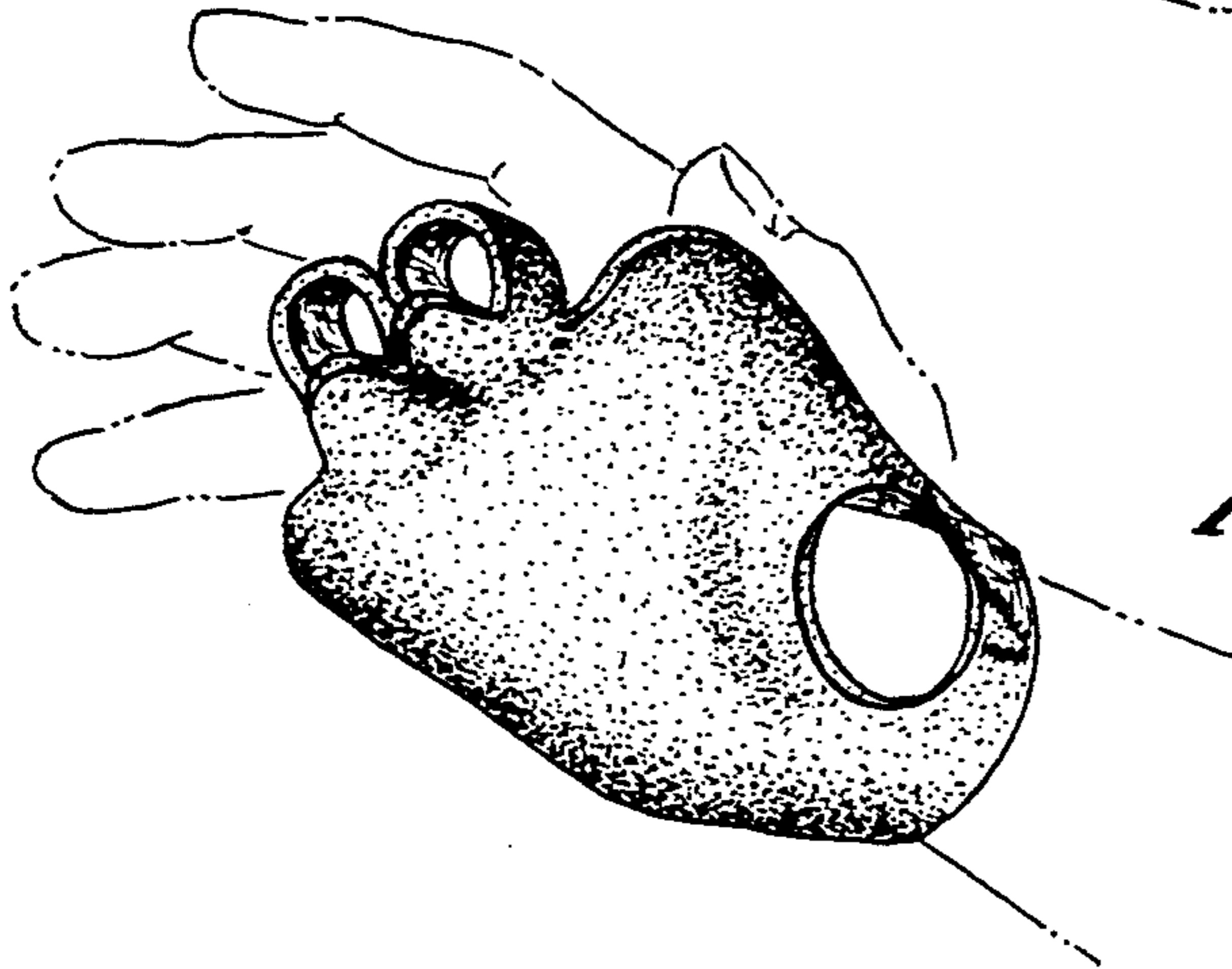
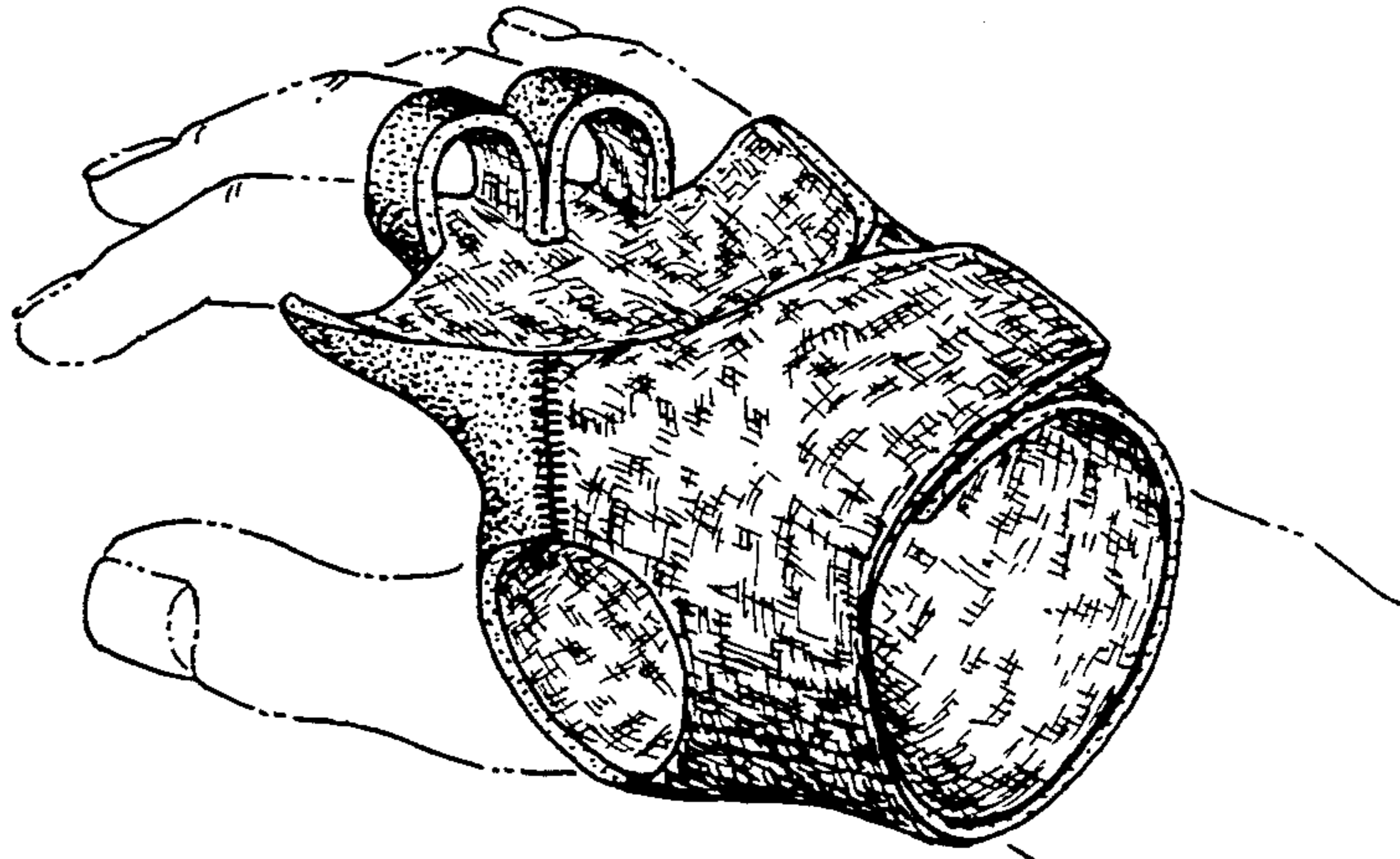
FIG. 4 is a side elevational view thereof;

FIG. 5 is a bottom plan view thereof; and,

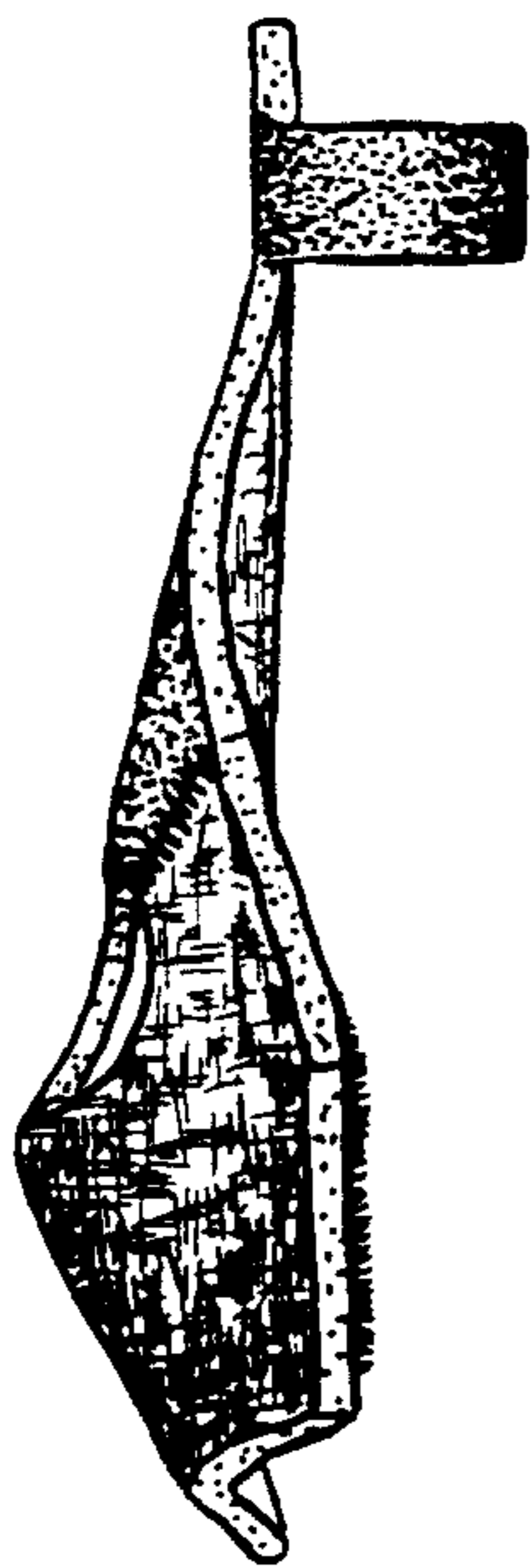
FIG. 6 is a front elevational view thereof.



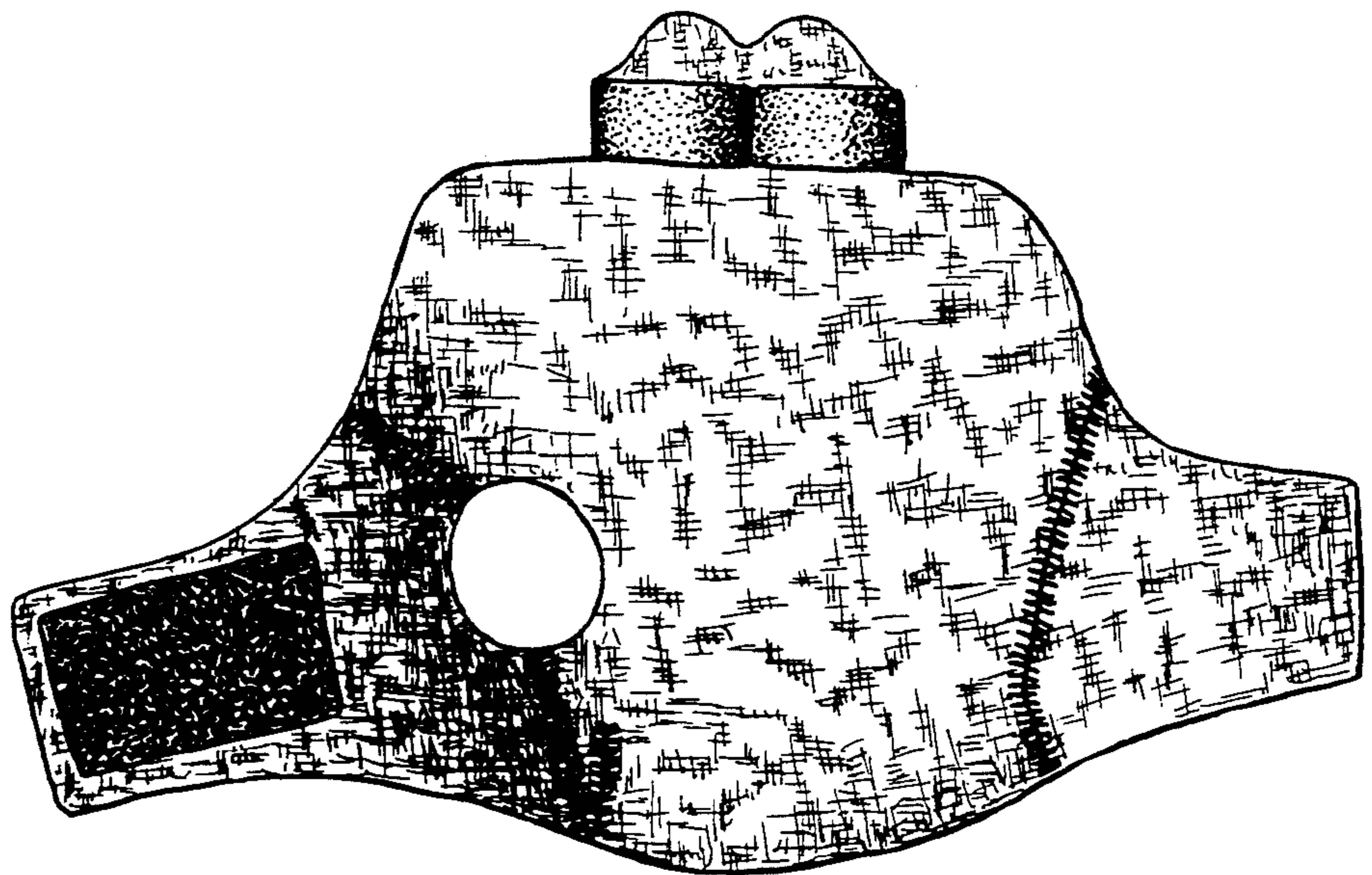

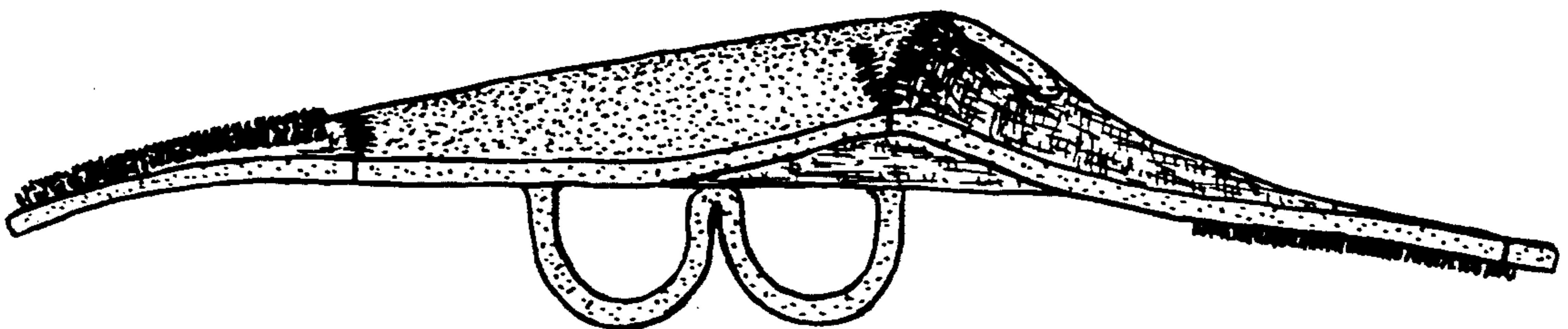
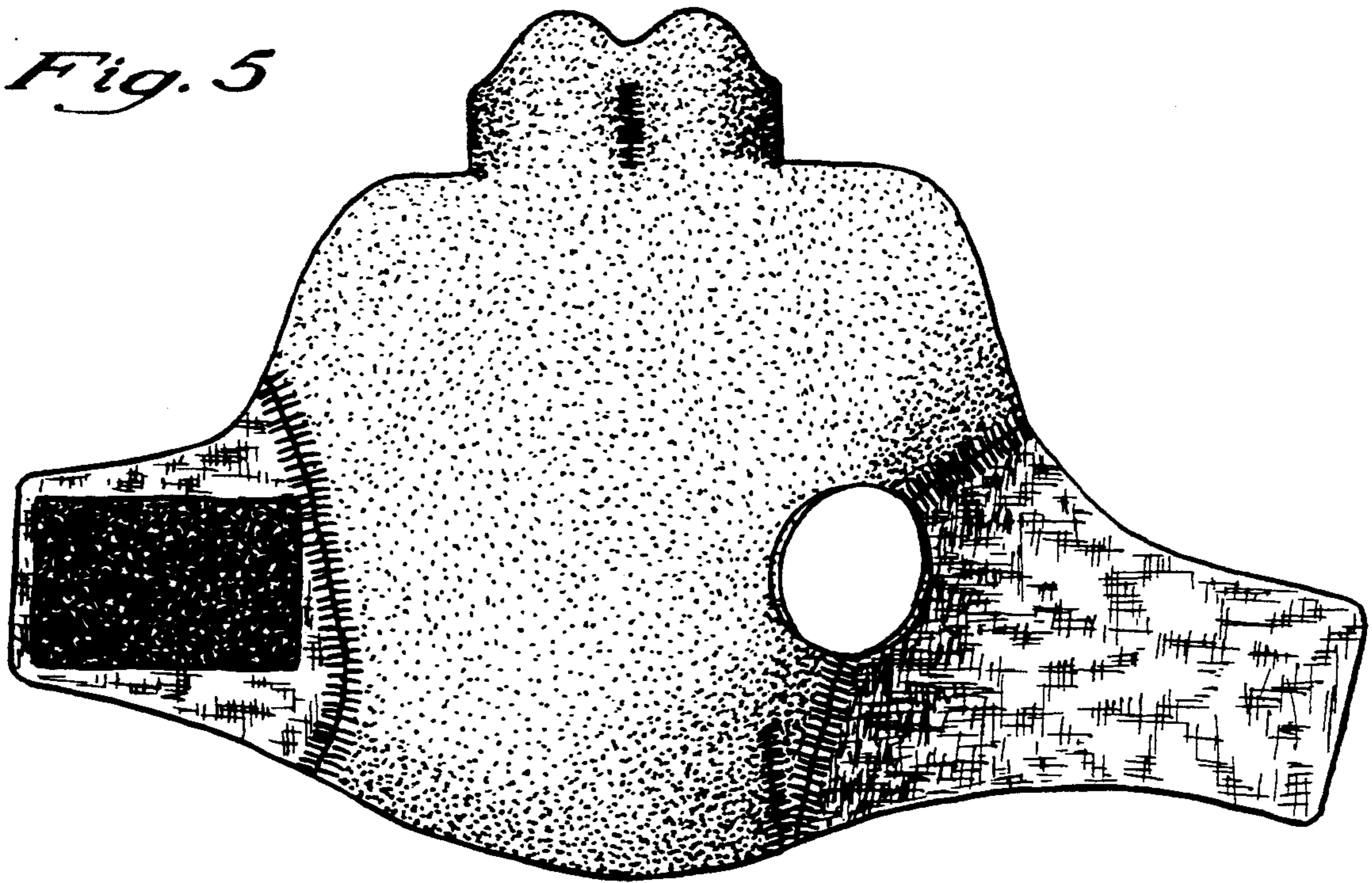
