The ornamental design for a portable display cart, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view showing our new design of a portable display cart;
 FIG. 2 is a front elevational view thereof;
 FIG. 3 is a side elevational view thereof, the left-side and right-side elevational views thereof being the same;
 FIG. 4 is a rear elevational view thereof;
 FIG. 5 is a top plan view thereof;
 FIG. 6 is a bottom plan view thereof;
 FIG. 7 is a perspective view of a second embodiment of the portable display cart, the bottom view thereof being the same as shown in FIG. 6;
 FIG. 8 is a front elevational view of FIG. 7;
 FIG. 9 is a side elevational view of FIG. 7, the opposite side view thereof being the same;
 FIG. 10 is a rear elevational view of FIG. 7;
 FIG. 11 is a top plan view of FIG. 7;
 FIG. 12 is a perspective view of a third embodiment of the portable display cart, the bottom view thereof being the same as shown in FIG. 6;
 FIG. 13 is a front elevational view of FIG. 12;
 FIG. 14 is a side elevational view of FIG. 12, the opposite side view thereof being the same;
 FIG. 15 is a rear elevational view of FIG. 12; and,
 FIG. 16 is a top plan view of FIG. 12.

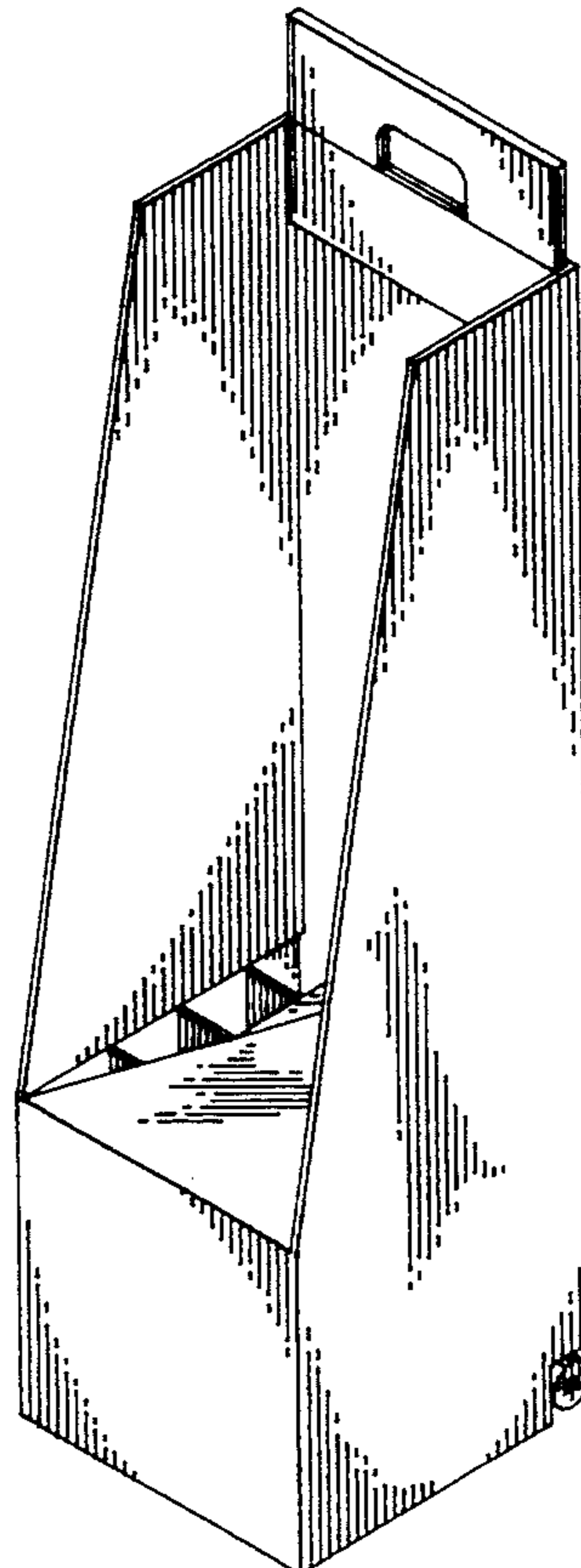

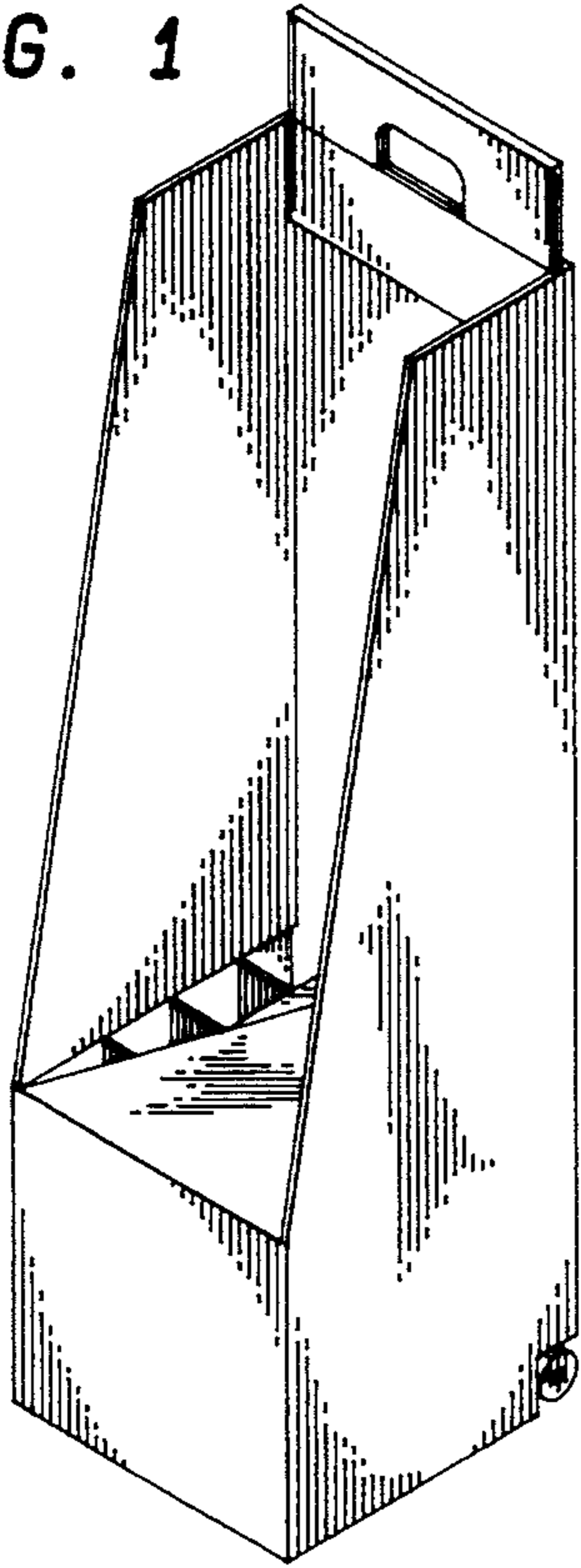

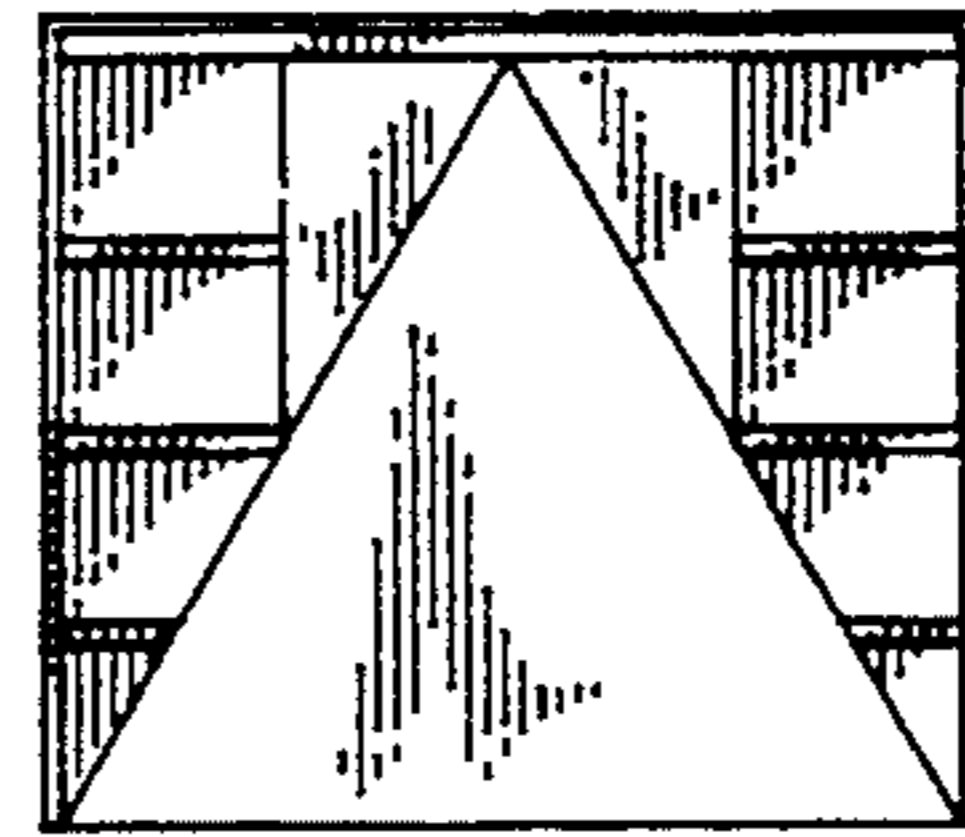

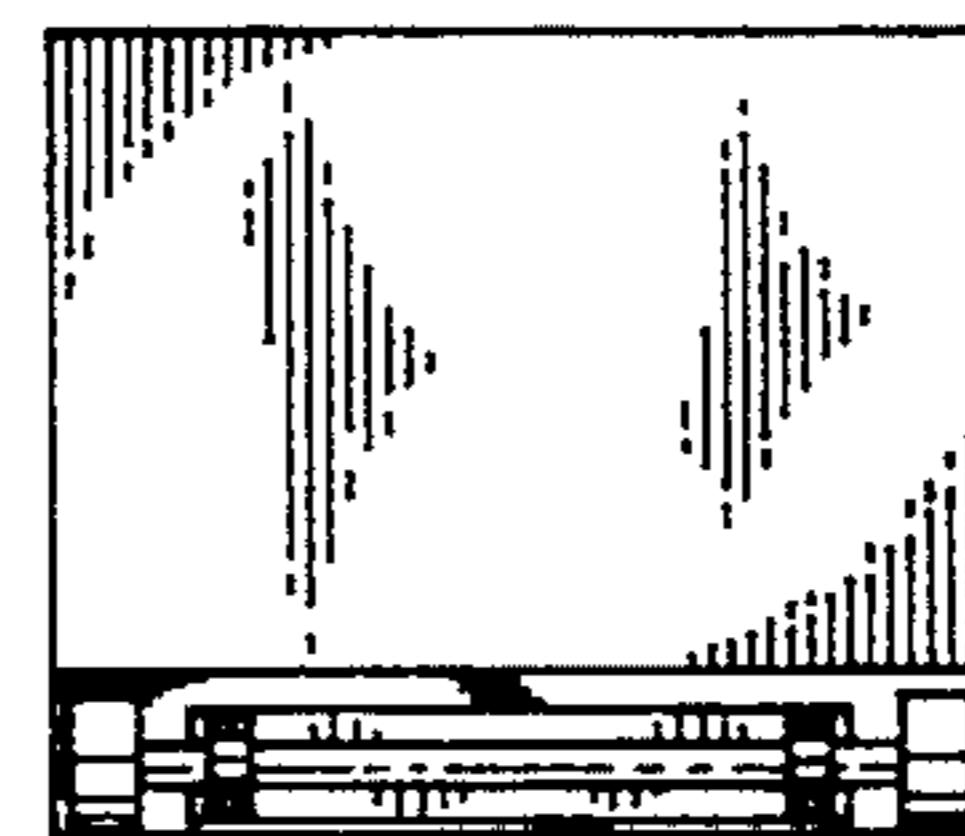

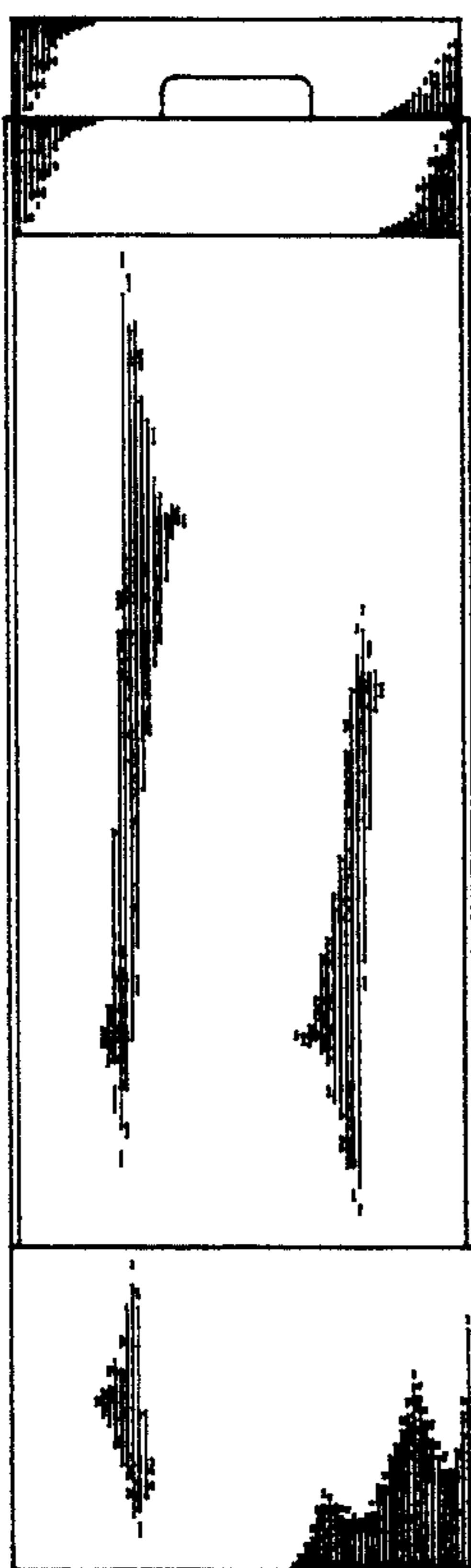

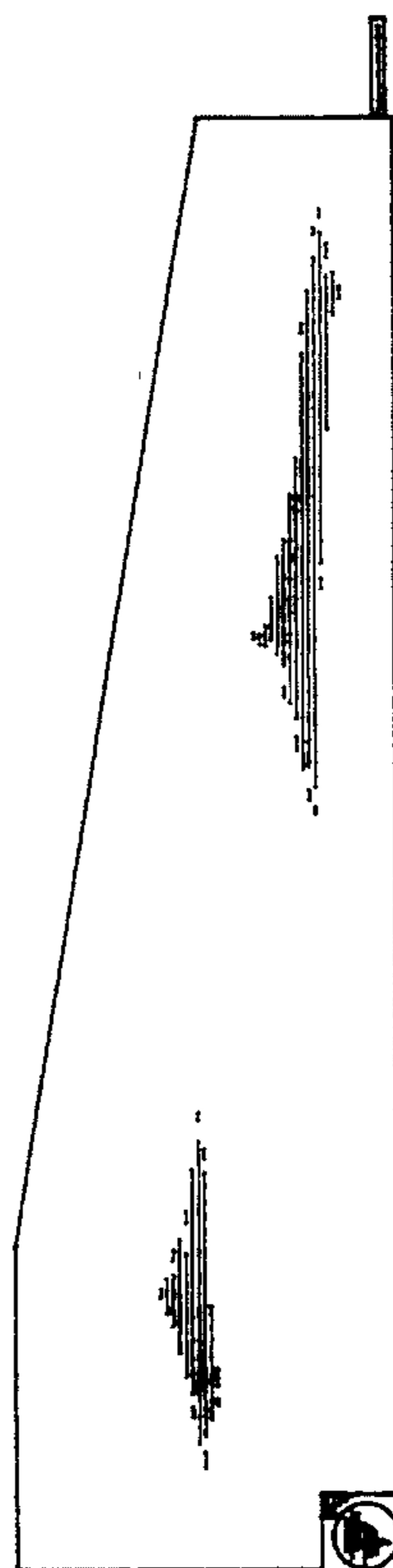

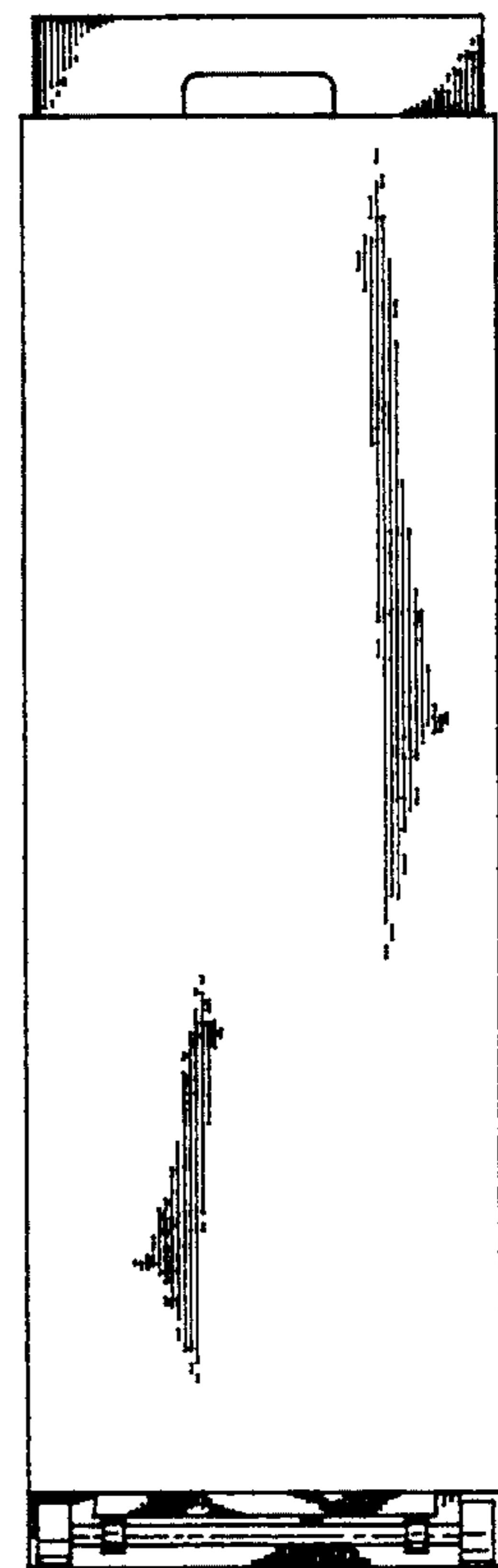

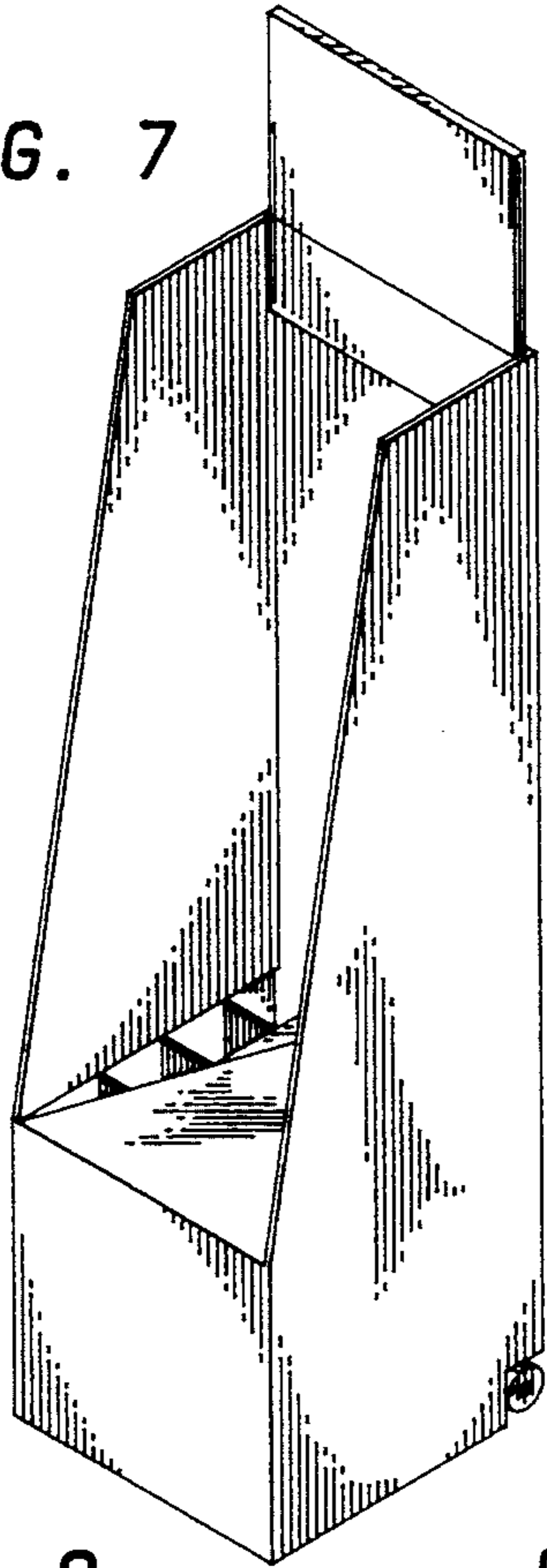

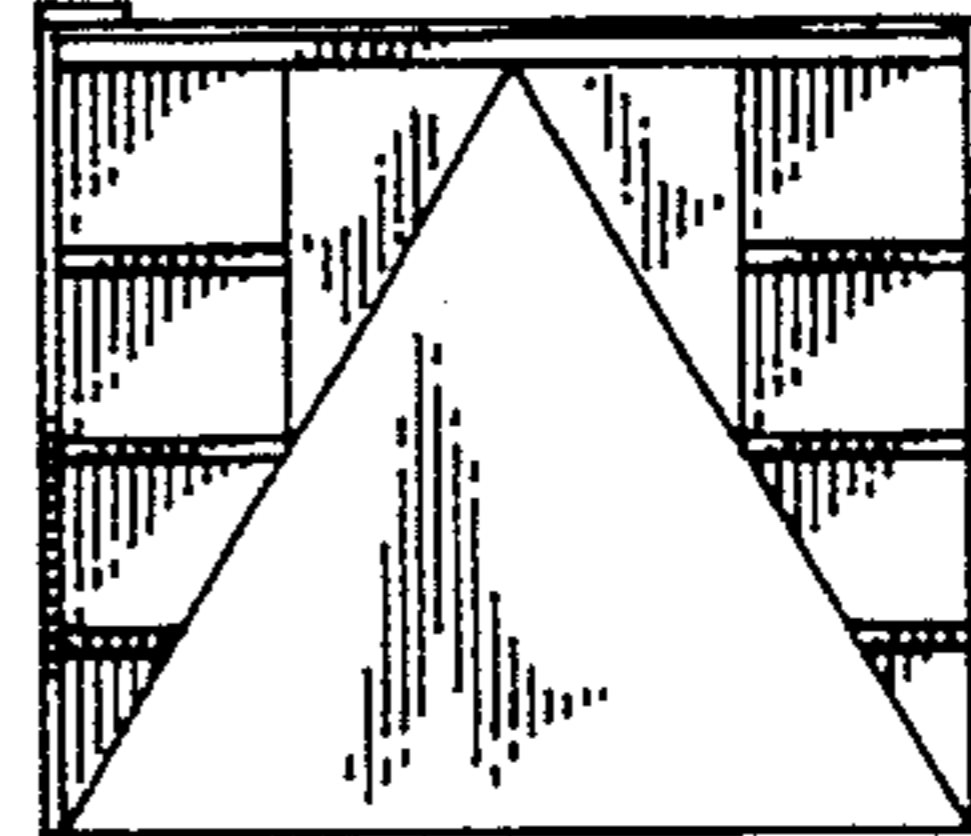

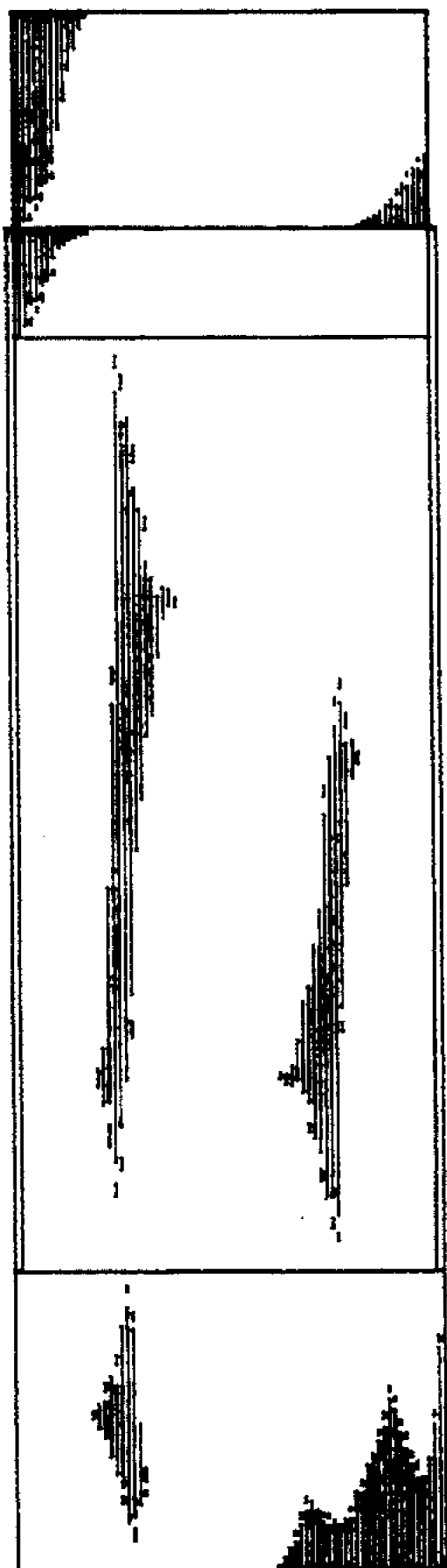

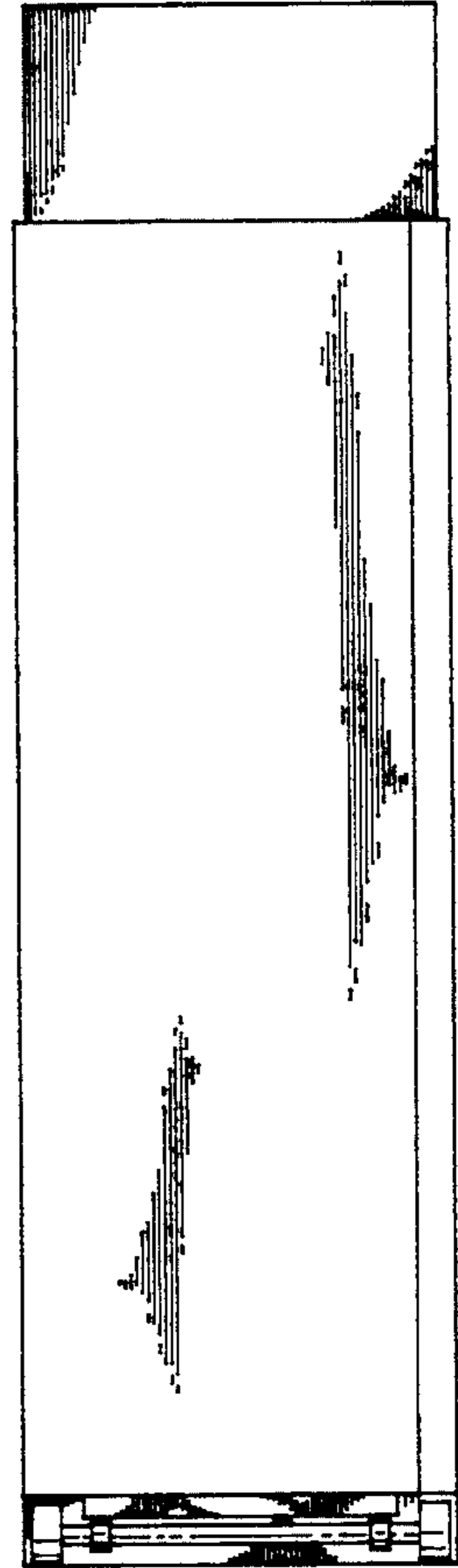

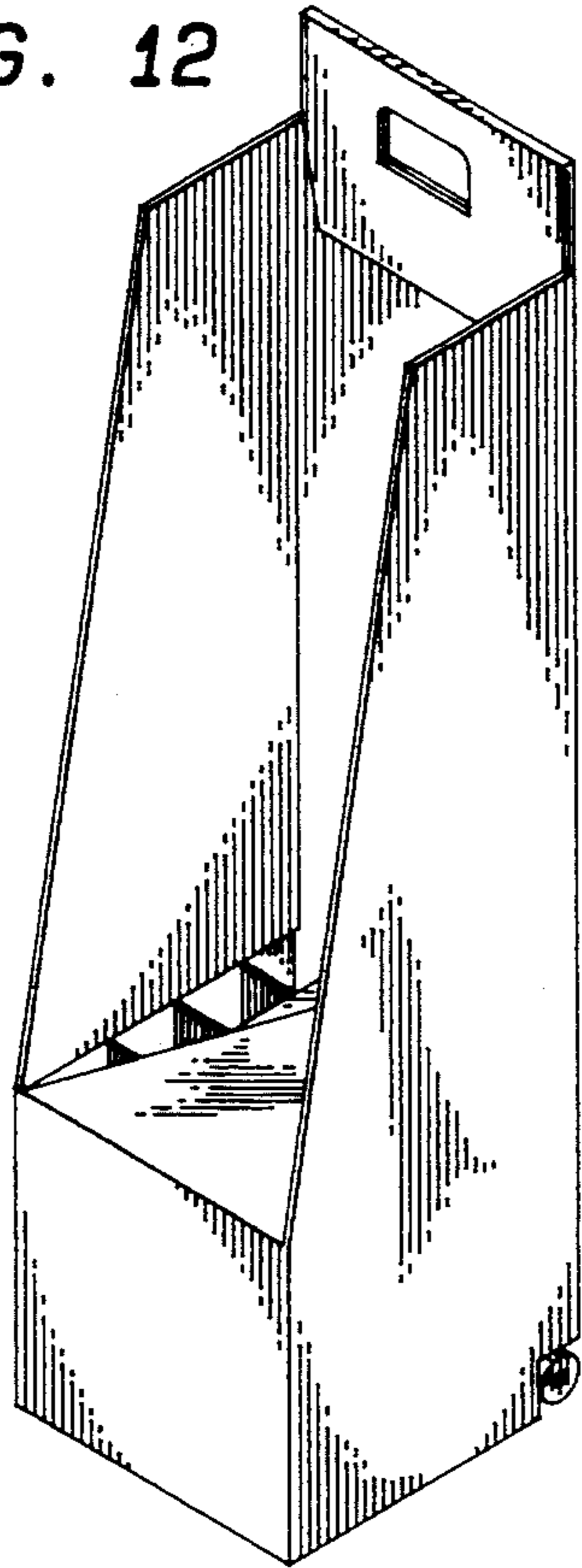

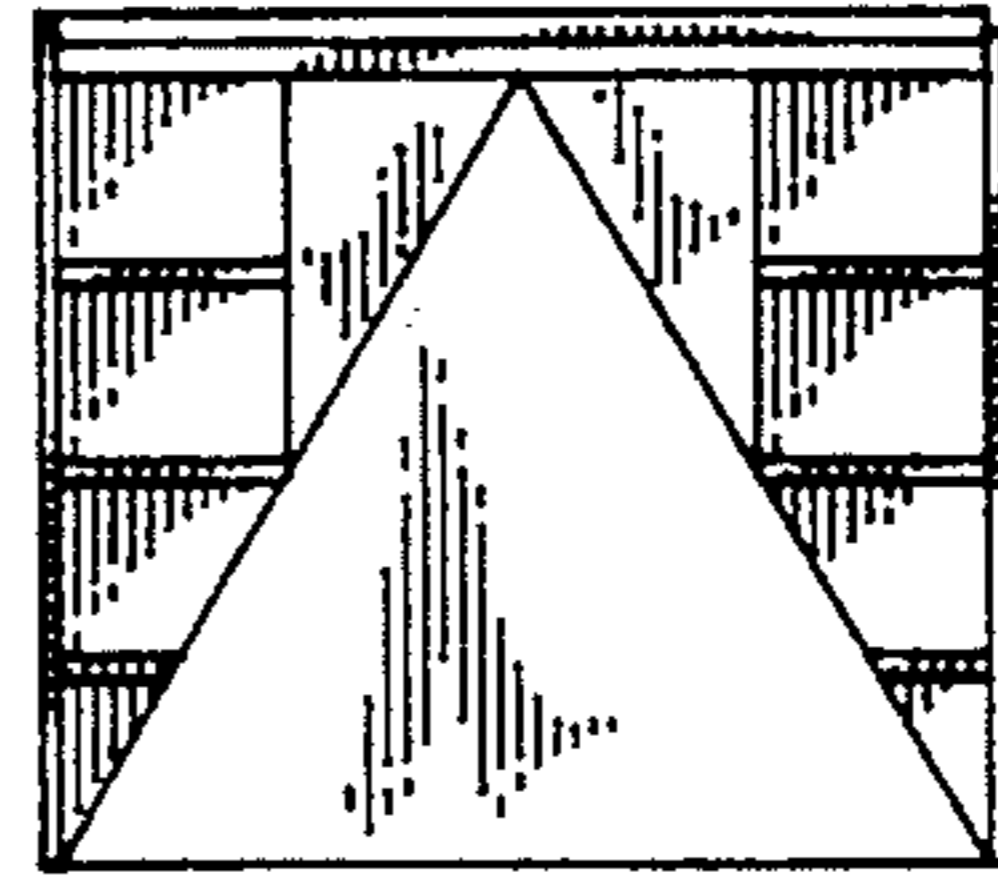

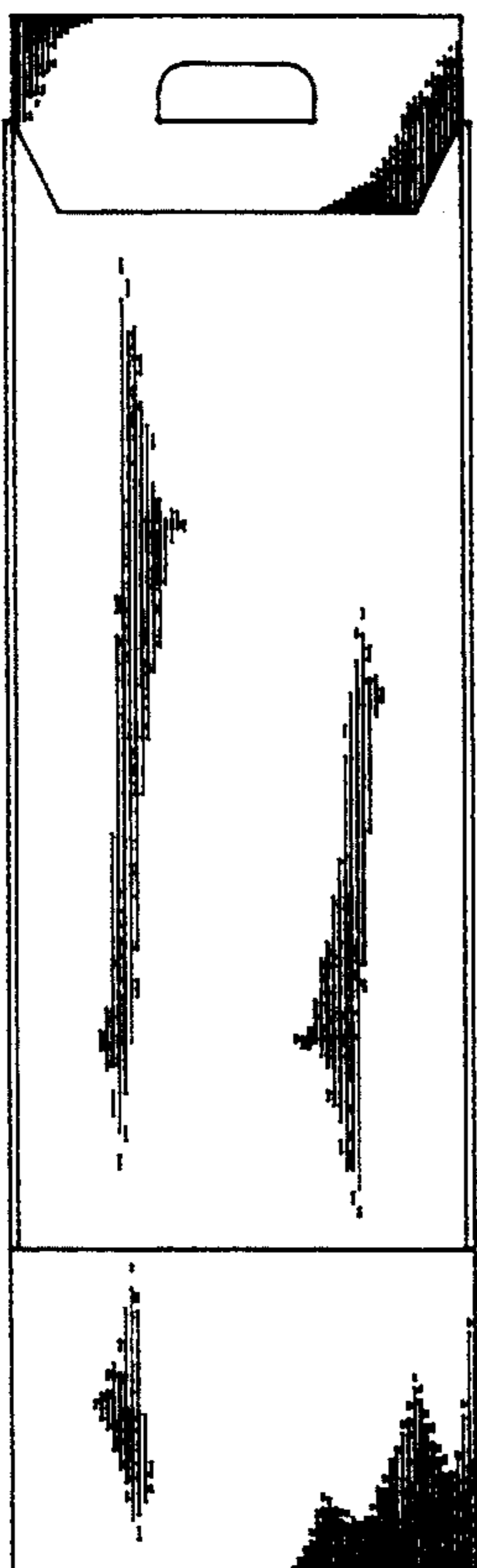

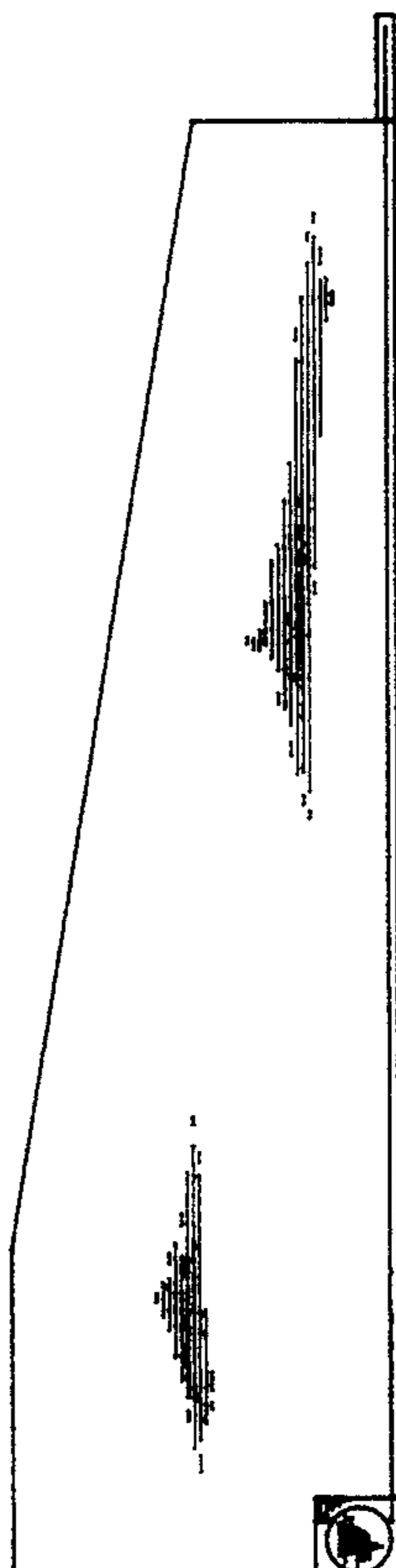
