### DESCRIPTION

FIG. 1 is a top, front and right side perspective view of a bottle with handle showing my new design;

 FIG. 7 is a bottom plan view thereof.

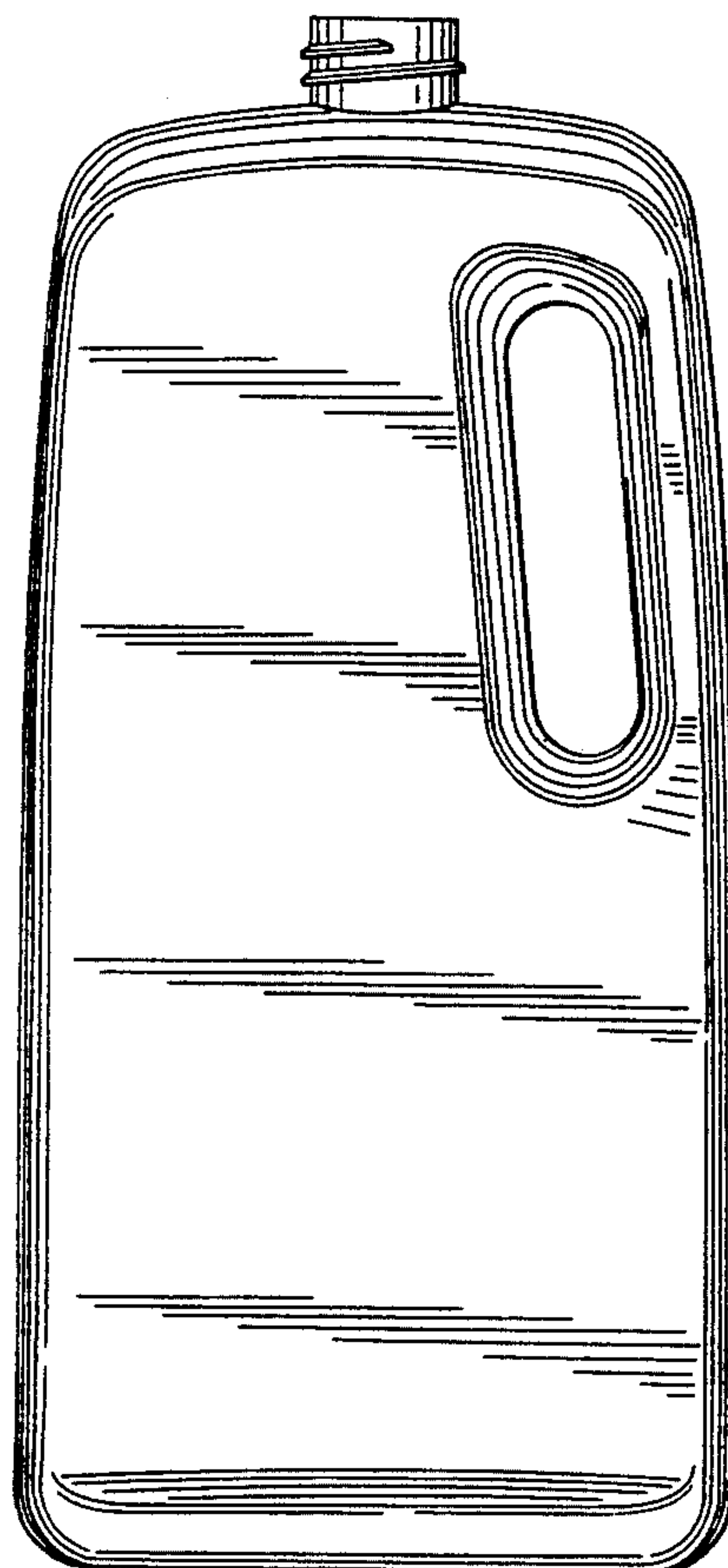

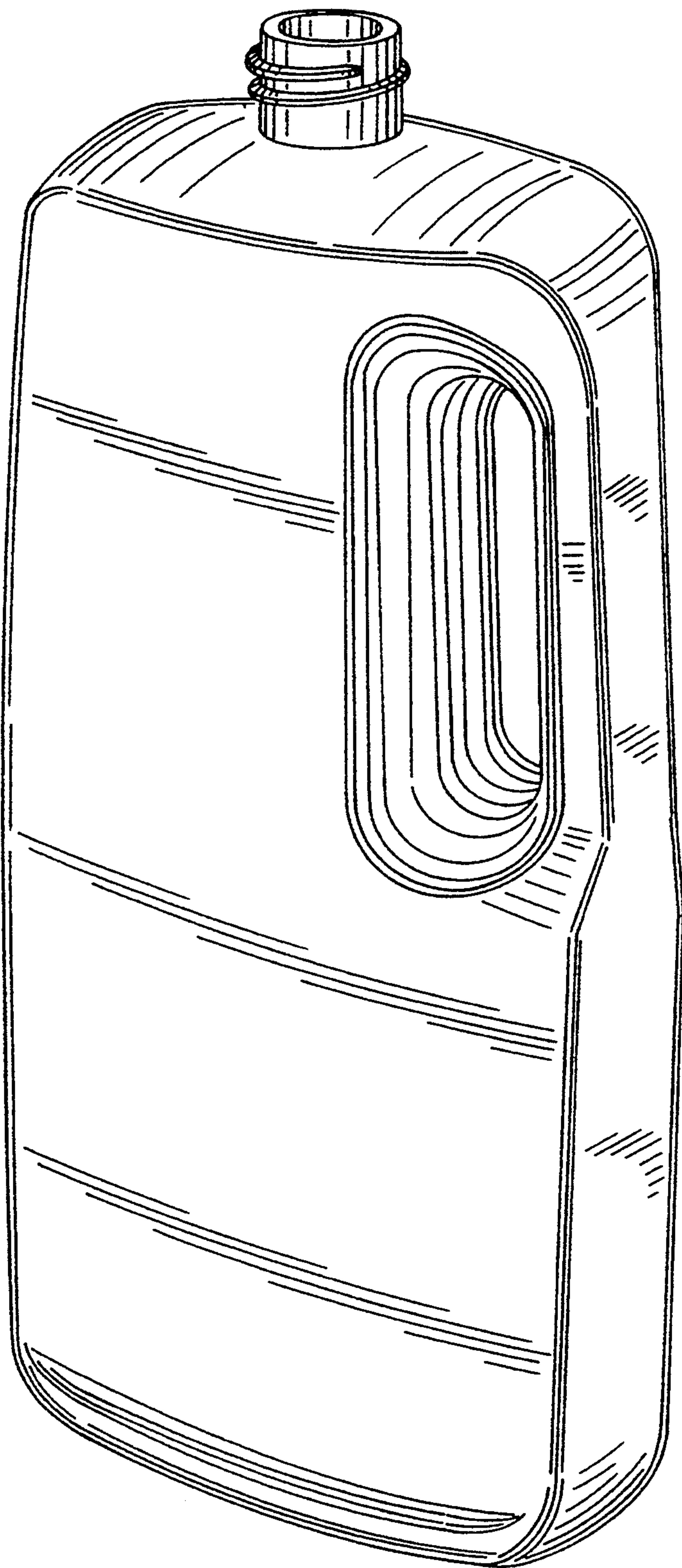

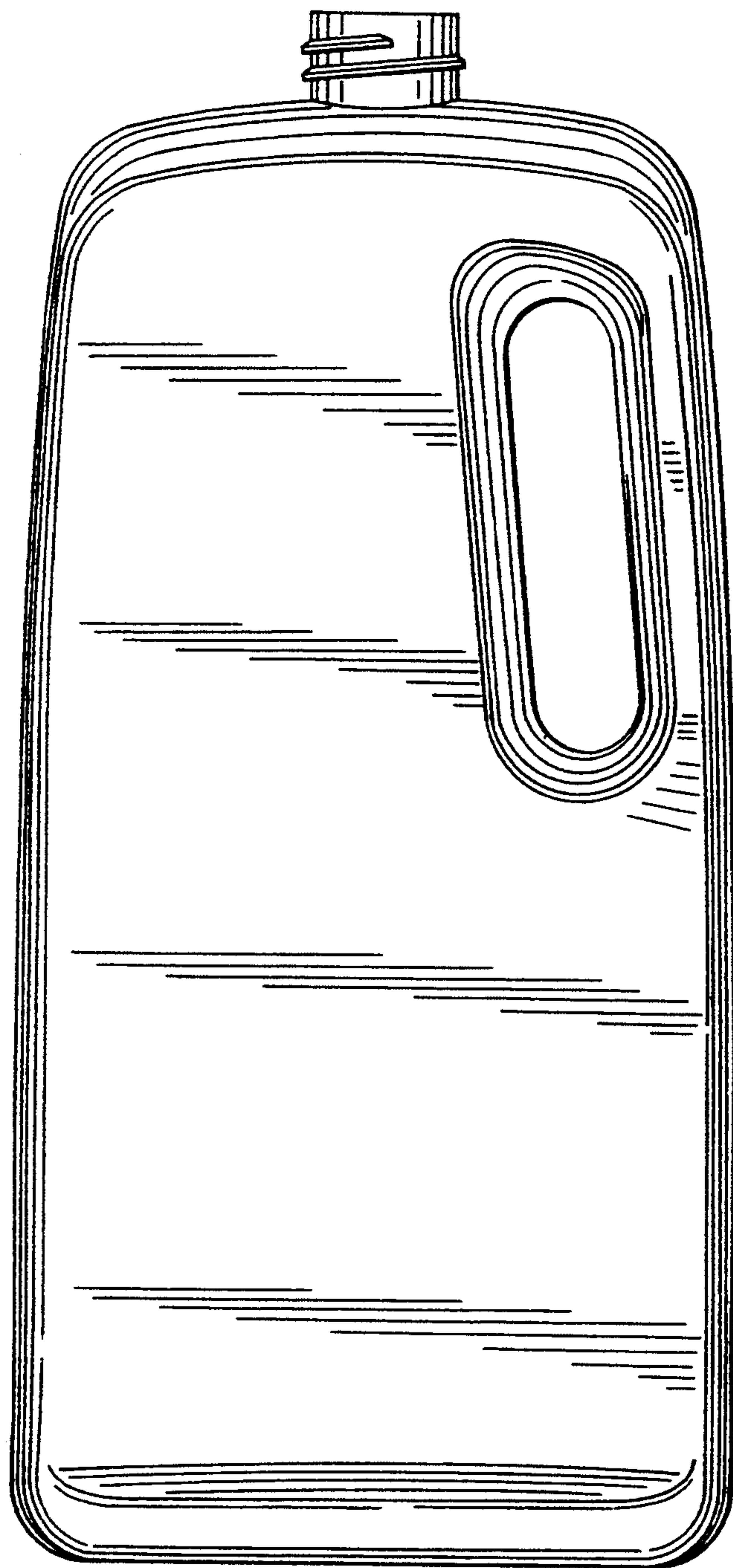

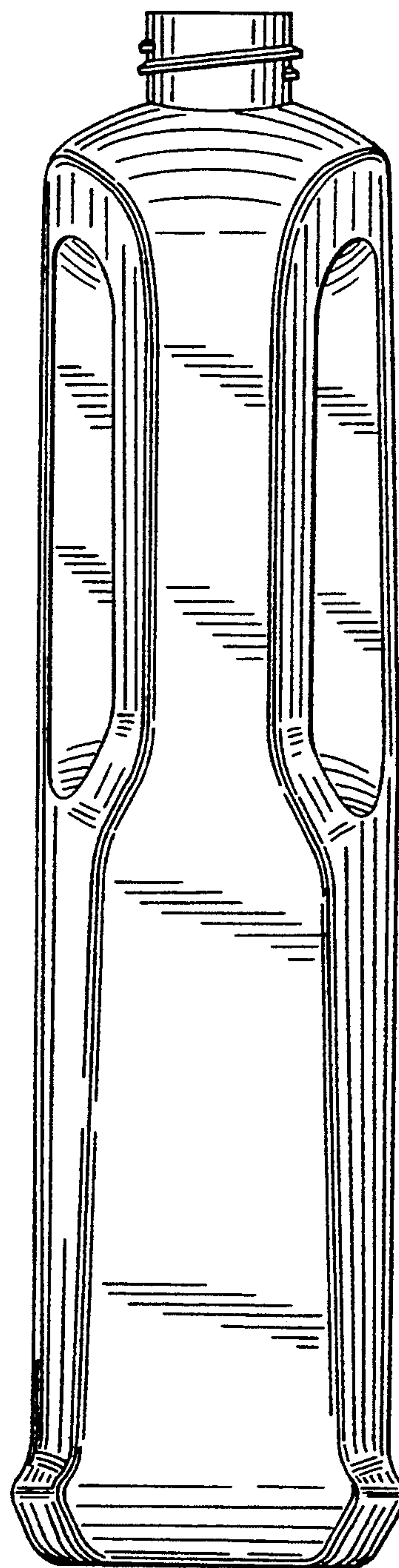

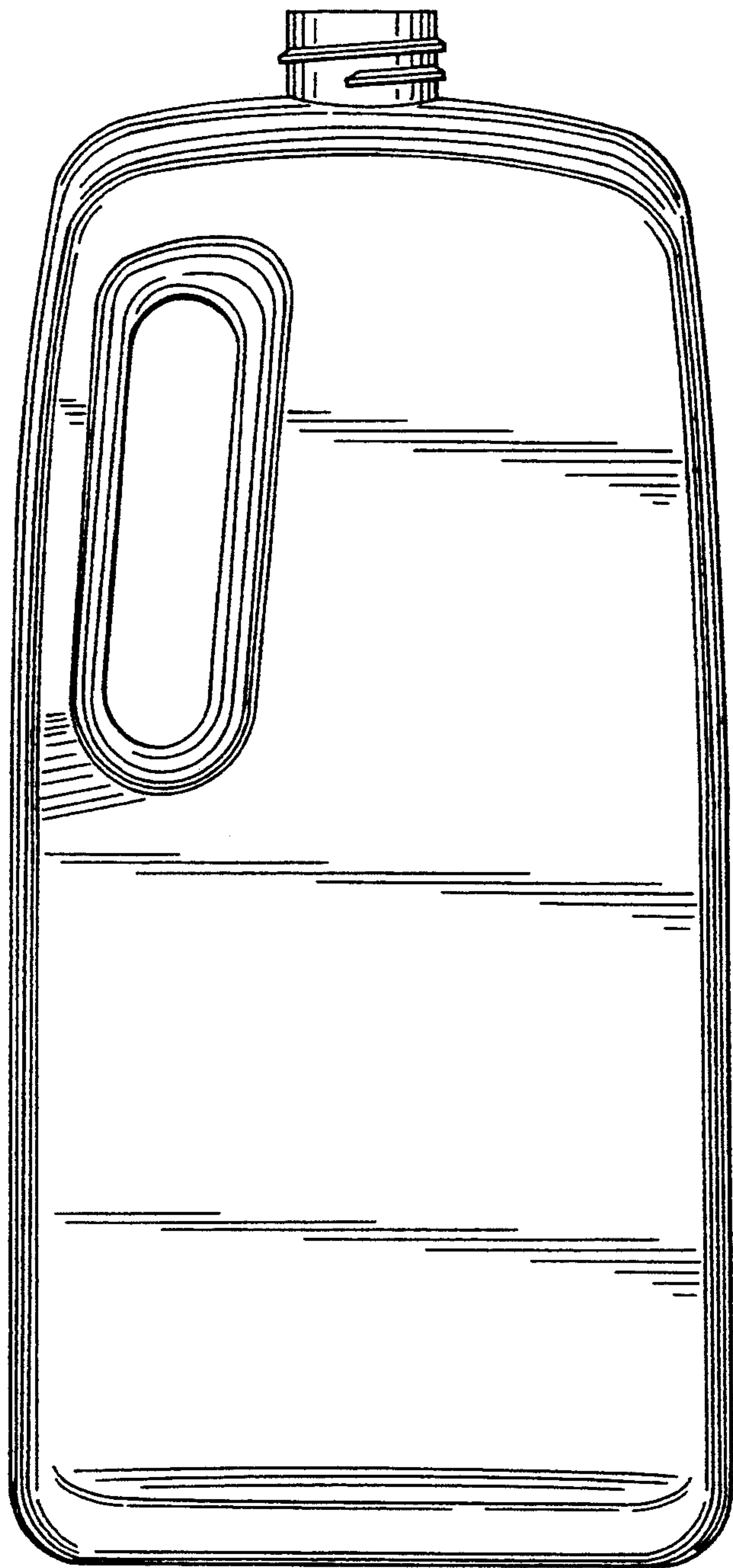

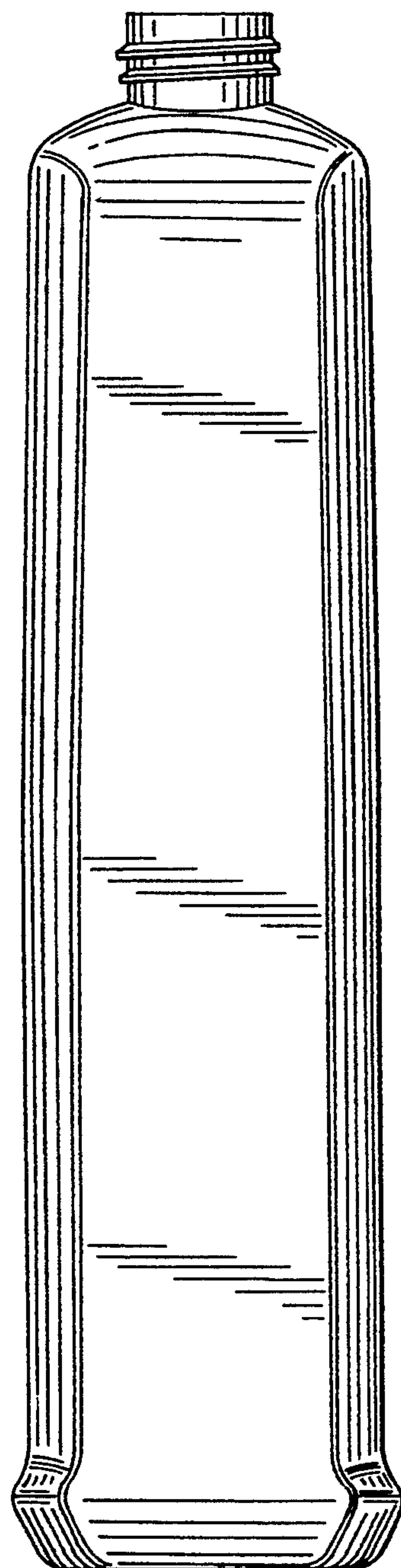

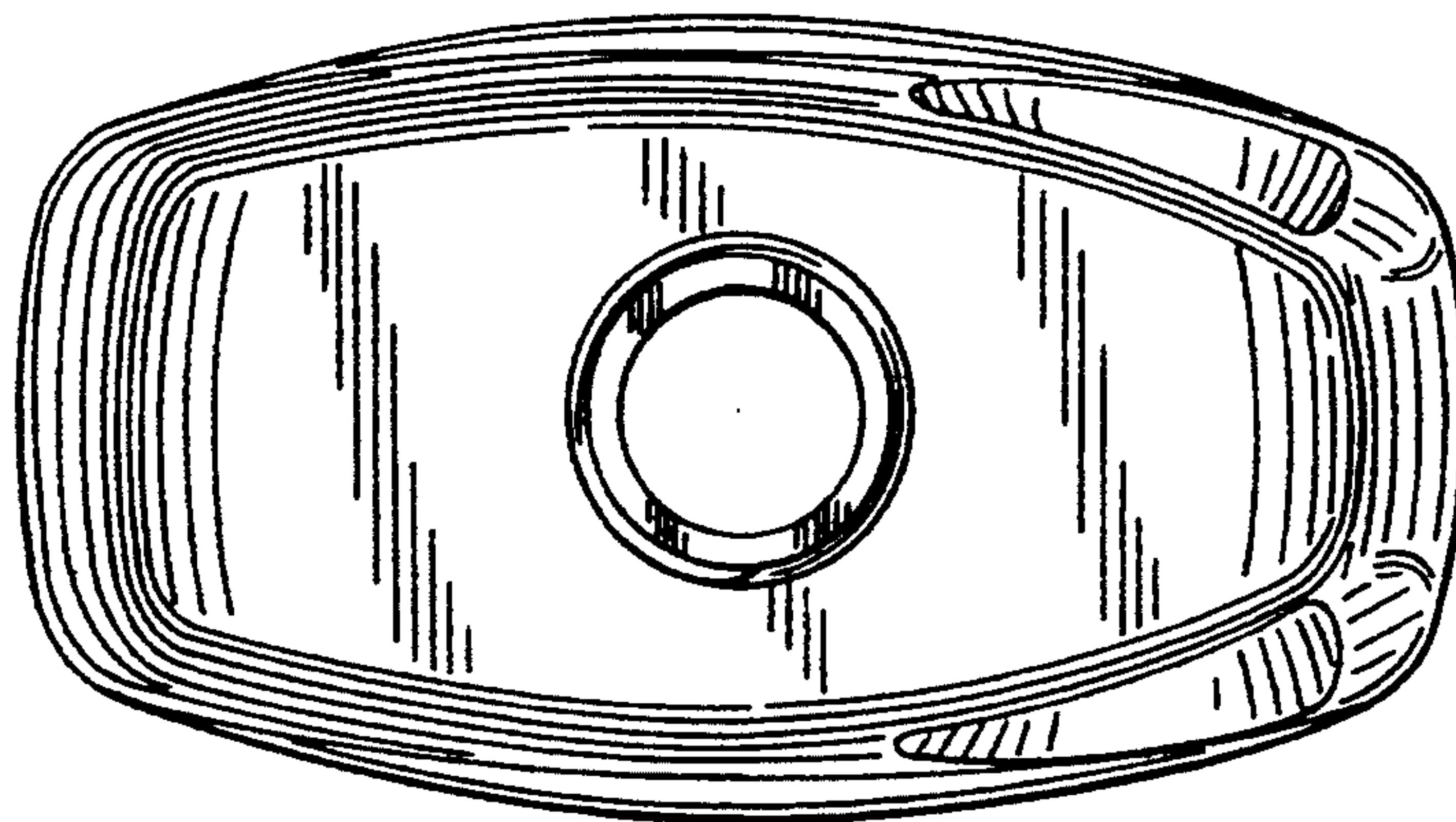
