### [57] CLAIM

The ornamental design of a collapsible holder for vehicles, as shown and described.

### DESCRIPTION

FIG. 1 is a top, front and right side perspective view of a collapsible holder for vehicles showing my new design;

FIG. 2 is a front elevation view of the collapsible holder depicted in FIG. 1;

FIG. 3 is a top plan view of the collapsible holder depicted in FIG. 1;

FIG. 4 is a right side elevation view of the collapsible holder depicted in FIG. 1, with a flexible attaching strap shown in broken lines and for illustrative purposes only and forming no part of the claimed design;

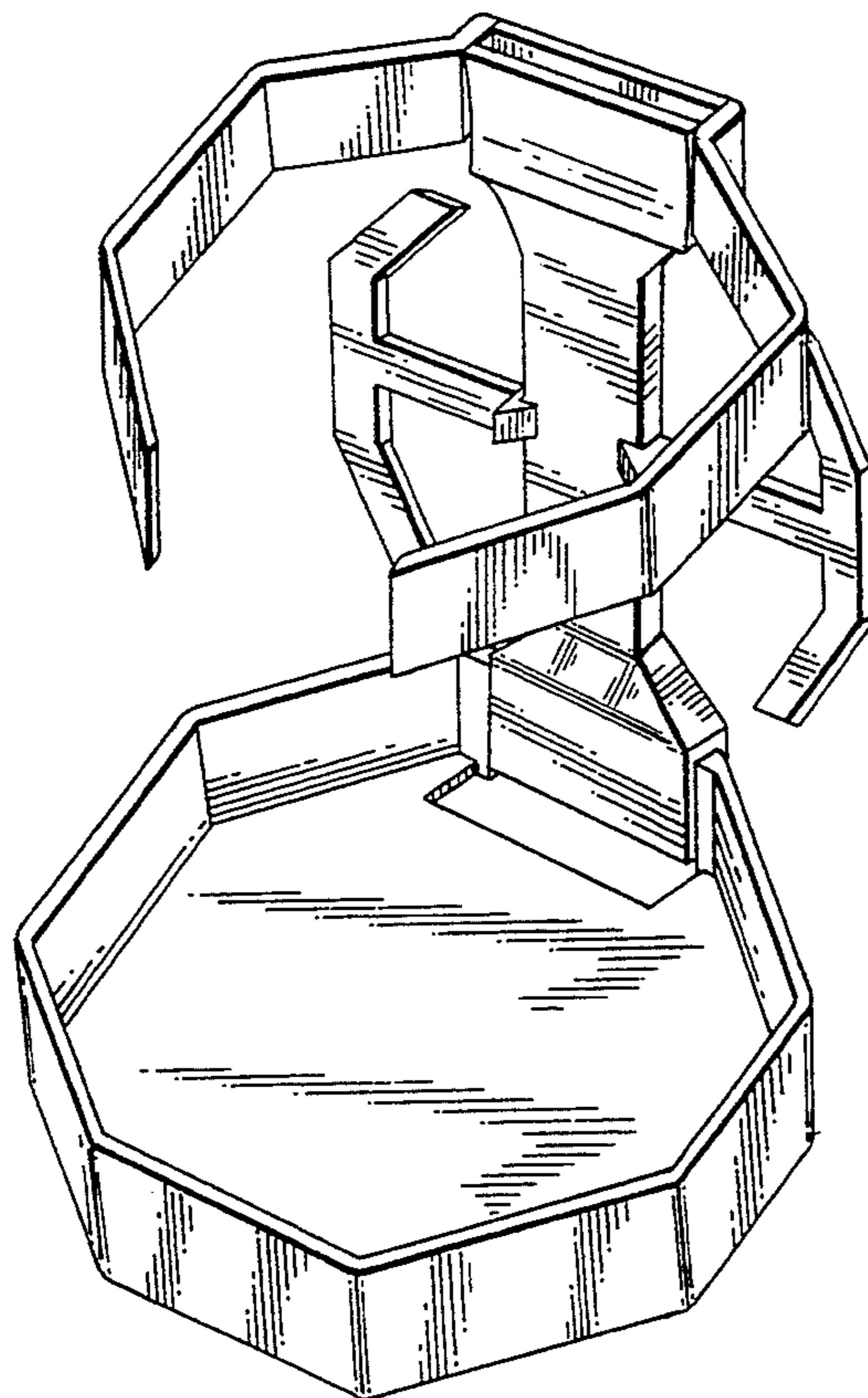
FIG. 5 is a rear elevation view of the collapsible holder depicted in FIG. 1;

FIG. 6 is a bottom plan view of the collapsible holder depicted in FIG. 1;

FIG. 7 is a side cross-sectional elevation view of the collapsible holder depicted in FIG. 1 taken along the line 7—7 of FIG. 3;

FIG. 8 is a front elevation of the collapsible holder of the present invention depicted in FIG. 1 but in a folded up position; and,

FIG. 9 is a side cross-sectional elevation view of the collapsible holder depicted in FIG. 8 taken along the line 9—9 of FIG. 8.



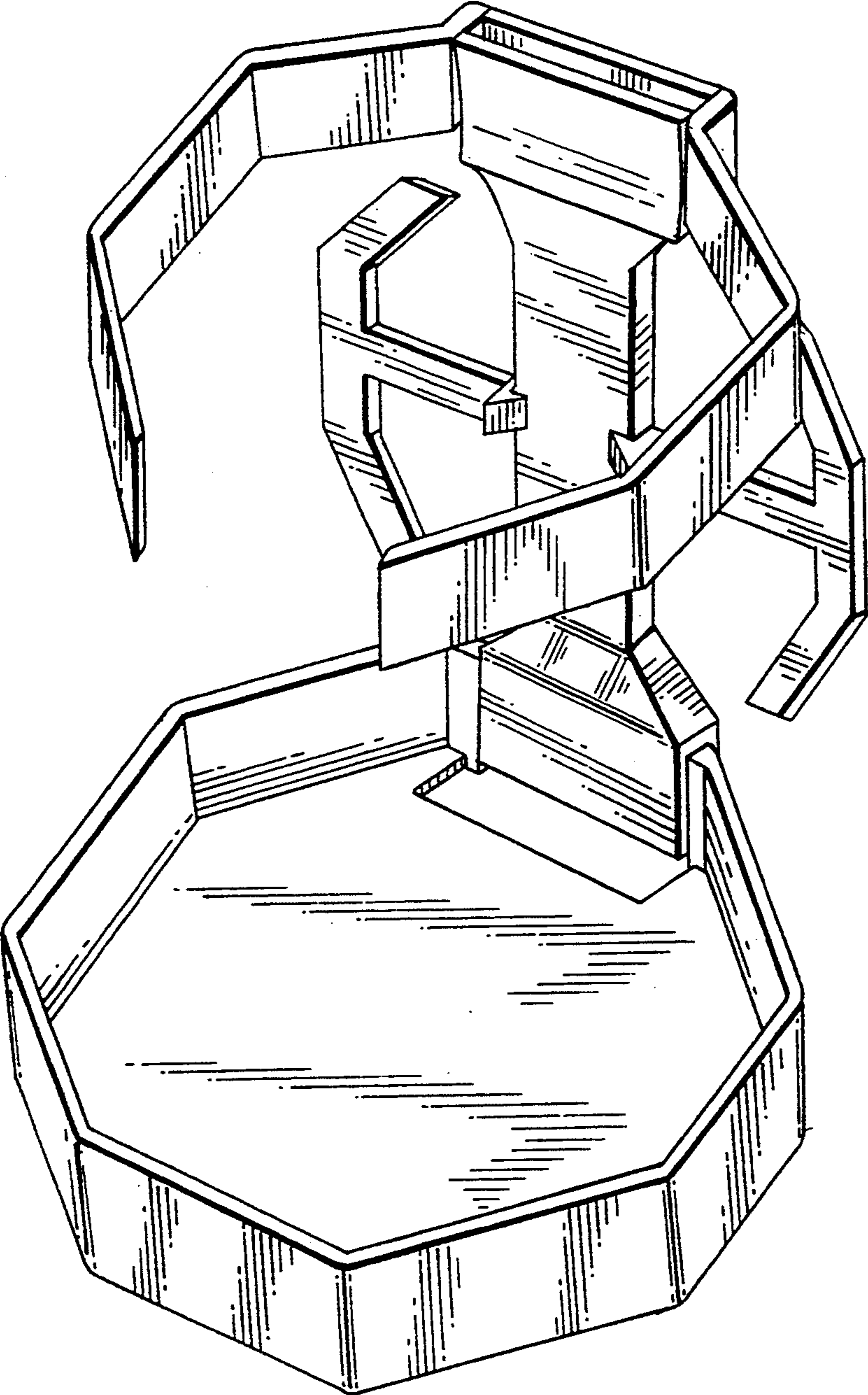

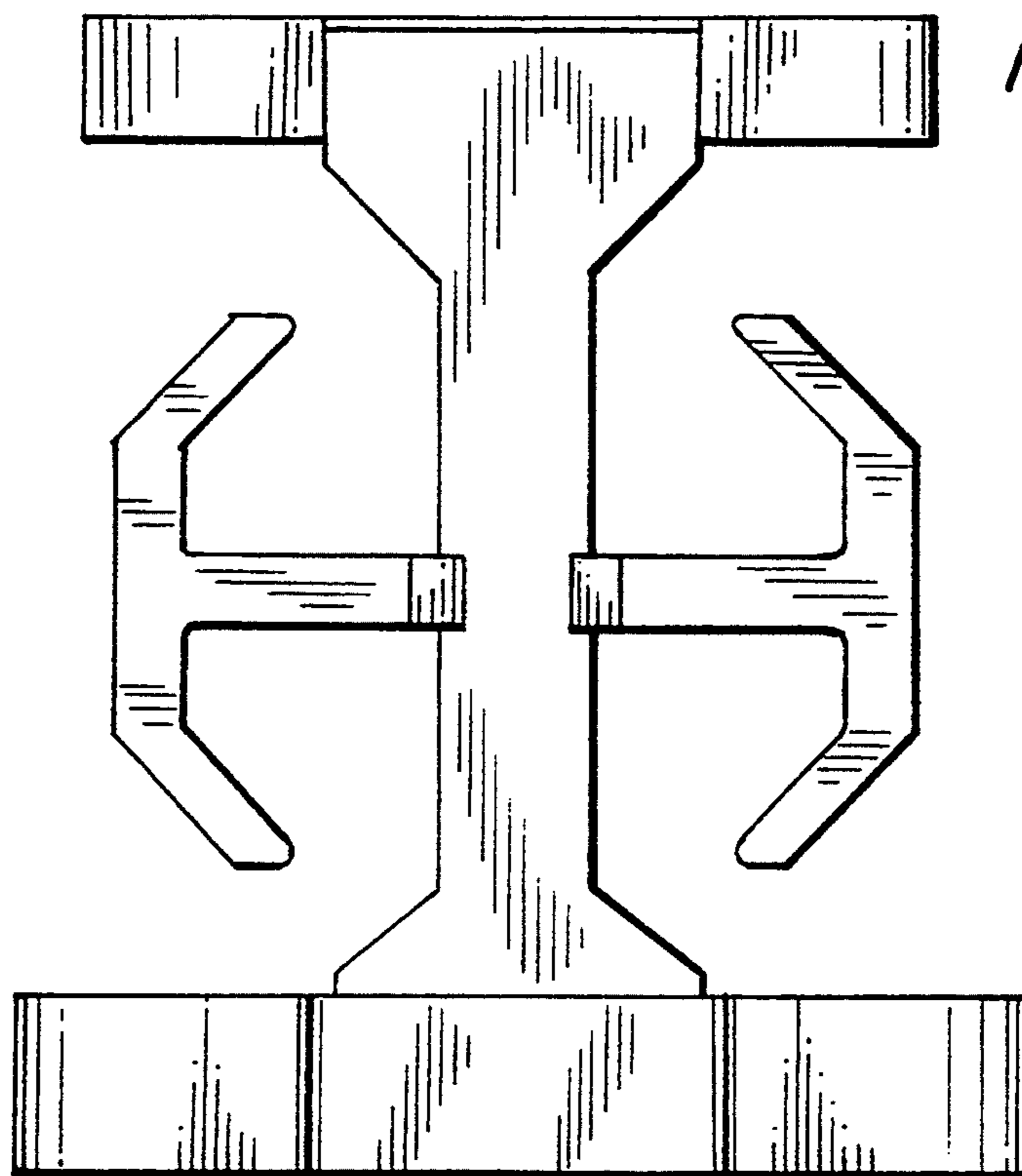

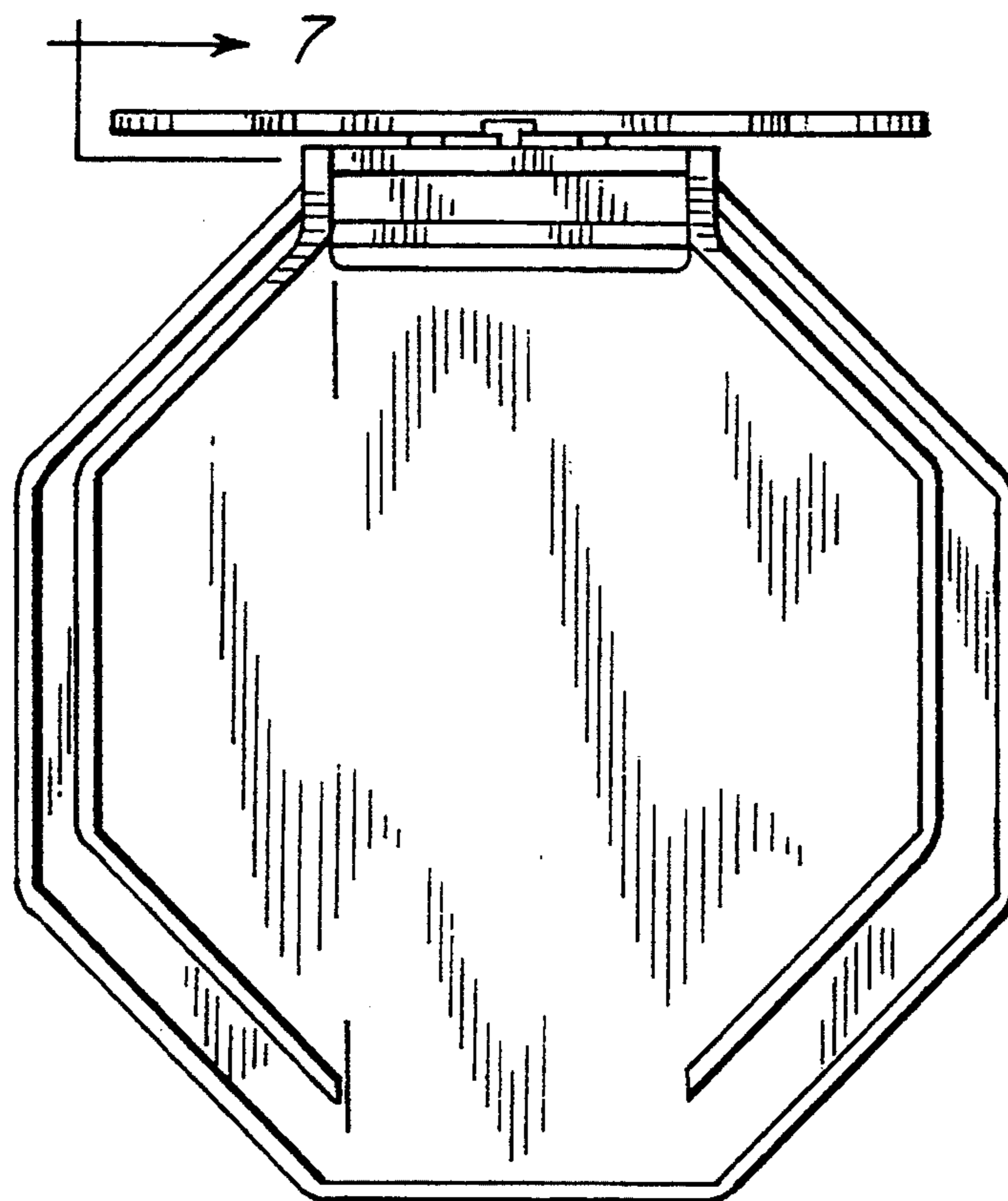

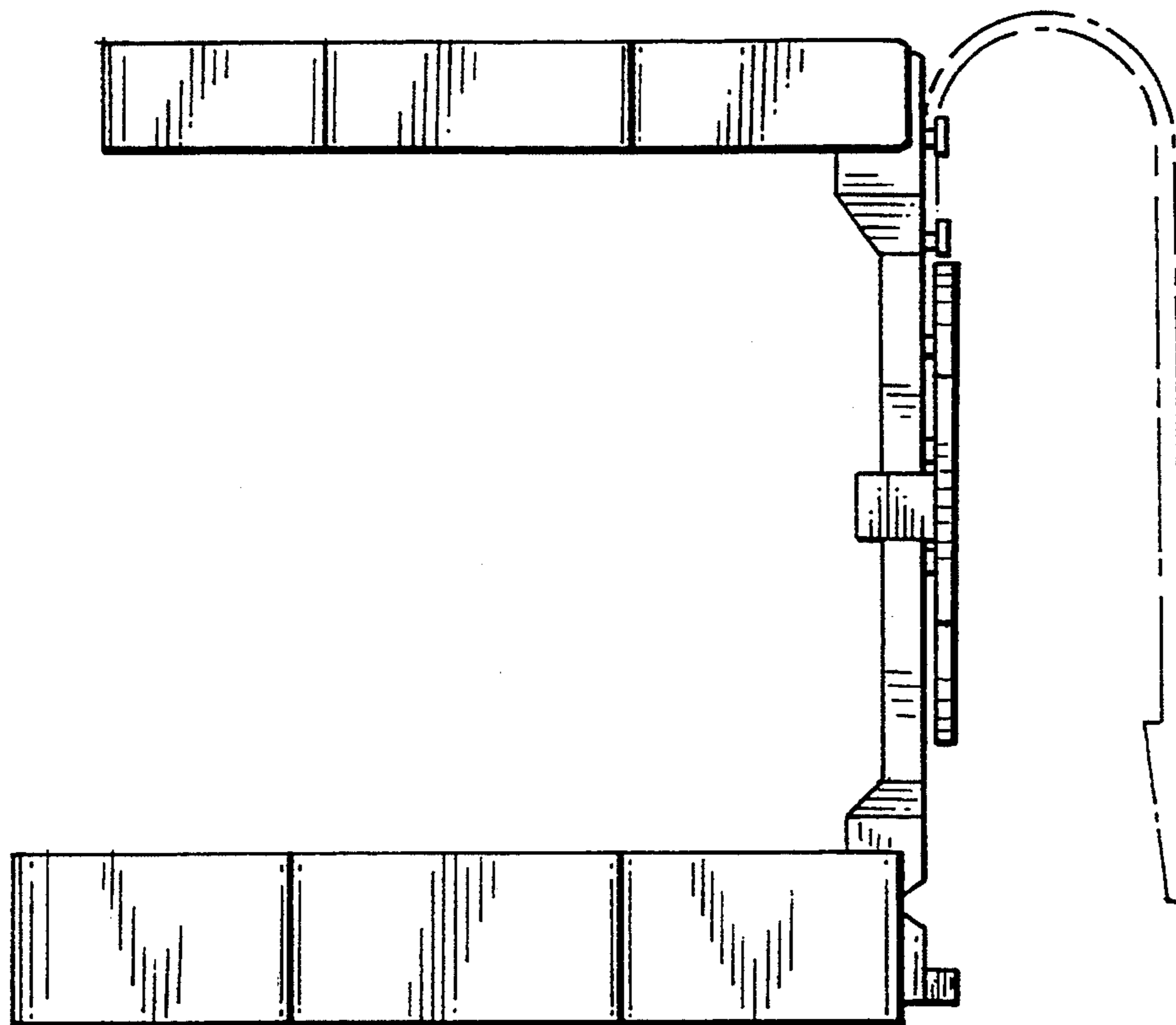

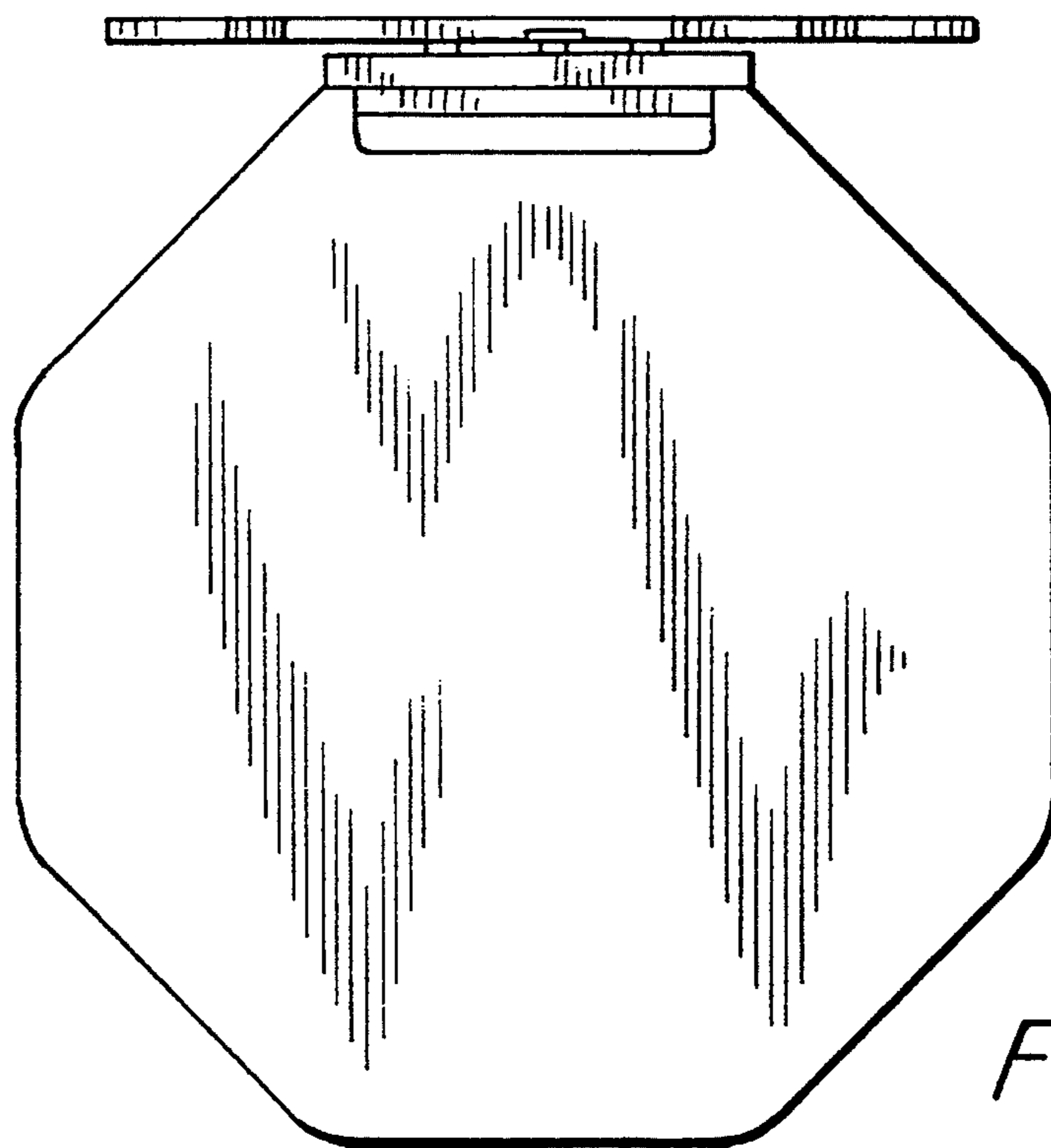

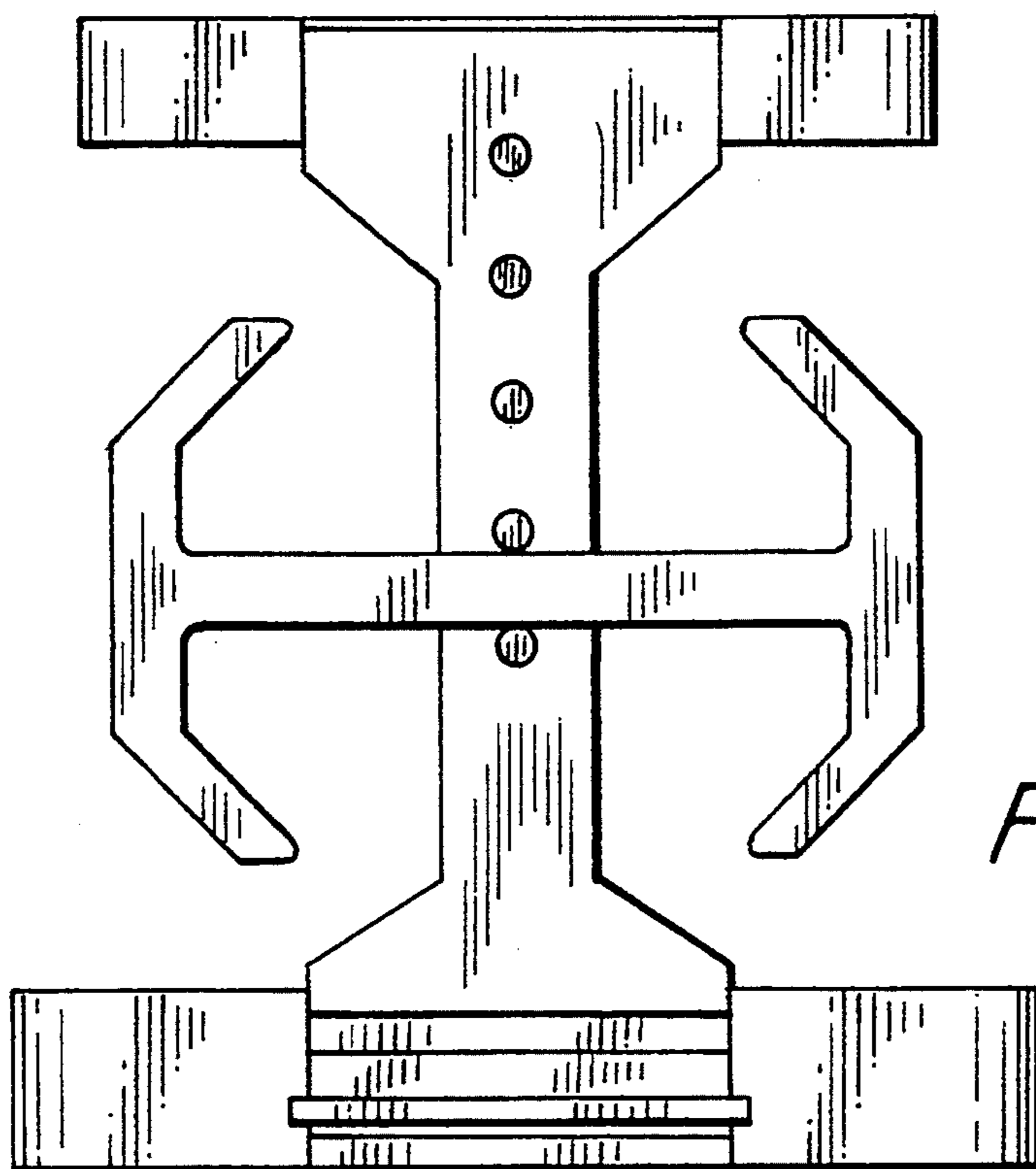

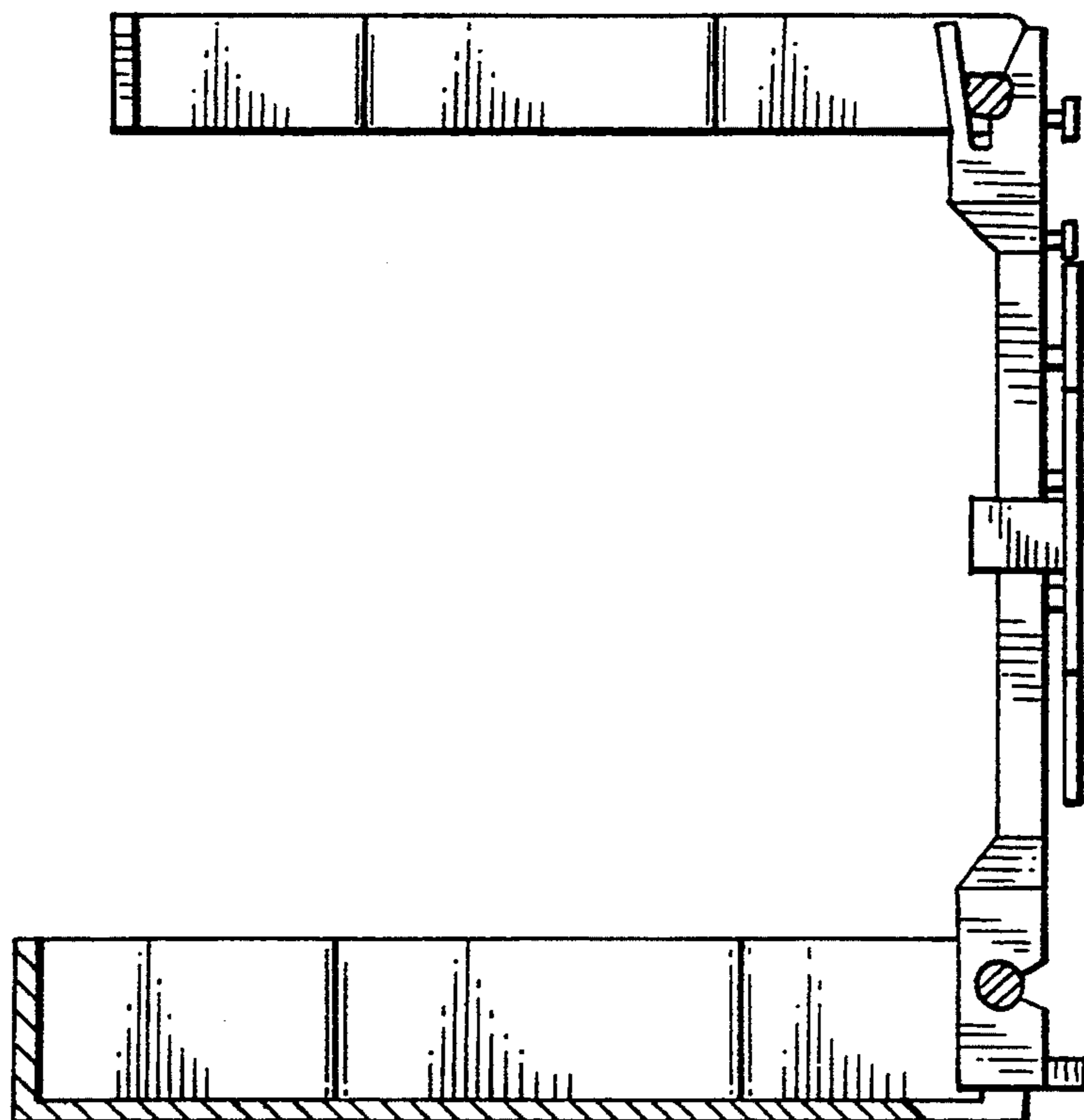

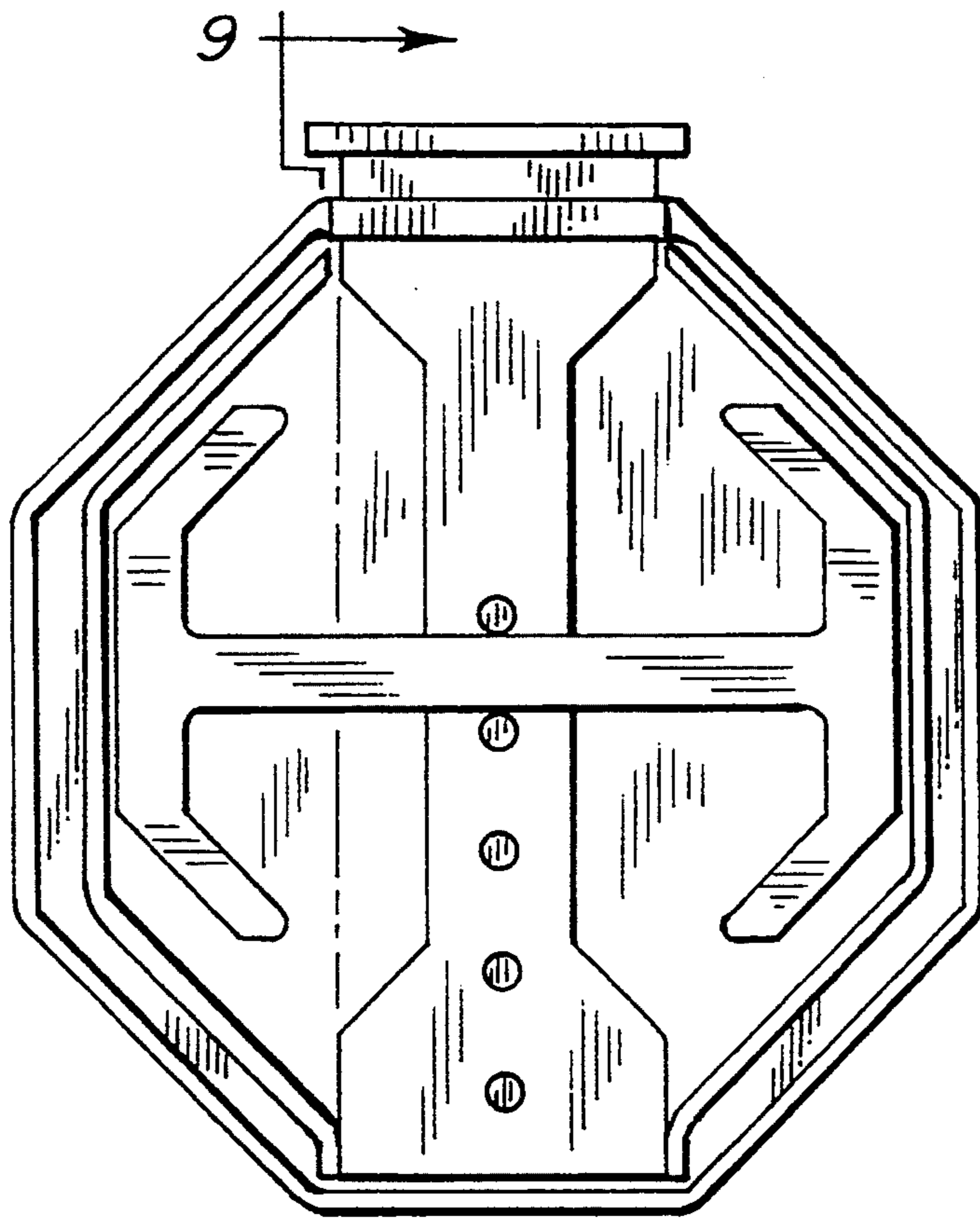

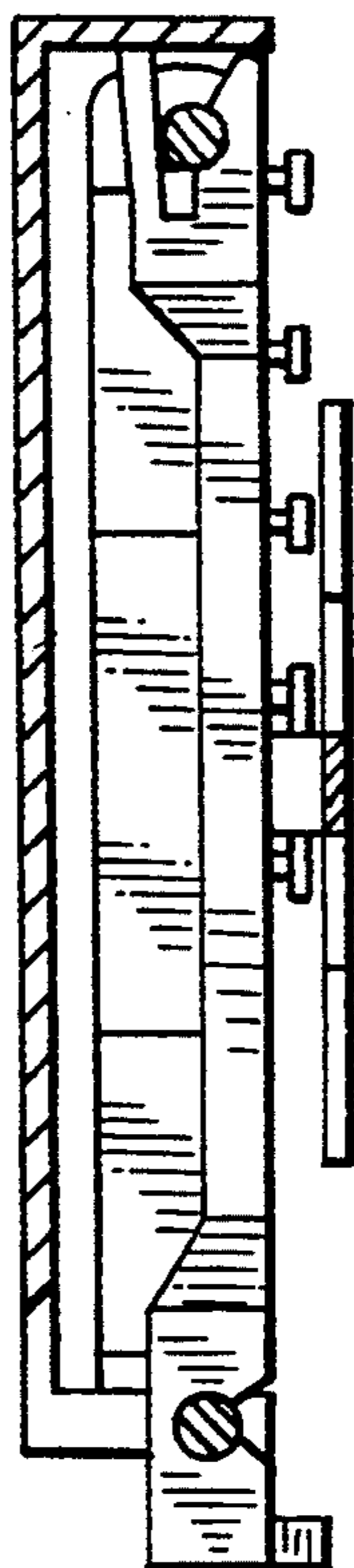
