FIG. 6 is a right side elevational view thereof;

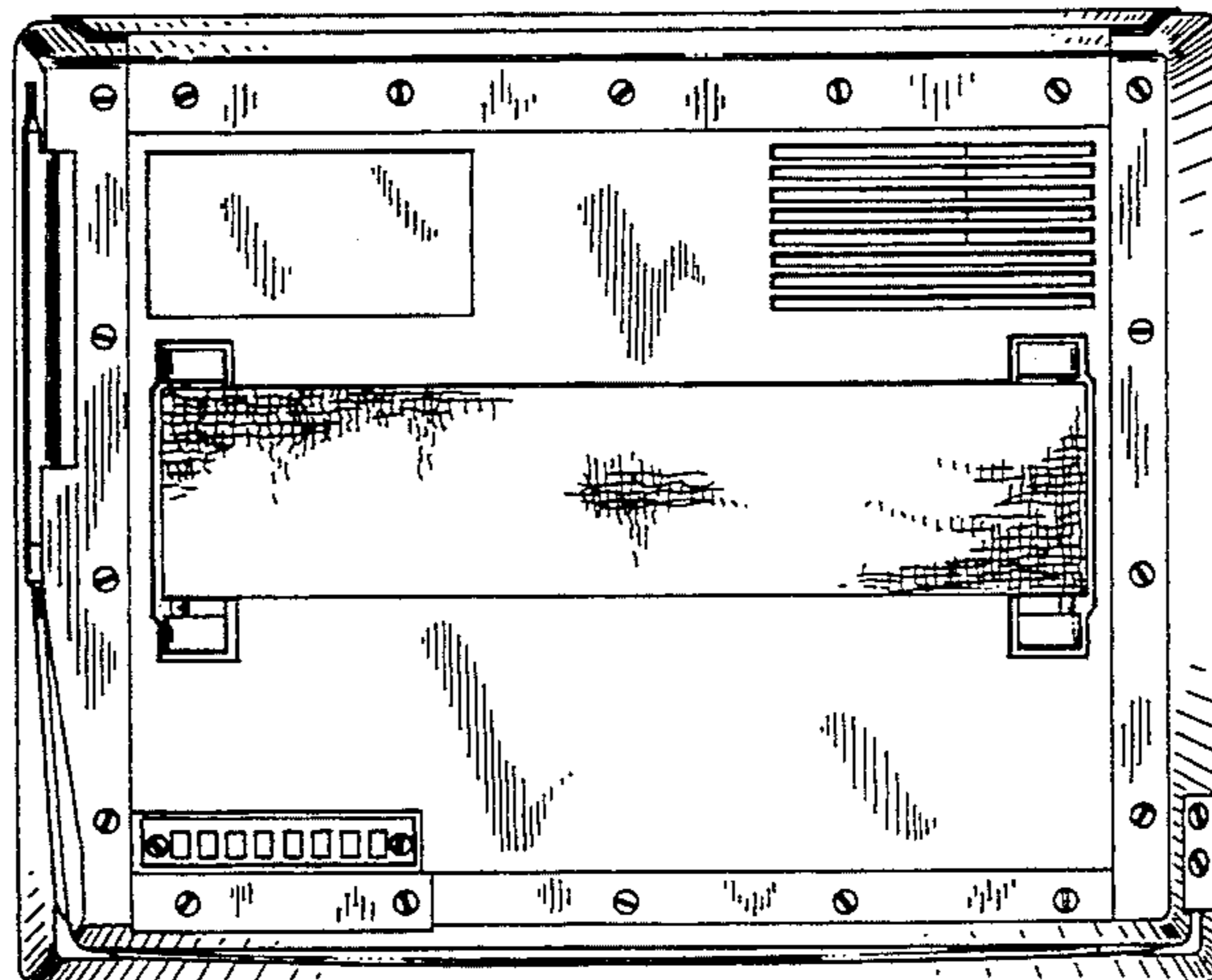
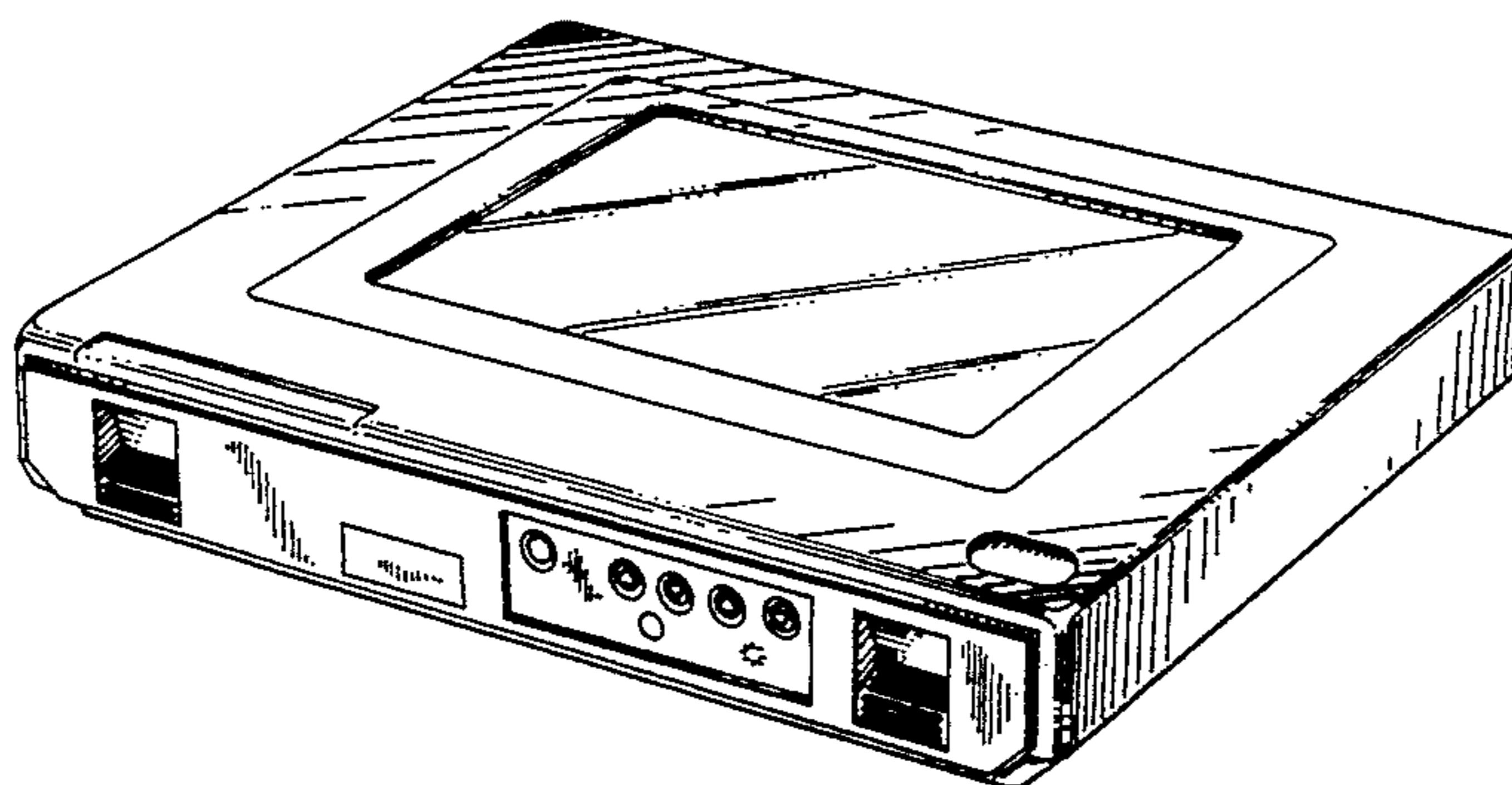
FIG. 7 is a left side elevational view thereof wherein the stylus is shown recessed within a snap-in holder pocket; and,

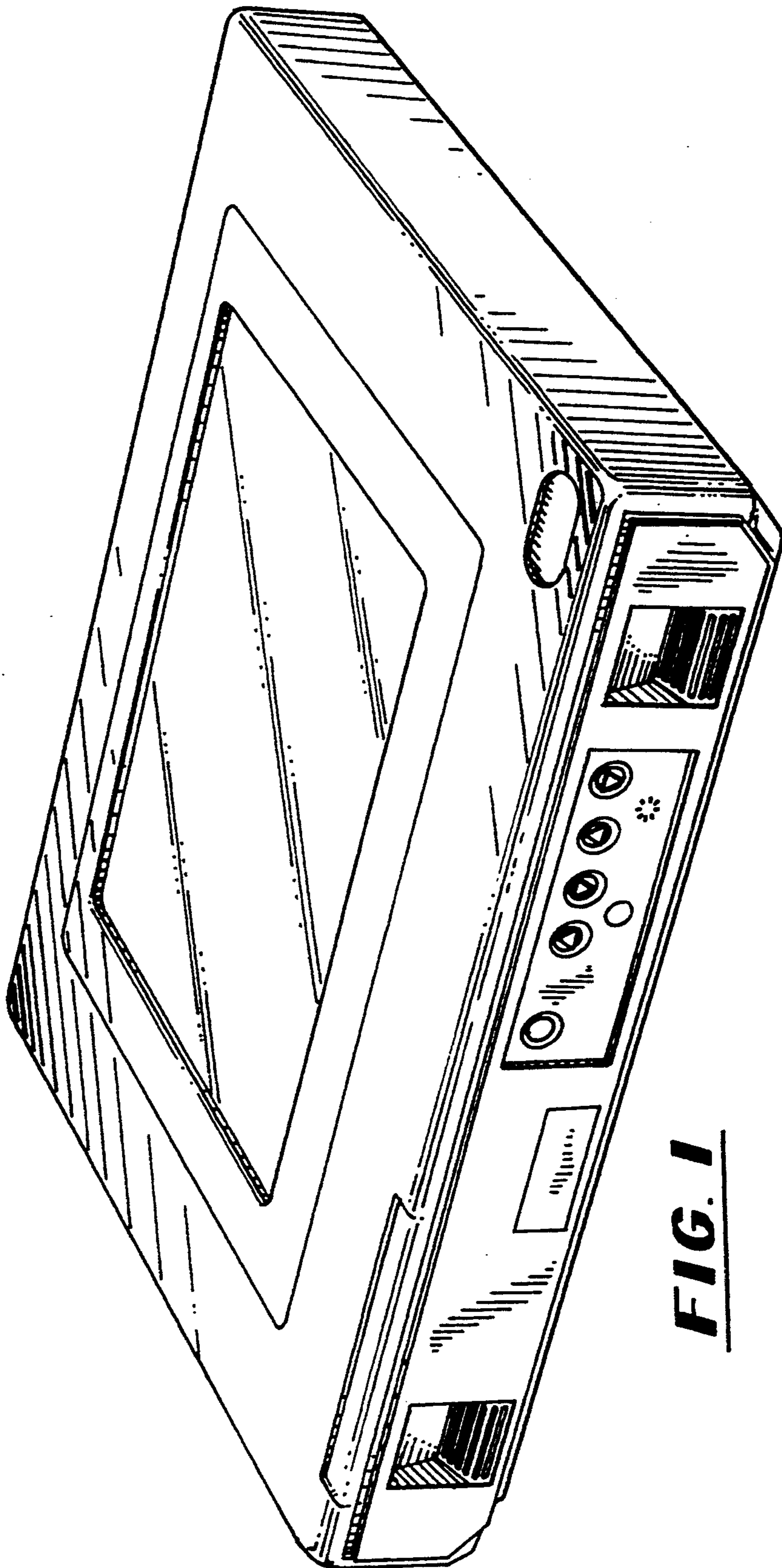

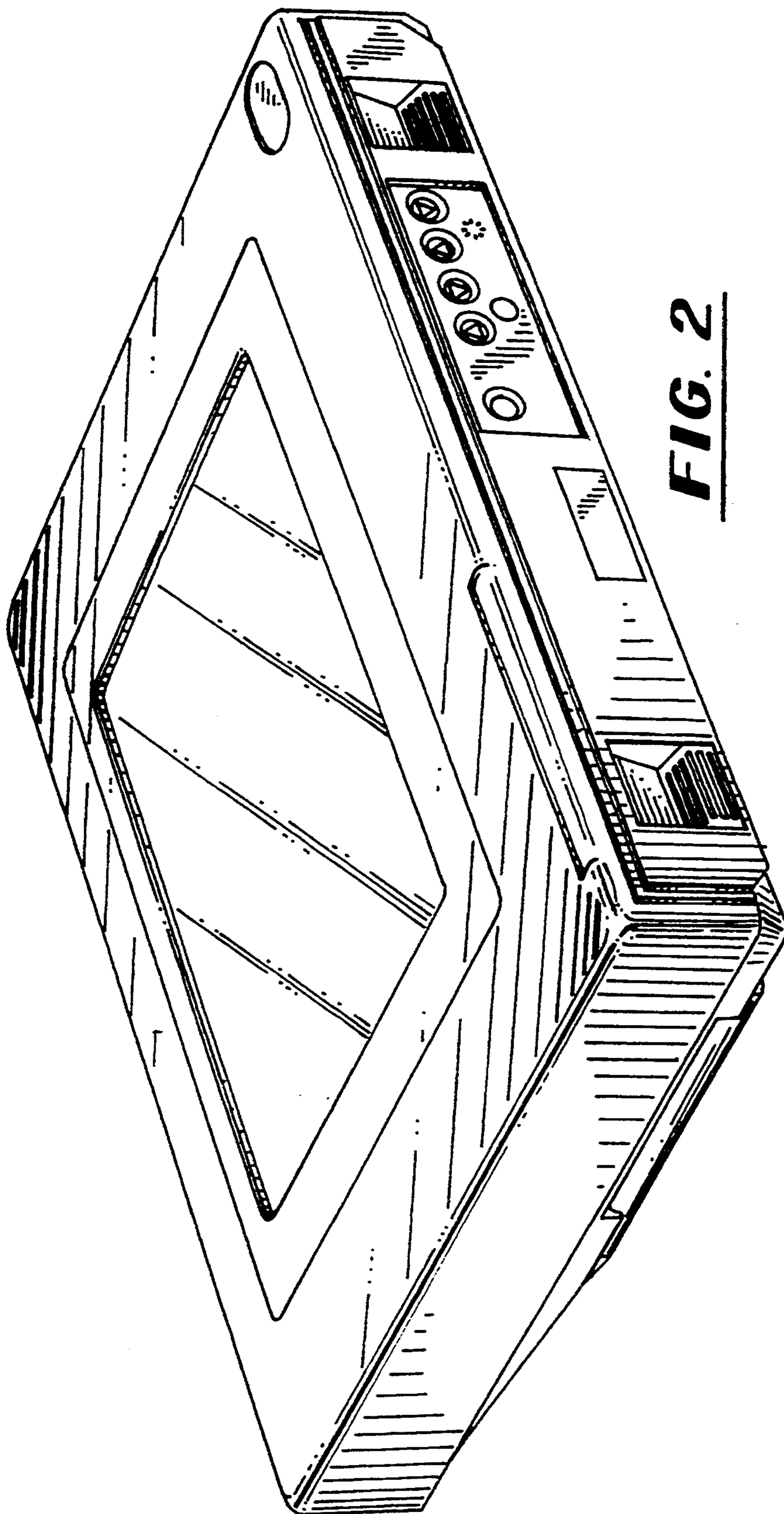

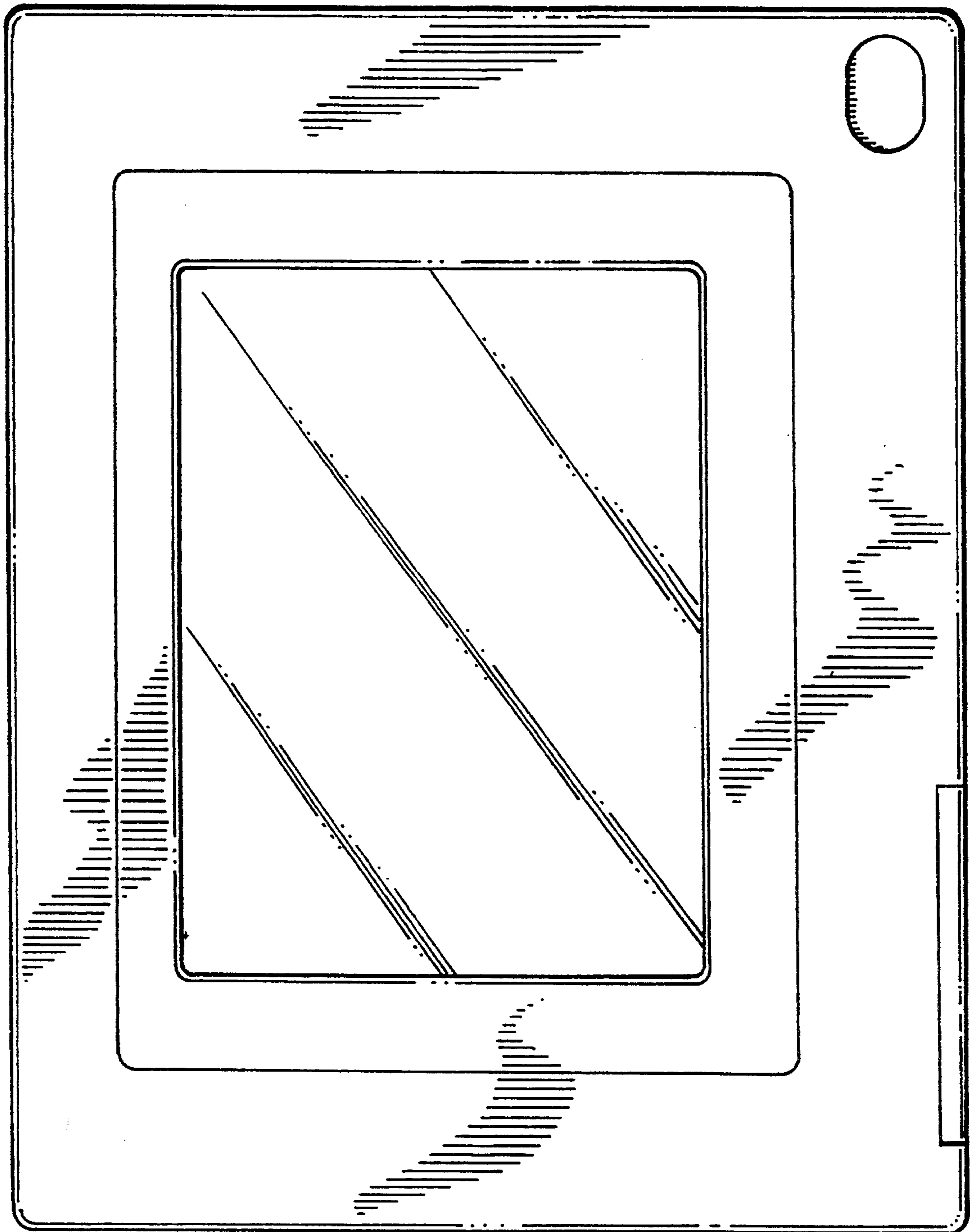

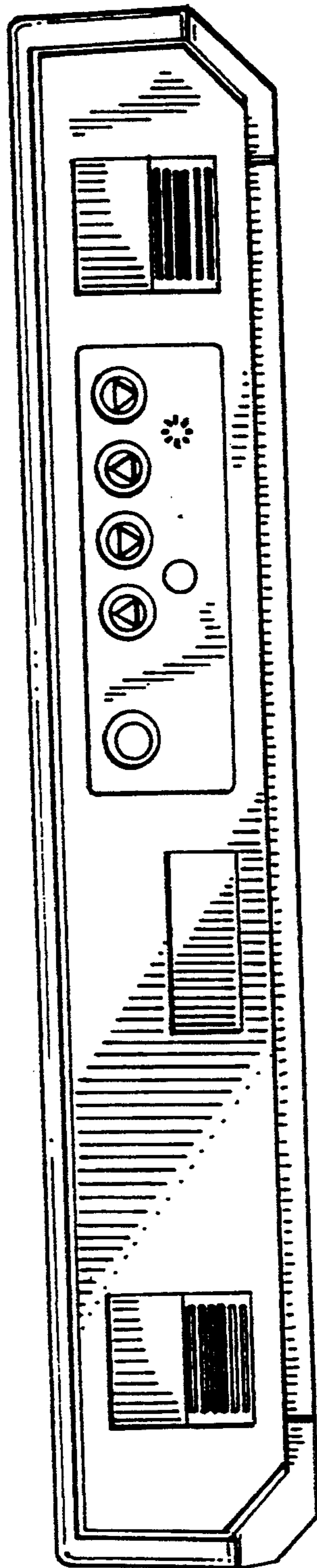

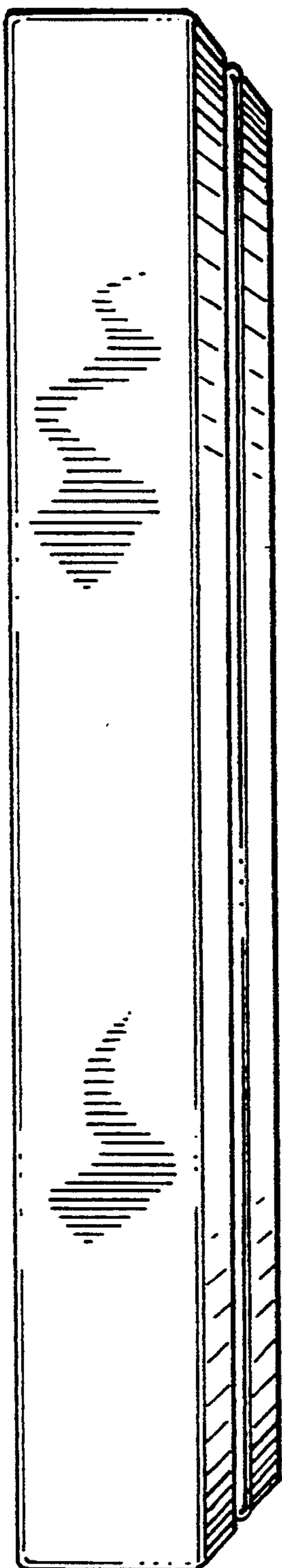

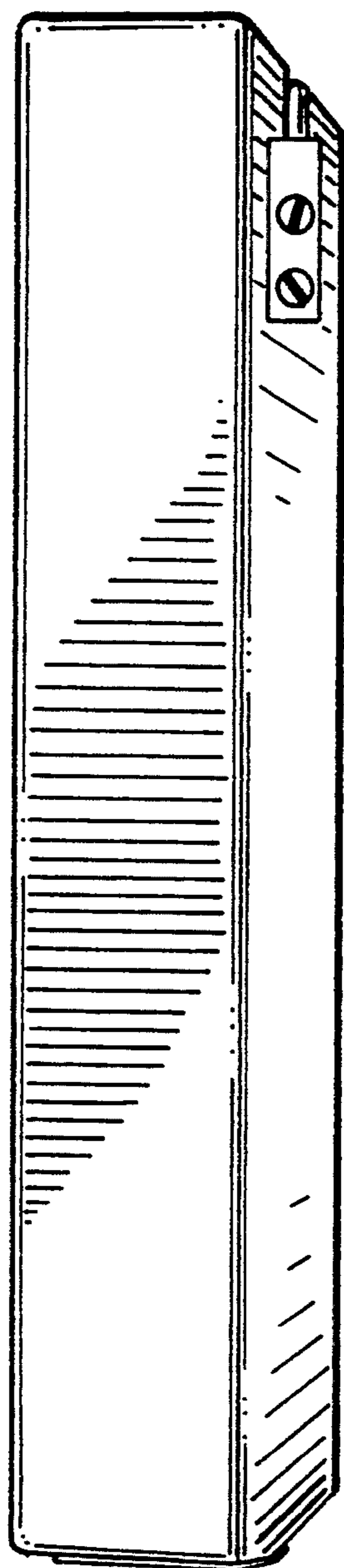

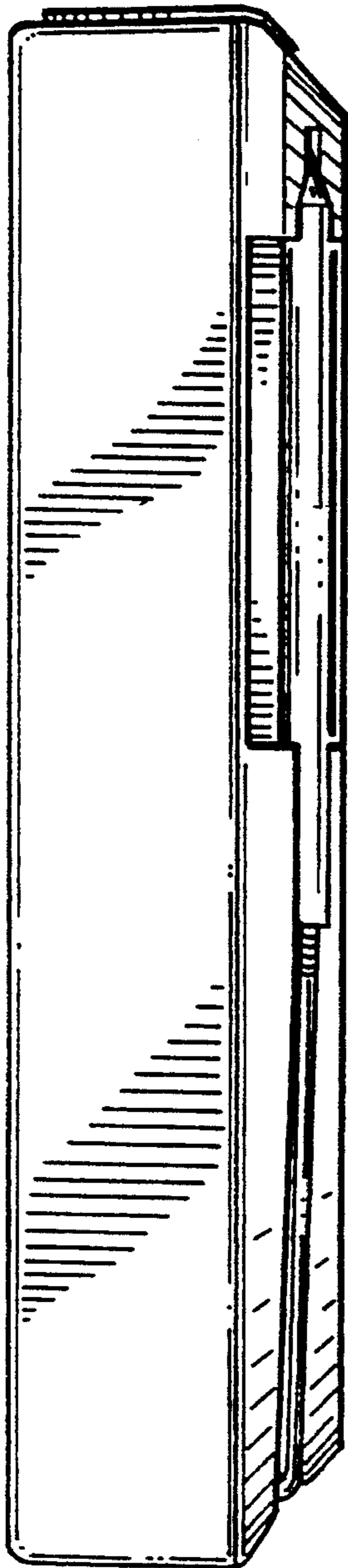

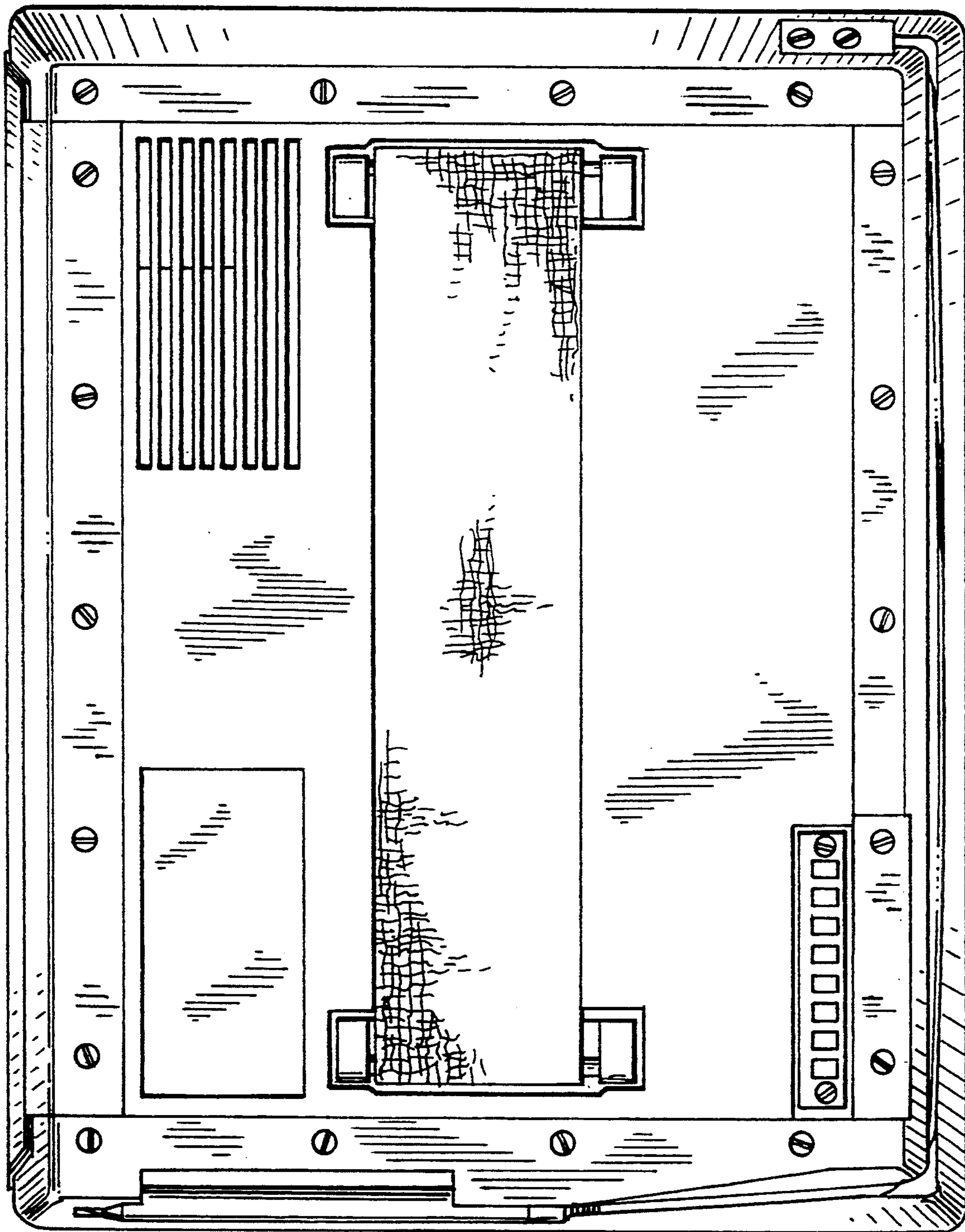
