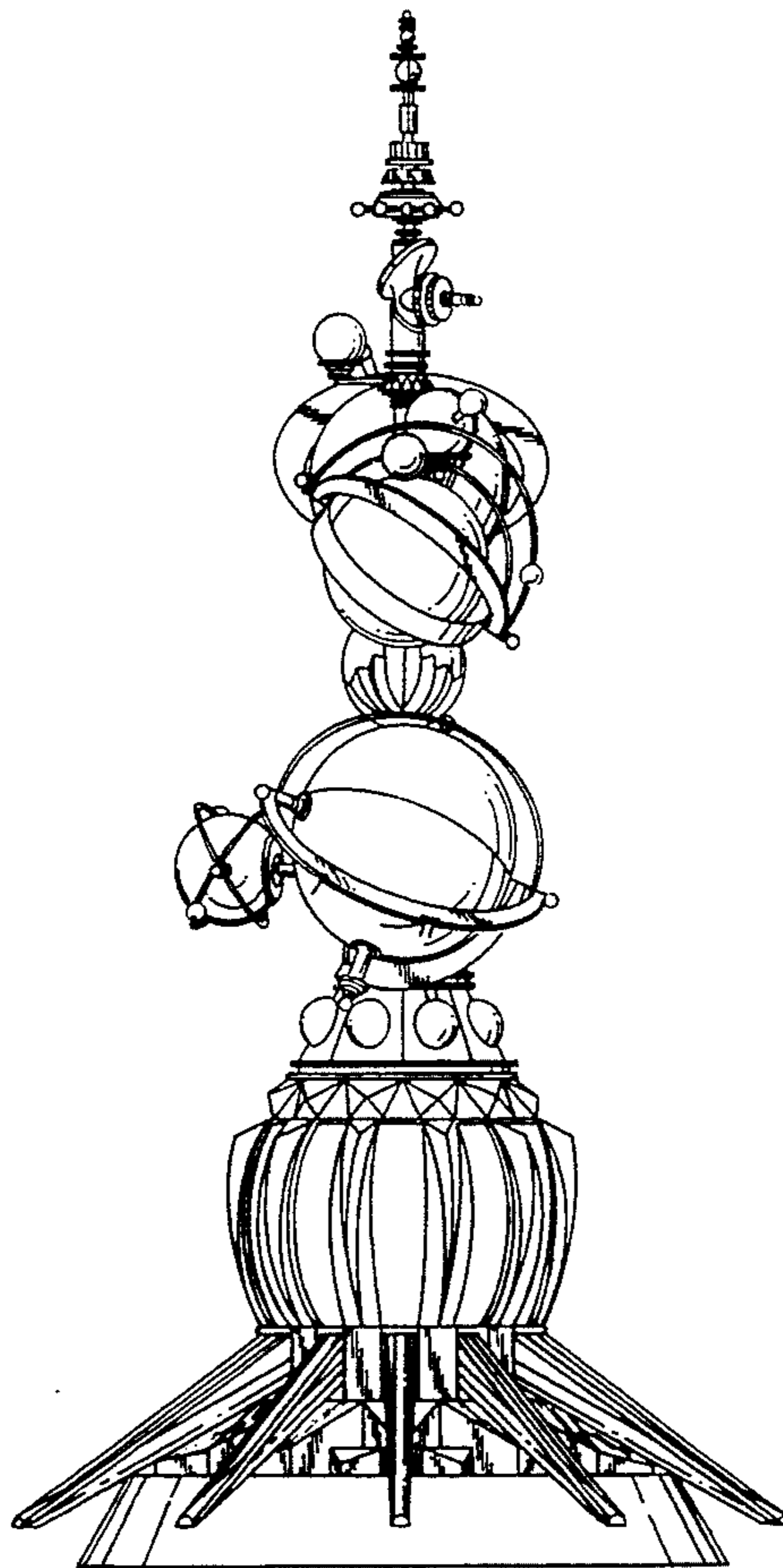

[57] **CLAIM**

The ornamental design for a spaceship amusement ride, as shown and described.

**DESCRIPTION**

FIG. 1 is a front elevational view of an spaceship amusement ride showing our new design; FIG. 2 is a left side elevational view thereof; FIG. 3 is a right side elevational view thereof; FIG. 4 is a rear elevational view thereof; and, FIG. 5 is a top plan view thereof. The broken line showing of space vehicles in FIG. 1 is for illustrative purpose only and forms no part of the claim.



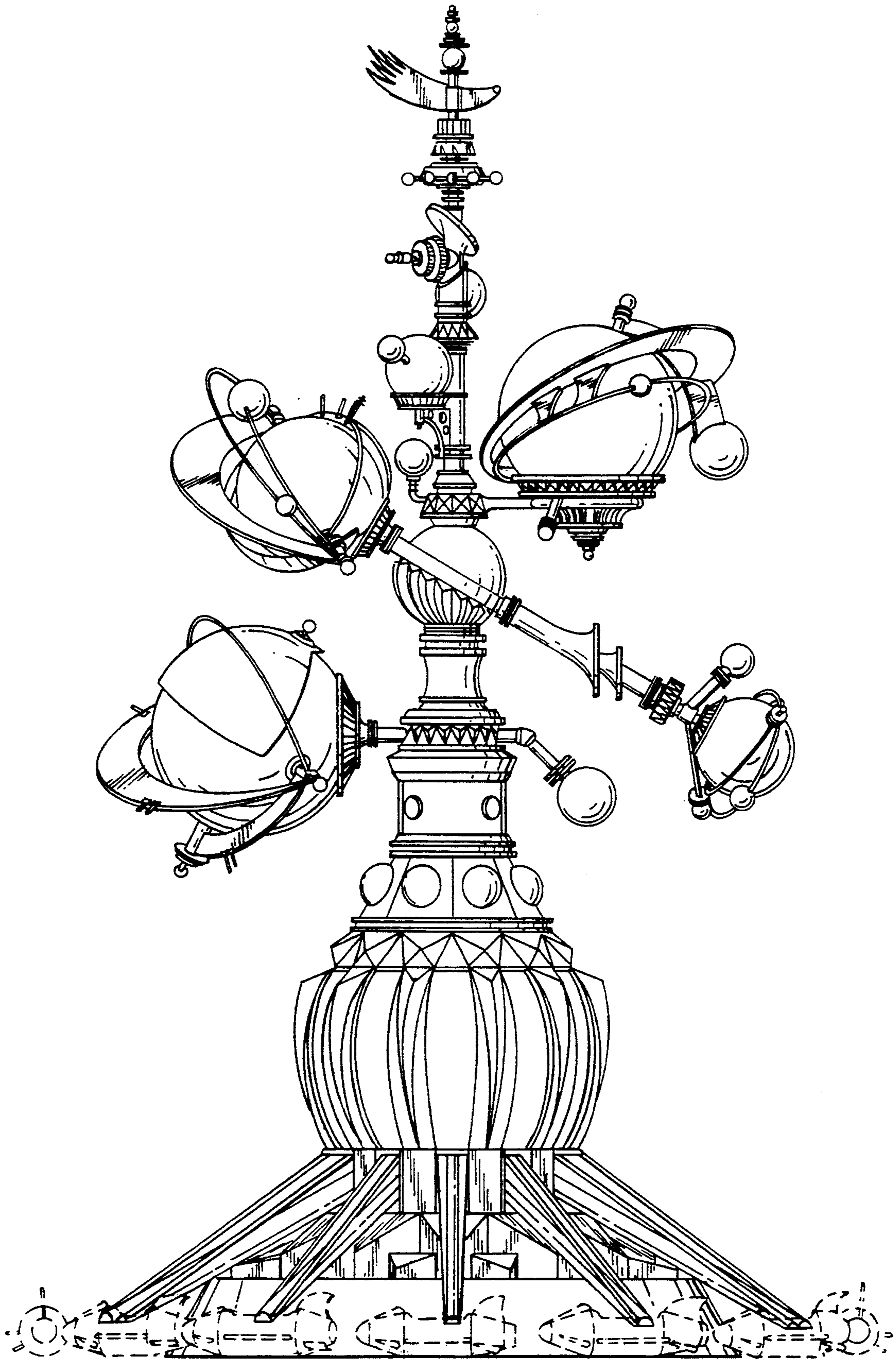
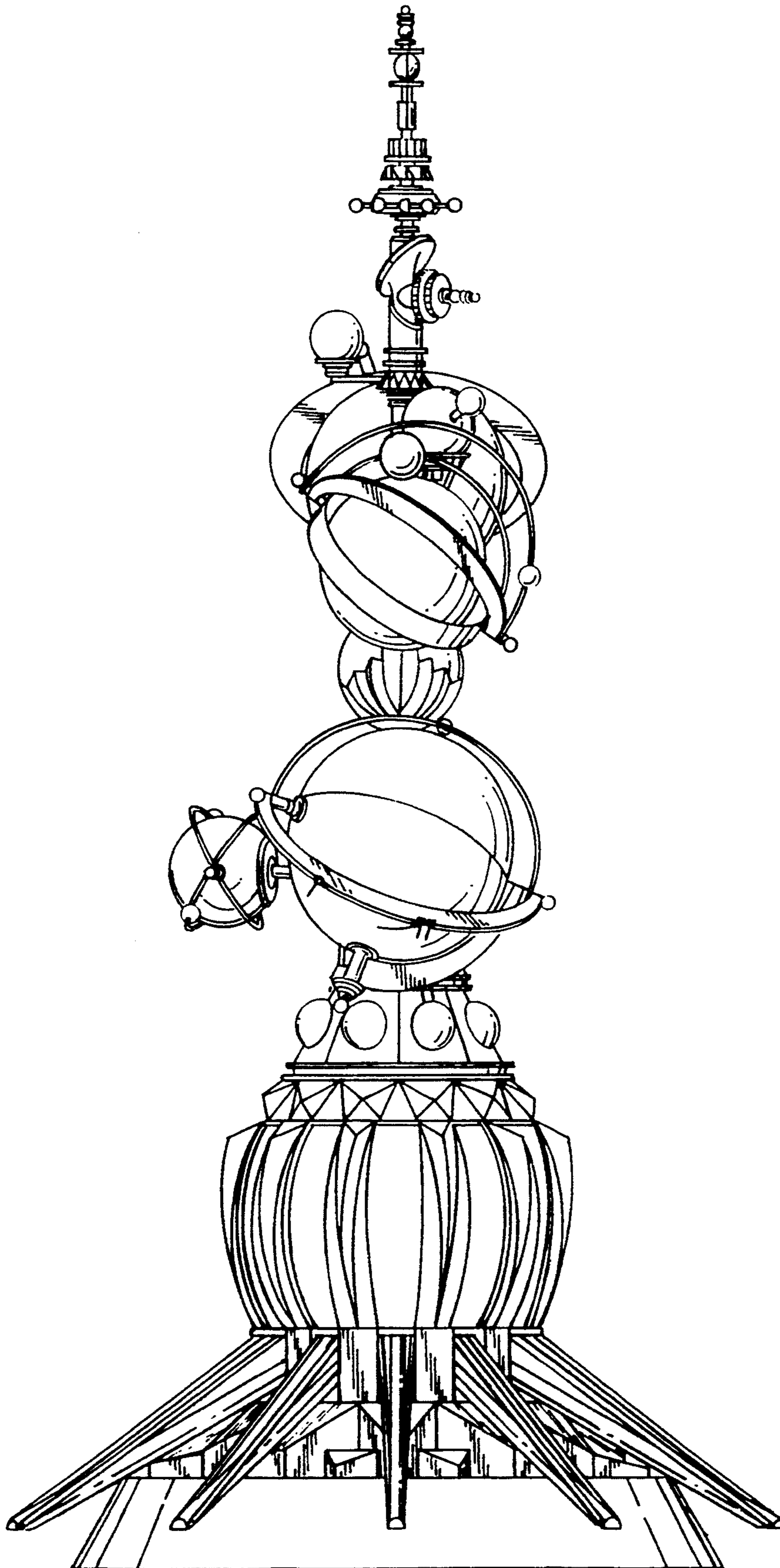

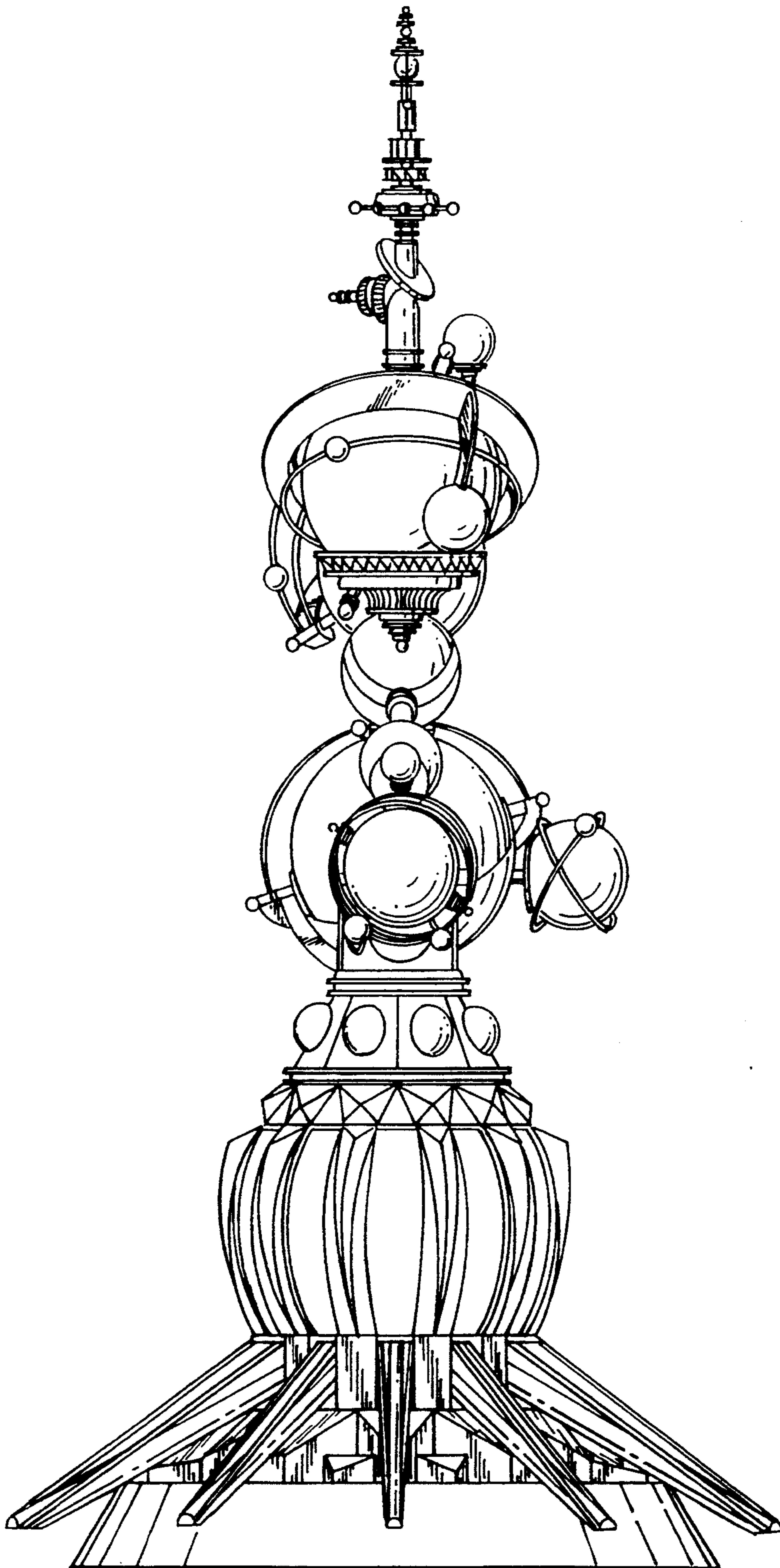

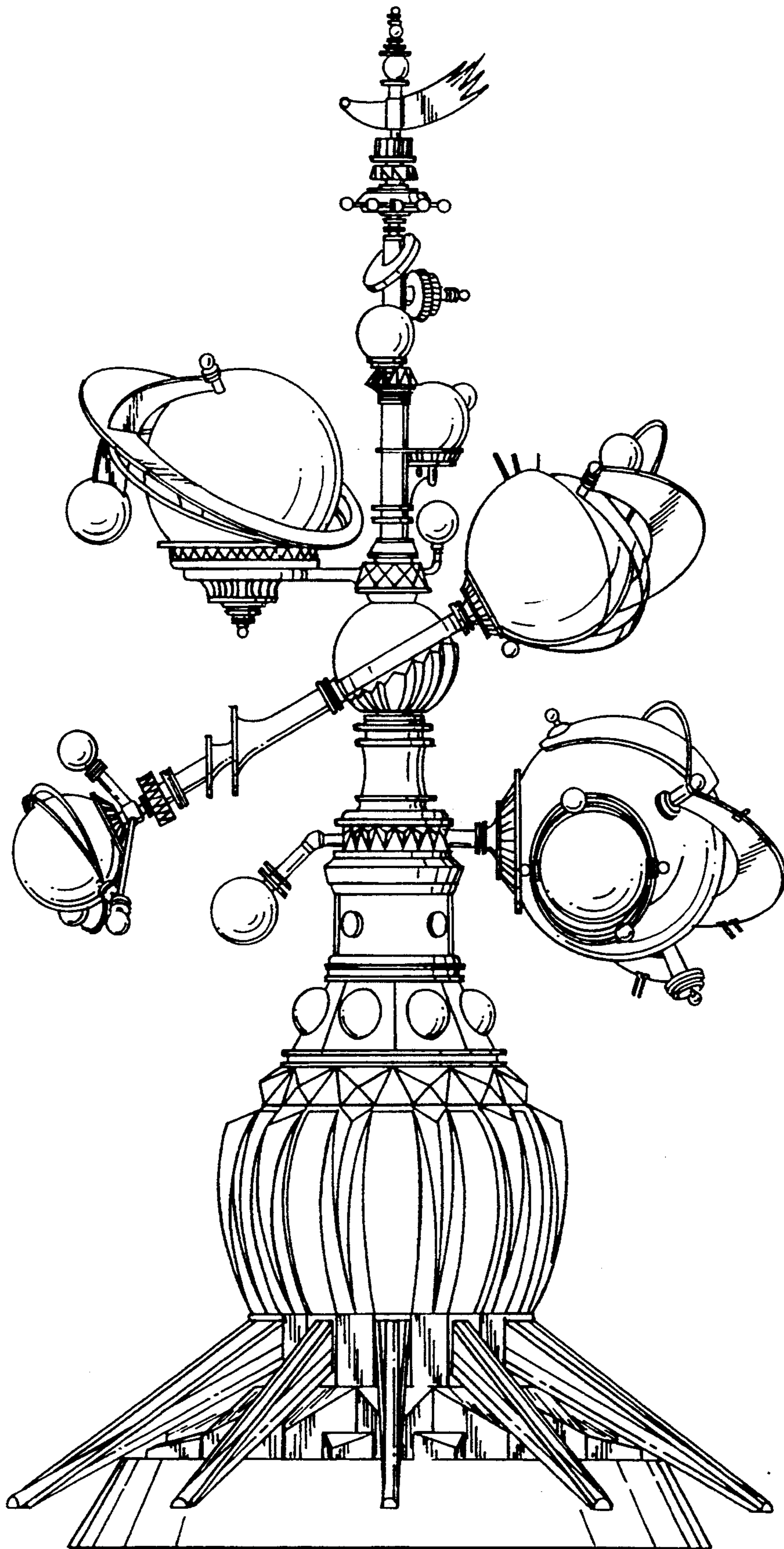
