**DESCRIPTION**

 FIG. 38 is a front perspective view of the embodiment shown in FIGS. 30-37 in an open position.

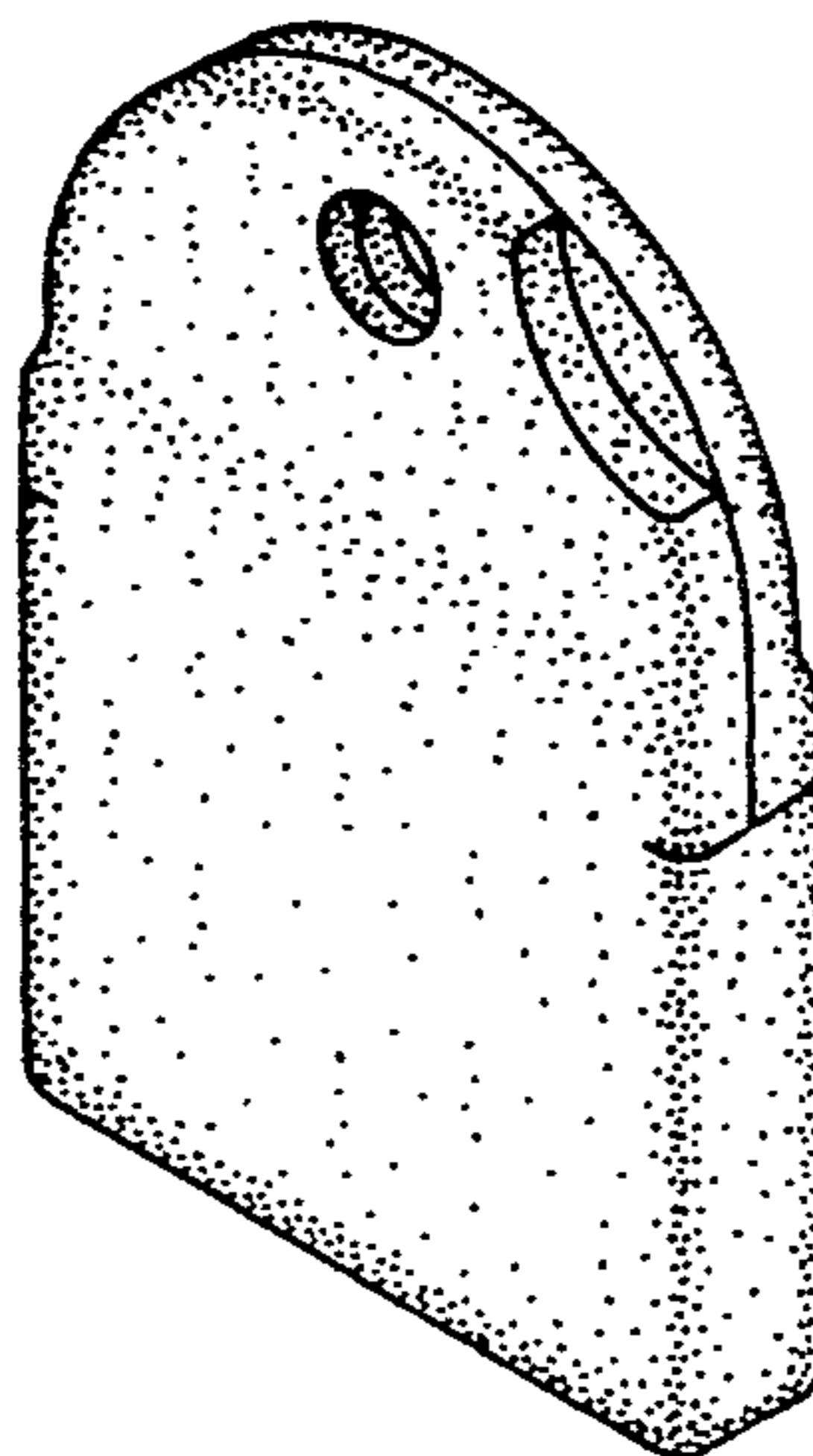

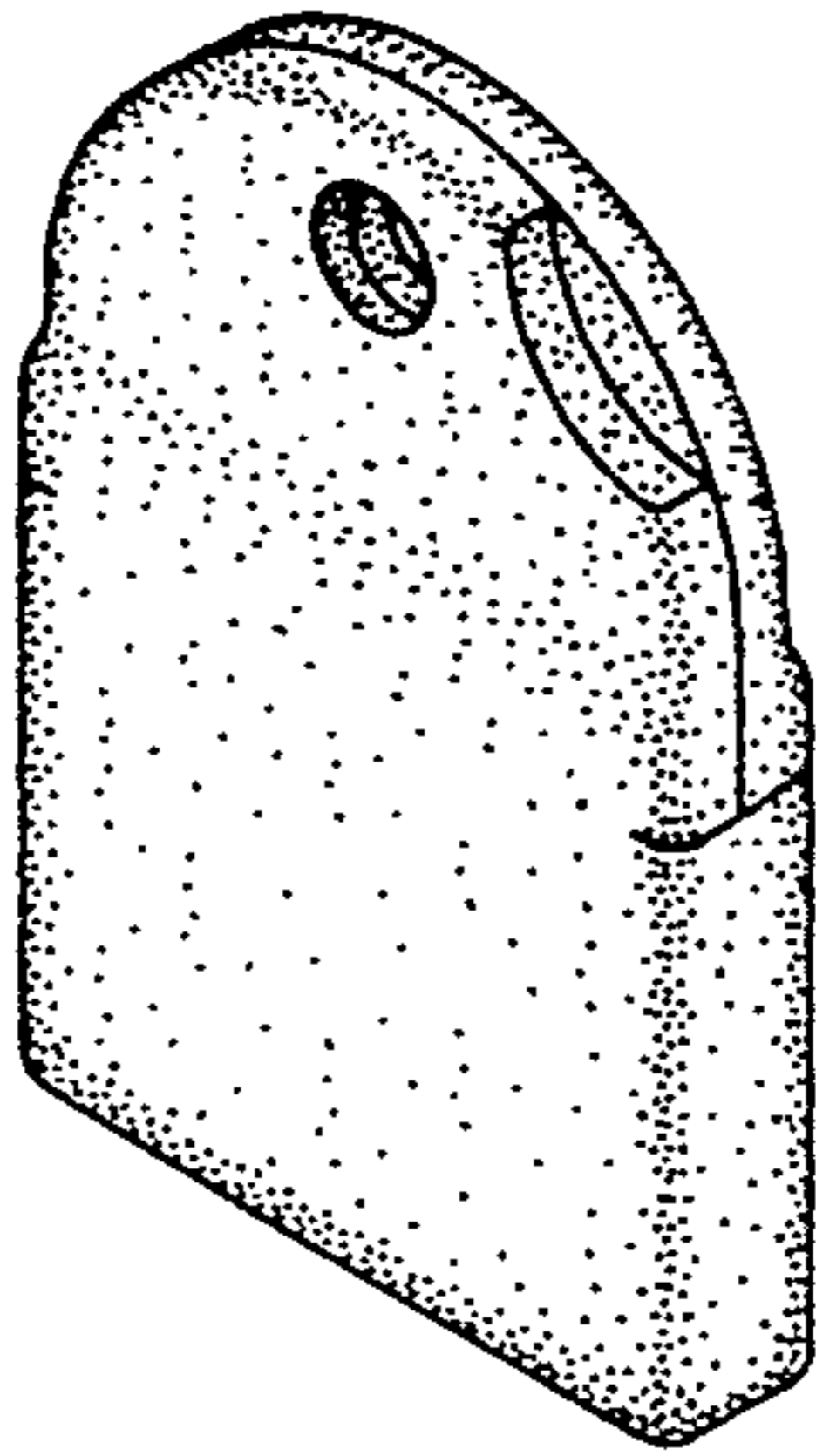

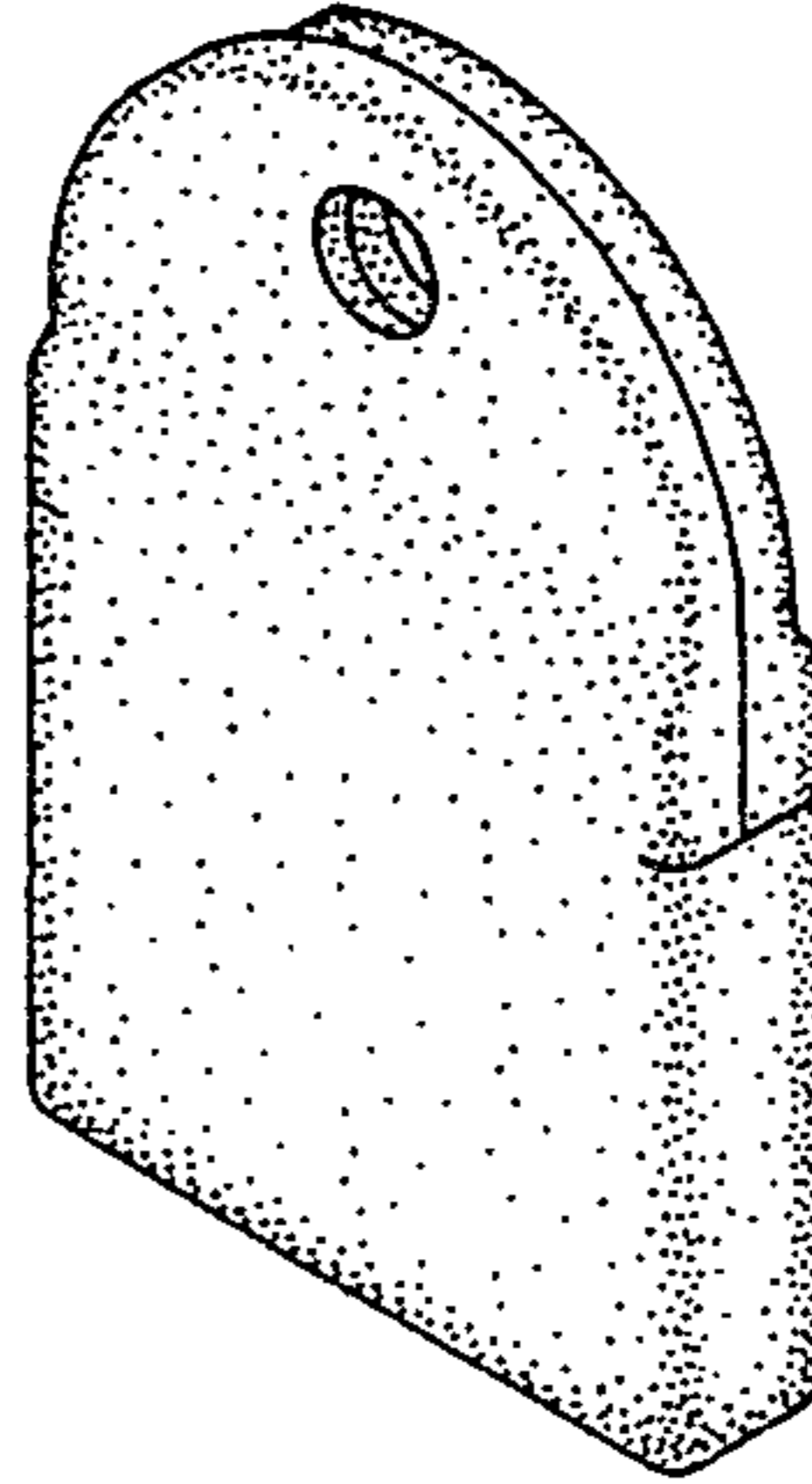

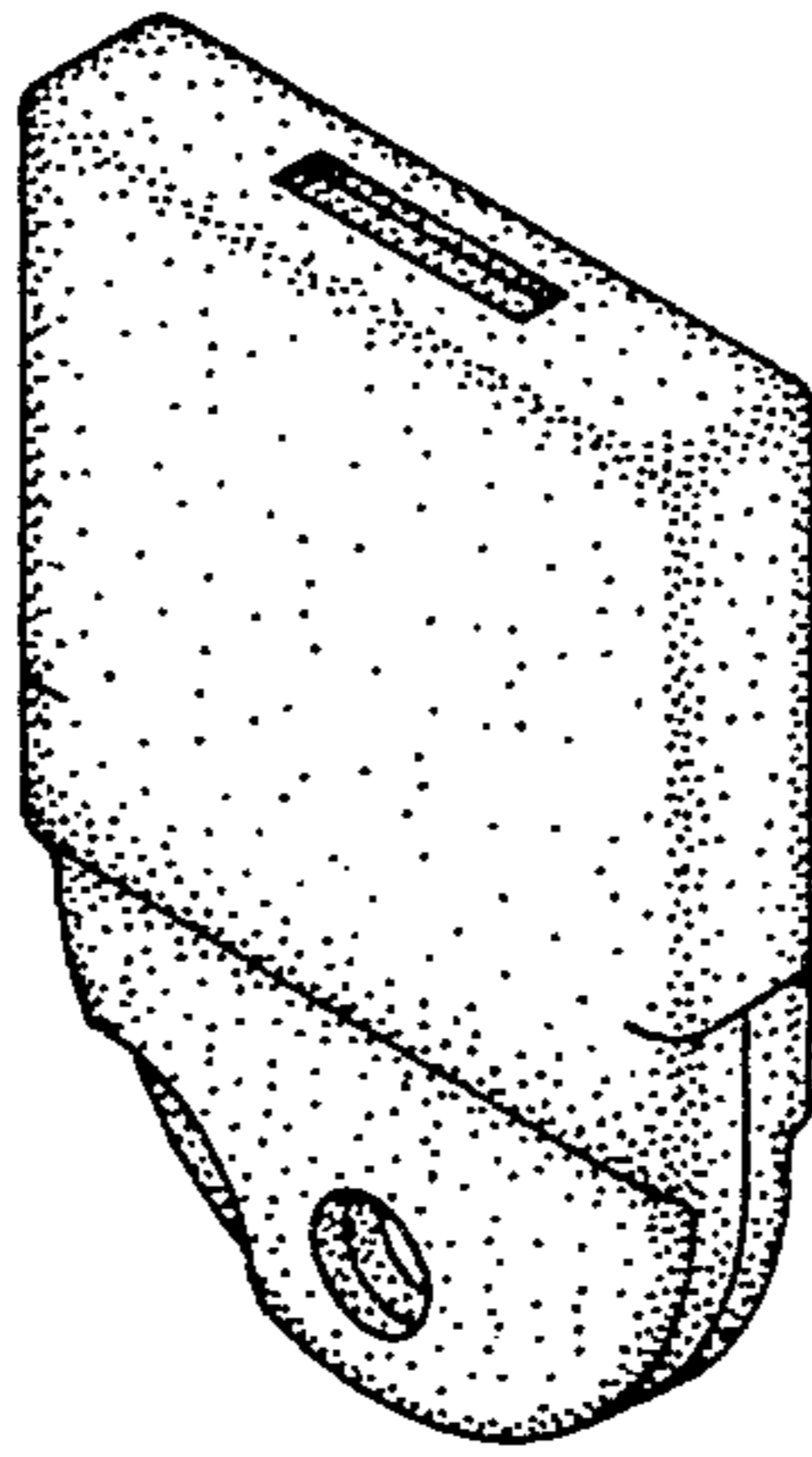

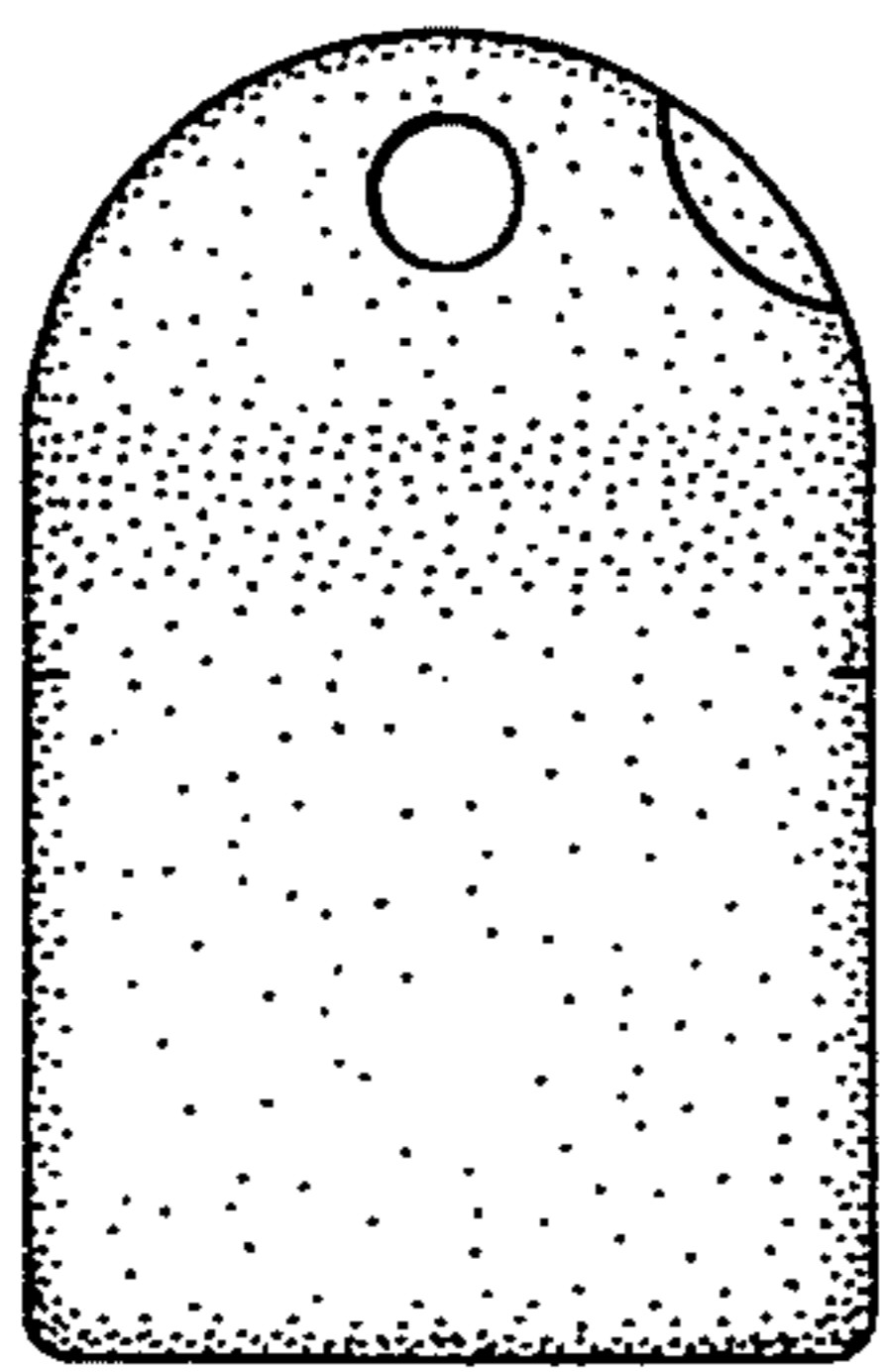

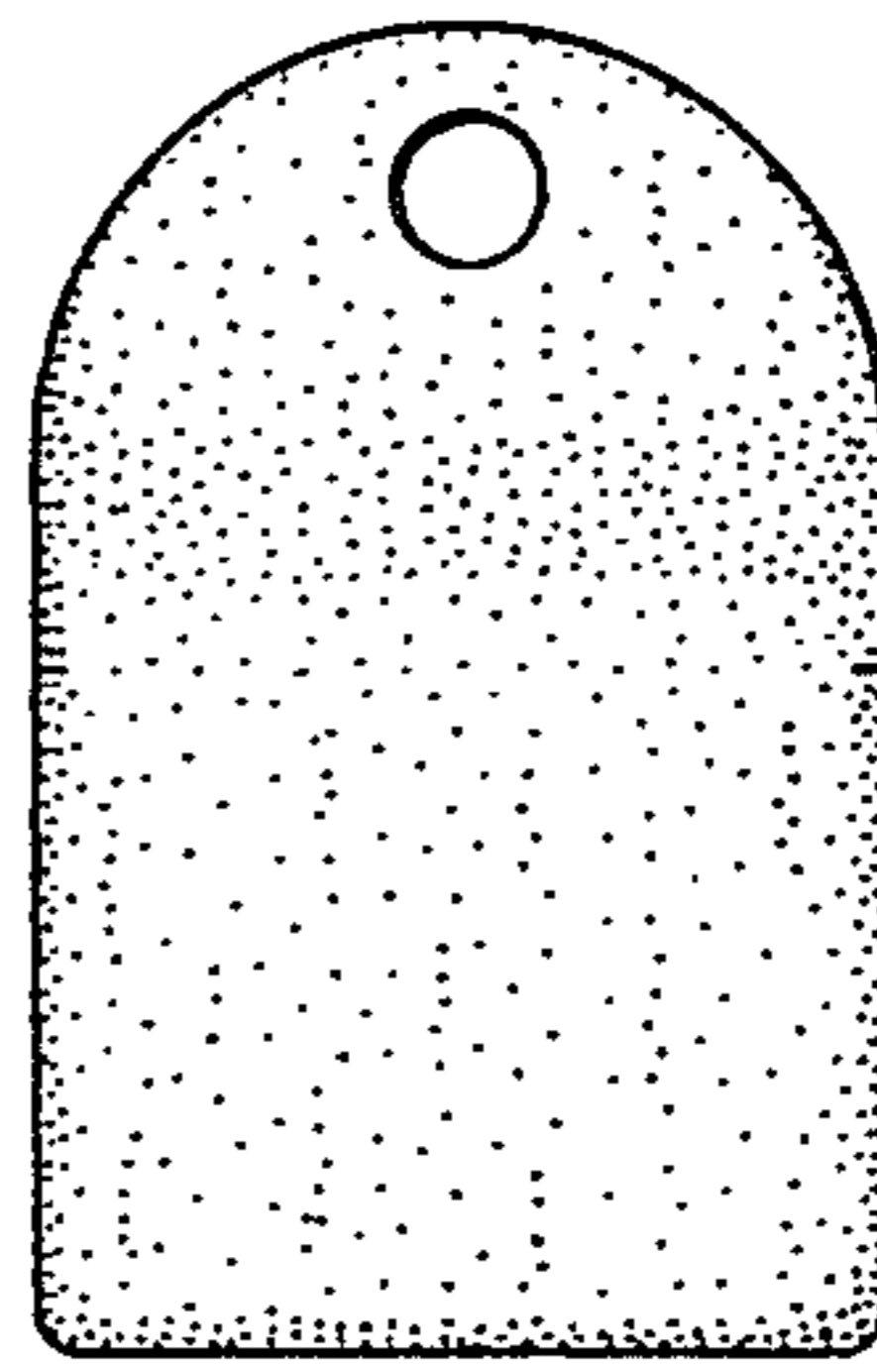

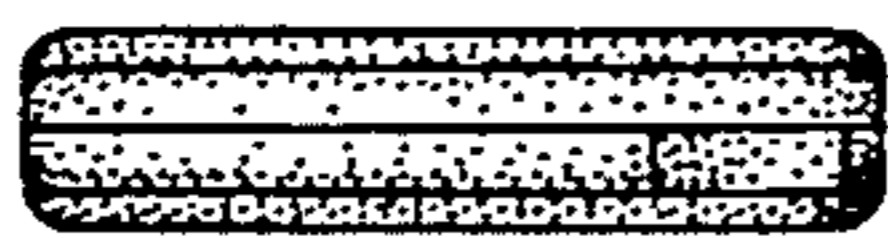

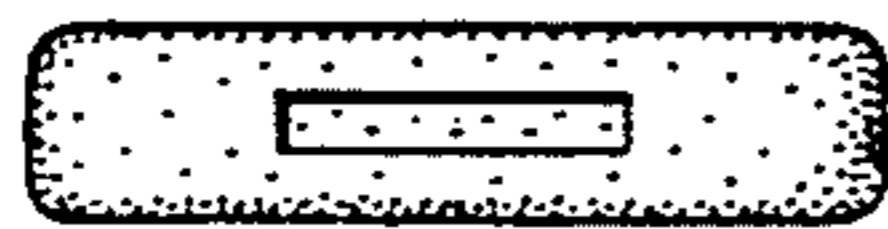

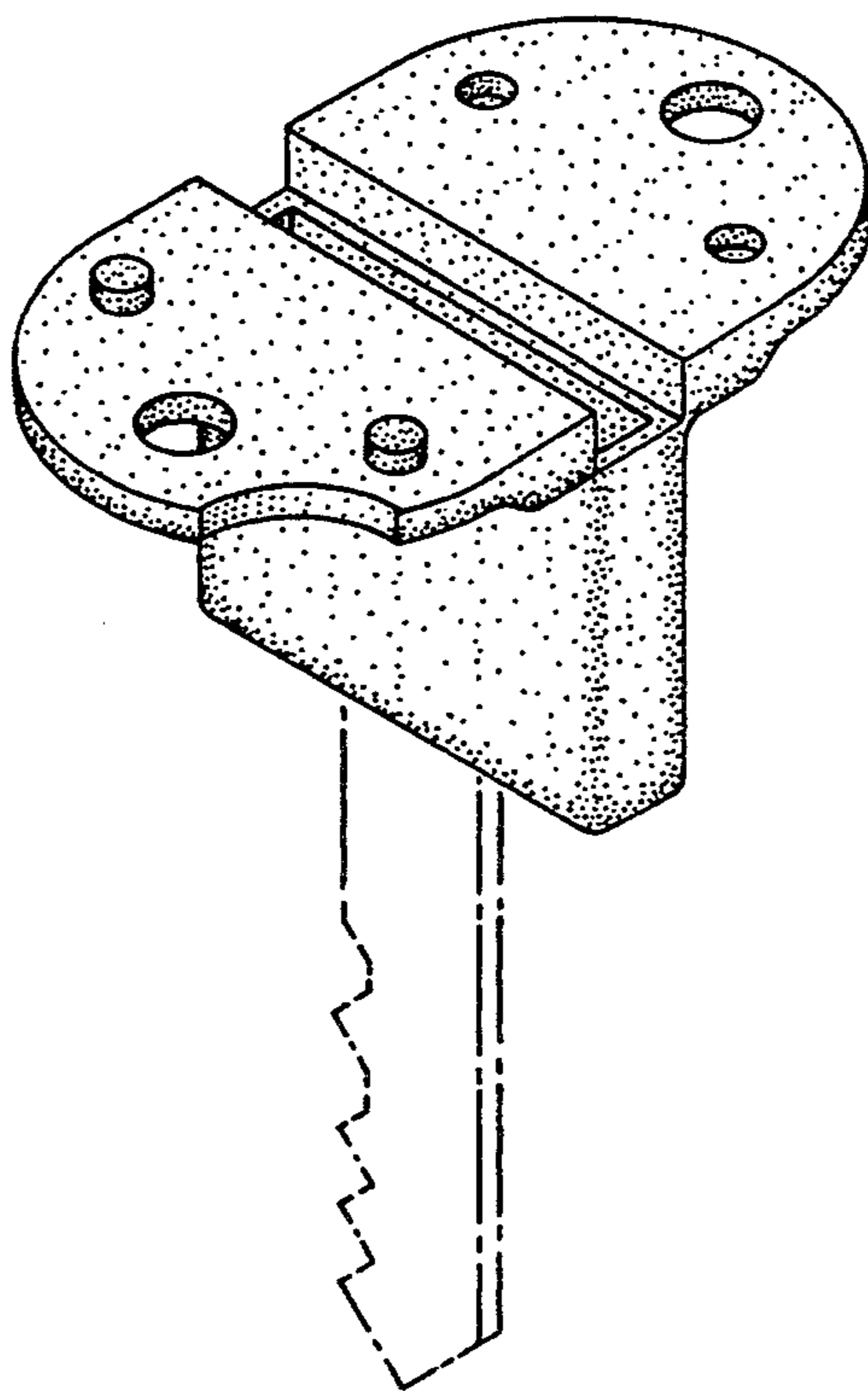

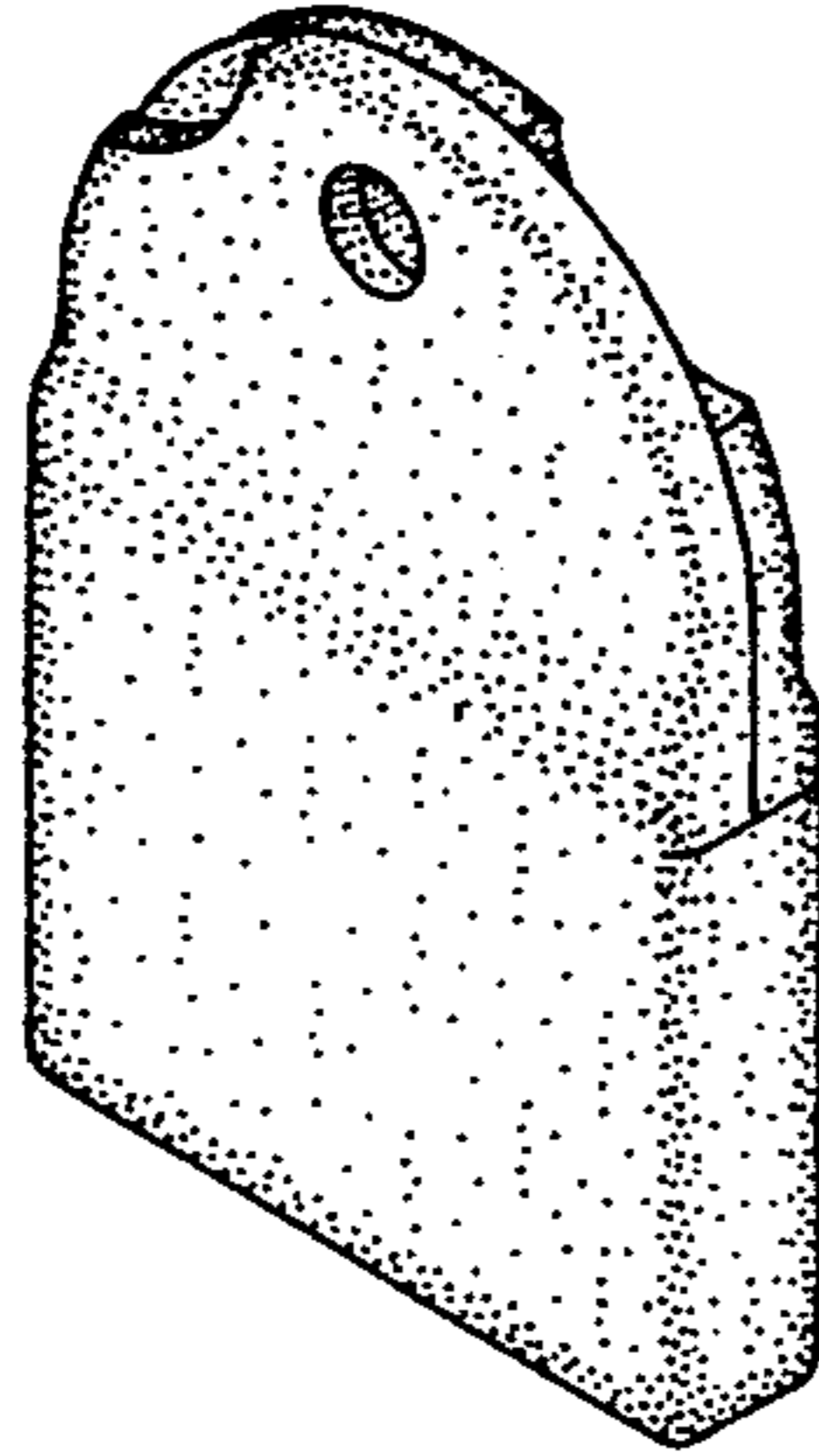

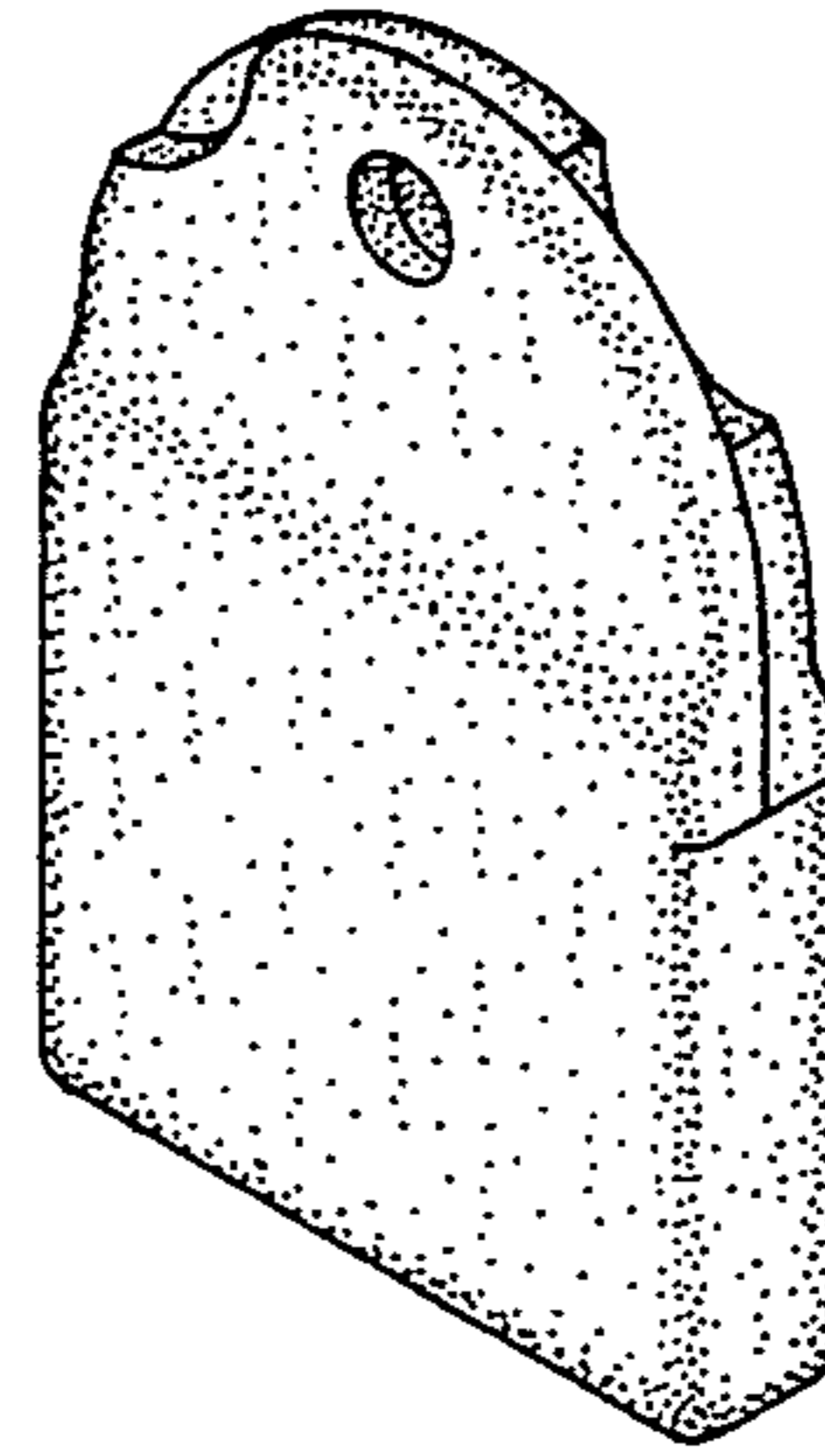

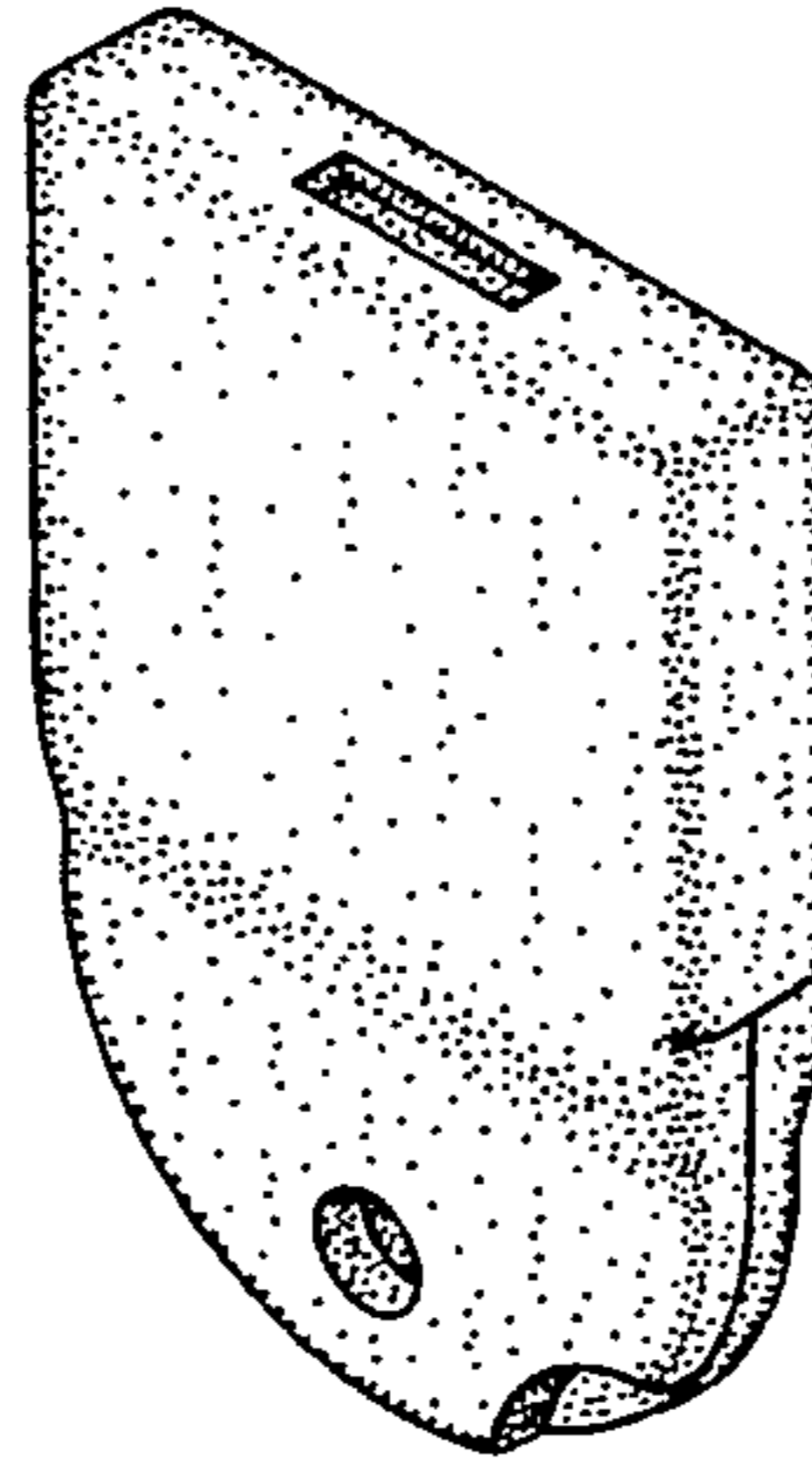

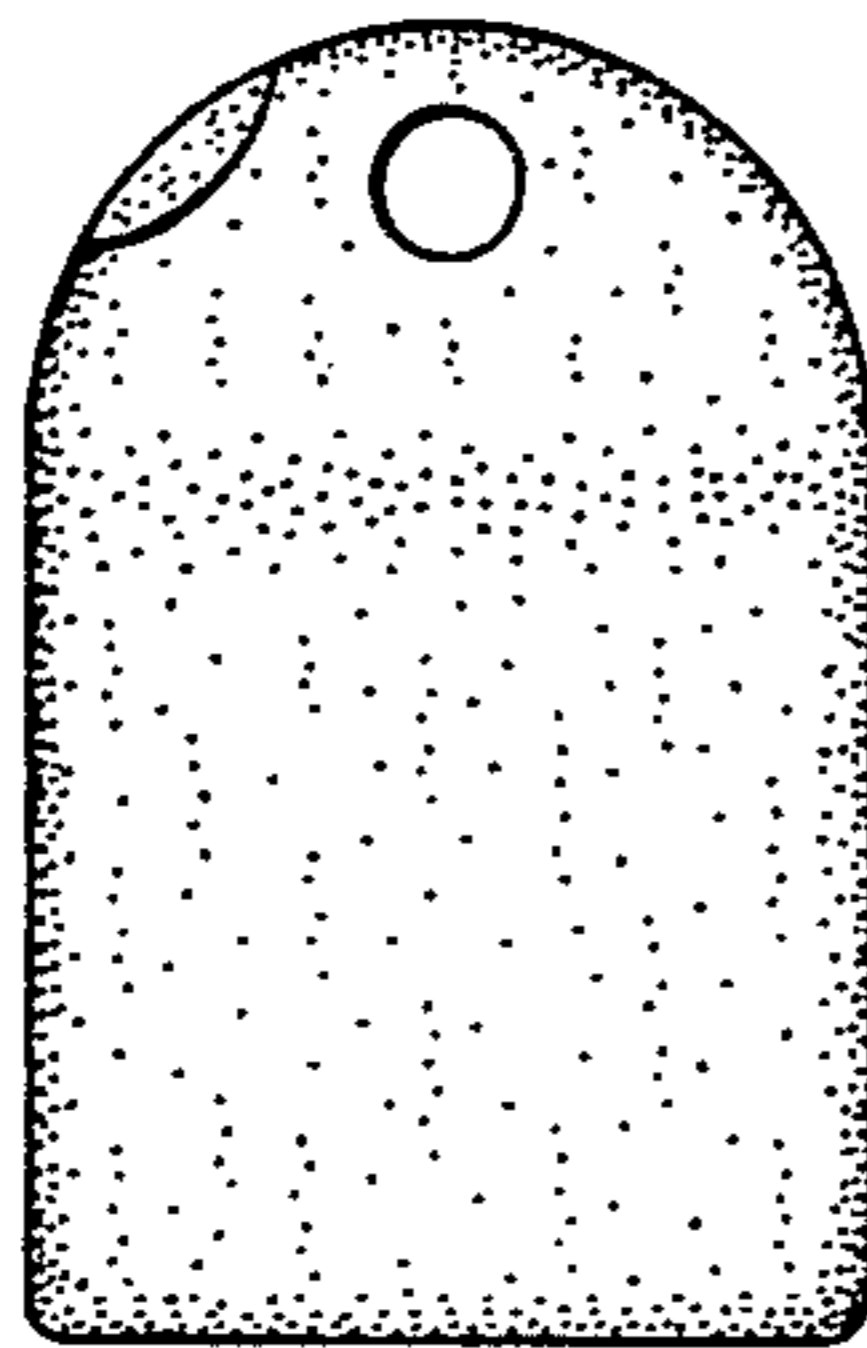

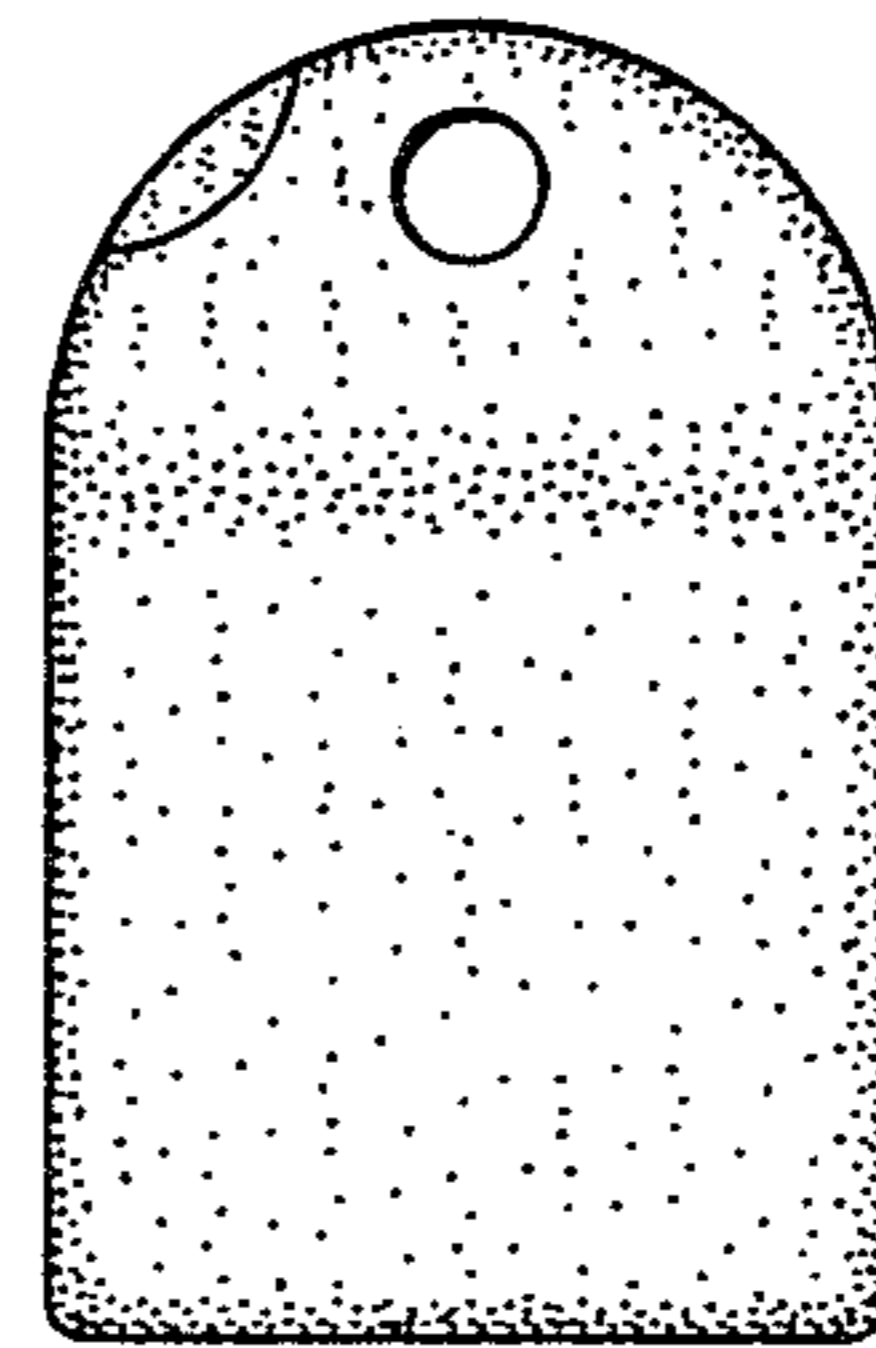

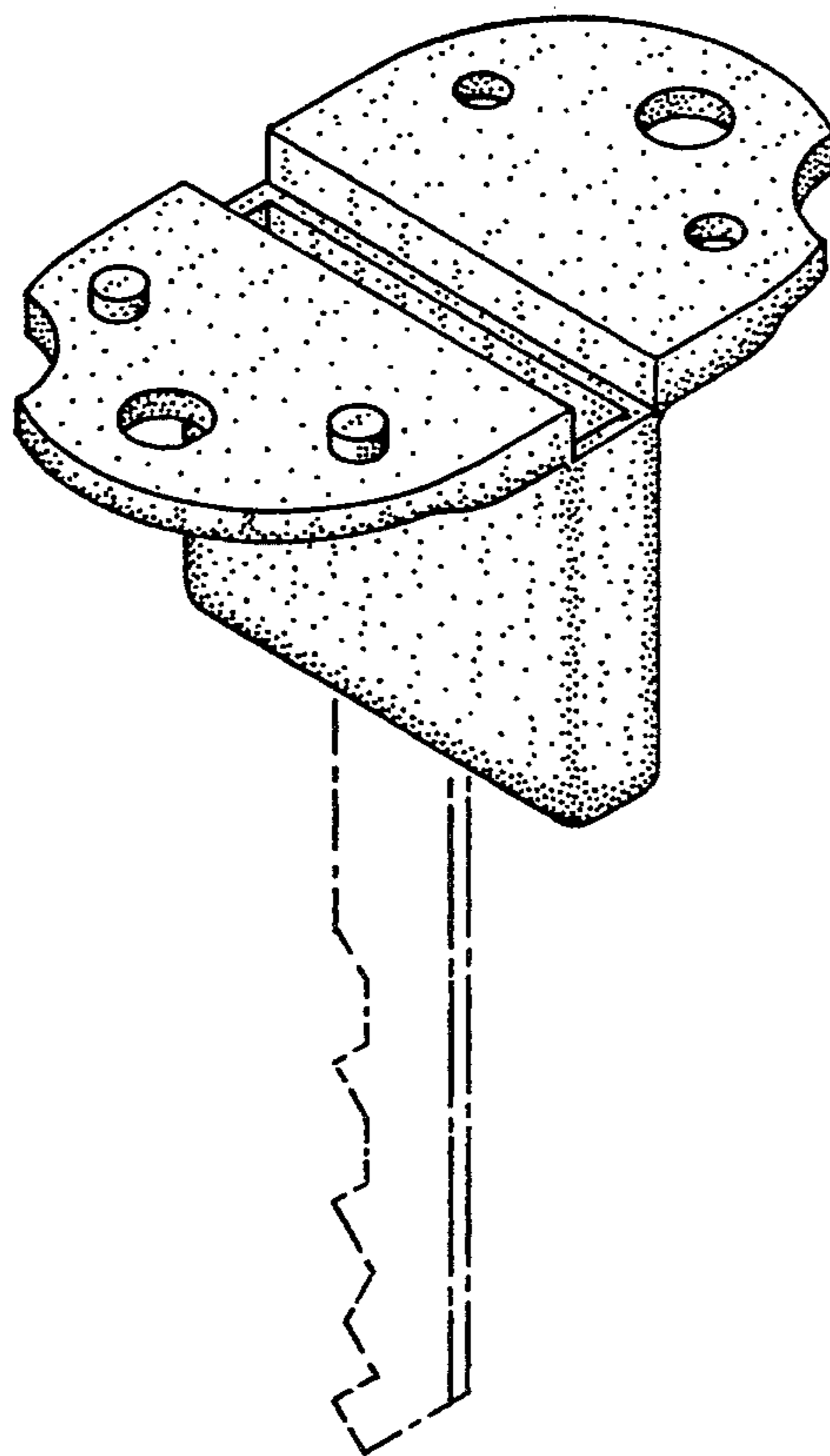

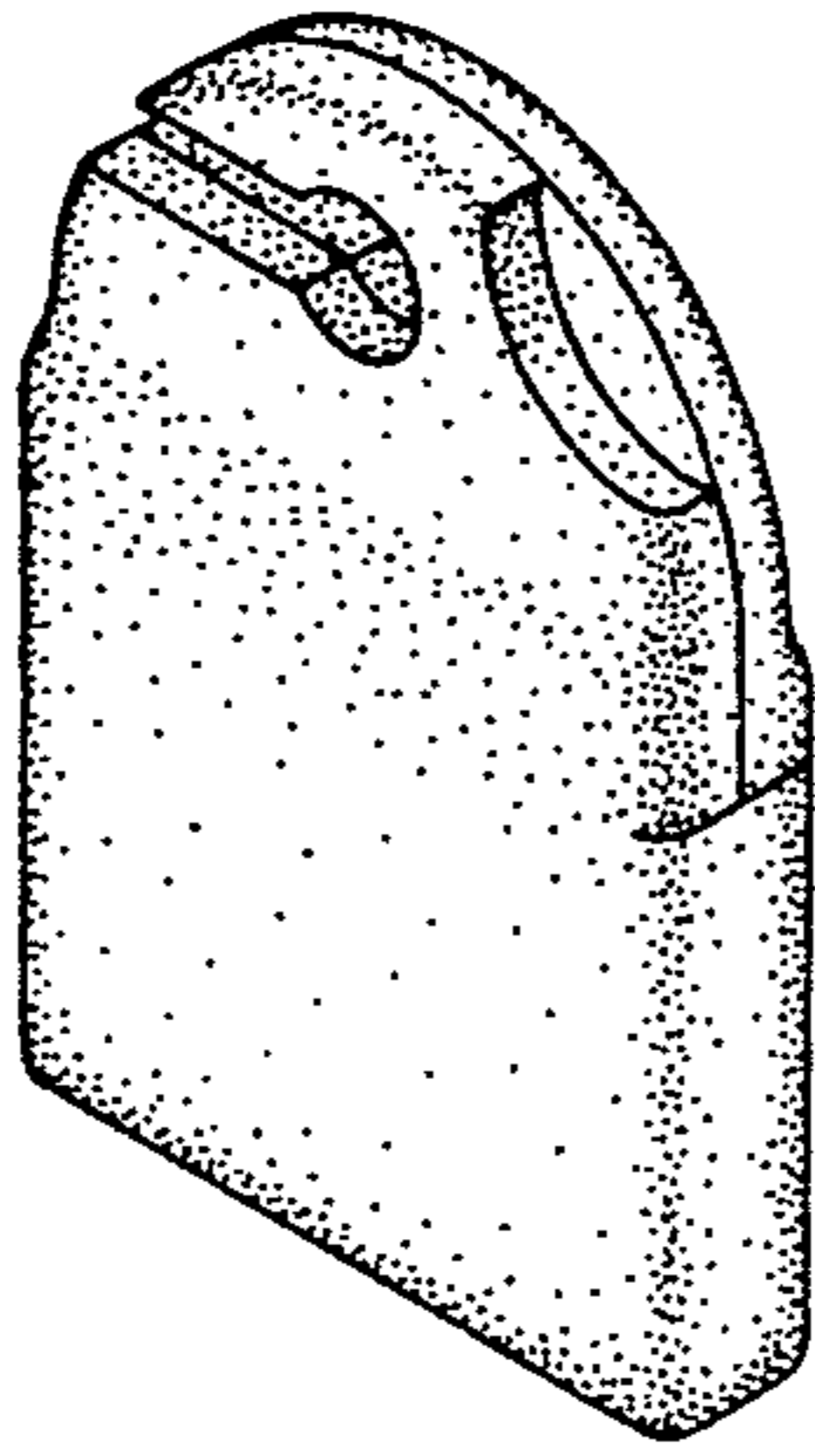

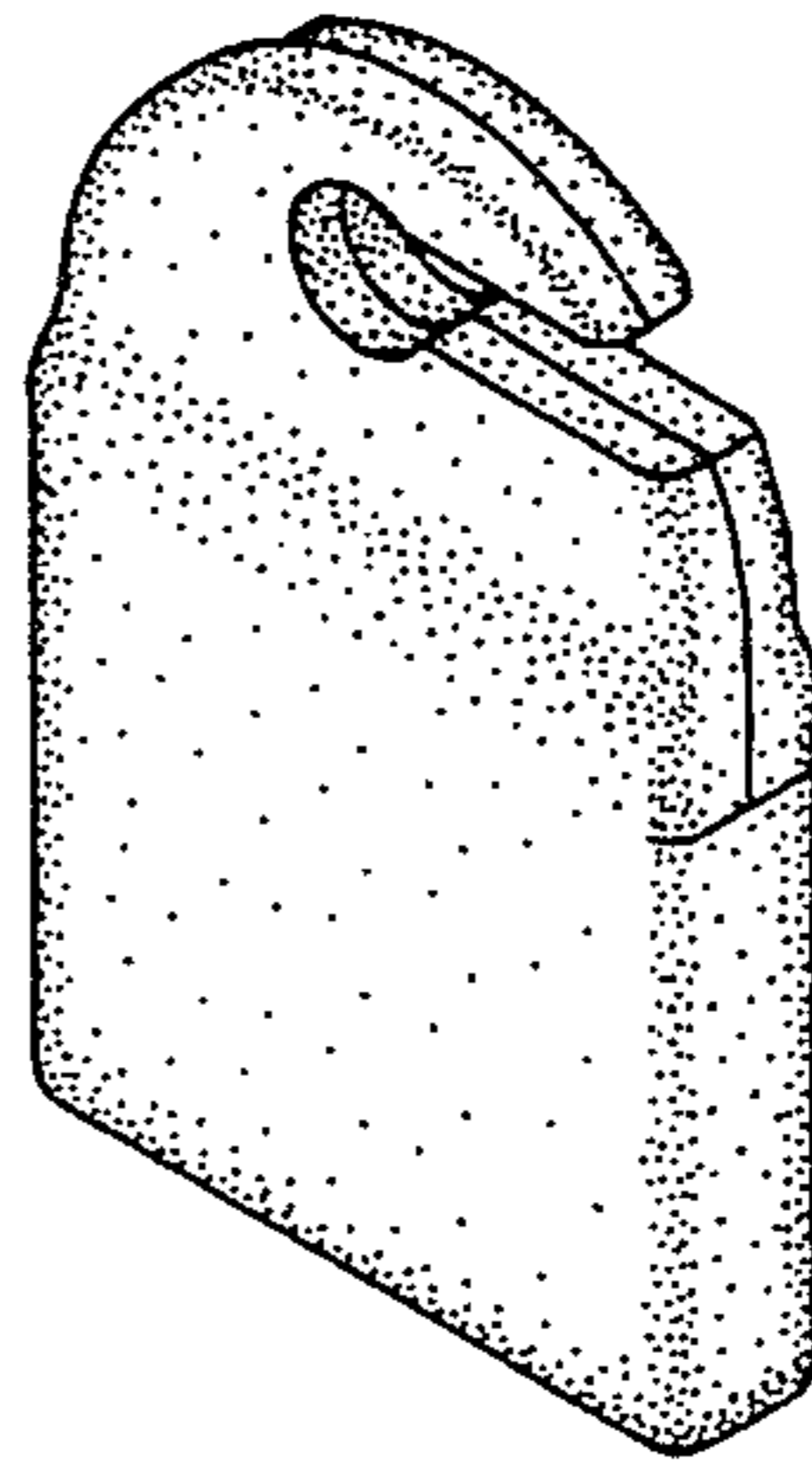

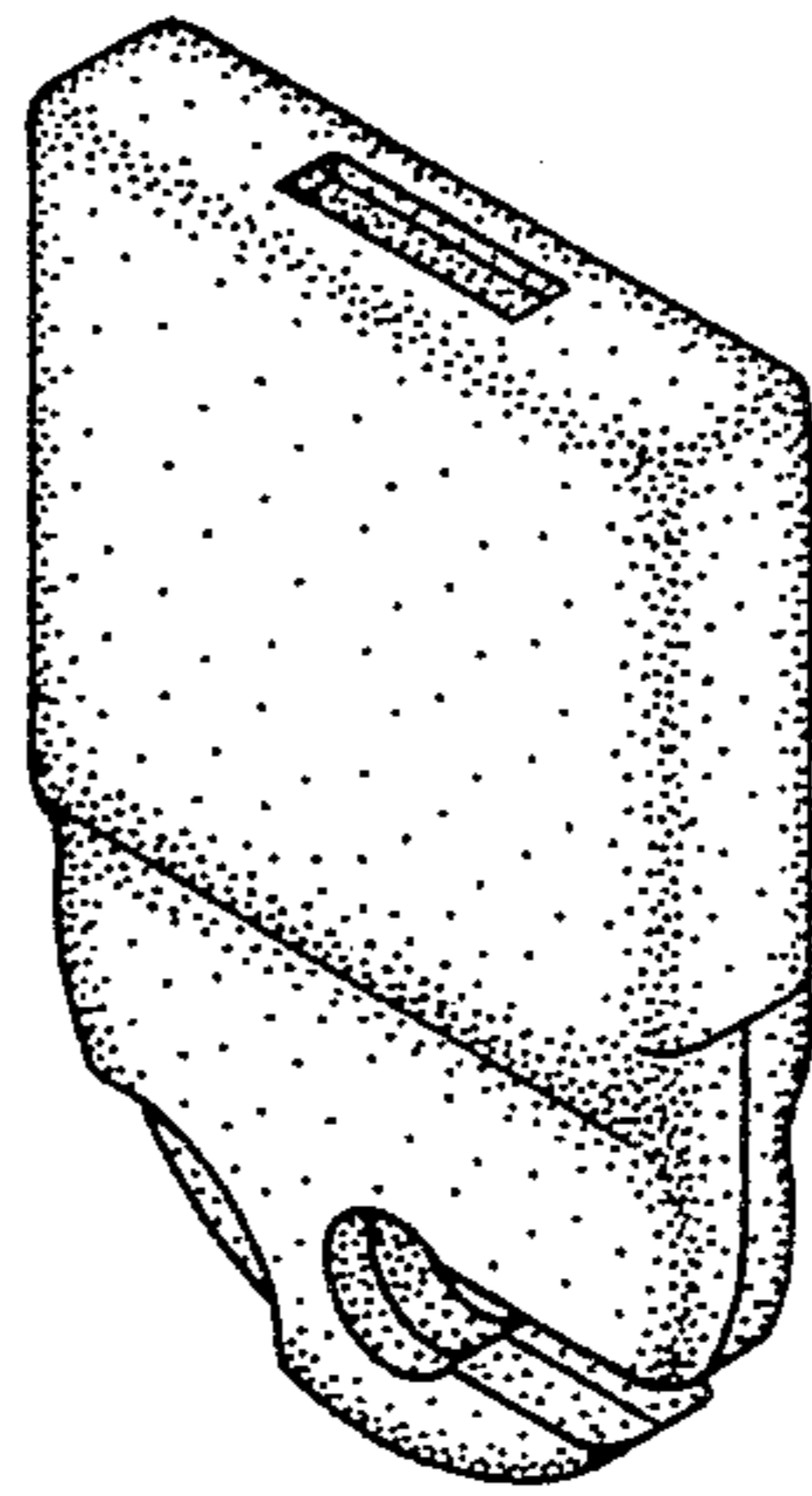

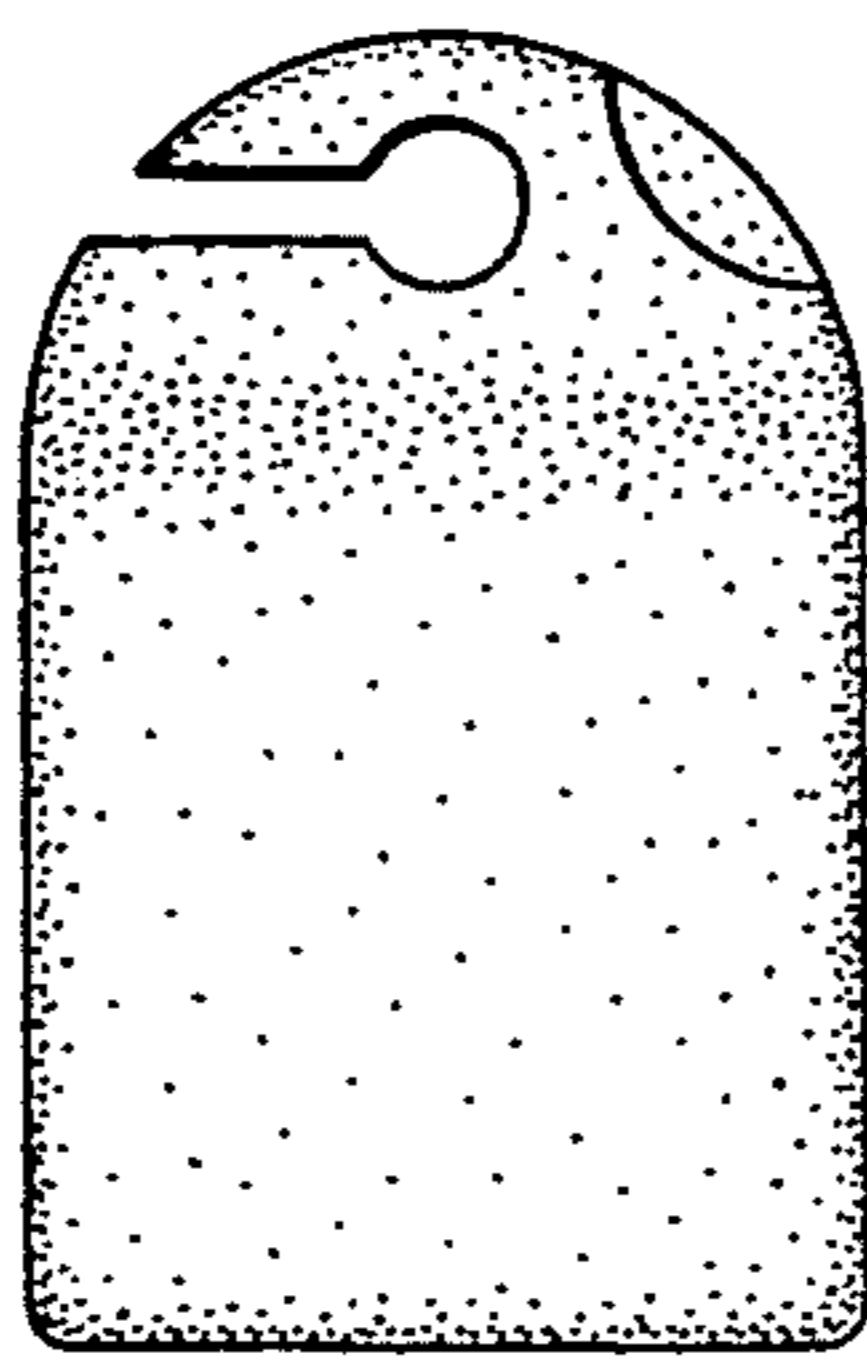

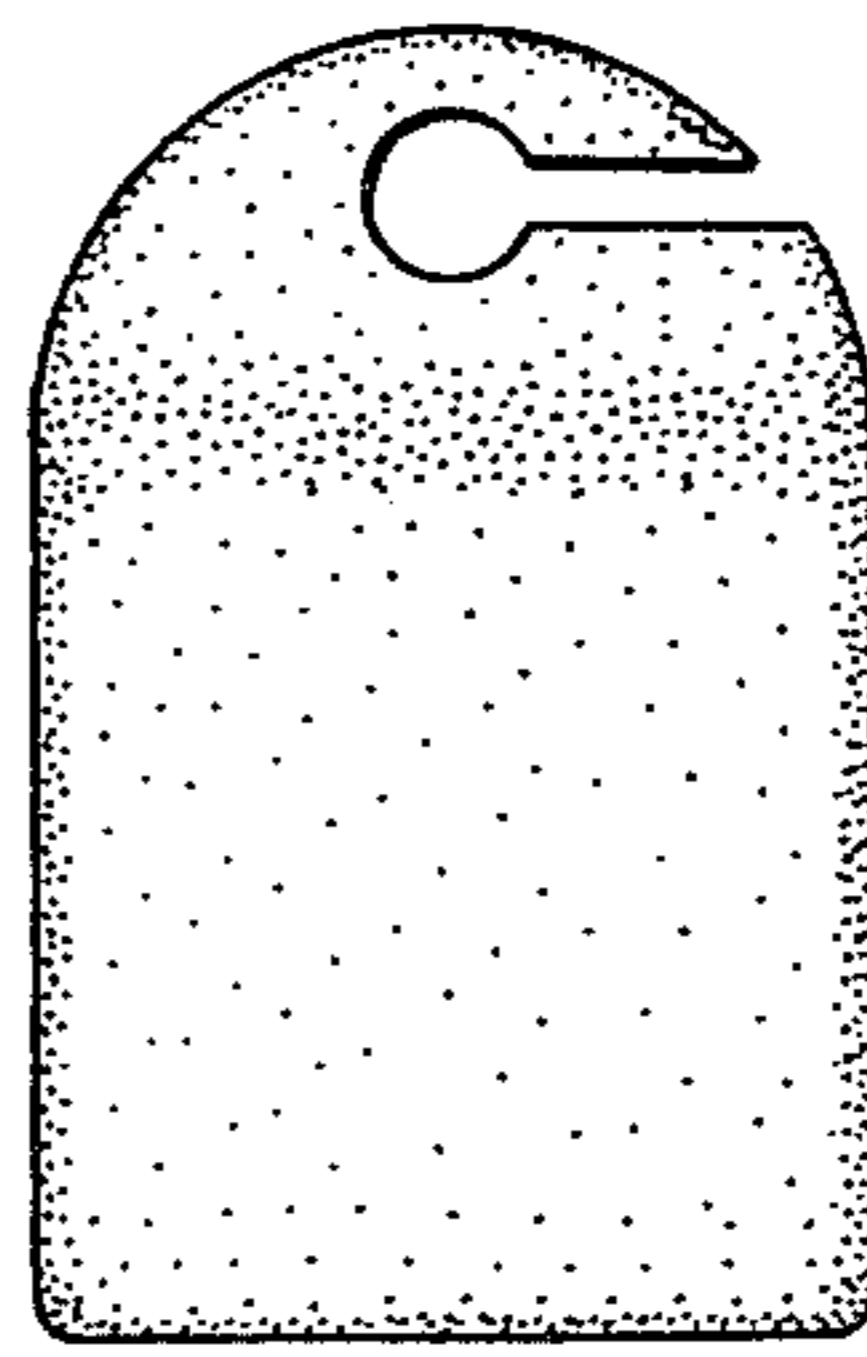

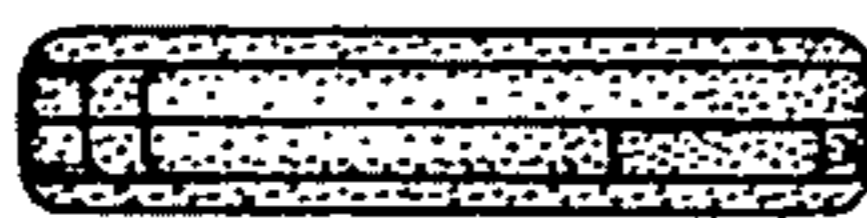

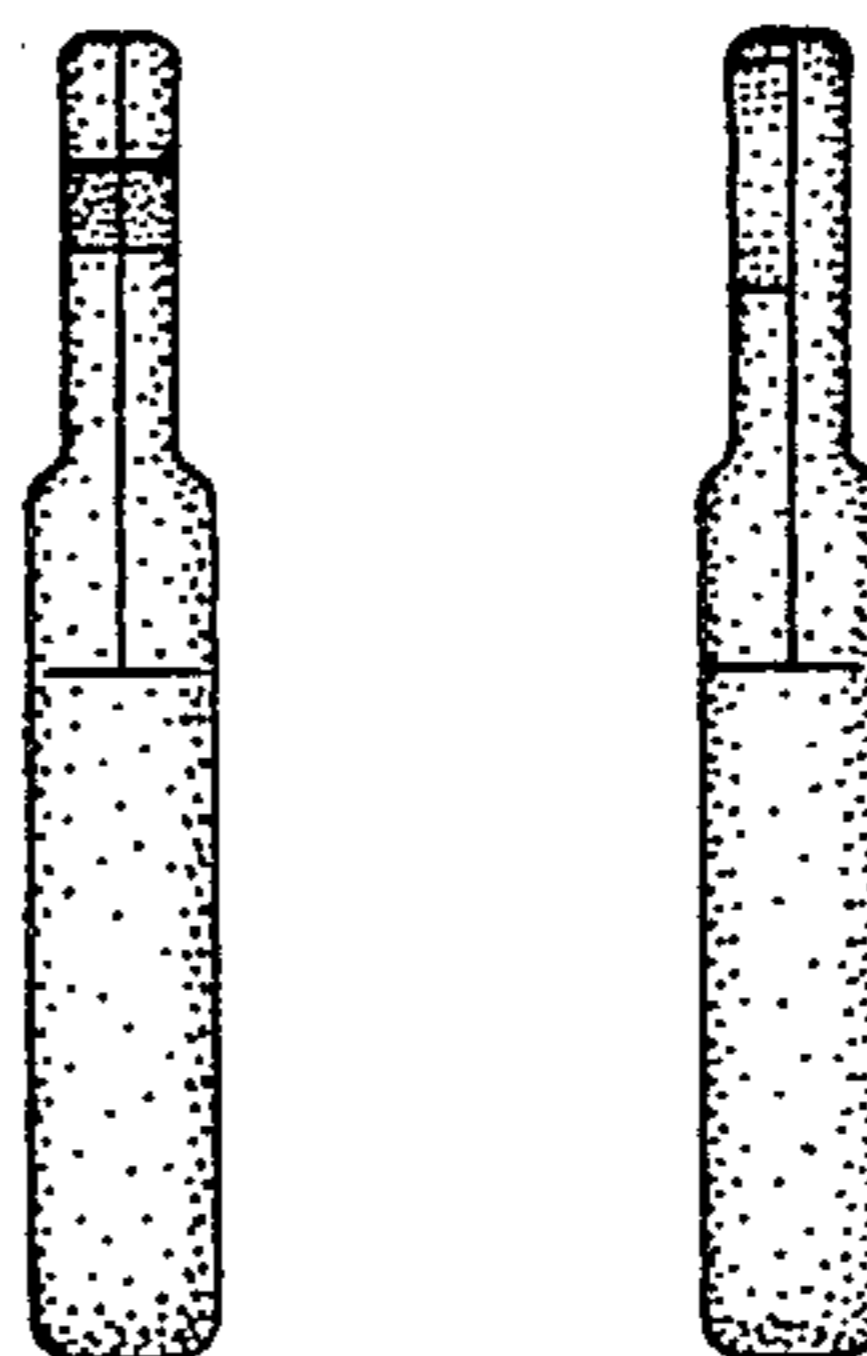


Fig. 27 Fig. 28

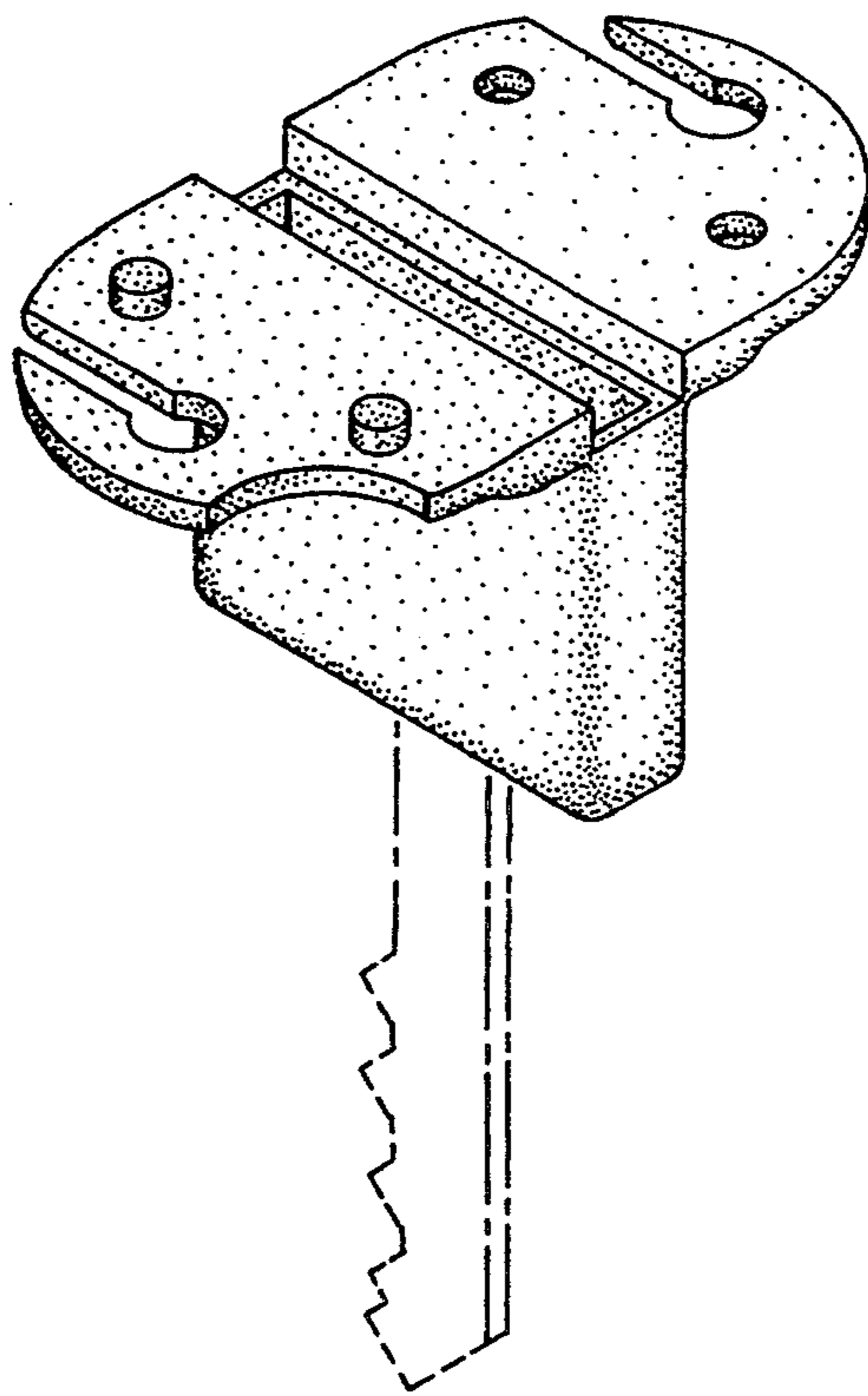

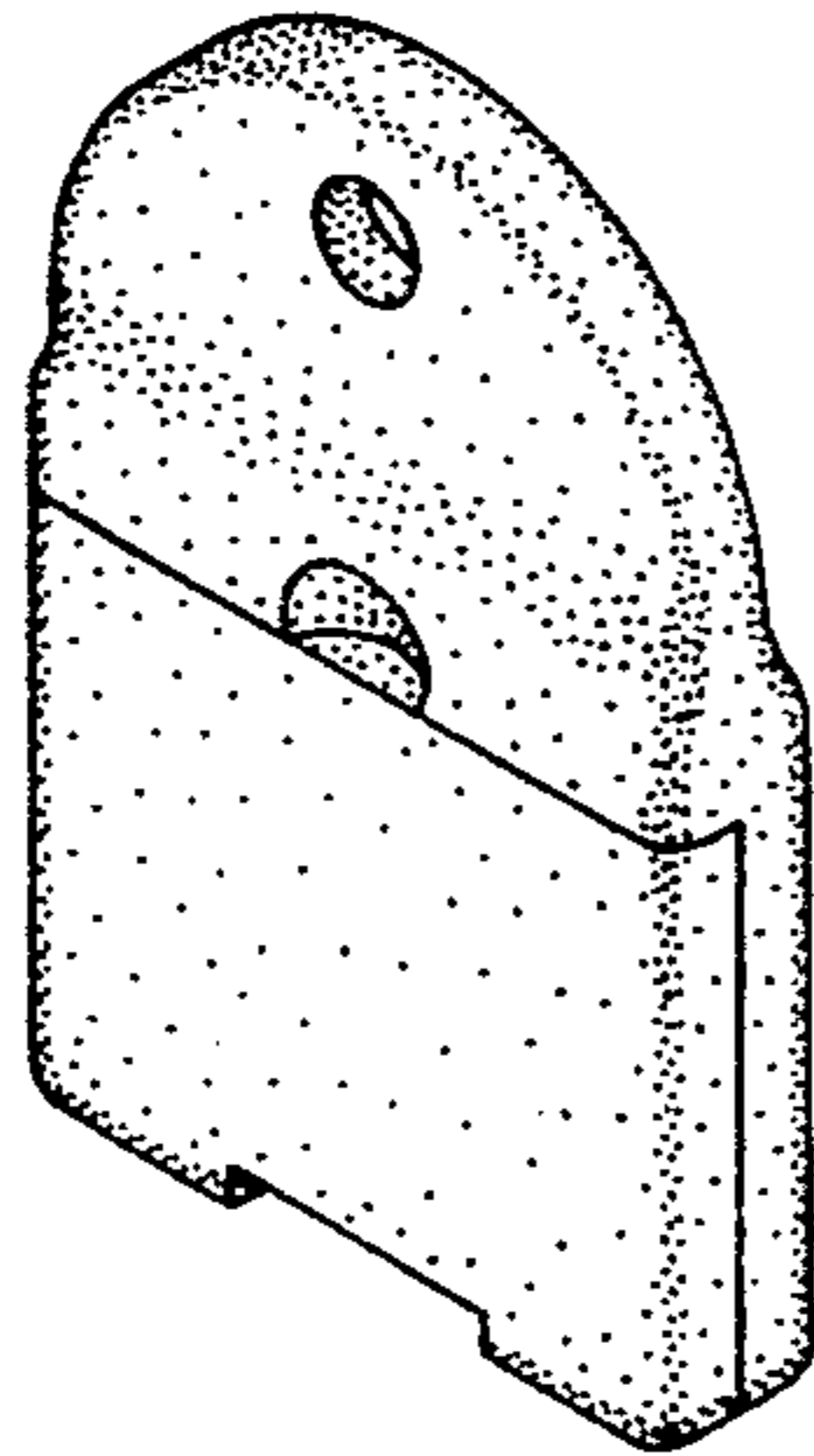

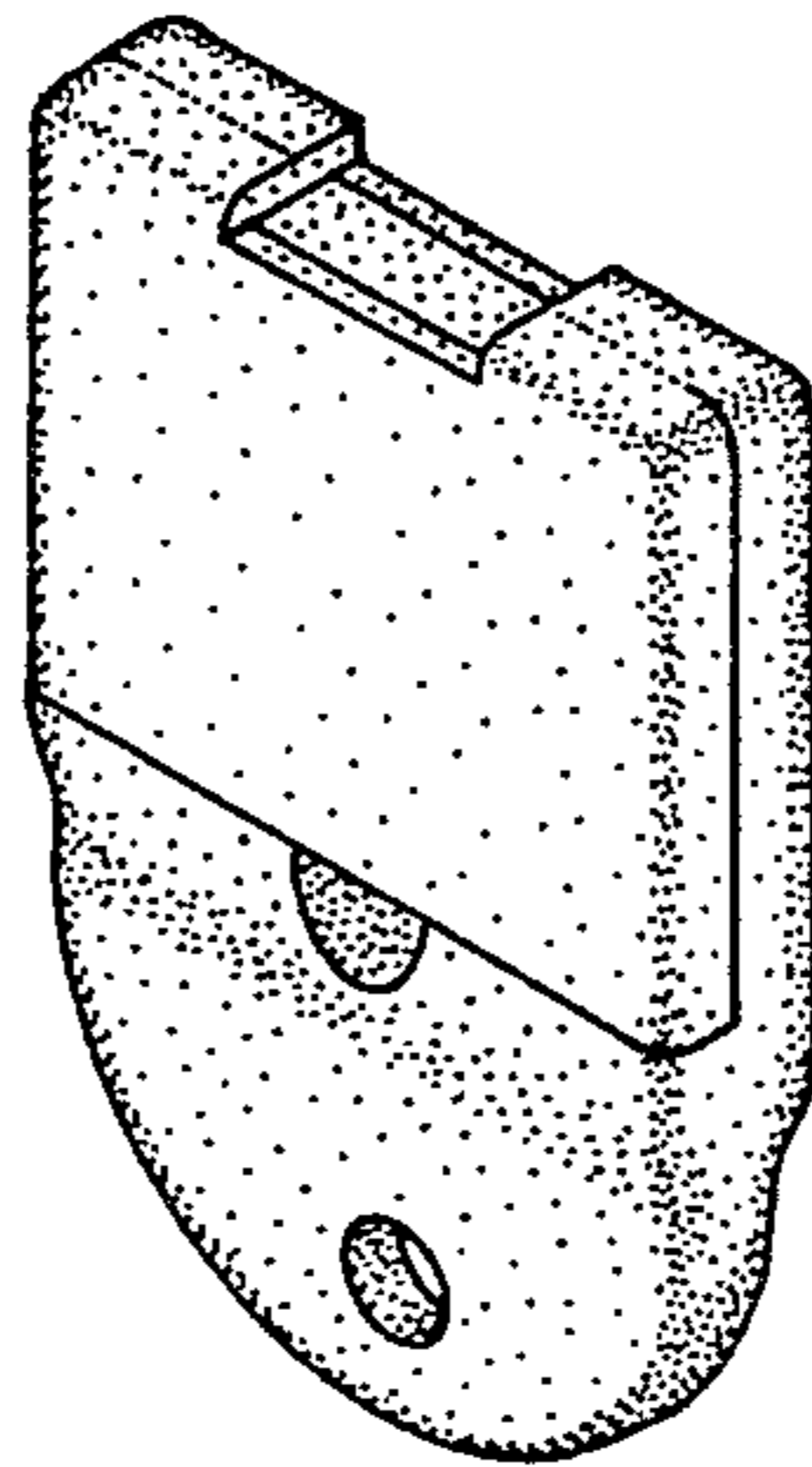
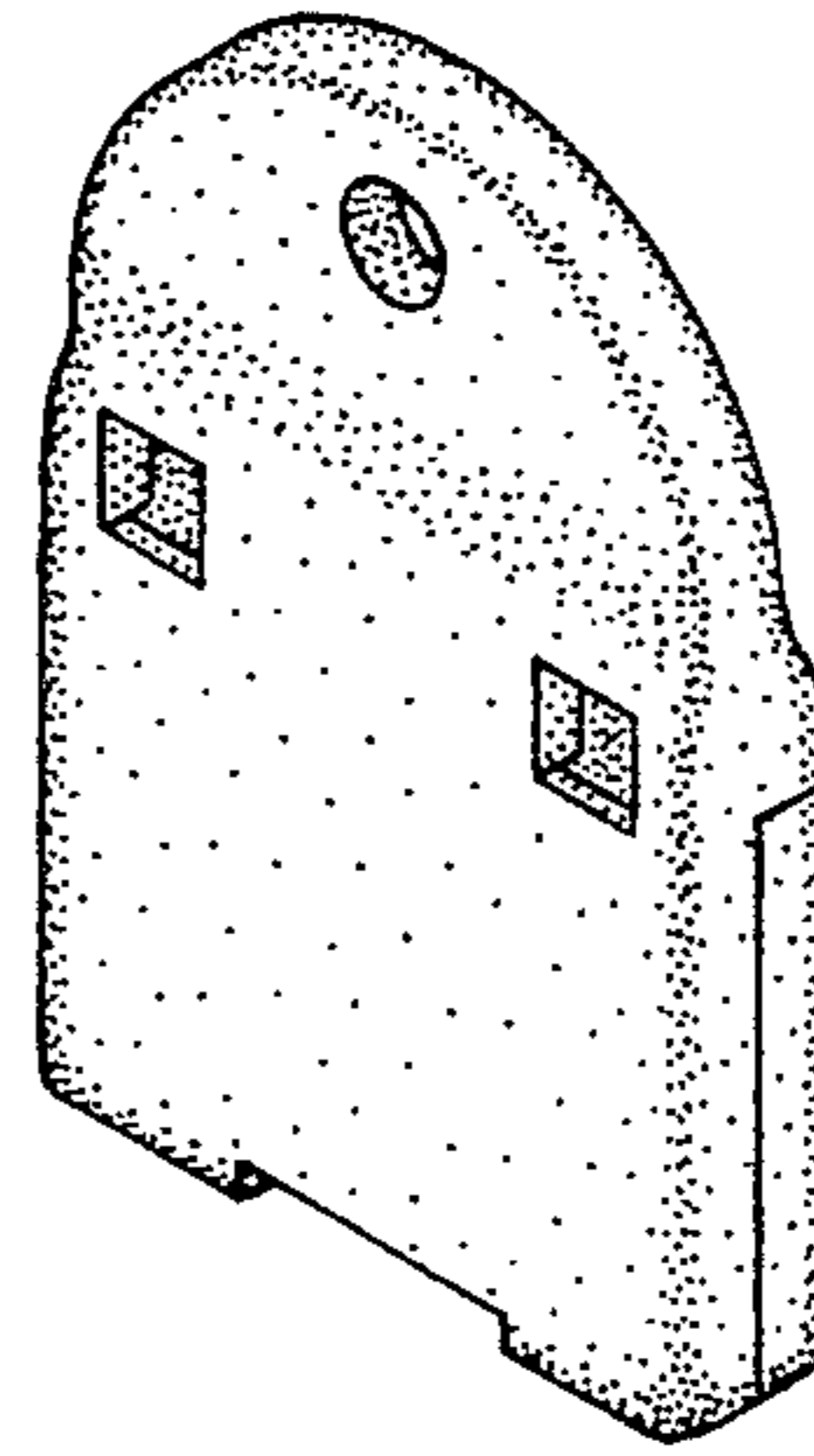

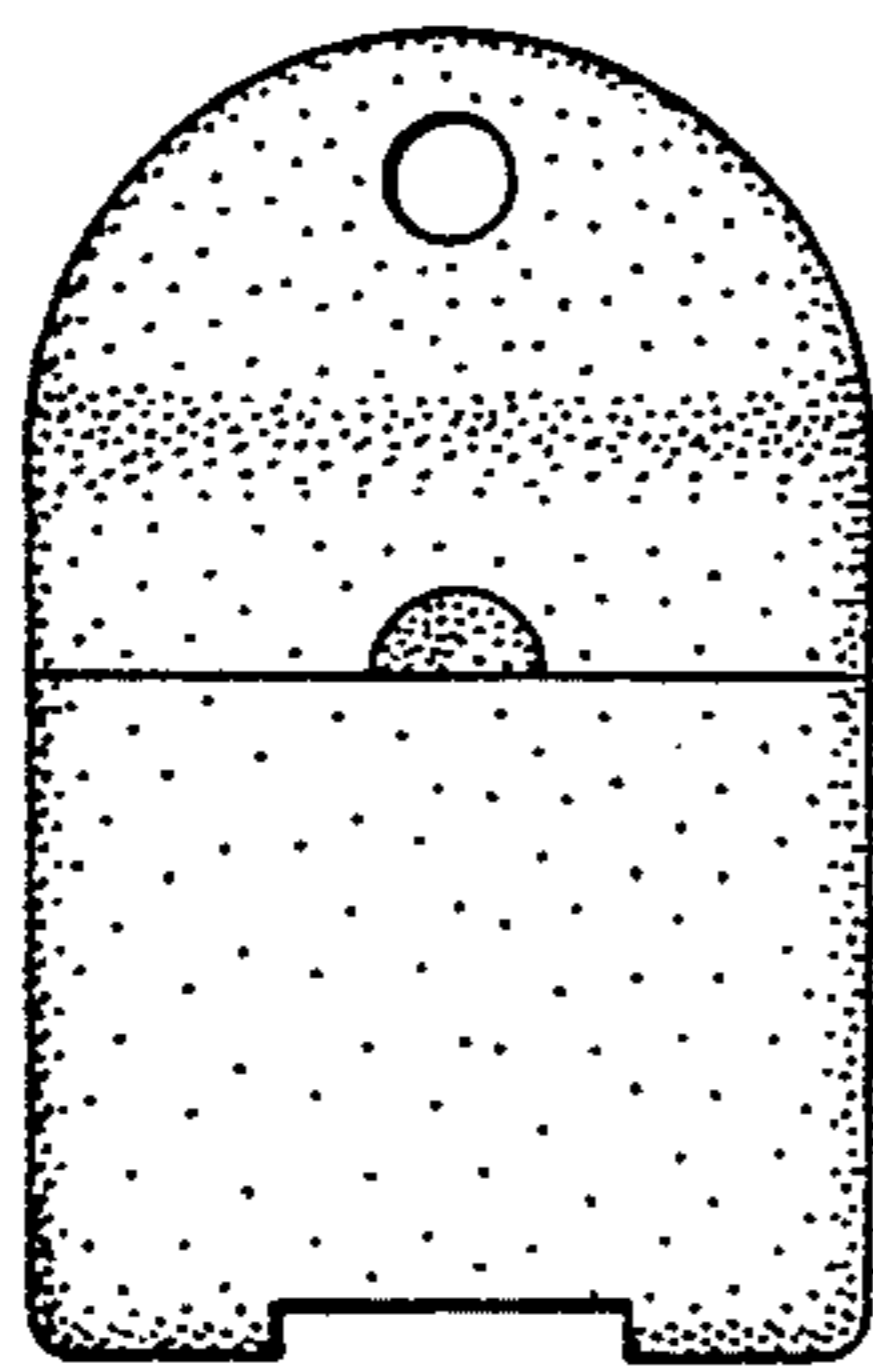

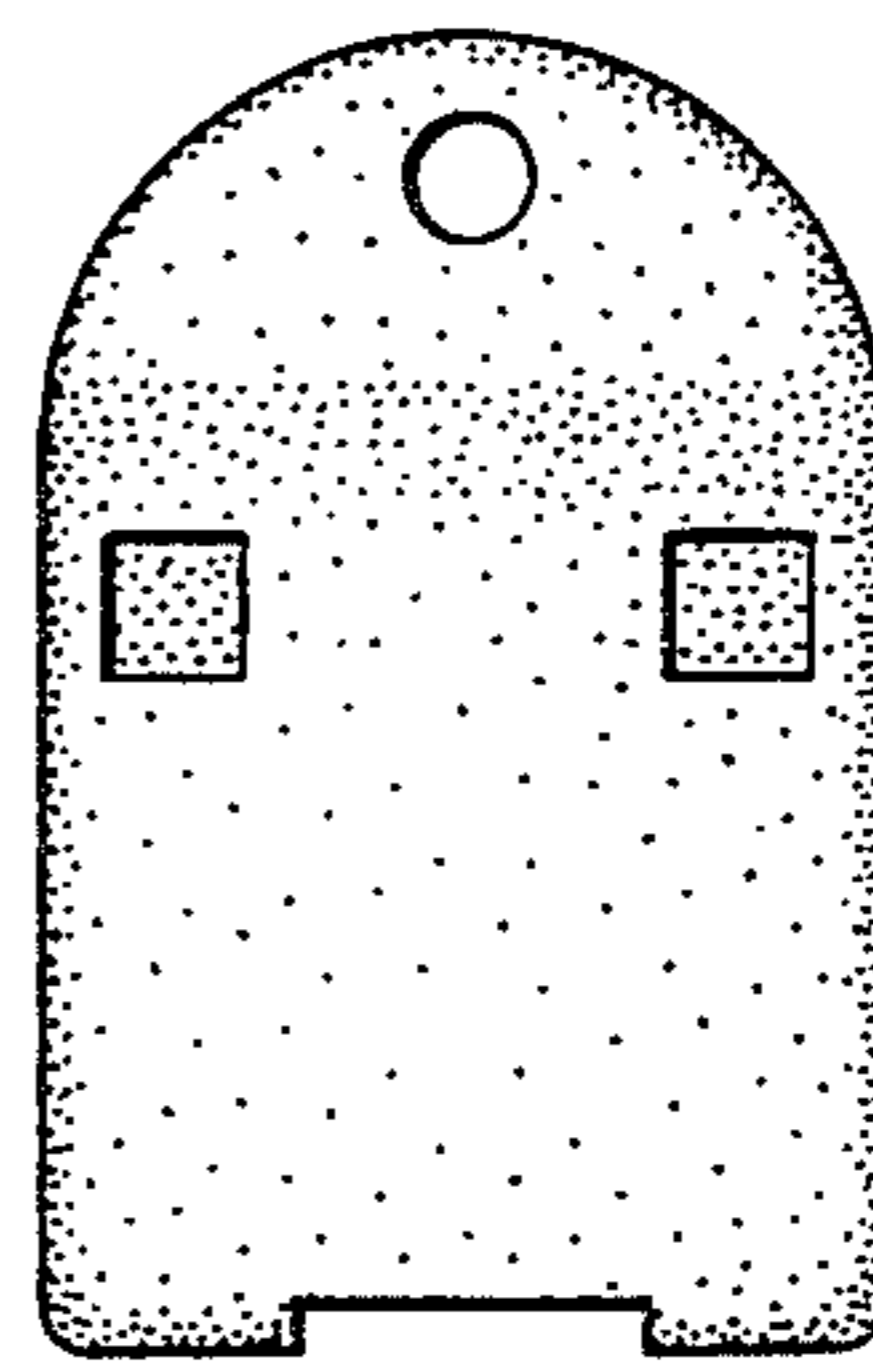

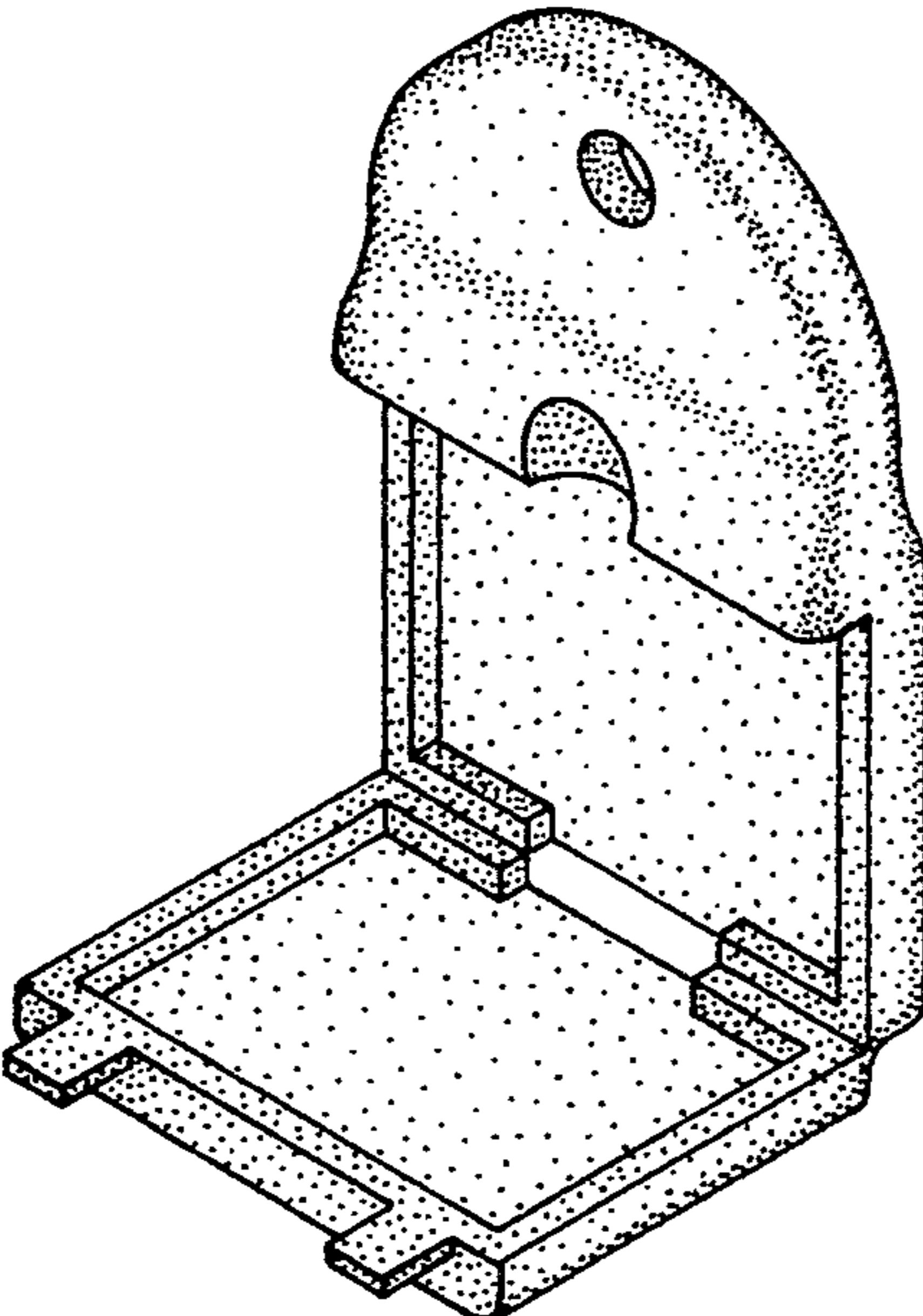
