[57] **CLAIM**

The ornamental design for combined ring holder and organizer for cosmetics, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a combined ring holder and organizer for cosmetics;
FIG. 2 is a front view of the organizer of FIG. 1;
FIG. 3 is a right end view of the organizer of FIG. 1, the left end view being the mirror image thereof;
FIG. 4 is a top view of the organizer of FIG. 1;
FIG. 5 is a rear view of the organizer of FIG. 1 with the handle and ring holder removed for ease of illustration;
FIG. 6 is a bottom view of the organizer of FIG. 1;
FIG. 7 is a perspective view of a second modified embodiment;
FIG. 8 is a front view of the organizer of FIG. 7;
FIG. 9 is a left end view of the organizer of FIG. 7, the right end view being the mirror image thereof;
FIG. 10 is a top view of the organizer of FIG. 7;
FIG. 11 is a rear view of the organizer of FIG. 7 with the handle and ring holder removed for ease of illustration;
FIG. 12 is a bottom view of the organizer of FIG. 7;
FIG. 13 is a perspective view of a third modified embodiment;
FIG. 14 is a front view of the organizer of FIG. 13;
FIG. 15 is a left end view of the organizer of FIG. 13, the right end view being the mirror image thereof;
FIG. 16 is a top view of the organizer of FIG. 13;
FIG. 17 is a rear view of the organizer of FIG. 13 with the handle and ring holder removed for ease of illustration; and,
FIG. 18 is a bottom view of the organizer of FIG. 13.

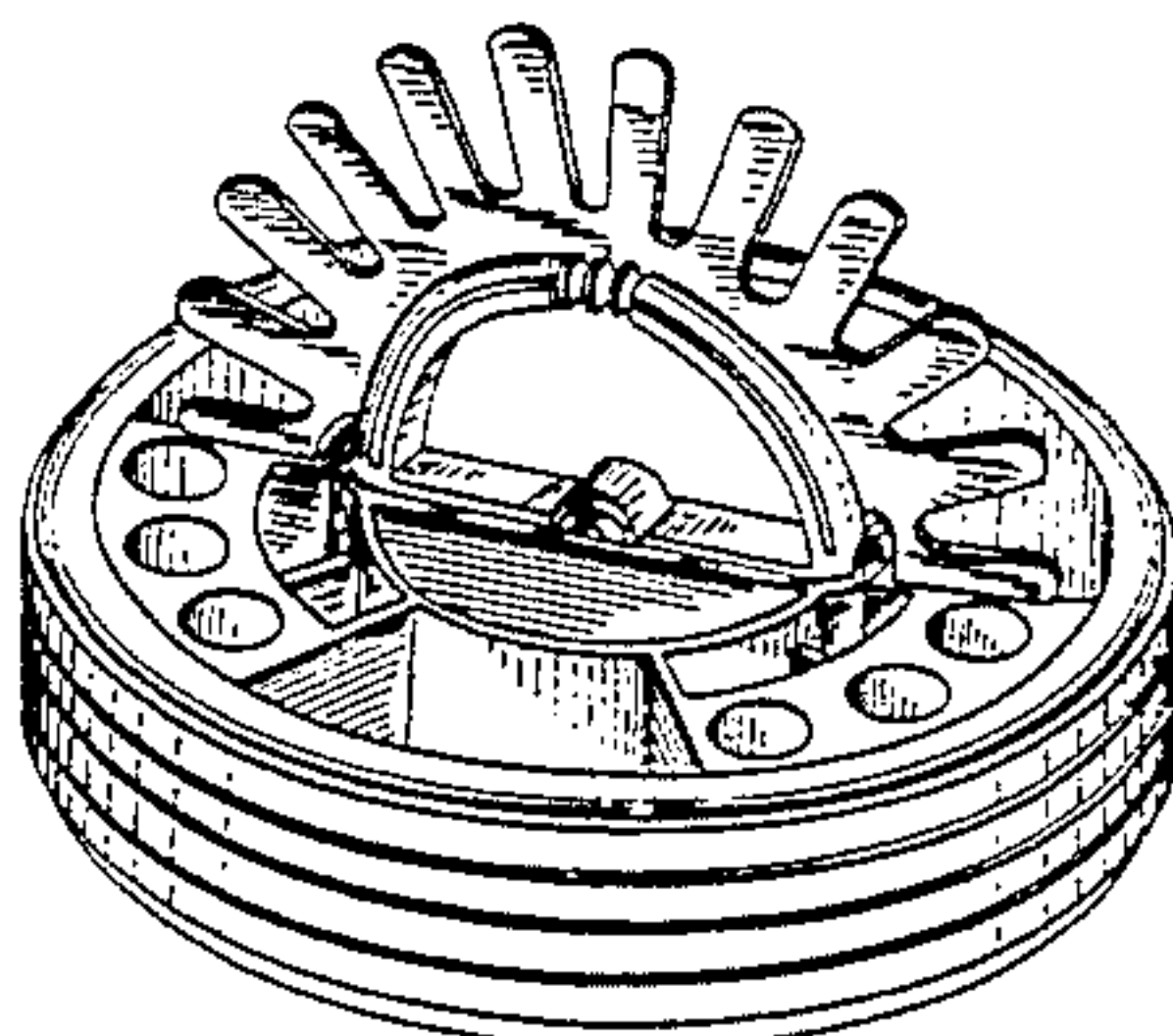
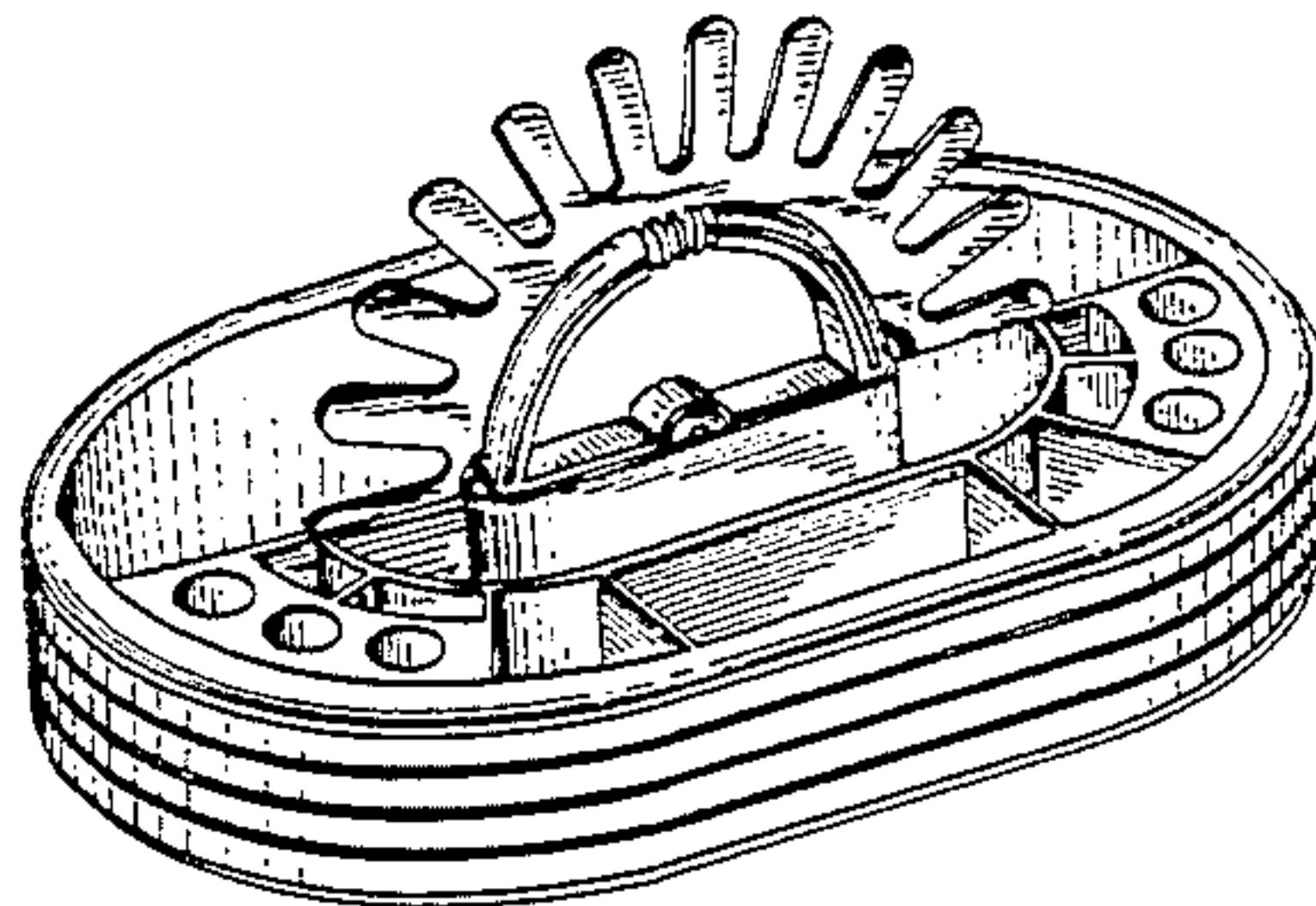
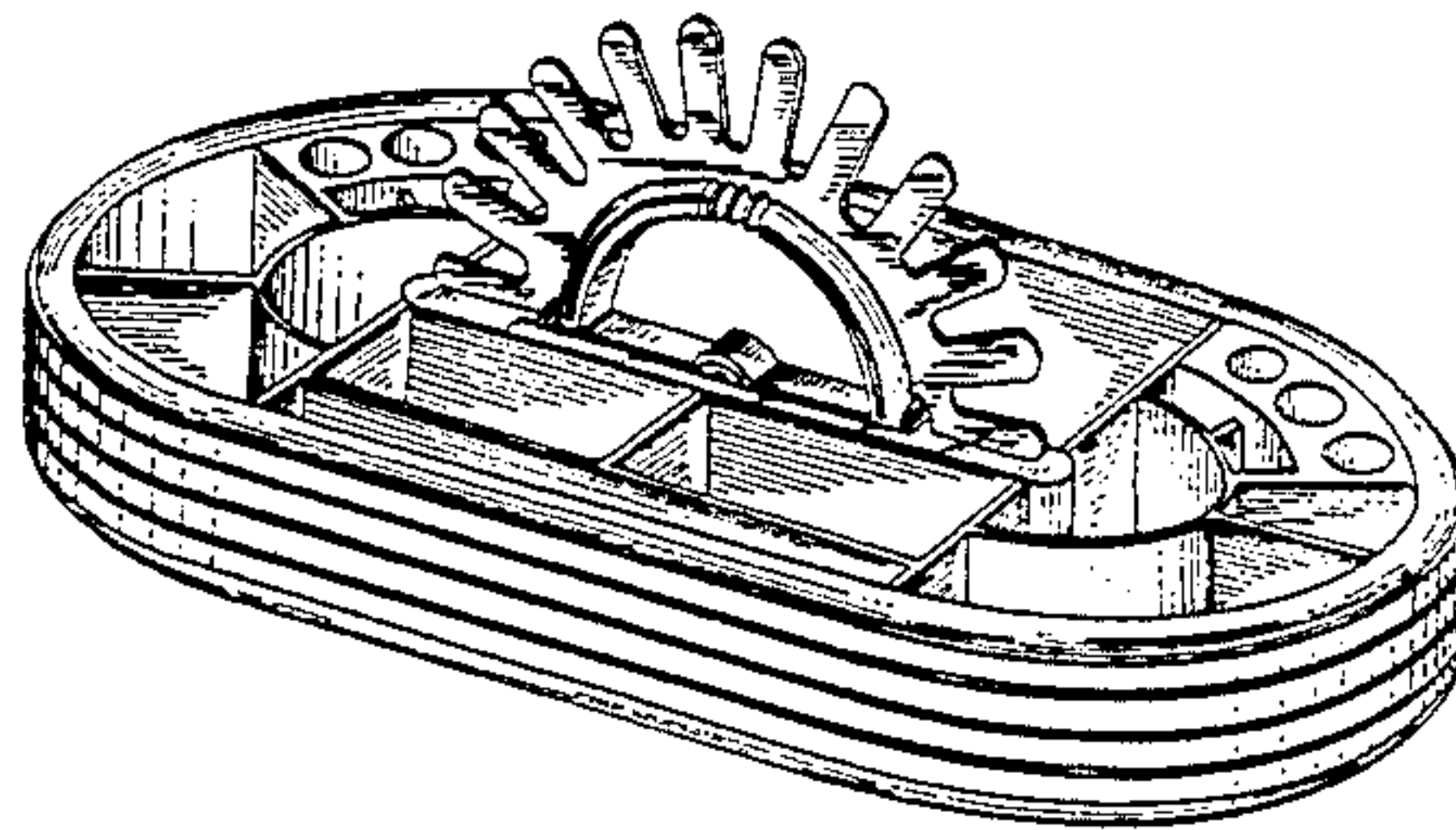

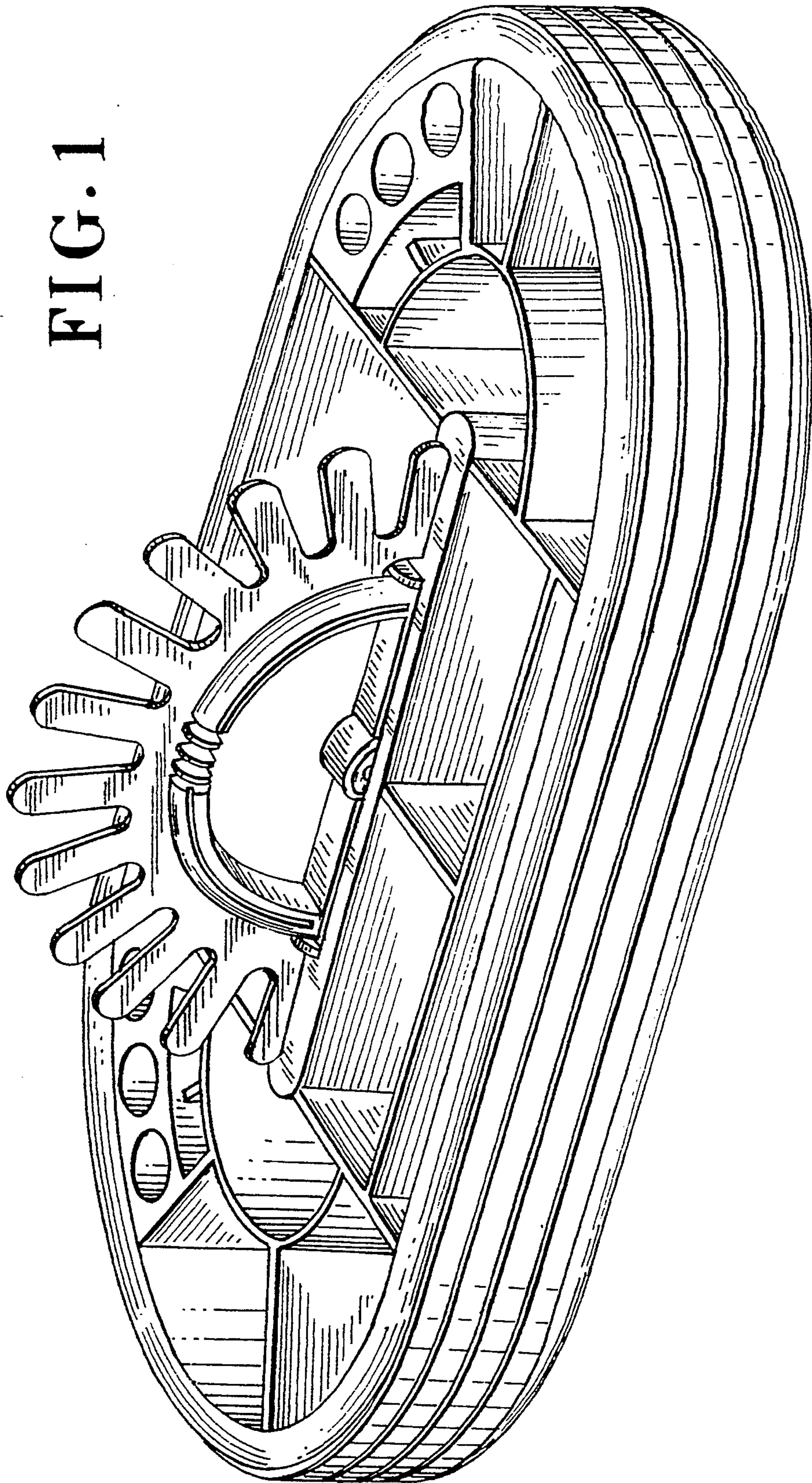

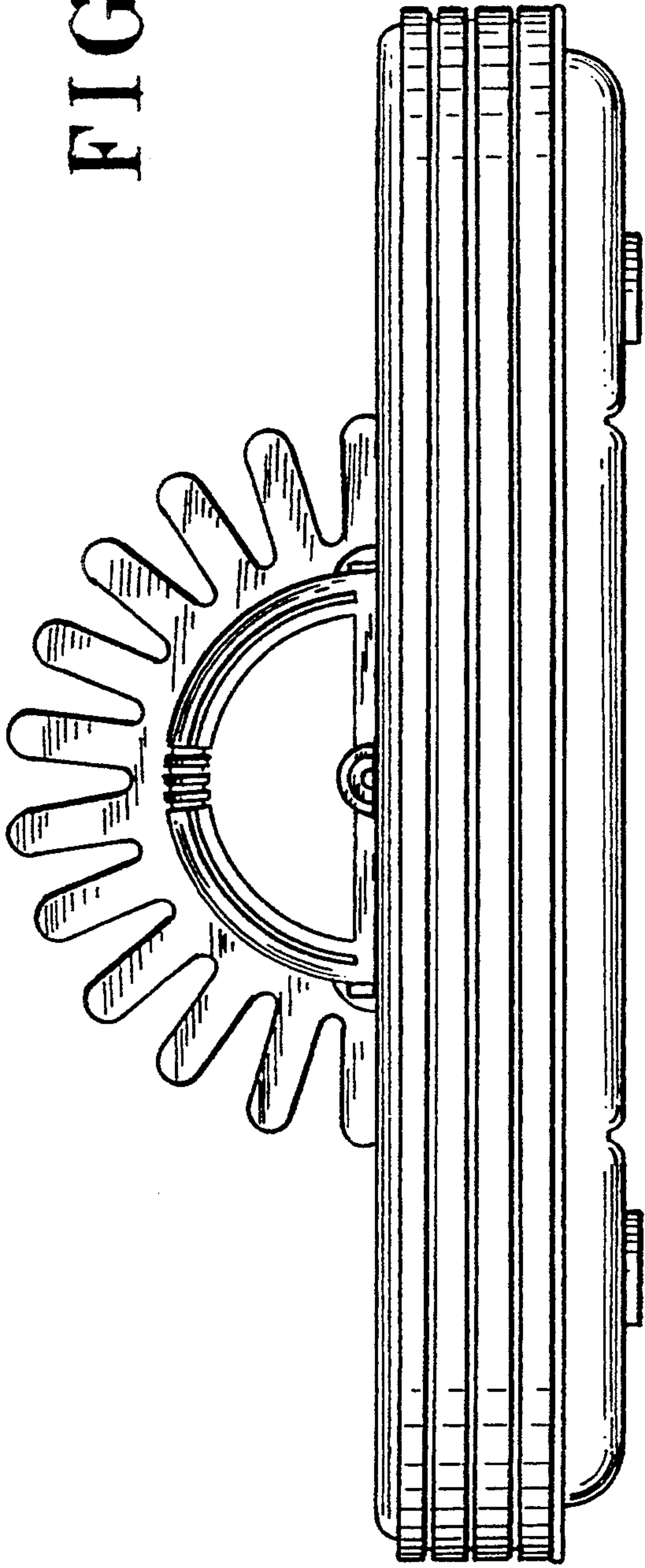

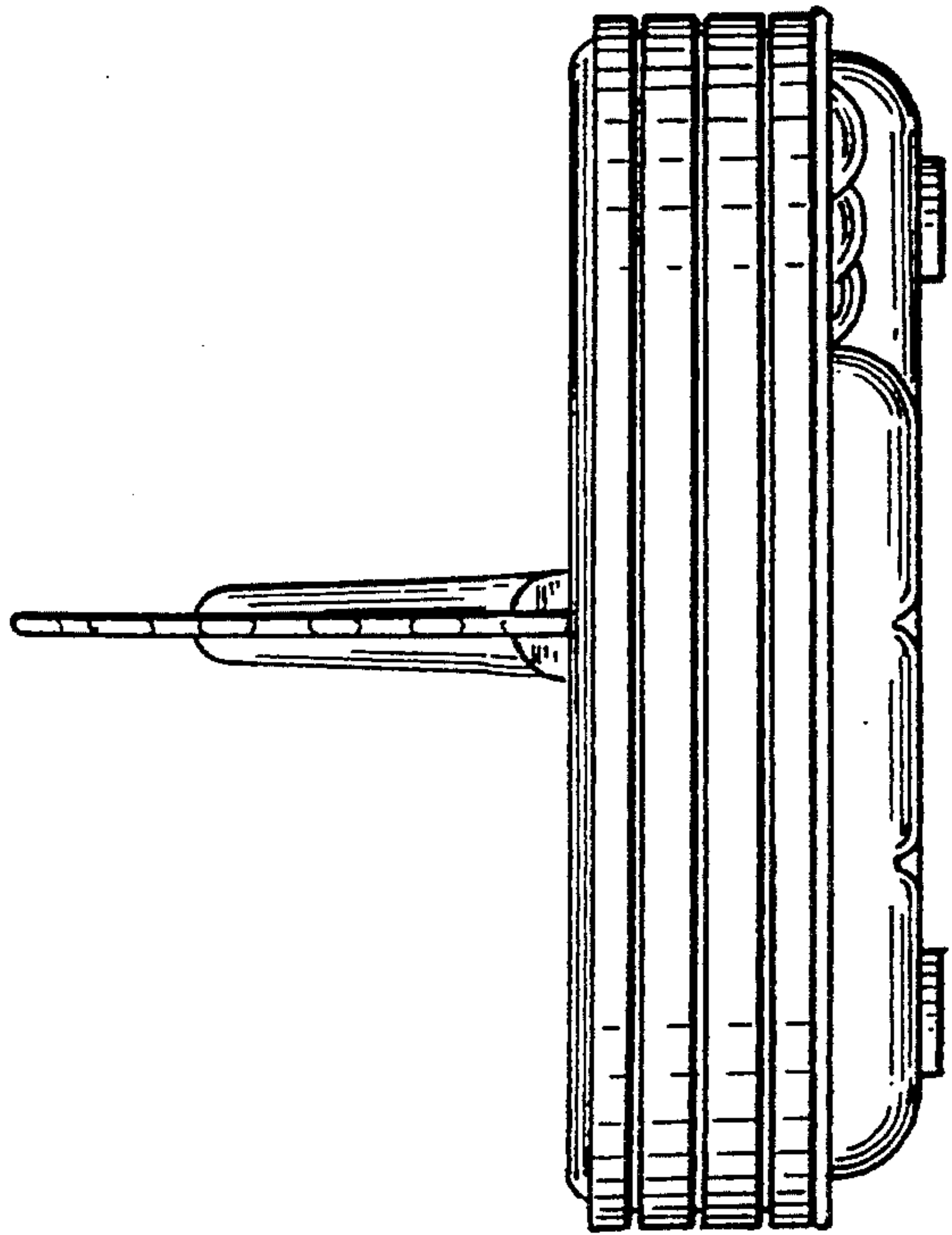

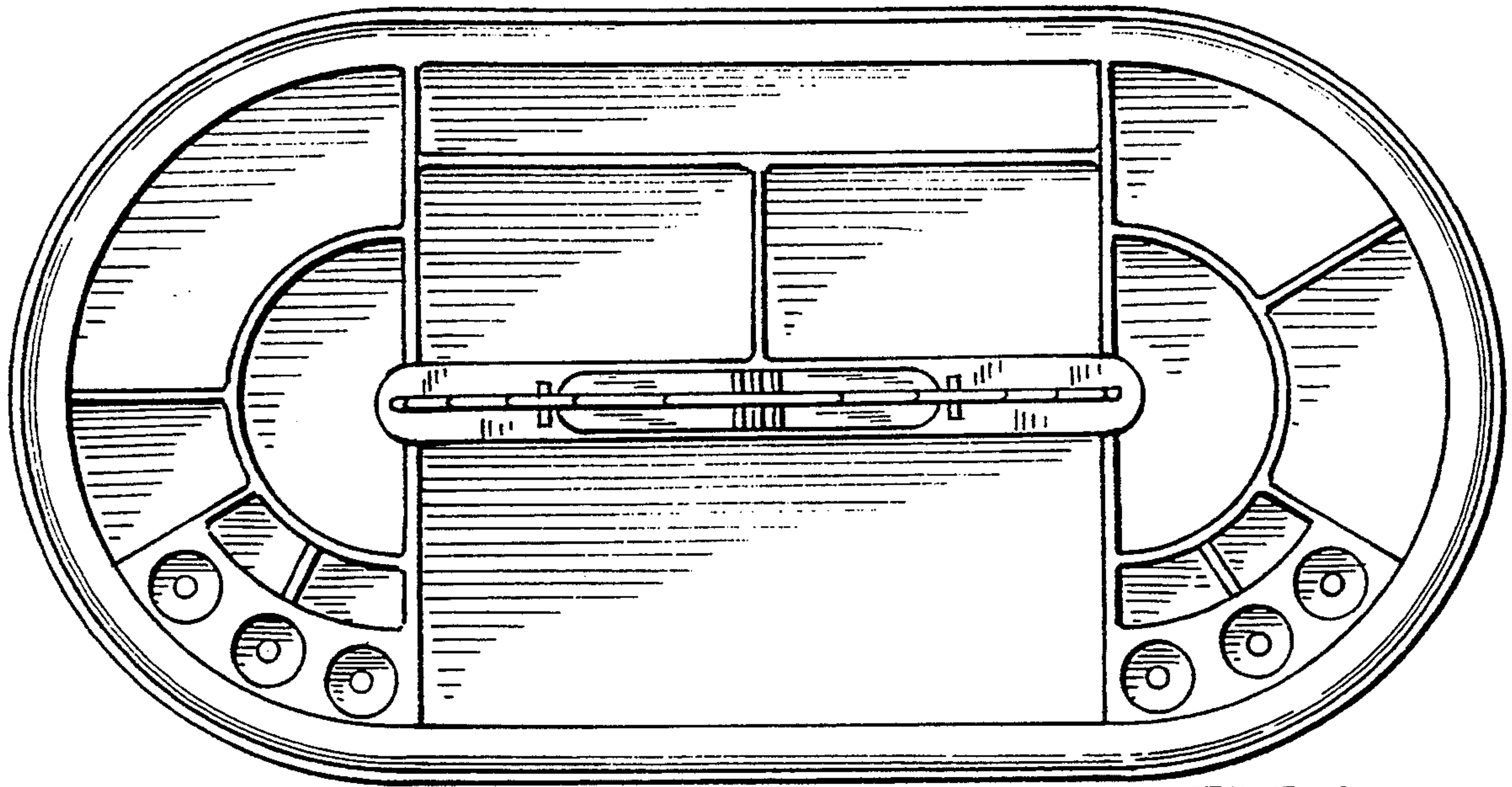

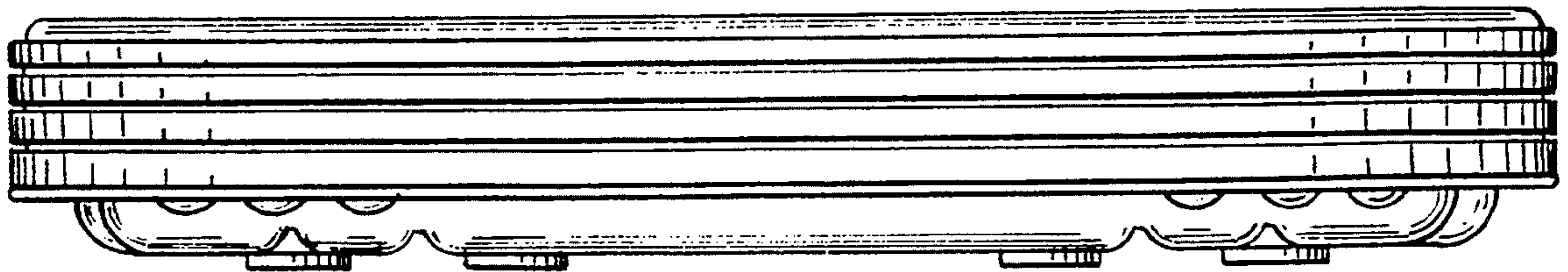

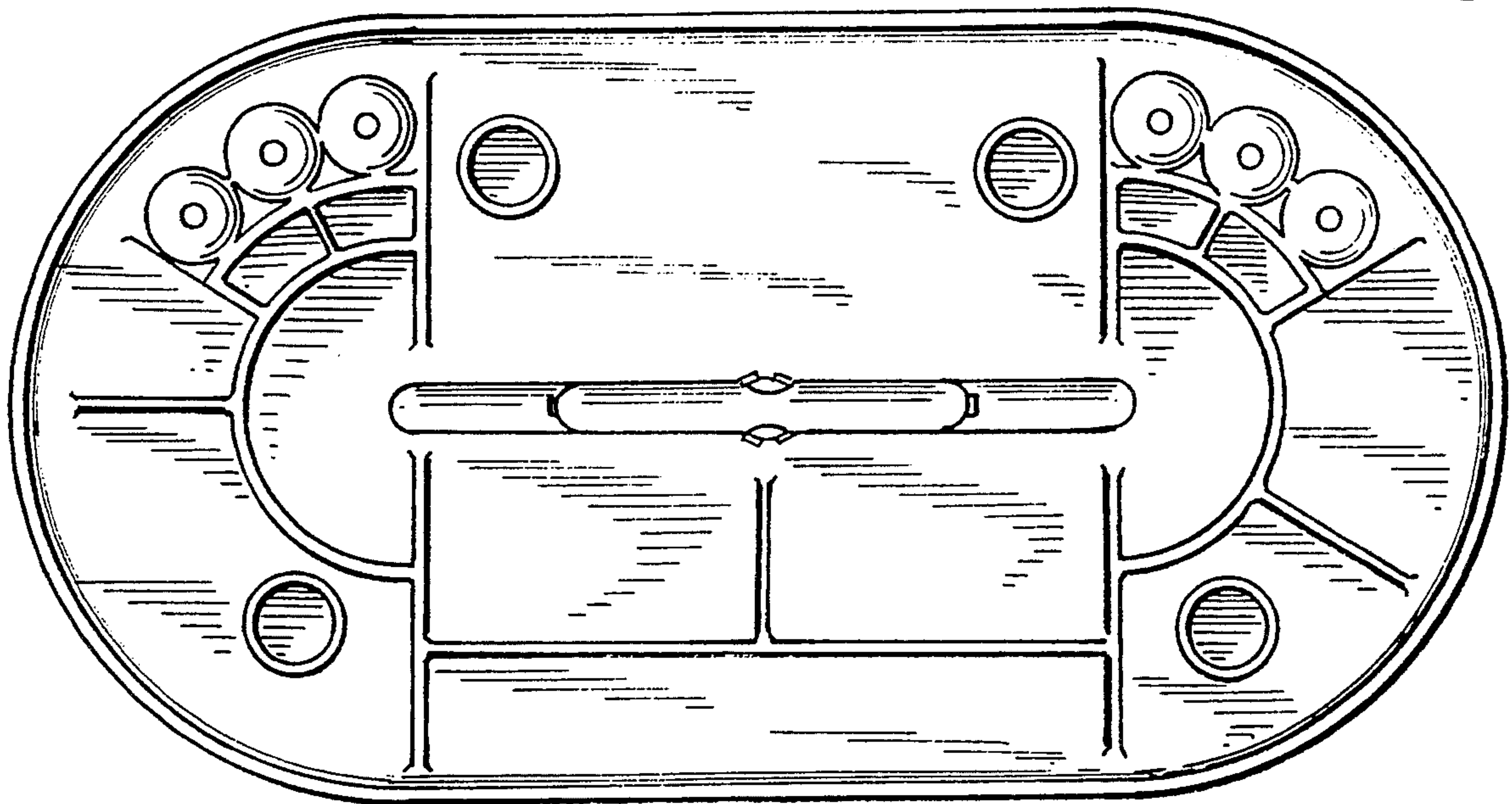

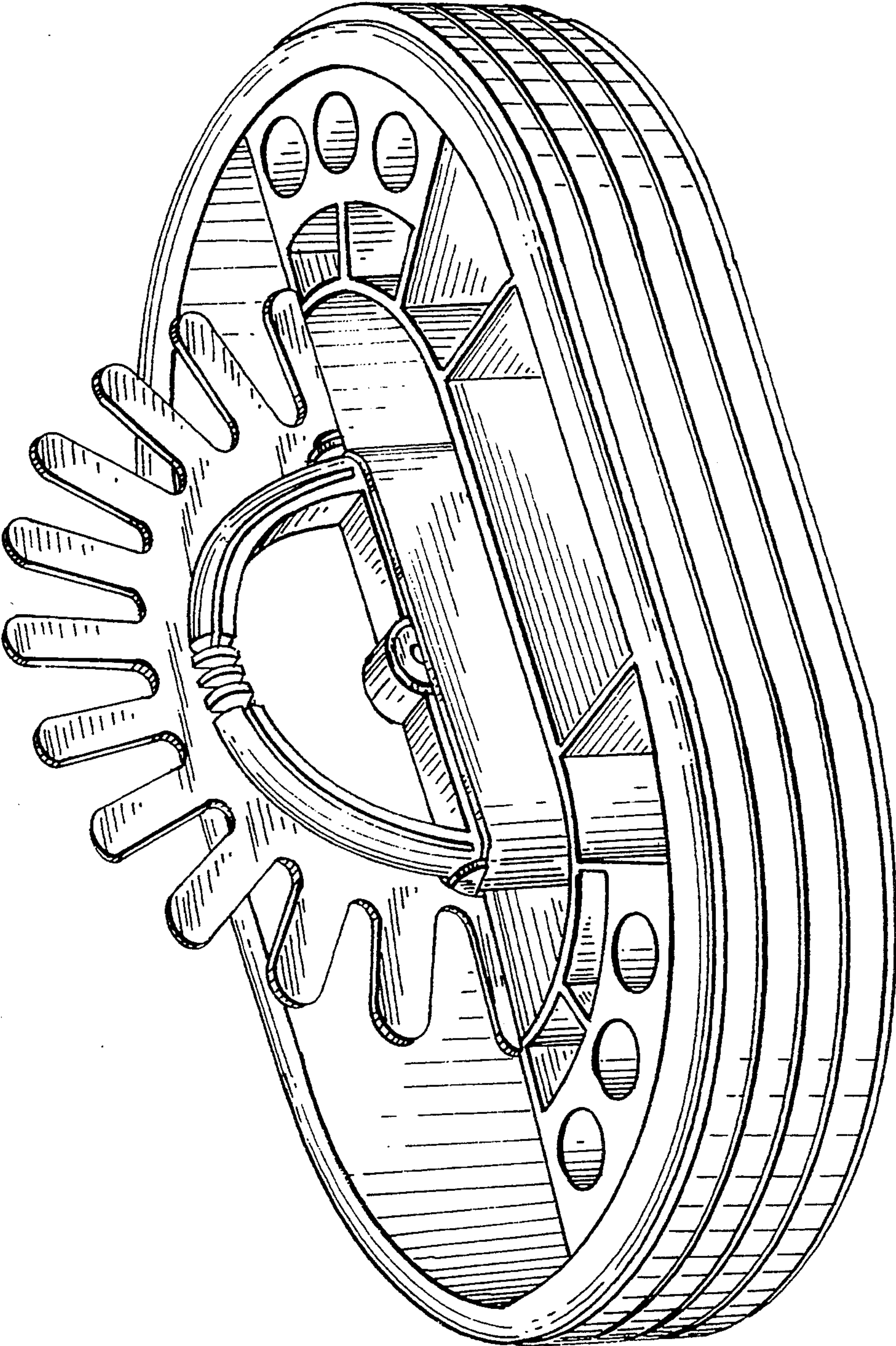

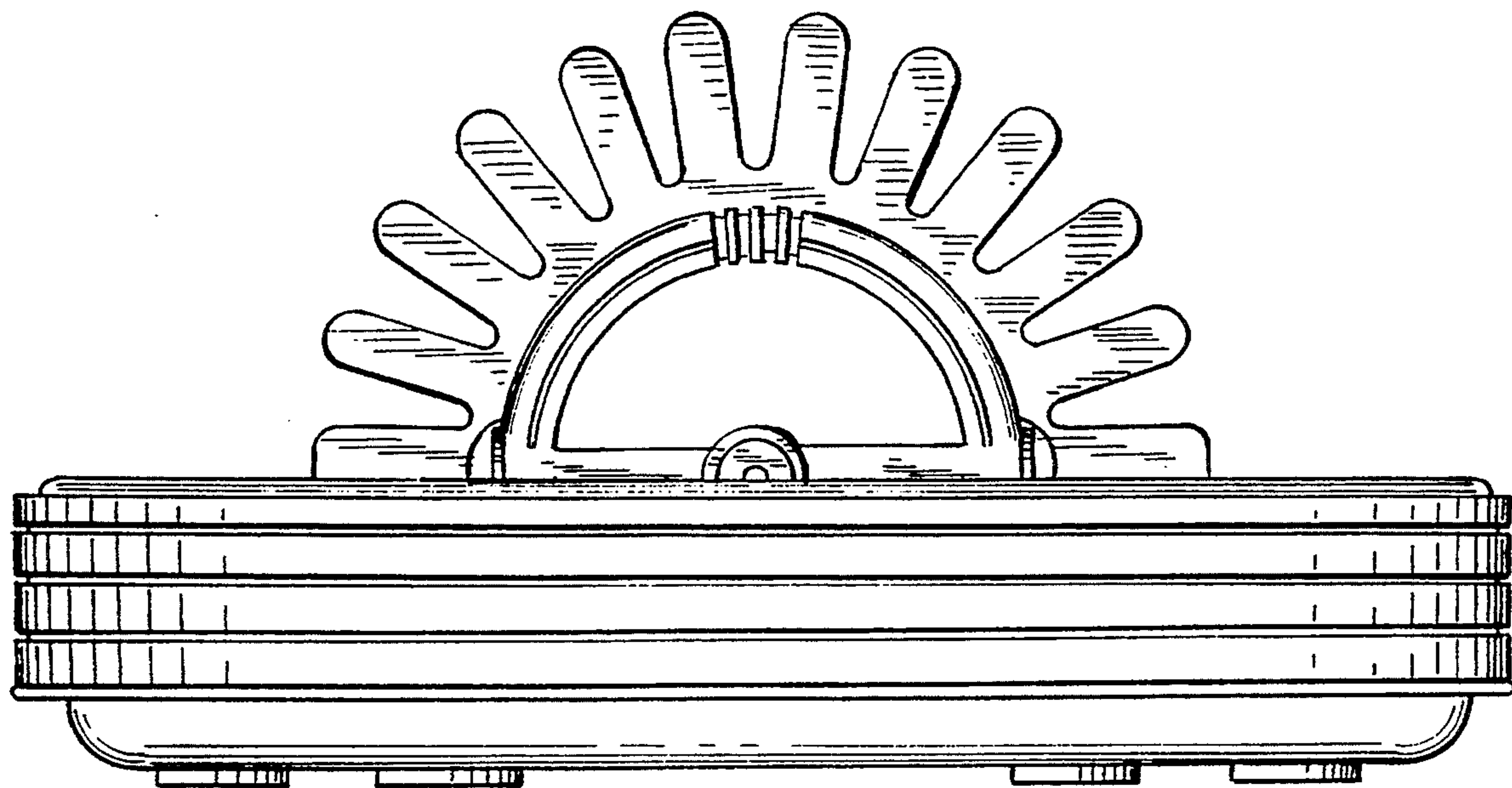

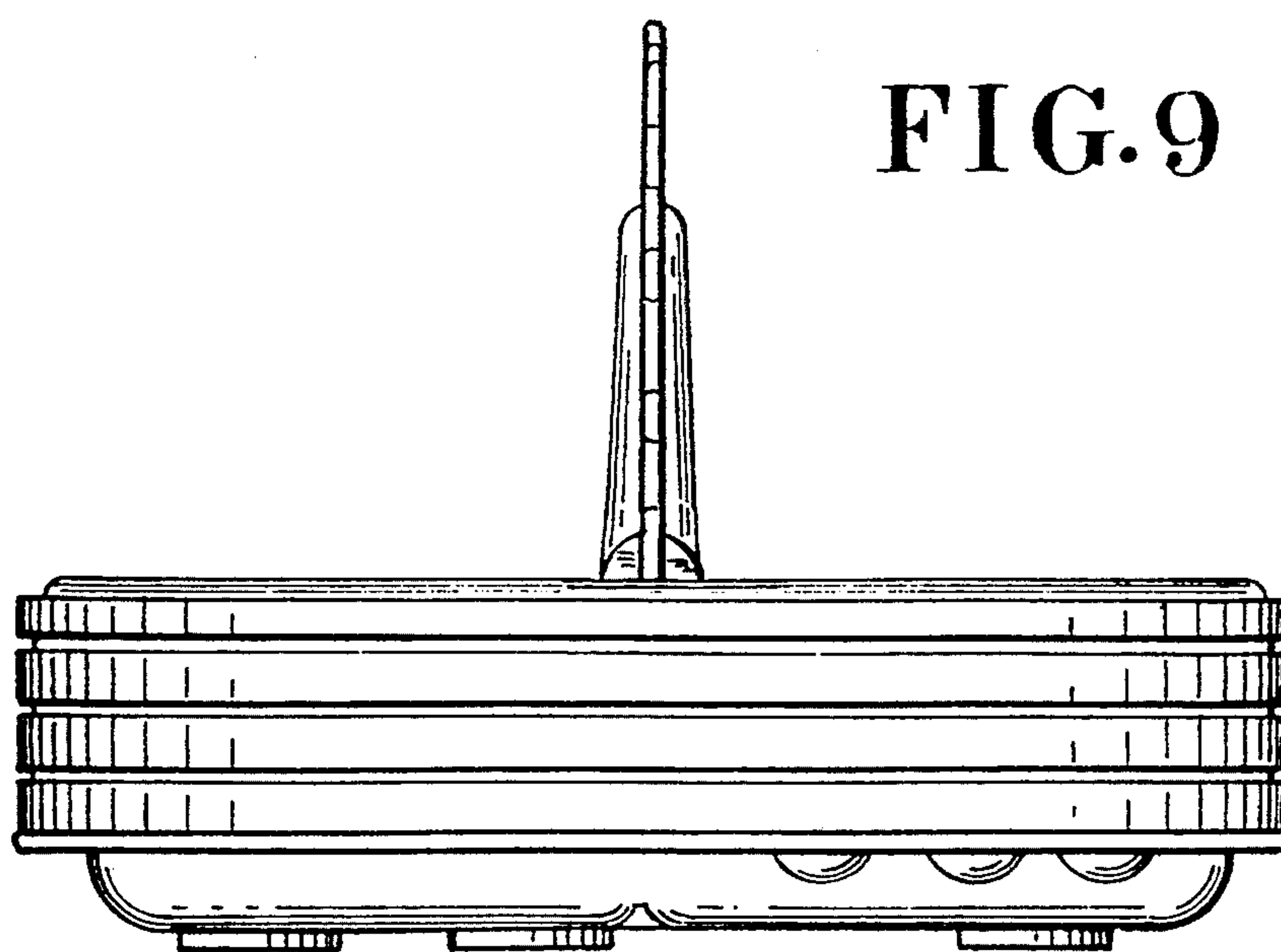

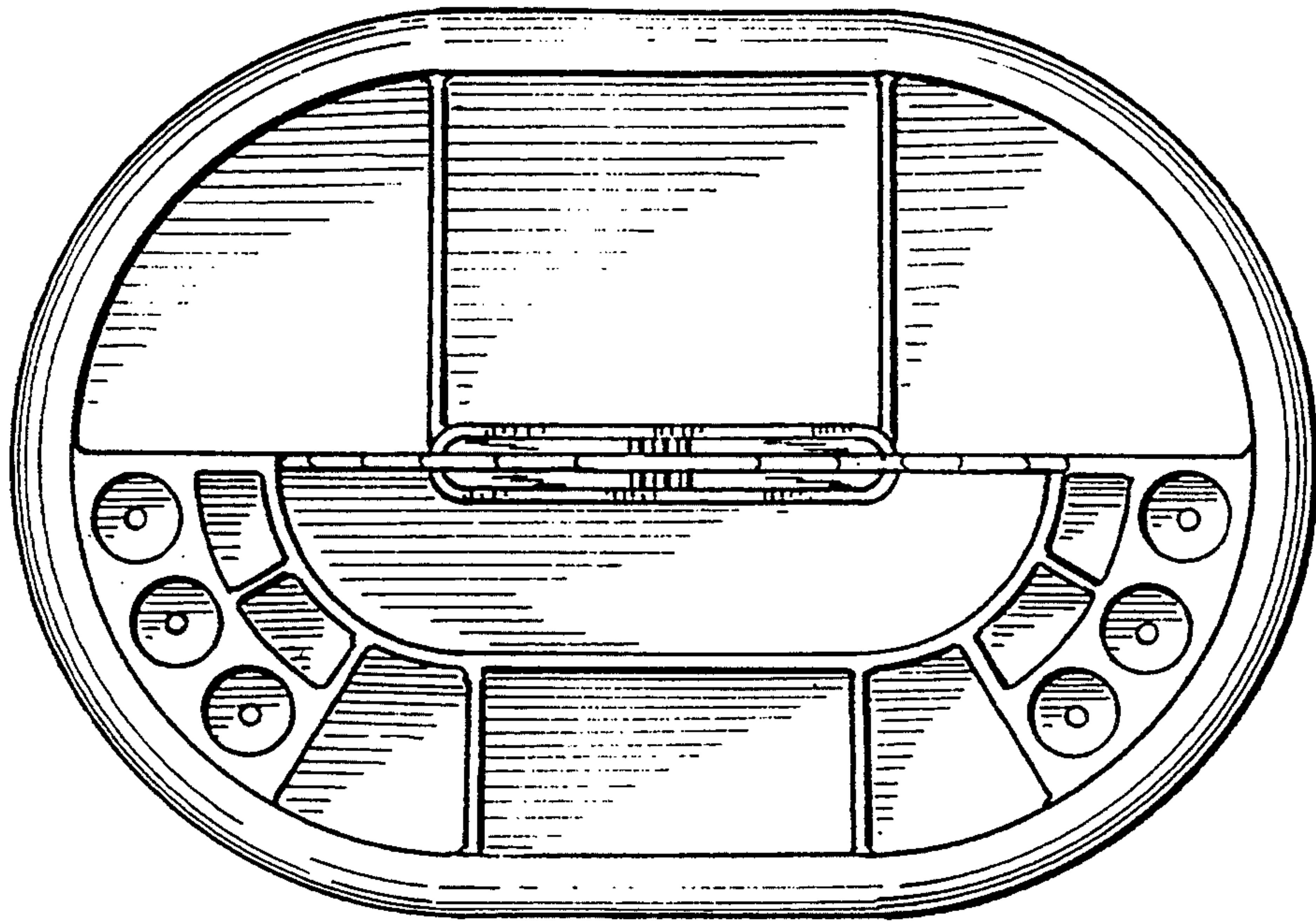

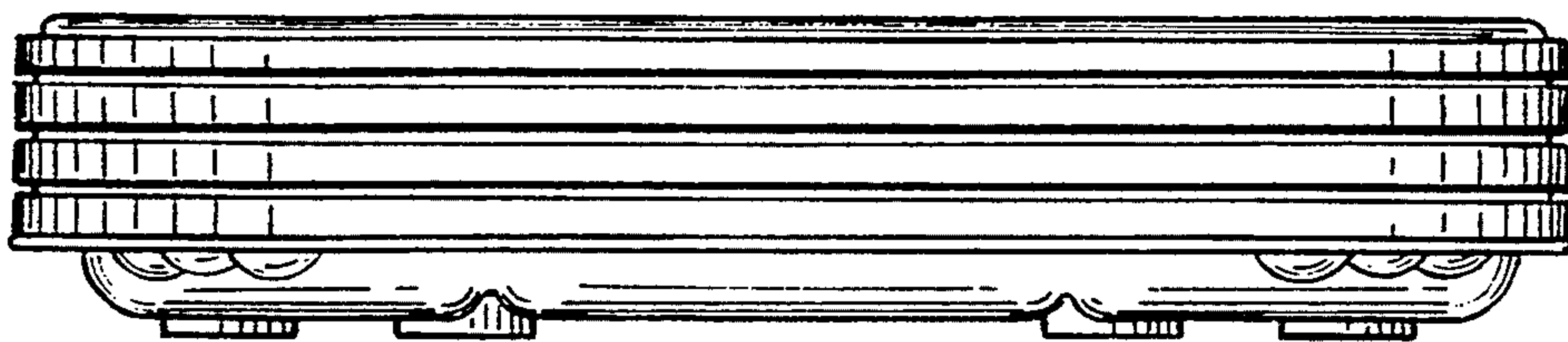

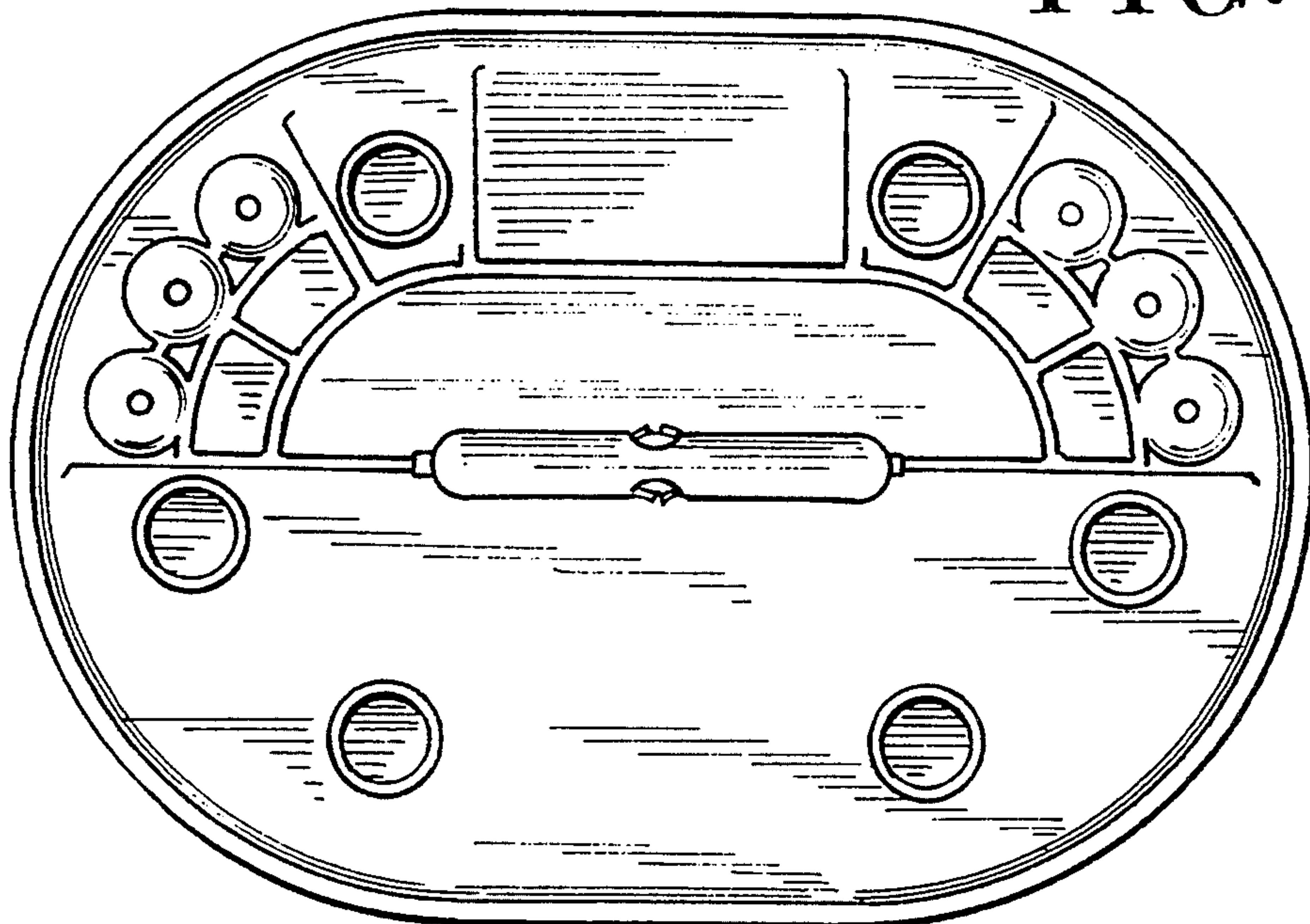

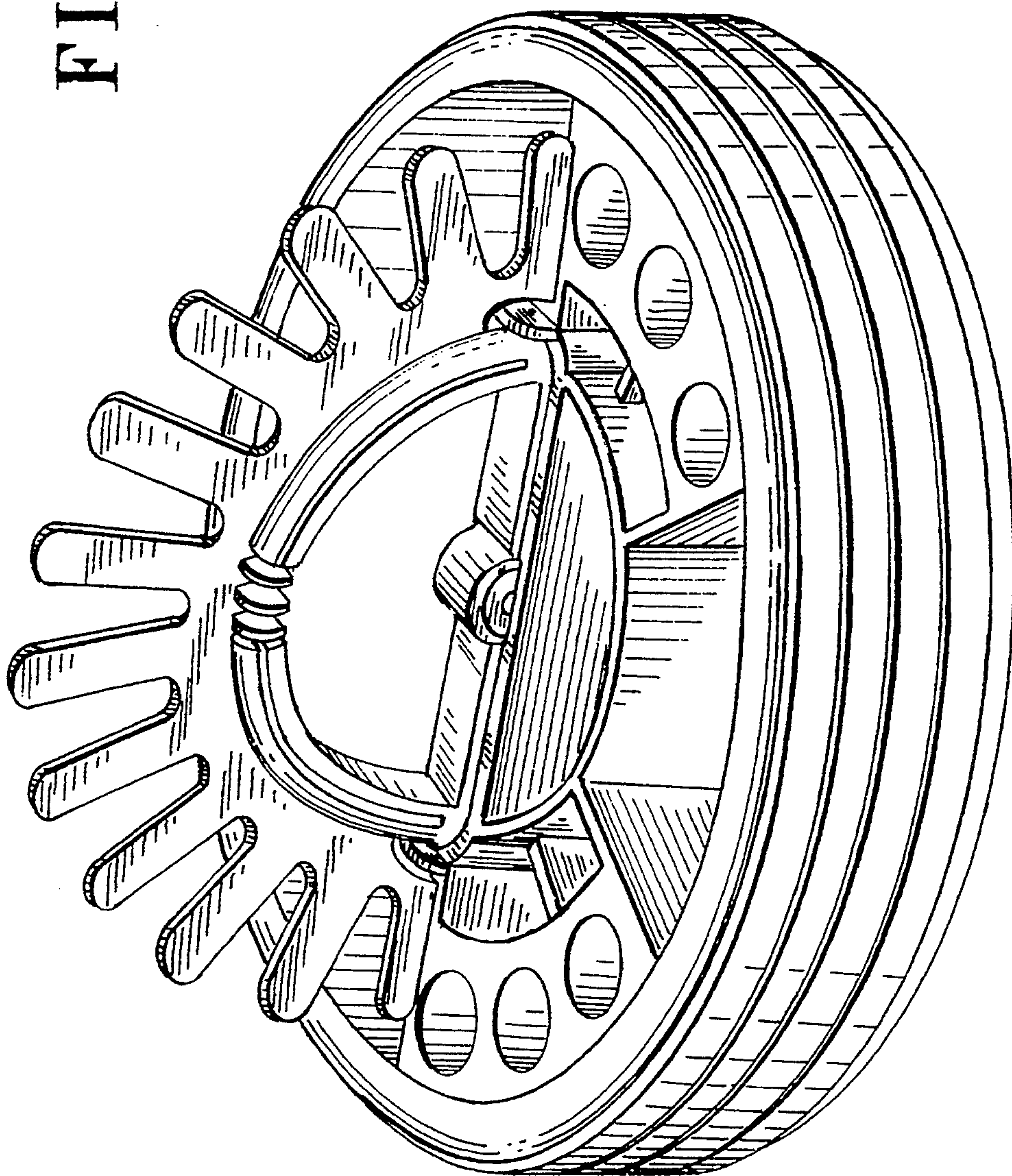

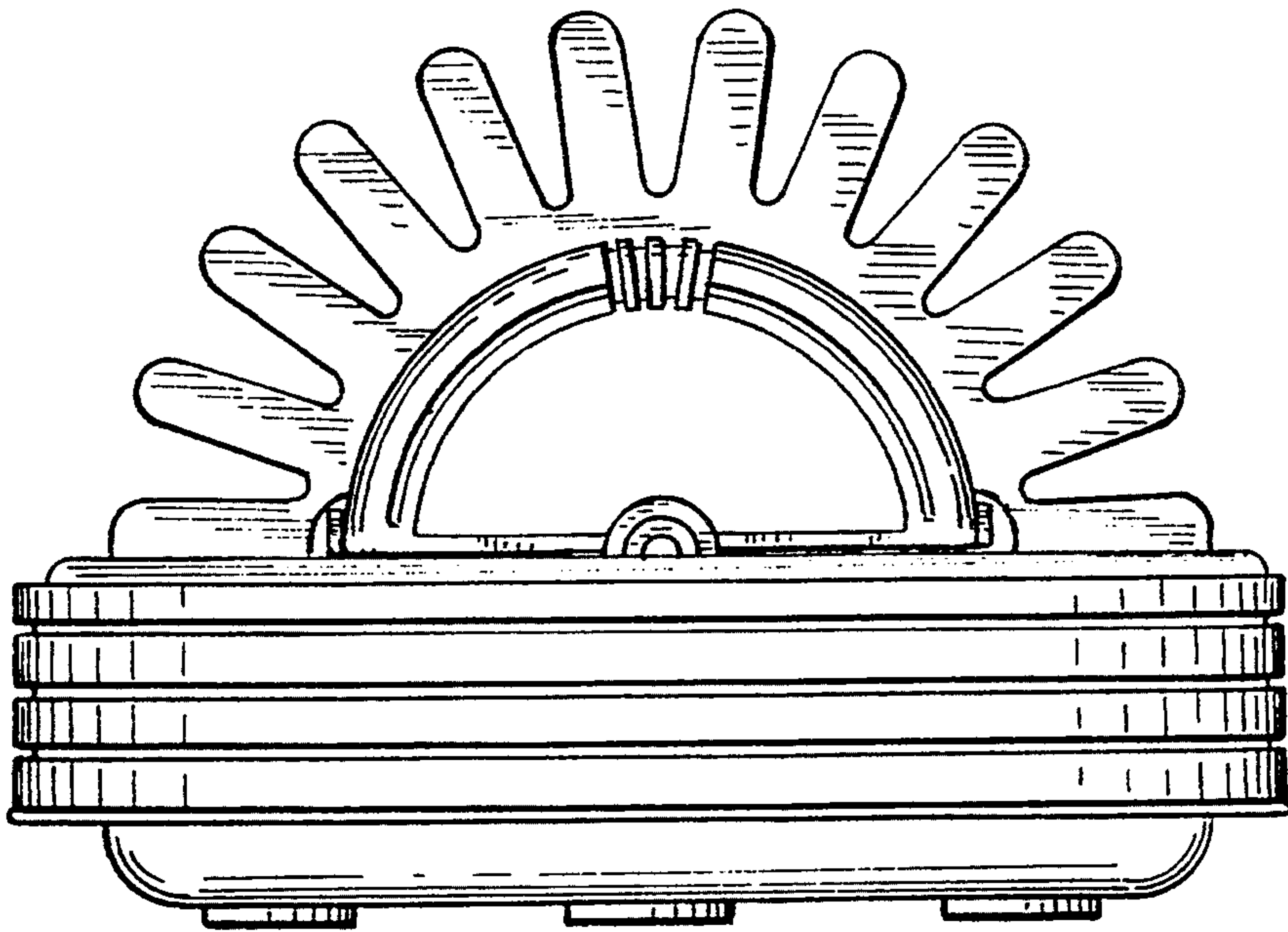

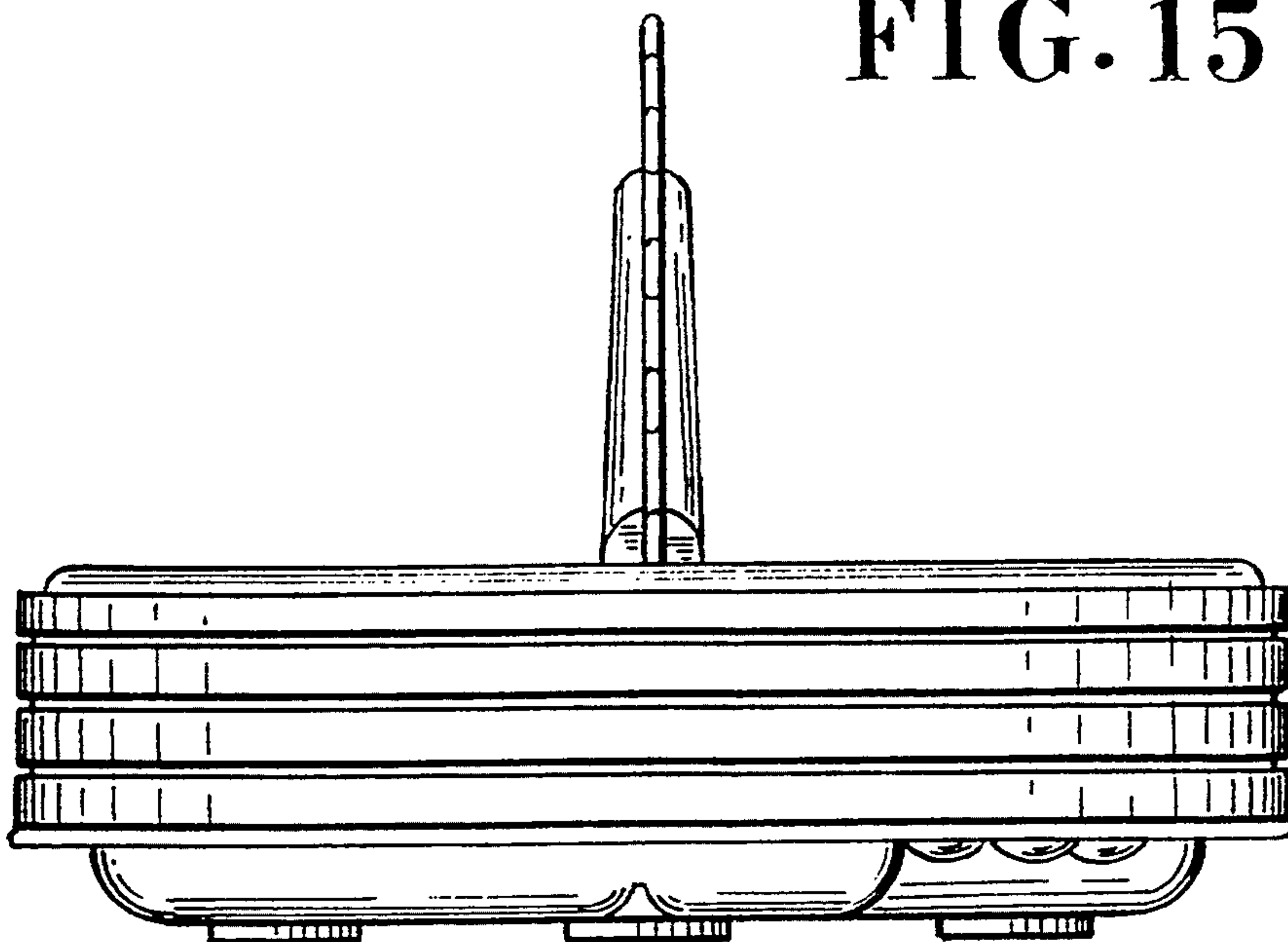

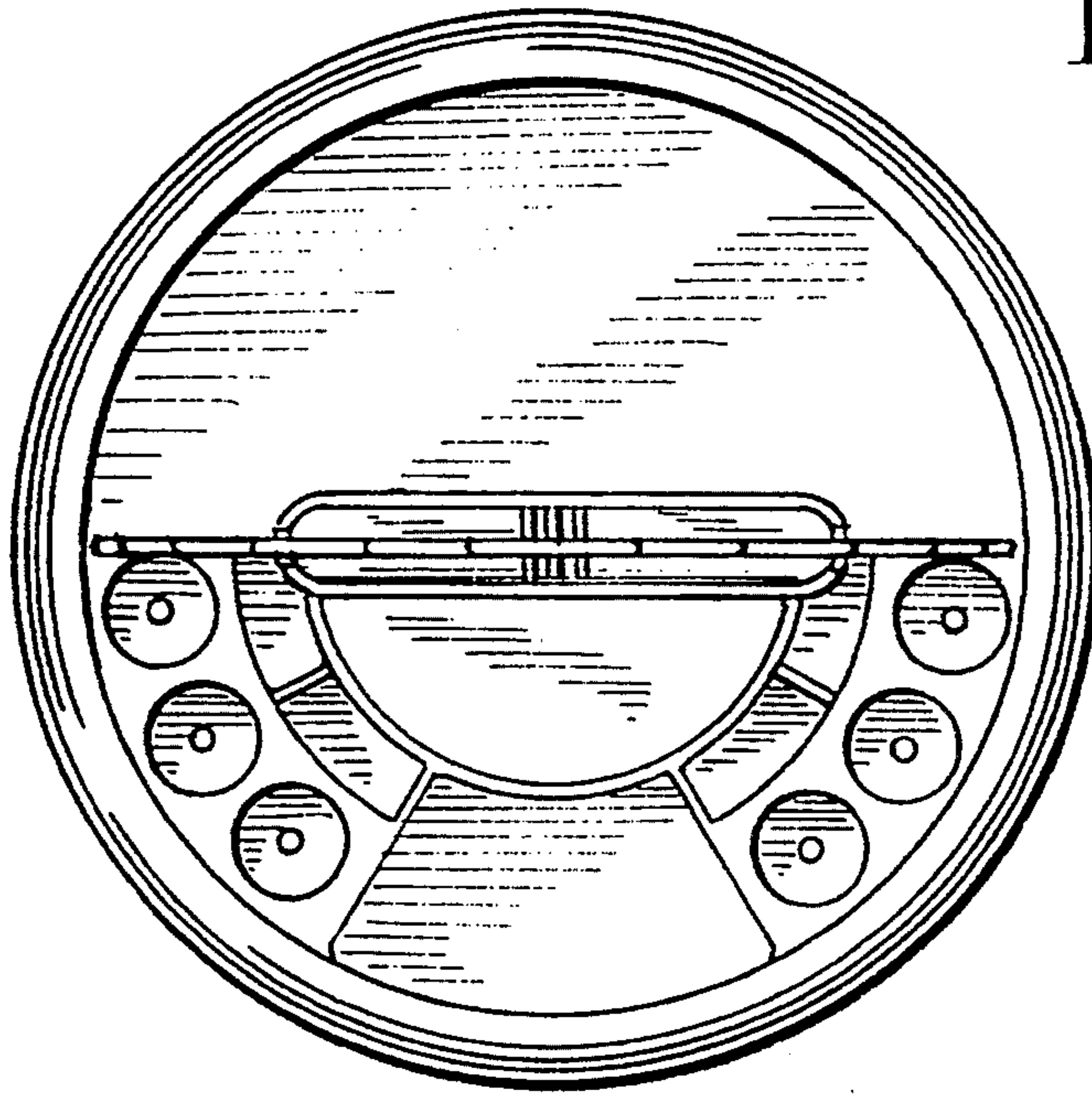

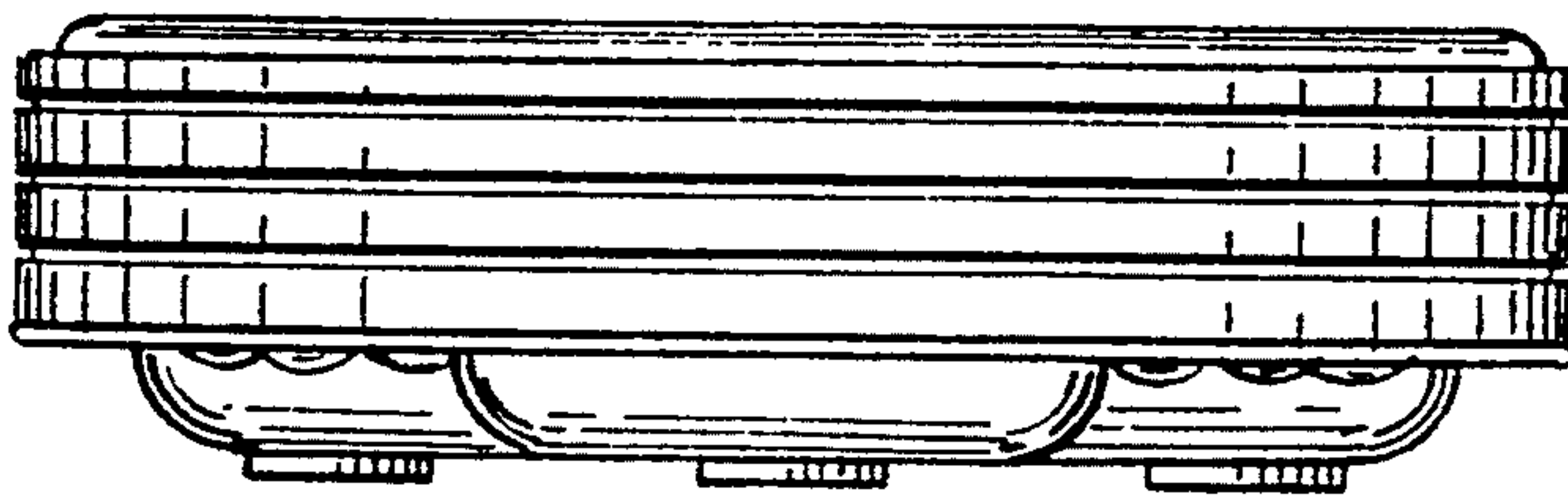
