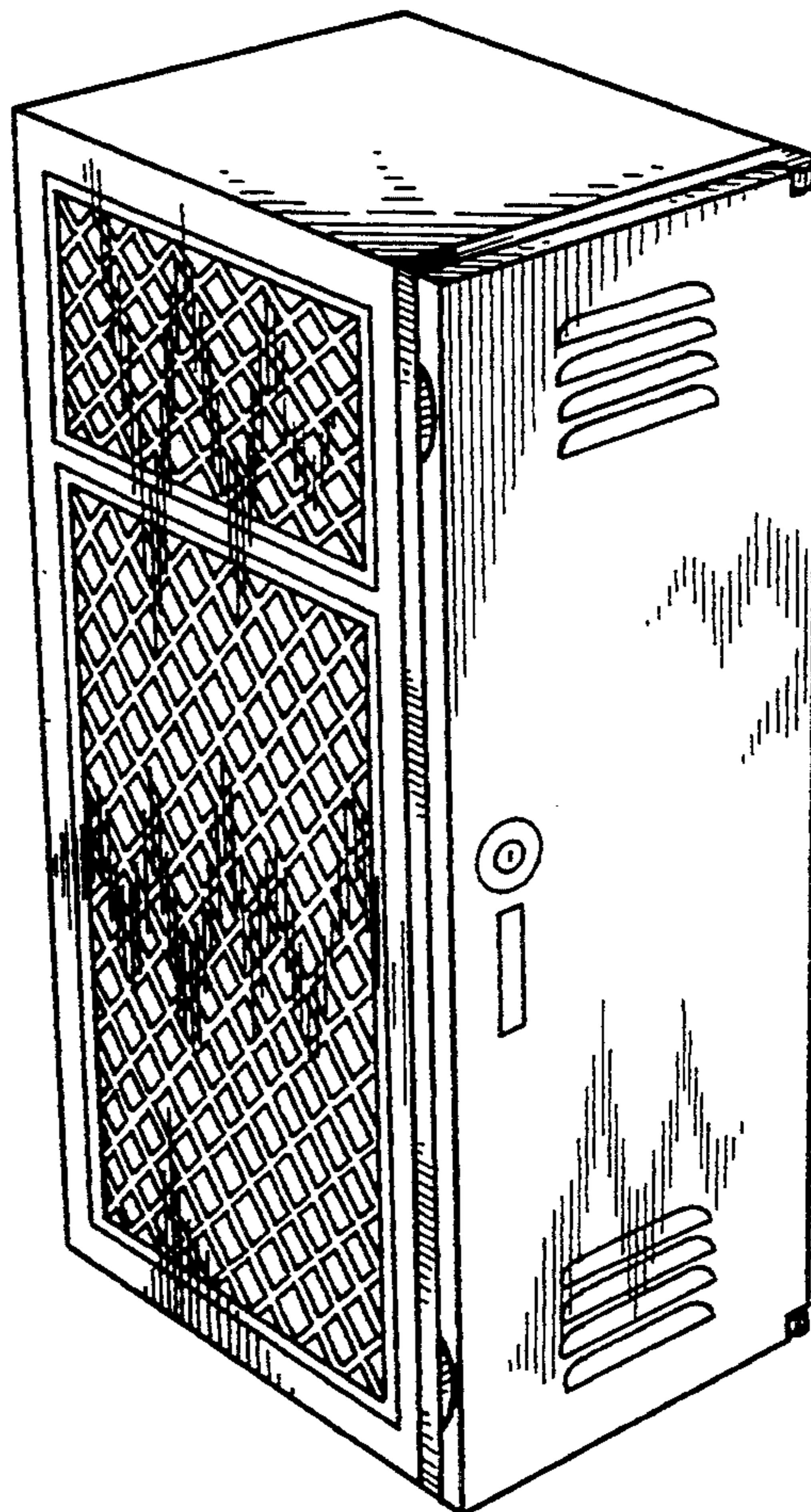

The ornamental design for storage container for sports memorabilia and collectible cards, as shown and described.

DESCRIPTION

FIG. 8 is a bottom view thereof.



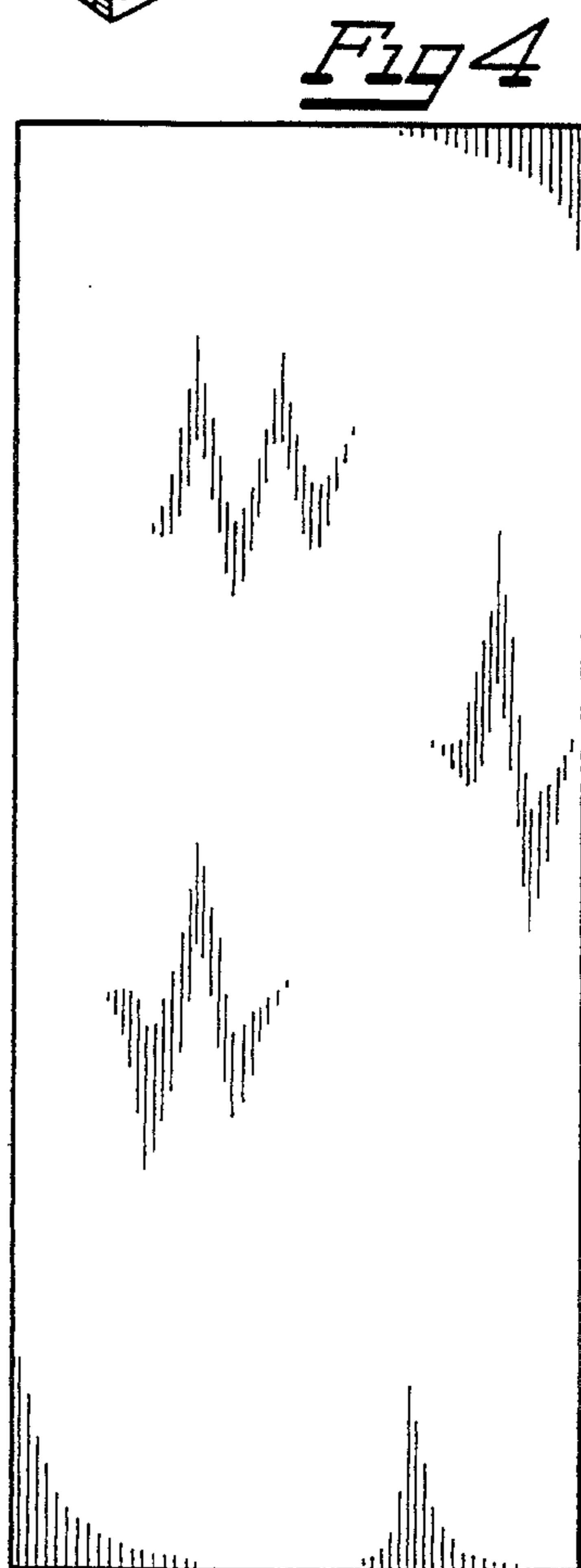
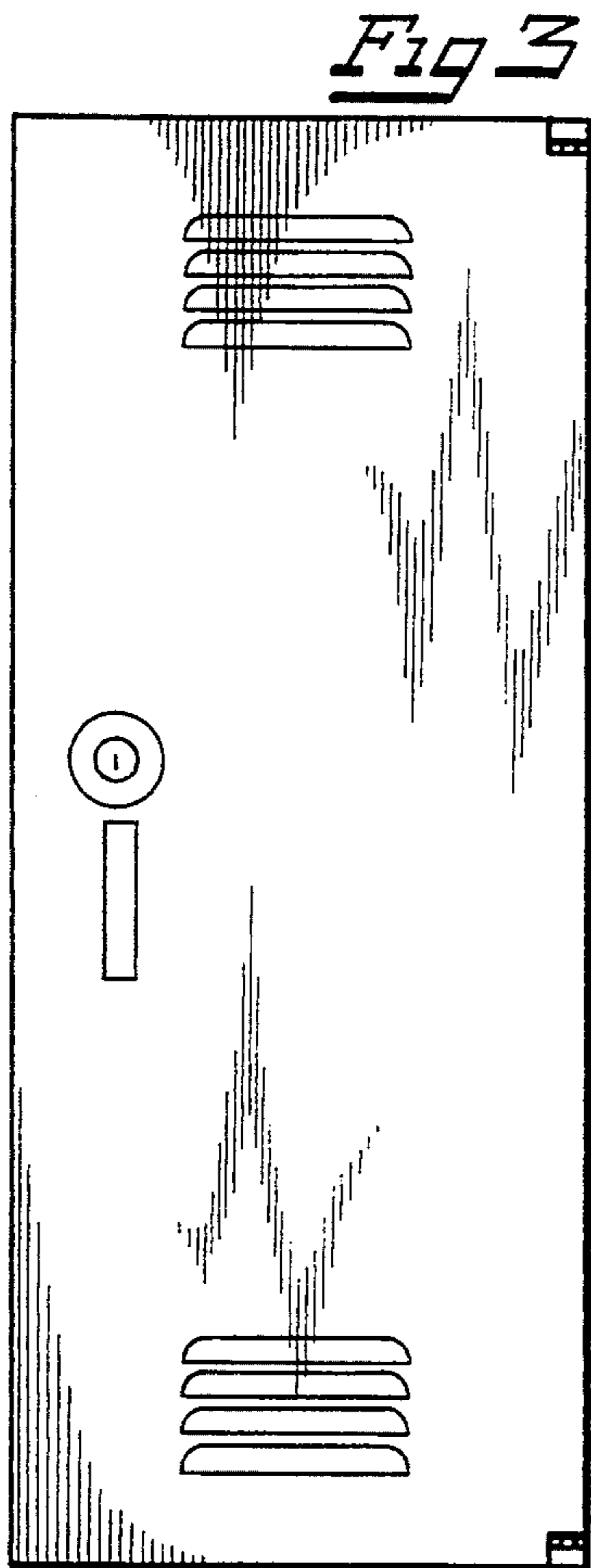
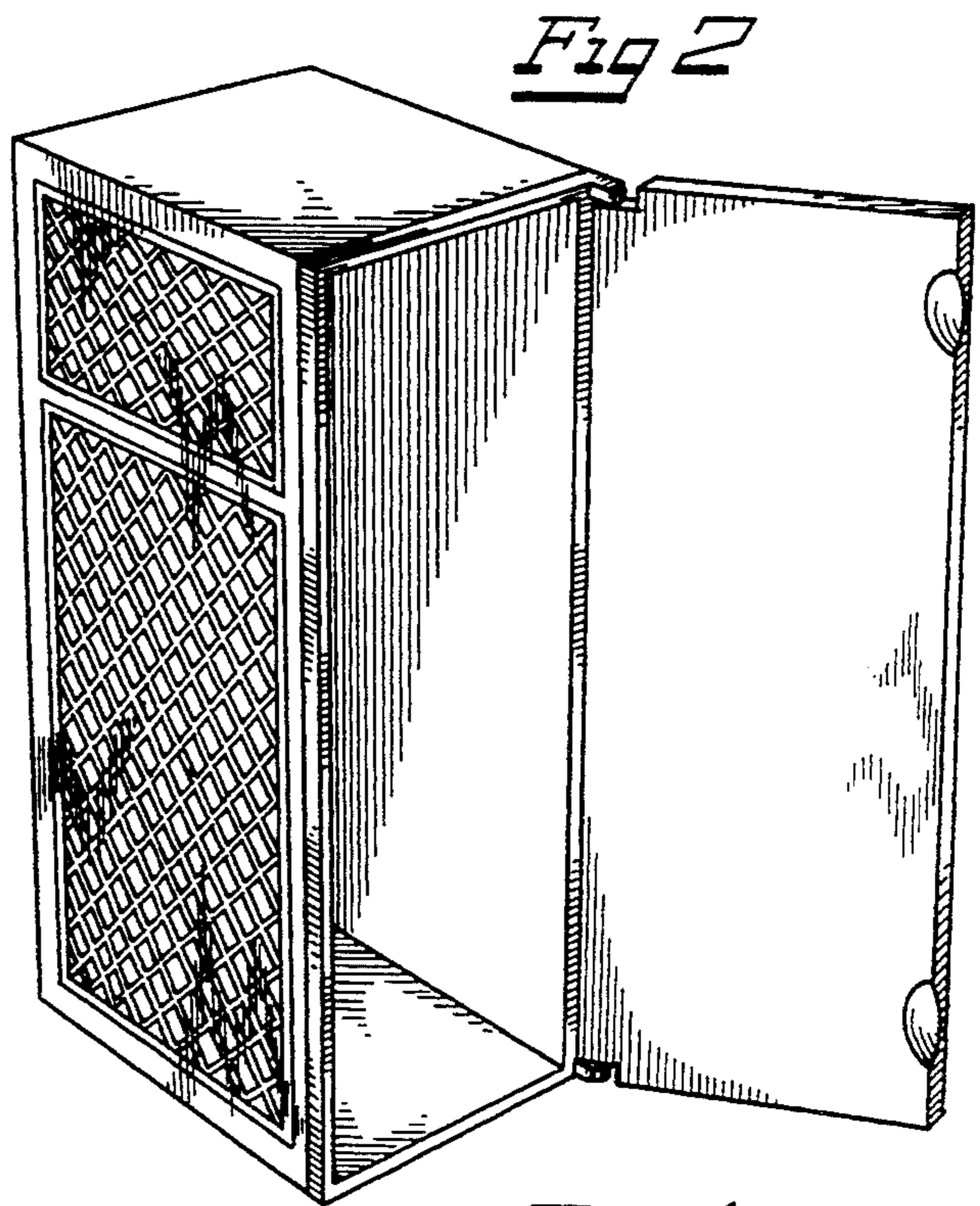
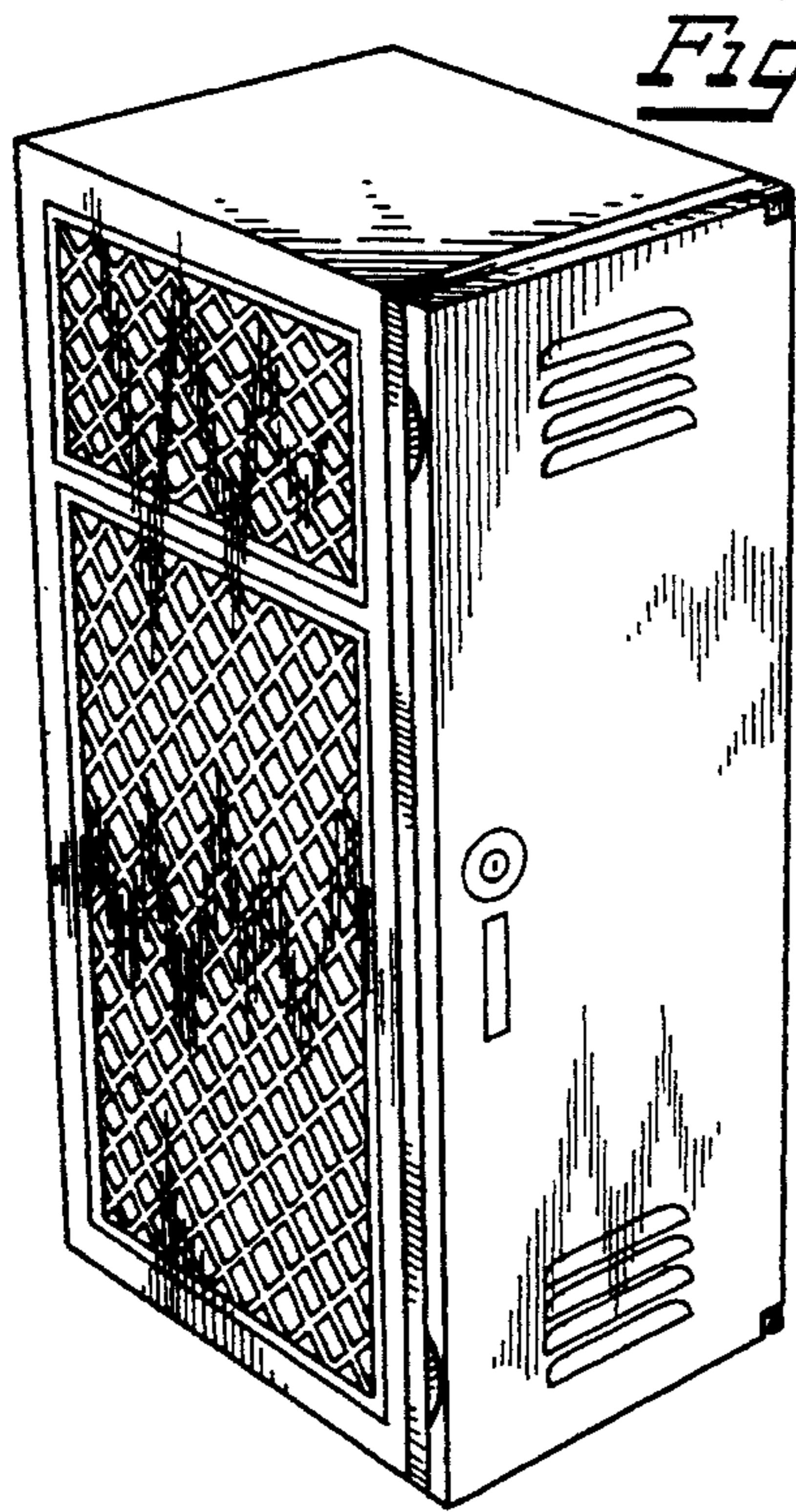

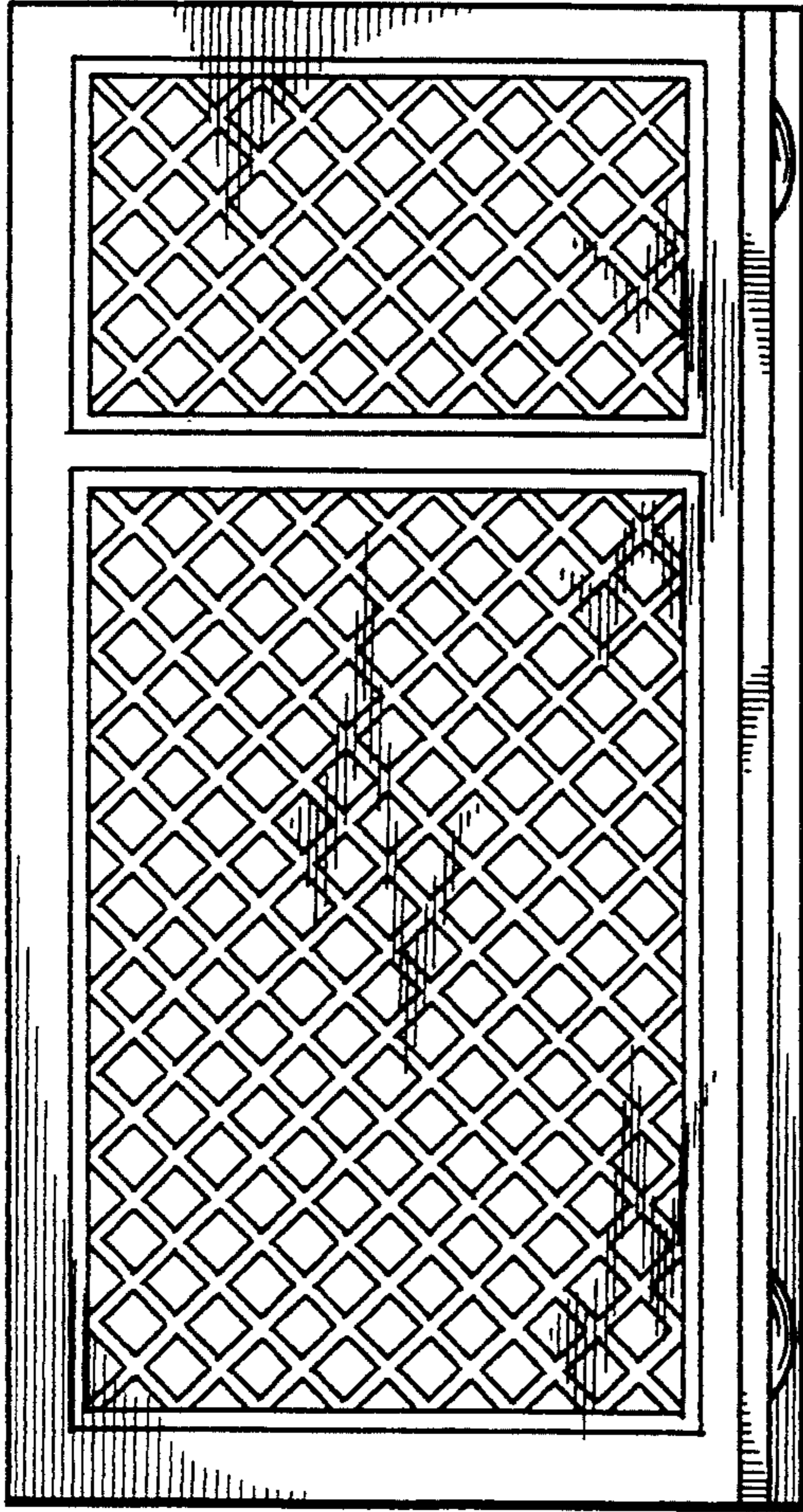

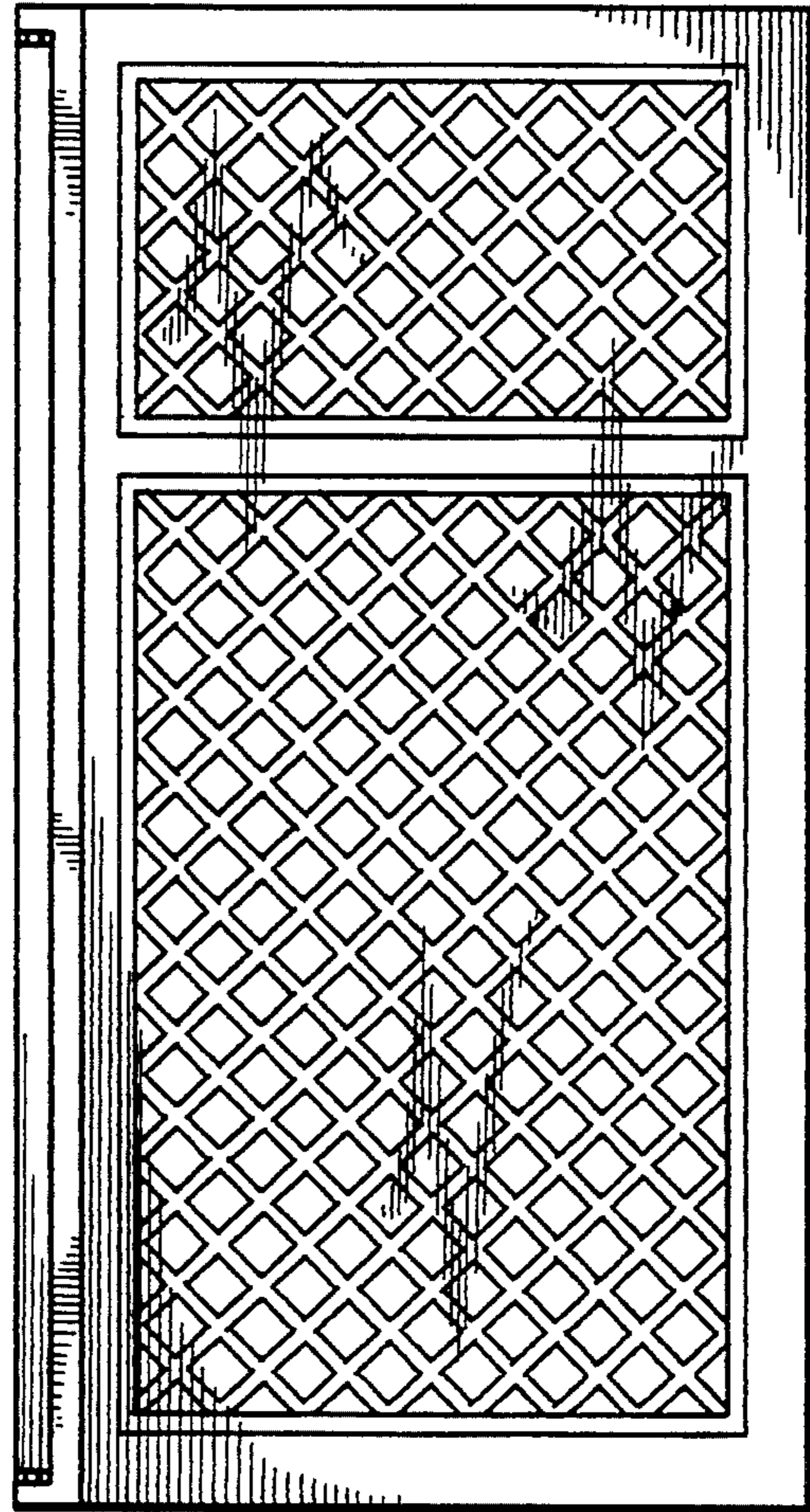

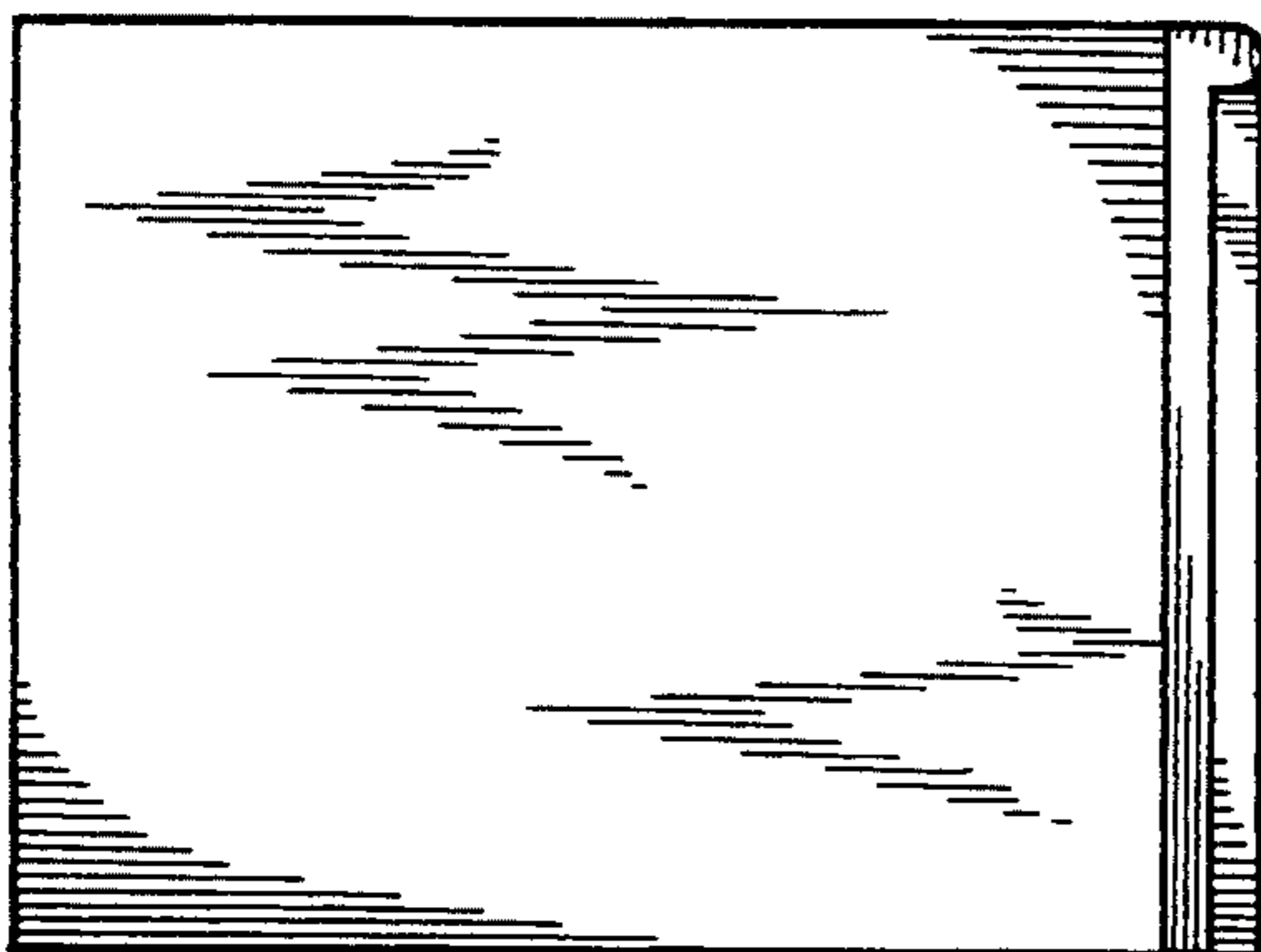
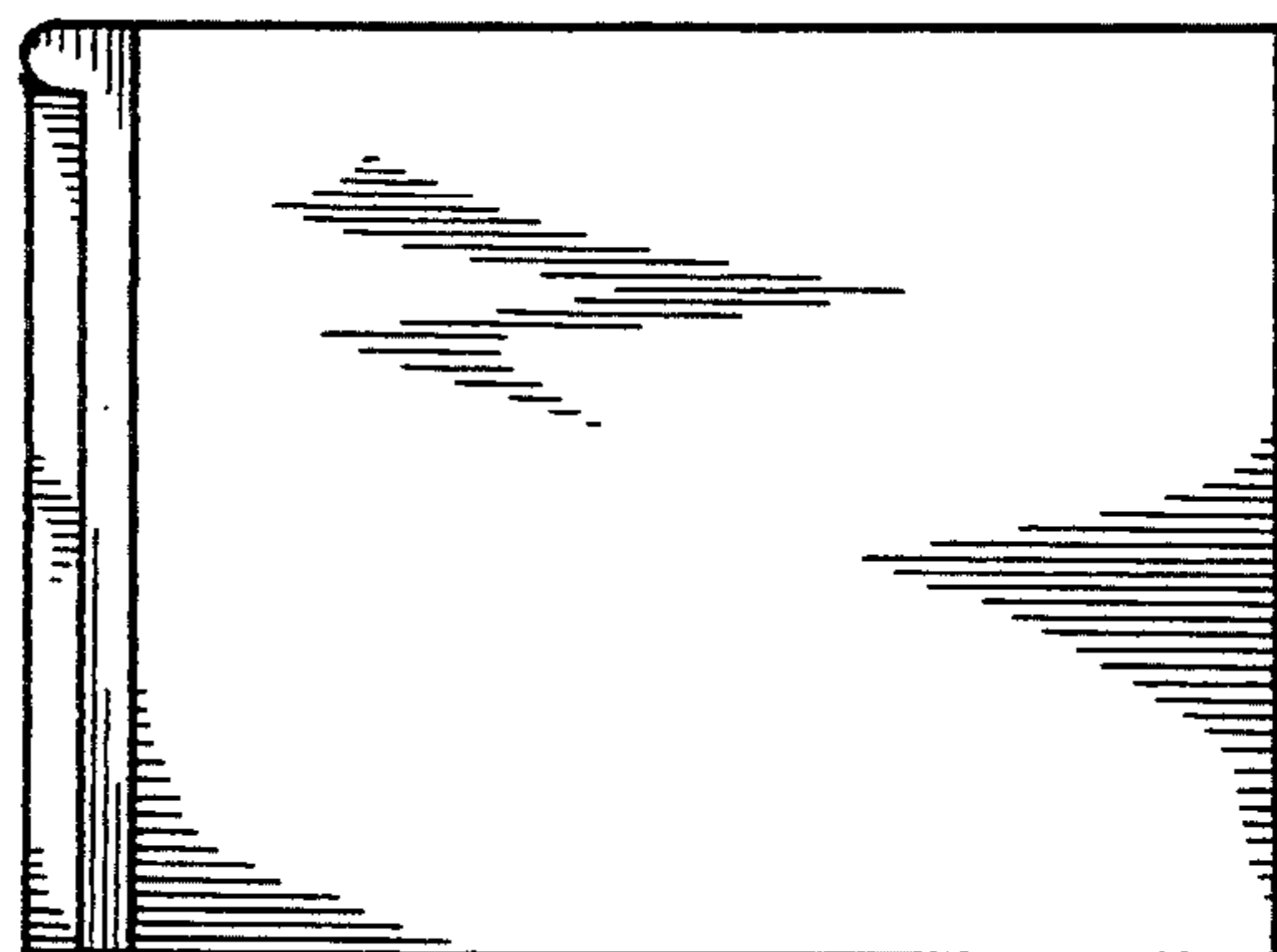
