[57] CLAIM

The ornamental design for a portable radiotelephone, as shown and described.

DESCRIPTION

FIG. 1 is a right side, top and front perspective view of a portable radiotelephone showing our new design; FIG. 2 is a front elevational view thereof; FIG. 3 is a rear elevational view thereof; FIG. 4 is a left side elevational view thereof; FIG. 5 is a right side elevational view thereof; FIG. 6 is a top plan view thereof; FIG. 7 is a bottom view thereof; and, FIG. 8 is a sectional view taken along line VIII—VIII in FIG. 2.

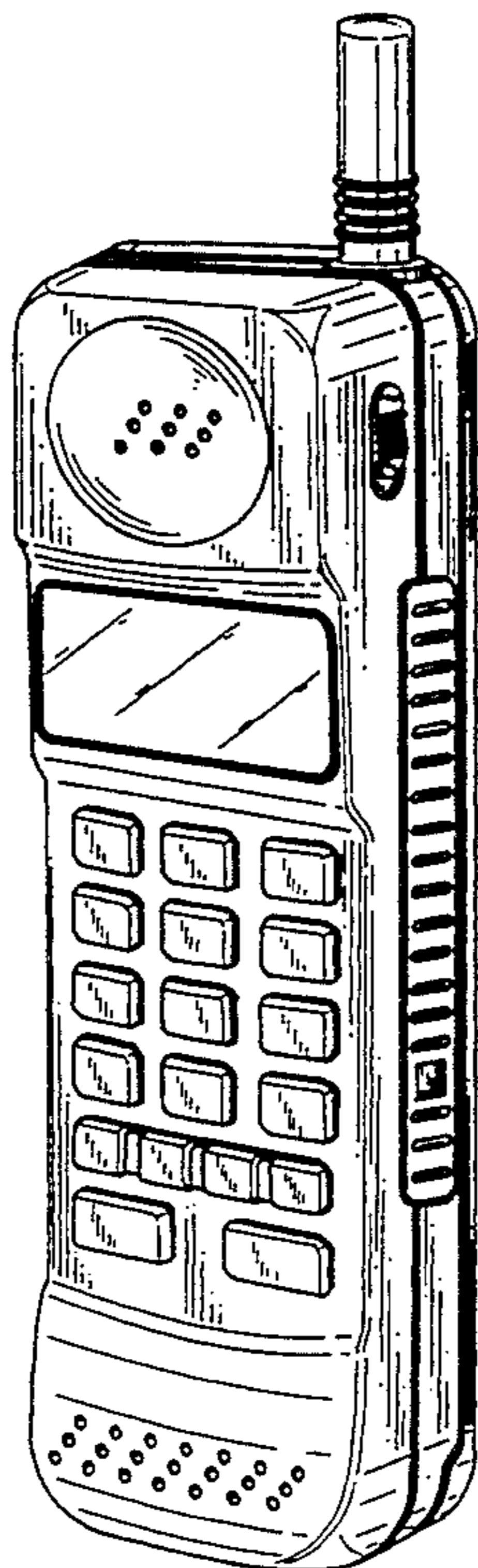

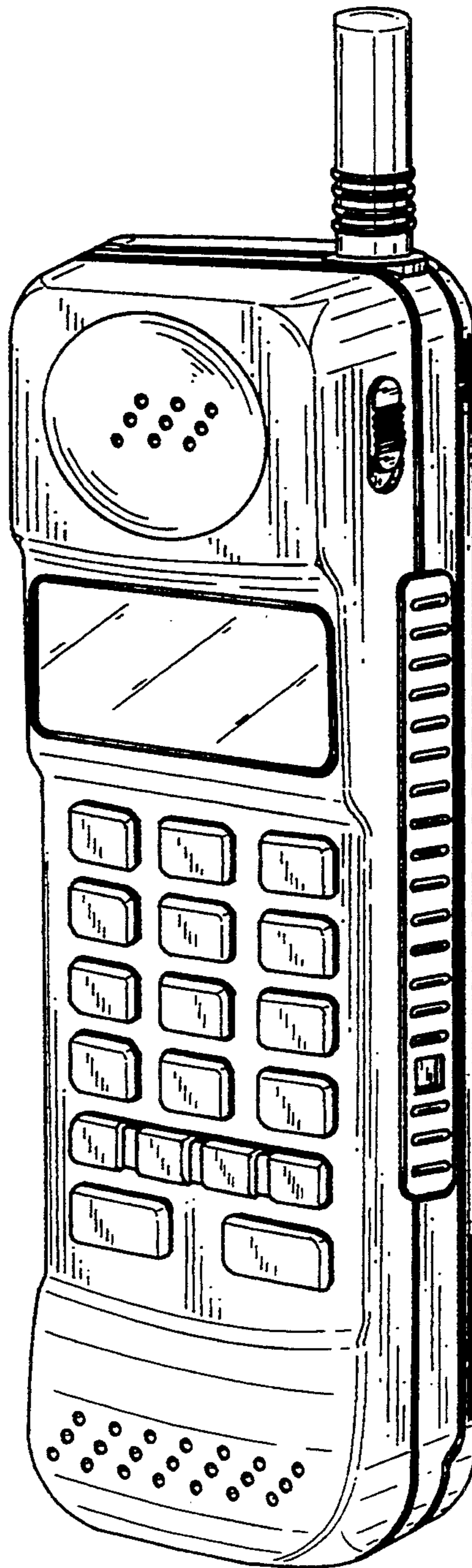
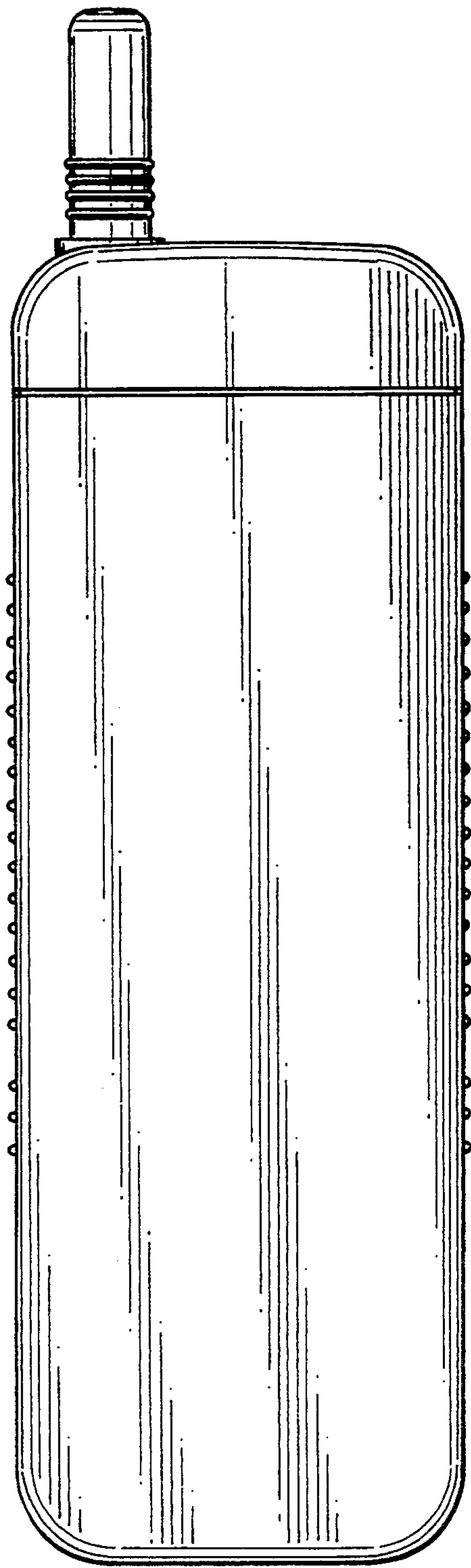
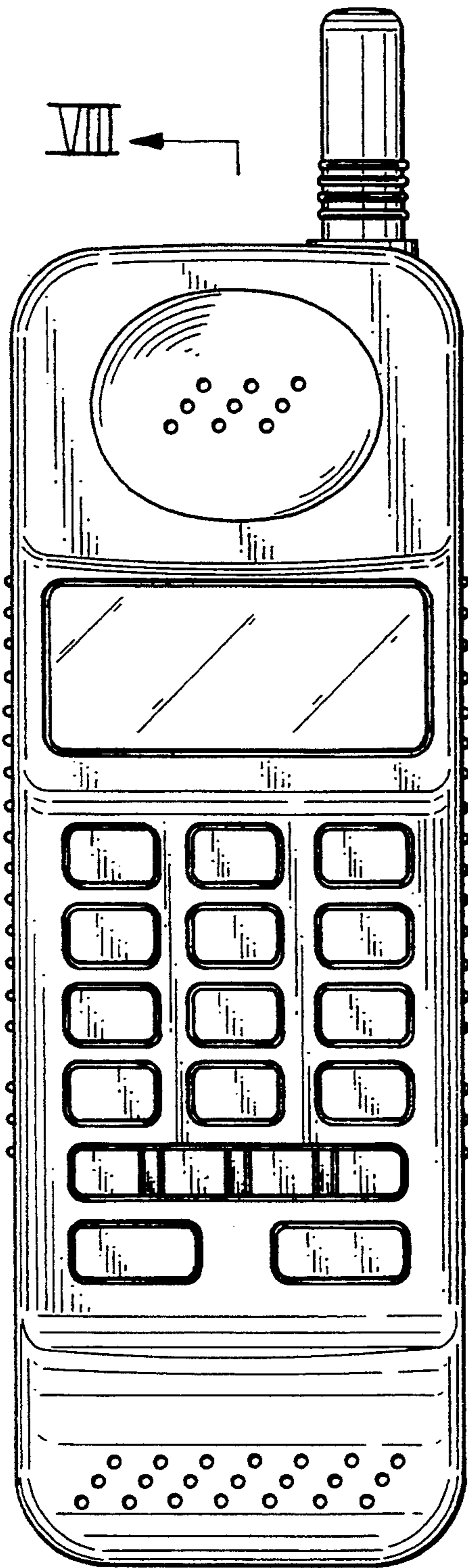

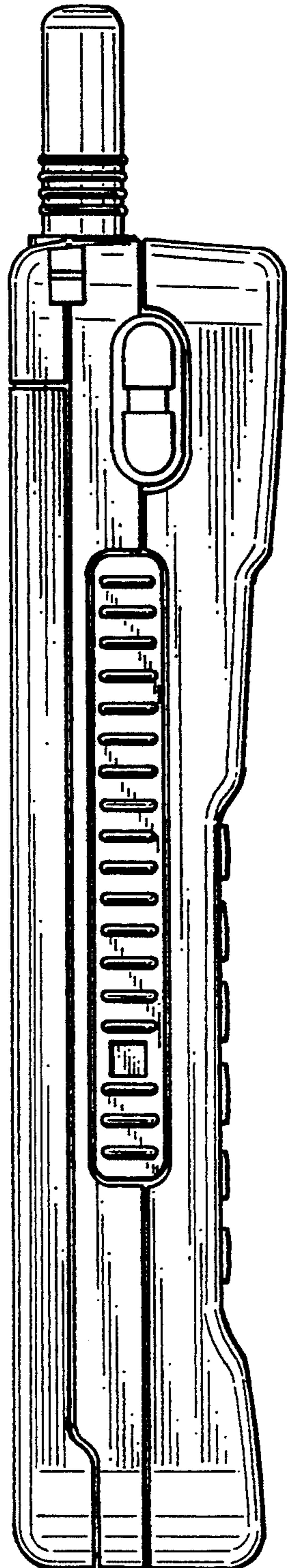

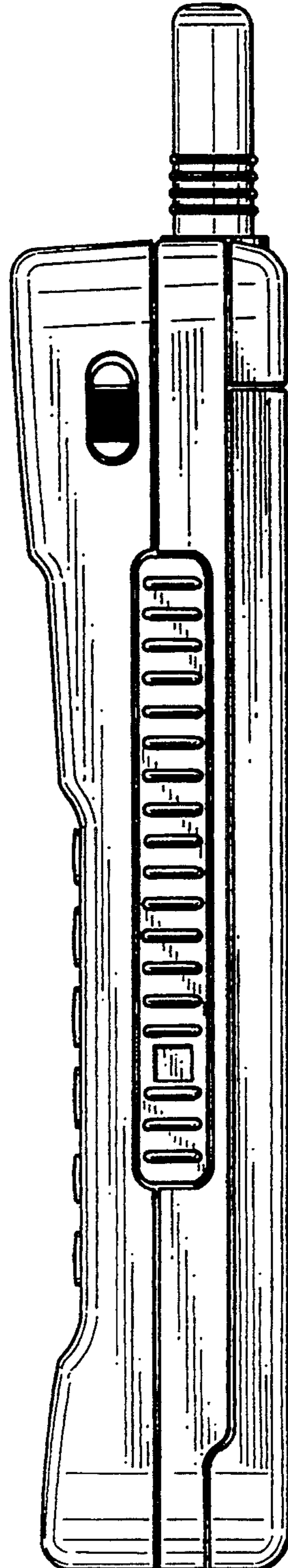

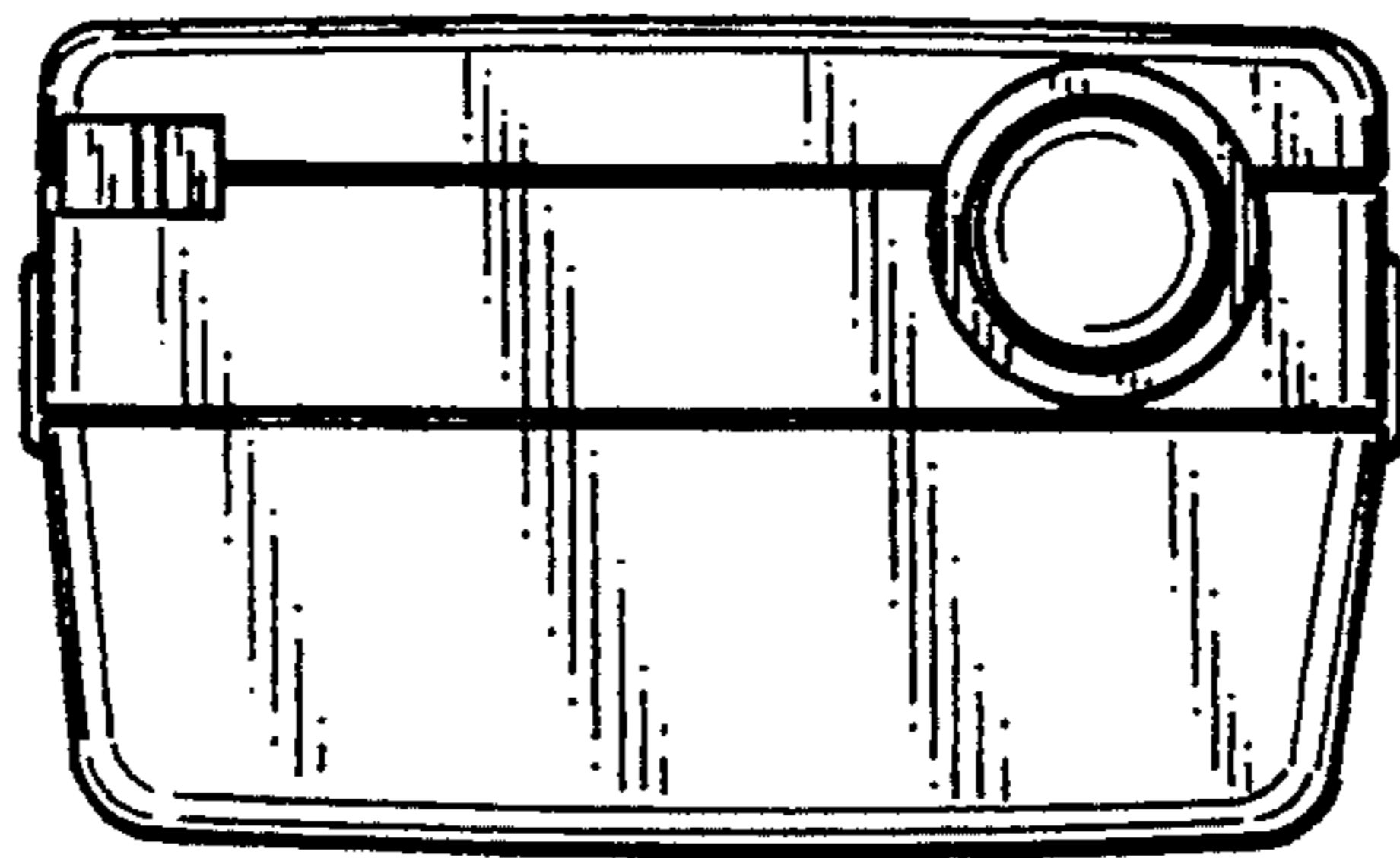

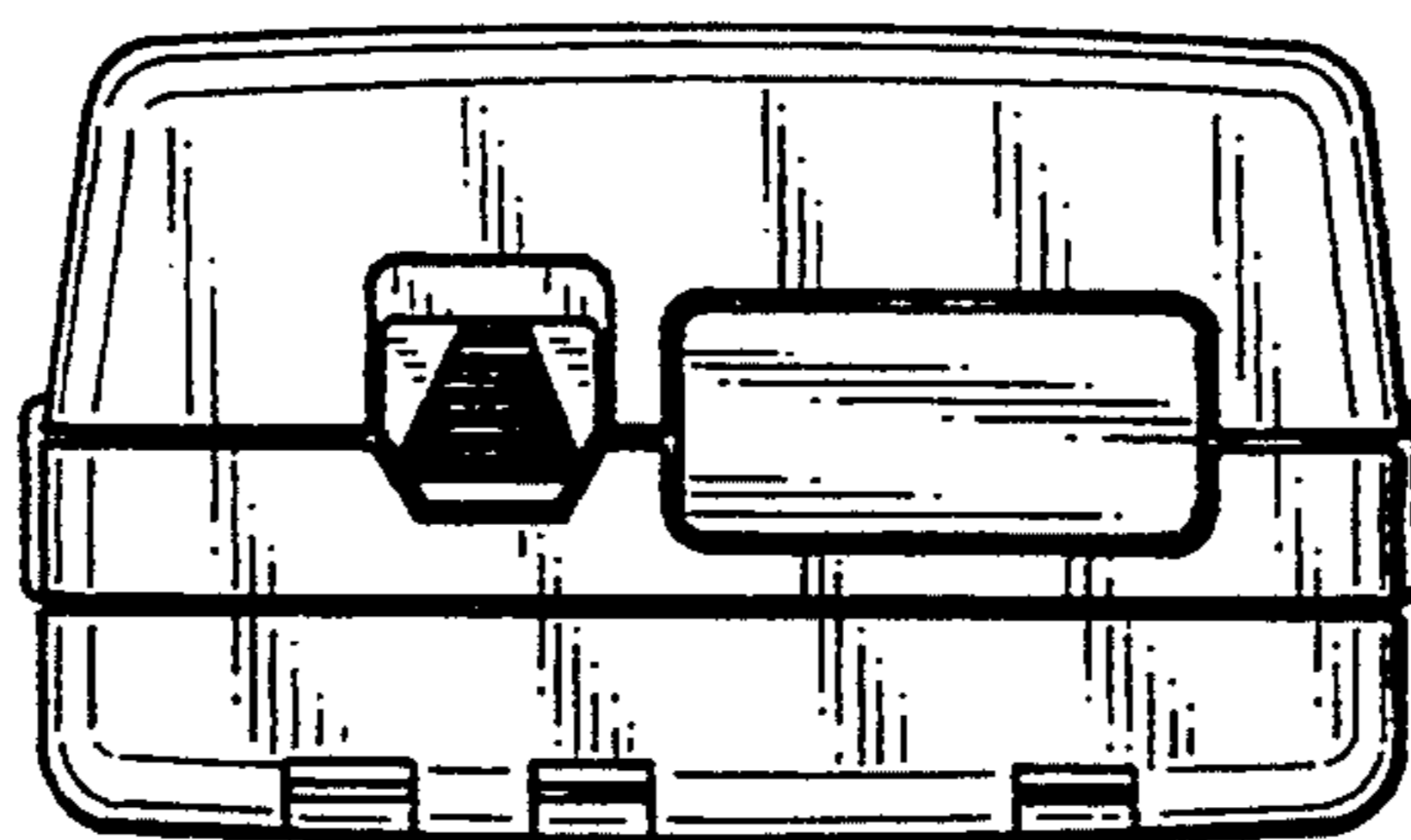
