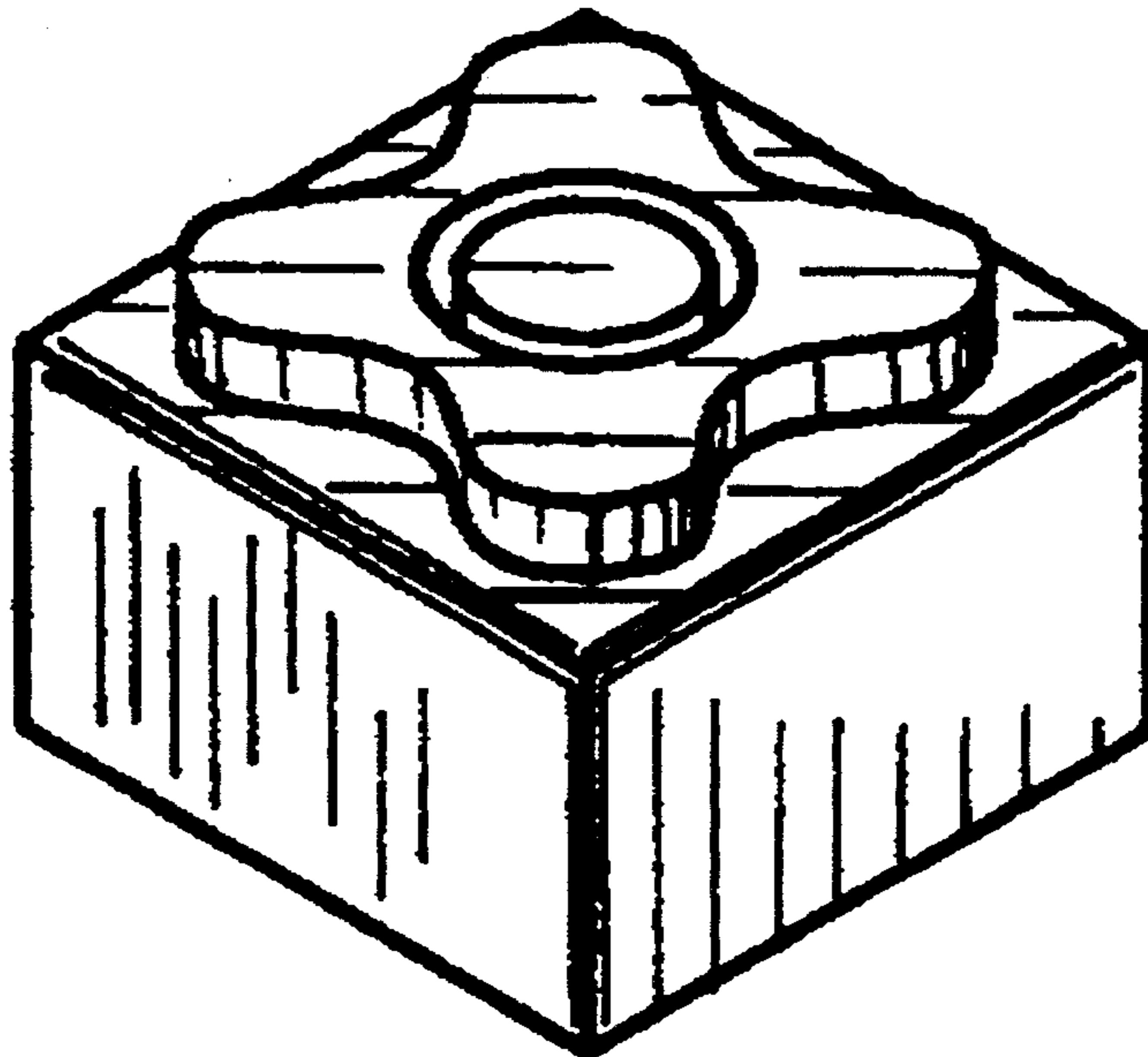

[57] **CLAIM**

The ornamental design for a building element for a toy building set, as shown and described.

**DESCRIPTION**

FIG. 1 is a top perspective view of the building element for a toy building set showing our new design; FIG. 2 is a bottom perspective view thereof; FIG. 3 is a right side elevational view thereof; FIG. 4 is a front elevational view thereof; FIG. 5 is a left side elevational view thereof; FIG. 6 is a rear elevational view thereof; FIG. 7 is a top plan view thereof; FIG. 8 is a bottom plan view thereof; and, FIG. 9 is a partial view thereof, shown separately for clarity of illustration only.



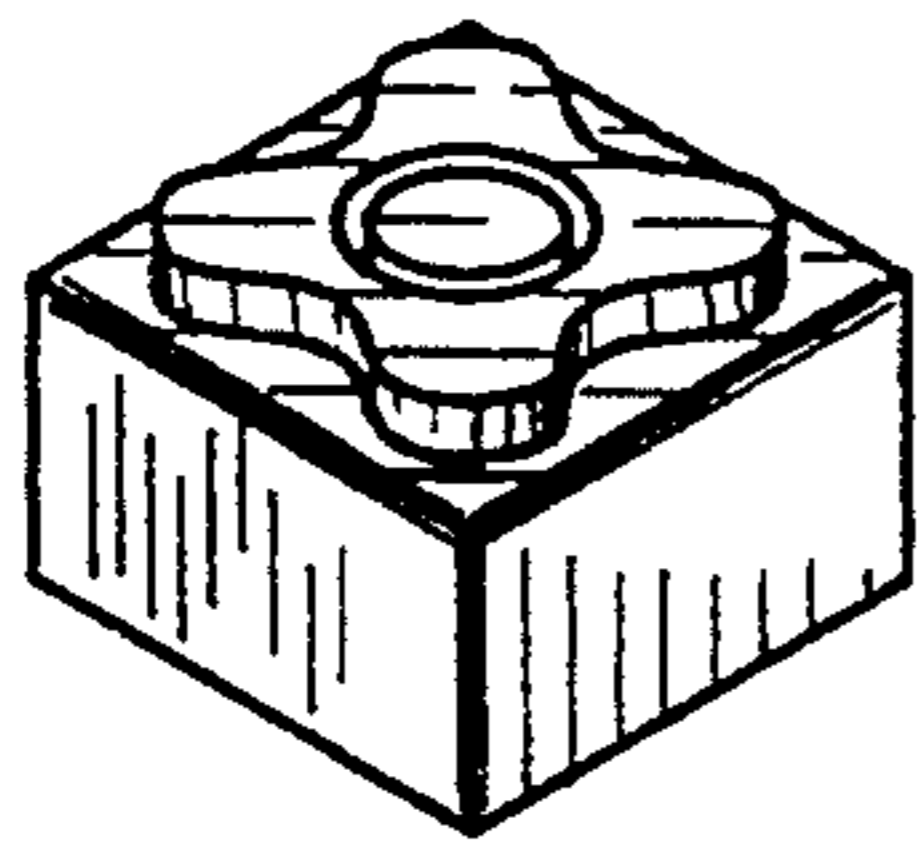

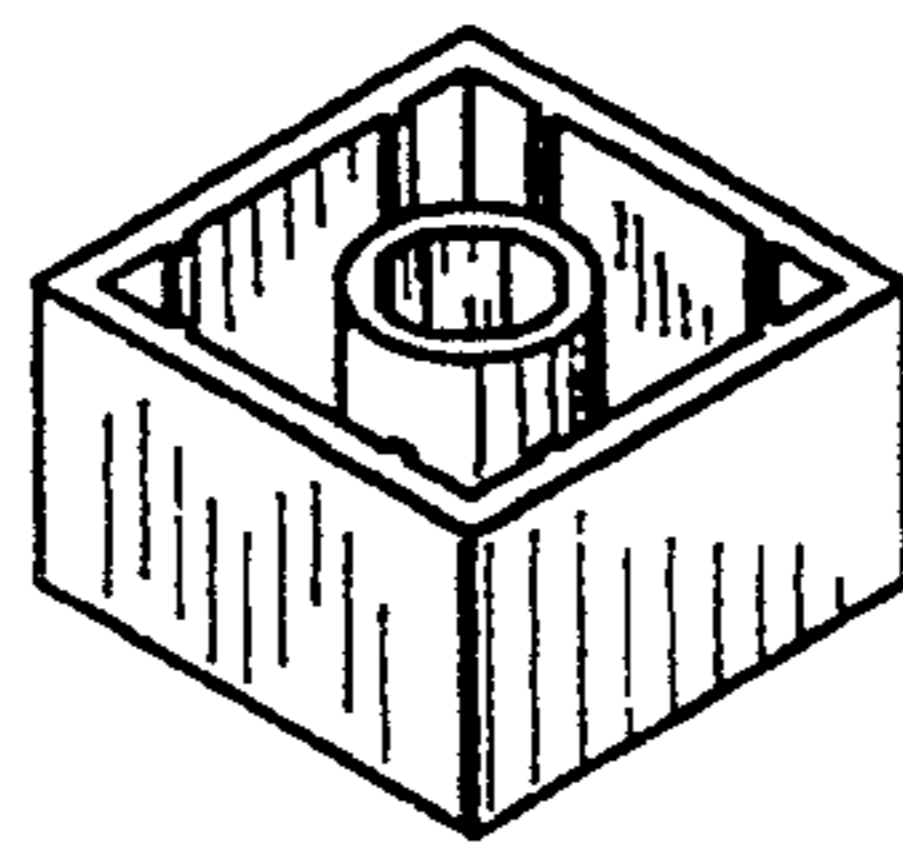

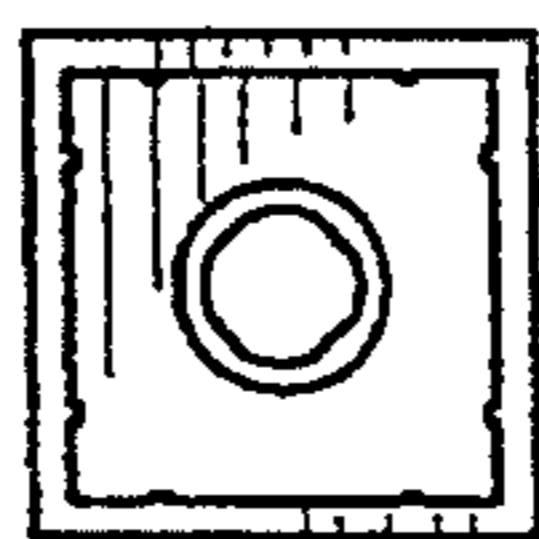

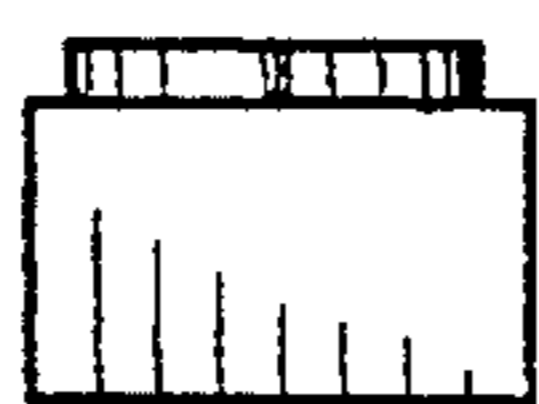

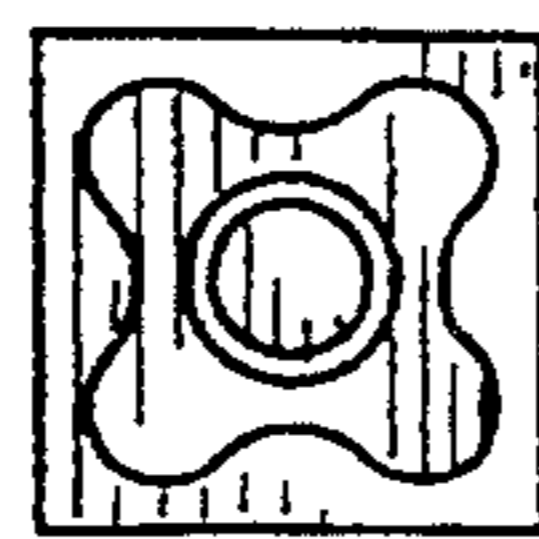
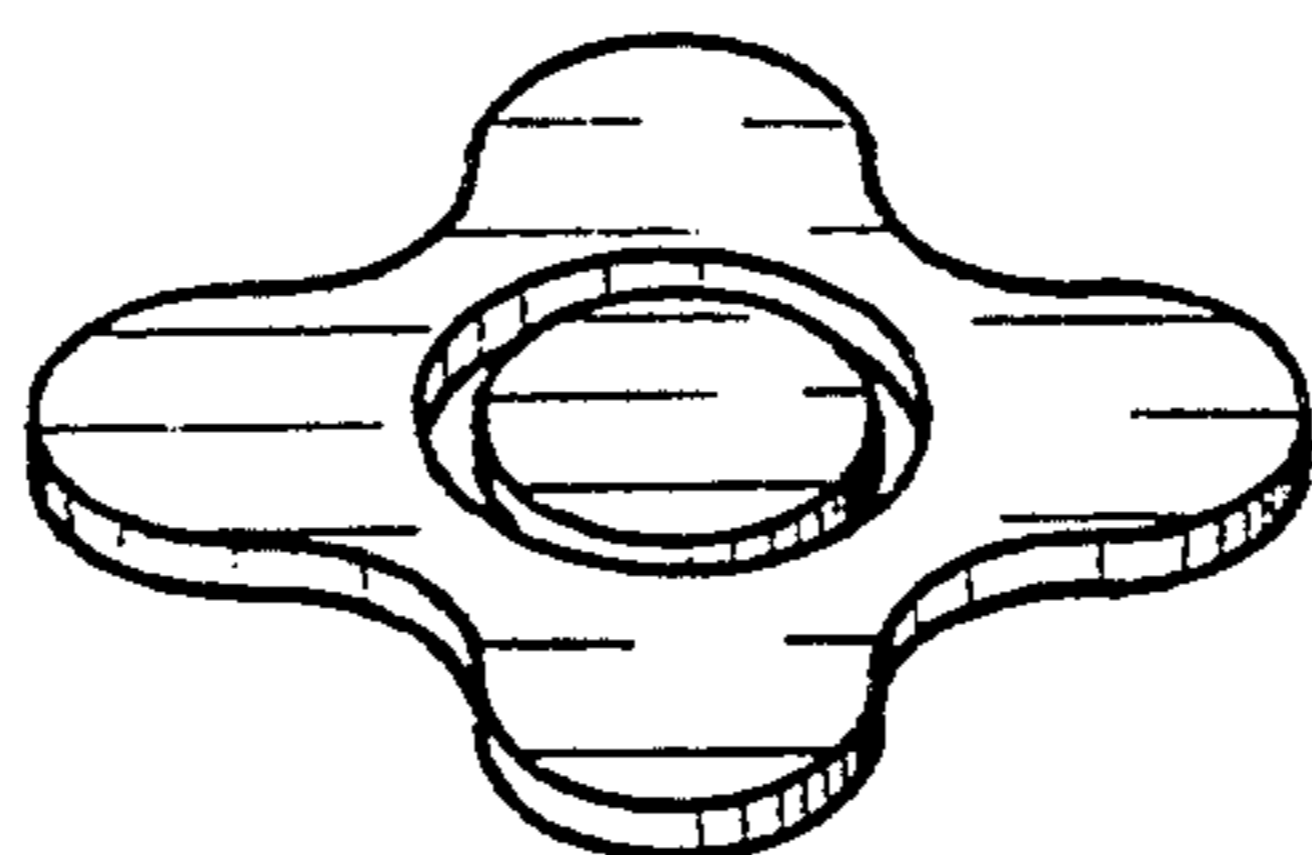
