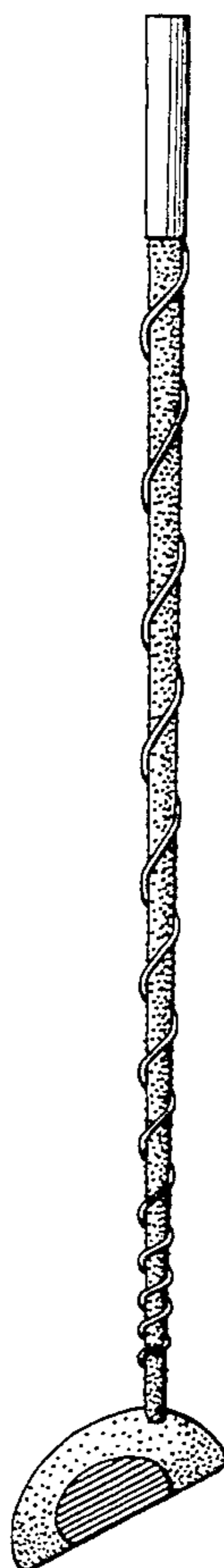

DESCRIPTION

FIG. 1 is a front elevational view of a golf club showing my new design;
 FIG. 2 is a right side elevational view of the golf club head thereof;

 FIG. 5 is a front elevational view of the golf club head thereof.



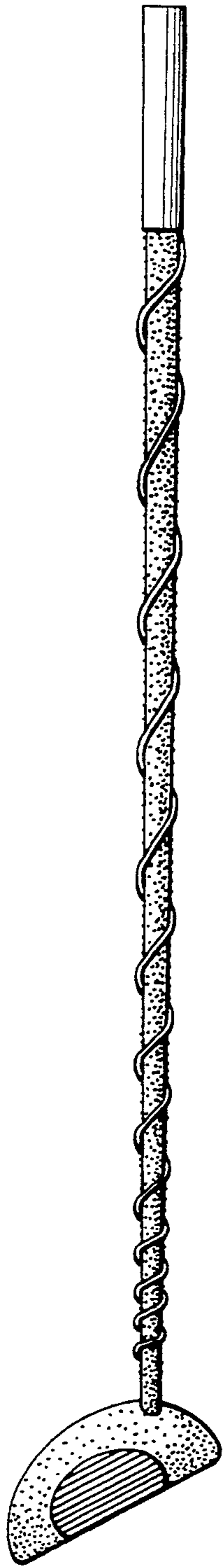

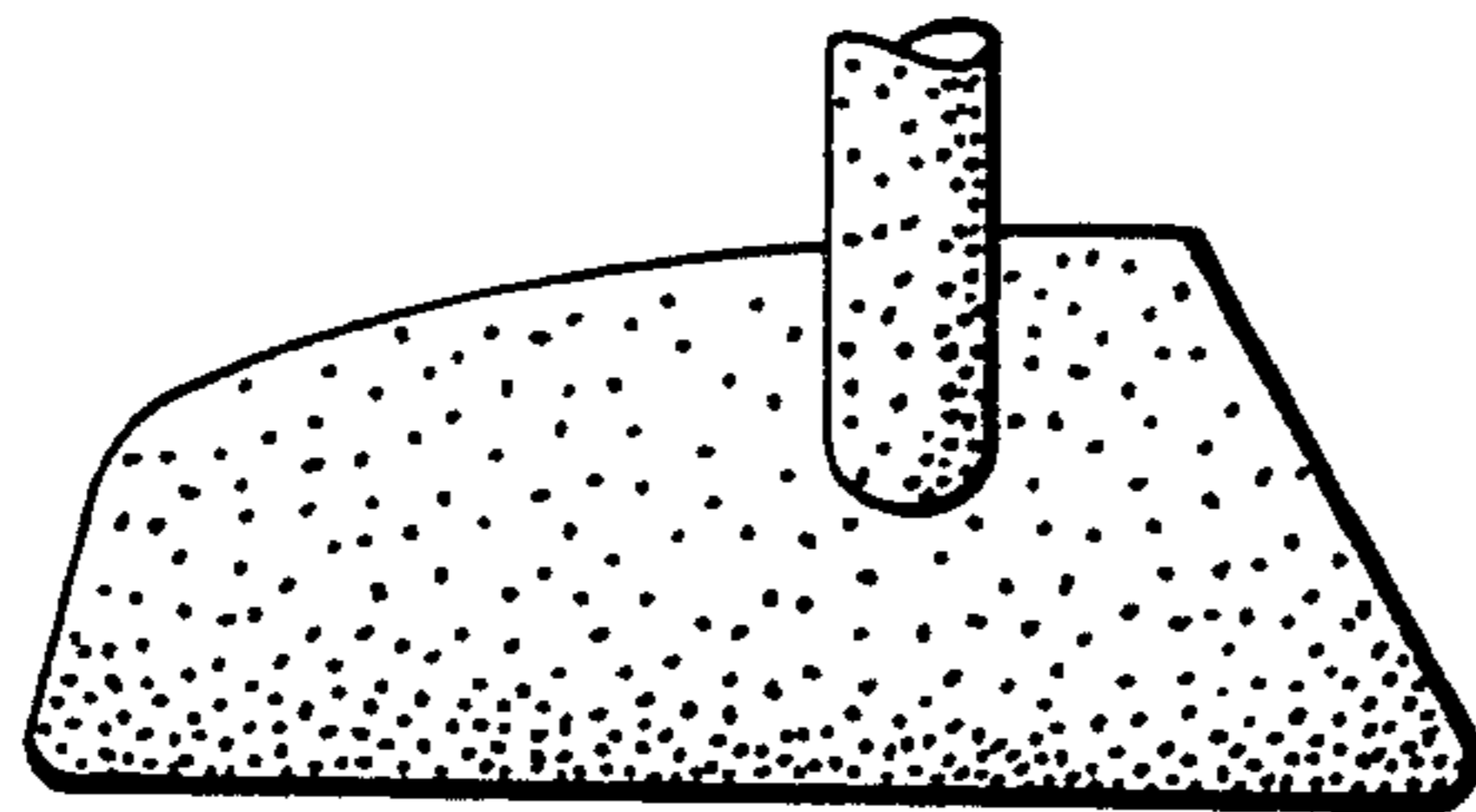

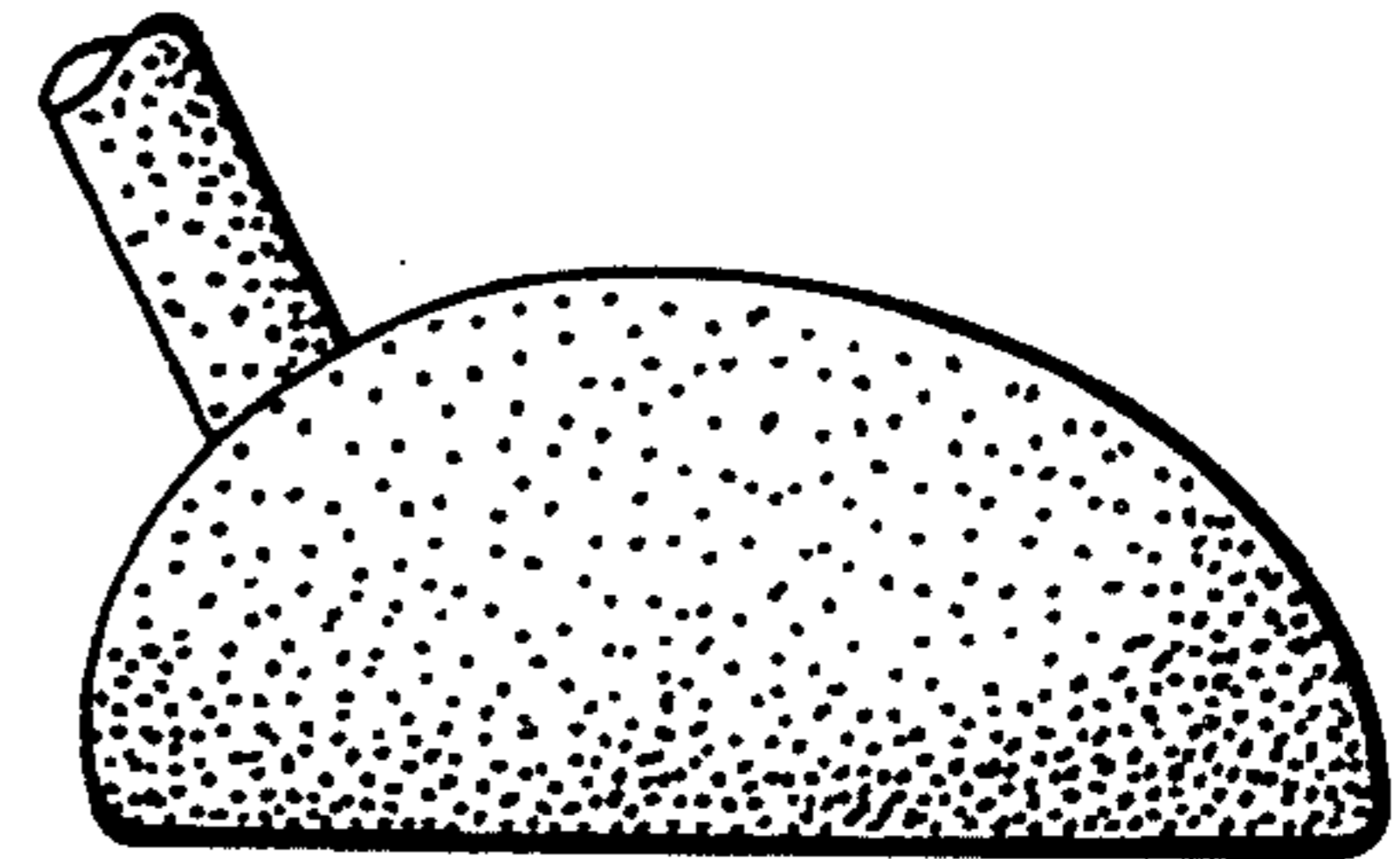

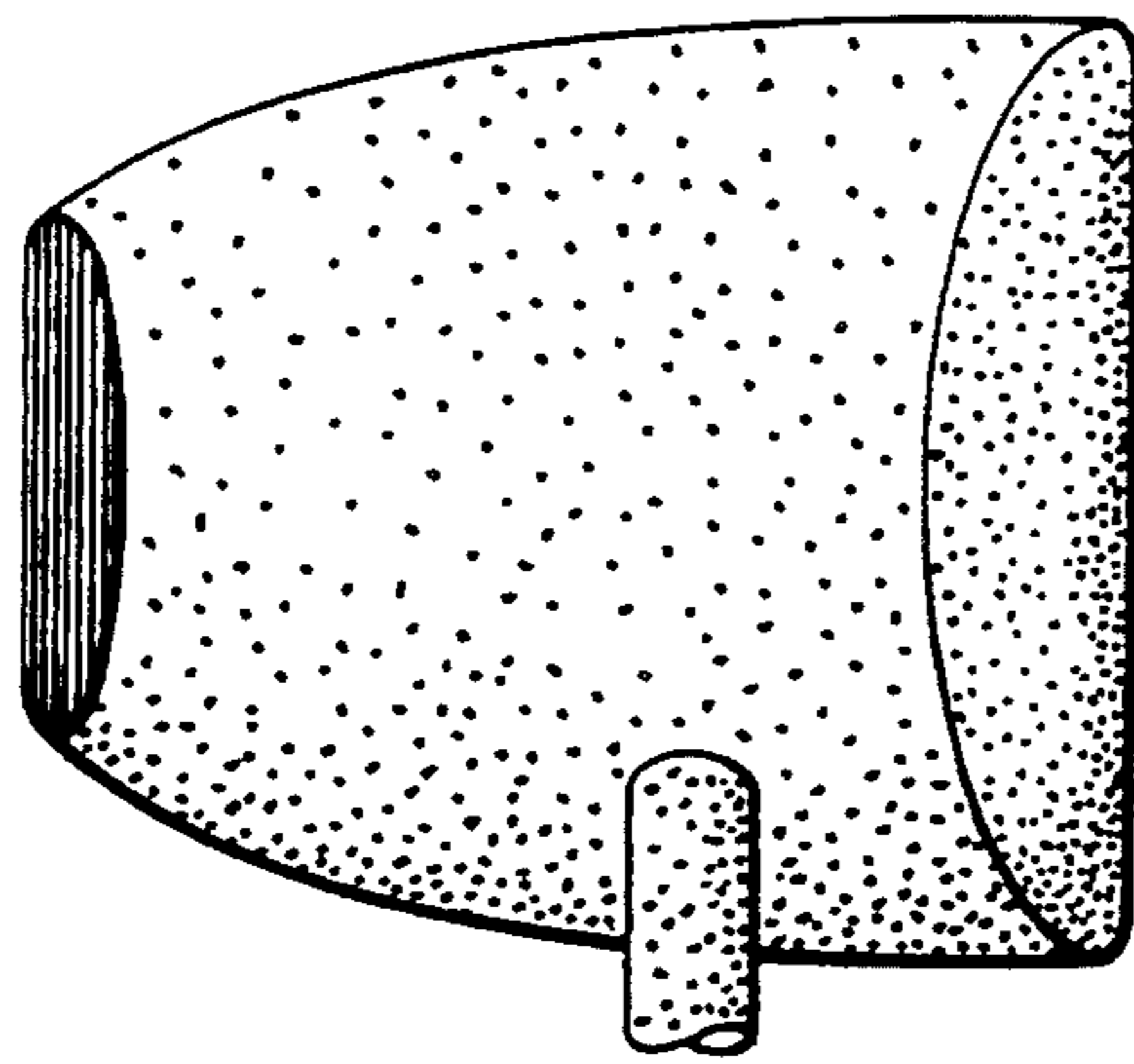

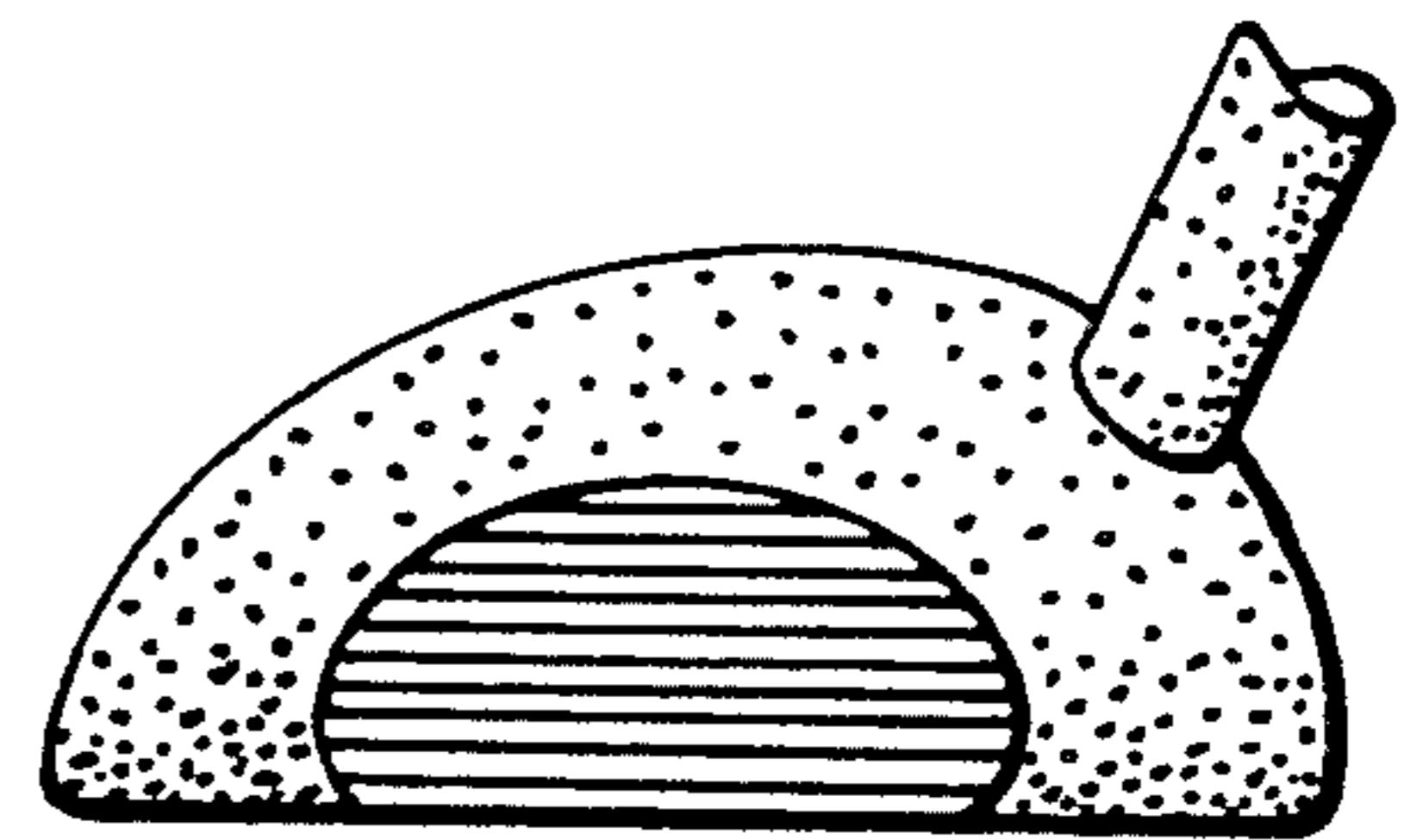
