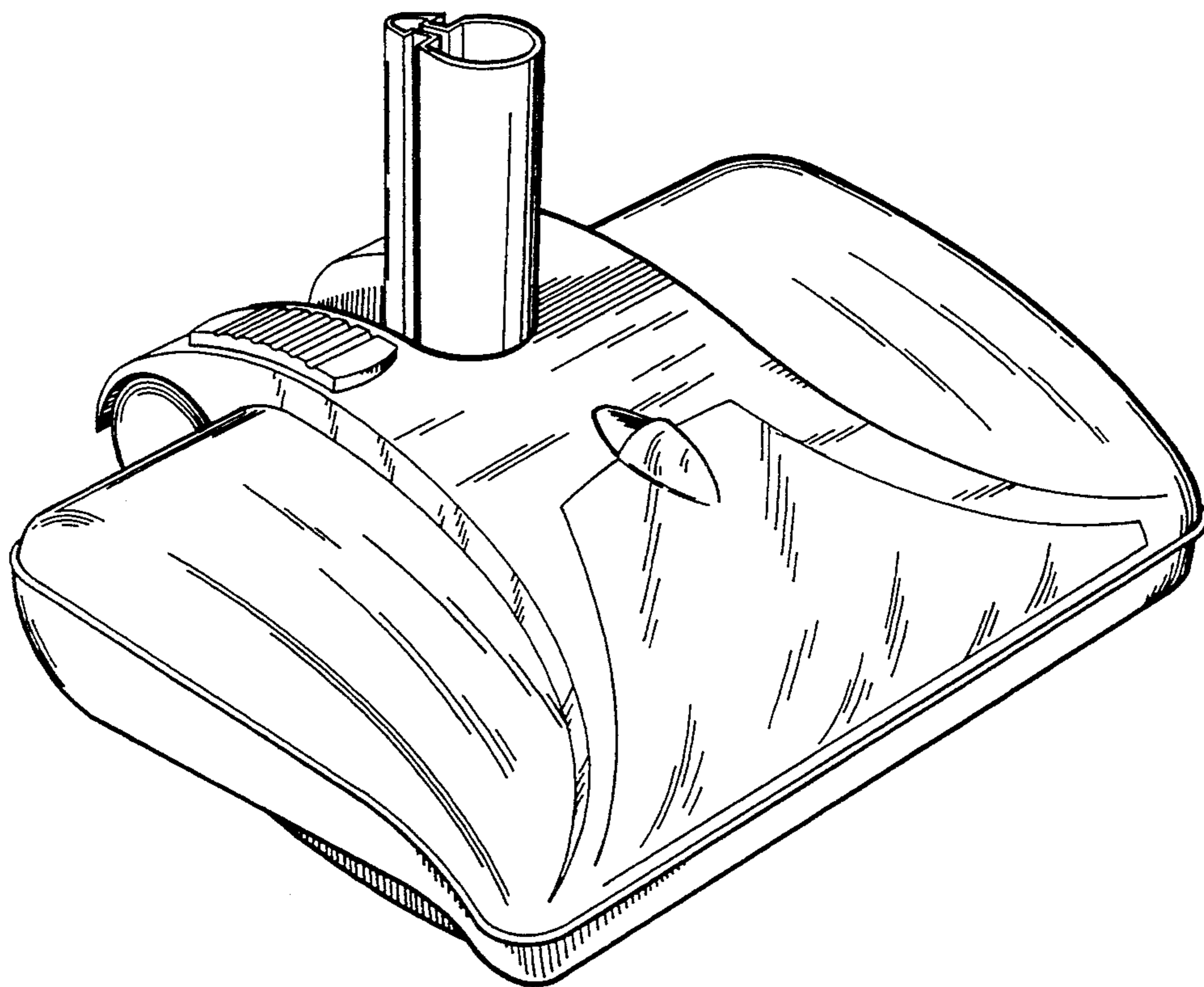

The ornamental design for a combination vacuum cleaner and water extractor foot, as shown and described.

### DESCRIPTION

FIG. 1 is a front perspective view of a combination vacuum cleaner and water extractor foot which embodies our design;  
FIG. 2 is a rear perspective view thereof;  
FIG. 3 is a top view thereof;  
FIG. 4 is a bottom view thereof;  
FIG. 5 is a left side elevational view;  
FIG. 6 is a right side elevational view;

FIG. 8 is a rear elevational view.



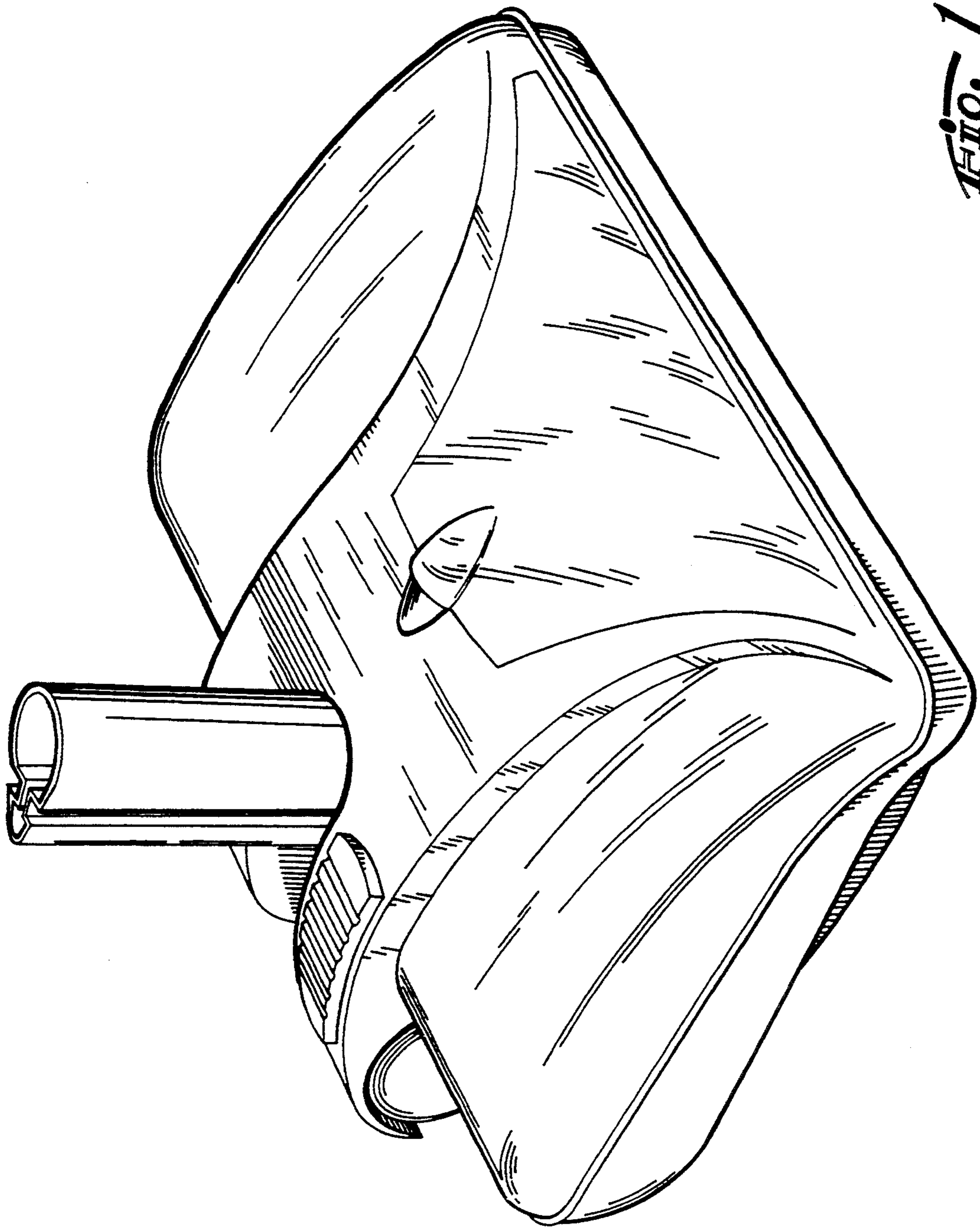

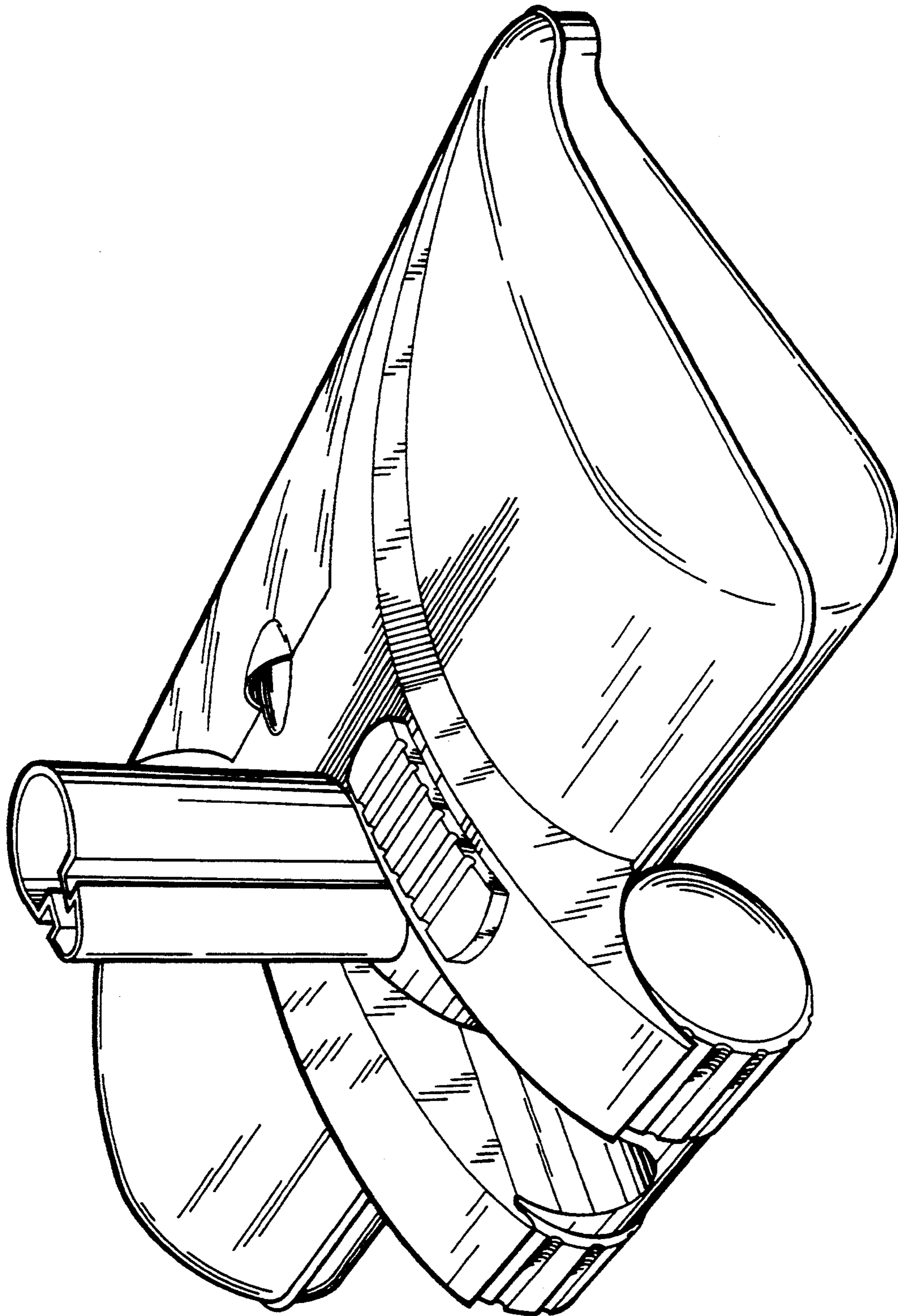
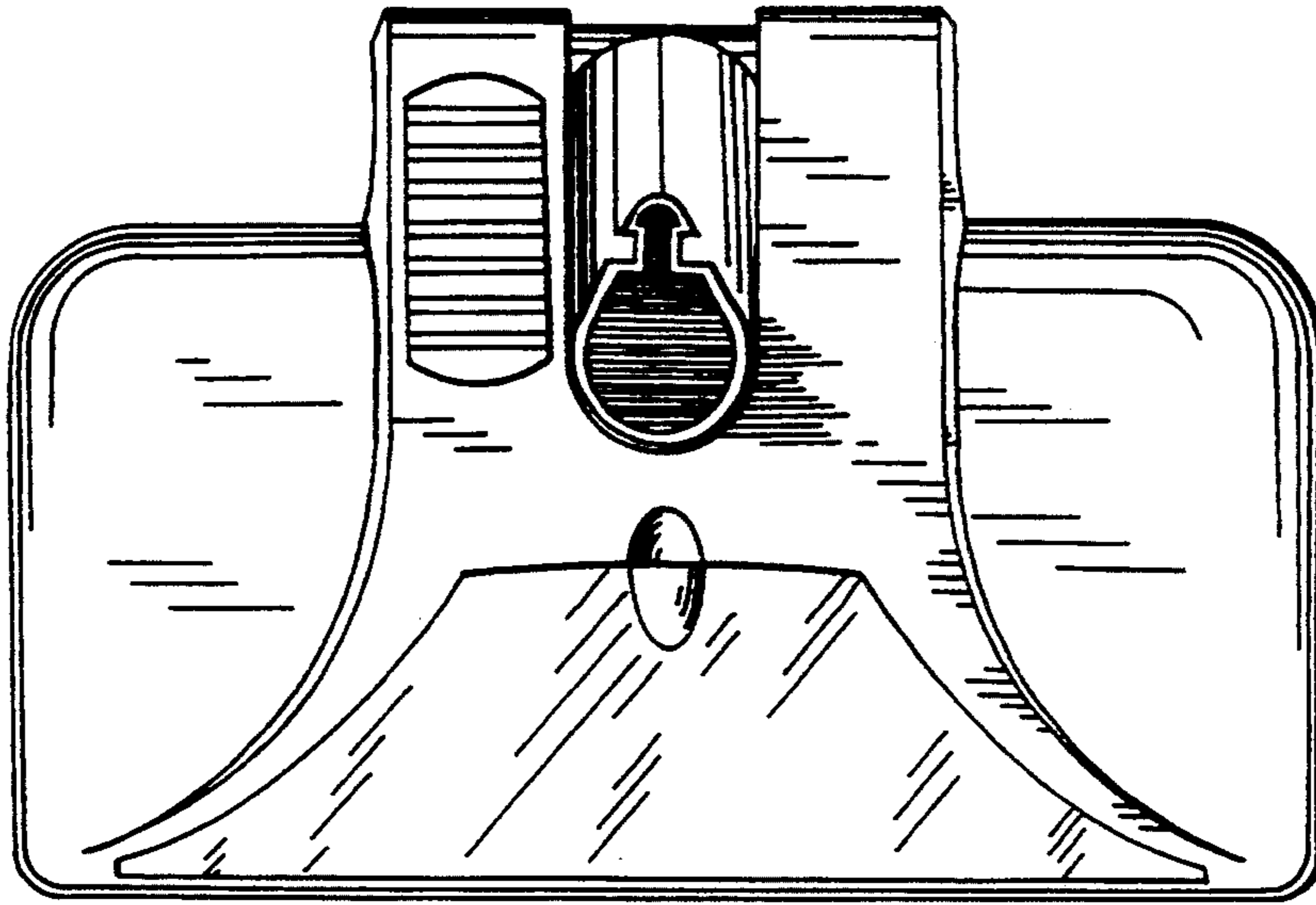
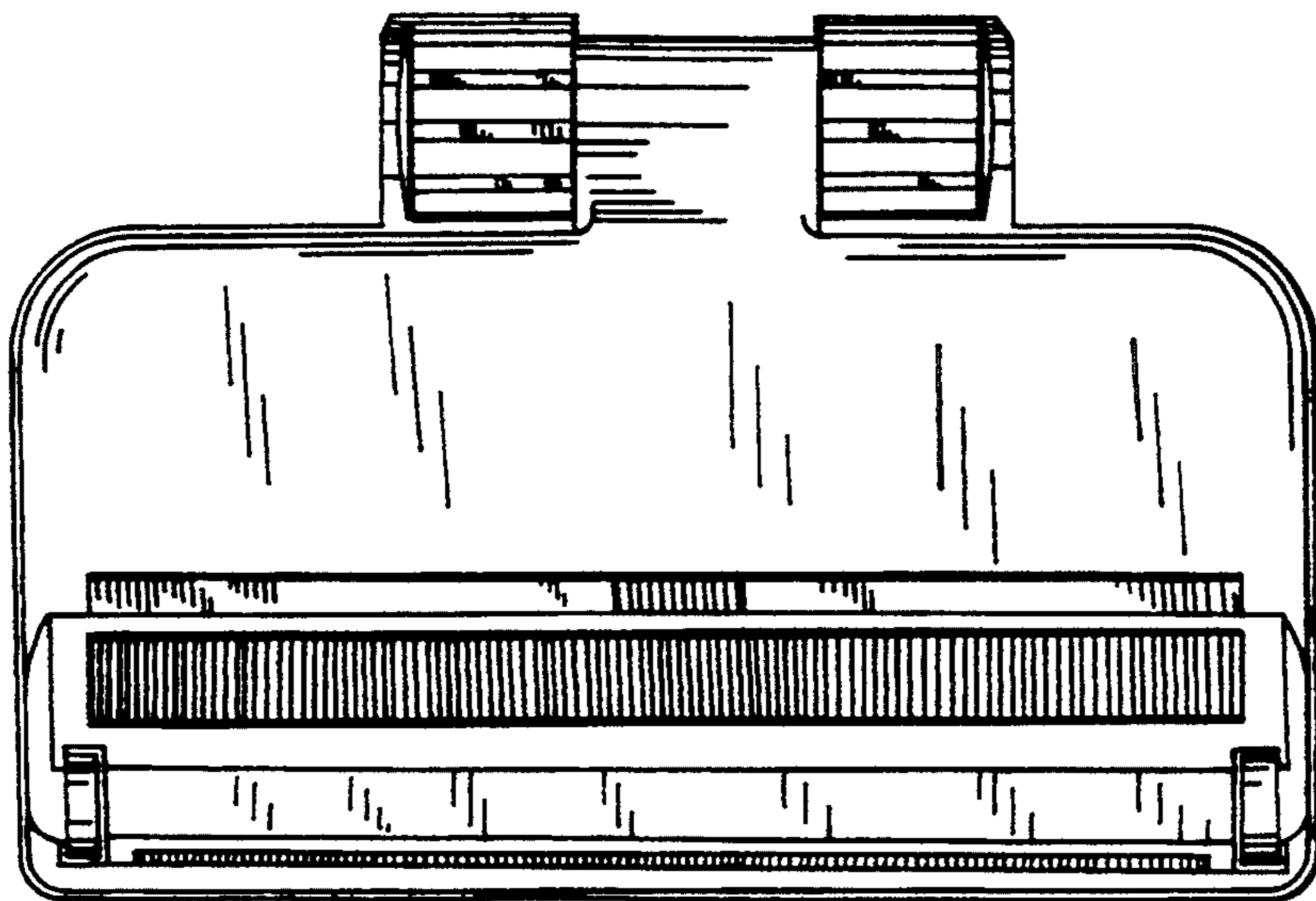


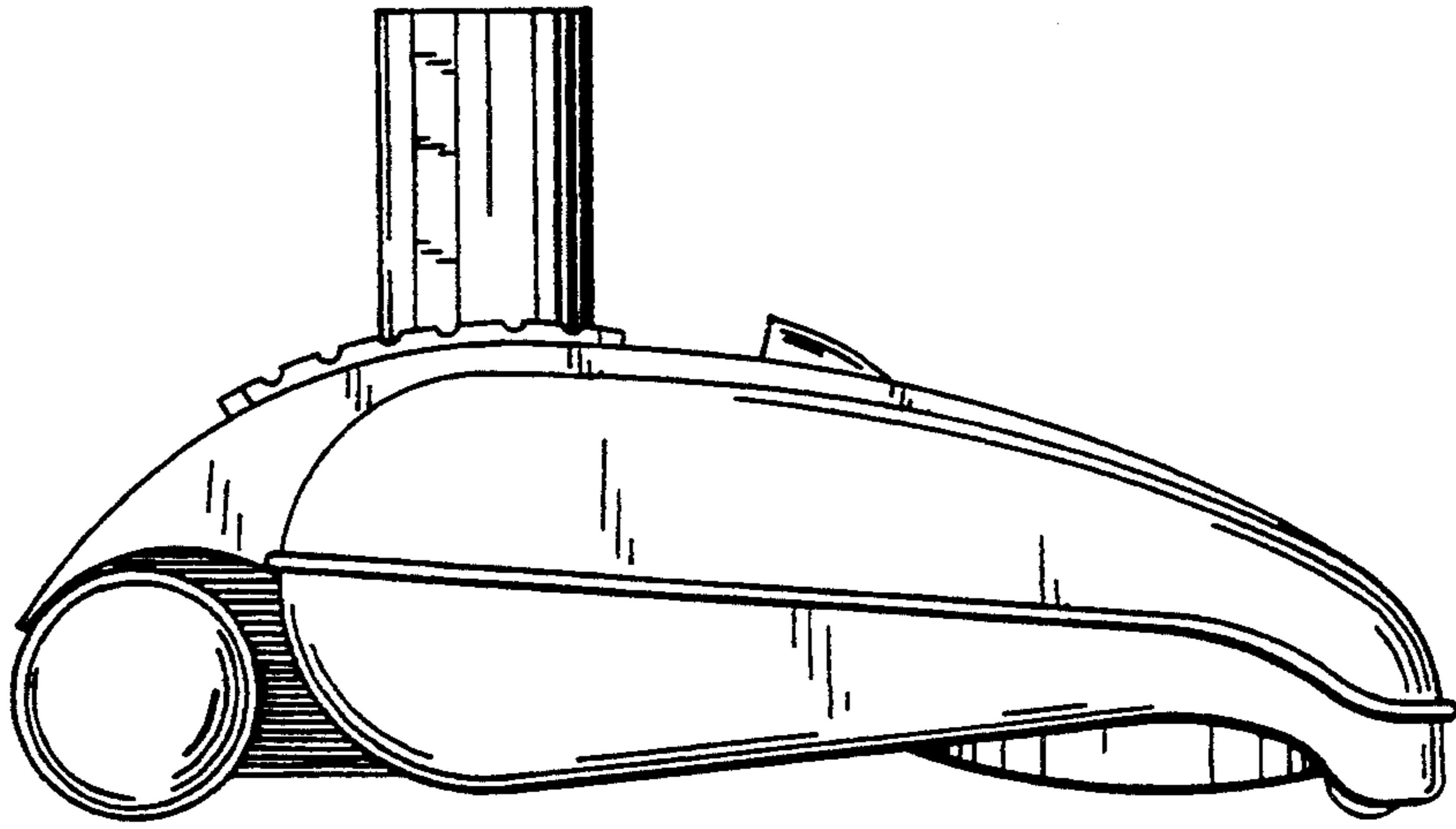

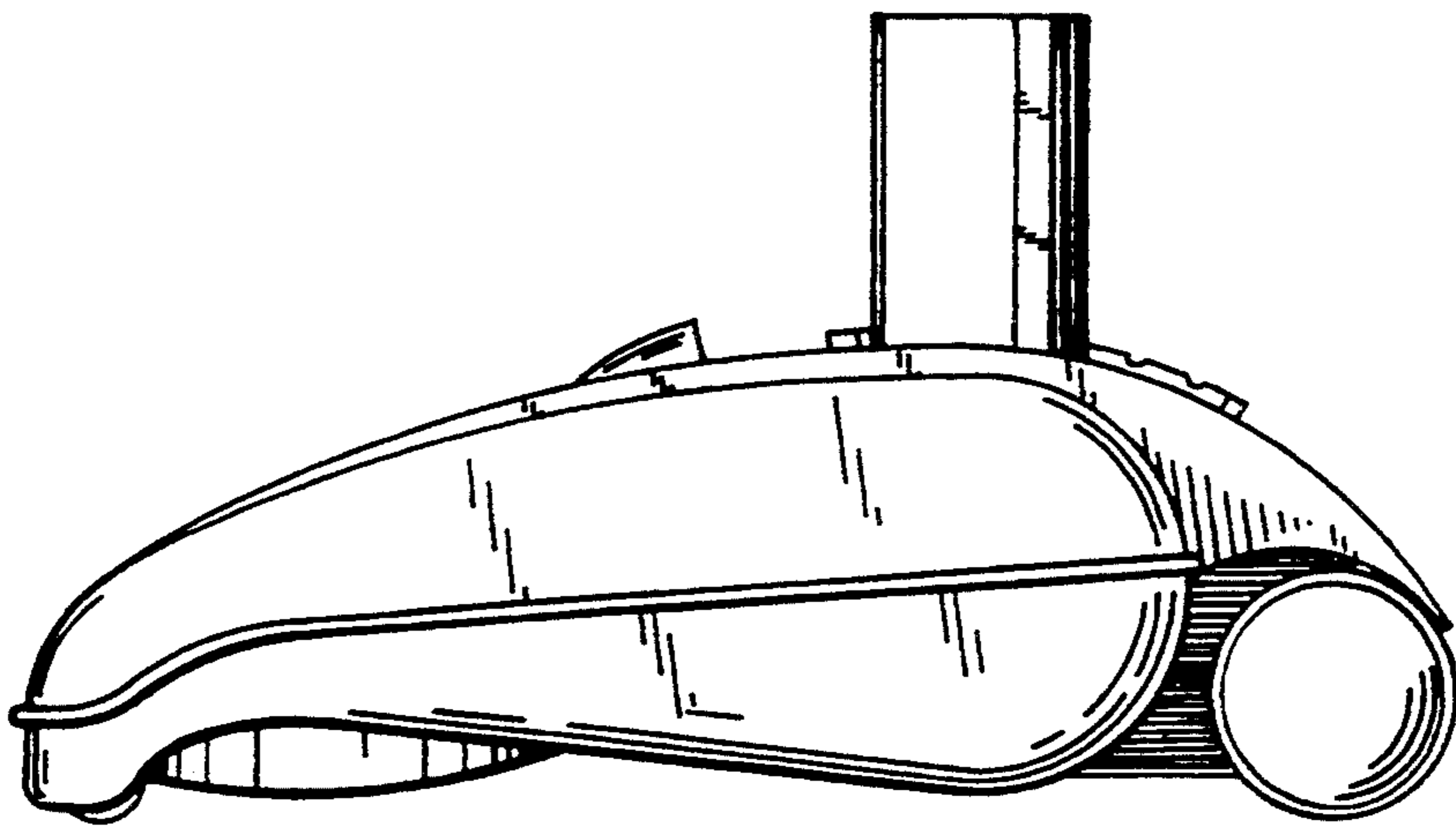

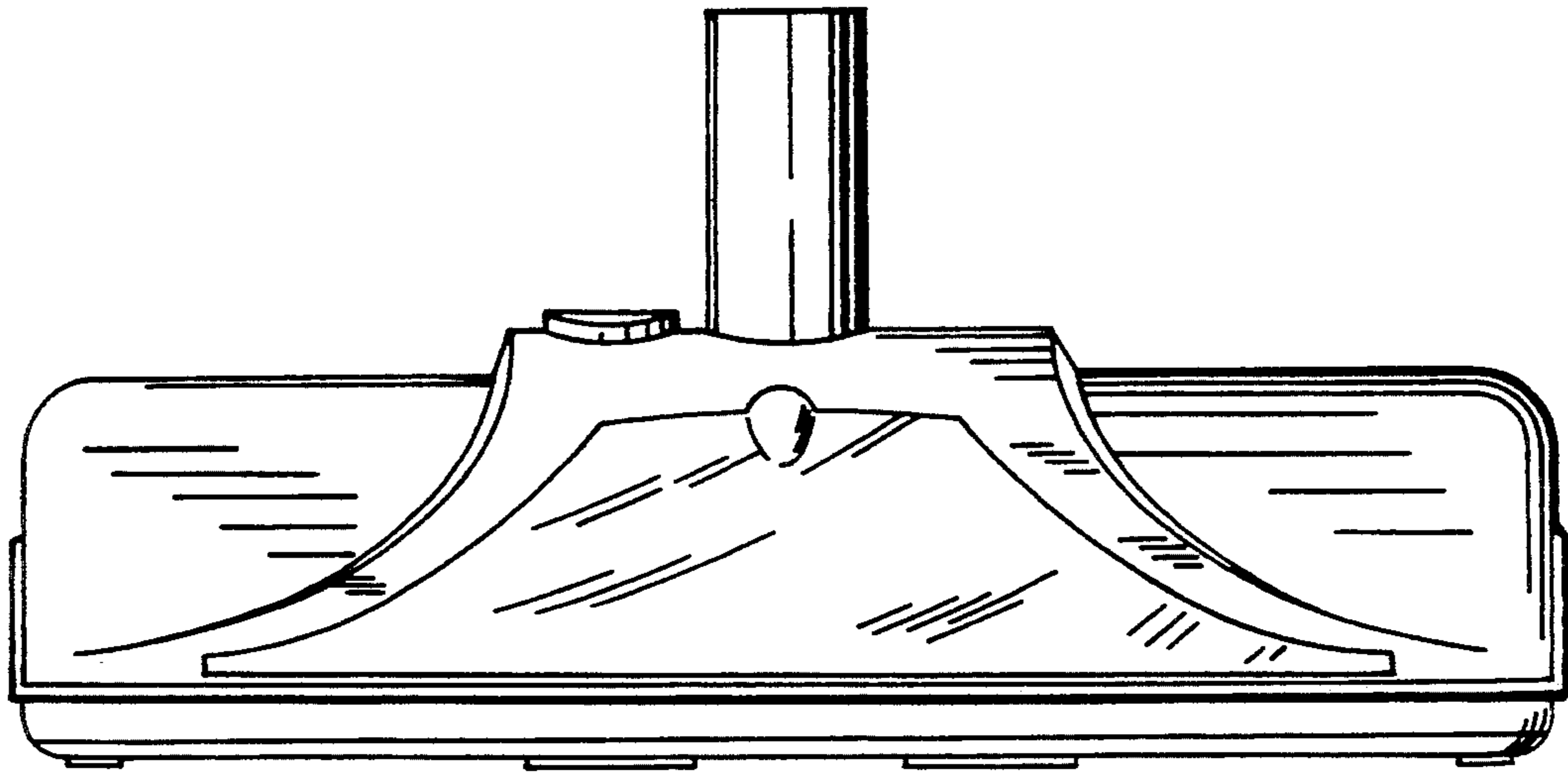

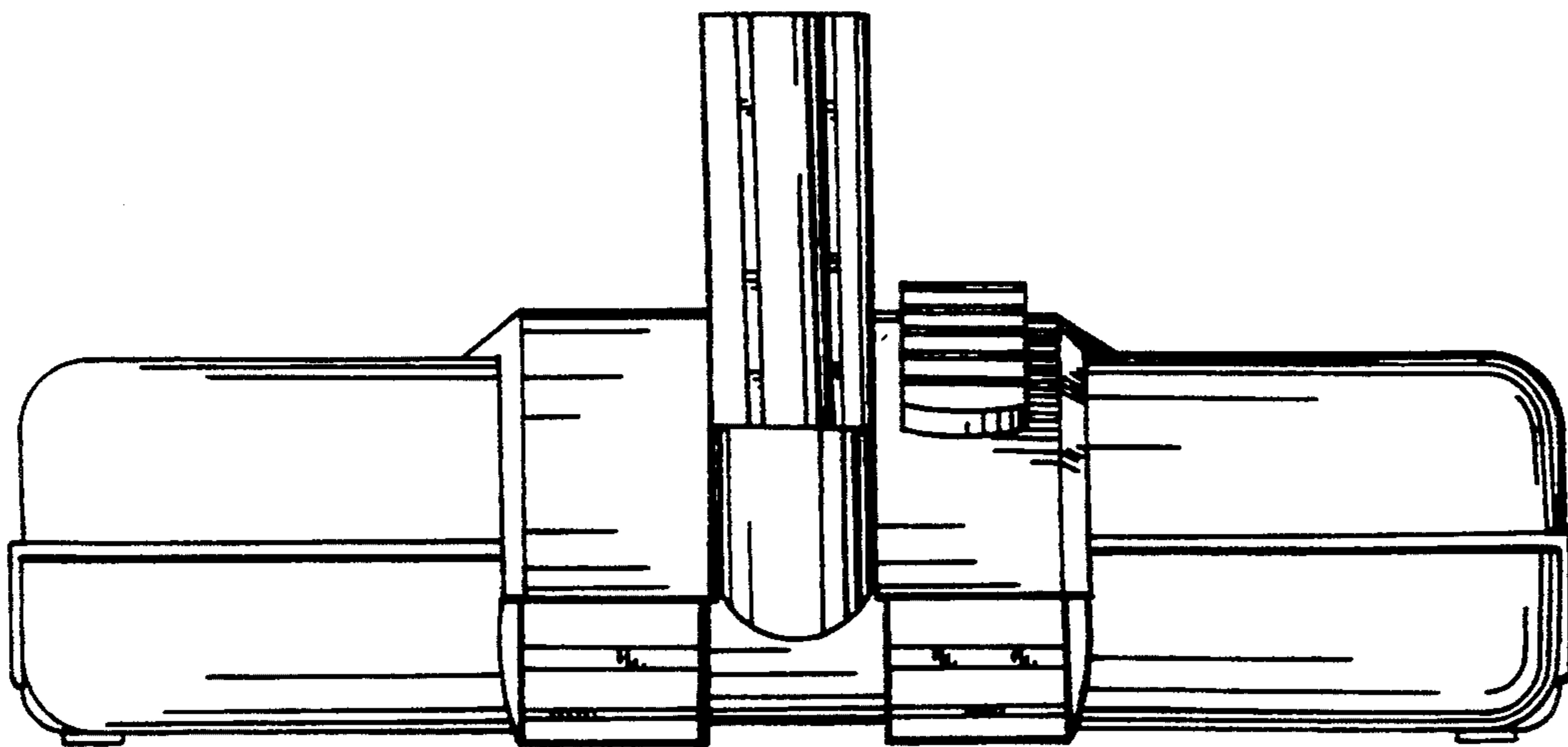
