FIG. 5 is a left side elevational view thereof;

FIG. 6 is a right side elevational view thereof;

FIG. 8 is a top, front, left side perspective view showing the article in use with the broken line showing of a trowel blade being for illustrative purposes only and forming no part of the claimed design.















