FIG. 1 is a top right rear perspective view of a bucket showing my new design. The broken lines are for illustrative purposes only and form no part of the claimed design;

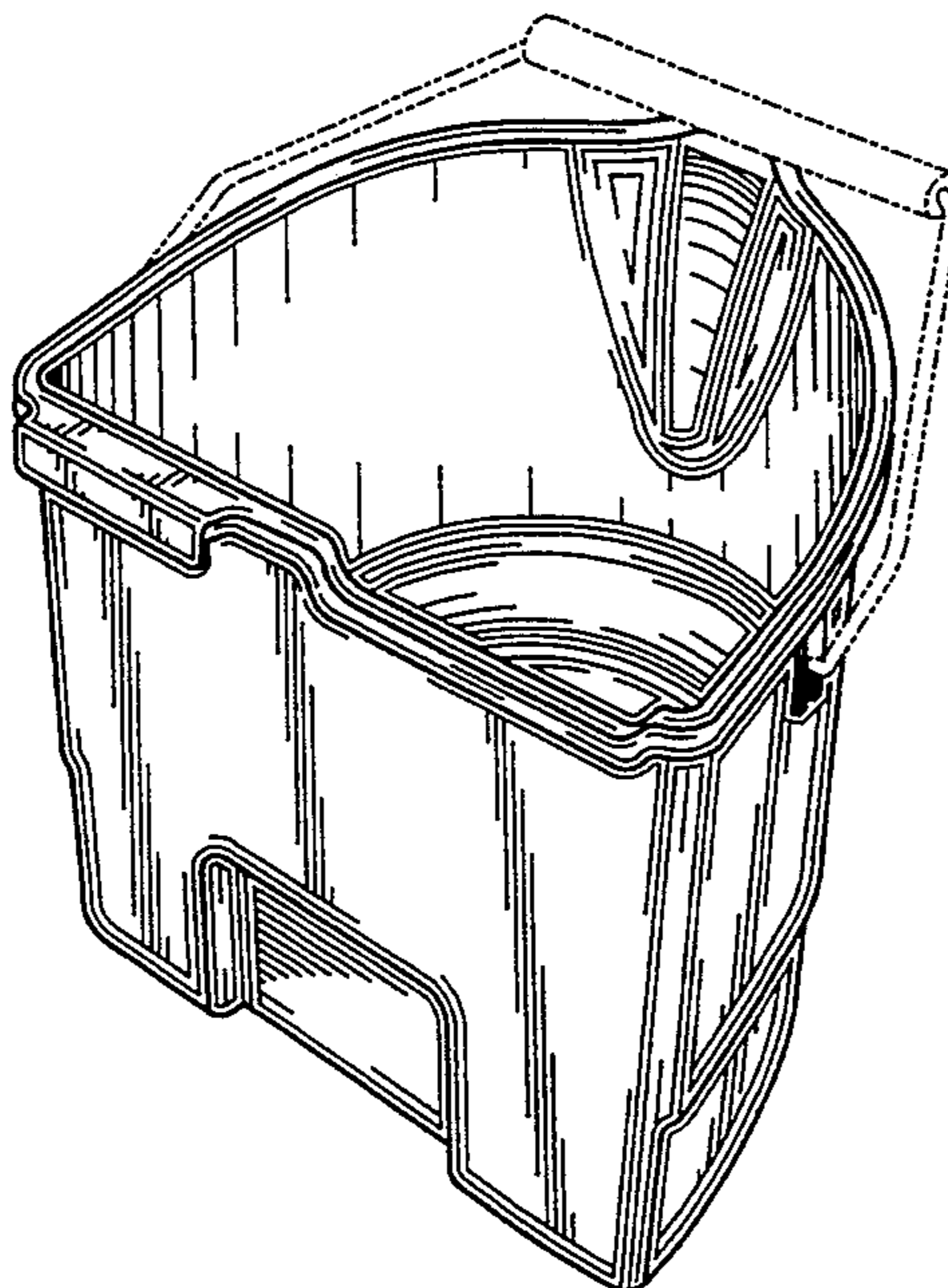
FIG. 2 is a front elevational view thereof;

FIG. 6 is a bottom plan view thereof.



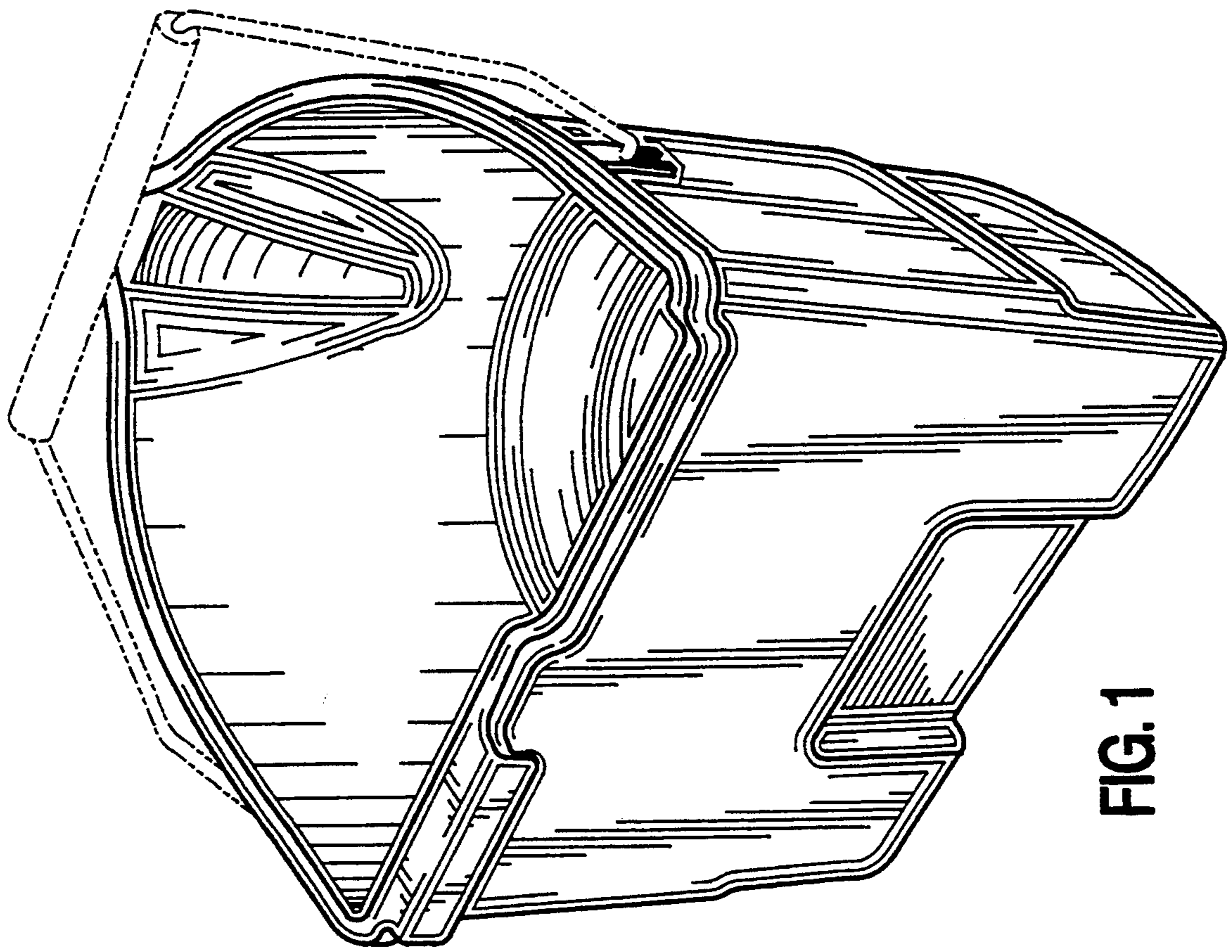

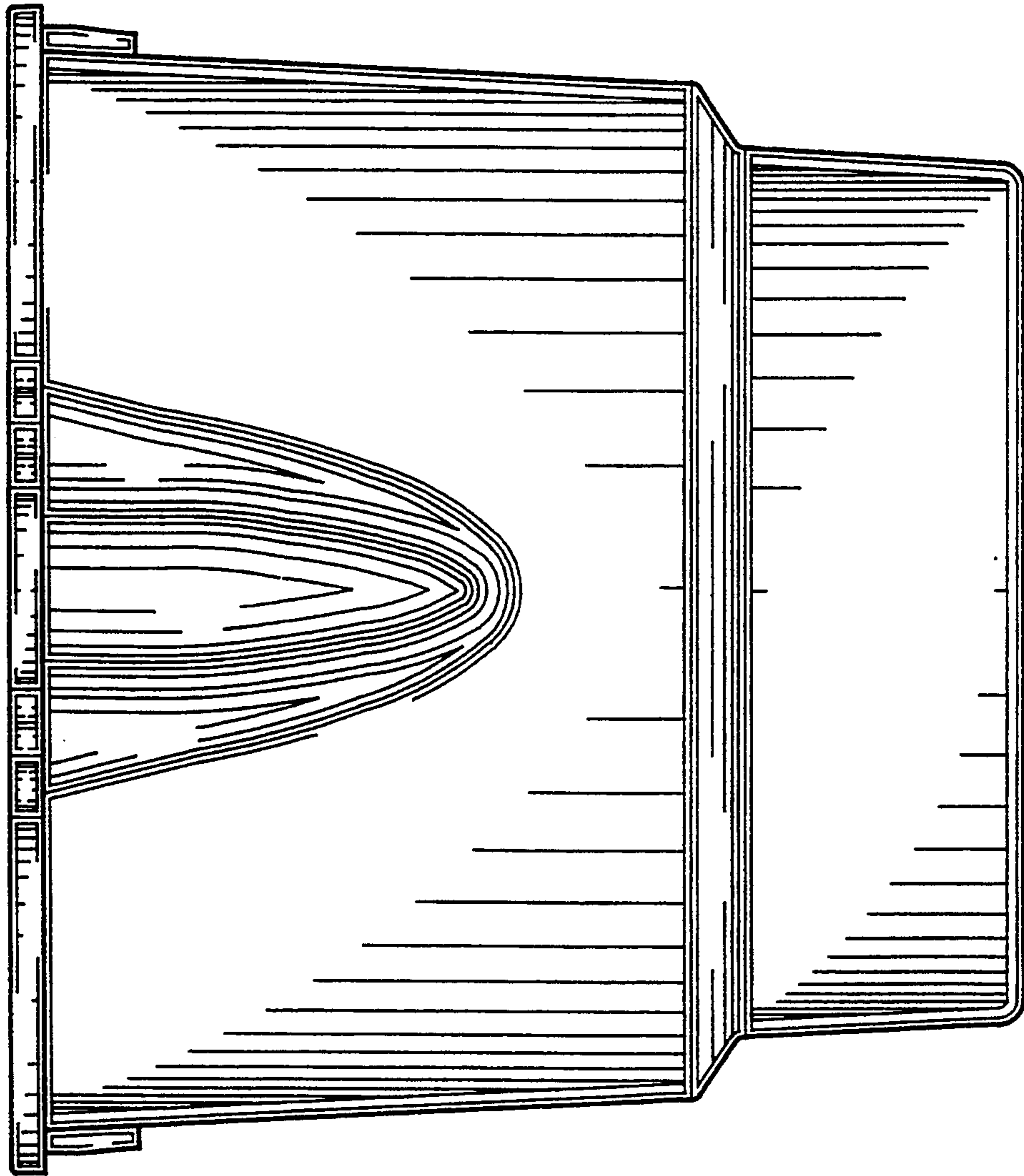

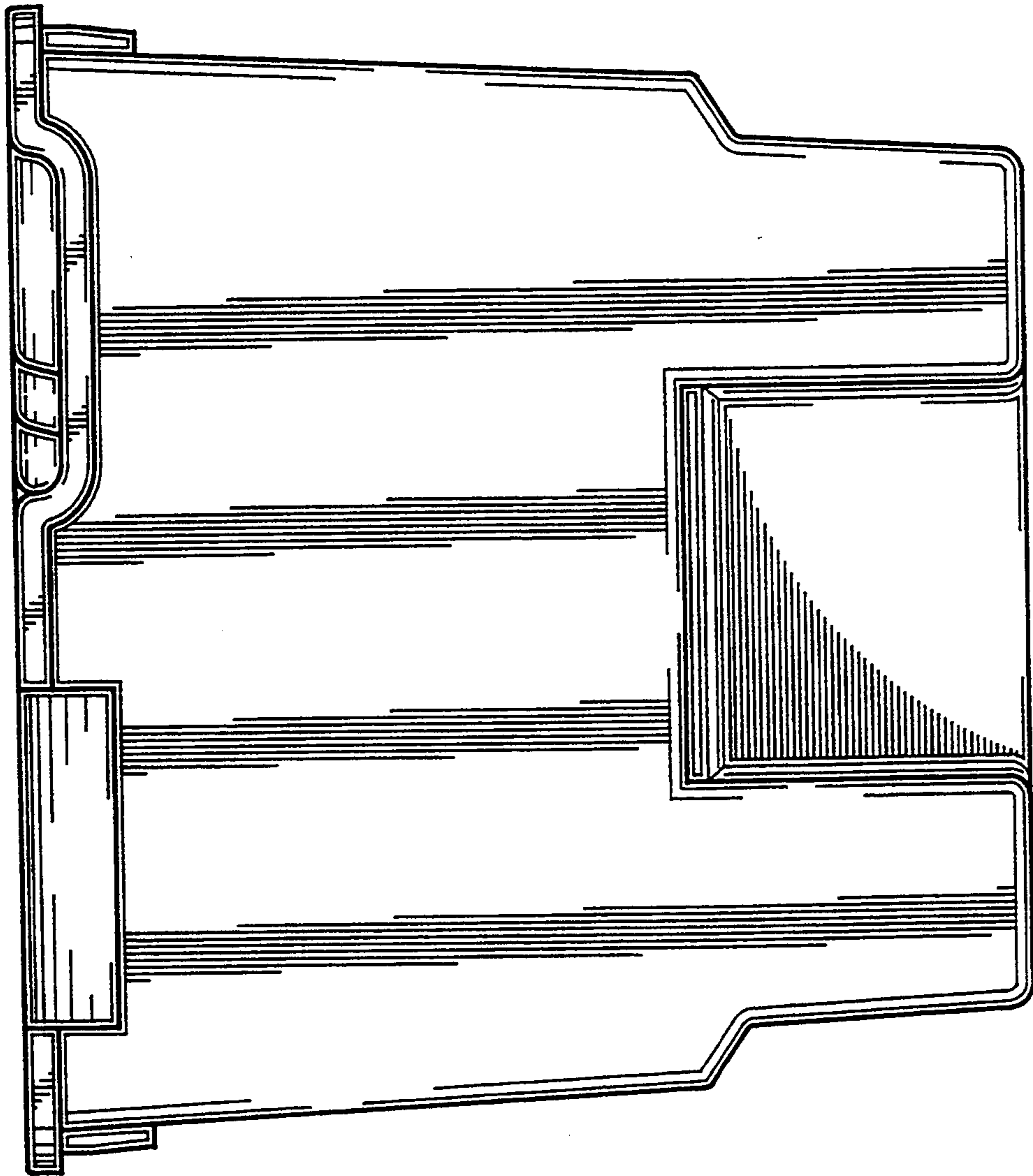

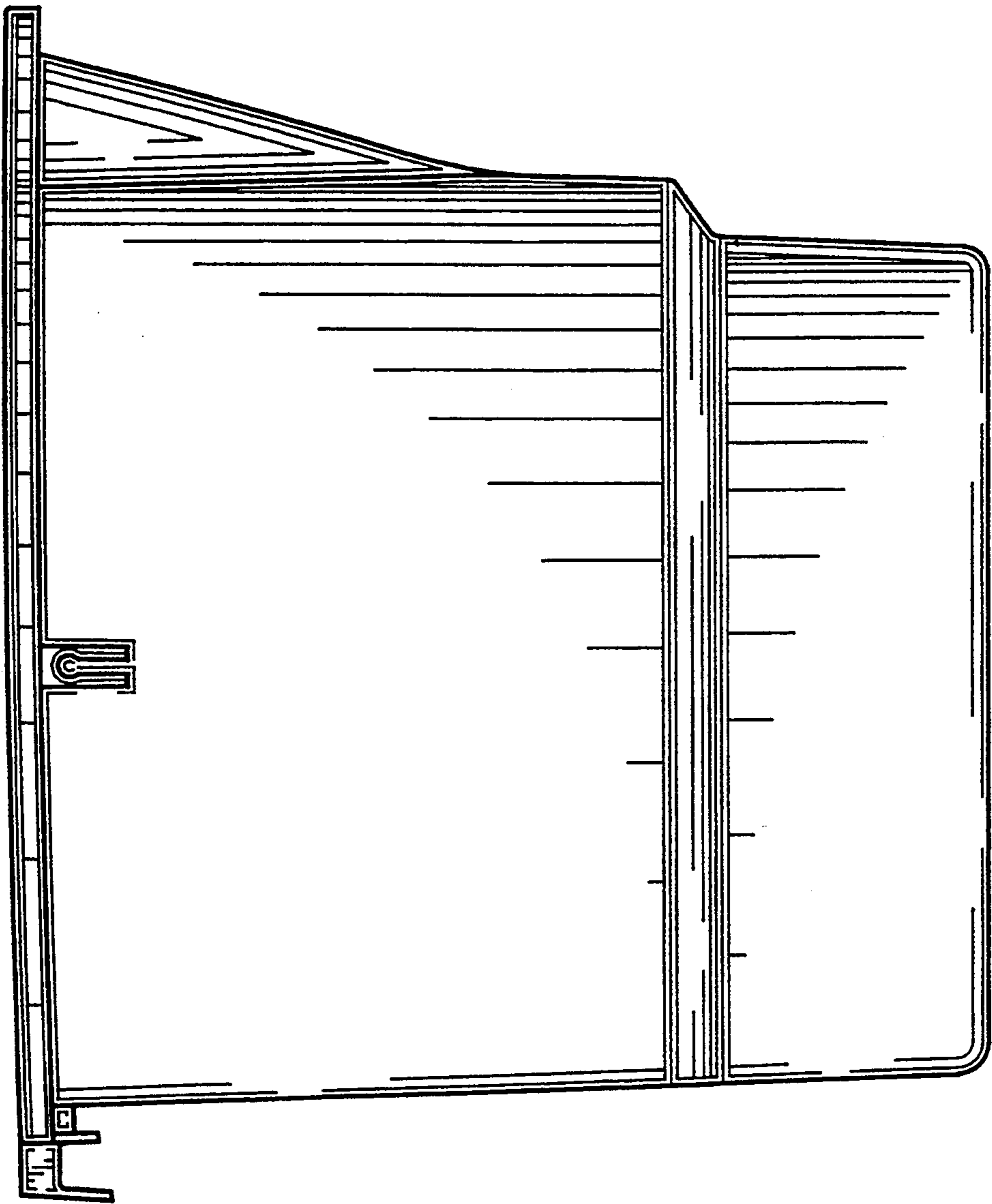

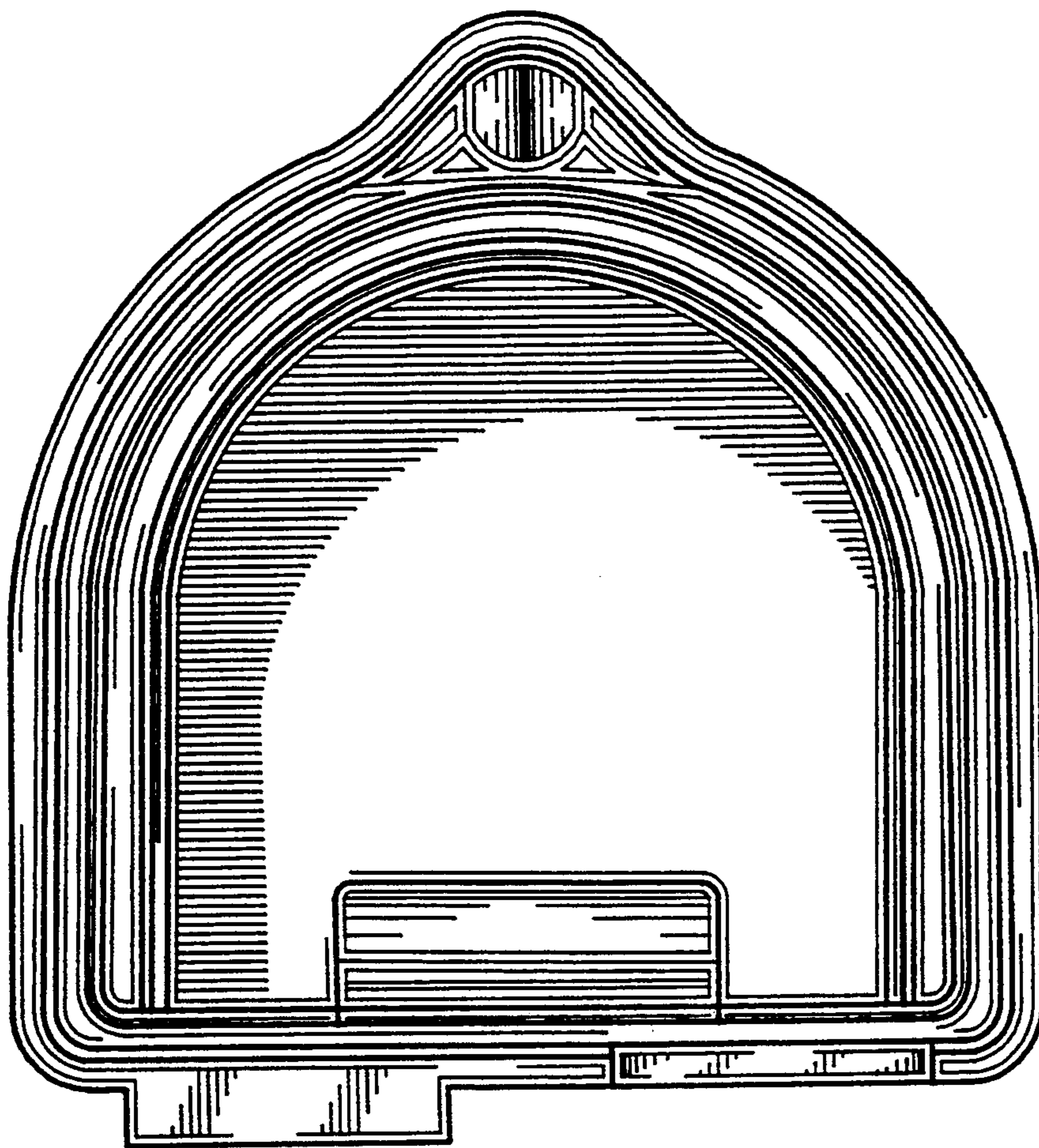

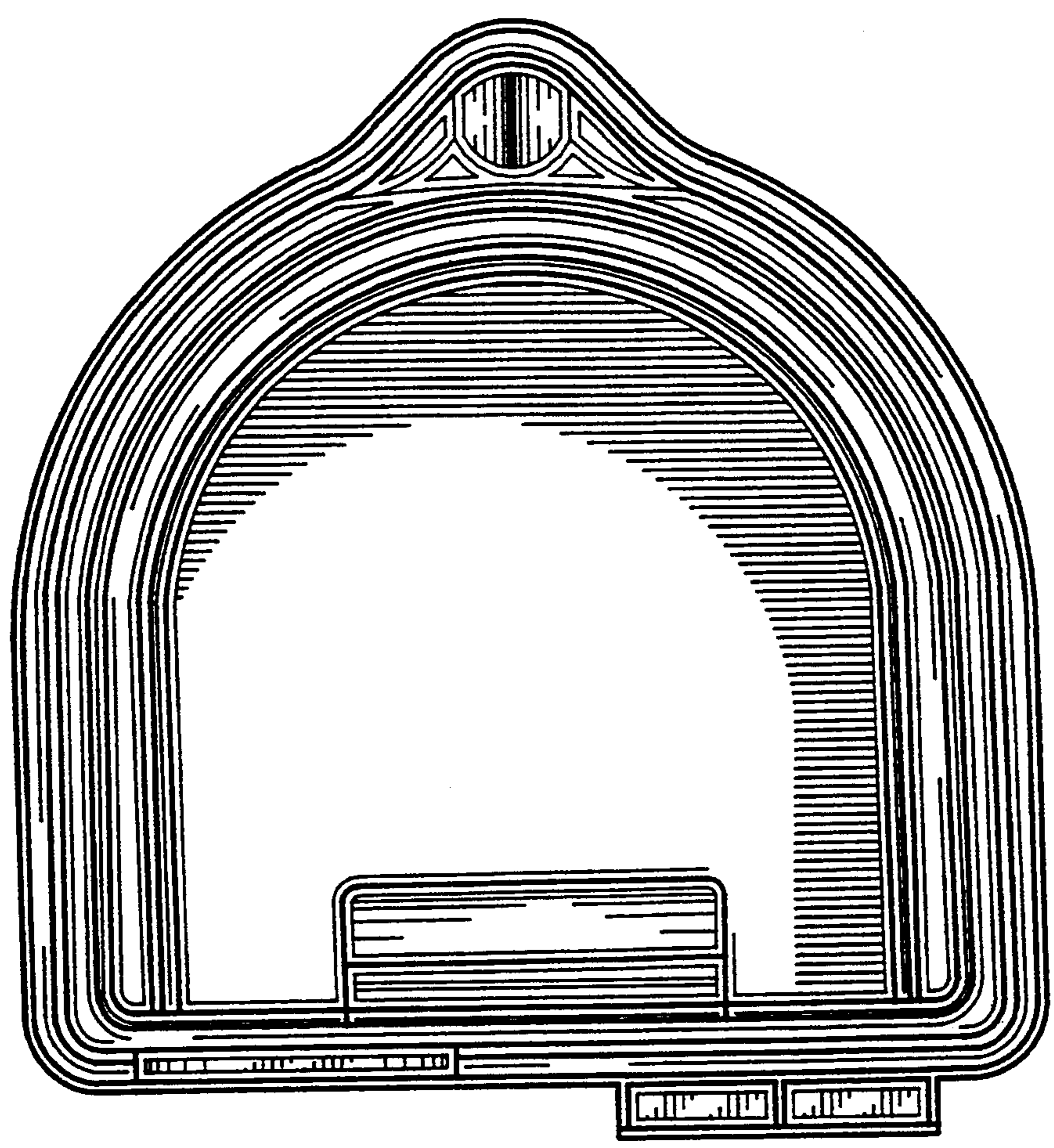
