[57] **CLAIM**

The ornamental design for a decorative key chain, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of the key chain of the present invention having a football ornament;  
 FIG. 2 is a front elevational view of the key chain of FIG. 1;  
 FIG. 3 is a rear elevational view of the key chain of FIG. 2;  
 FIG. 4 is a right-side elevational view of the key chain in FIG. 1;  
 FIG. 5 is a left-side elevational view of the key chain in FIG. 1;  
 FIG. 6 is a top plan view of the key chain of FIG. 1;  
 FIG. 7 is a bottom plan view of the key chain of FIG. 1;  
 FIG. 8 is a front elevational view of a key chain showing a second embodiment of the present invention hav-

ing a basketball ornament. The rear elevational view is the same as FIG. 3;  
 FIG. 9 is a right-side elevational view of the key chain of FIG. 8;  
 FIG. 10 is a left-side elevational view of the key chain of FIG. 8;  
 FIG. 11 is a top plan view of the key chain of FIG. 8;  
 FIG. 12 is a bottom plan view of the key chain in FIG. 8;  
 FIG. 13 is a front elevational view of the key chain showing a third embodiment of the present invention having a baseball ornament. The rear elevational view is the same as FIG. 3;  
 FIG. 14 is a right-side elevational view of the key chain of FIG. 13;  
 FIG. 15 is a left-side elevational view of the key chain of FIG. 13;  
 FIG. 16 is a top plan view of the key chain of FIG. 13;

 FIG. 18 is a front elevational view of the key chain showing a fourth embodiment with a soccer ornament. The rear elevational view is the same as FIG. 3;

 FIG. 20 is a left-side elevational view of the key chain of FIG. 18;  
 FIG. 21 is a top plan view of the key chain of FIG. 18;  
 FIG. 22 is a bottom plan view of the key chain of FIG. 18;  
 FIG. 23 is a front elevational view of a key chain showing a fifth embodiment of the invention with a hockey ornament. The rear elevational view is the same as FIG. 3;  
 FIG. 24 is a right-side elevational view of the key chain of FIG. 23;  
 FIG. 25 is a left-side elevational view of the key chain of FIG. 23;  
 FIG. 26 is a top plan view of the key chain of FIG. 23;  
 FIG. 27 is a bottom plan view of the key chain of FIG. 23;  
 FIG. 28 is a front elevational view of a key chain showing a sixth embodiment of the invention with a megaphone ornament. The rear elevational view is the same as FIG. 3;  
 FIG. 29 is a right-side elevational view of the key chain of FIG. 28;

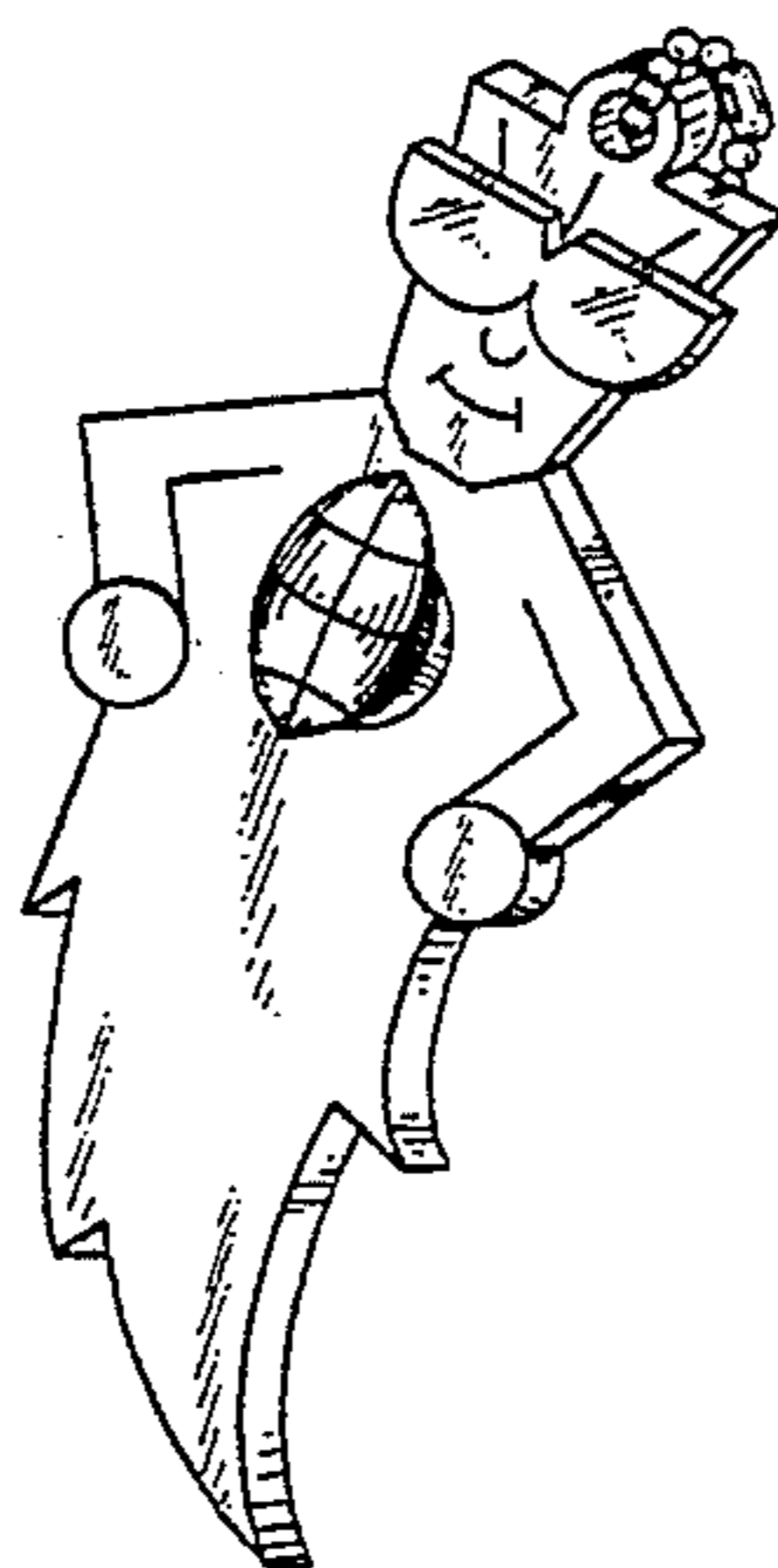


FIG. 30 is a left-side elevational view of the key chain of FIG. 28;

FIG. 42 is a bottom plan view of the key chain of FIG. 38.

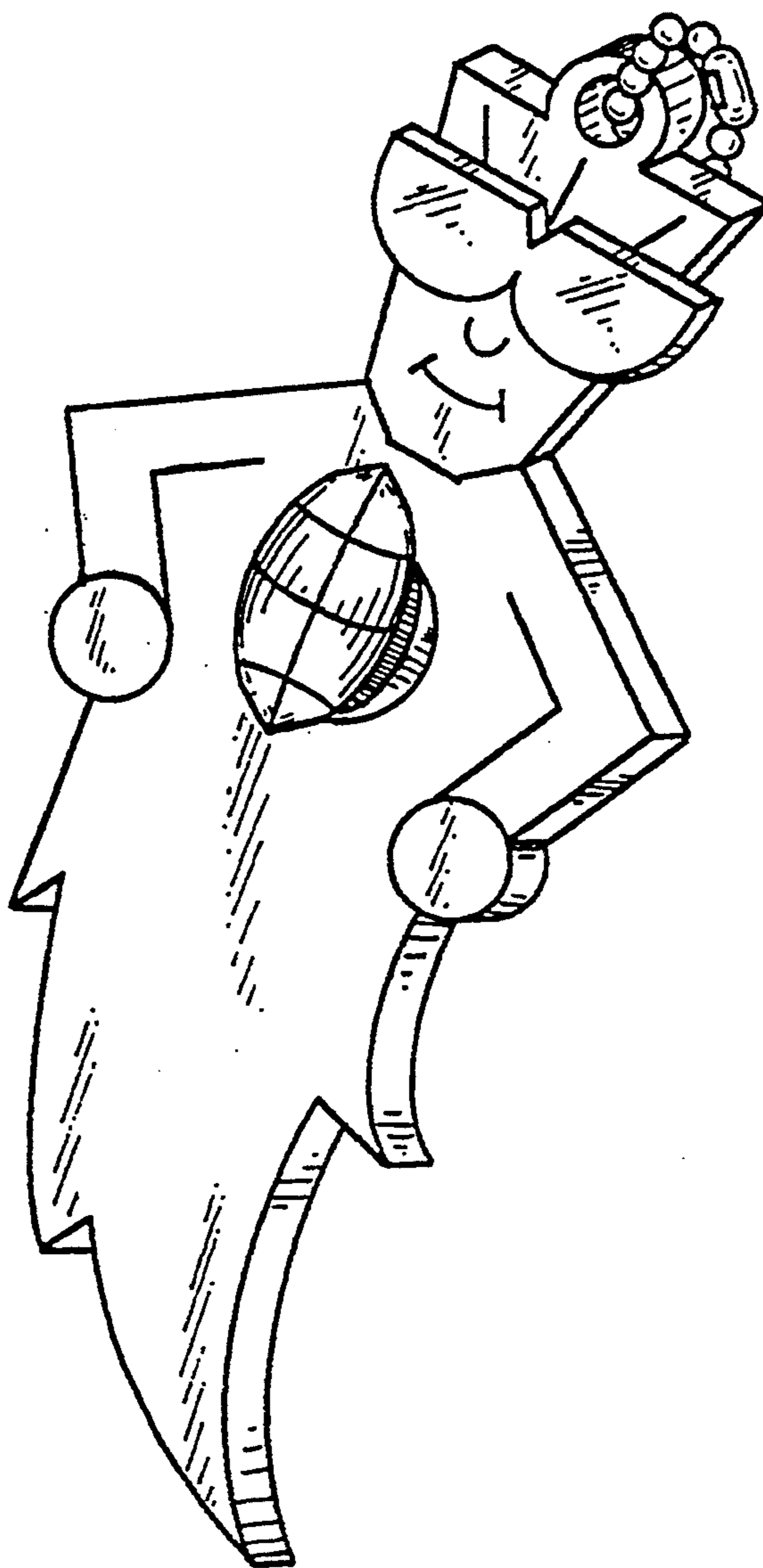

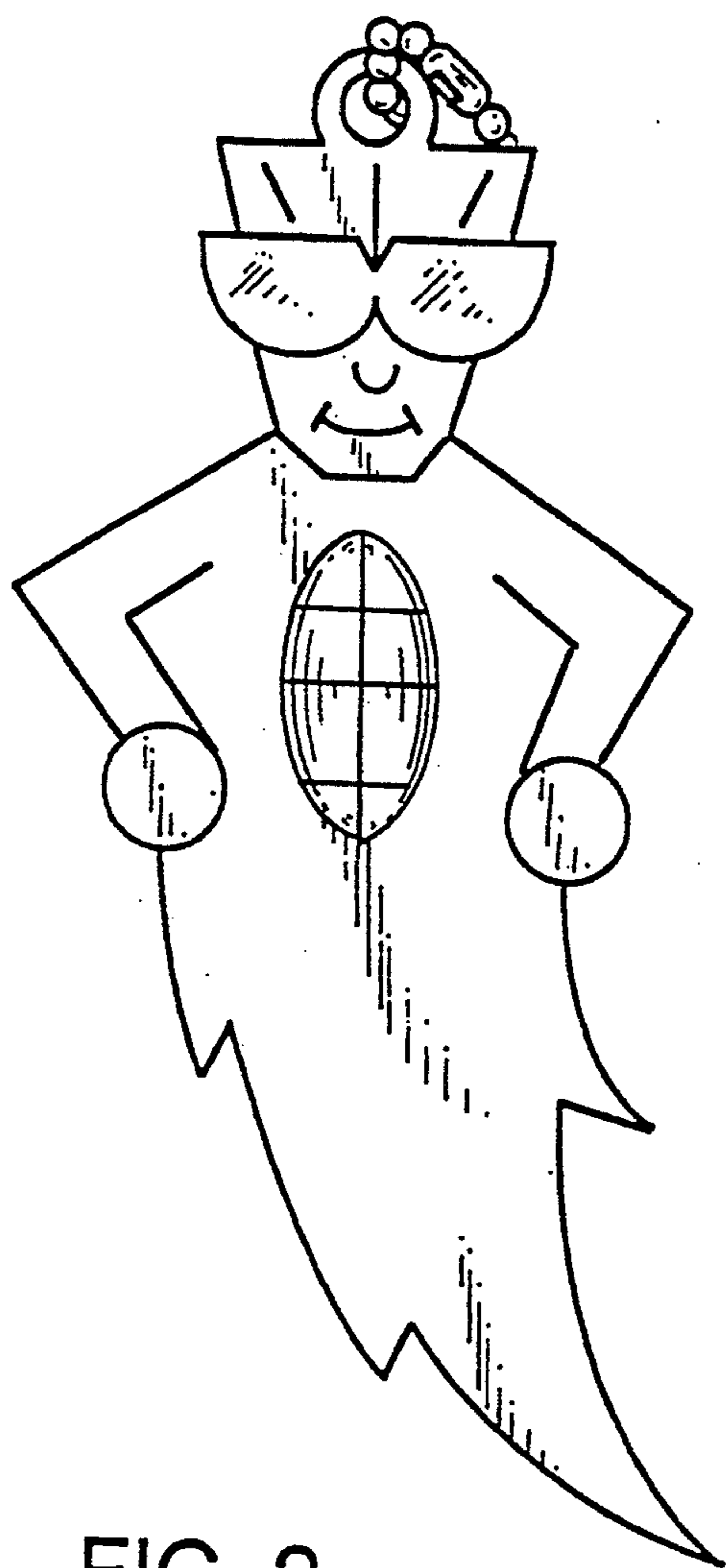

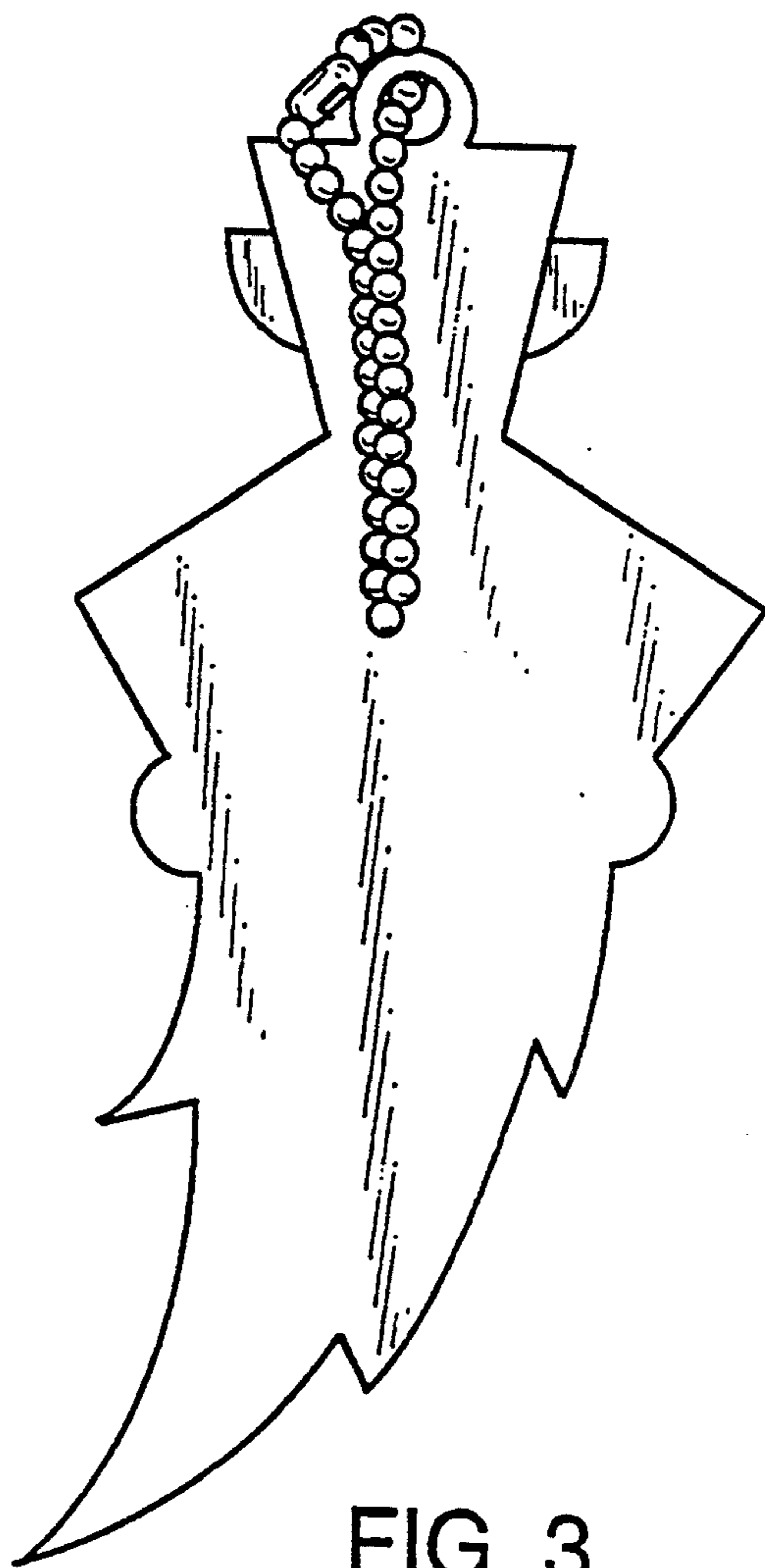

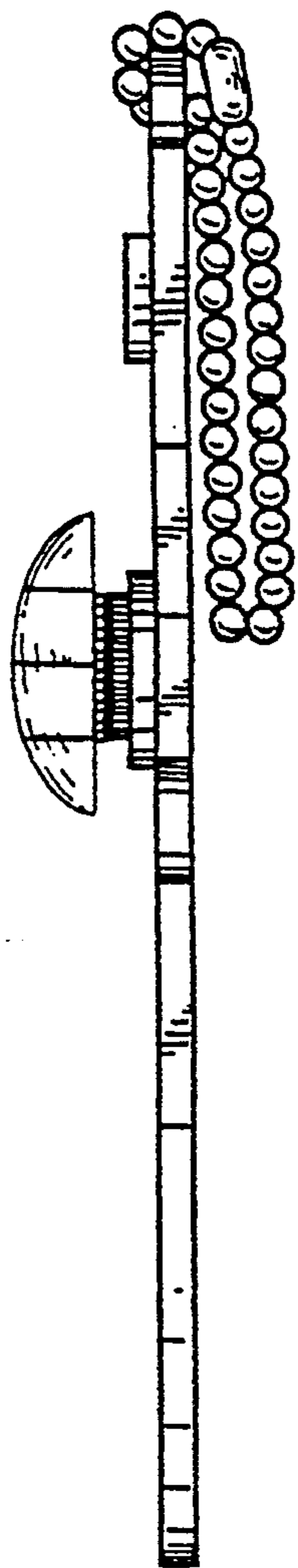

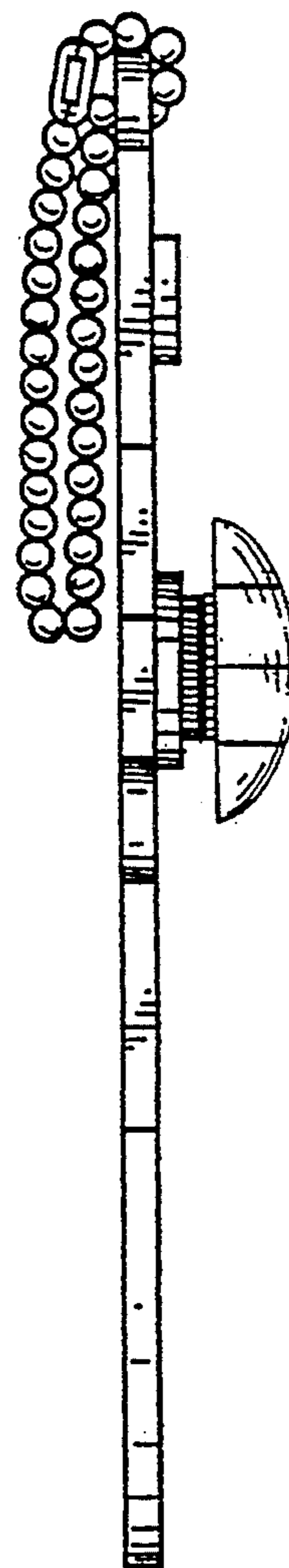

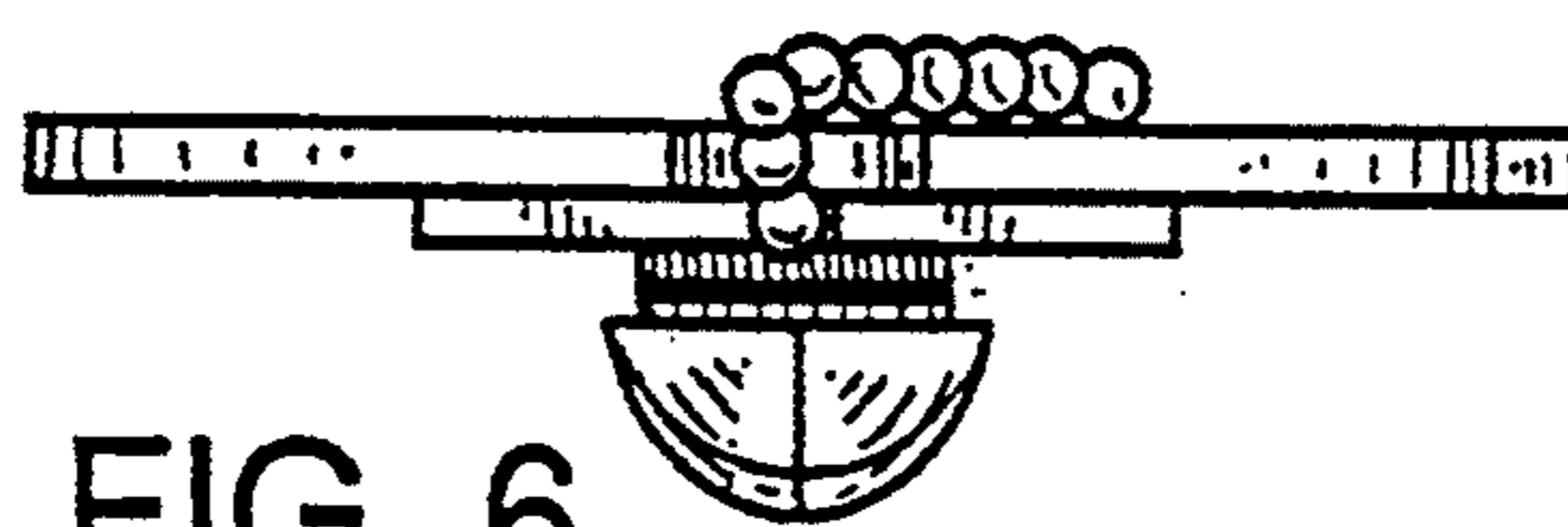

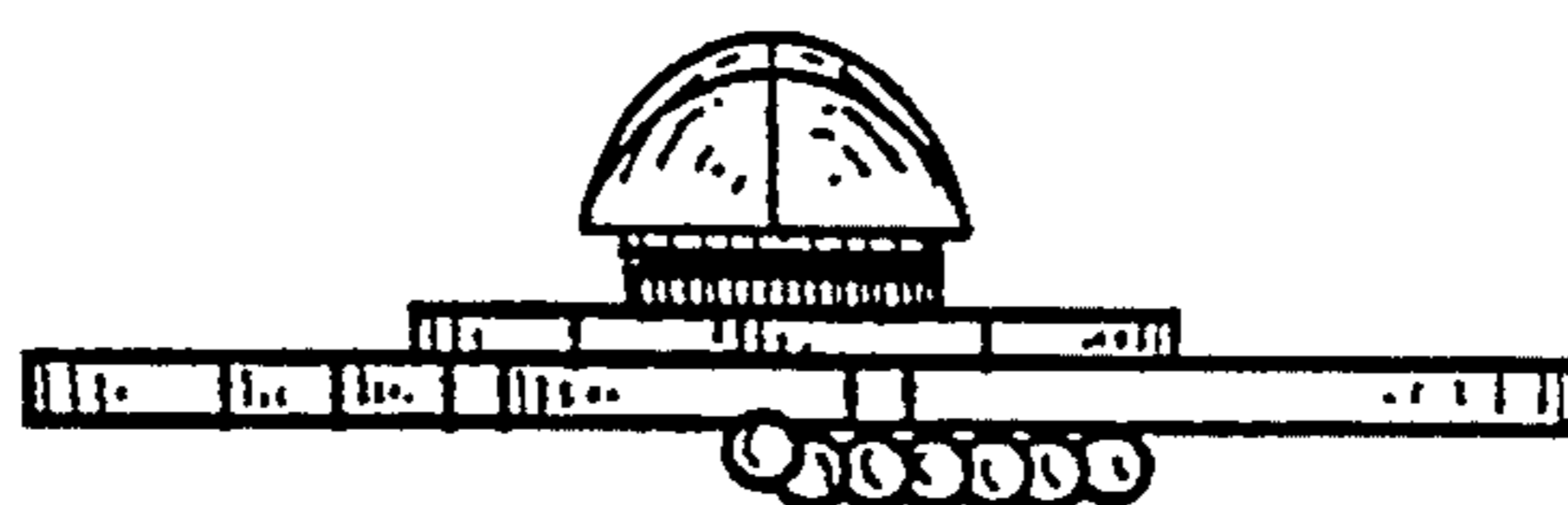

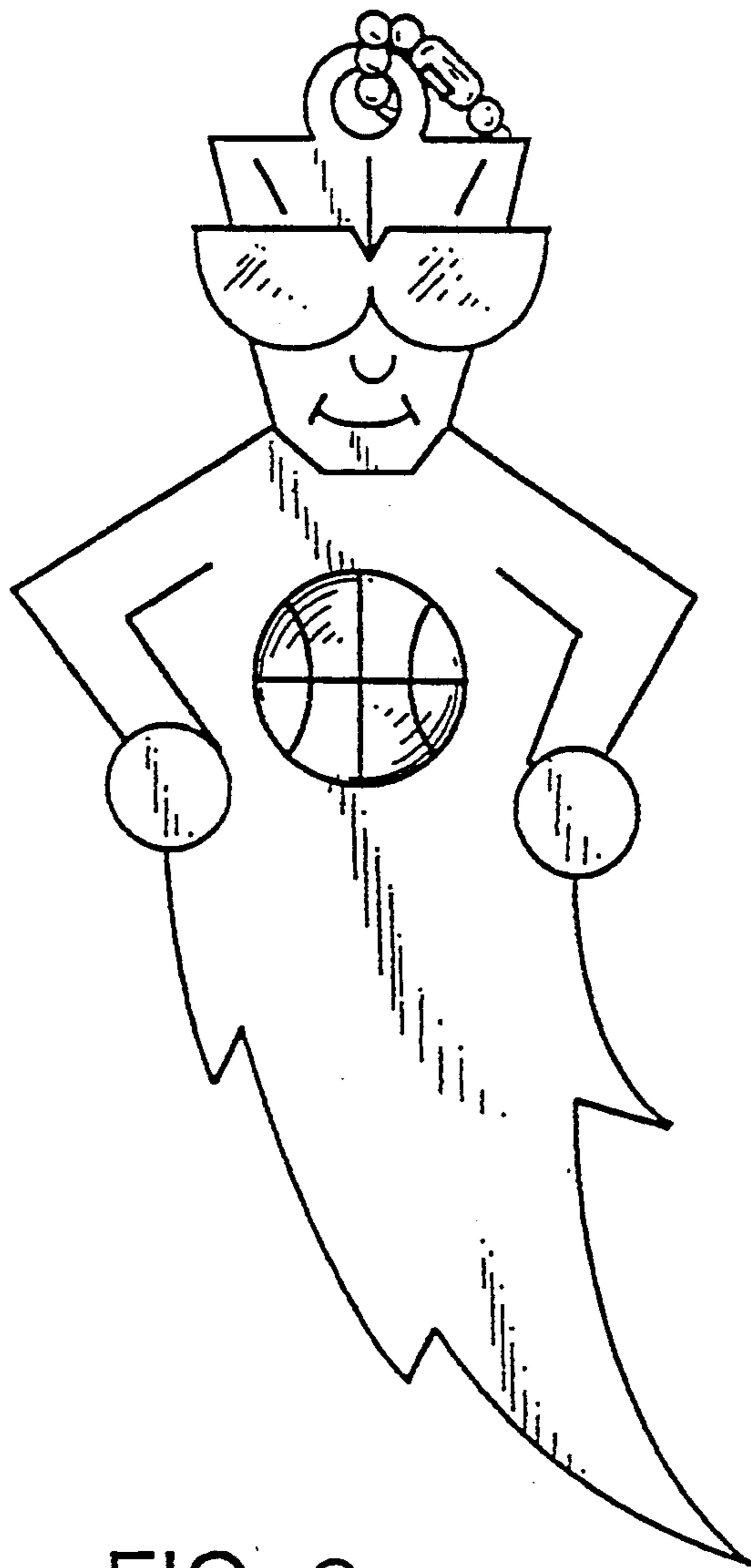

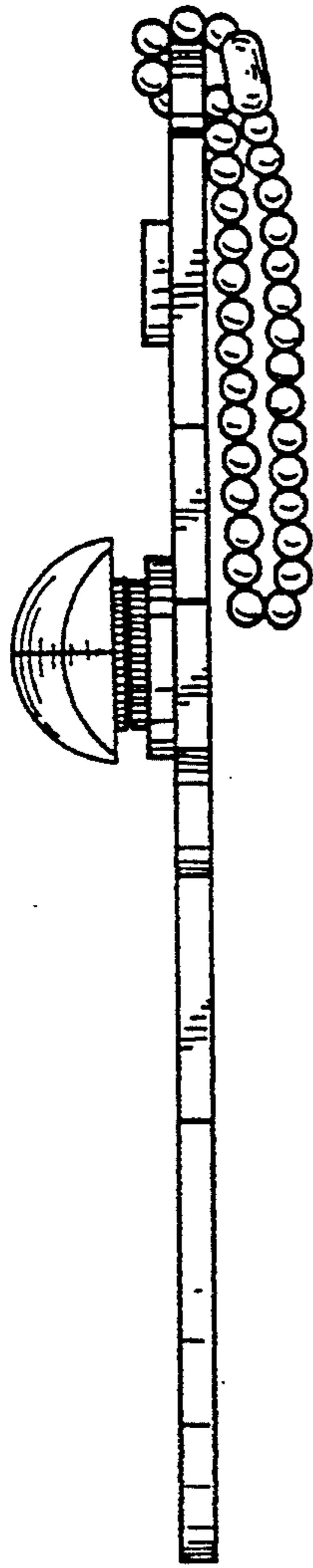

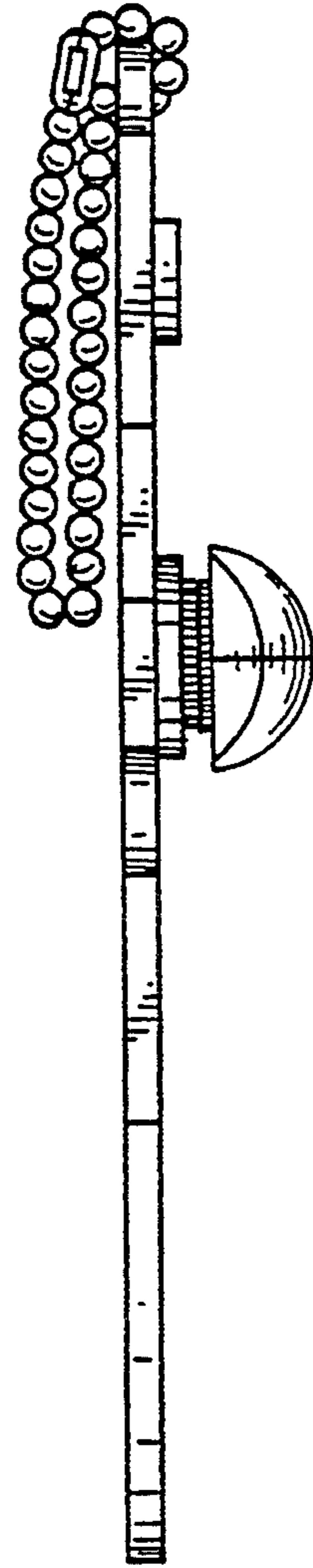

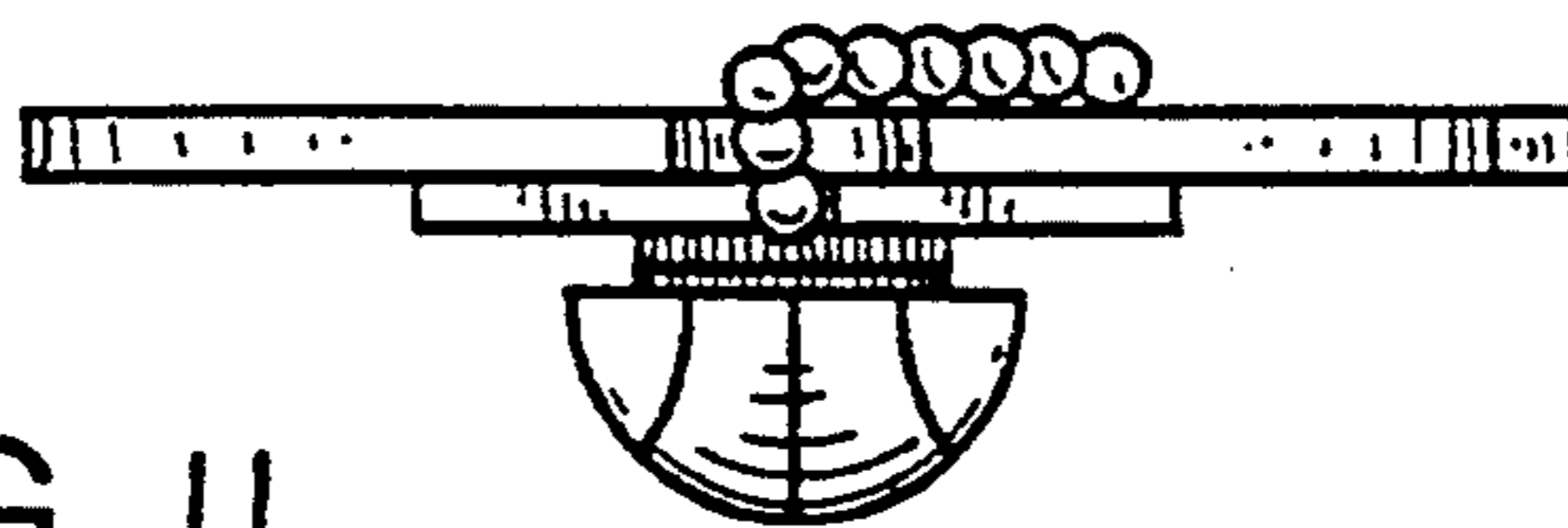

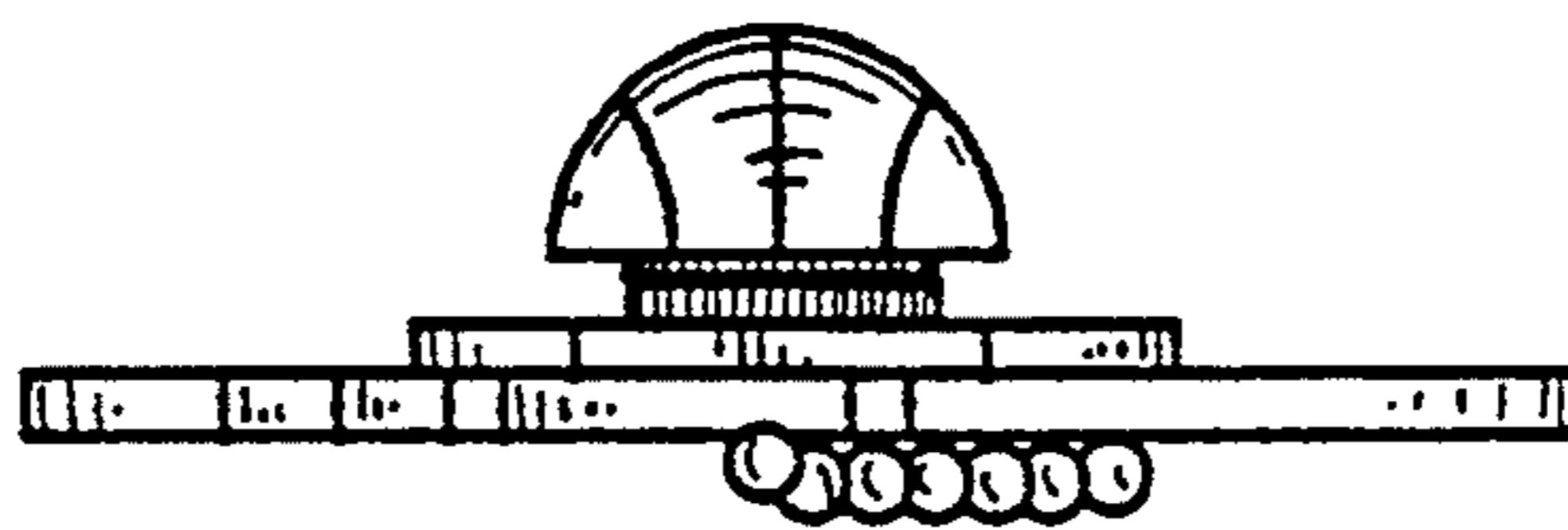

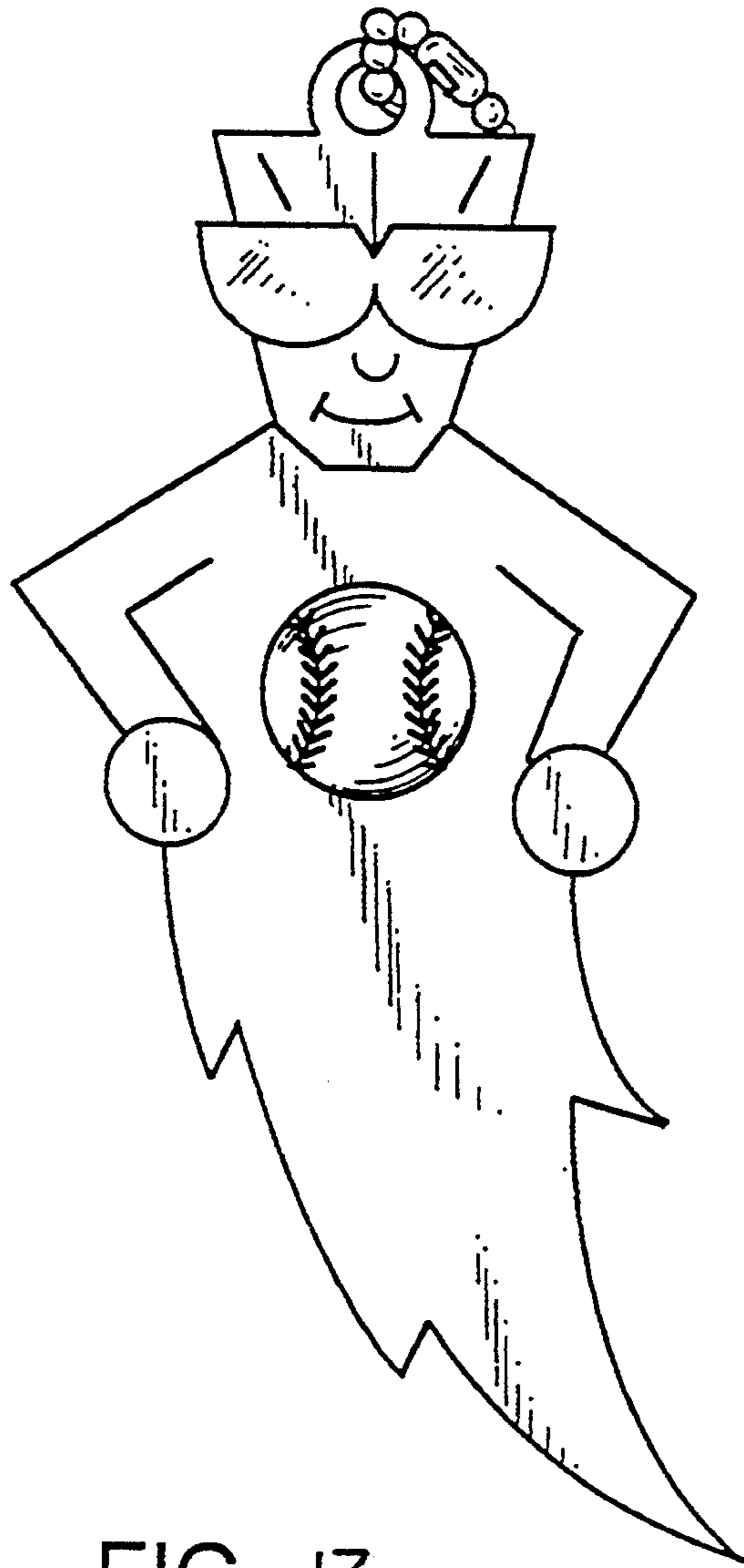

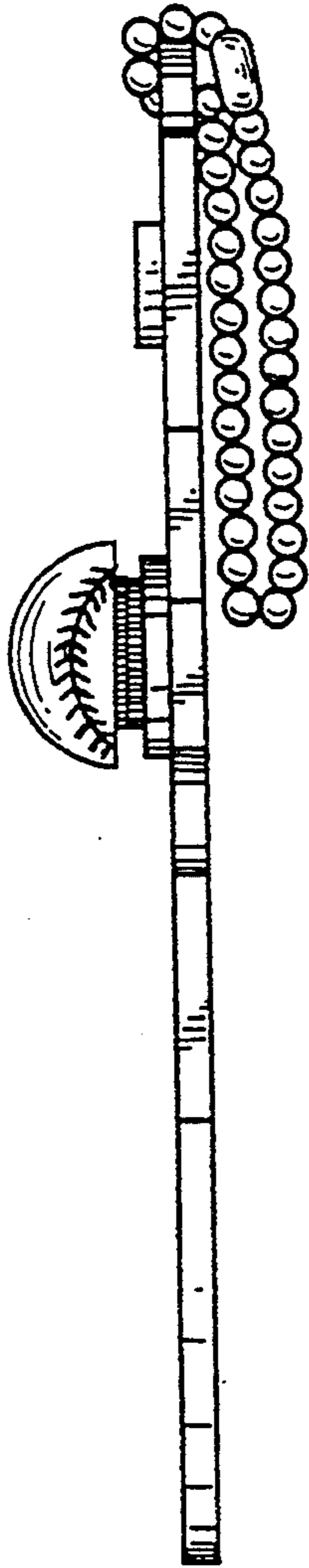

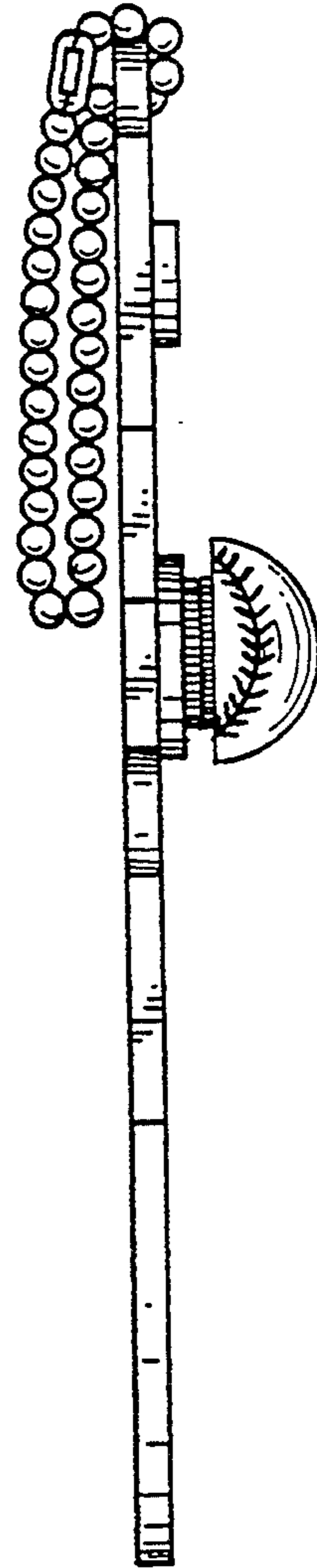

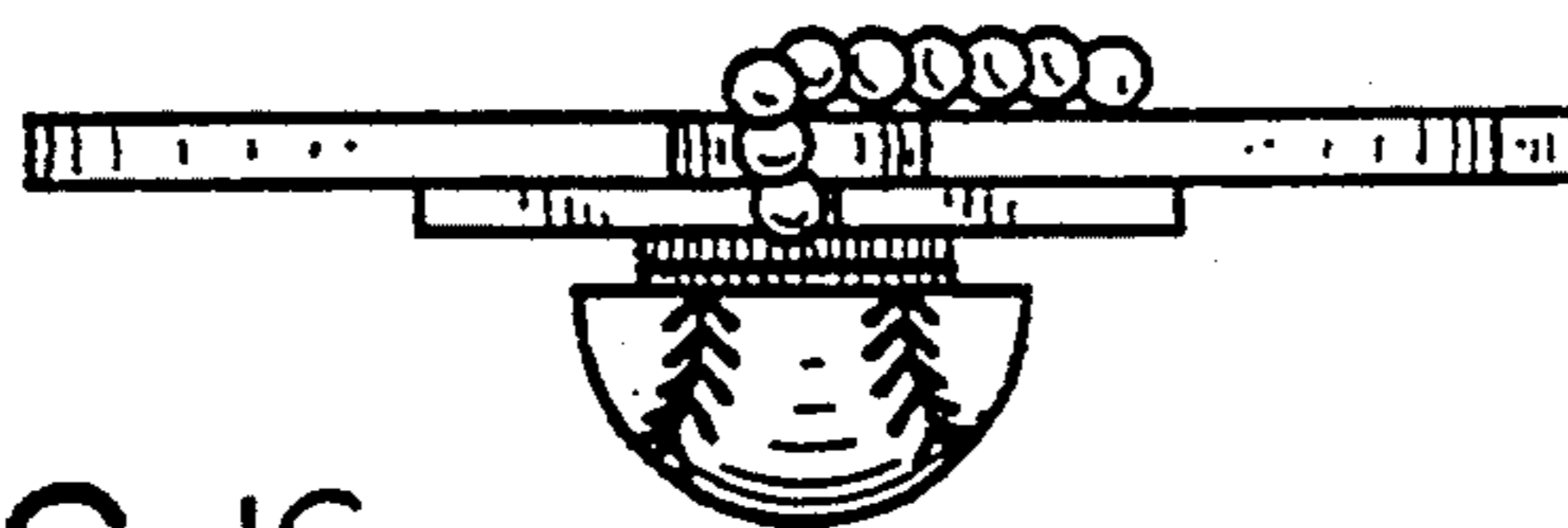

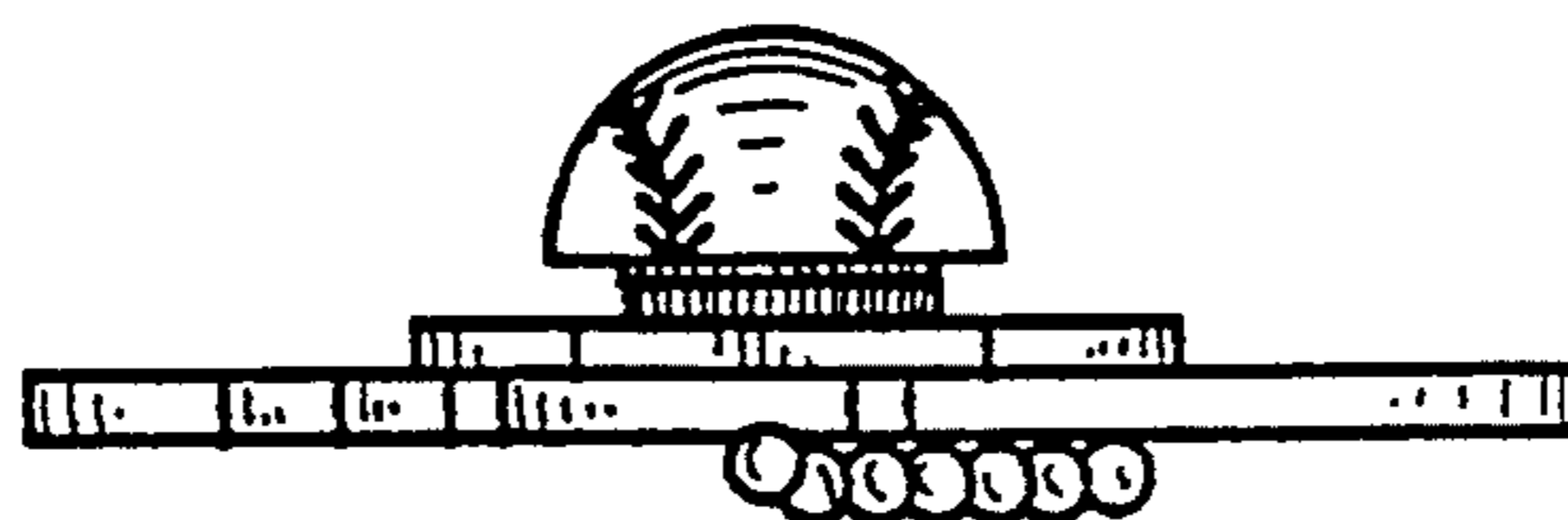

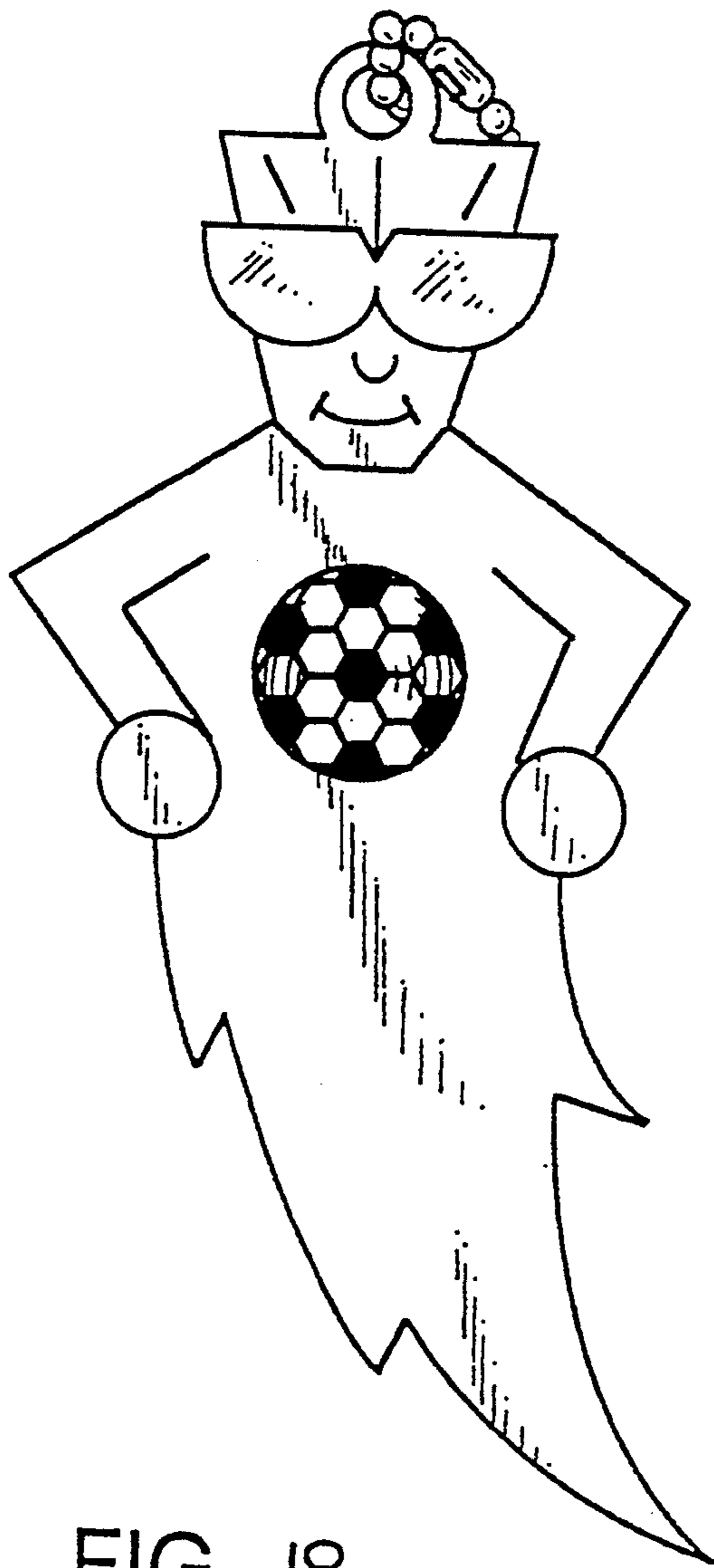

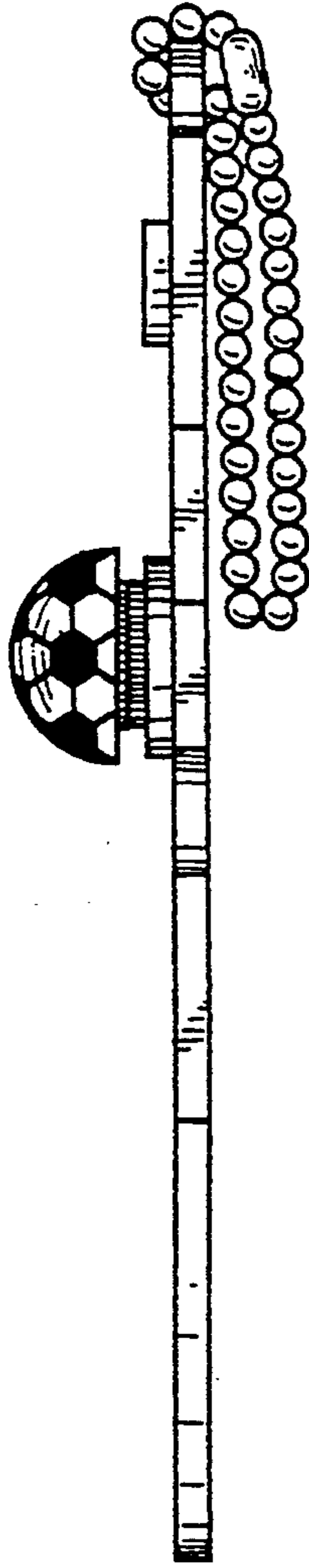

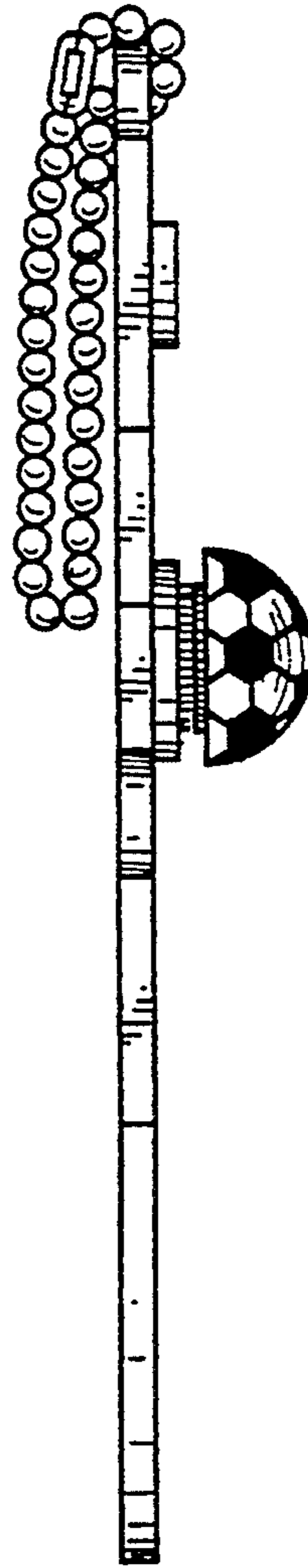

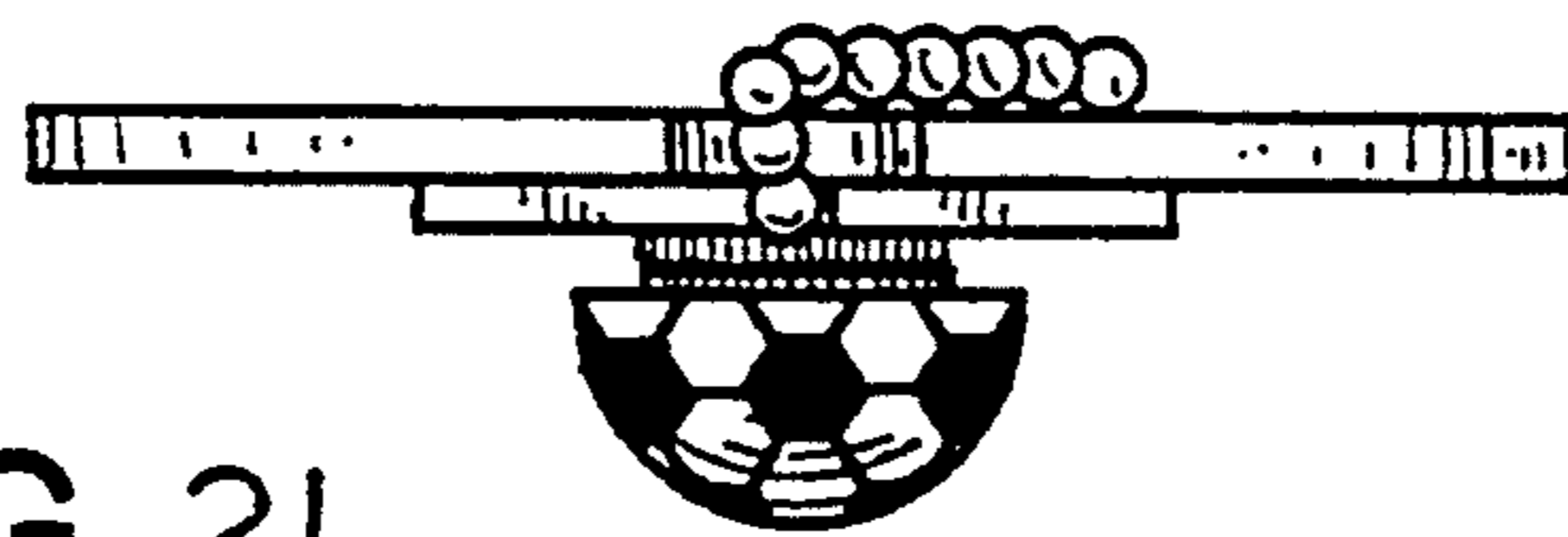

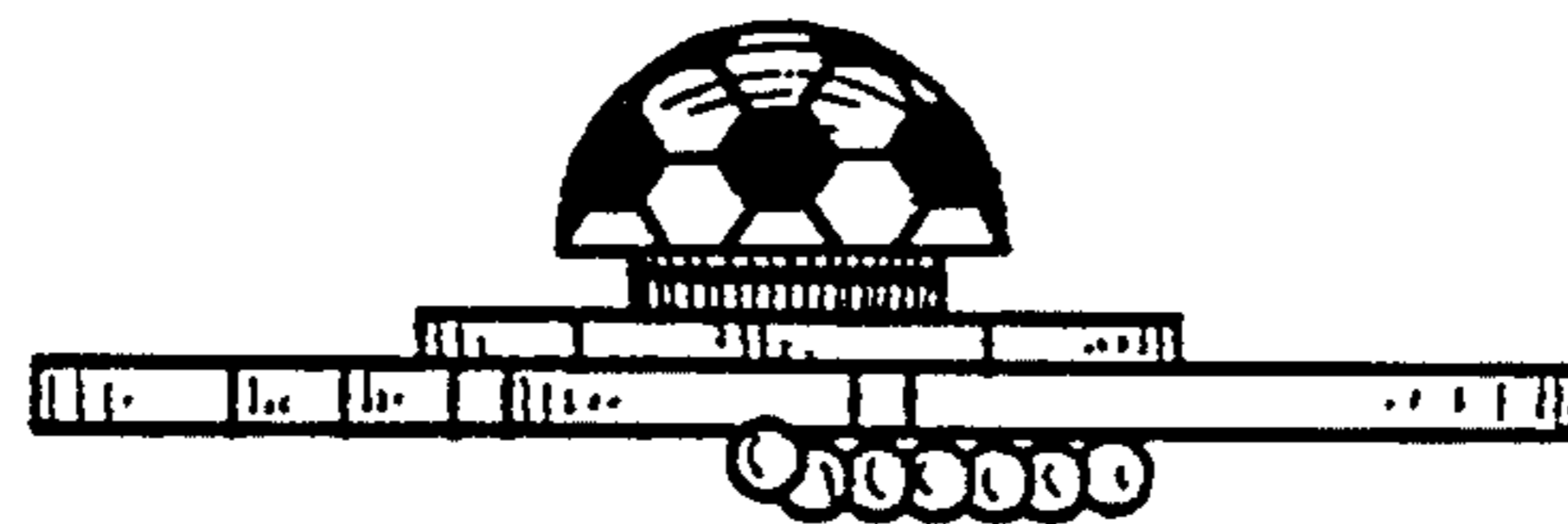

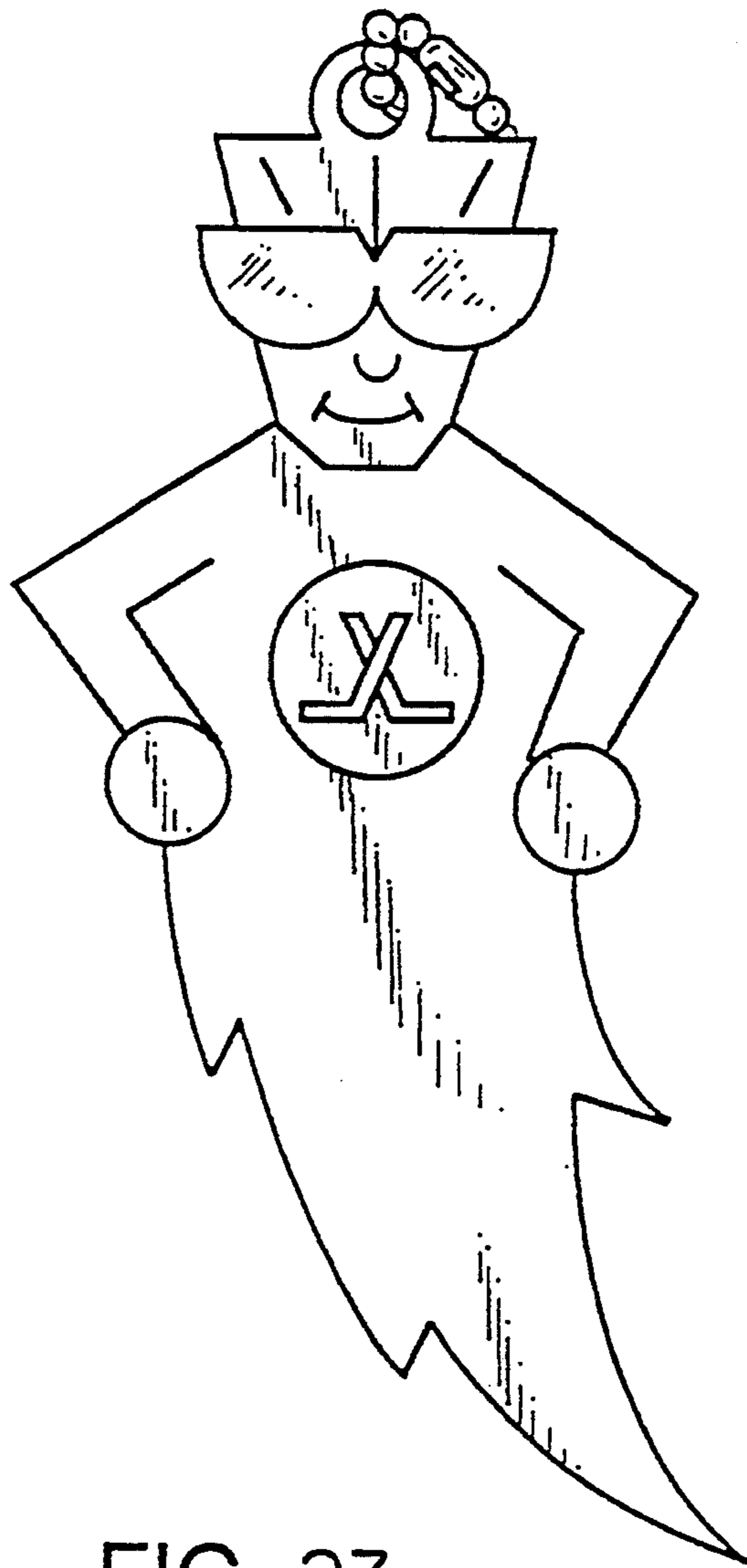

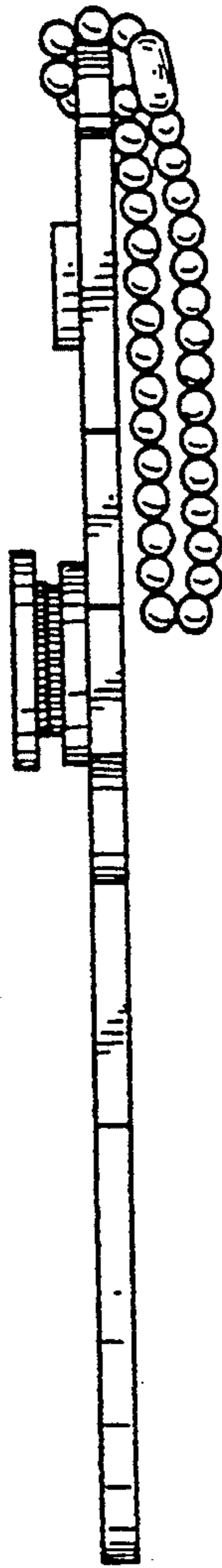

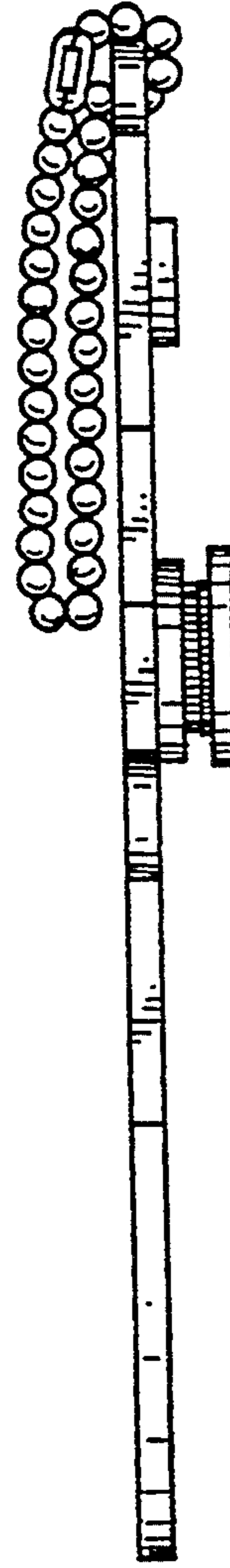

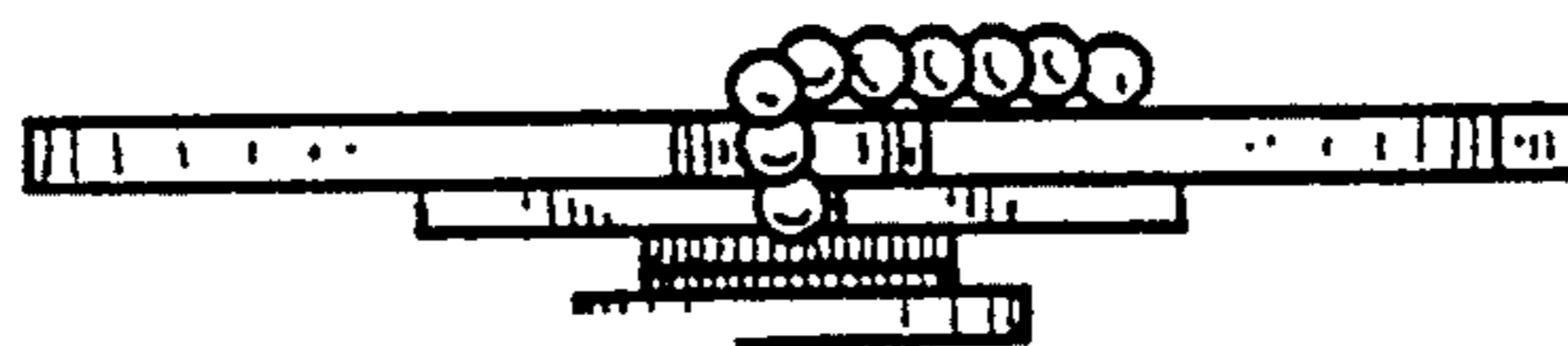

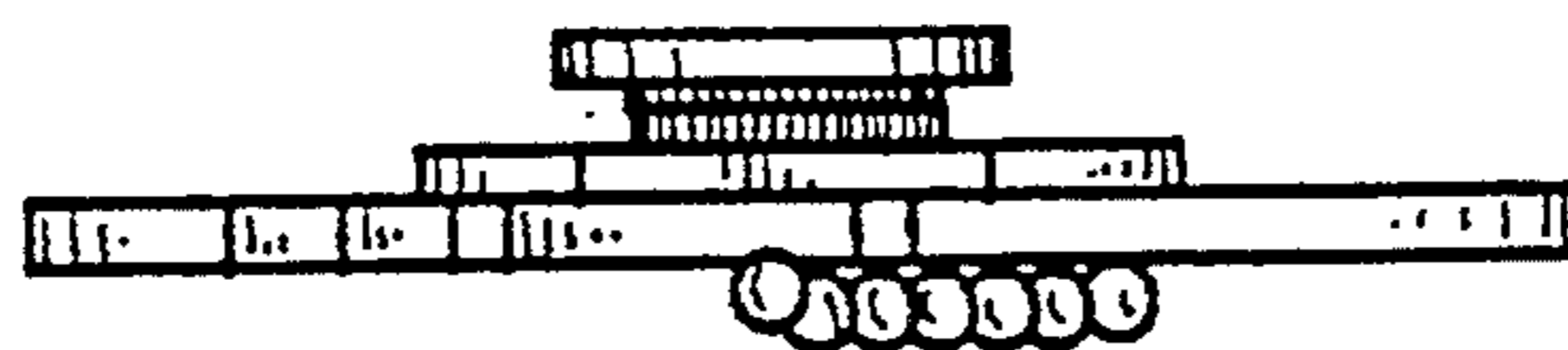

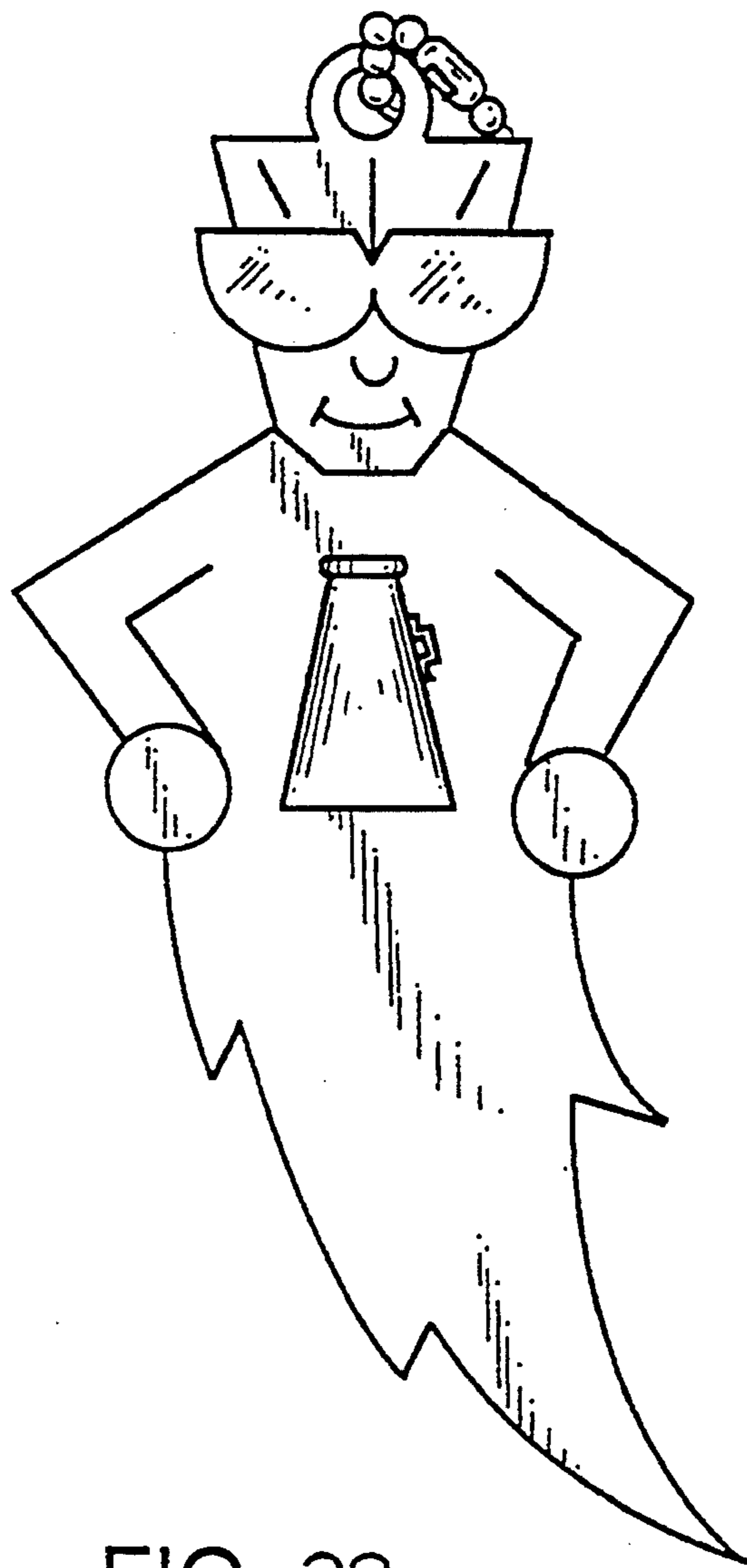

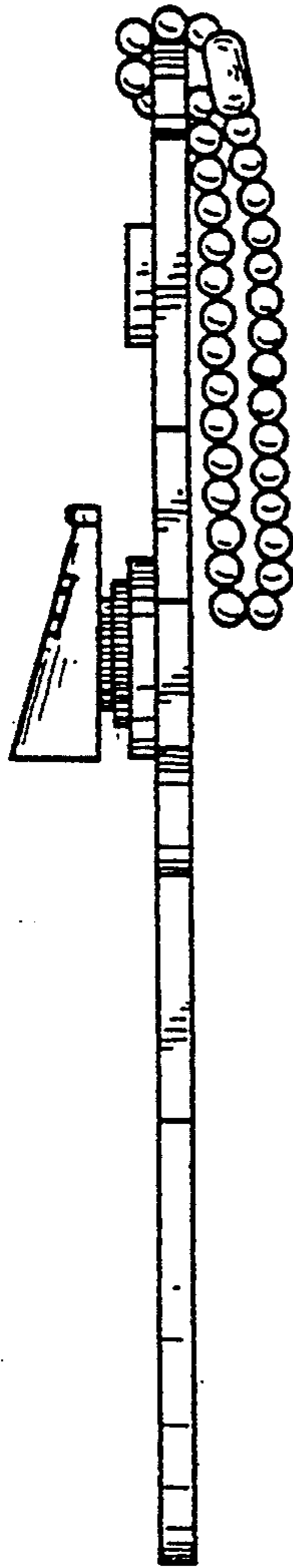

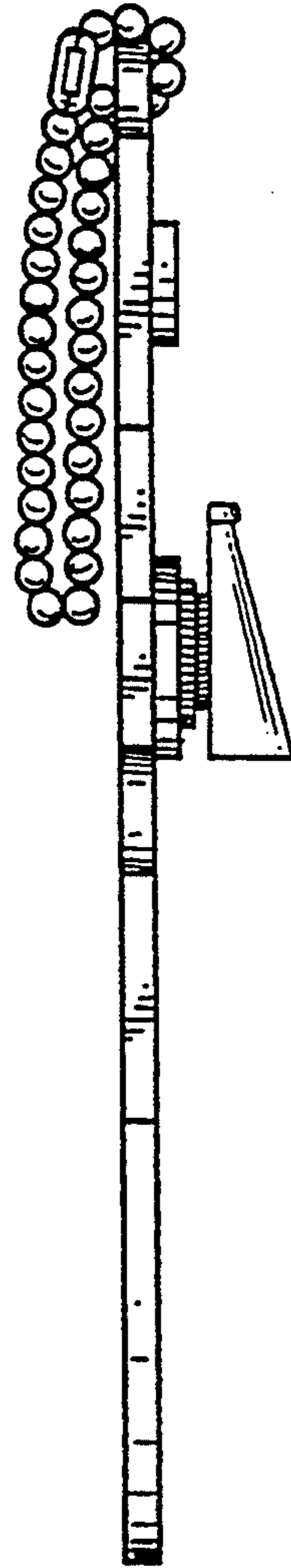

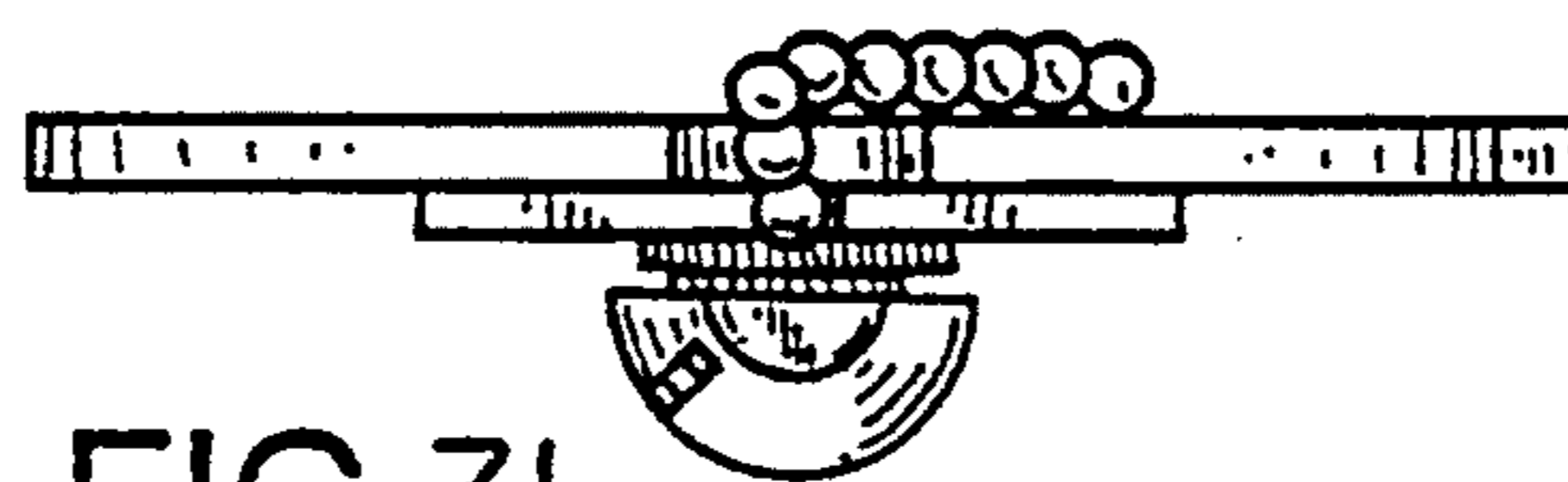

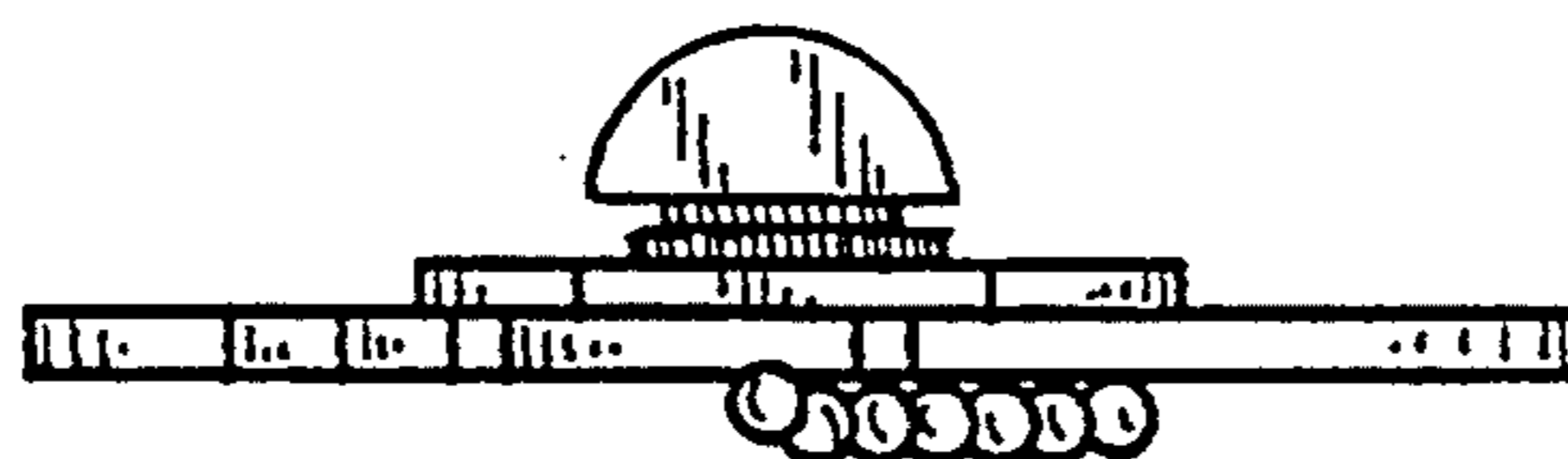

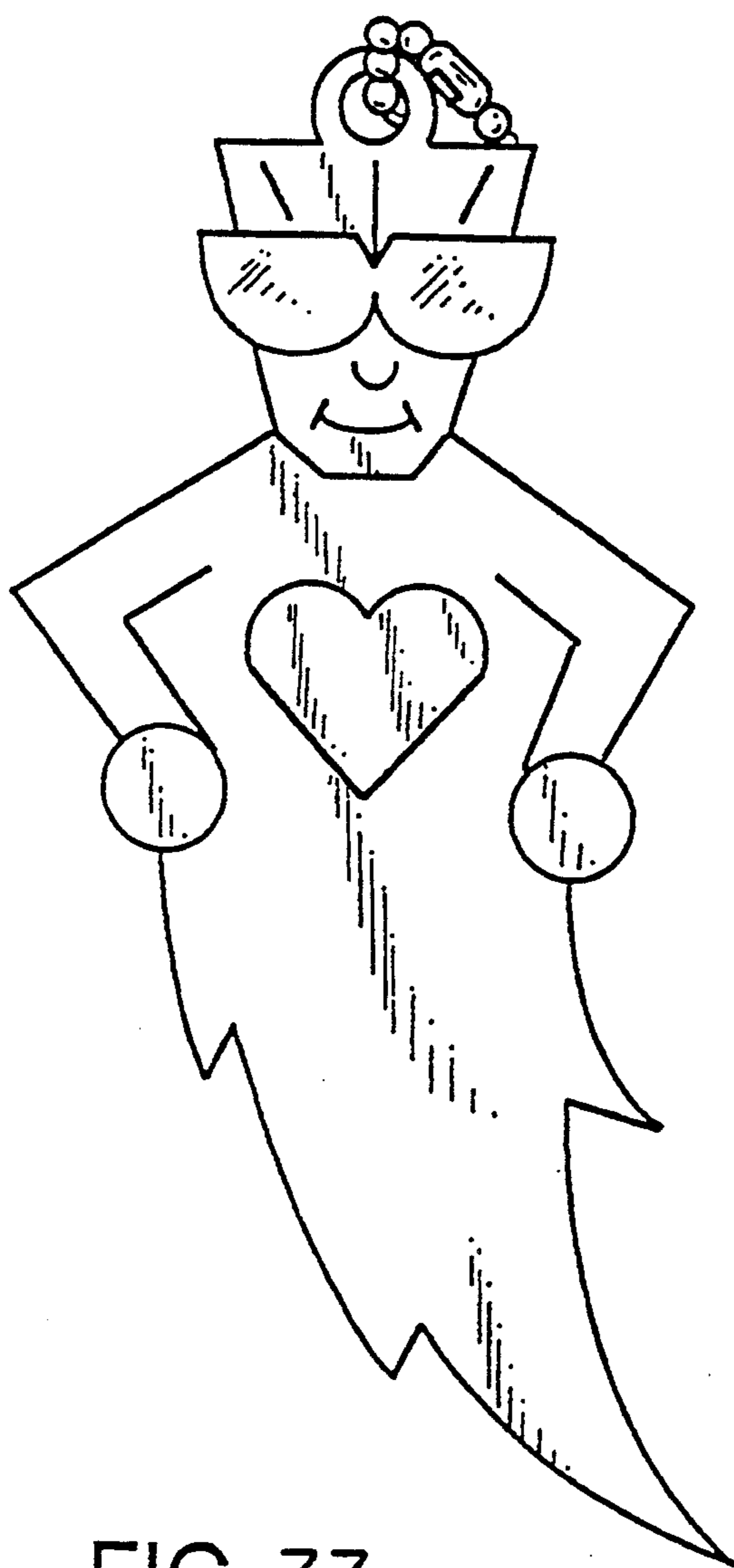

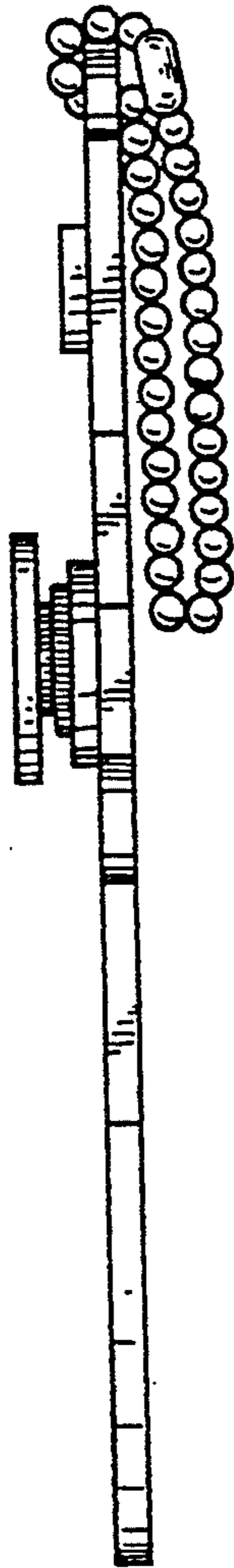

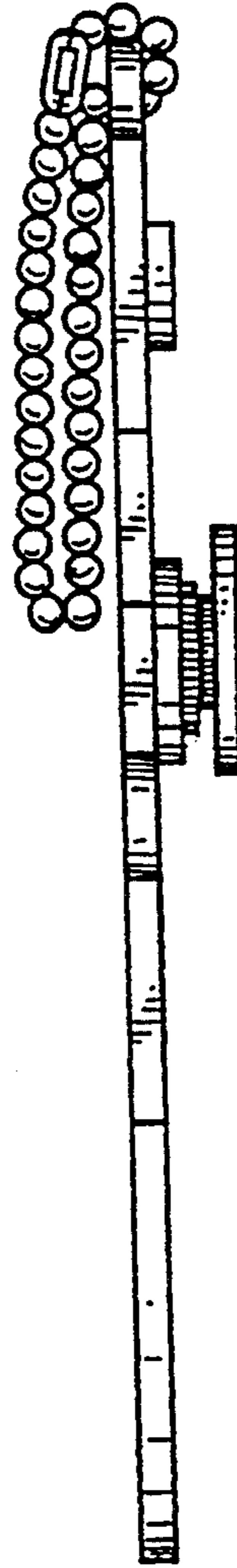

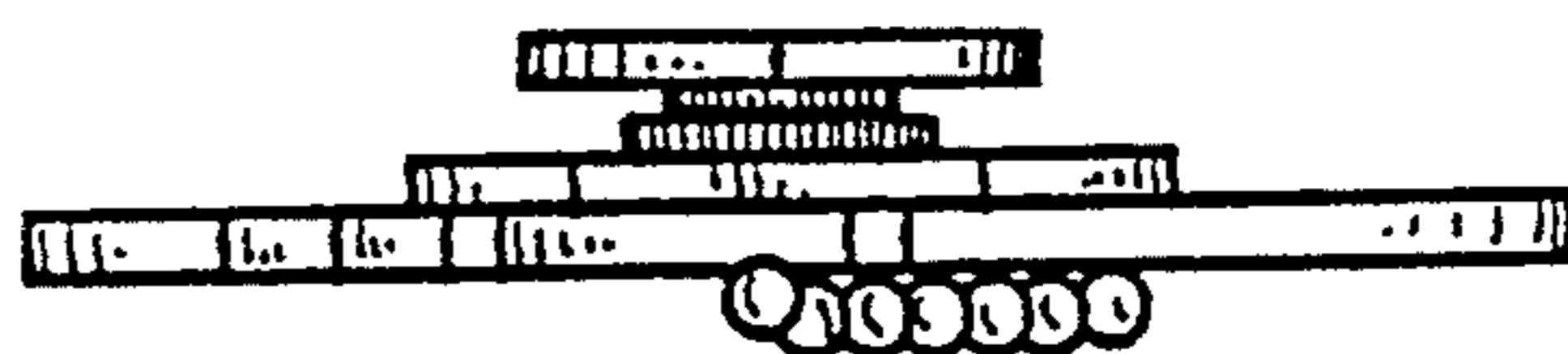

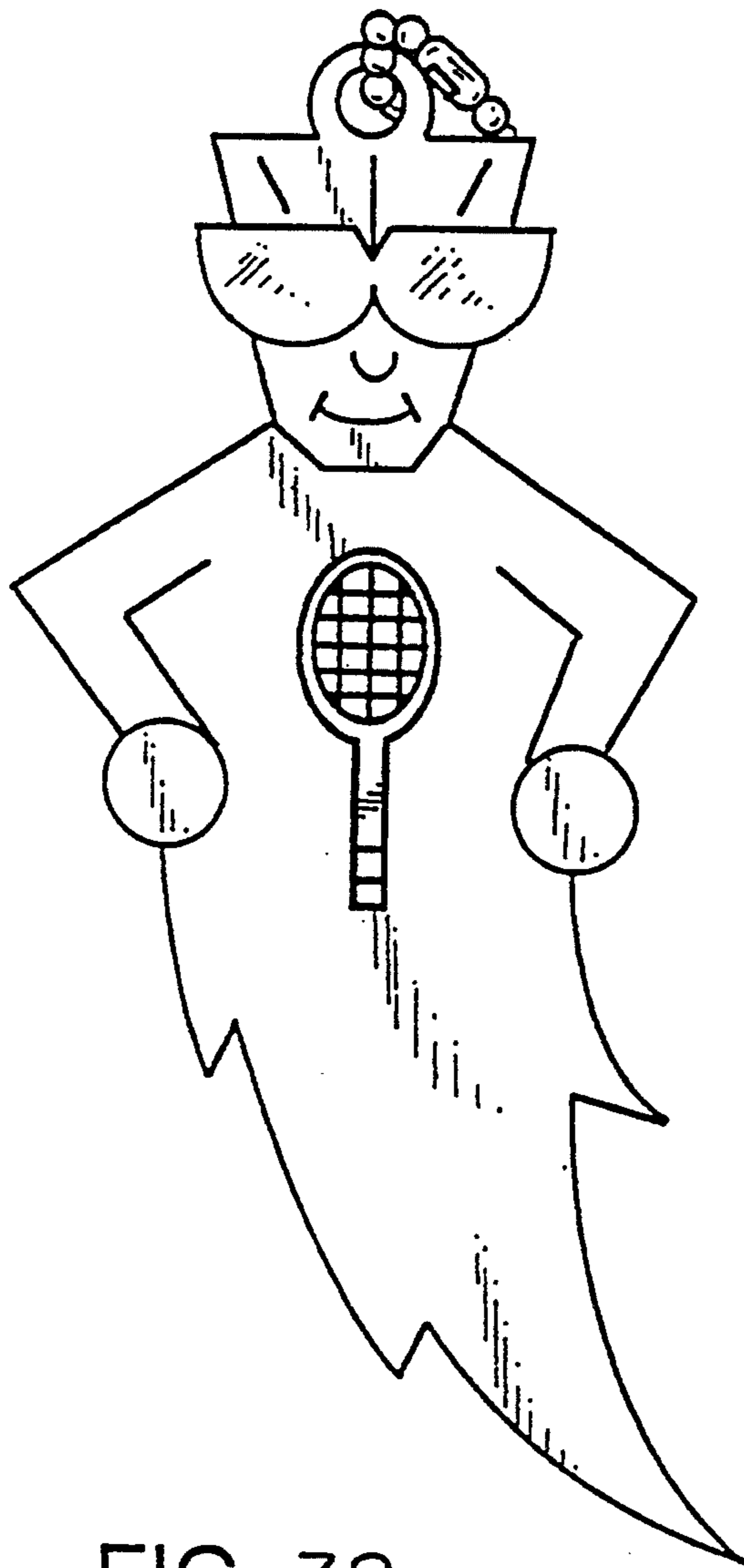

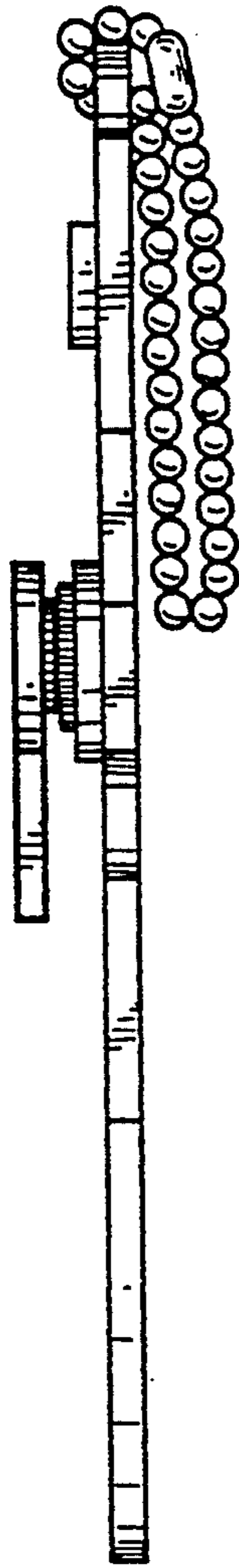
