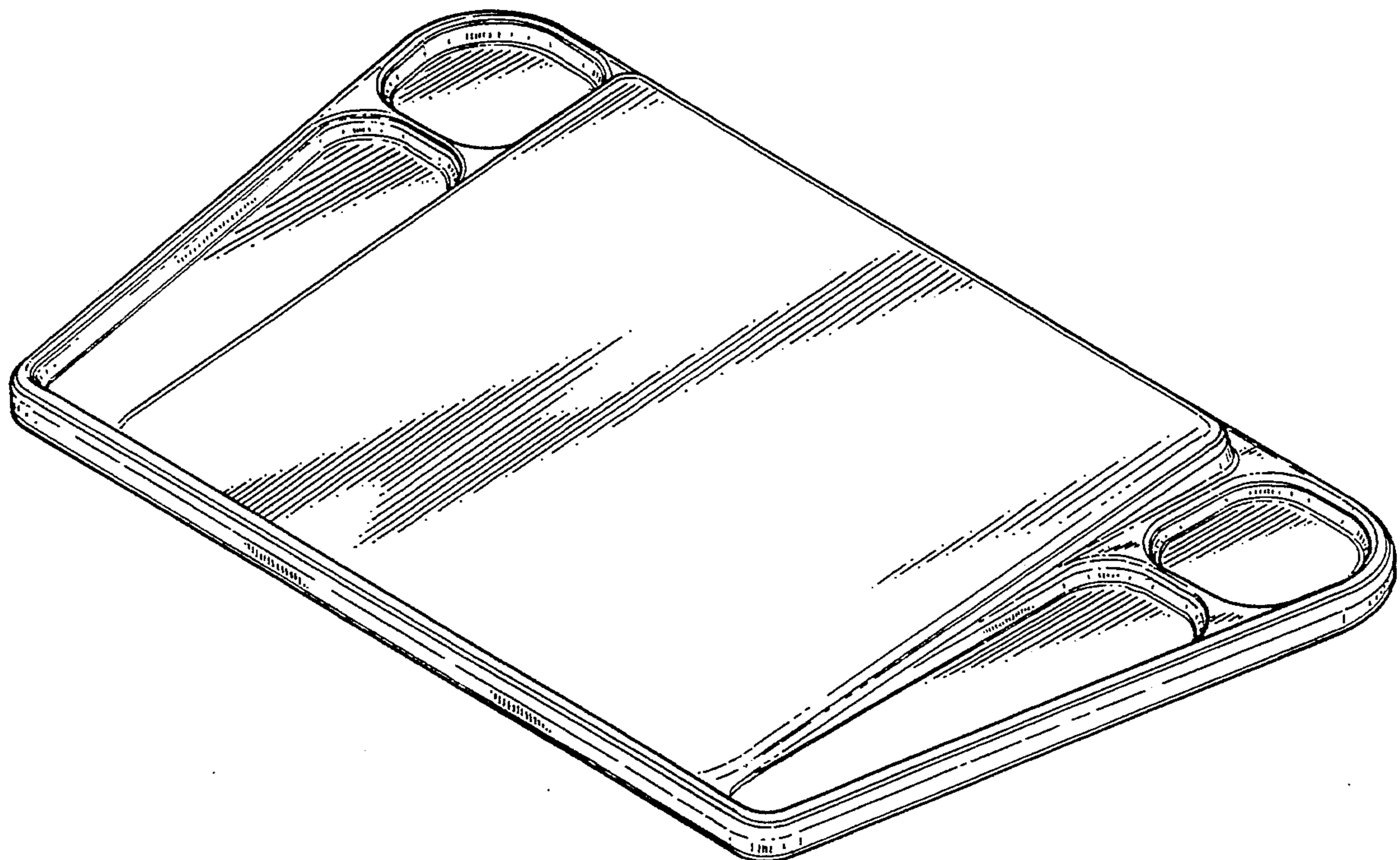
[57] CLAIM

The ornamental design for a portable writing board, as shown and described.

DESCRIPTION

FIG. 1 is a top right front perspective view of a portable writing board showing our new design; FIG. 2 is a front elevational view thereof; FIG. 3 is a rear elevational view thereof; FIG. 4 is a top plan view thereof; FIG. 5 is a left side elevational view thereof; the right side elevational view being a mirror image; and, FIG. 6 is a bottom plan view thereof.

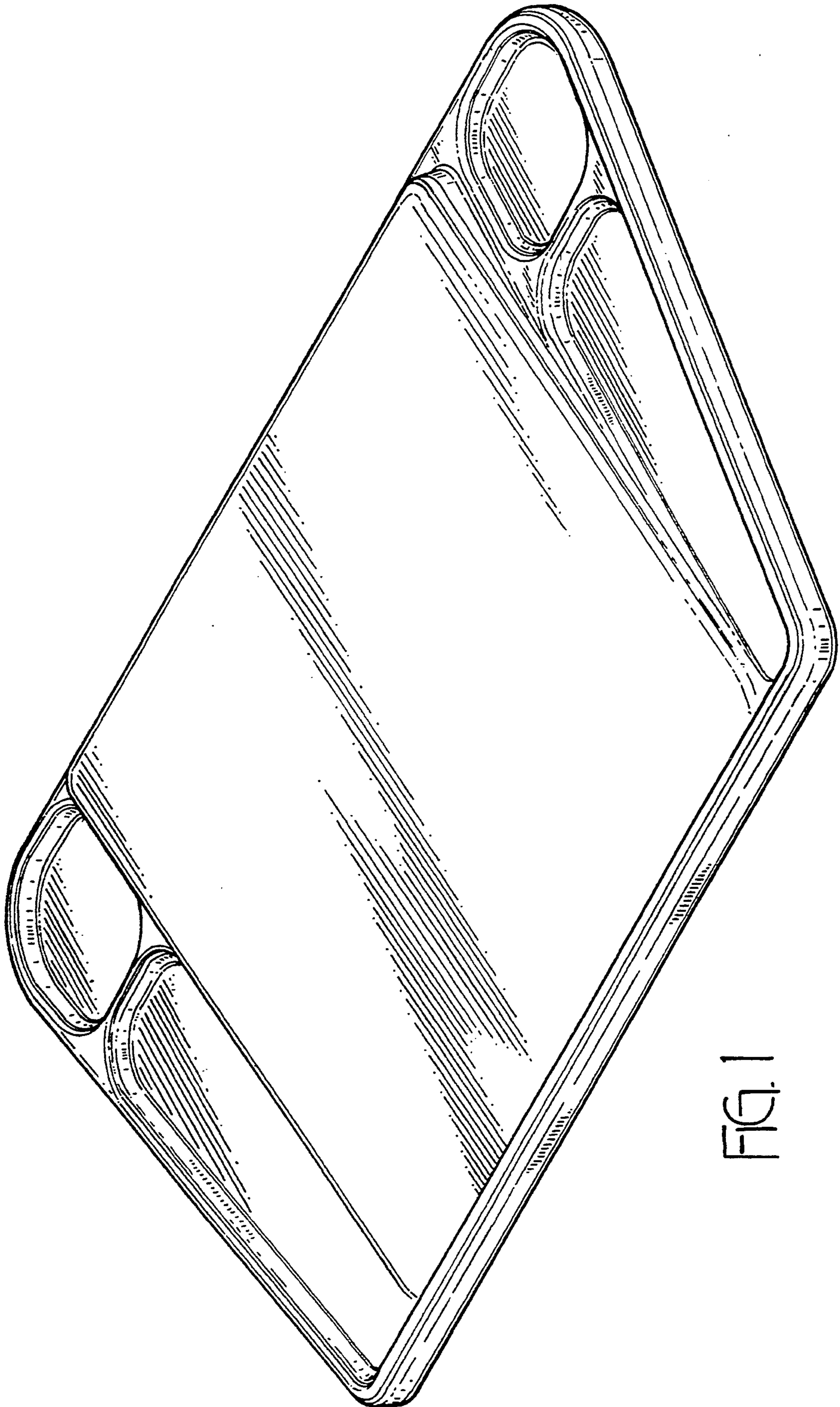

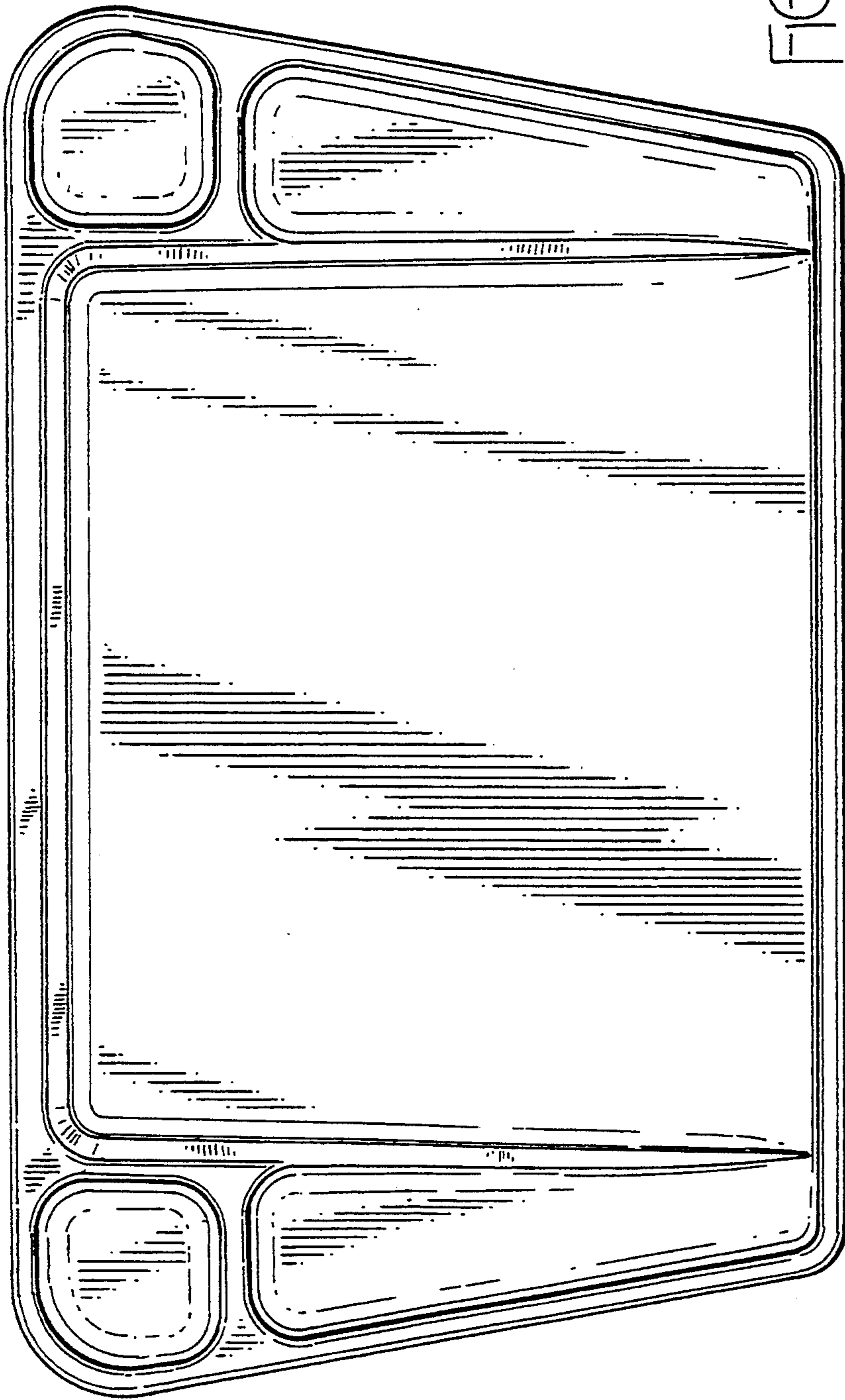

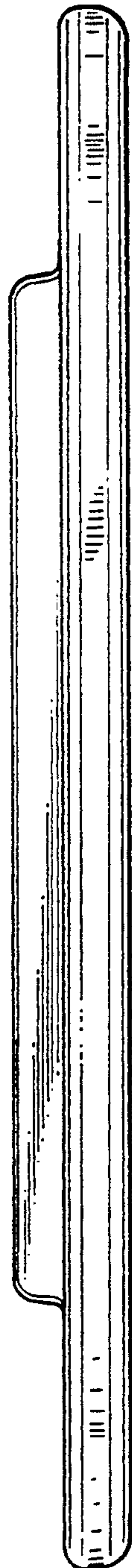

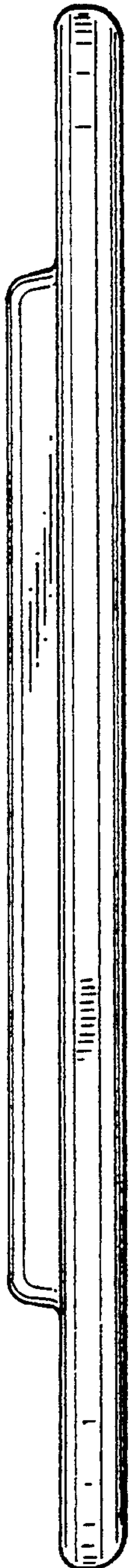

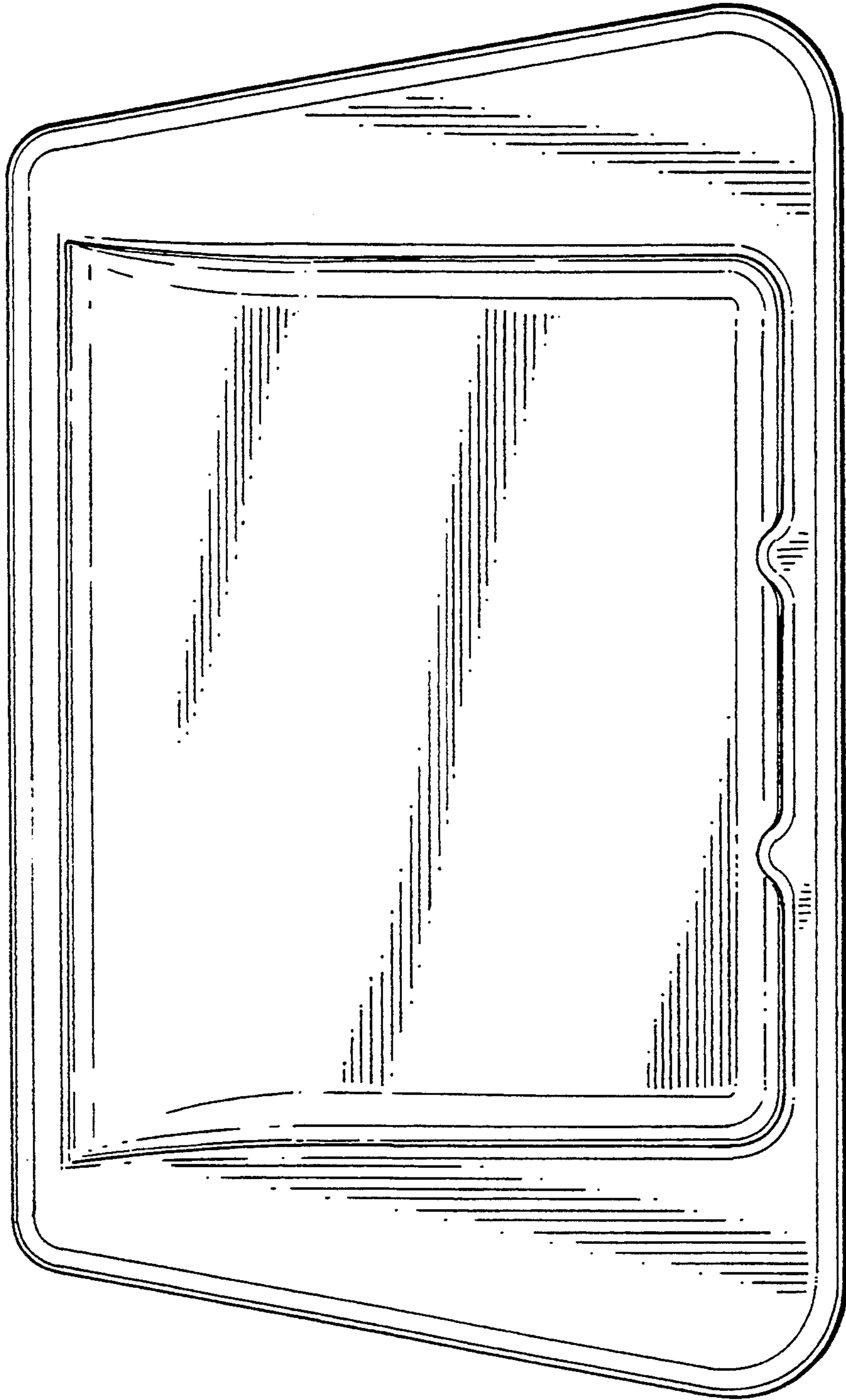

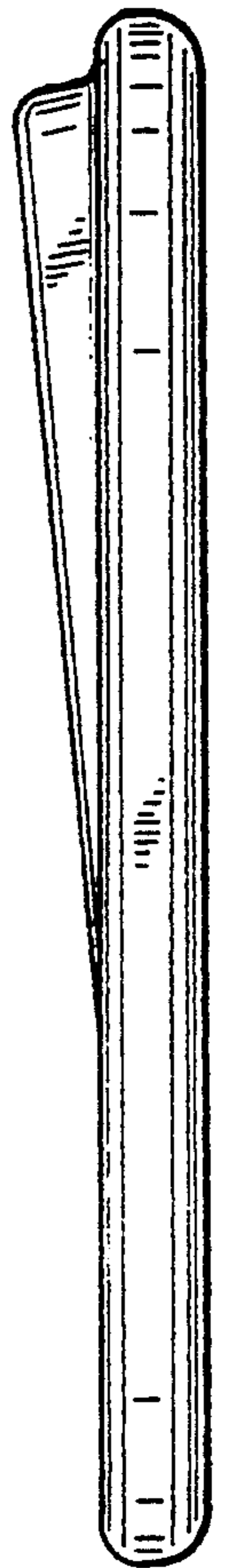
