The ornamental design for a chess set, as shown and described.

**DESCRIPTION**

FIG. 28 is a perspective view of a chess piece representing the pawn;

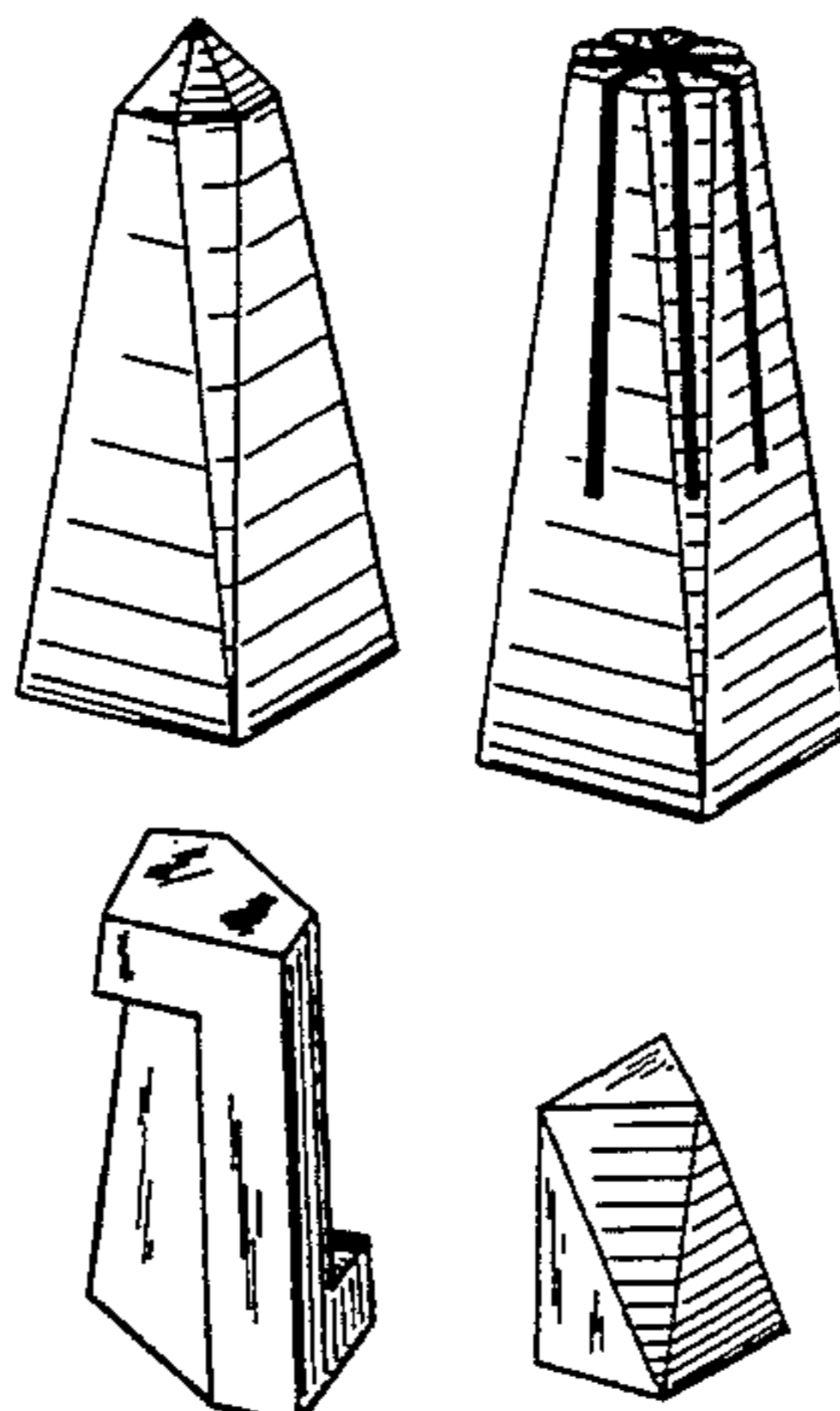
FIG. 29 is a front view of the pawn chess piece of FIG. 28;

FIG. 33 is a side view of the pawn chess piece of FIG. 28.



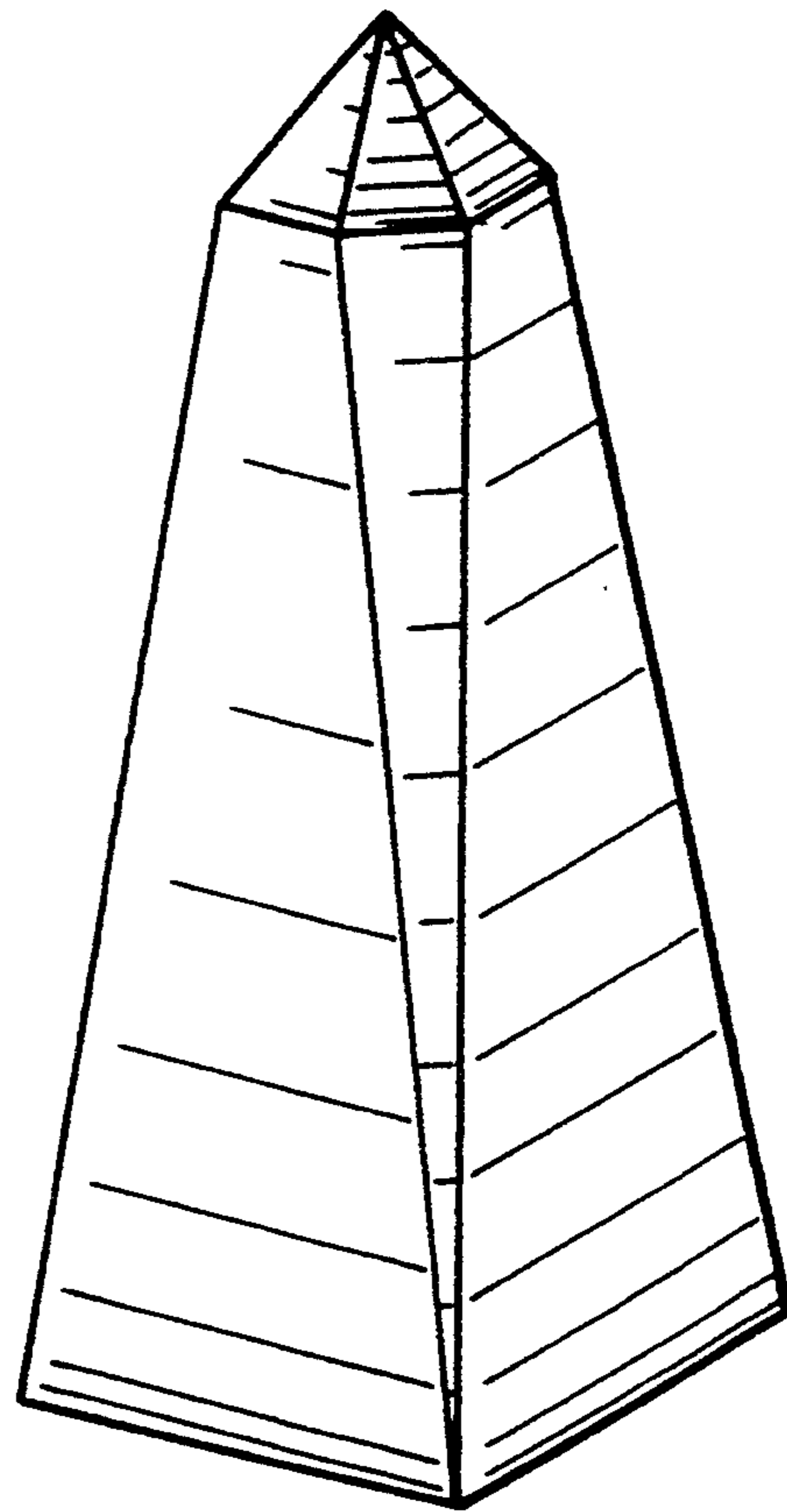

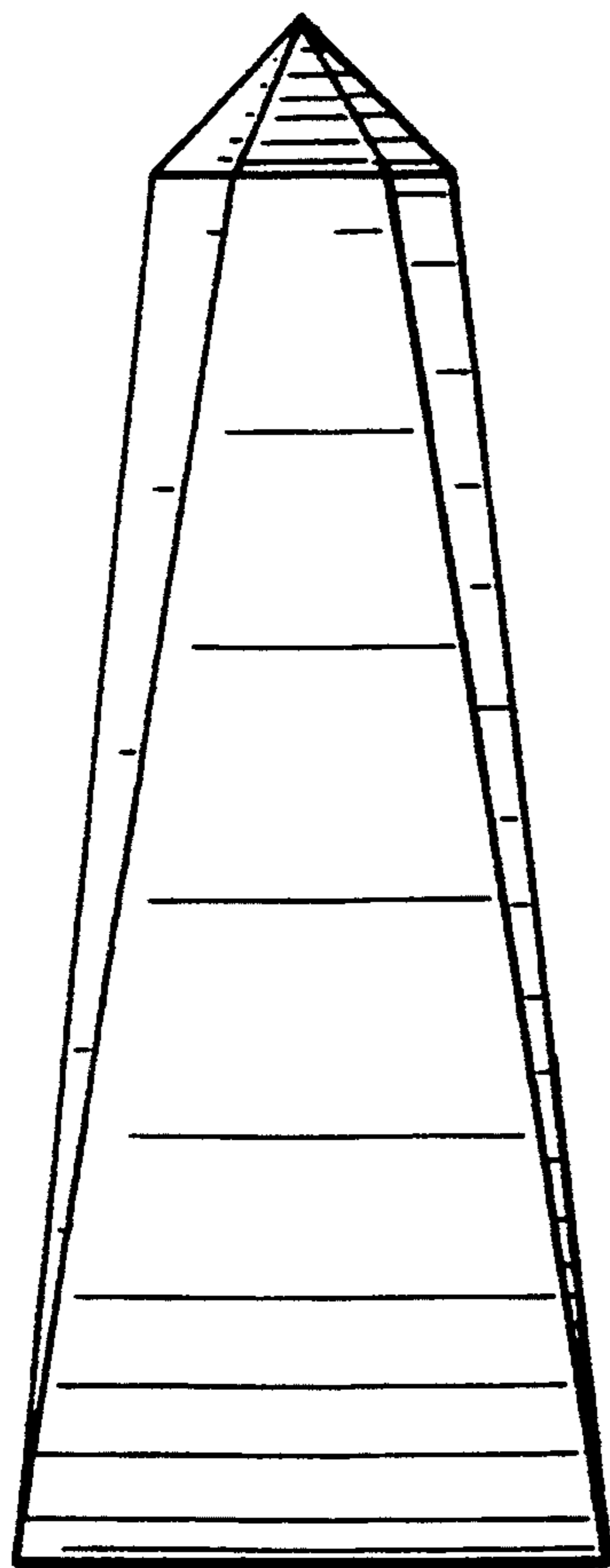

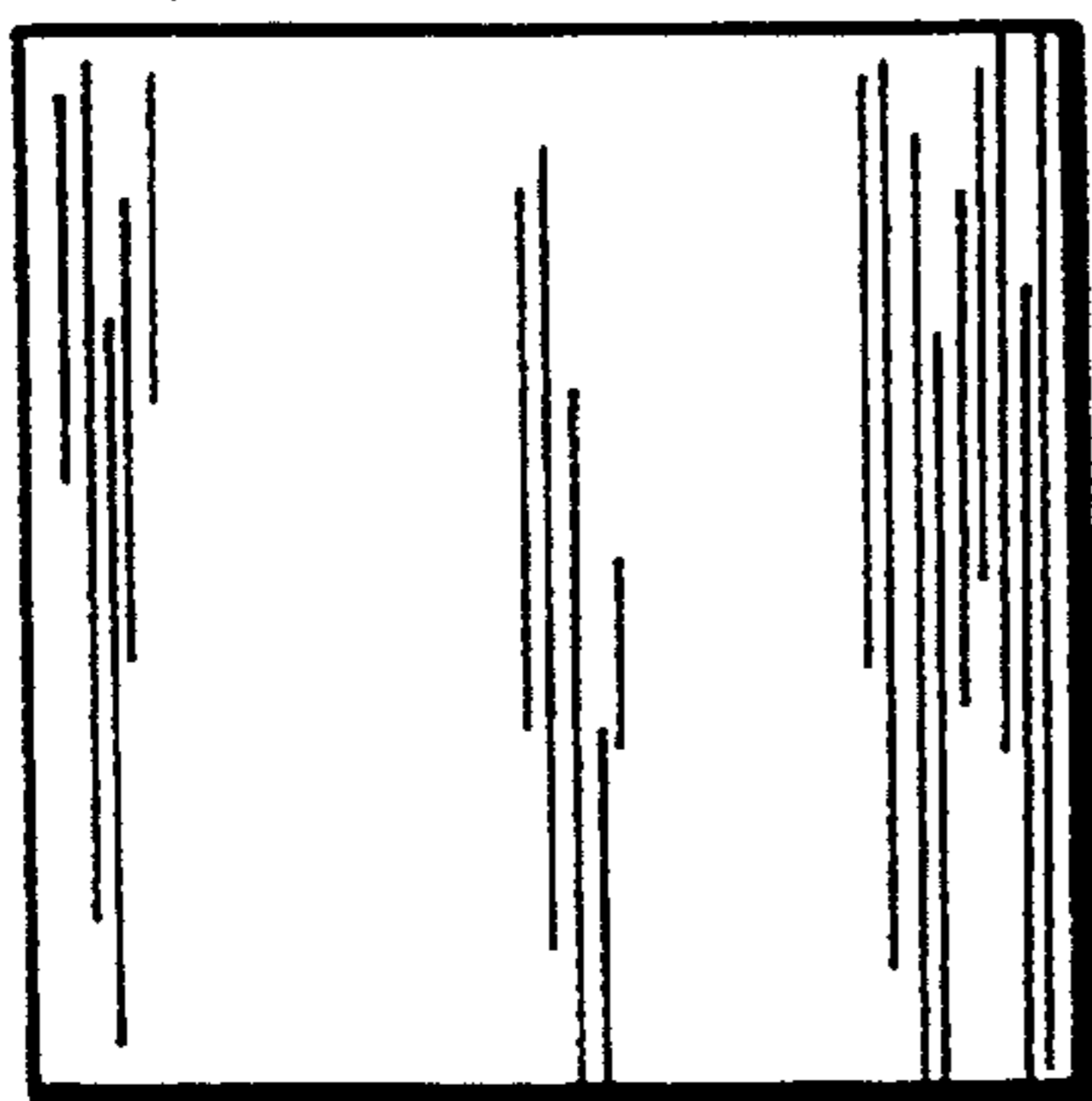

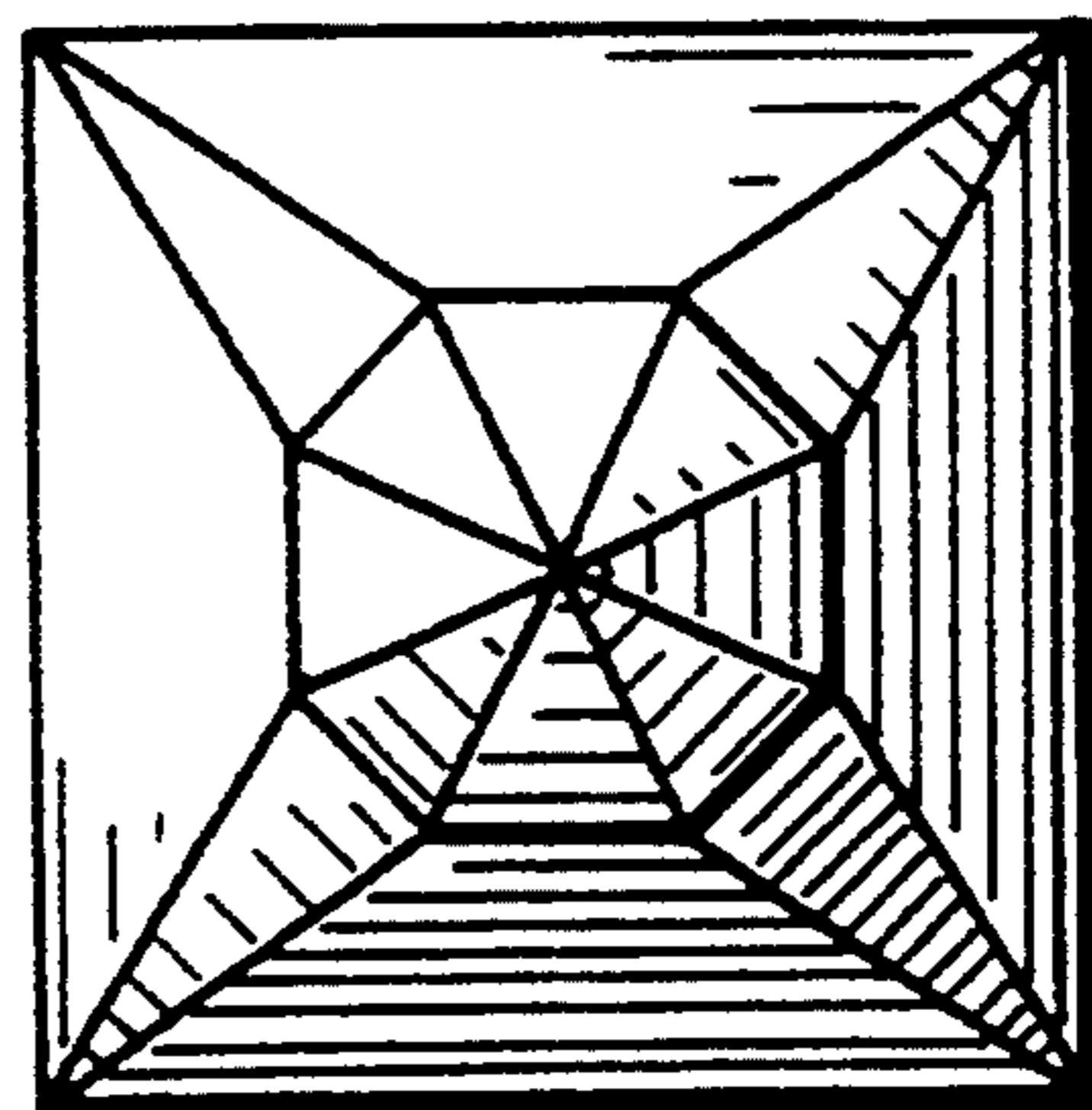

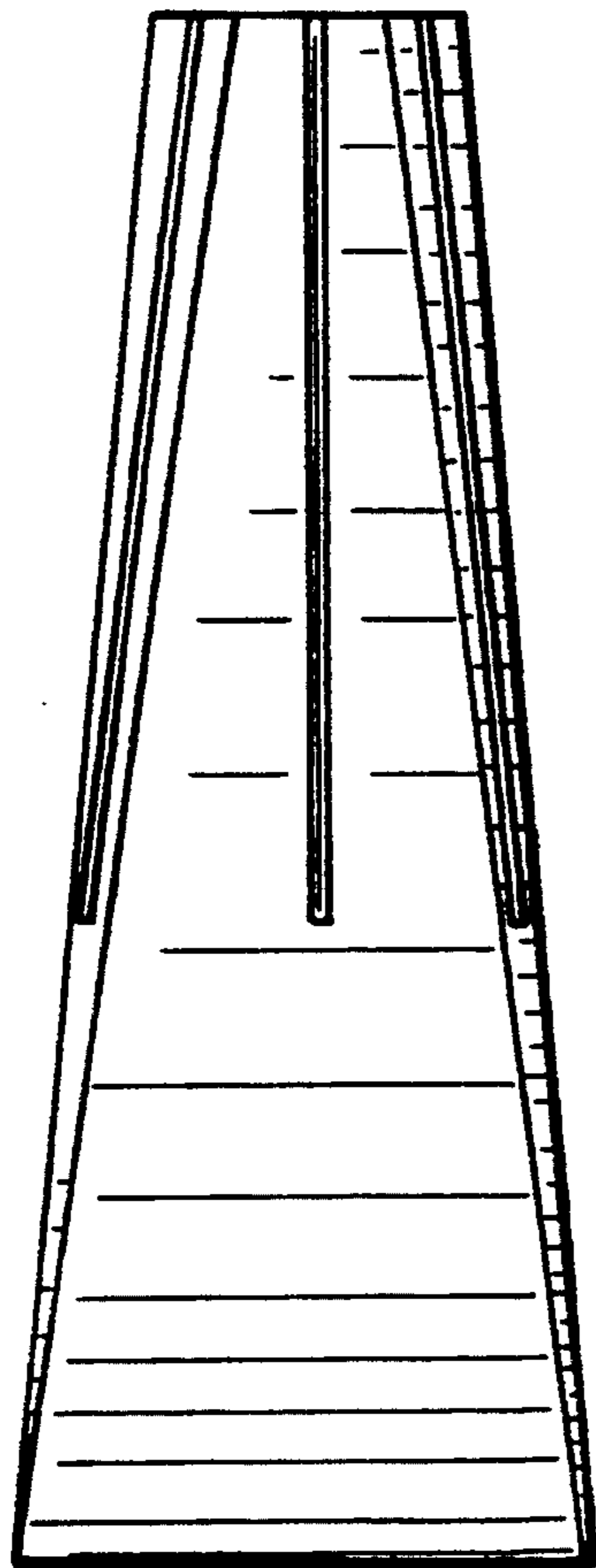

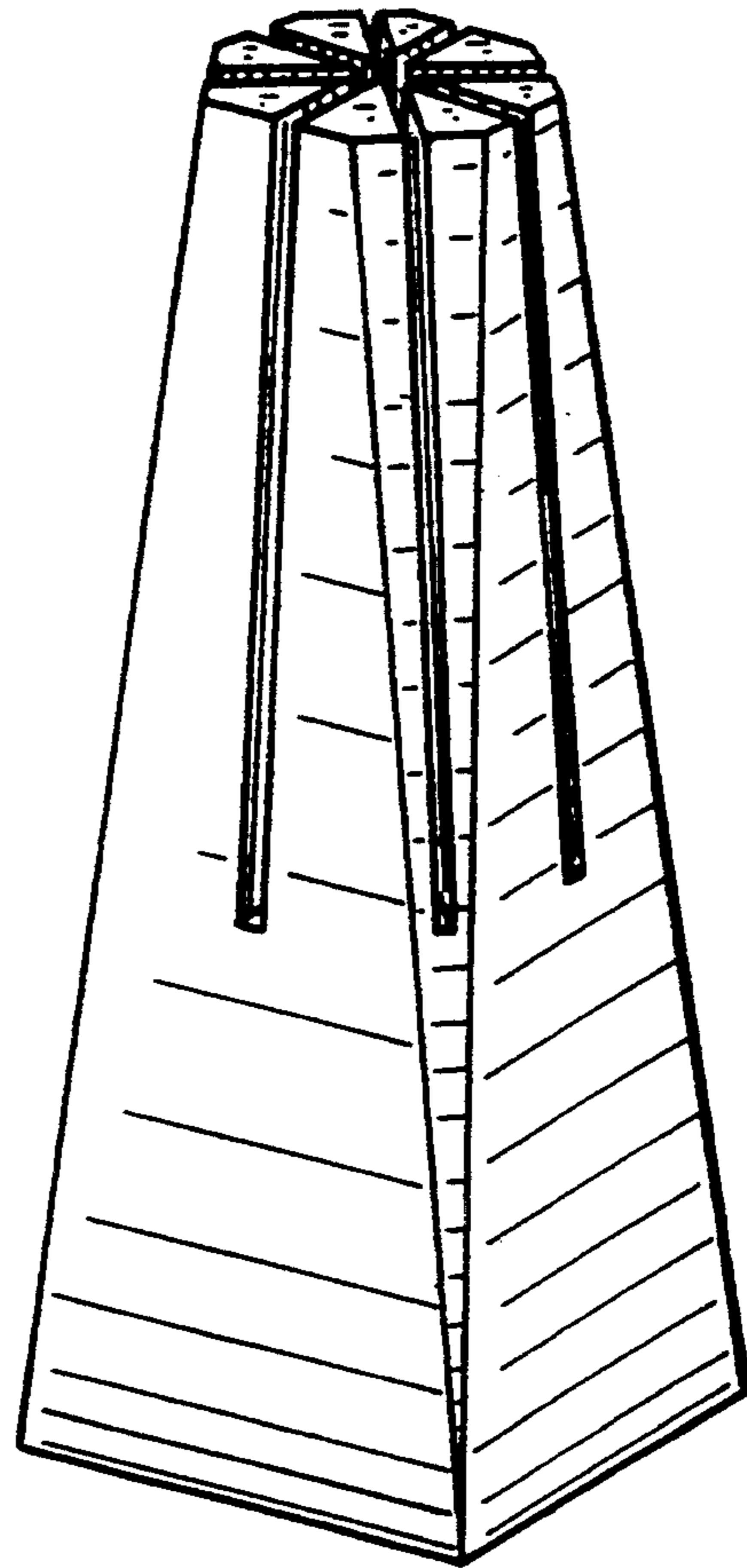

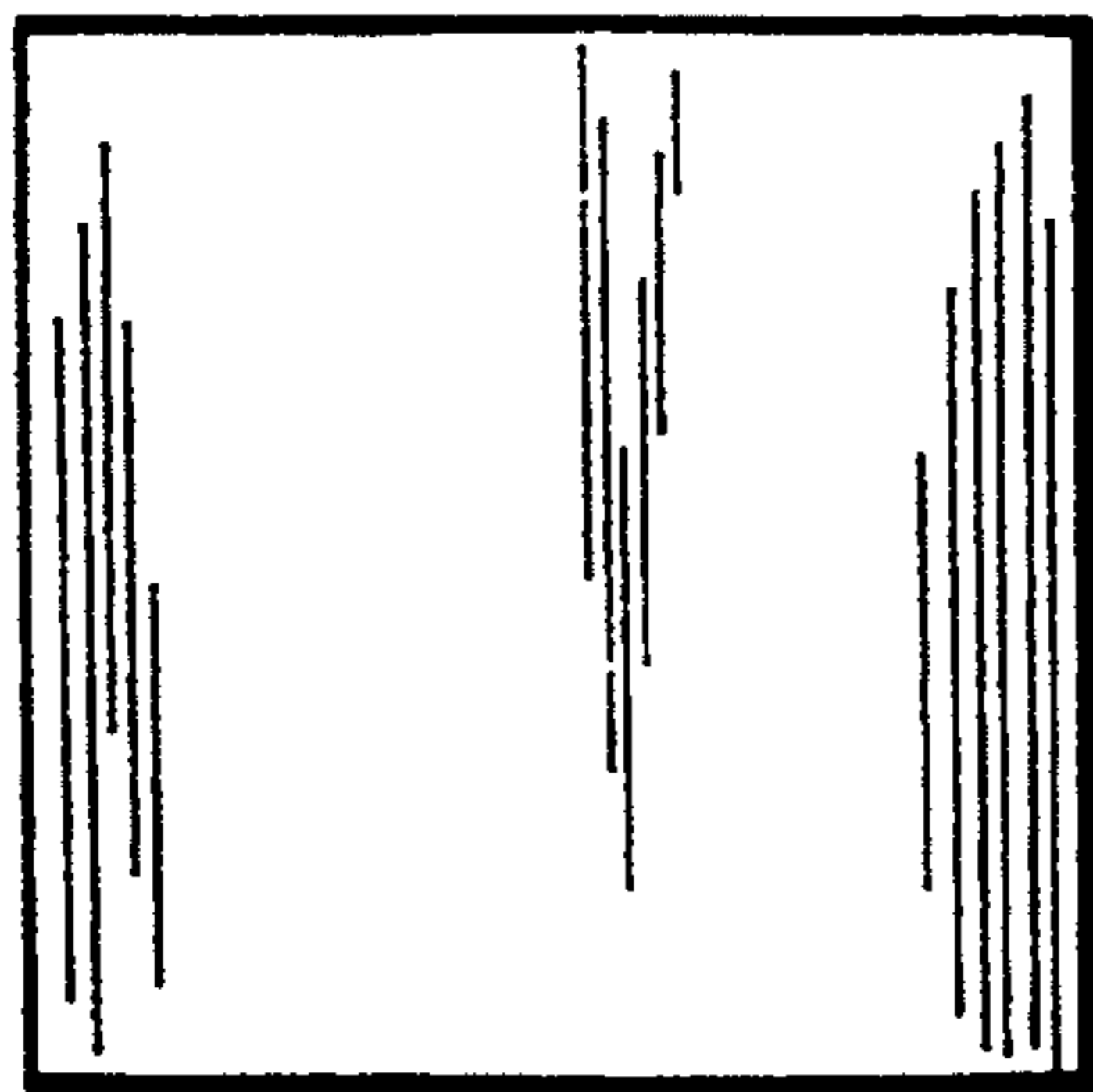

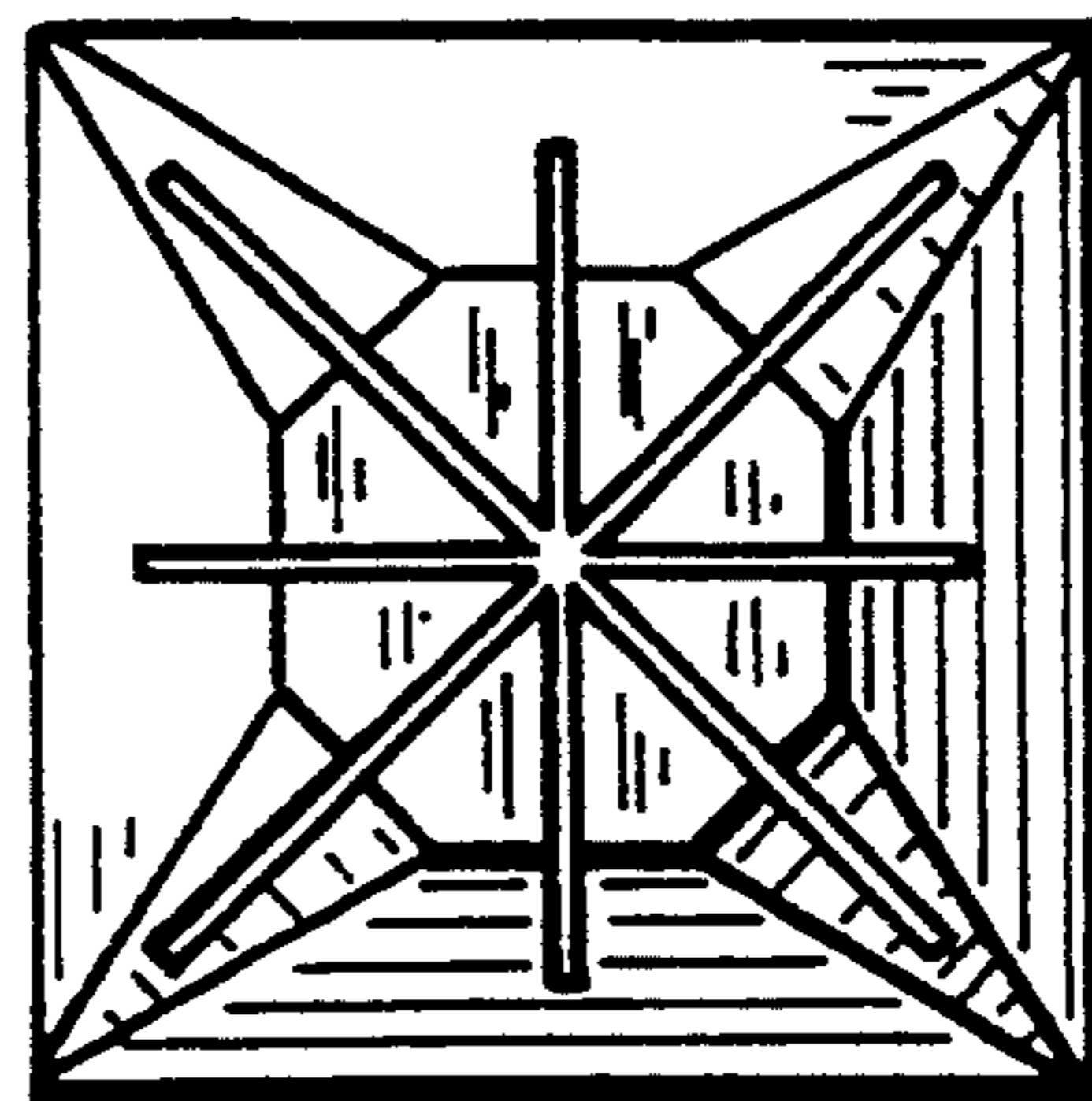

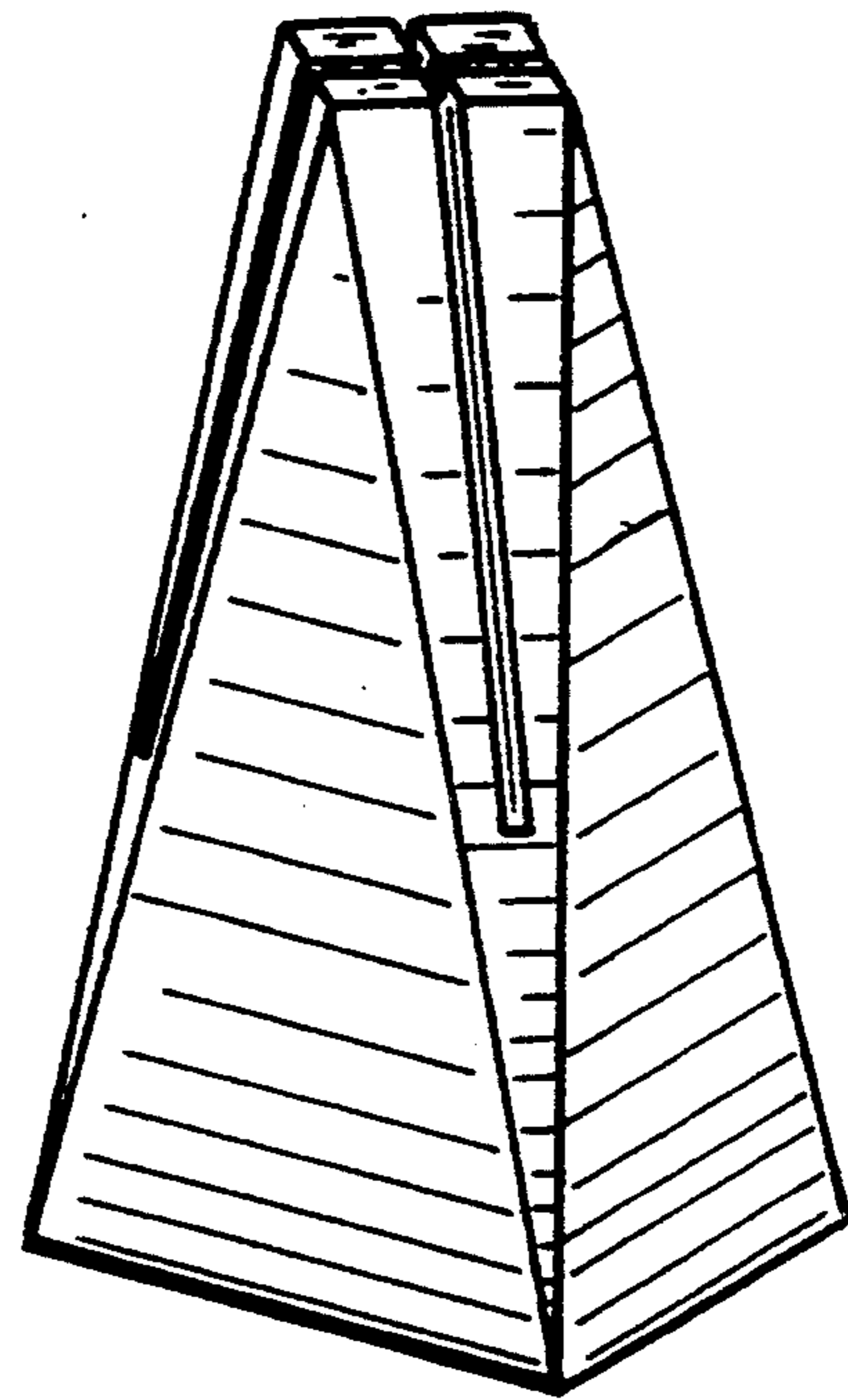

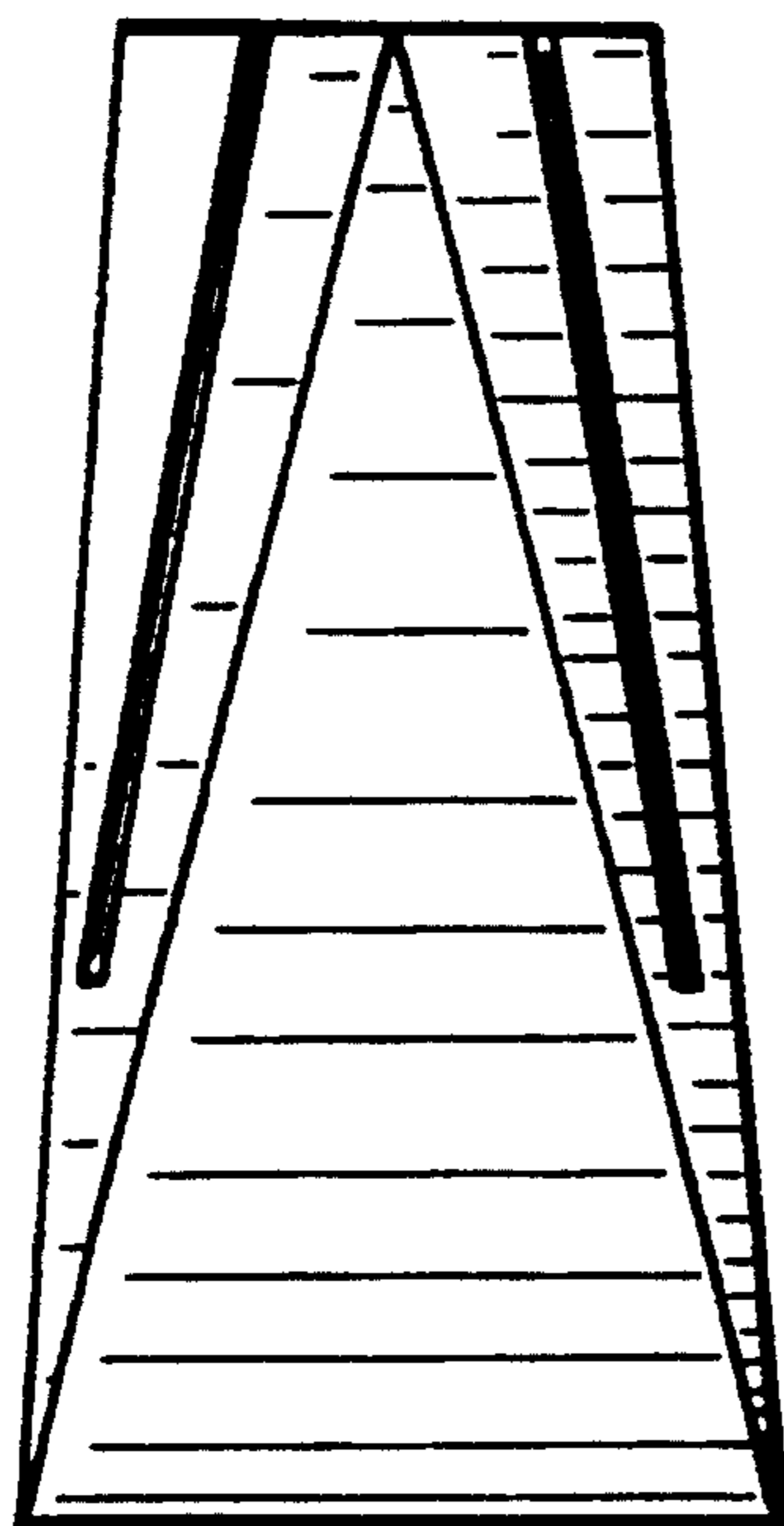

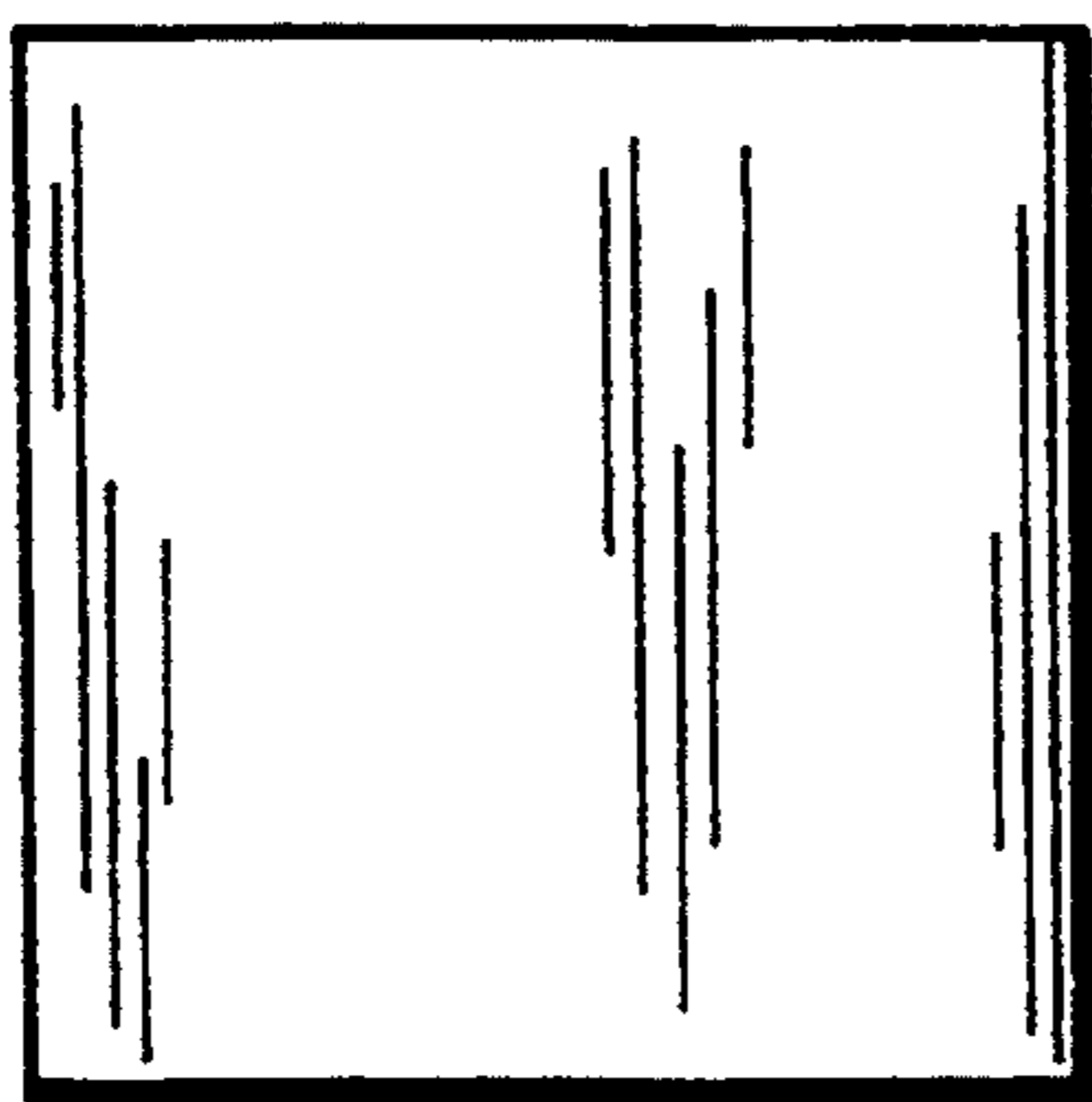

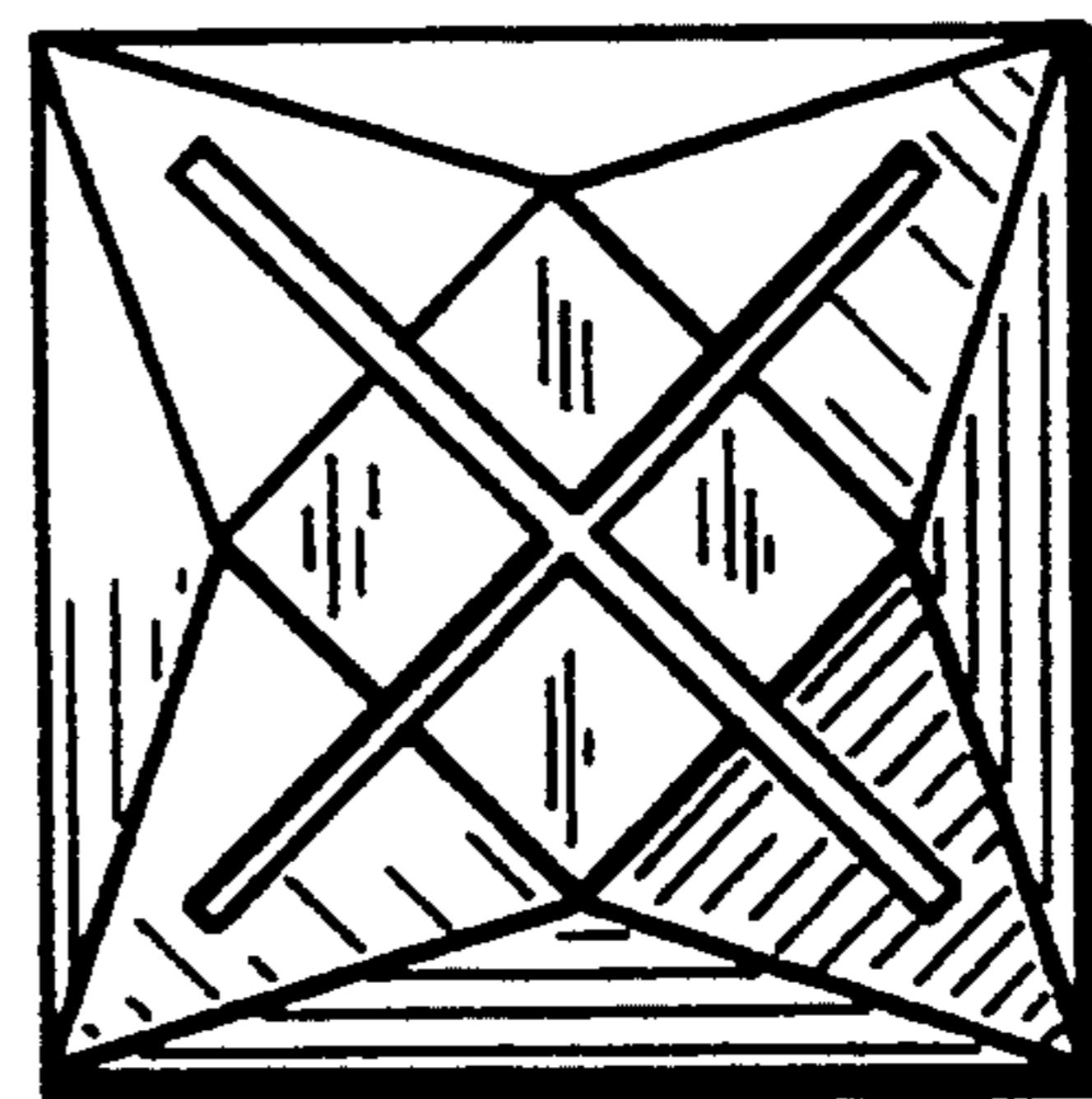

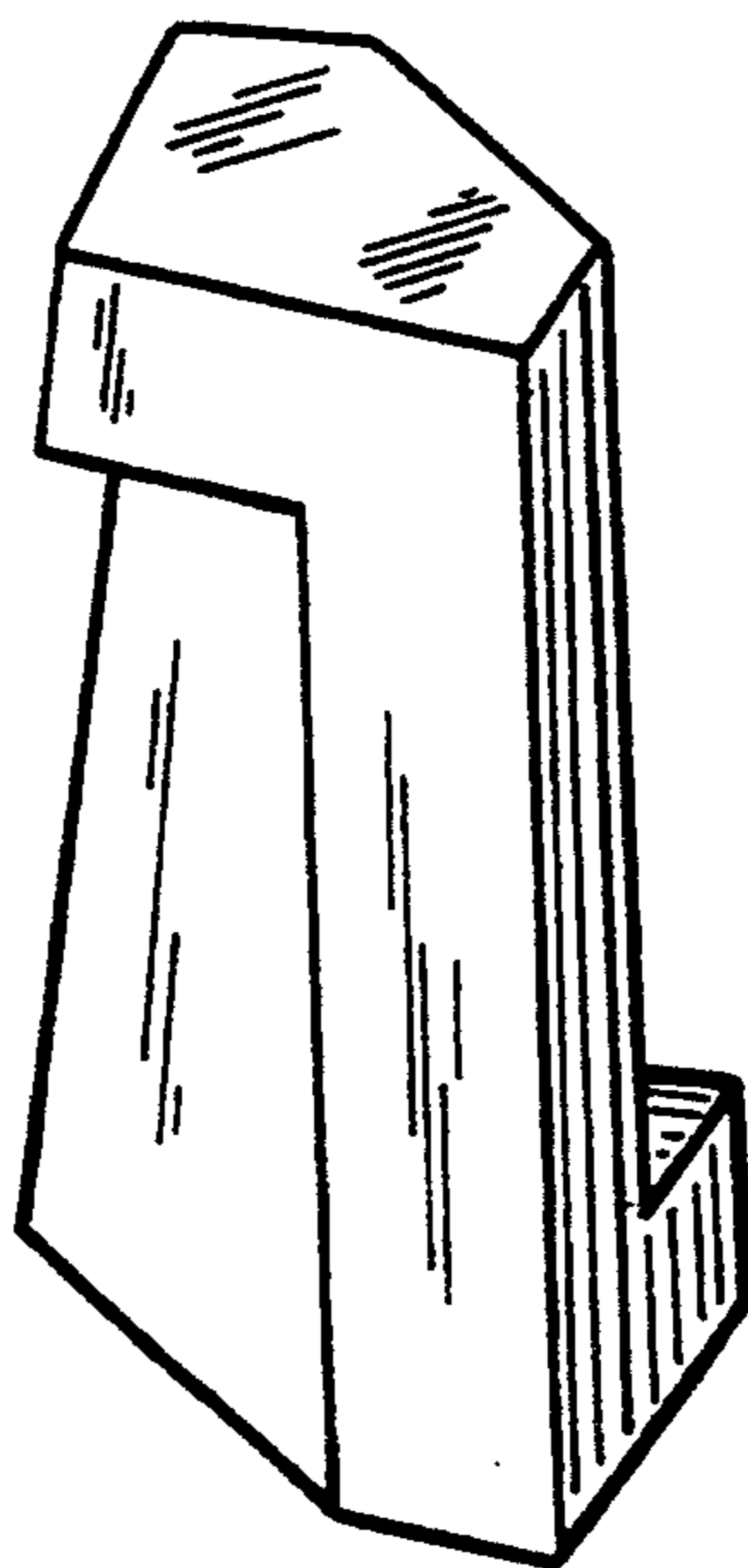

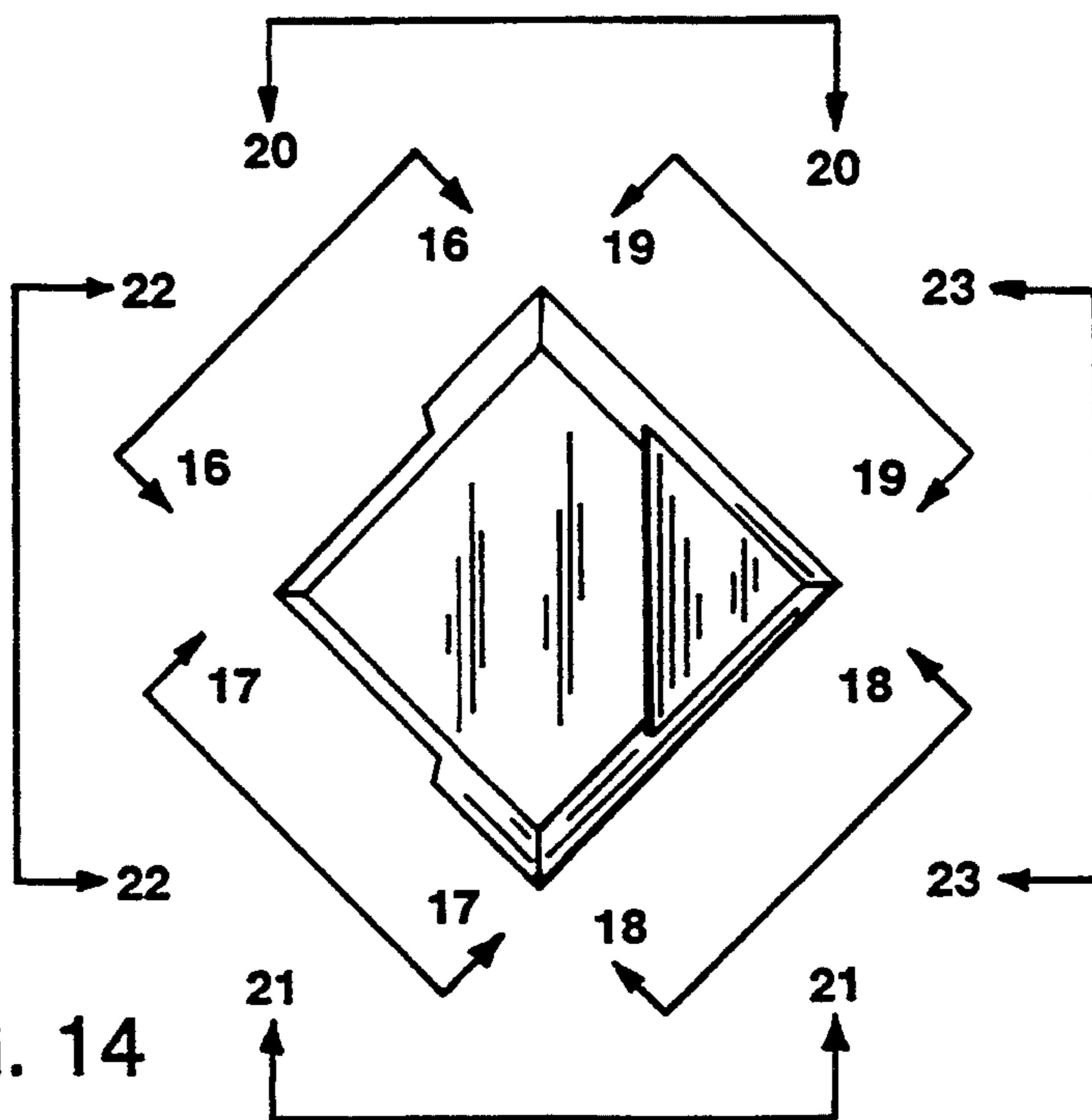

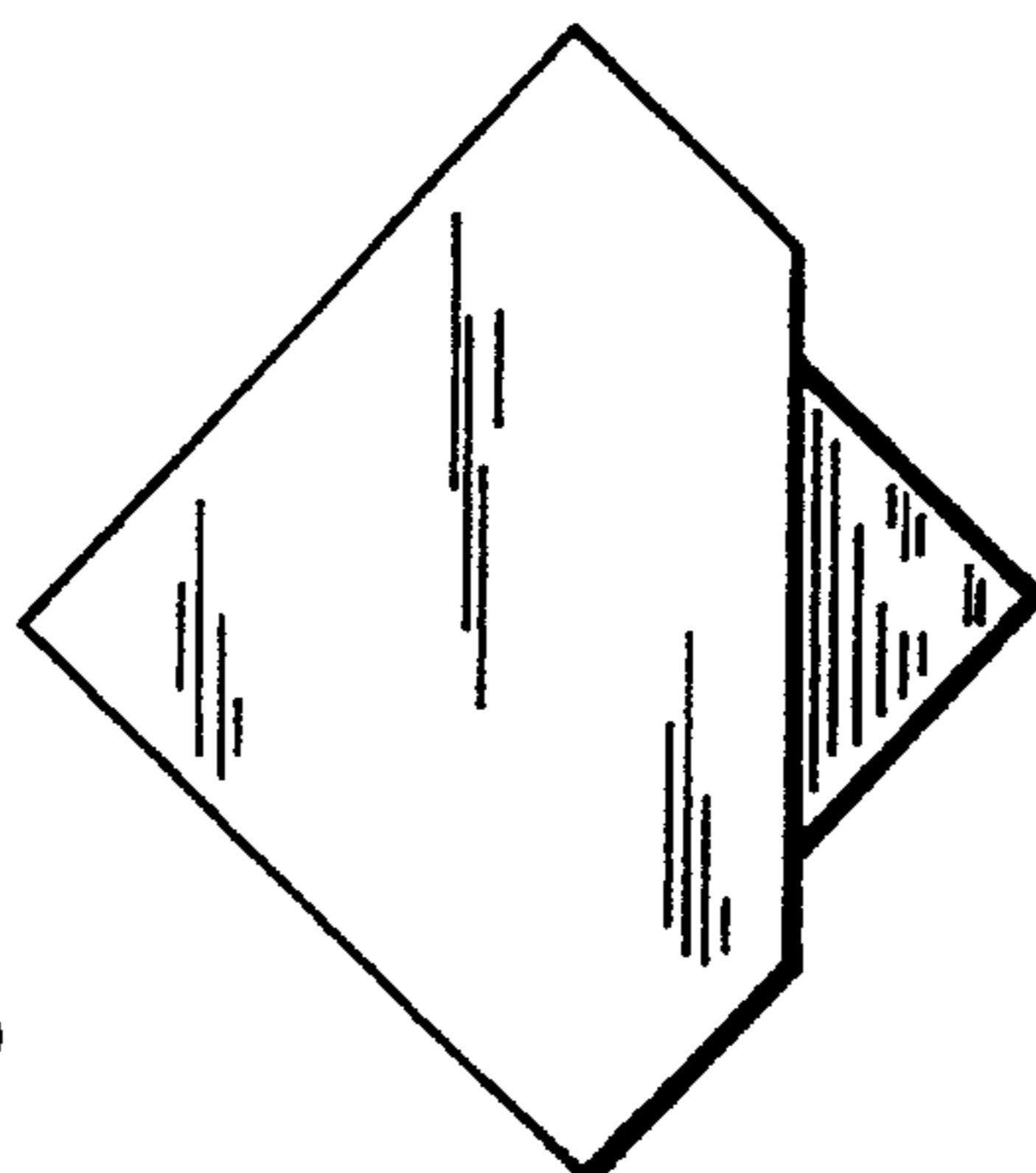

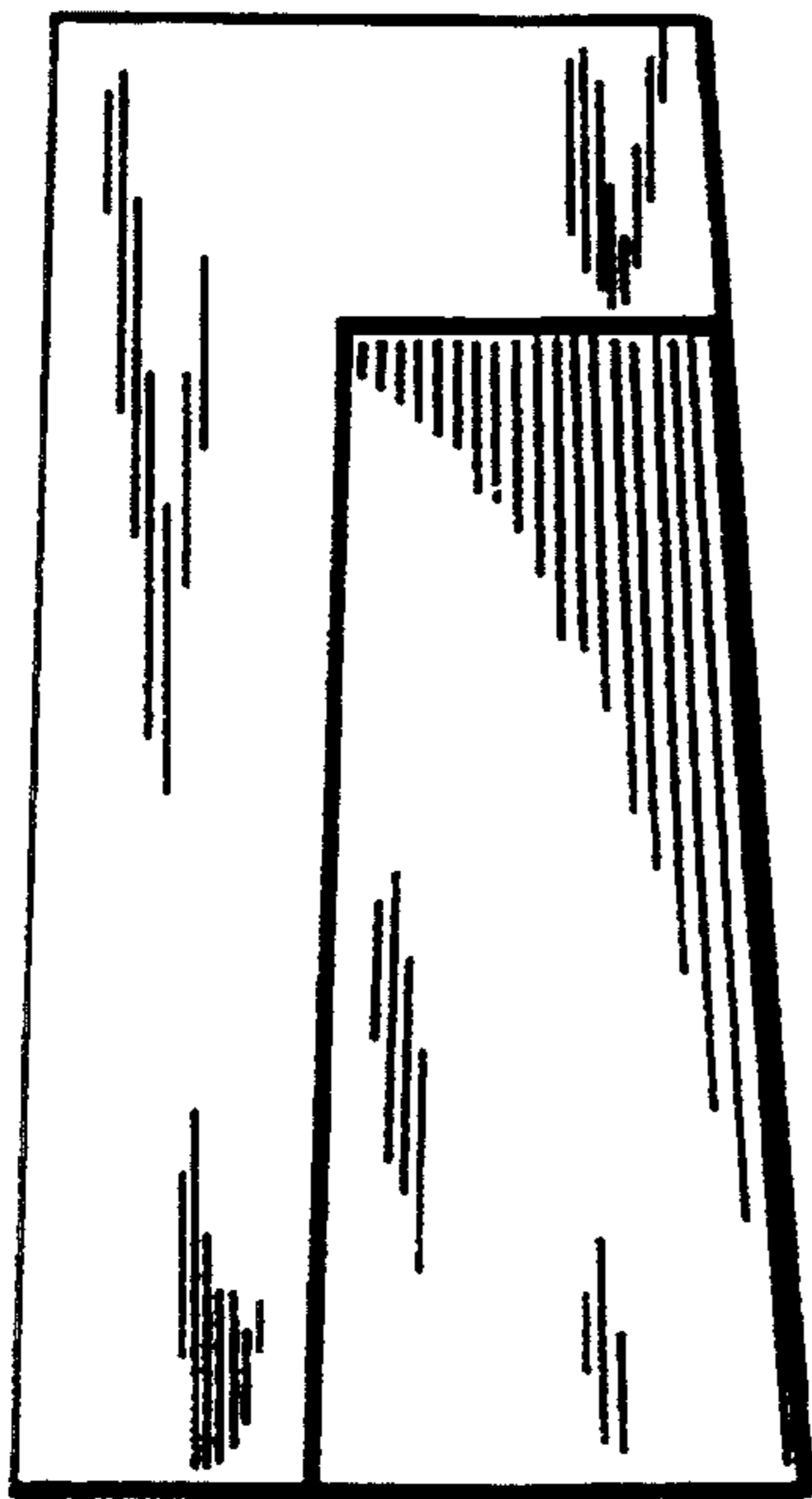

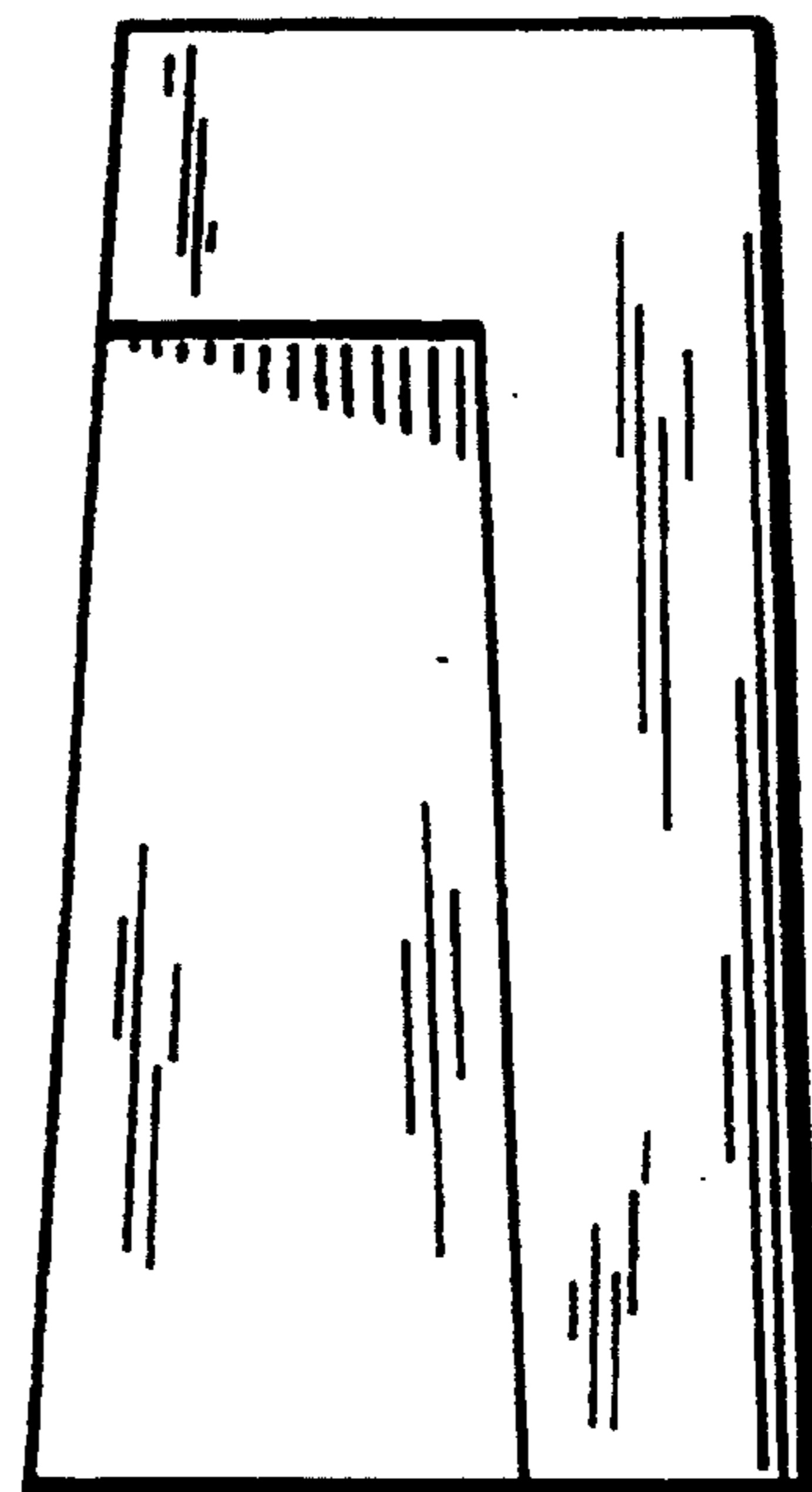

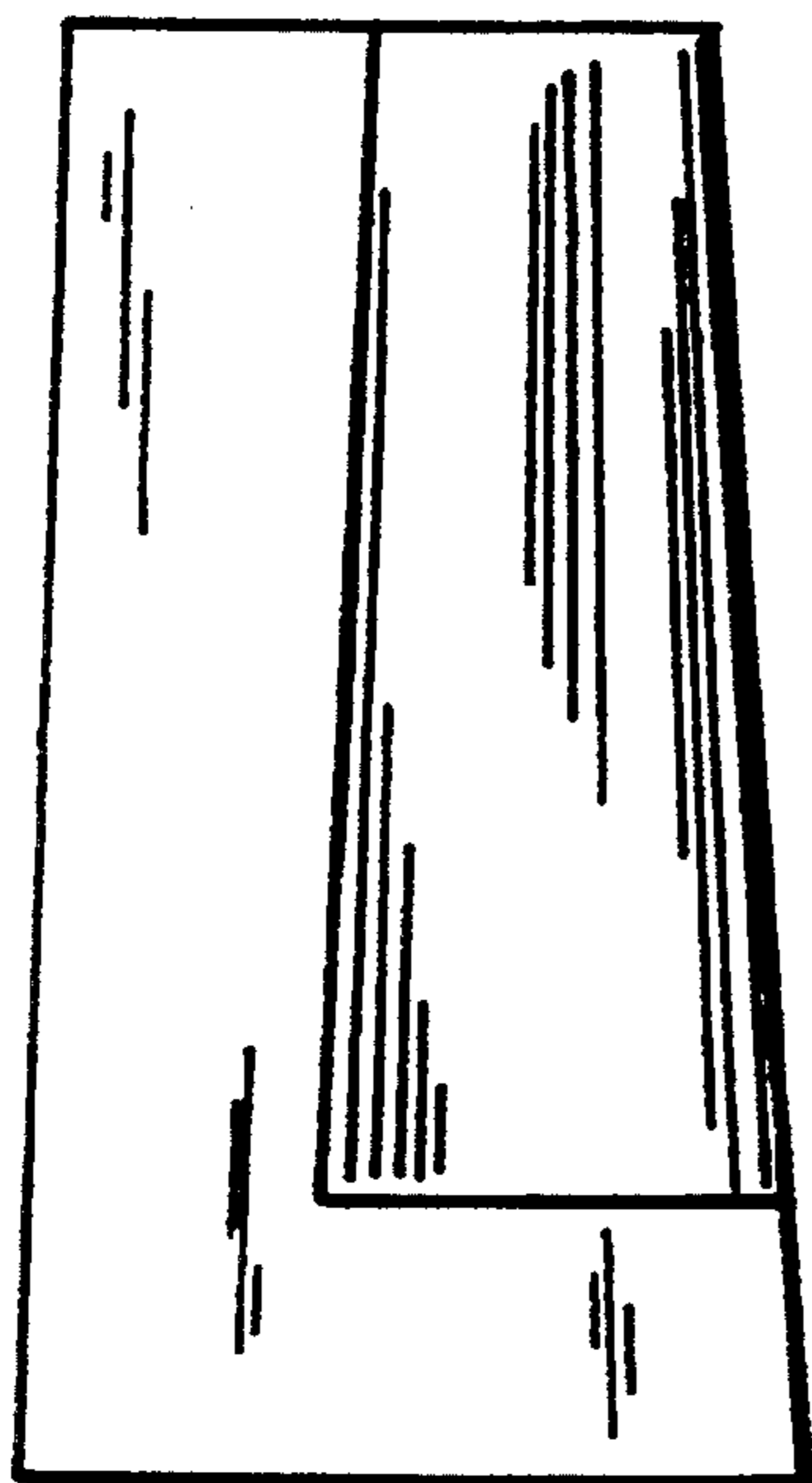

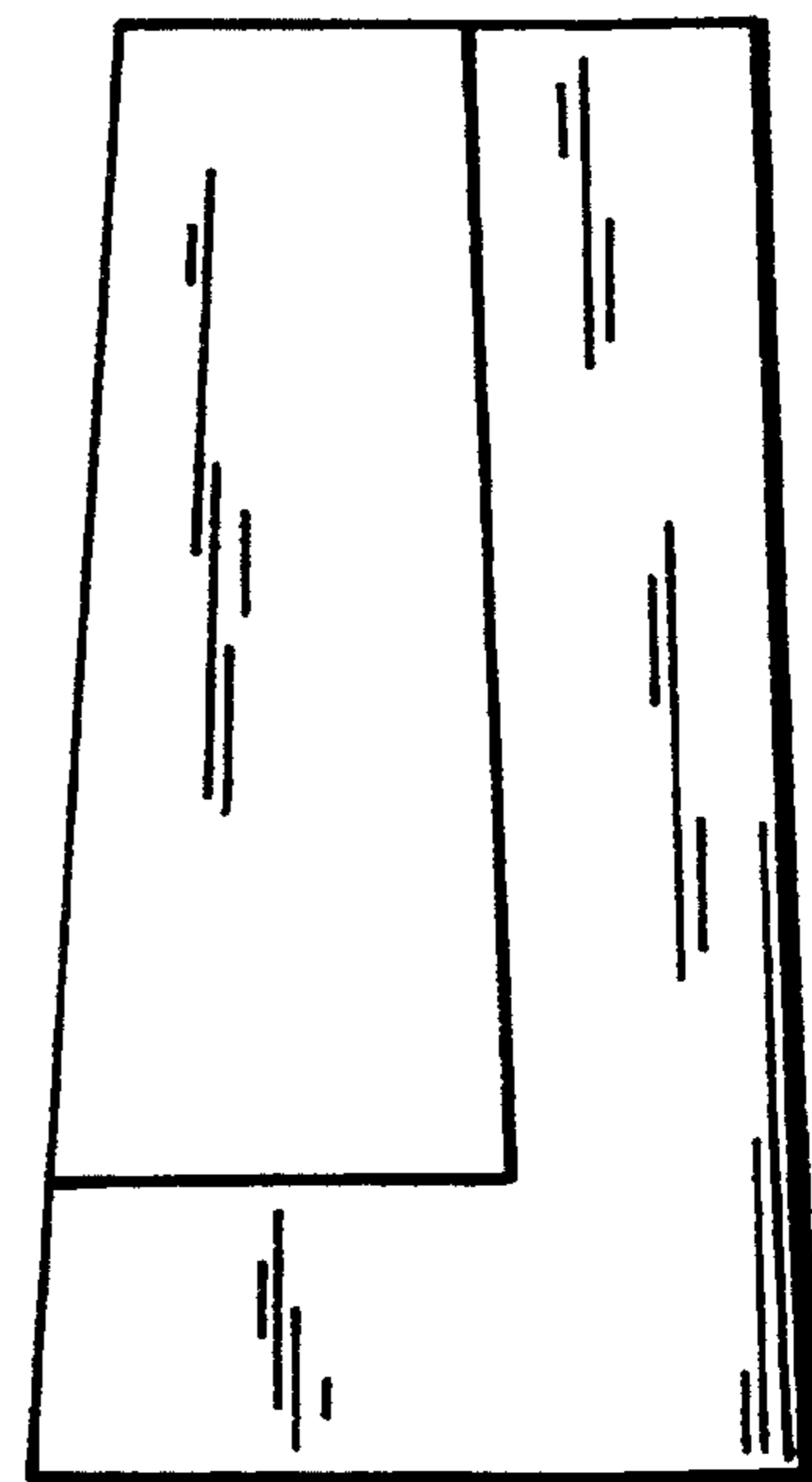

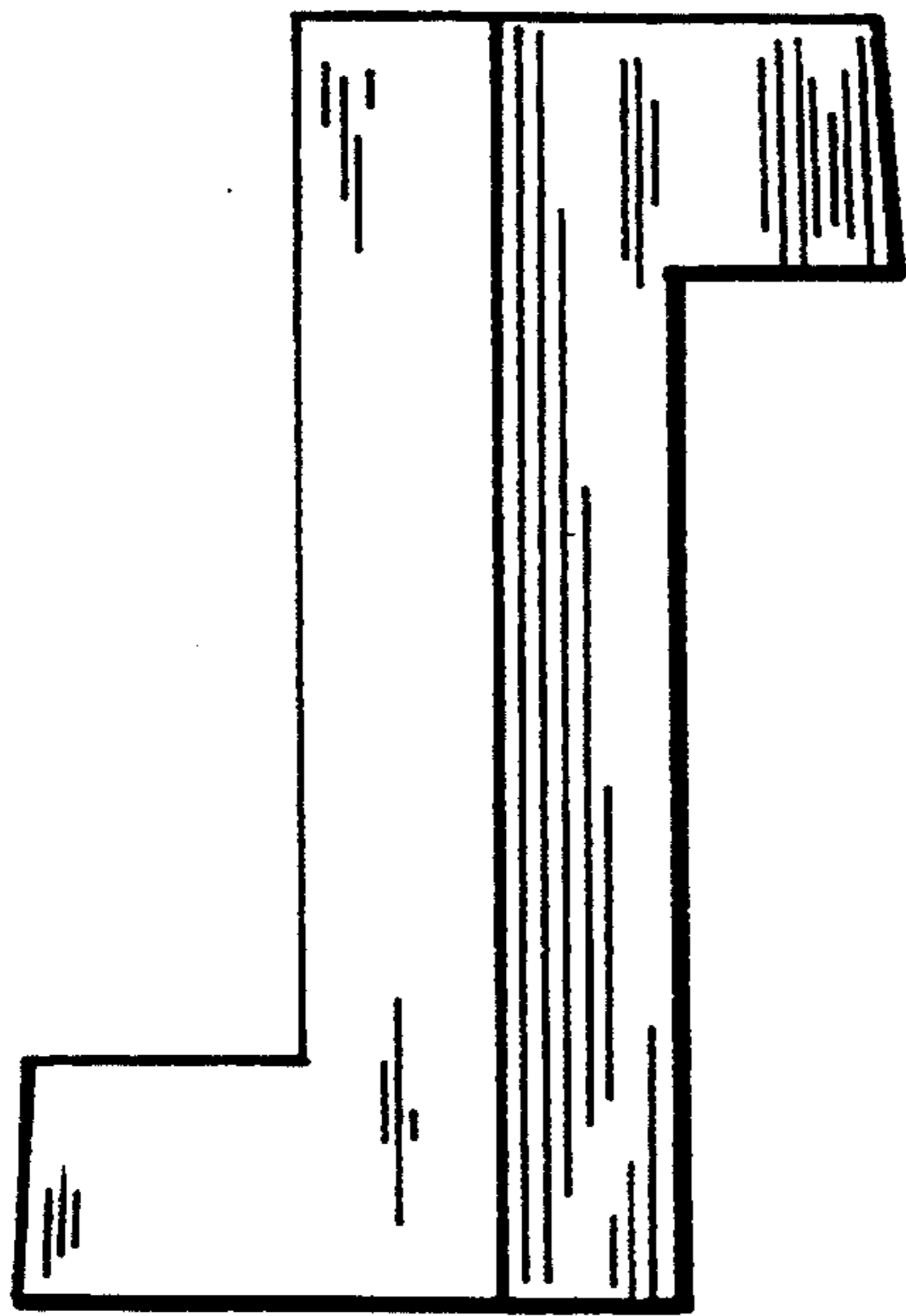

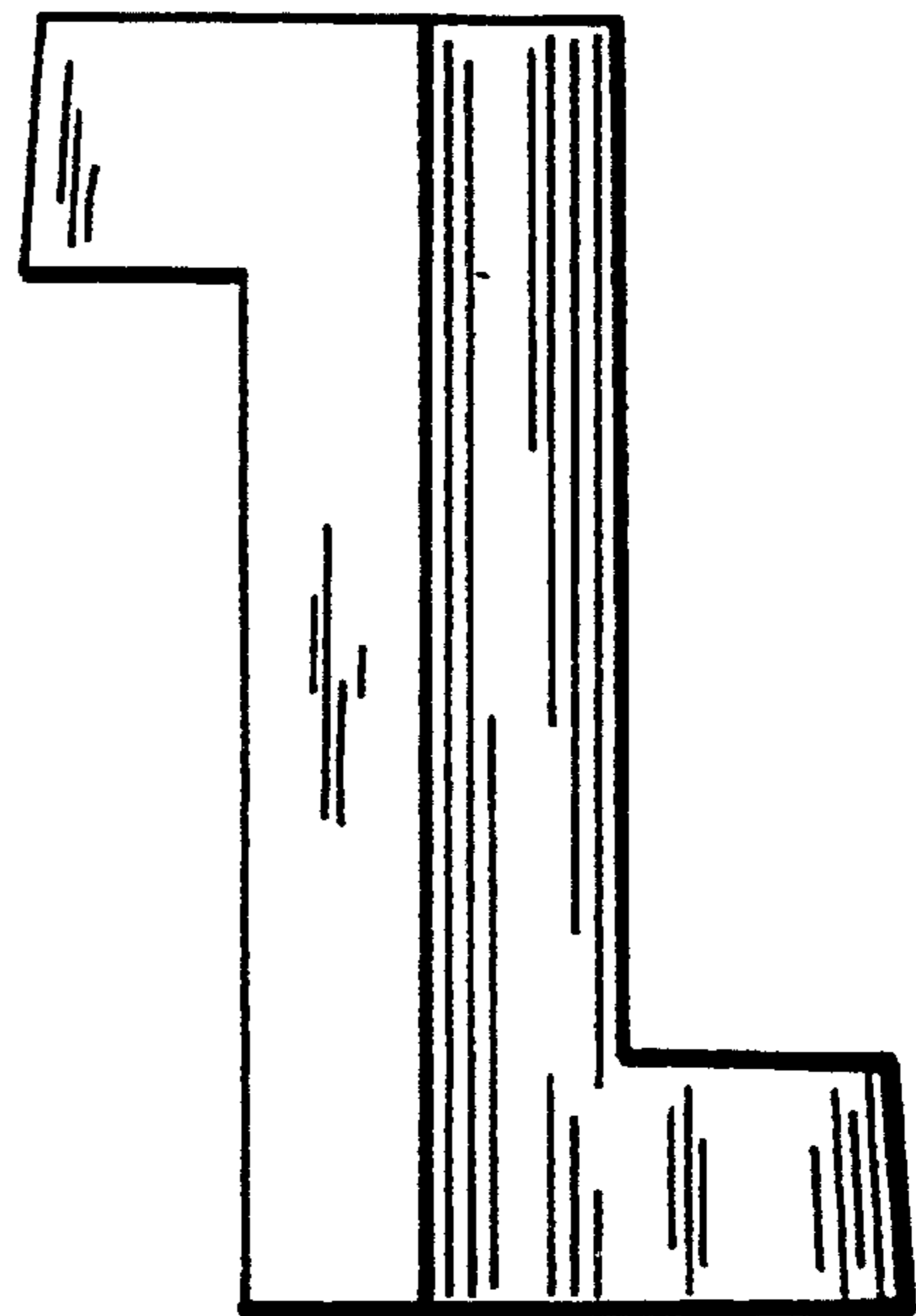

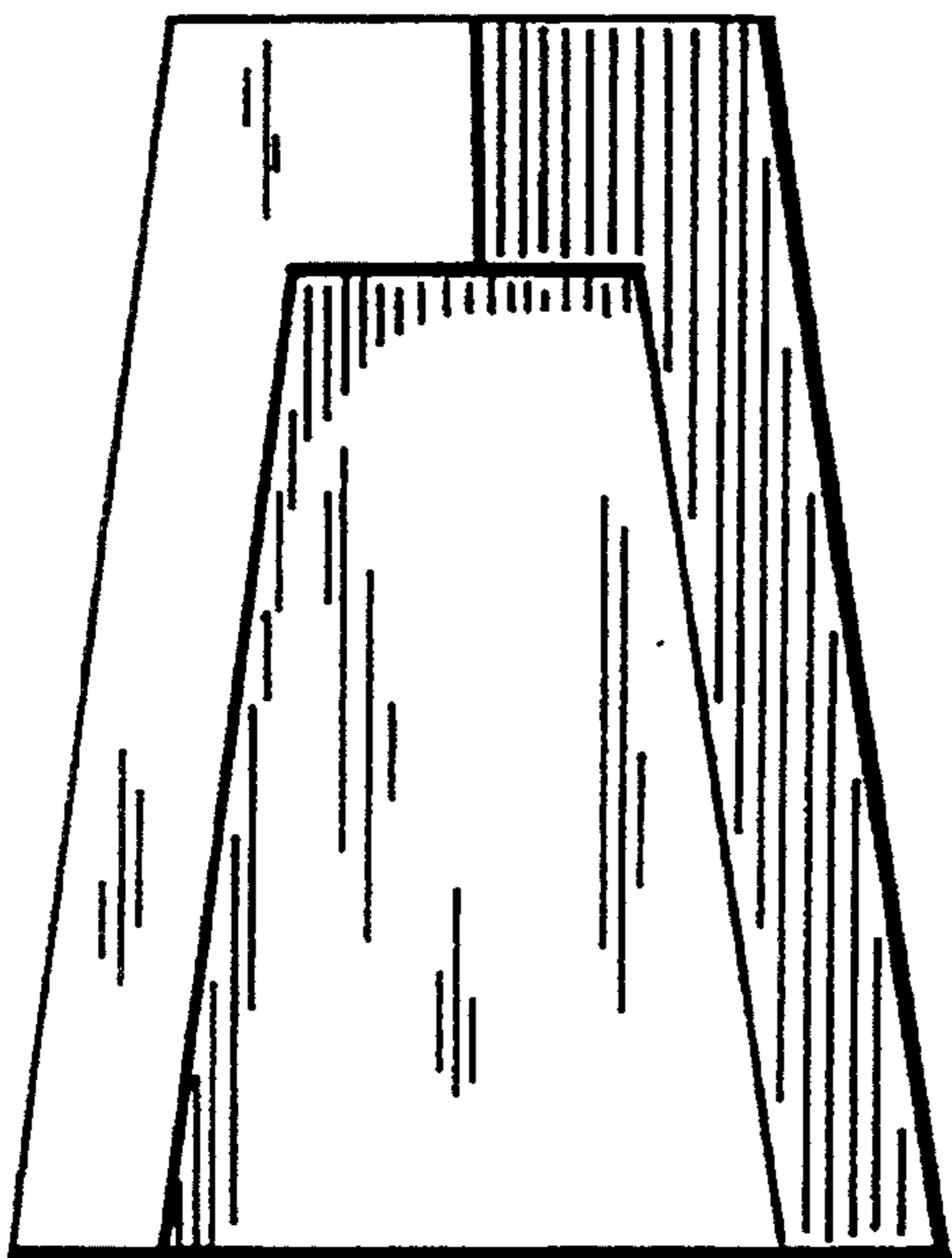

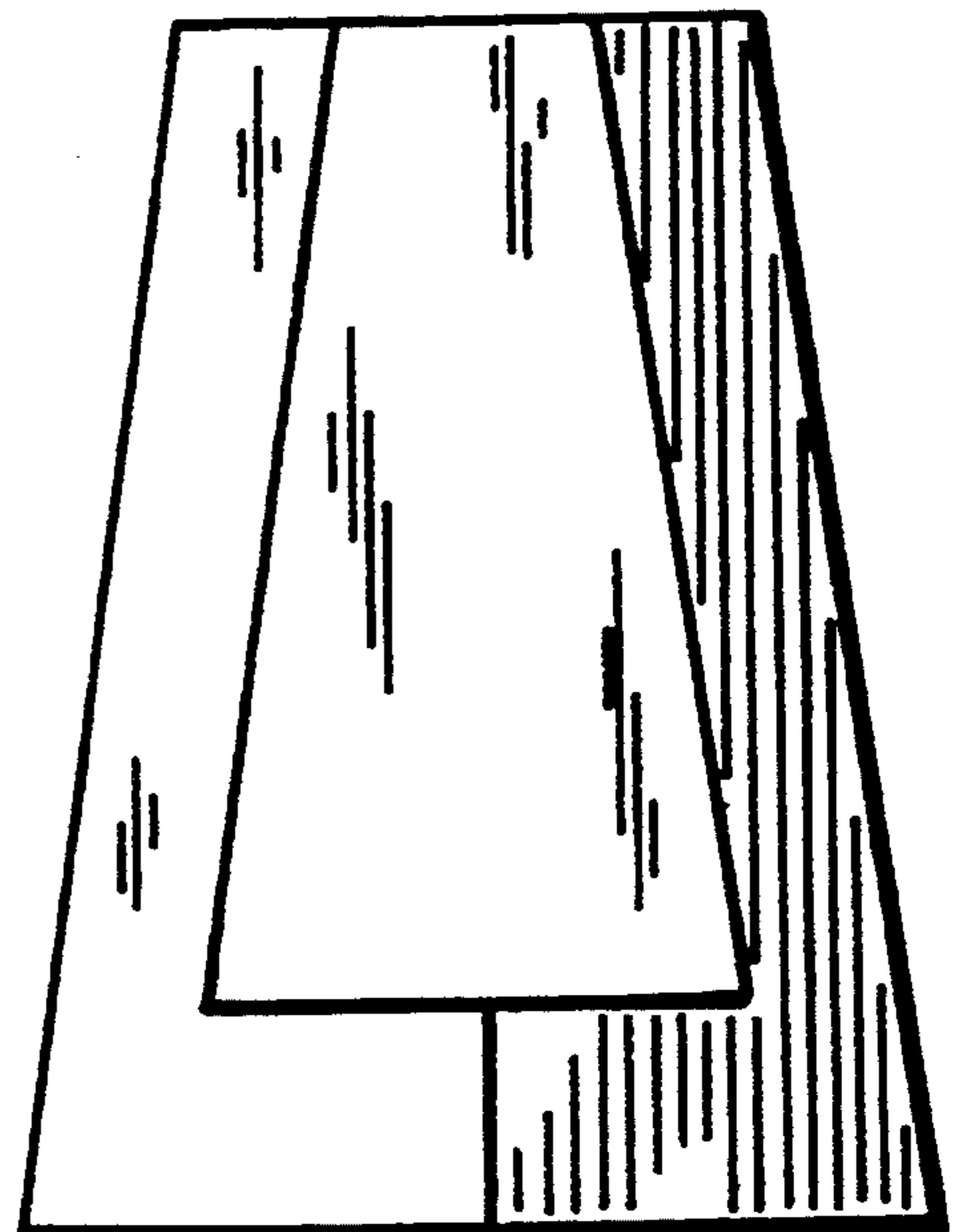

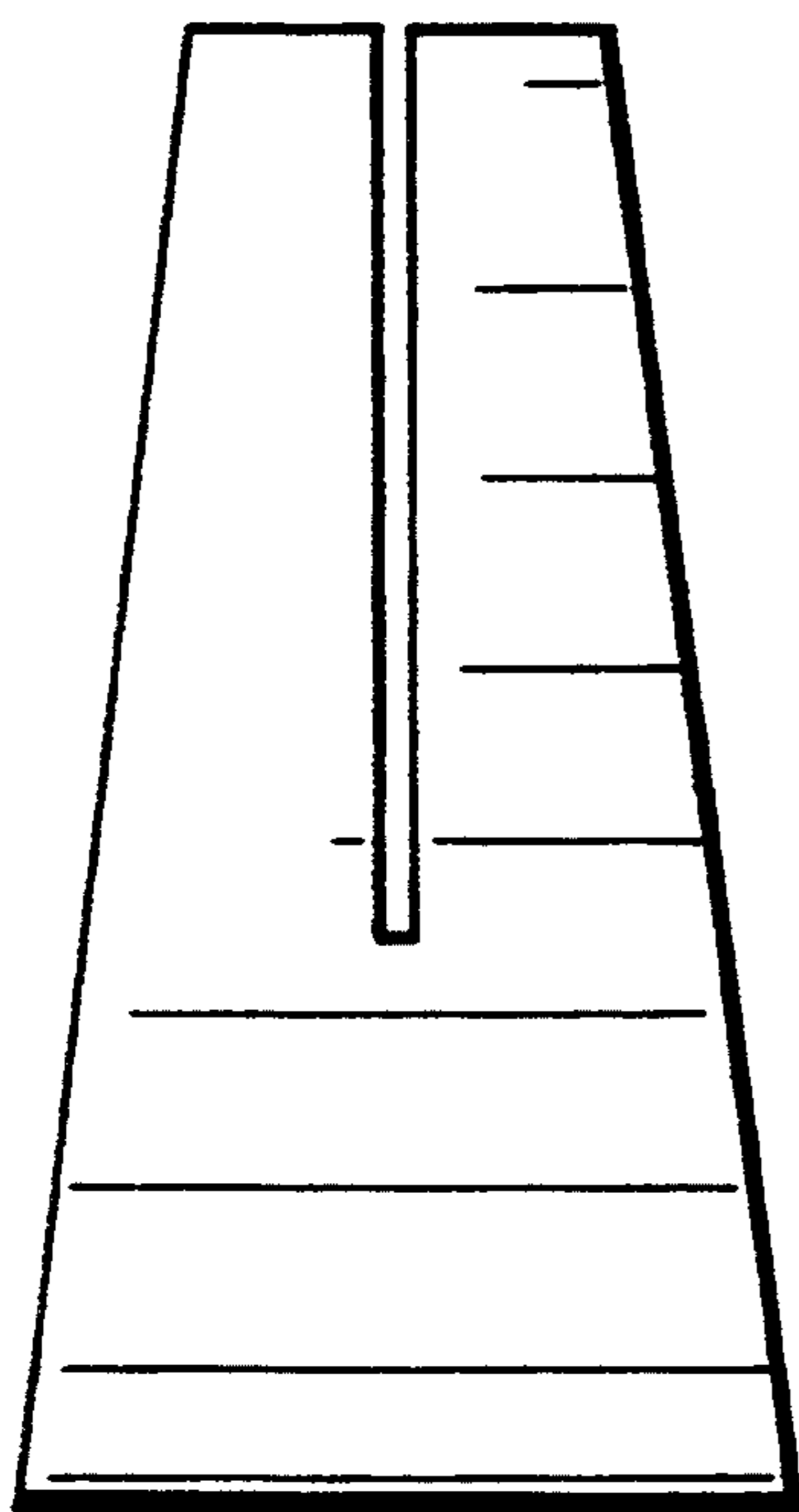

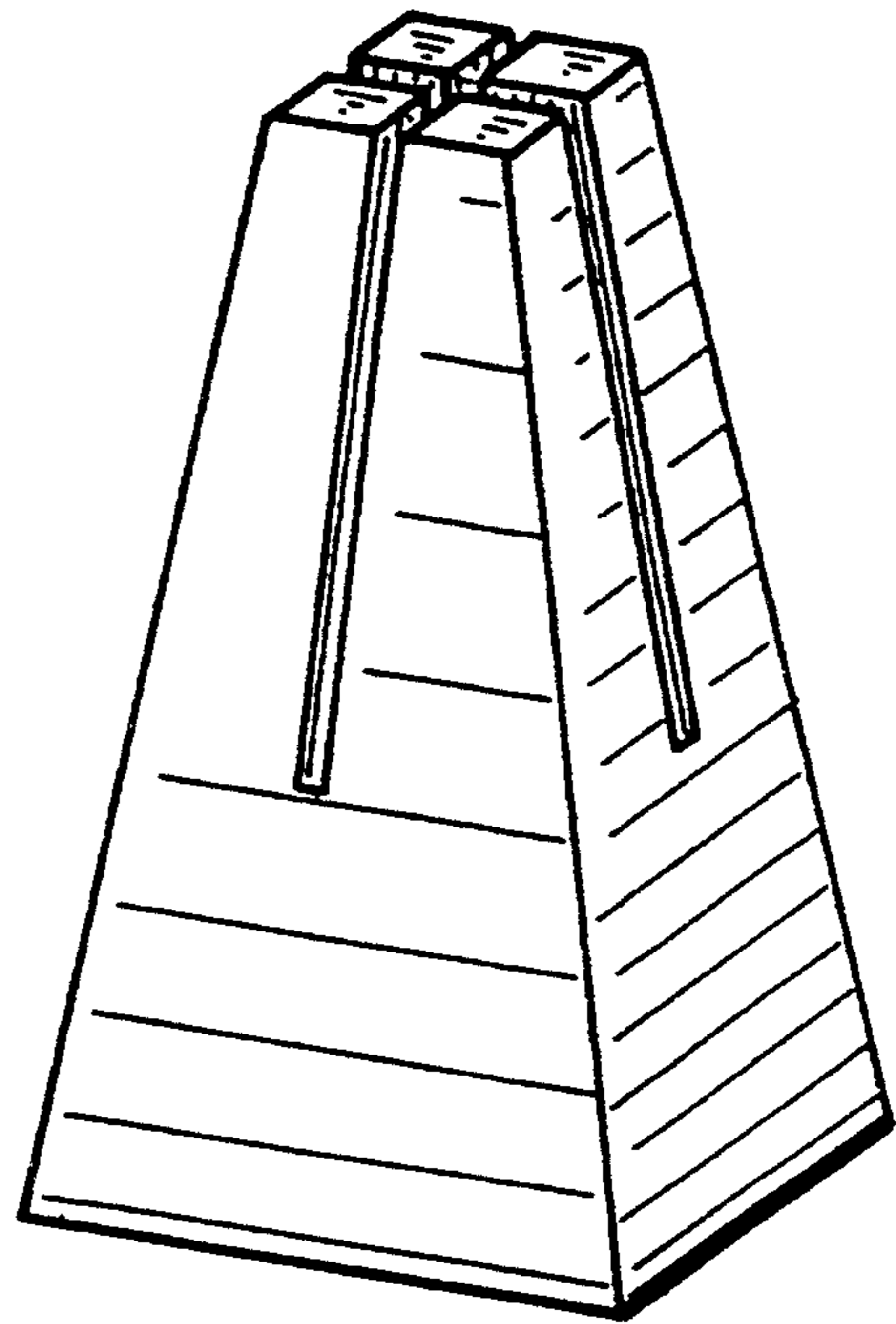

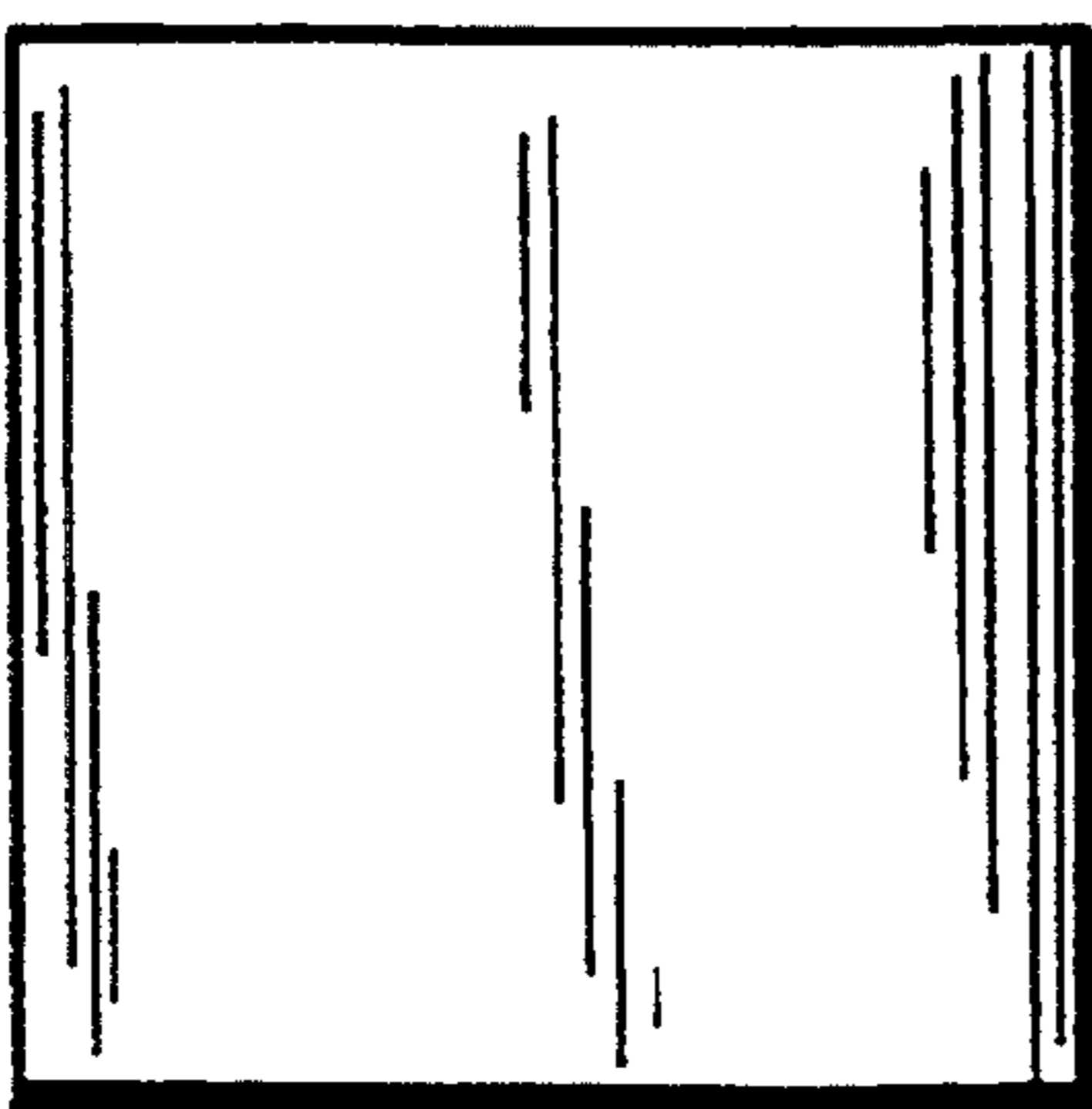

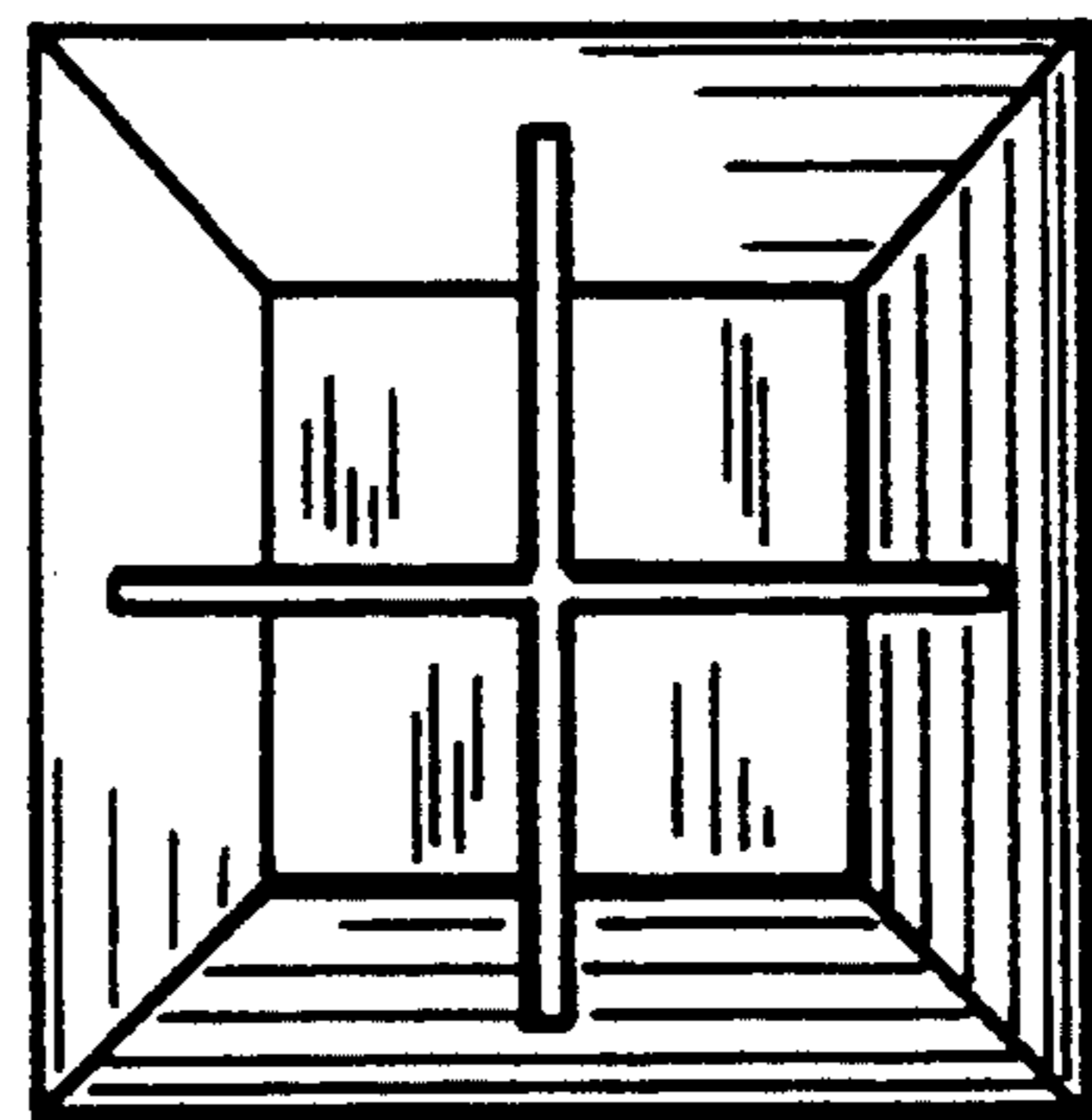

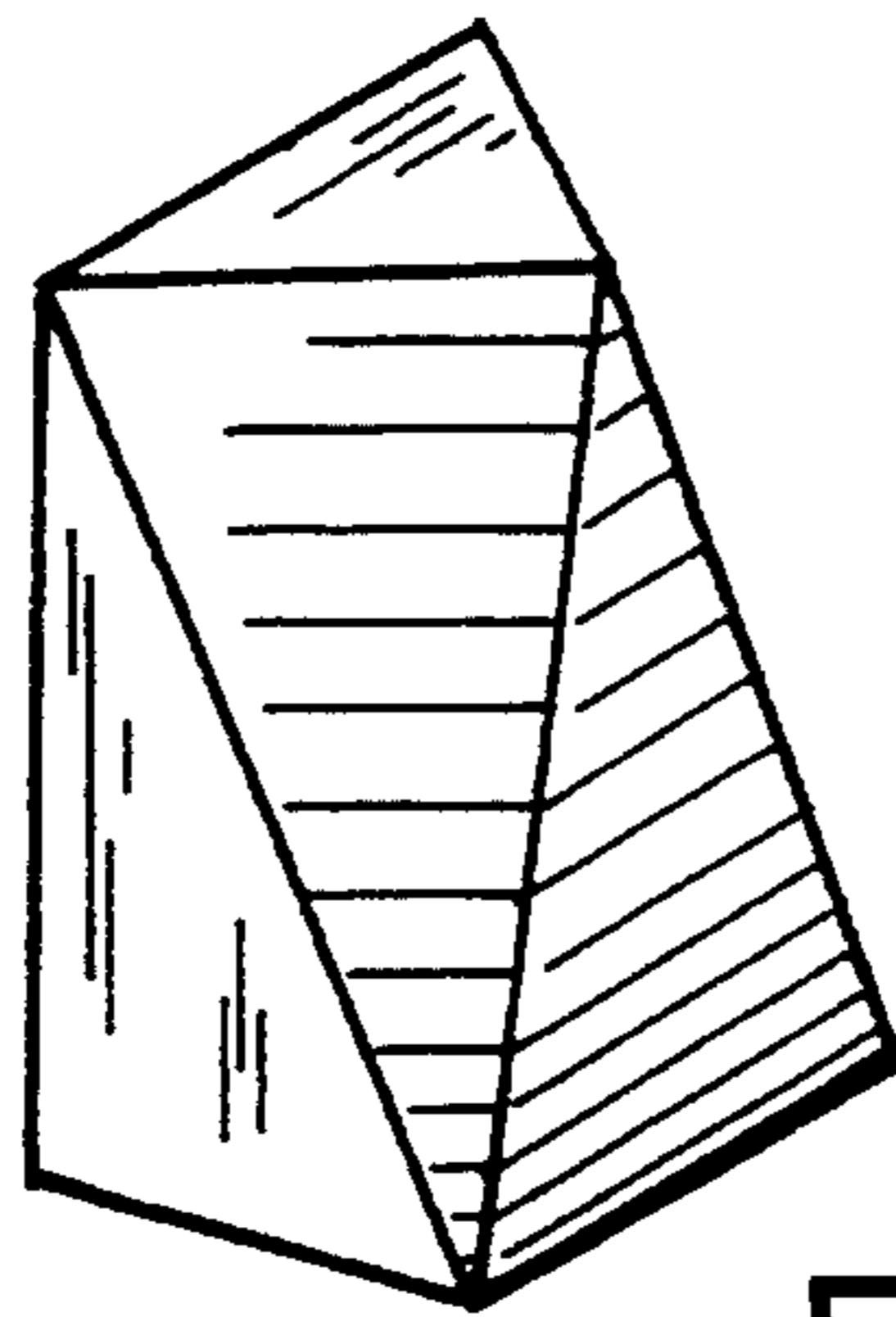

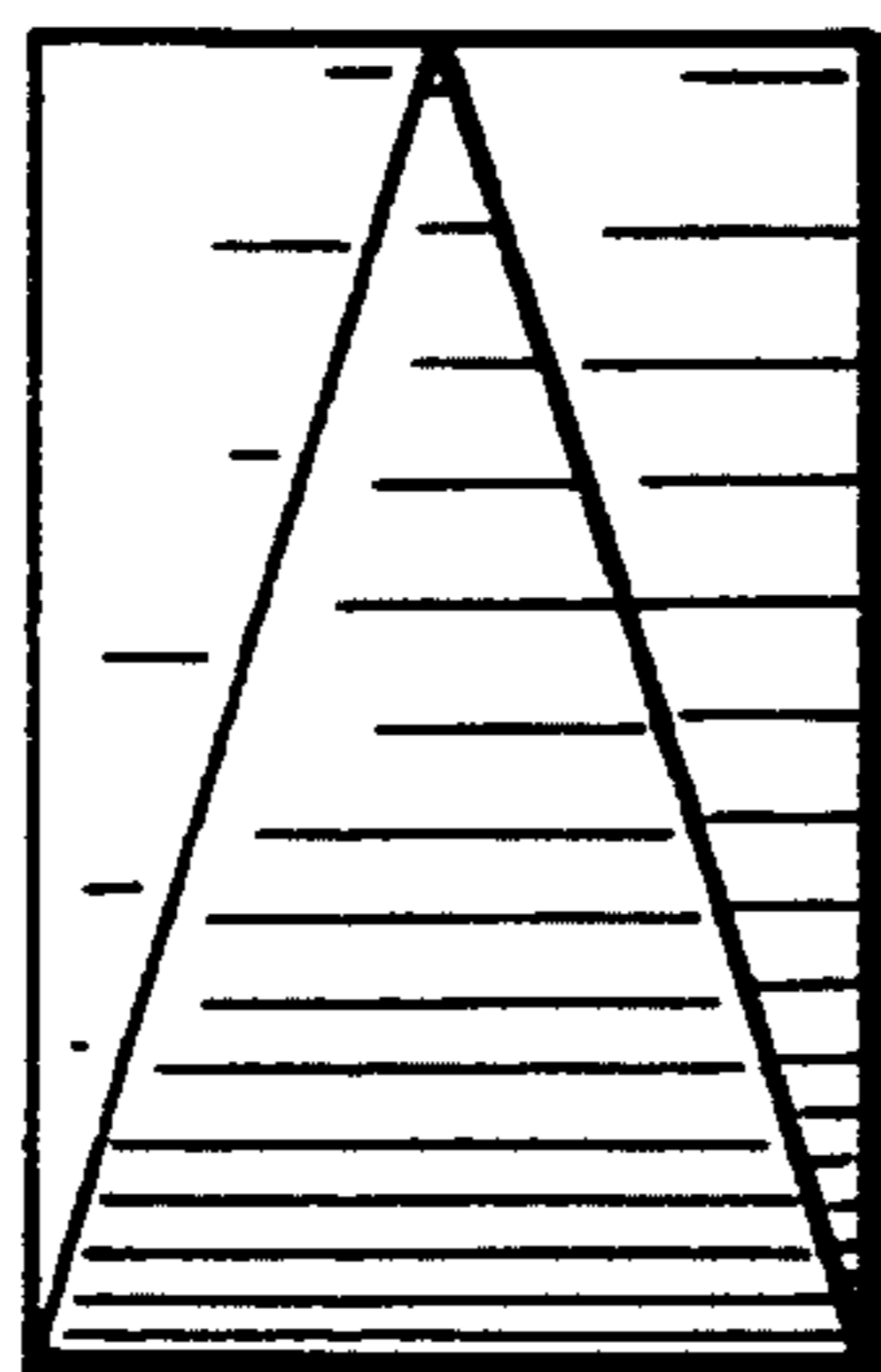

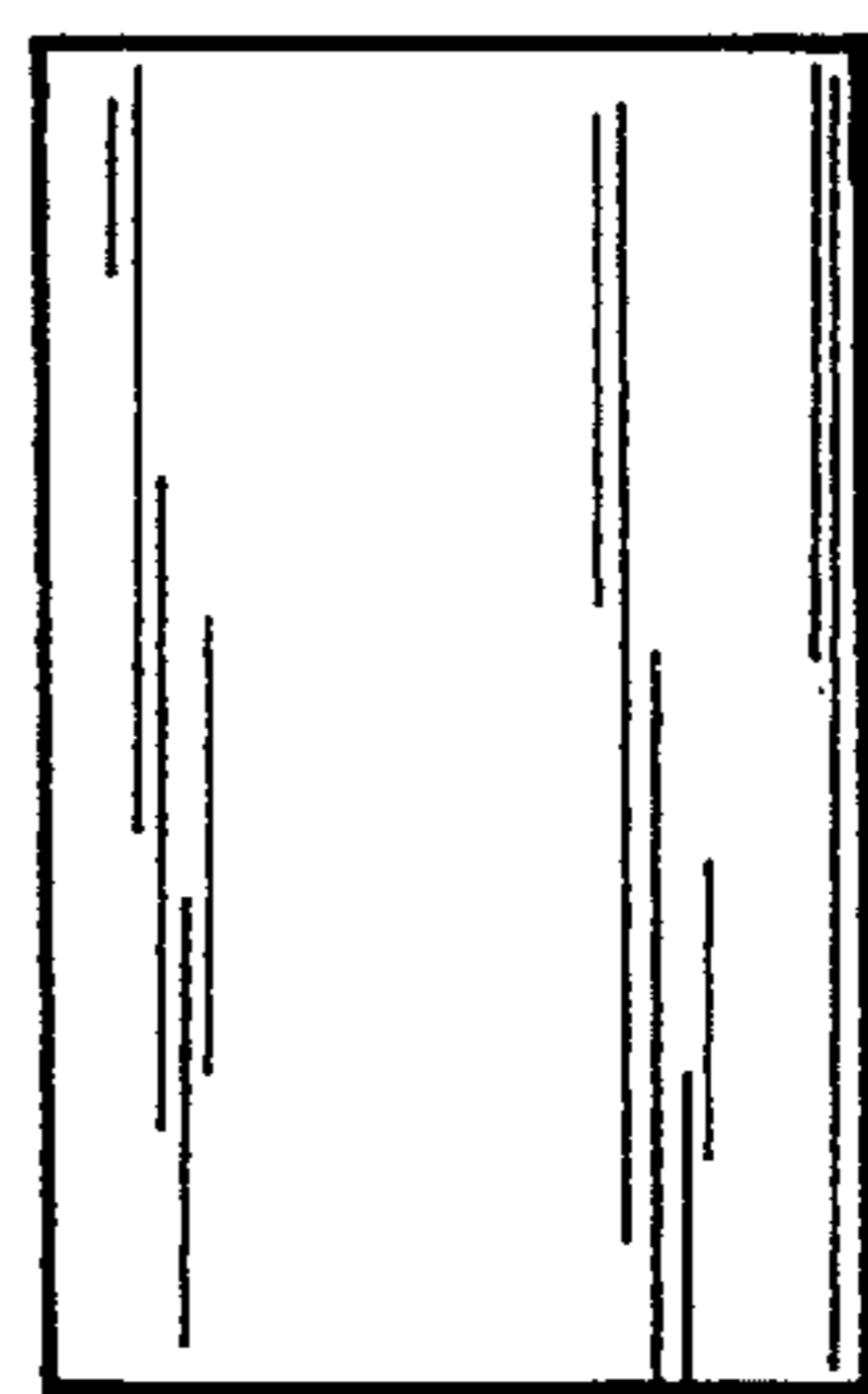

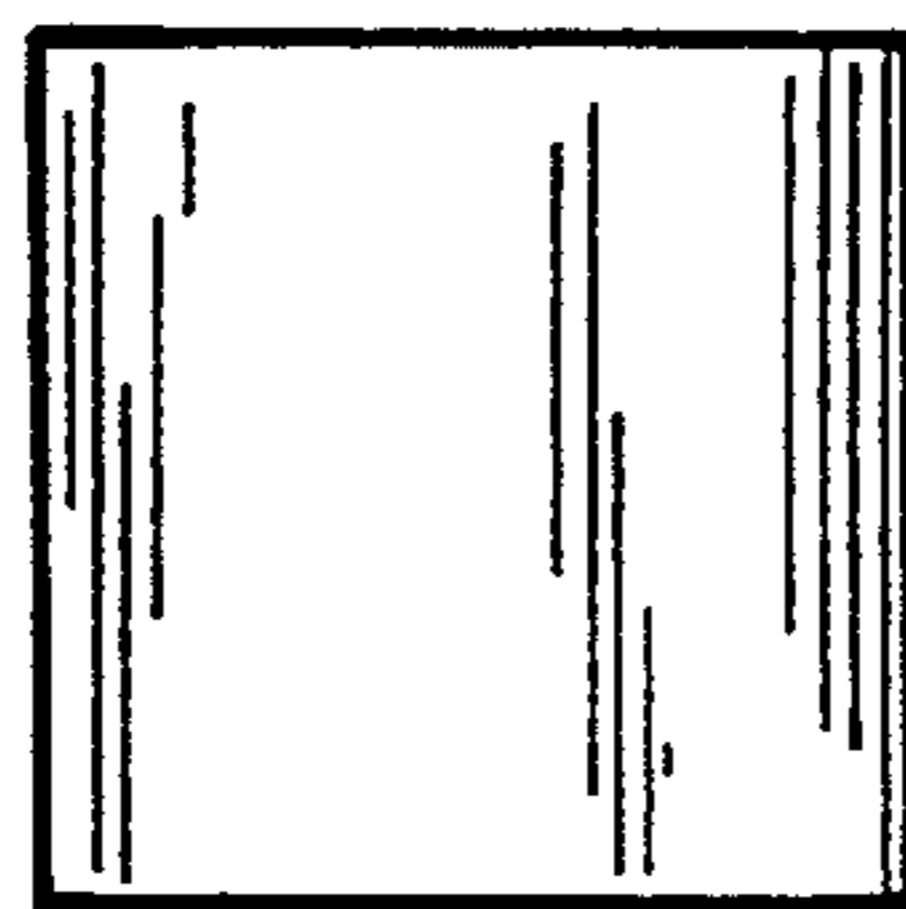

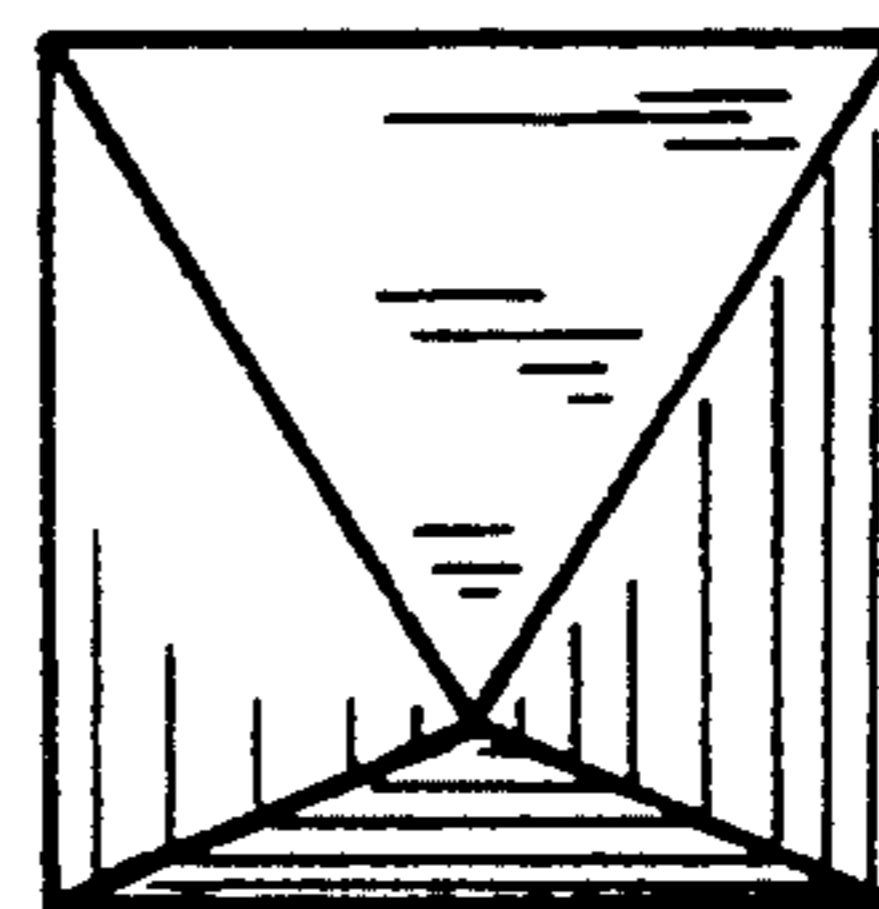

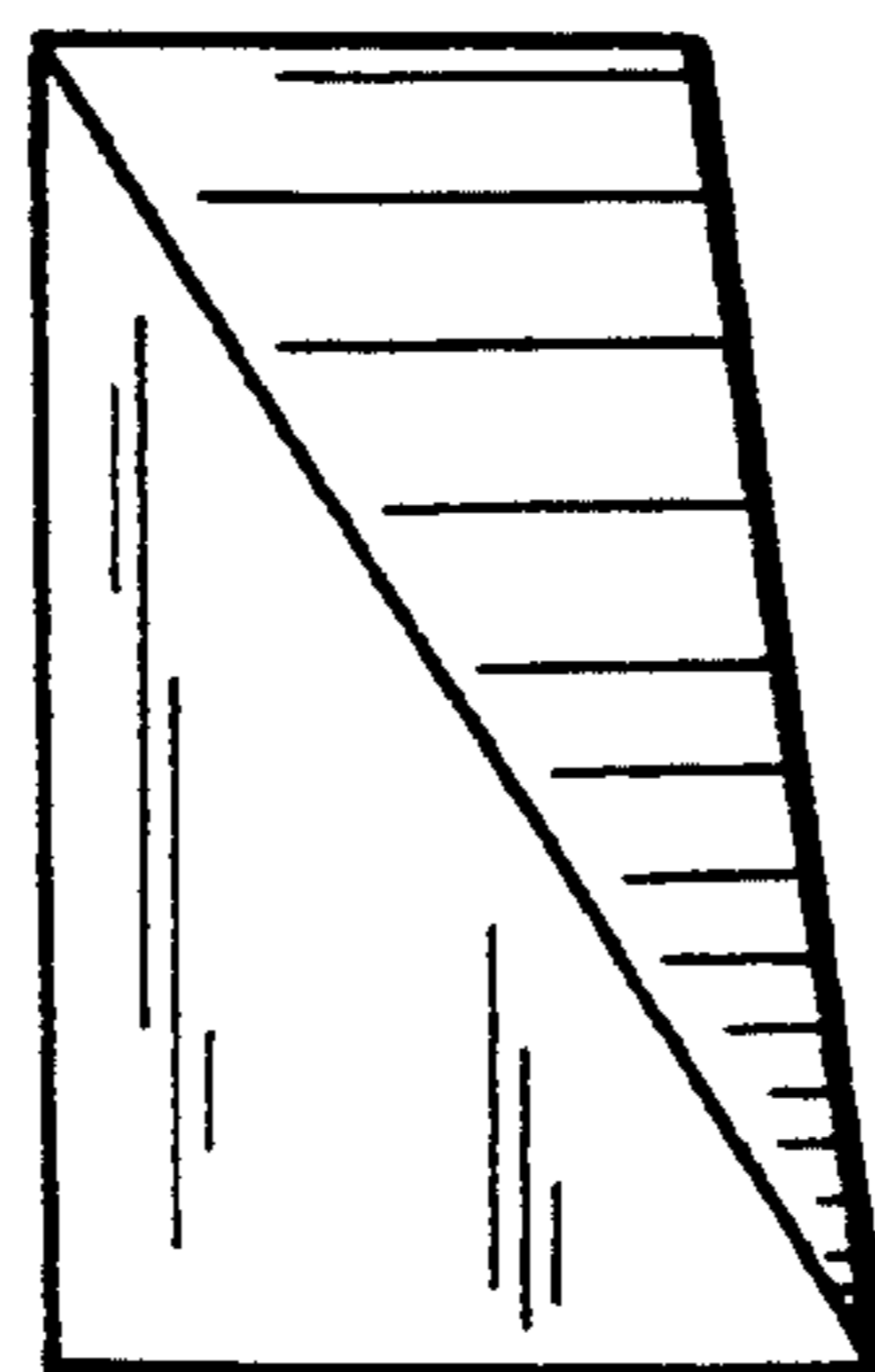
